(57) **CLAIM**

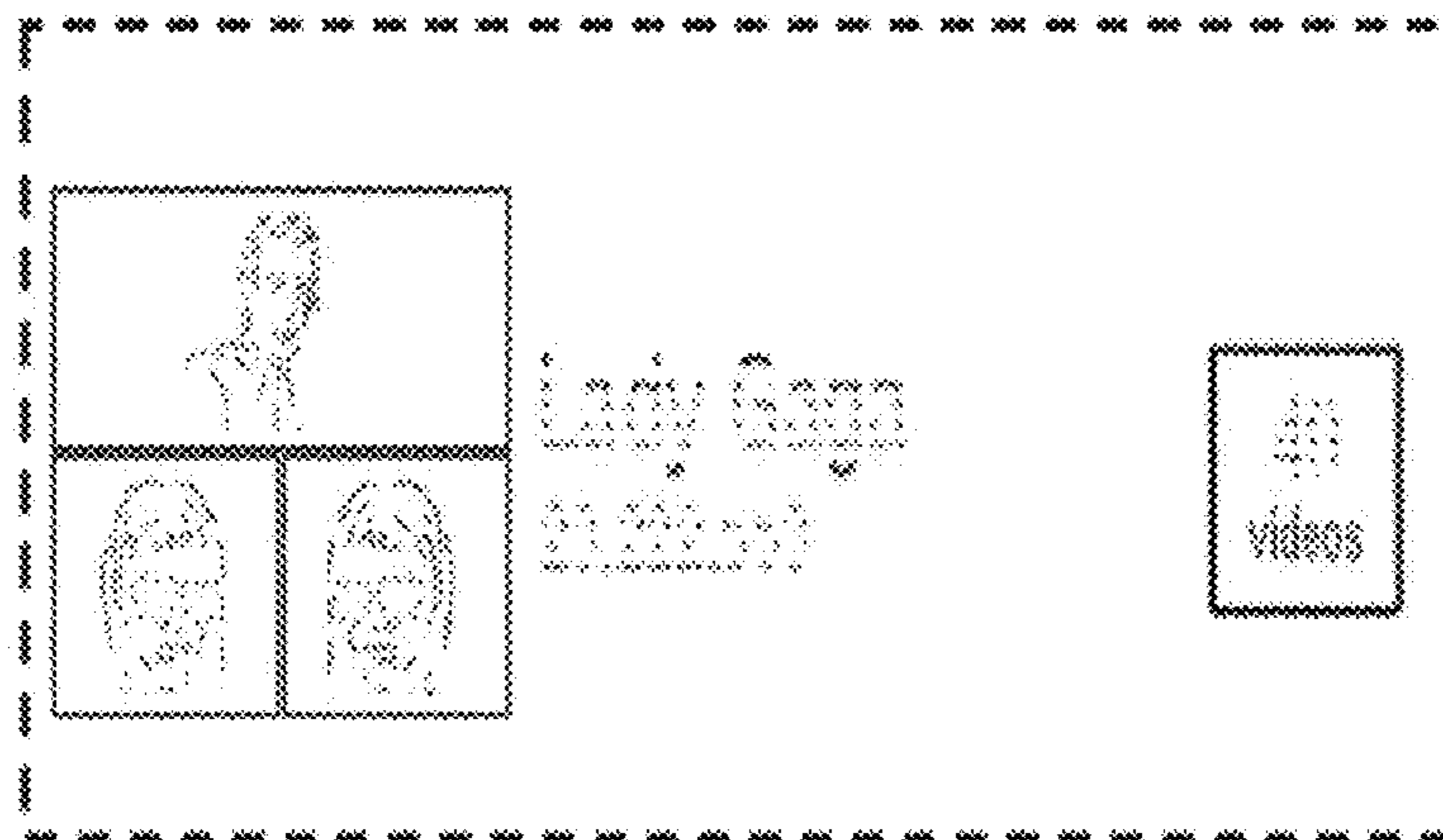
The ornamental design for a portion of a display panel with a topic icon, as shown and described.
