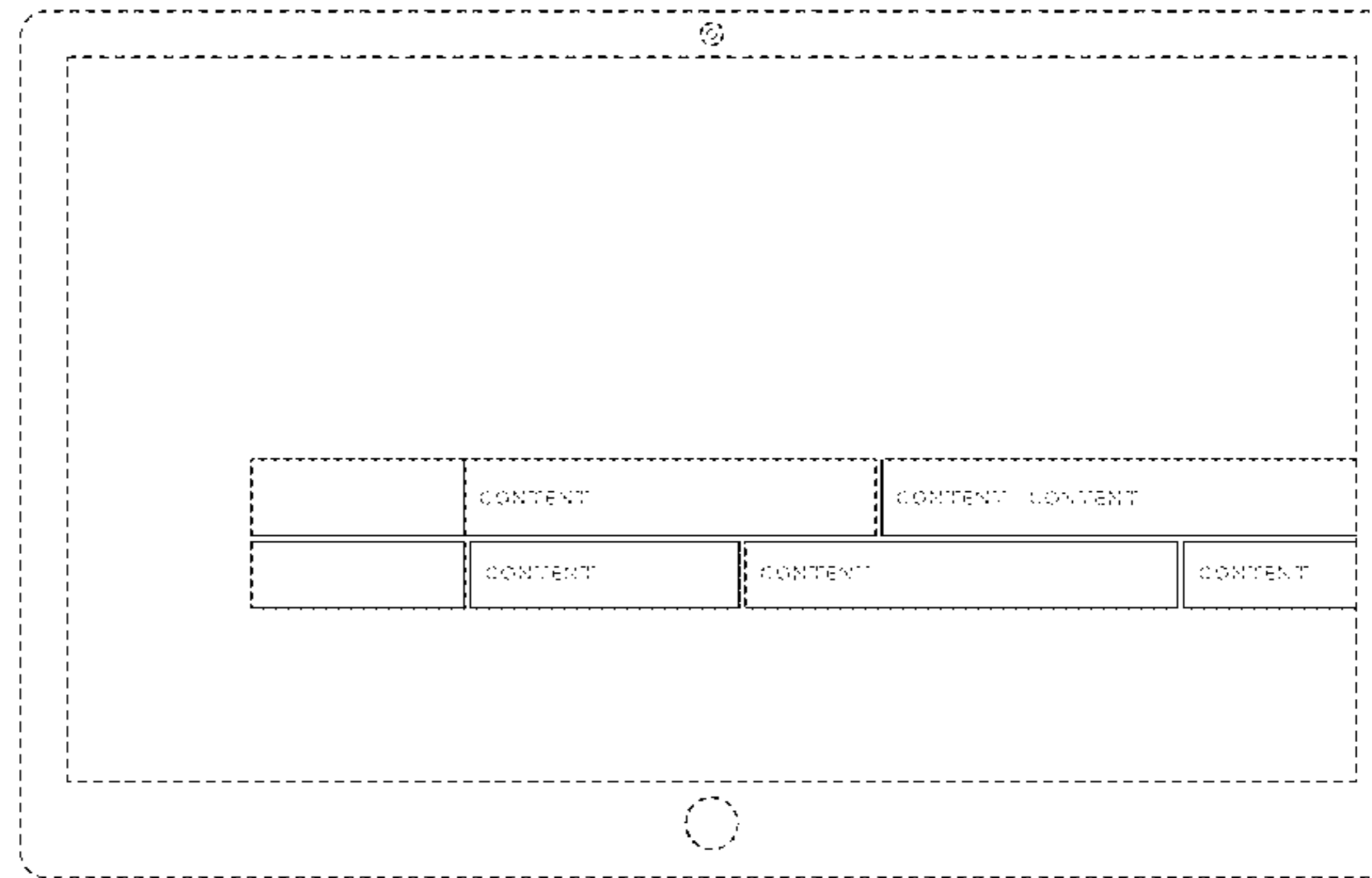
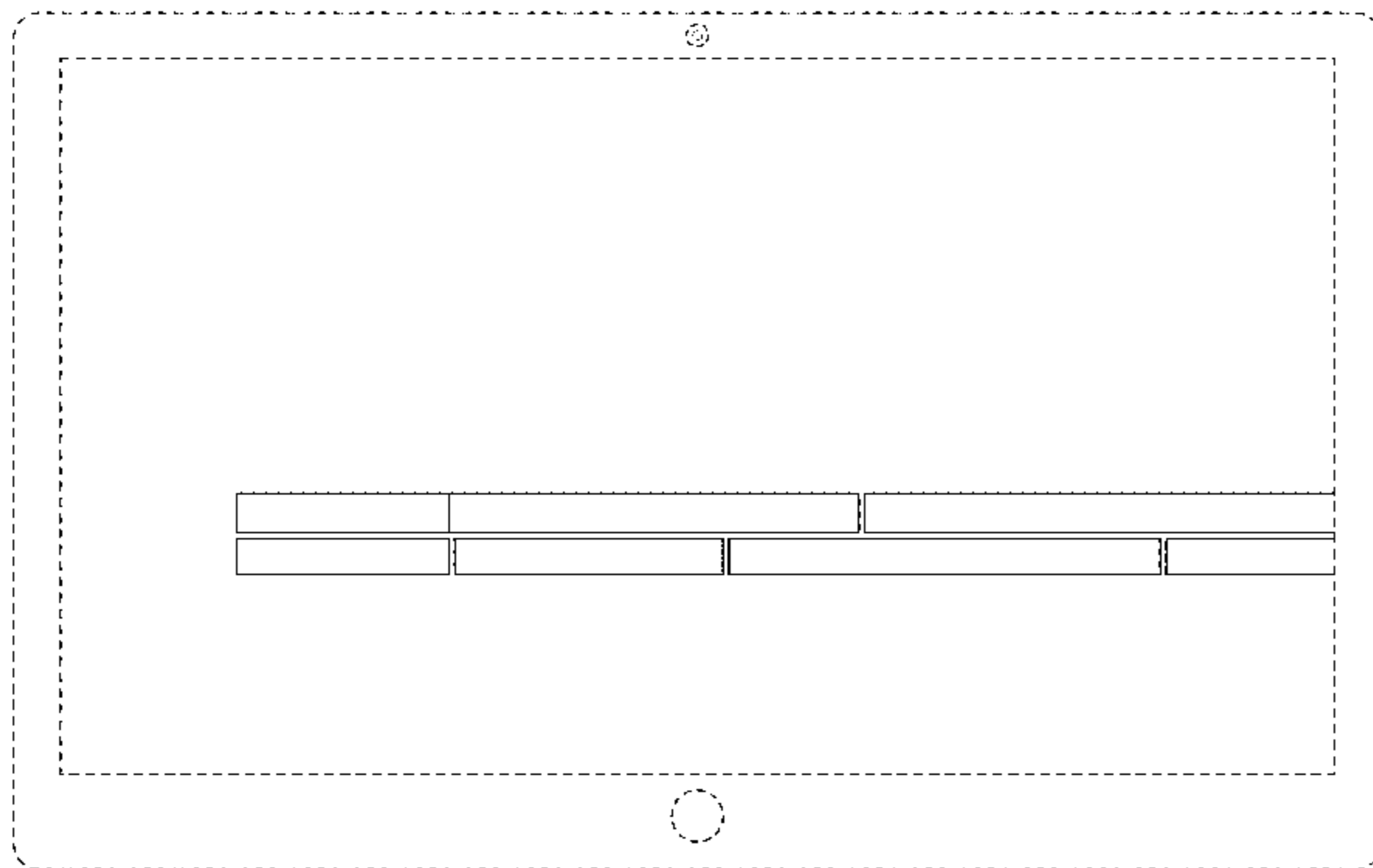
(57) **CLAIM**

The ornamental design for a display screen with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is the first image in a sequence for a display screen with animated graphical user interface showing my new design; FIG. 2 is the second image thereof; FIG. 3 is the third image thereof; FIG. 4 is the fourth image thereof; FIG. 5 is the fifth image thereof; FIG. 6 is the sixth image thereof; and, FIG. 7 is the seventh image thereof. The appearance of the animated user interface sequentially transitions between the images shown in FIGS. 1-7. The process or period in which one image transitions to another forms no part of the claimed design. The broken line showing of the text, tiles, display screen and the device are for environmental purposes only and form no part of the claimed design.

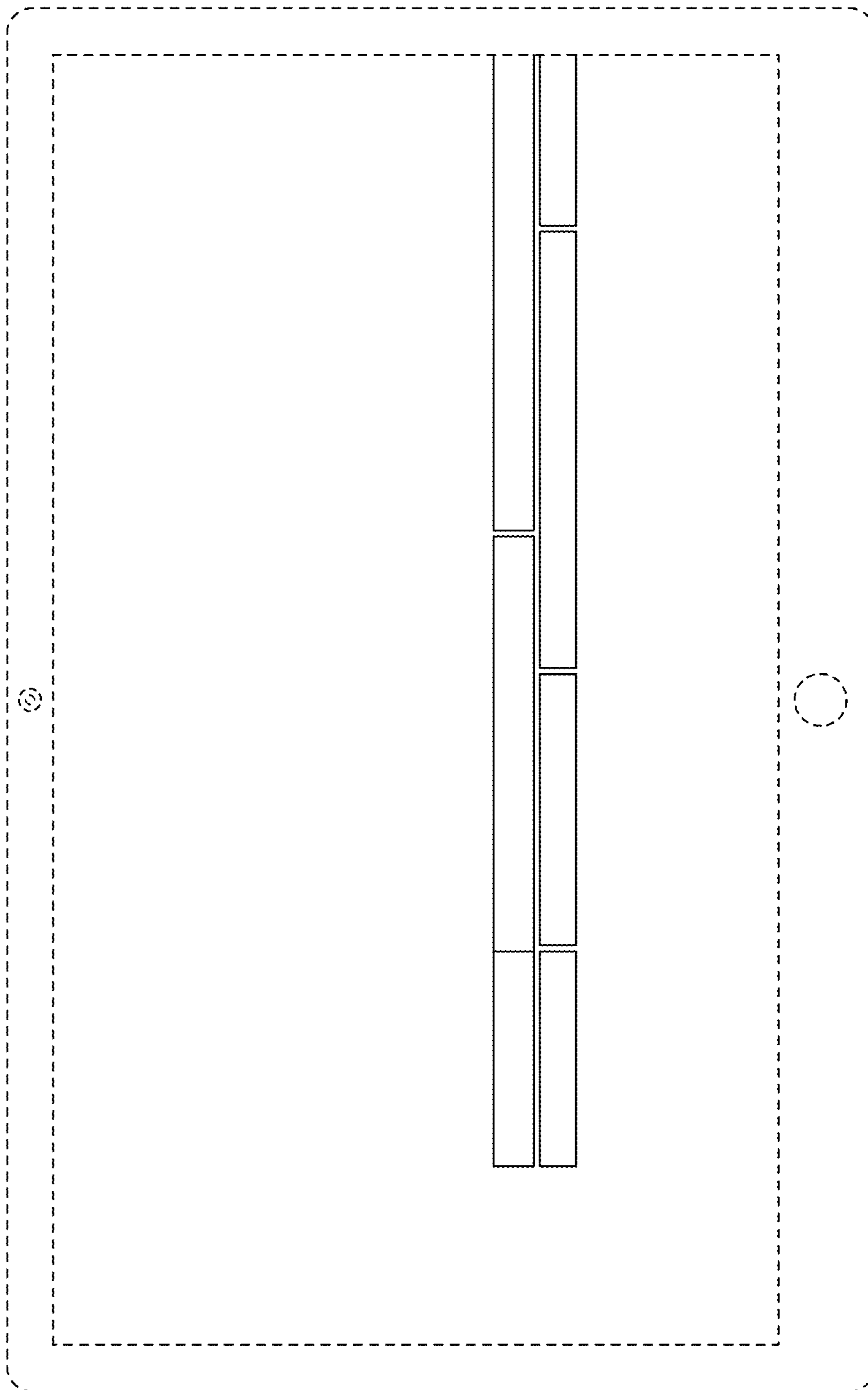

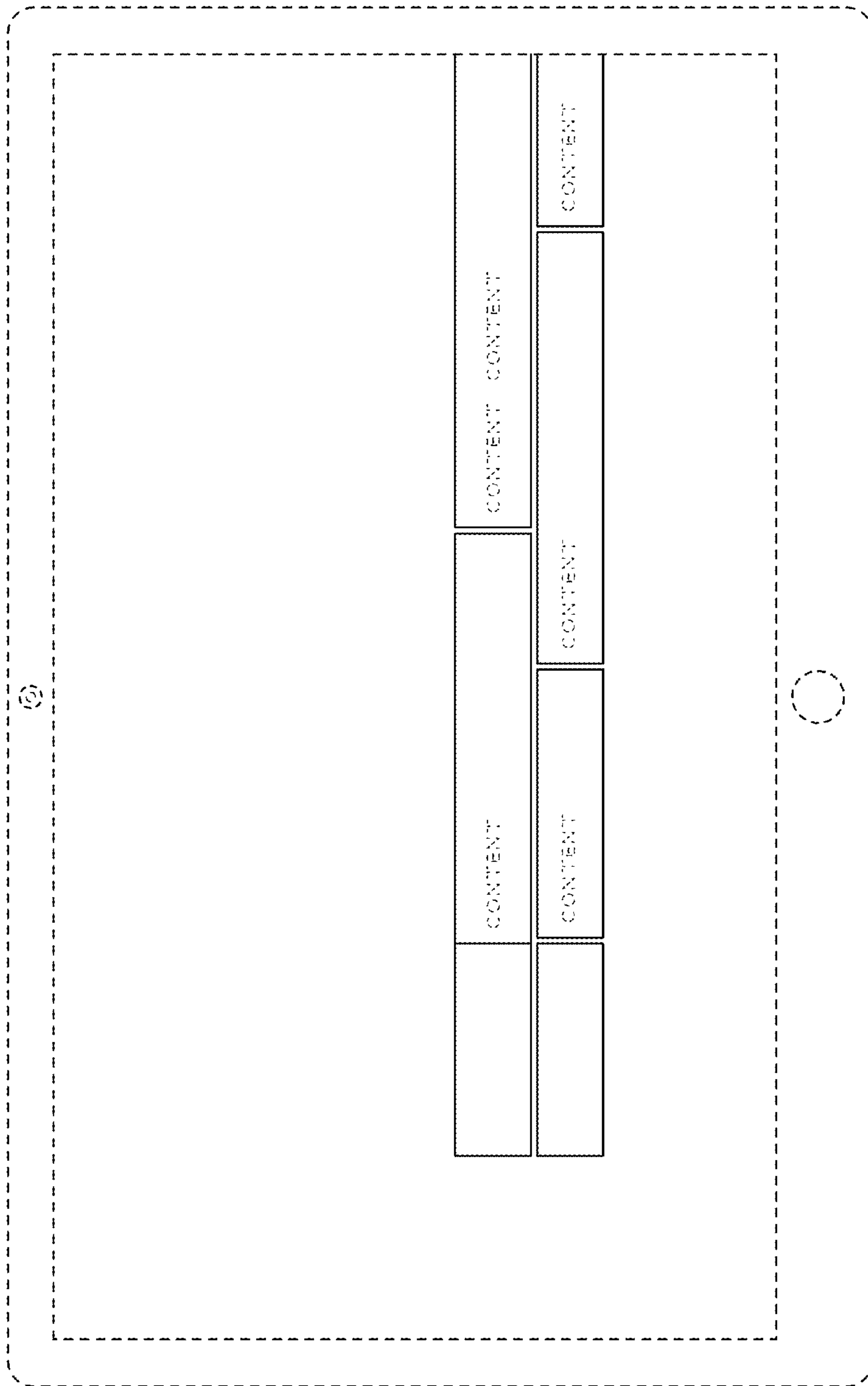

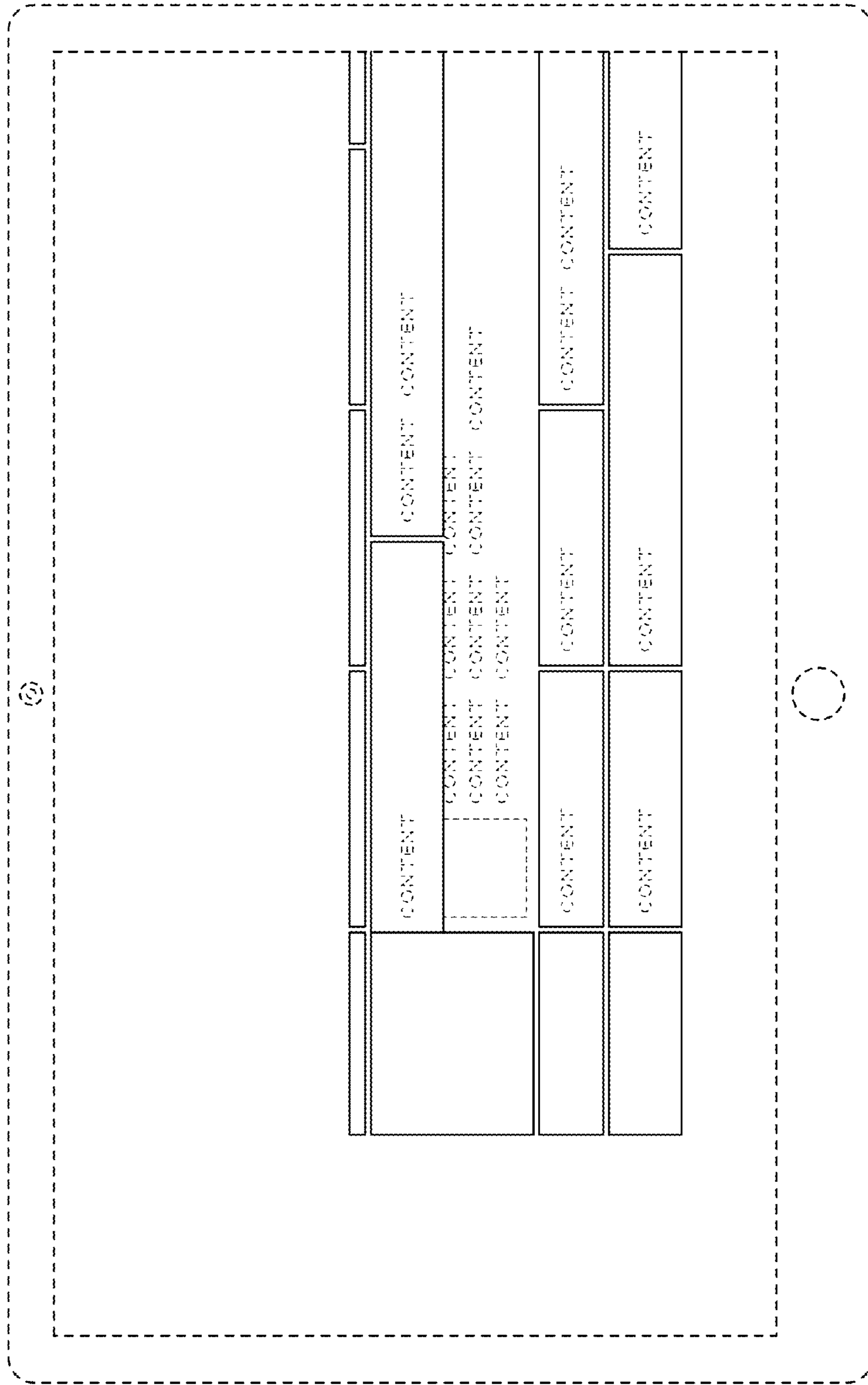

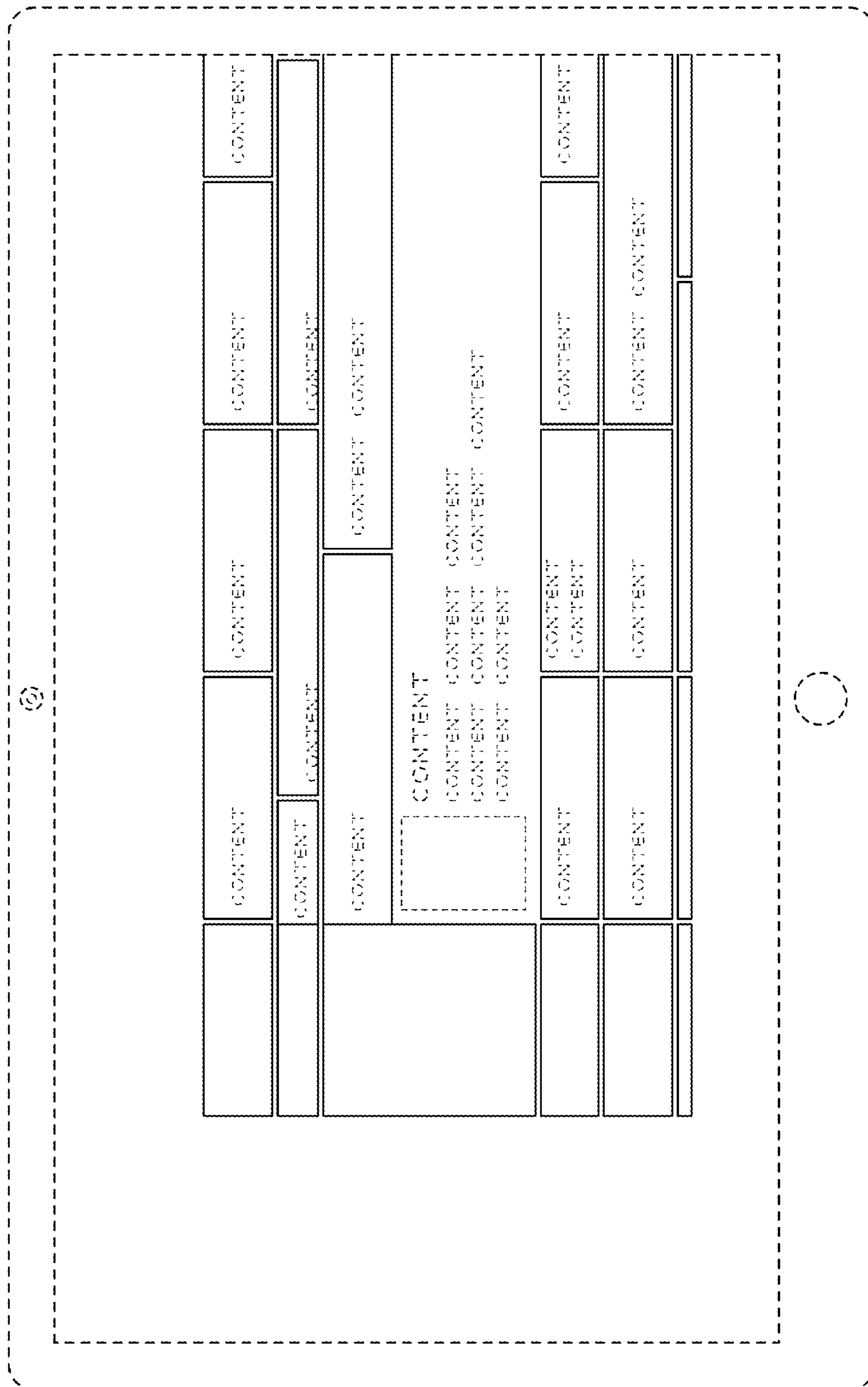
