**DESCRIPTION**

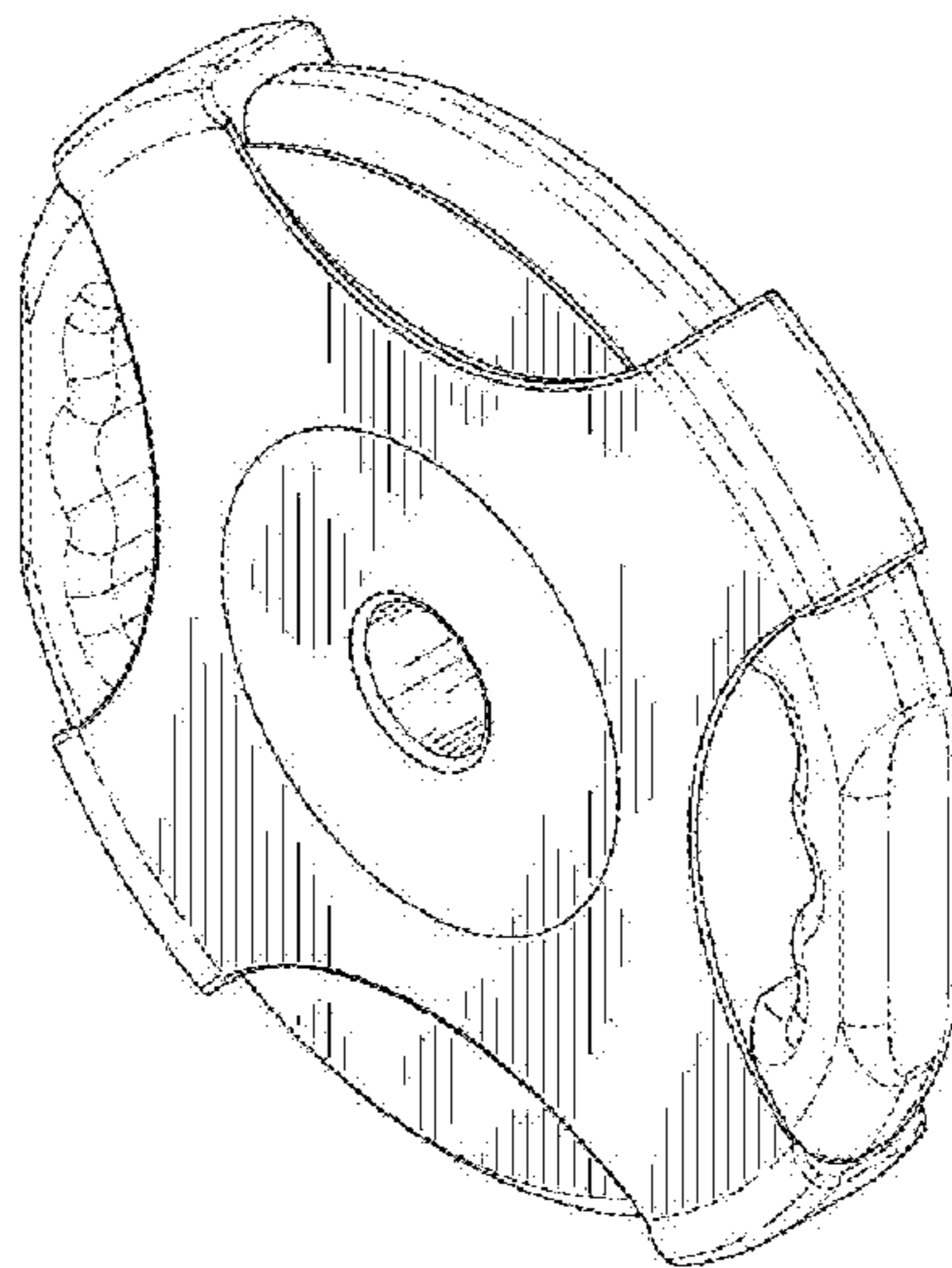
FIG. 1 is an isometric view of the individual cross grip olympic

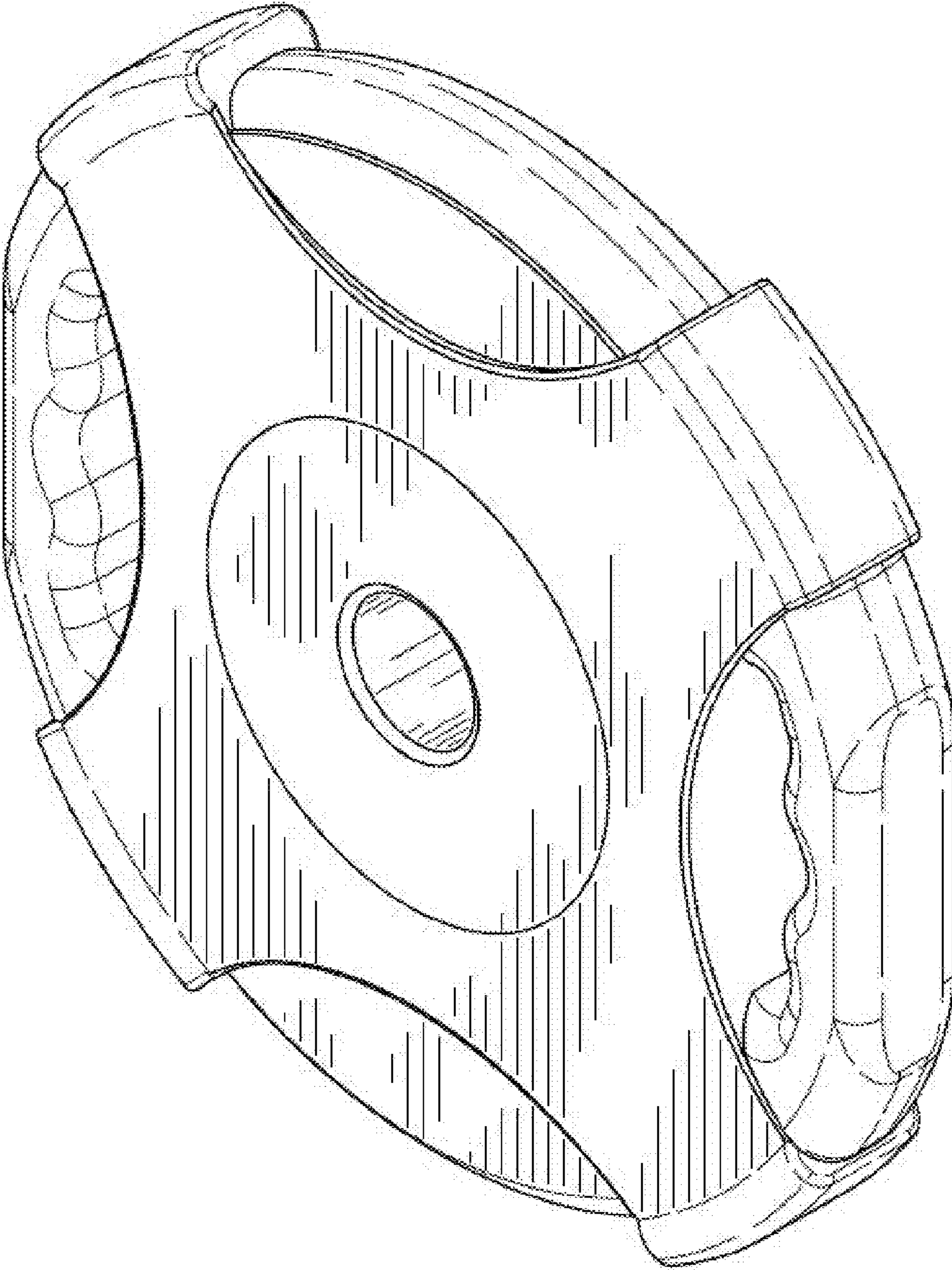

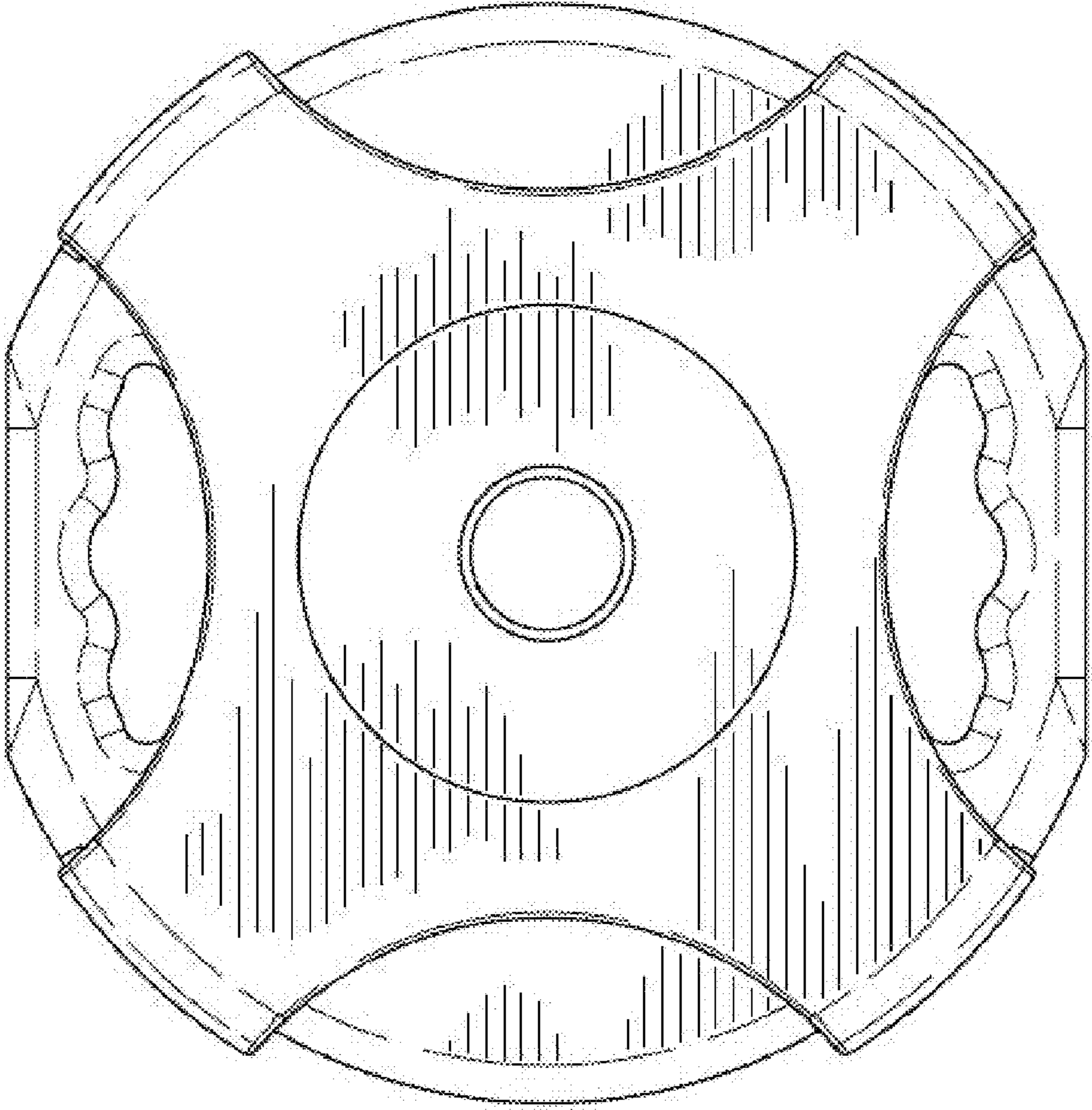

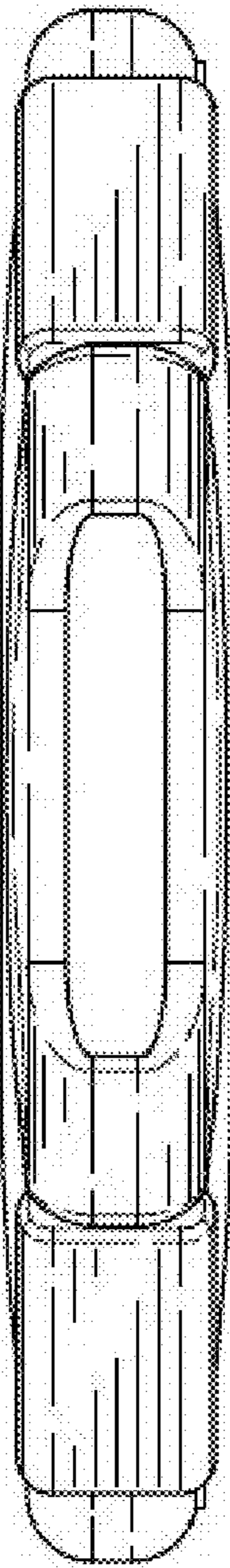

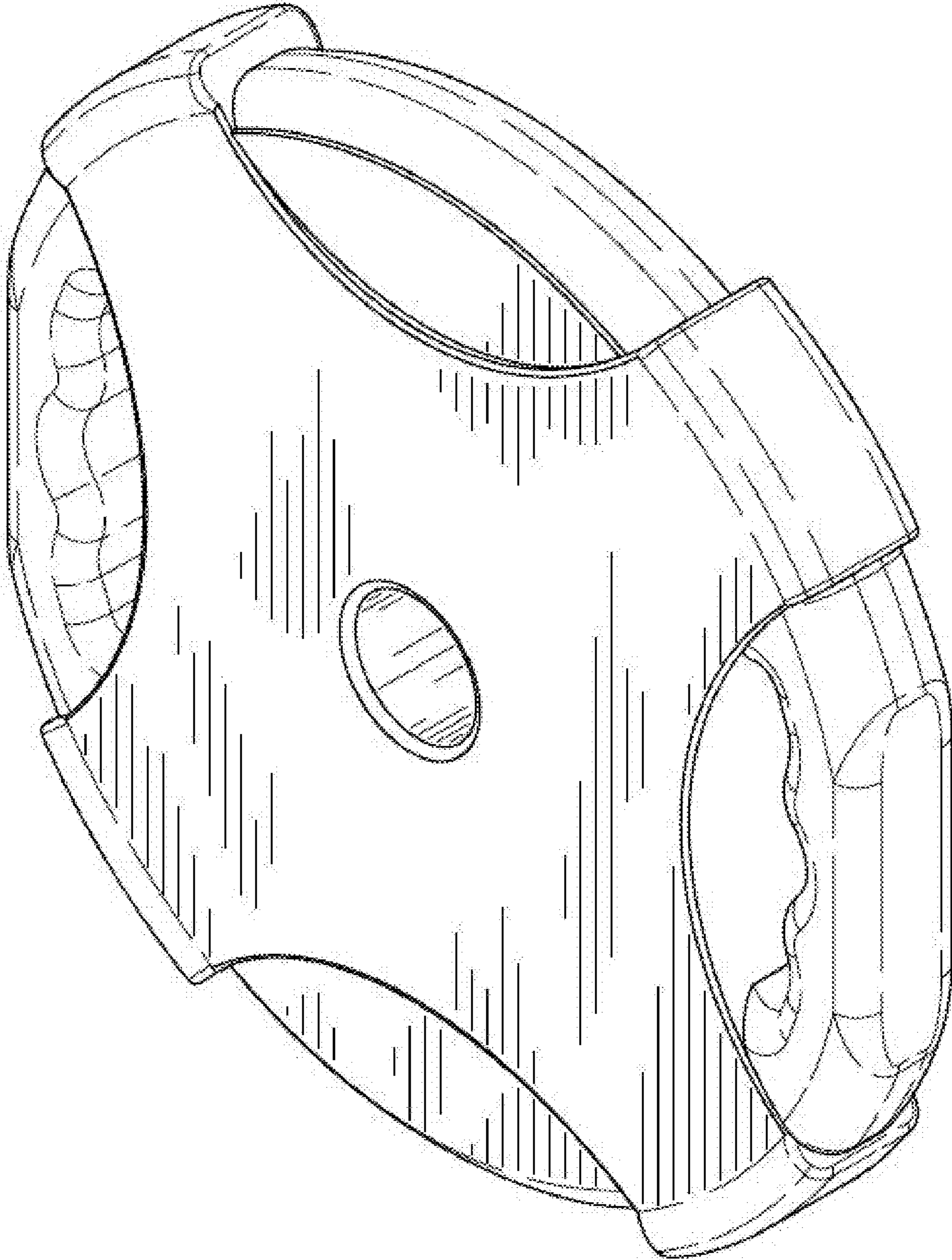

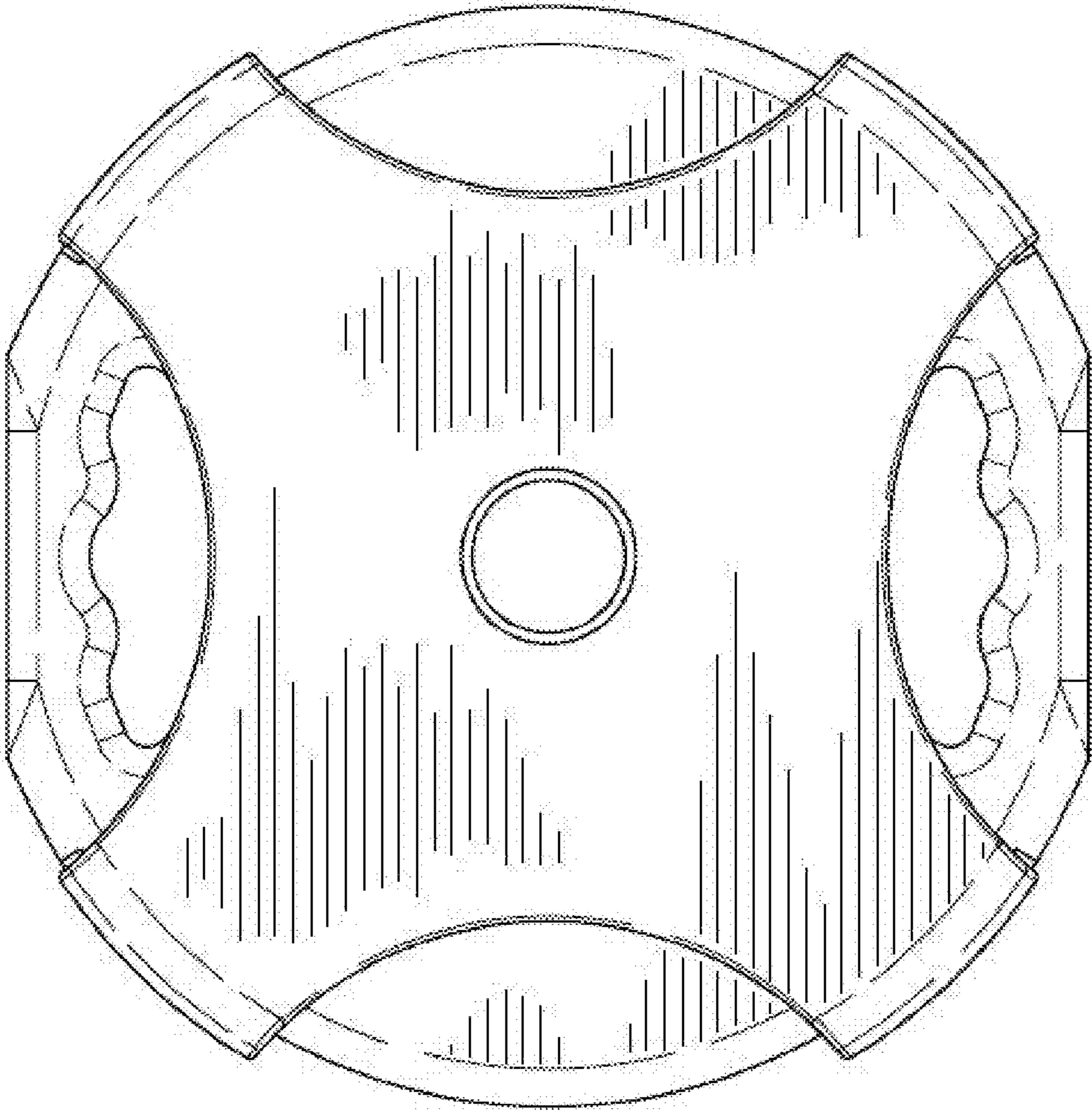

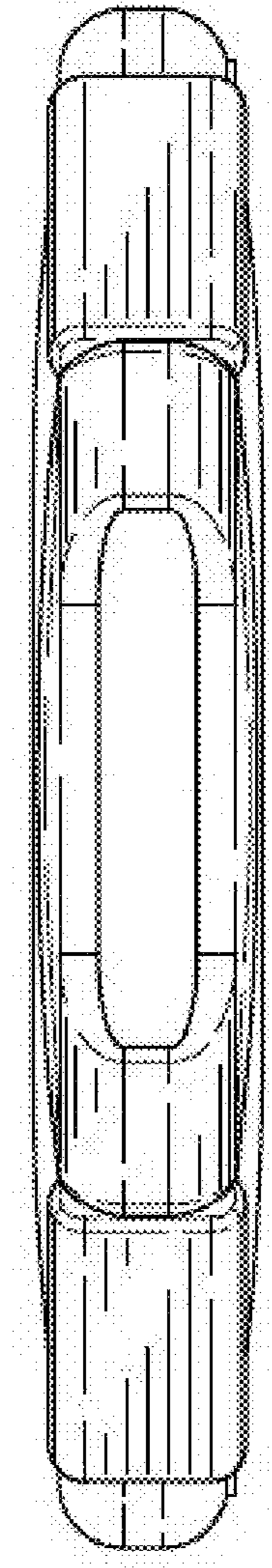

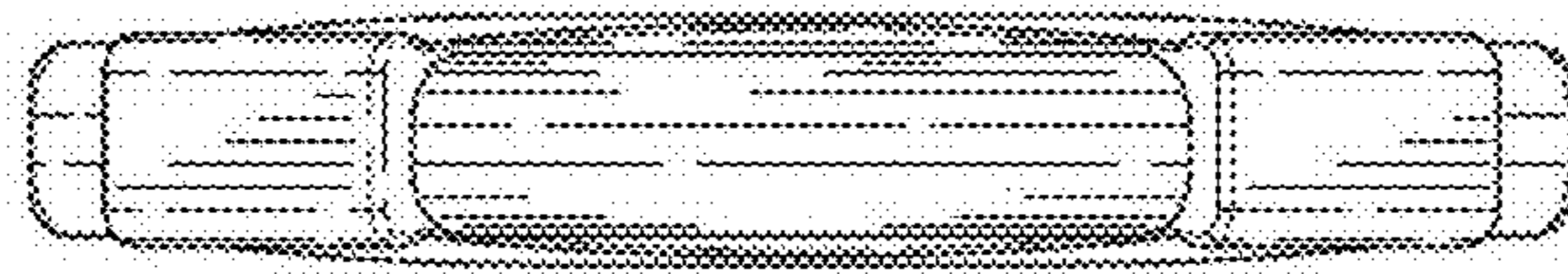
