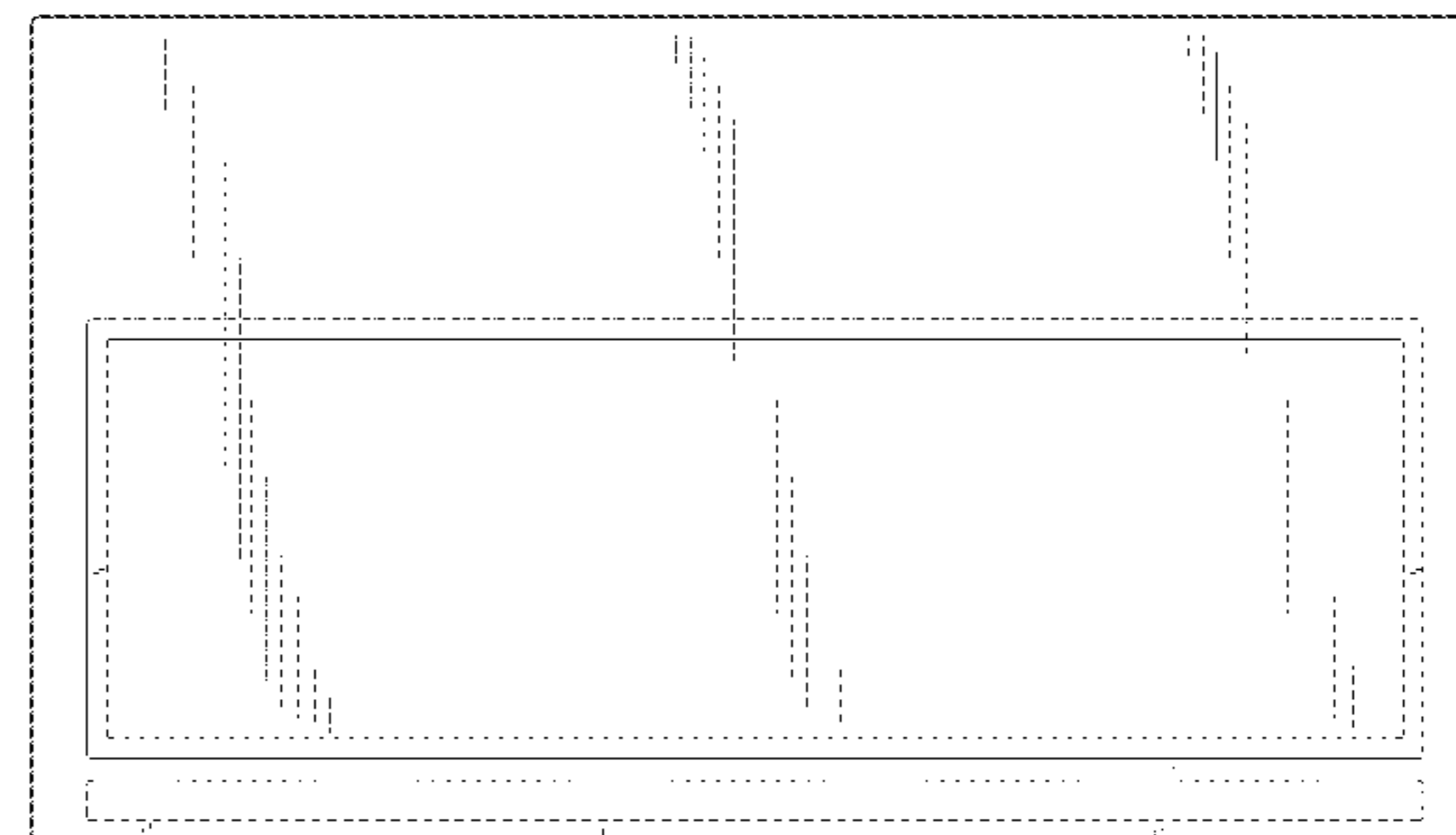
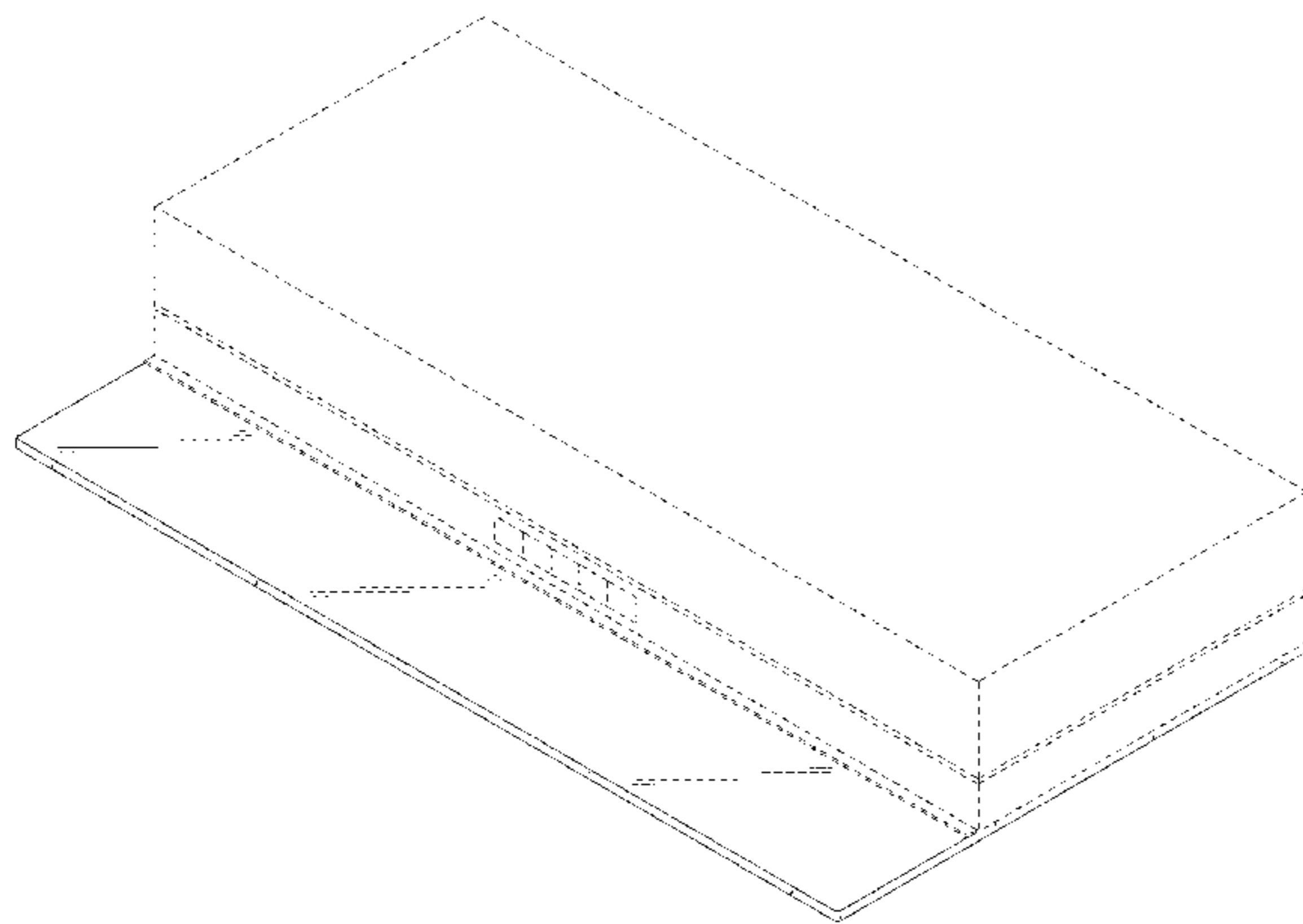
We claim the ornamental design for an undercabinet vent hood, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of an undercabinet vent hood of the present disclosure;

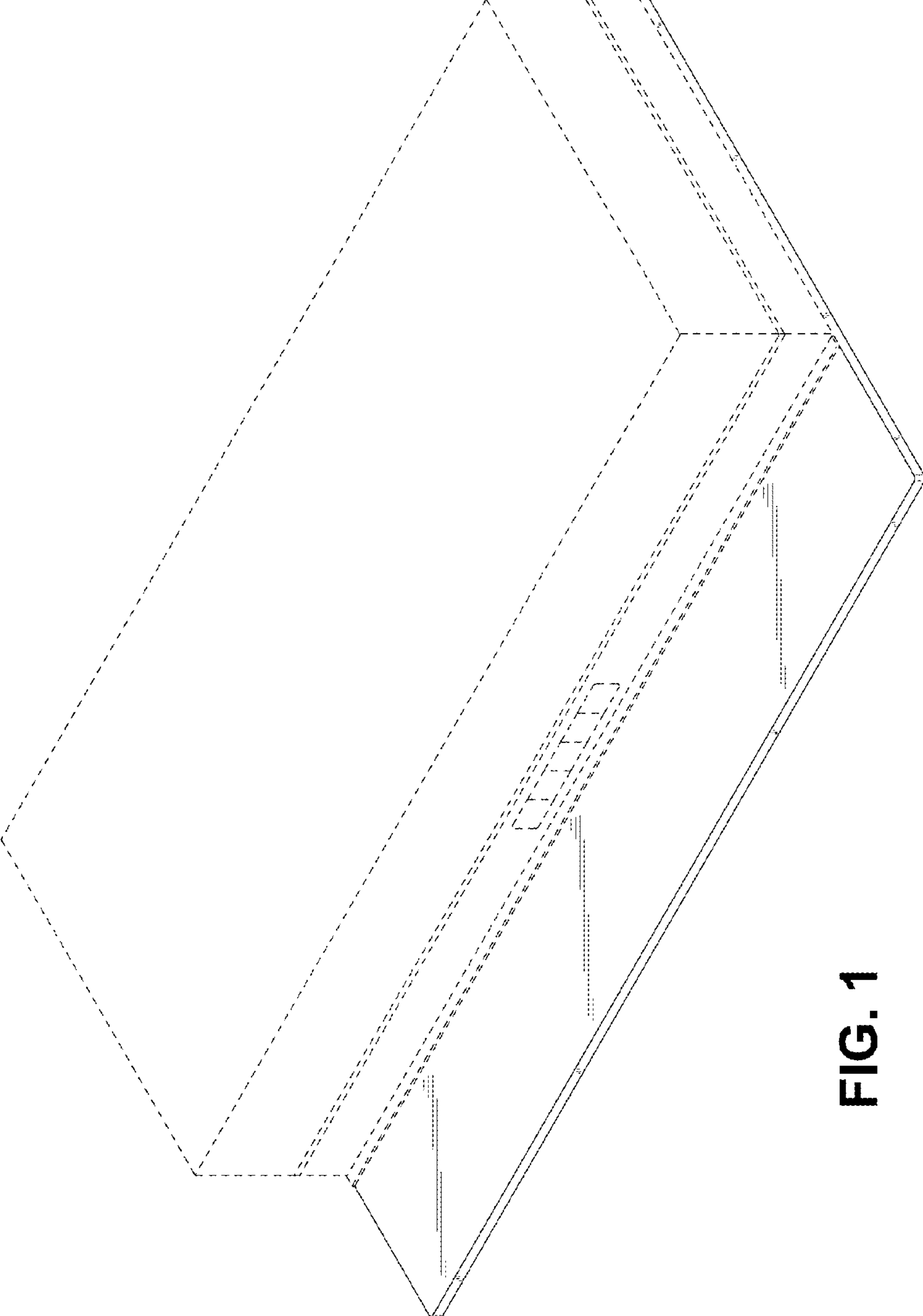

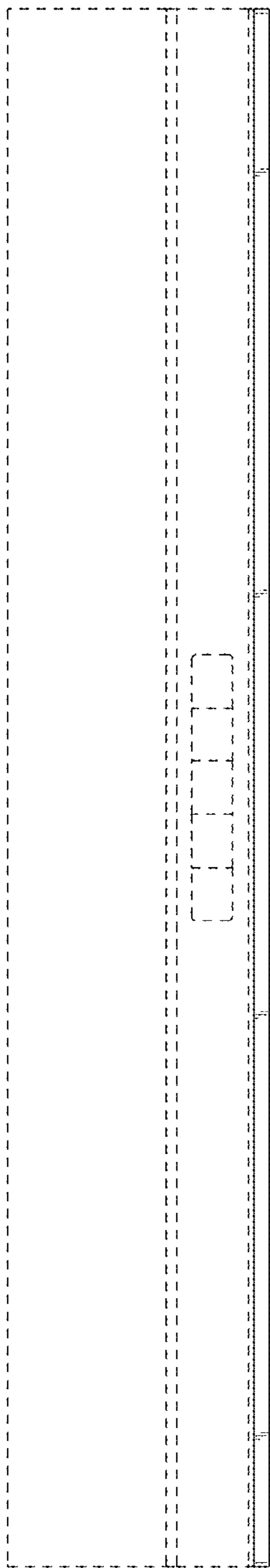

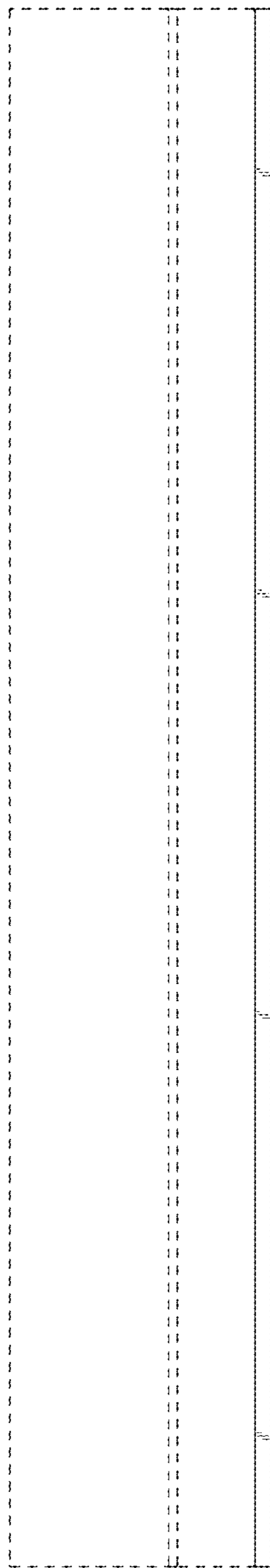

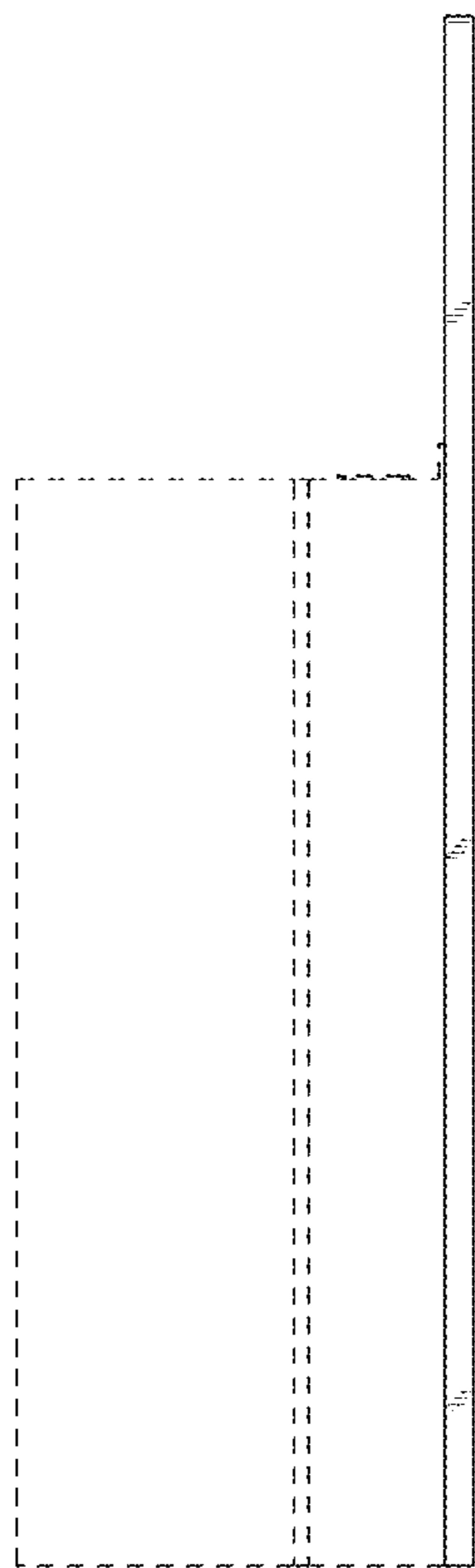

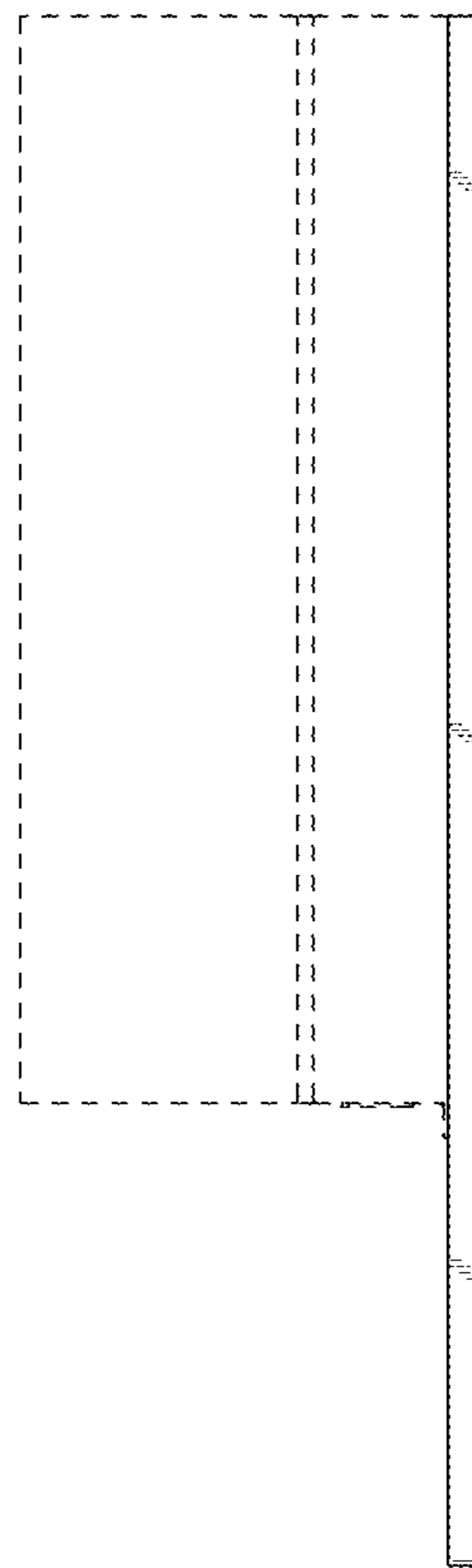

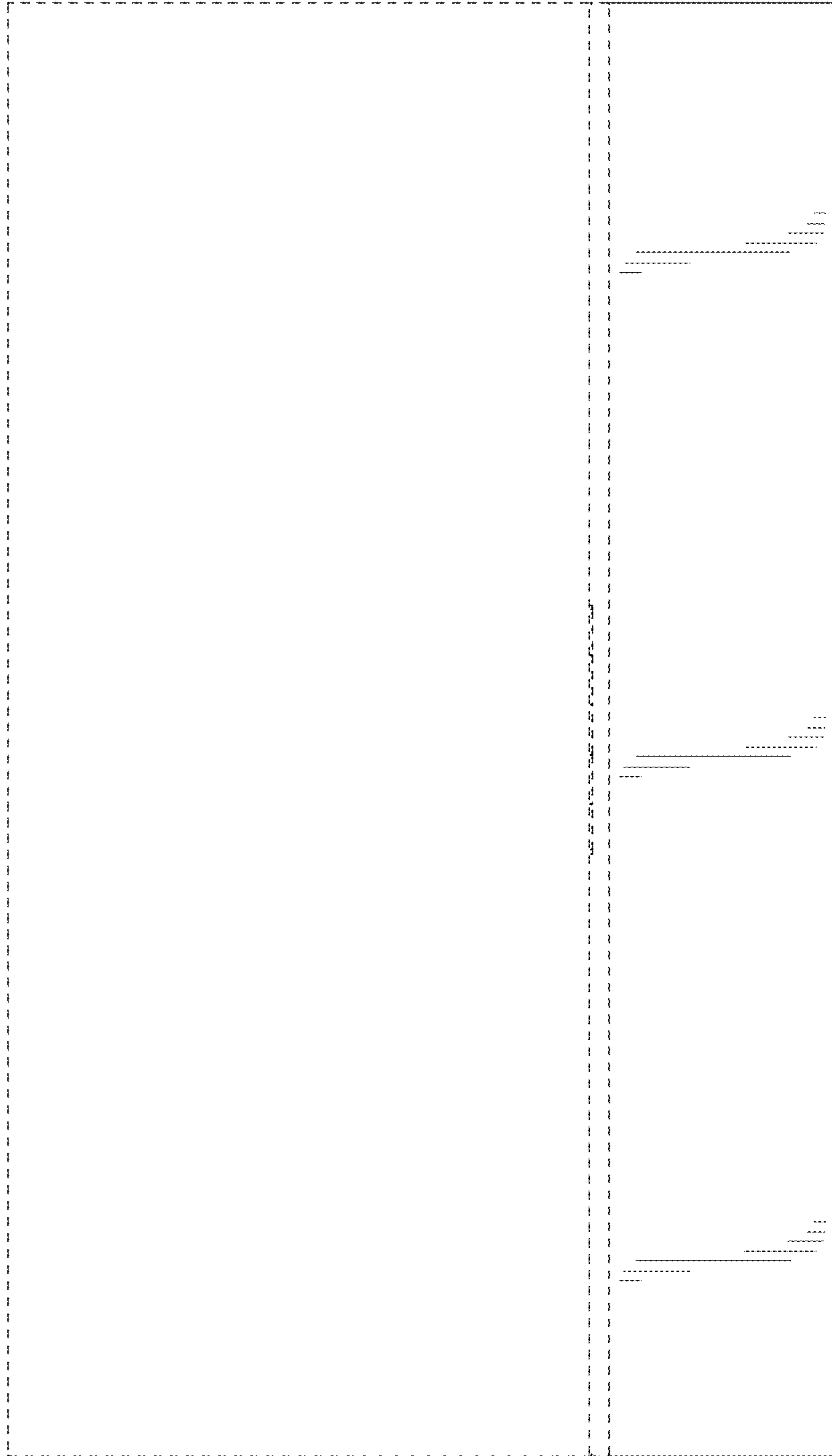

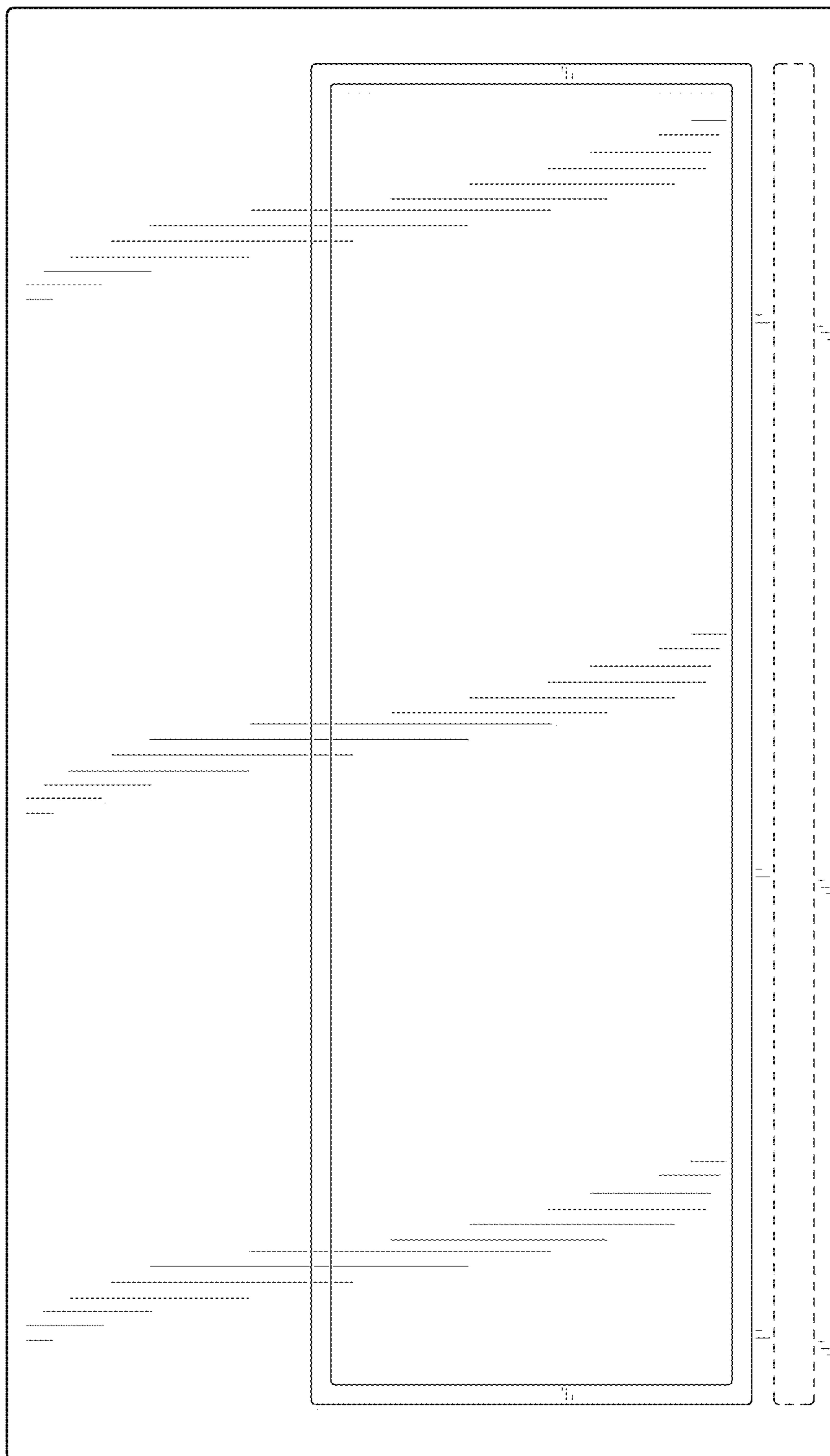
