(57) **CLAIM**

The ornamental design for a sanitary pad, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a sanitary pad showing our new design.

FIG. 2 is a top view thereof.

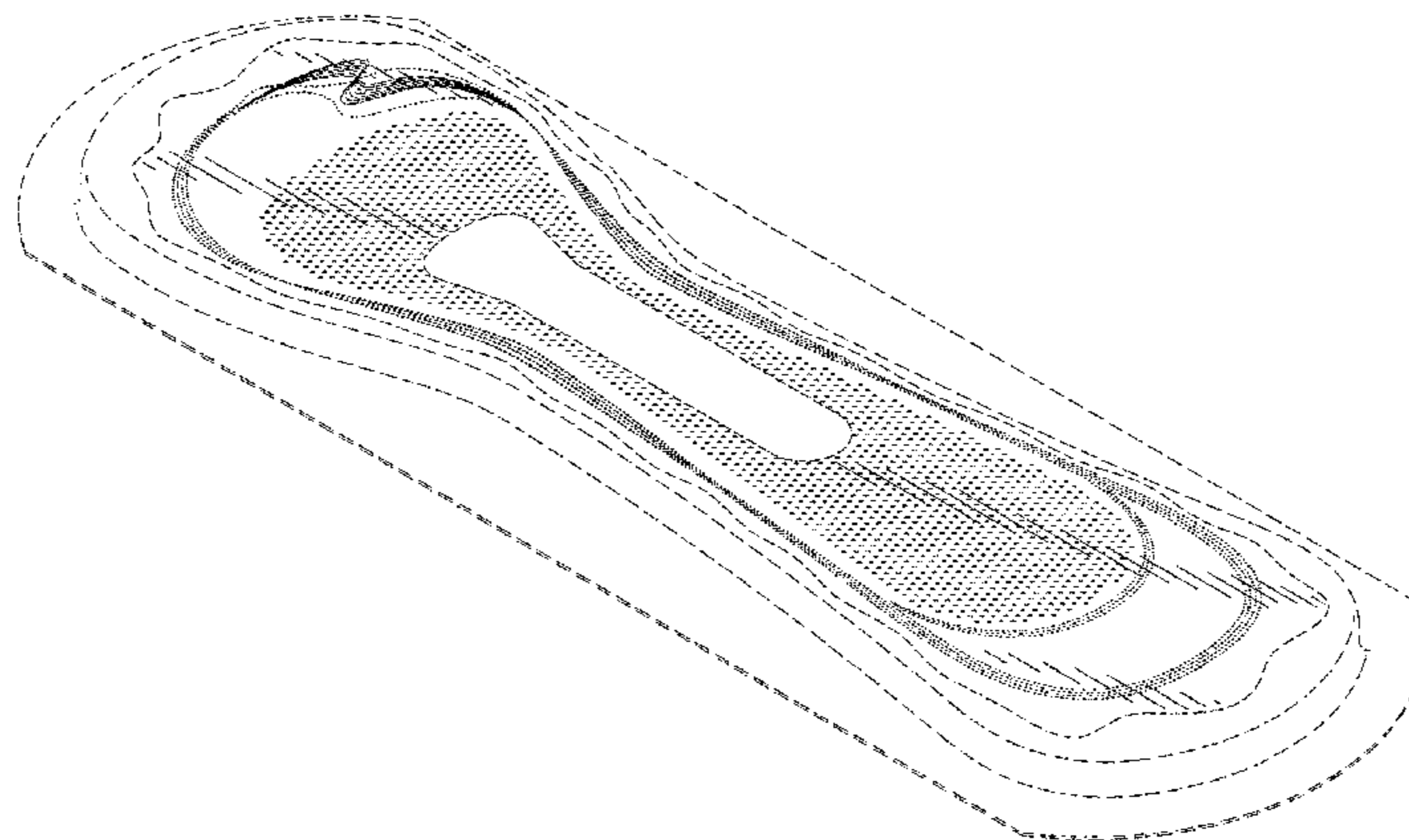
FIG. 3 is a left side view thereof, the right side being a mirror image thereof.

FIG. 4 is a front elevational view thereof; and,

FIG. 5 is a rear elevational view thereof.

The broken lines in FIGS. 1-5, the portion inside the broken lines shown in the center of FIGS. 1-2, and the portions outside the broken lines of FIGS. 1-2 that are not in the center of the sanitary pad illustrate portions of the sanitary pad that form no part of the claimed design.

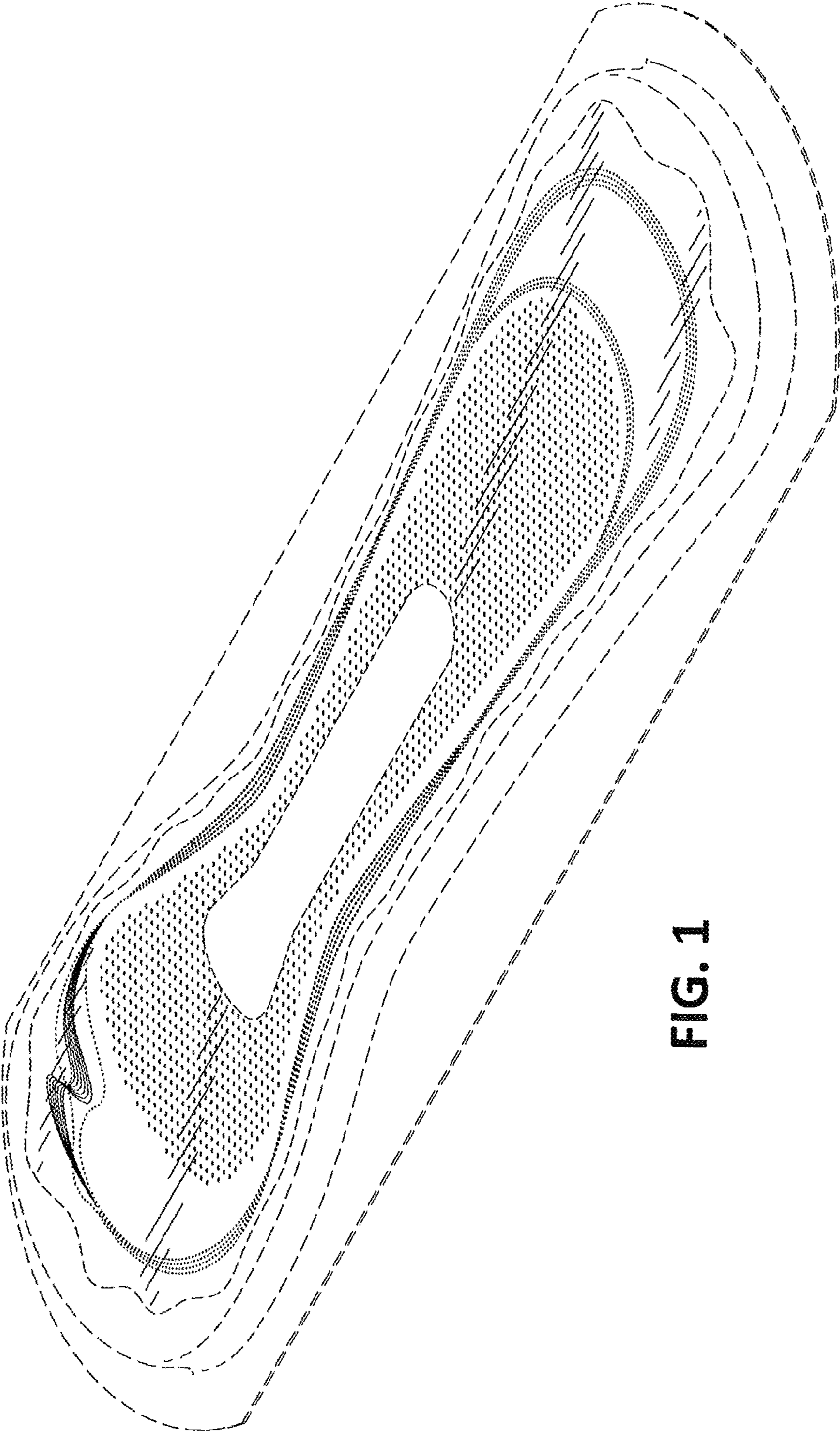

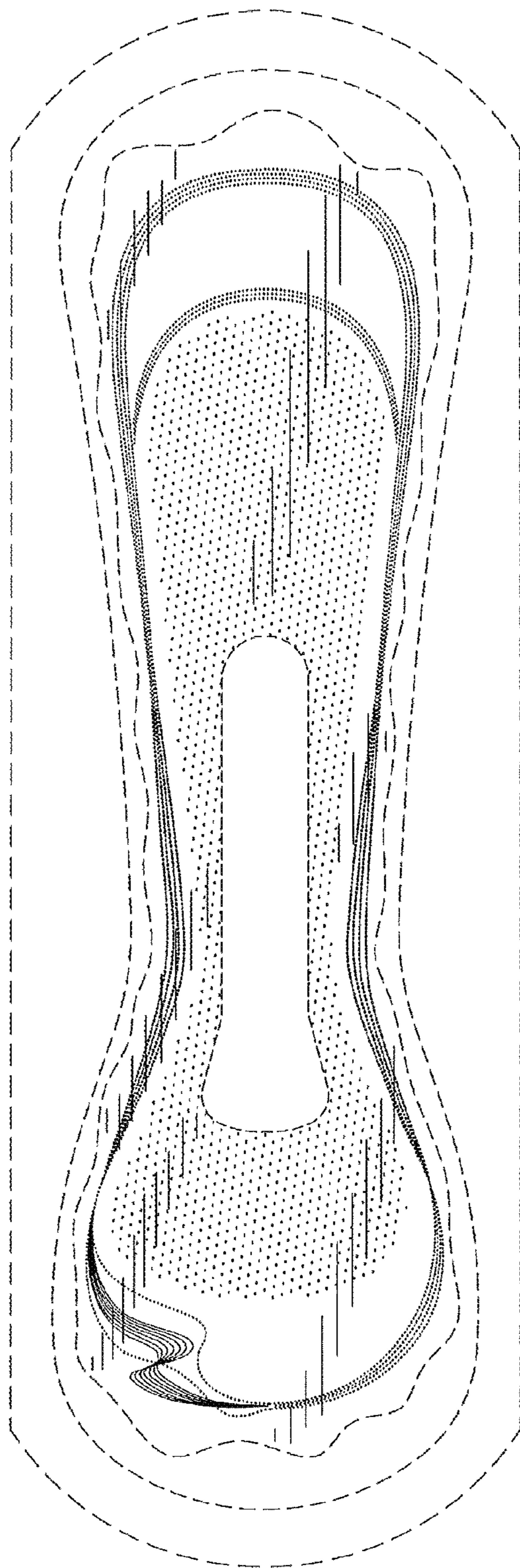
