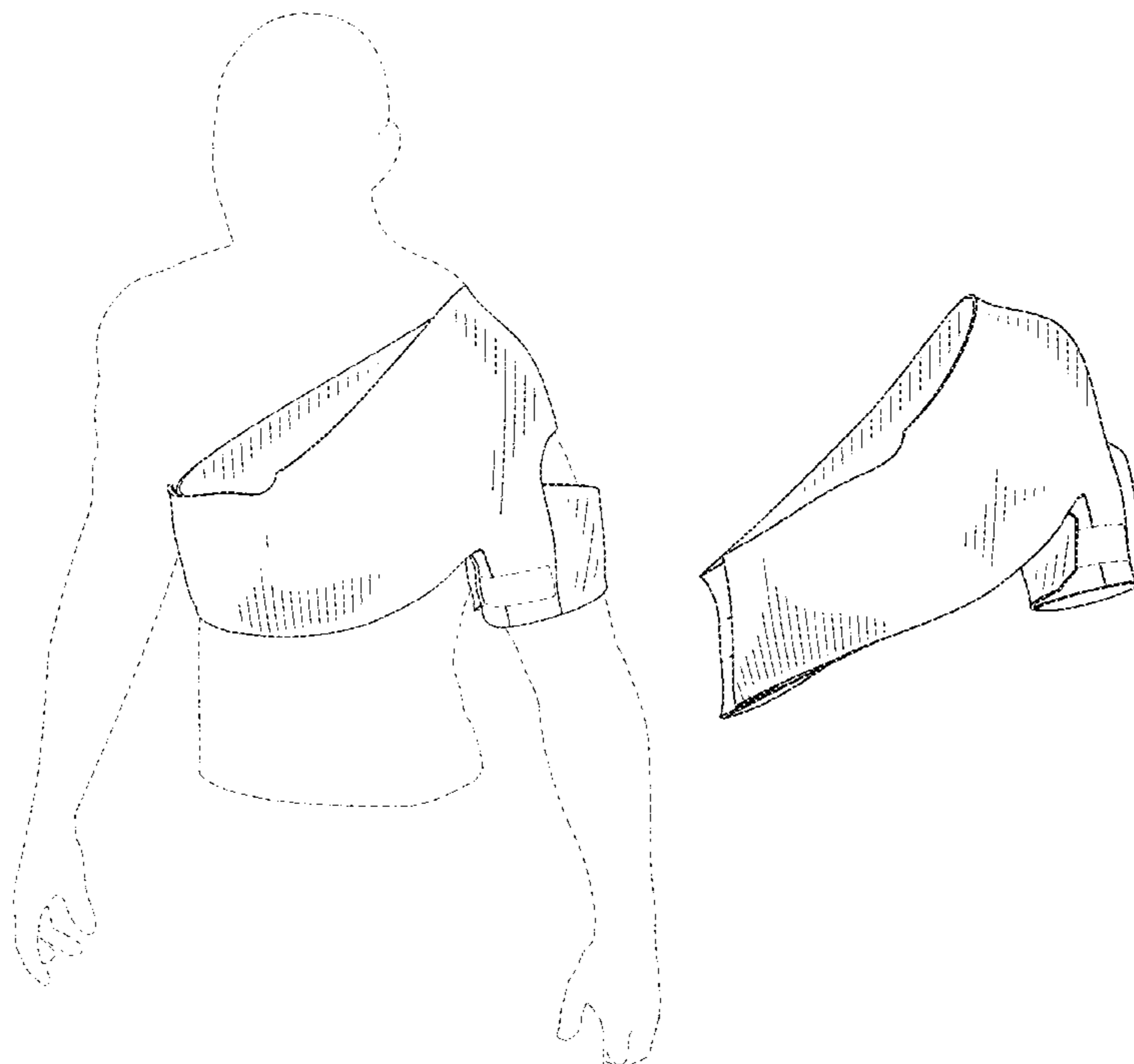
(57) **CLAIM**  
The ornamental design for a shoulder wrap, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective front view of a shoulder wrap, shown in use on an upper torso;  
FIG. 2 is a front view of the shoulder wrap;  
FIG. 3 is a rear view of the shoulder wrap;  
FIG. 4 is a left view of the shoulder wrap;  
FIG. 5 is a right view of the shoulder wrap;  
FIG. 6 is a top plan view of the shoulder wrap; and,  
FIG. 7 is a bottom plan view of the shoulder wrap.  
The upper torso of a human and the rectangular fasteners are shown in broken lines for the purpose of illustrating environment that forms no part of the claim.

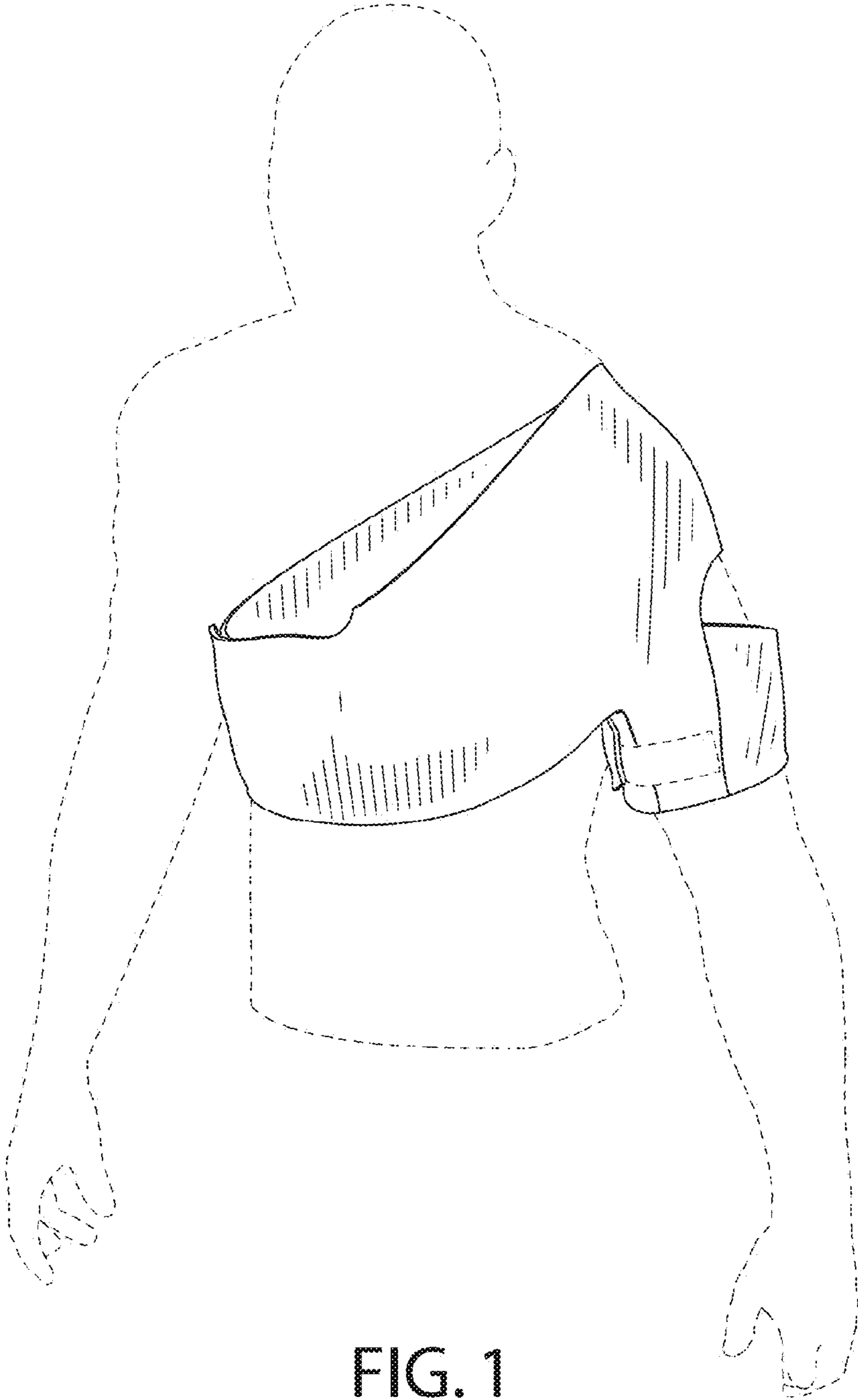

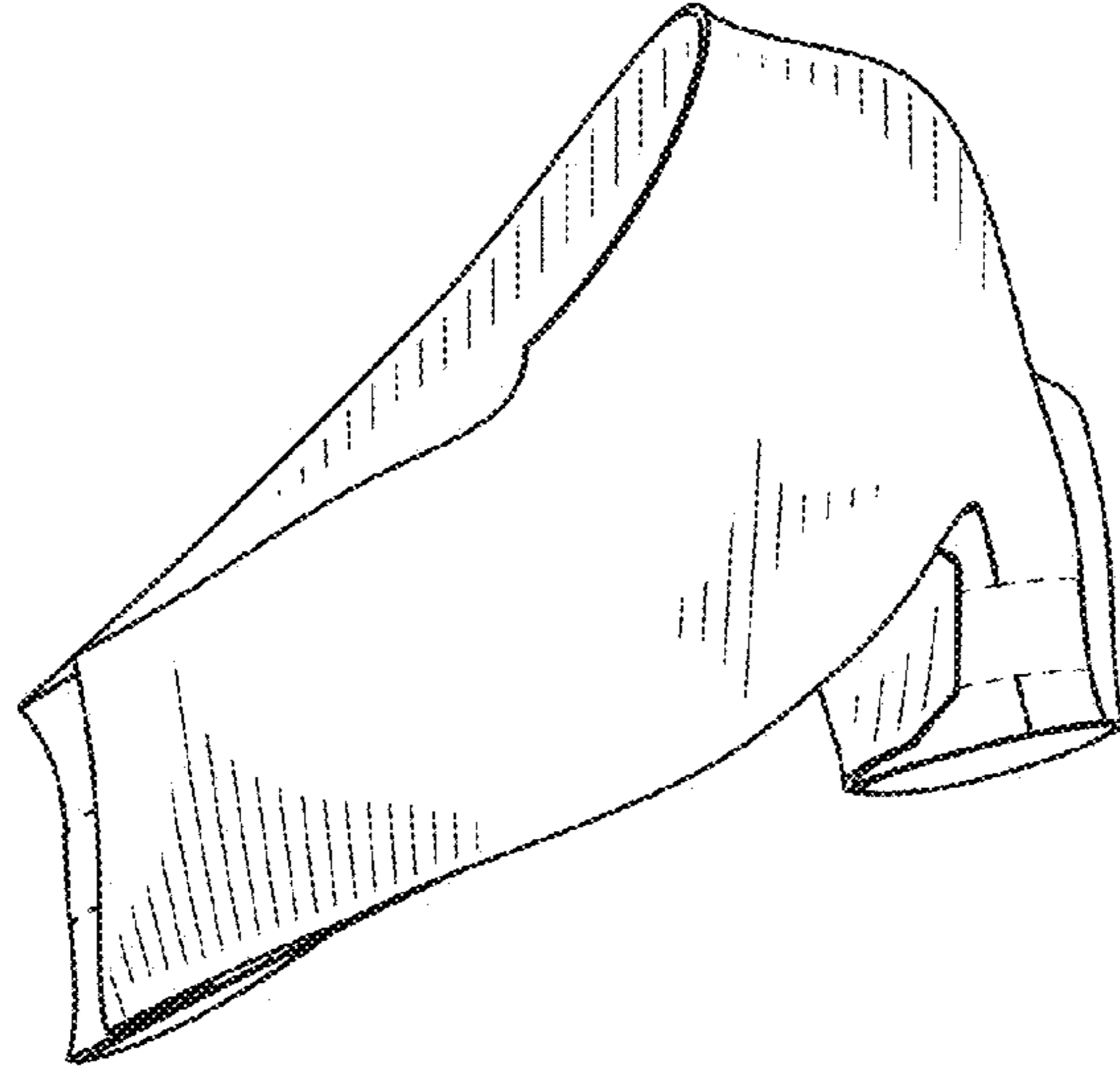

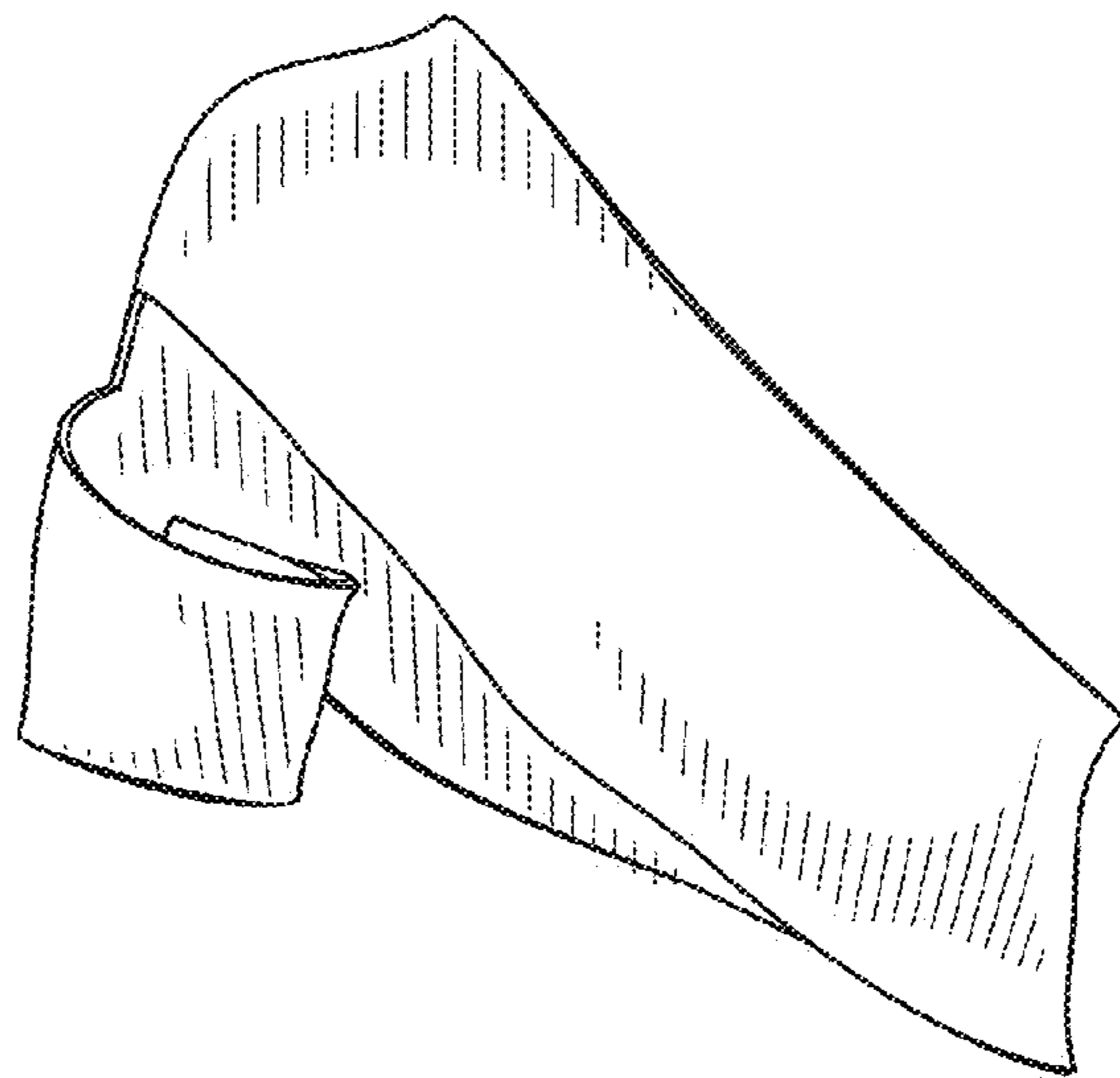

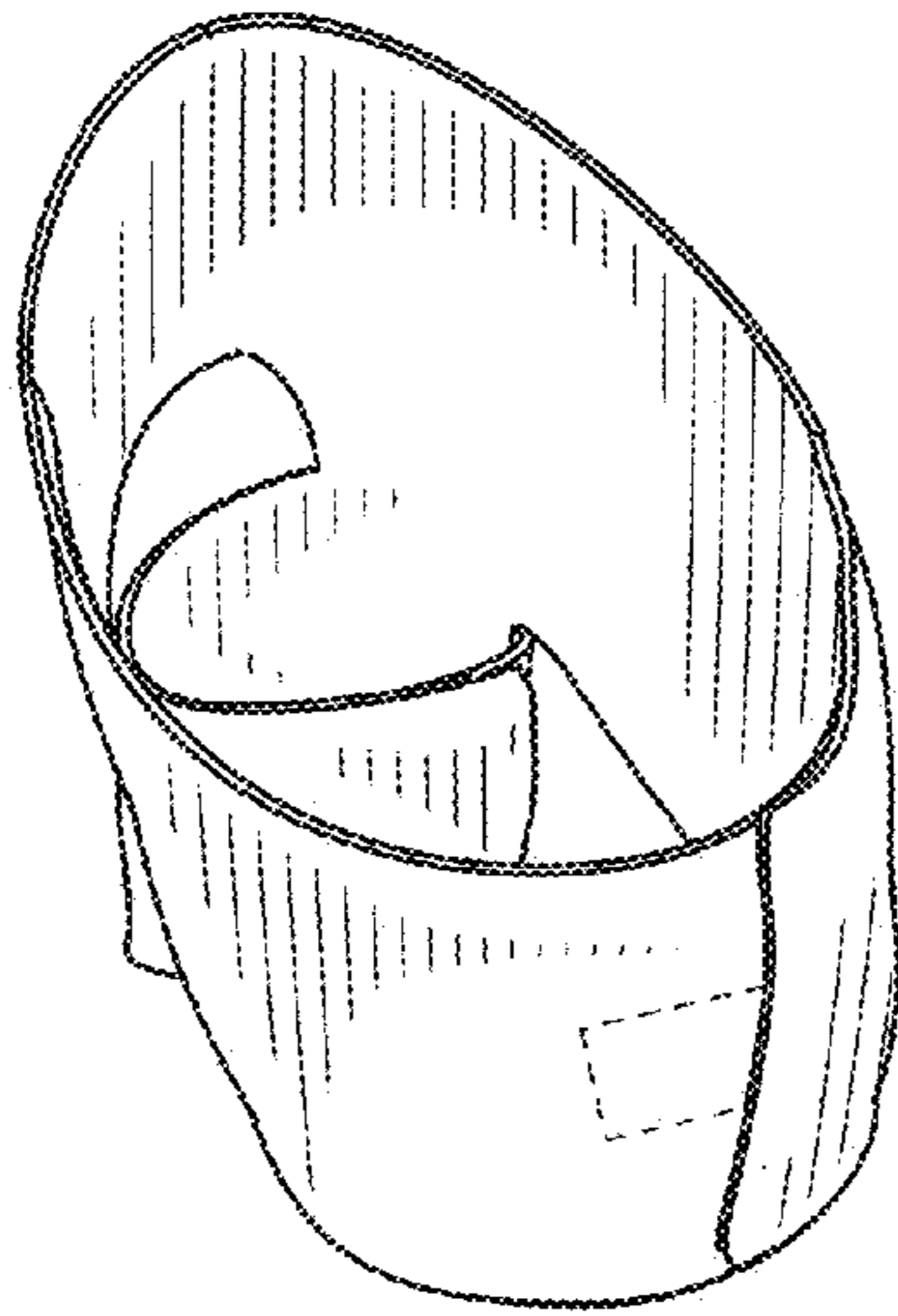

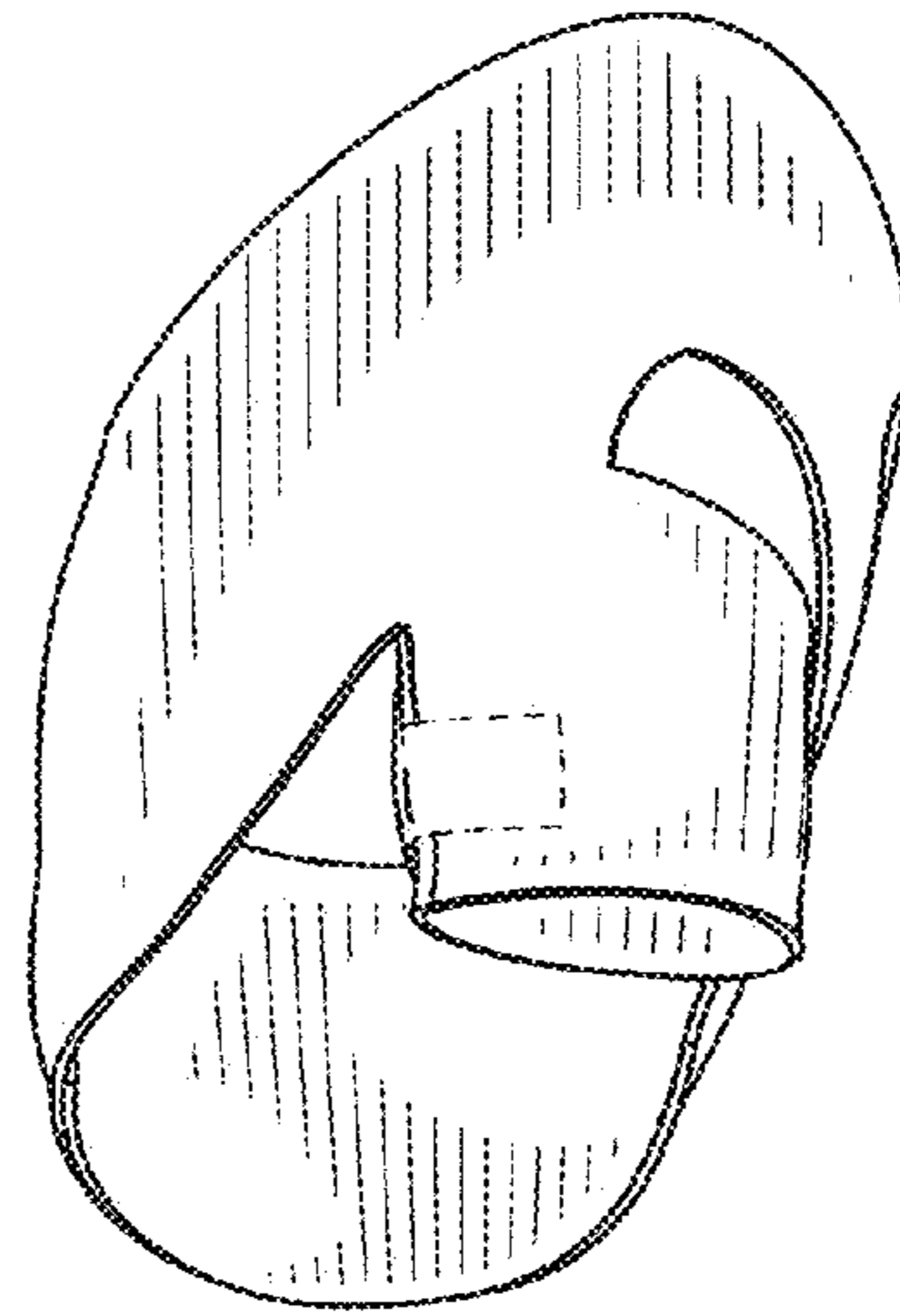

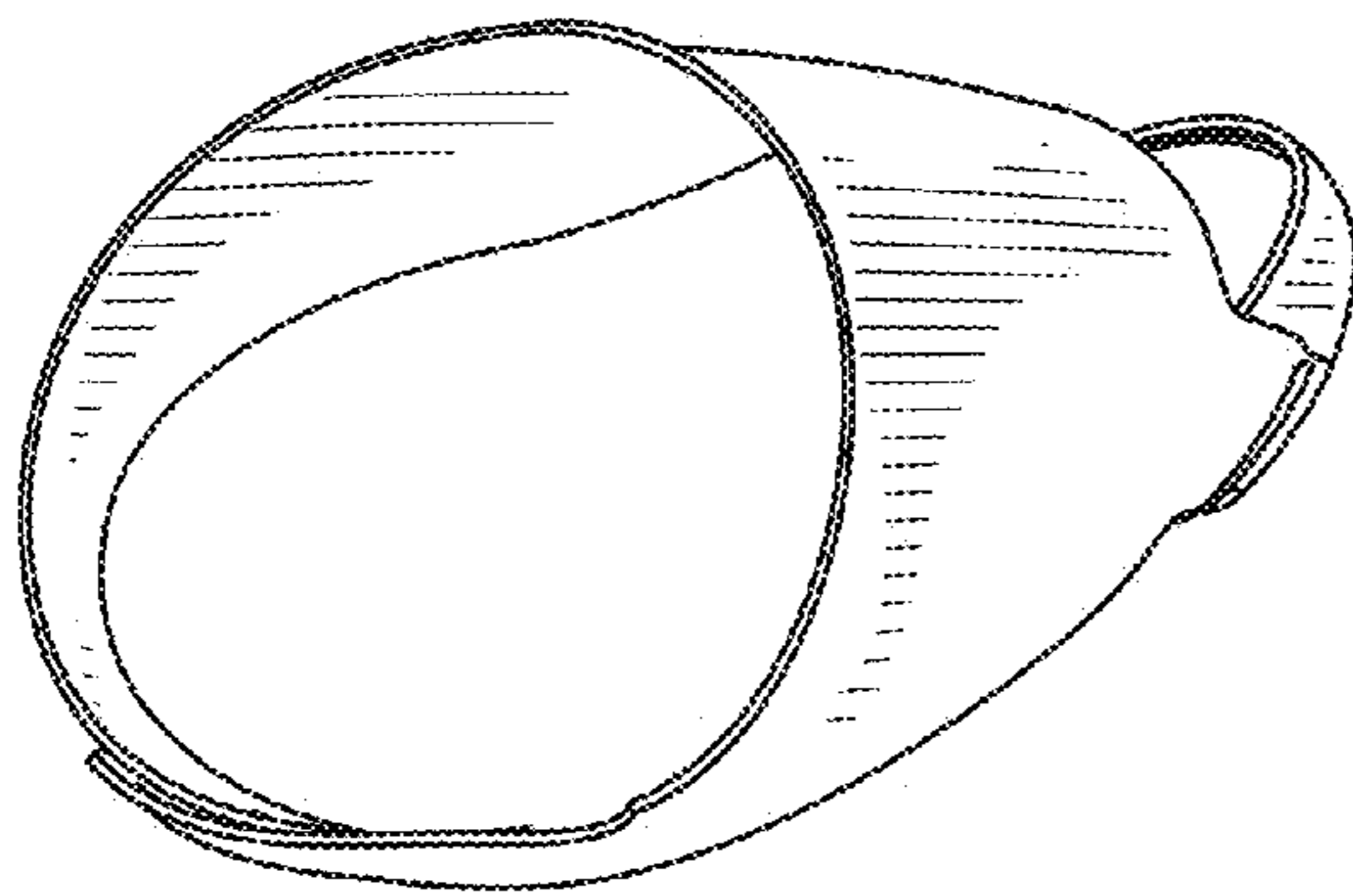

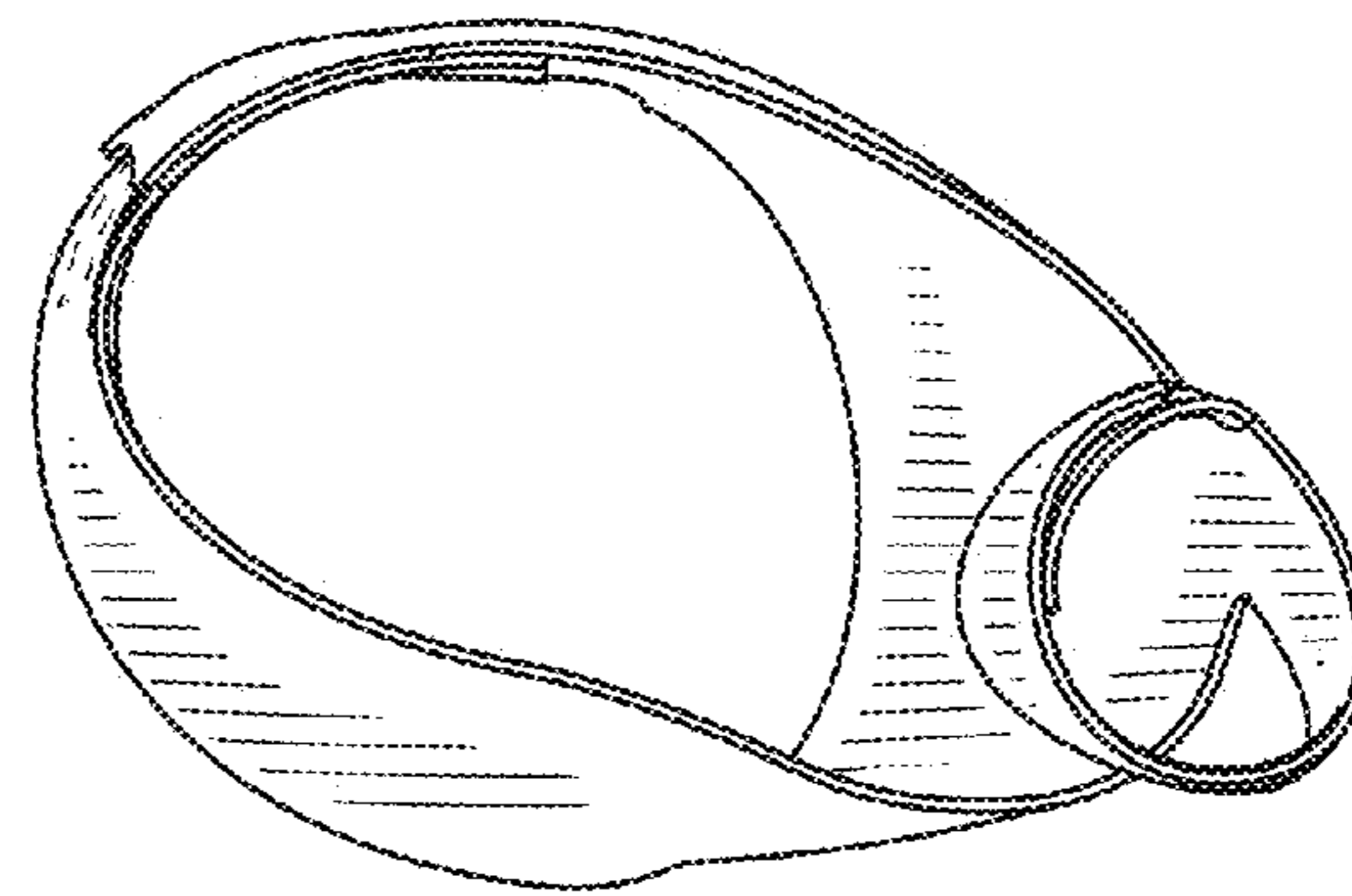
