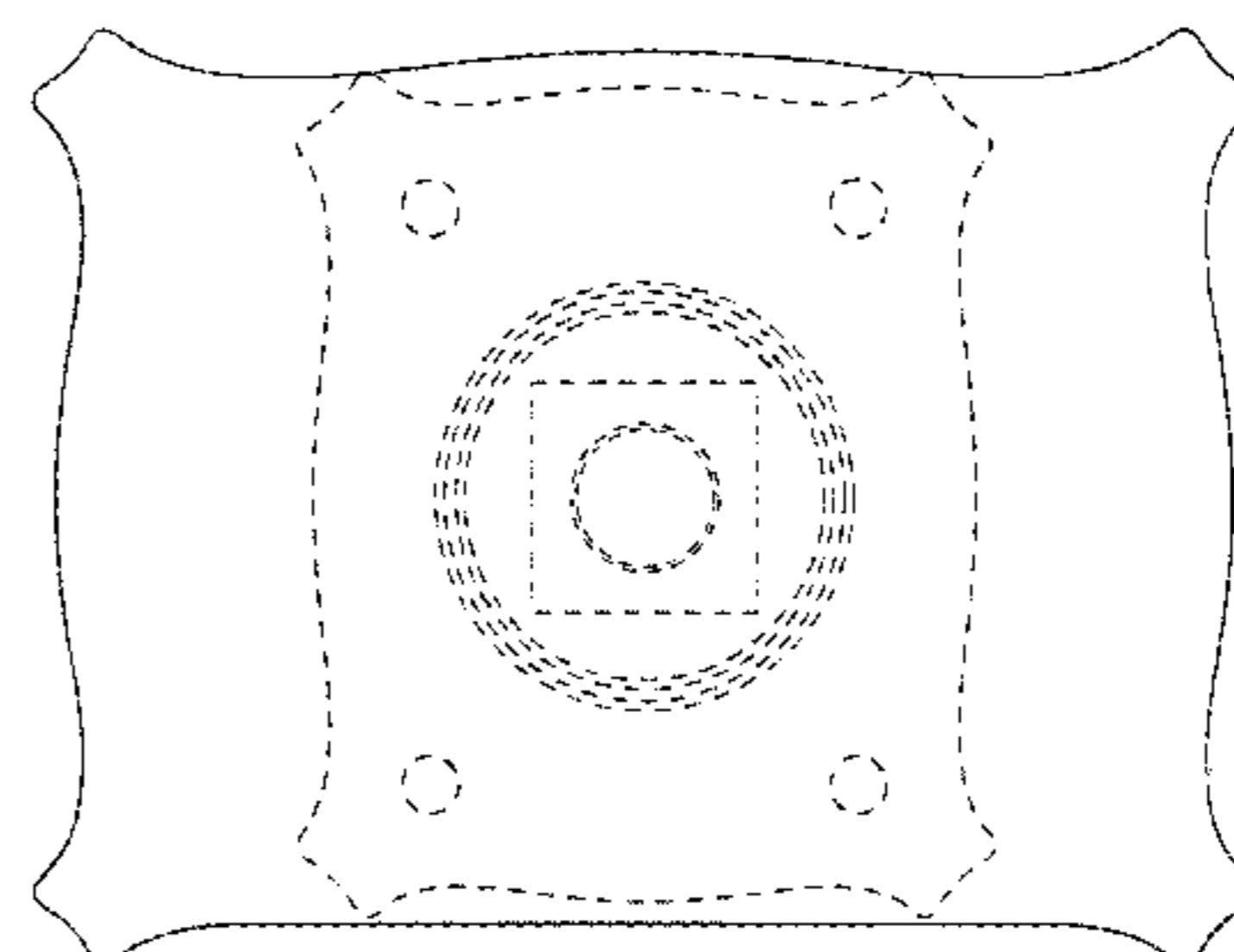
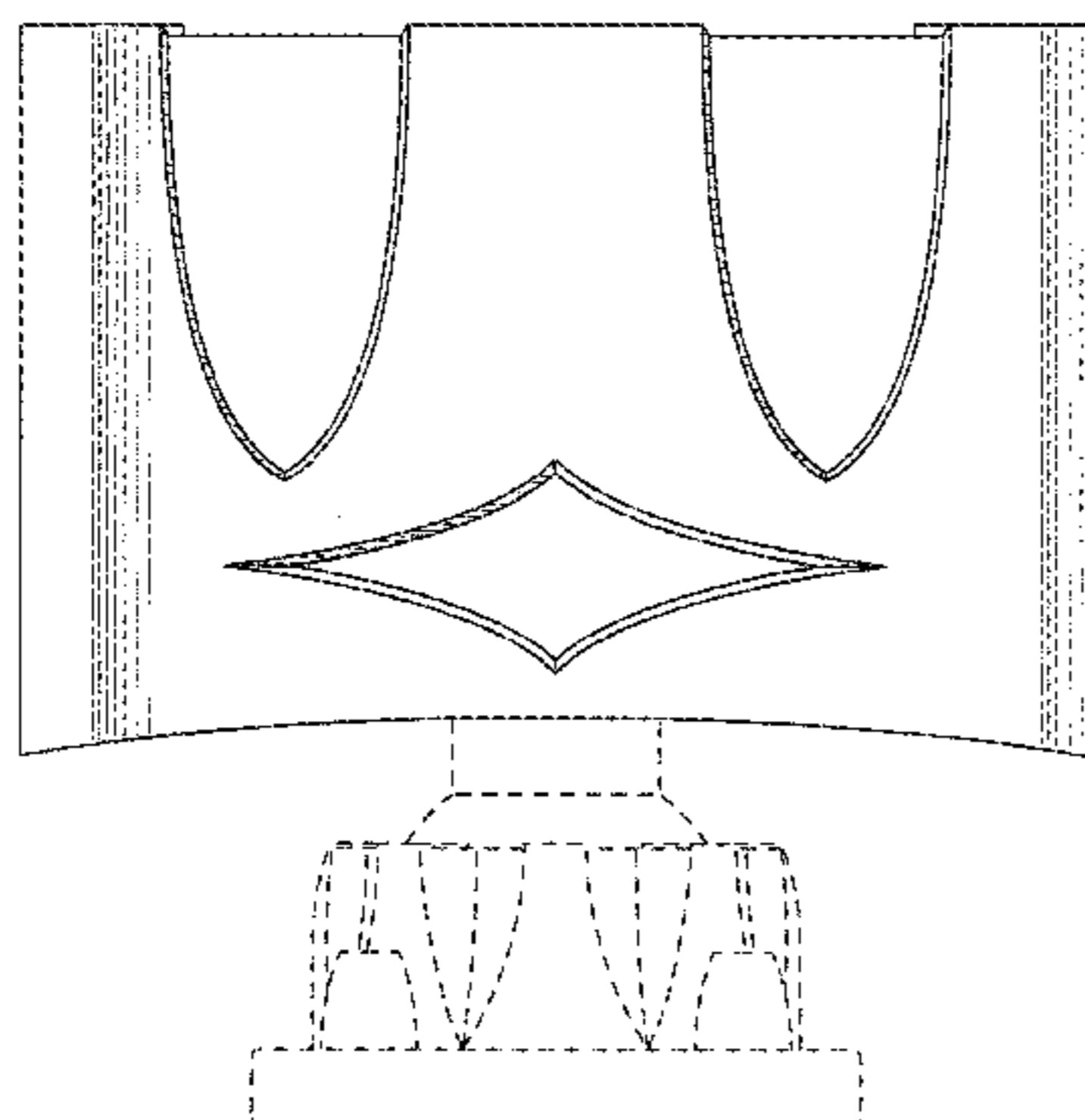
(57) **CLAIM**

I claim the ornamental design for a top rail end cup, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a top rail end cup showing my new design;
FIG. 2 is a rear elevational view of the top rail end cup of FIG. 1;
FIG. 3 is a top plan view of the top rail end cup of FIG. 1;
FIG. 4 is a bottom plan view of the top rail end cup of FIG. 1;
FIG. 5 is a right side elevational view of the top rail end cup of FIG. 1;
FIG. 6 is a left side elevational view of the top rail end cup of FIG. 1;
FIG. 7 is an exploded front elevational view of the top rail end cup of FIG. 1; and,
FIG. 8 is an exploded cross-sectional front elevational view of the top rail end cup of FIG. 1.

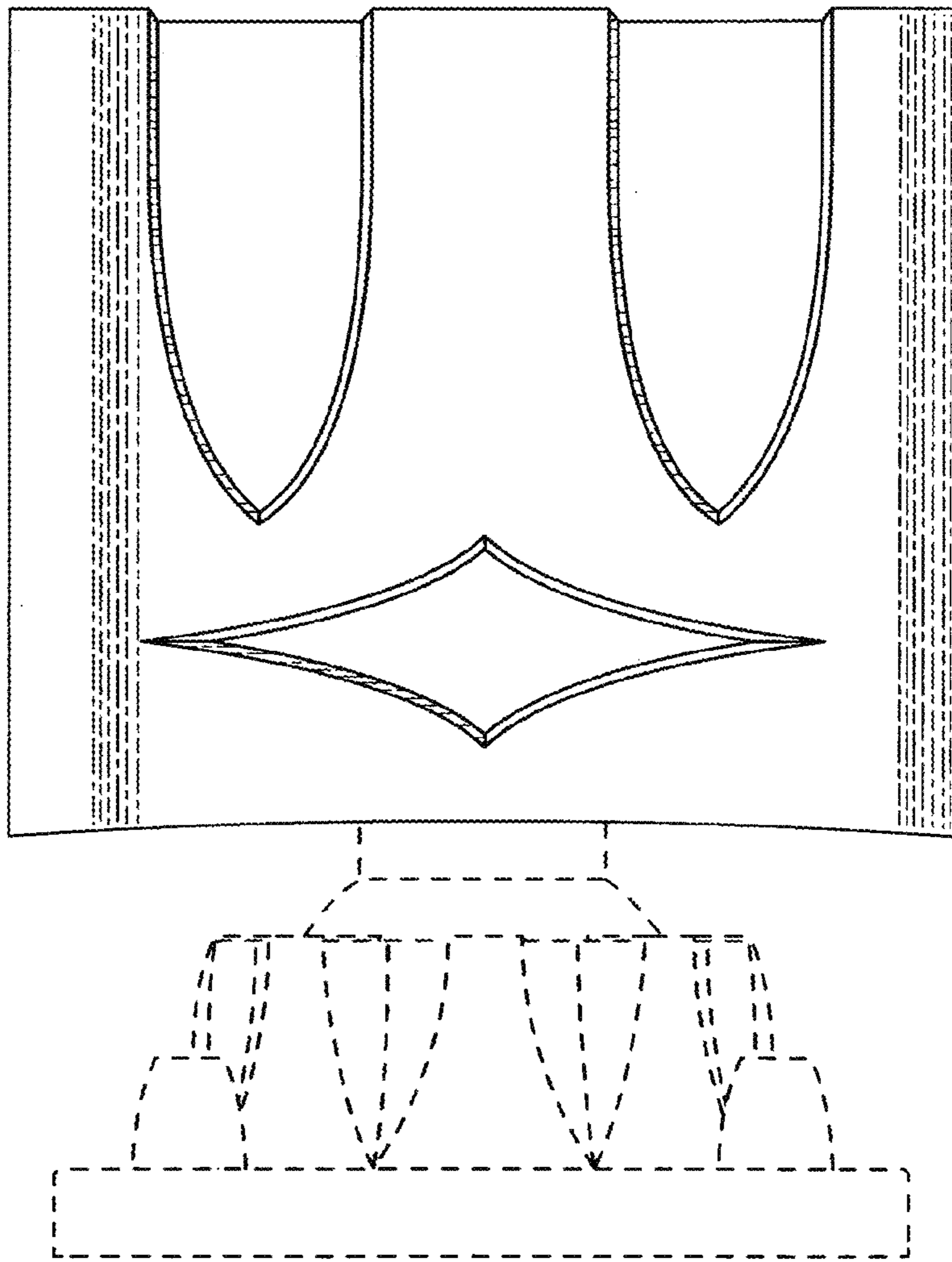

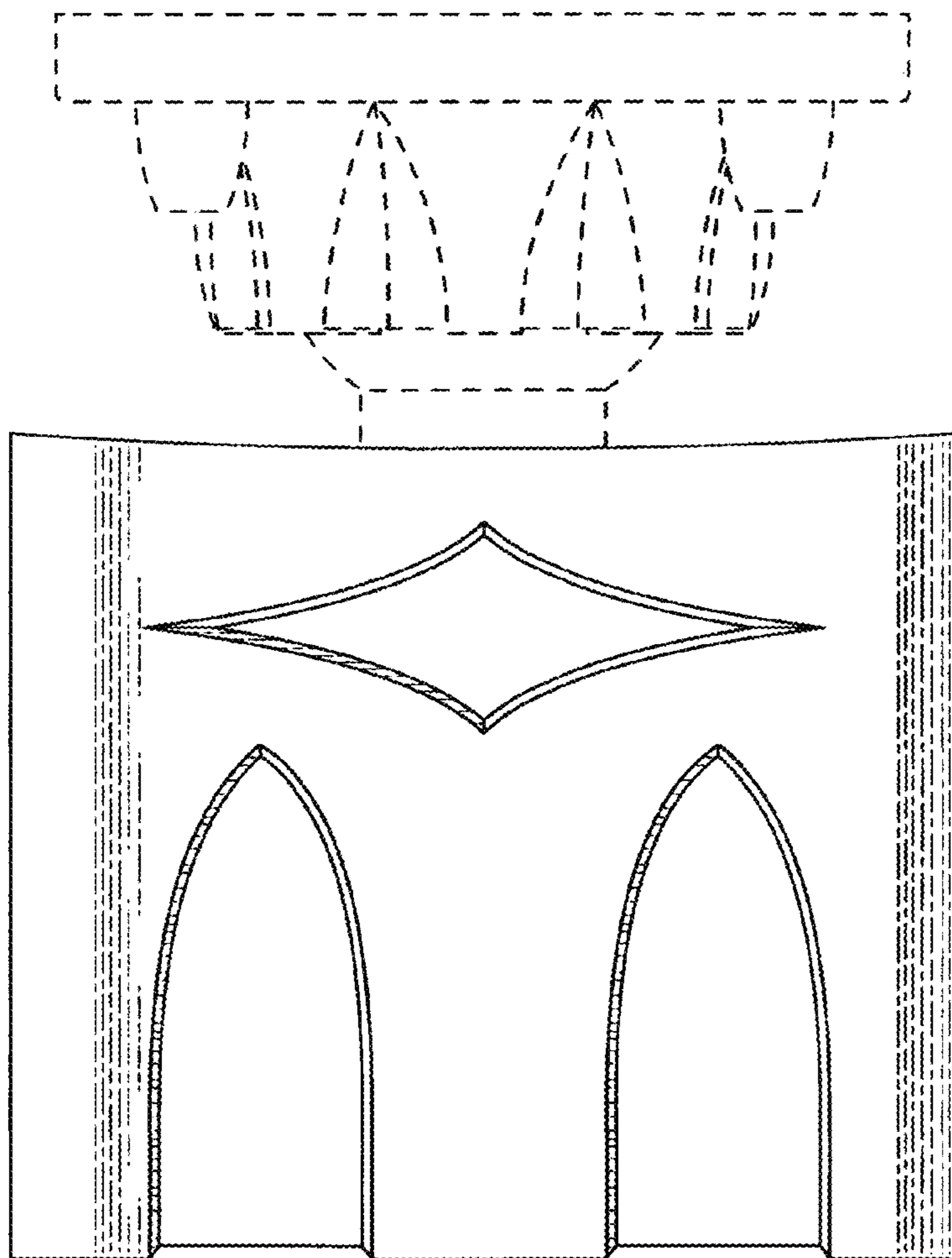

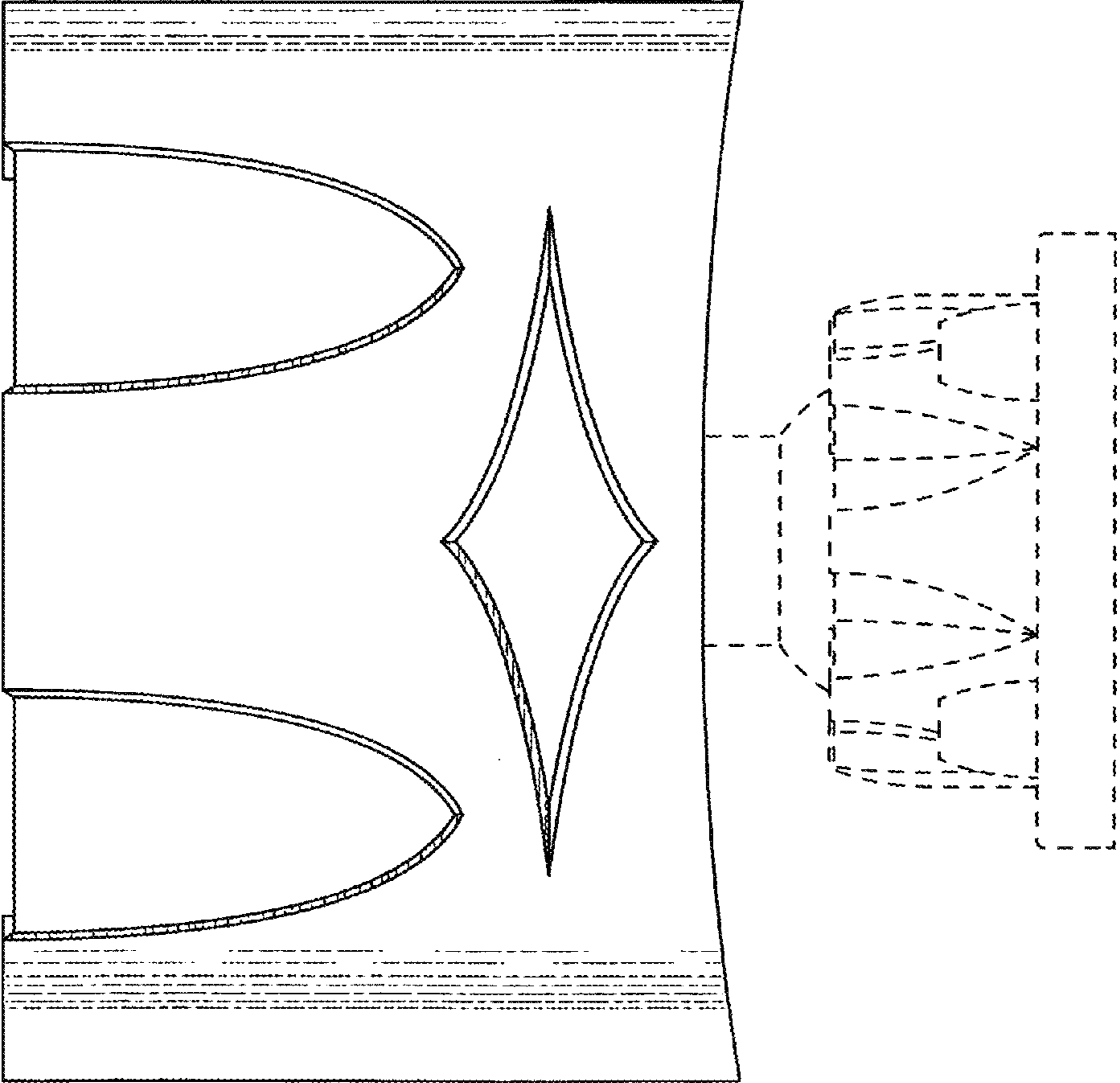

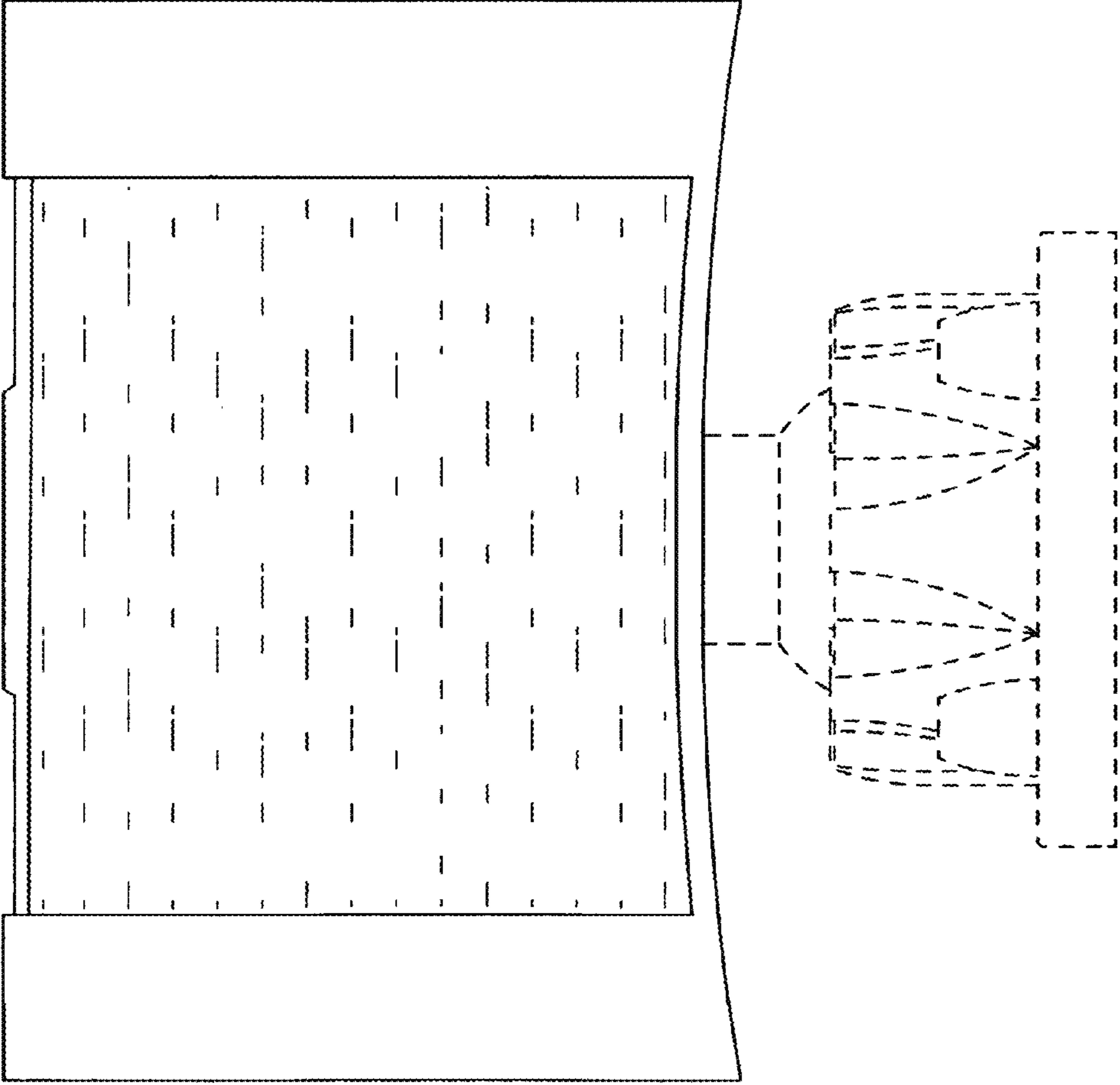

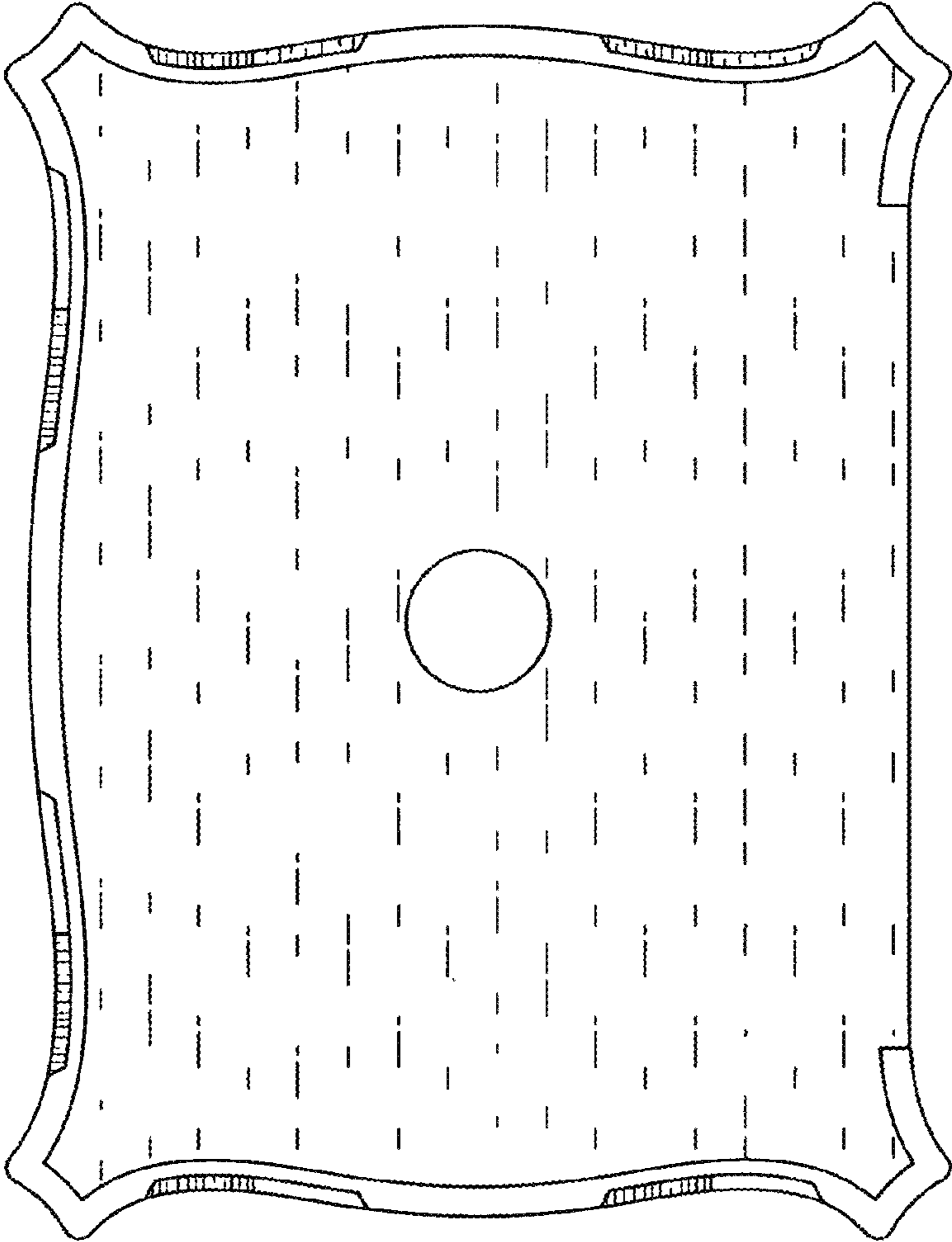

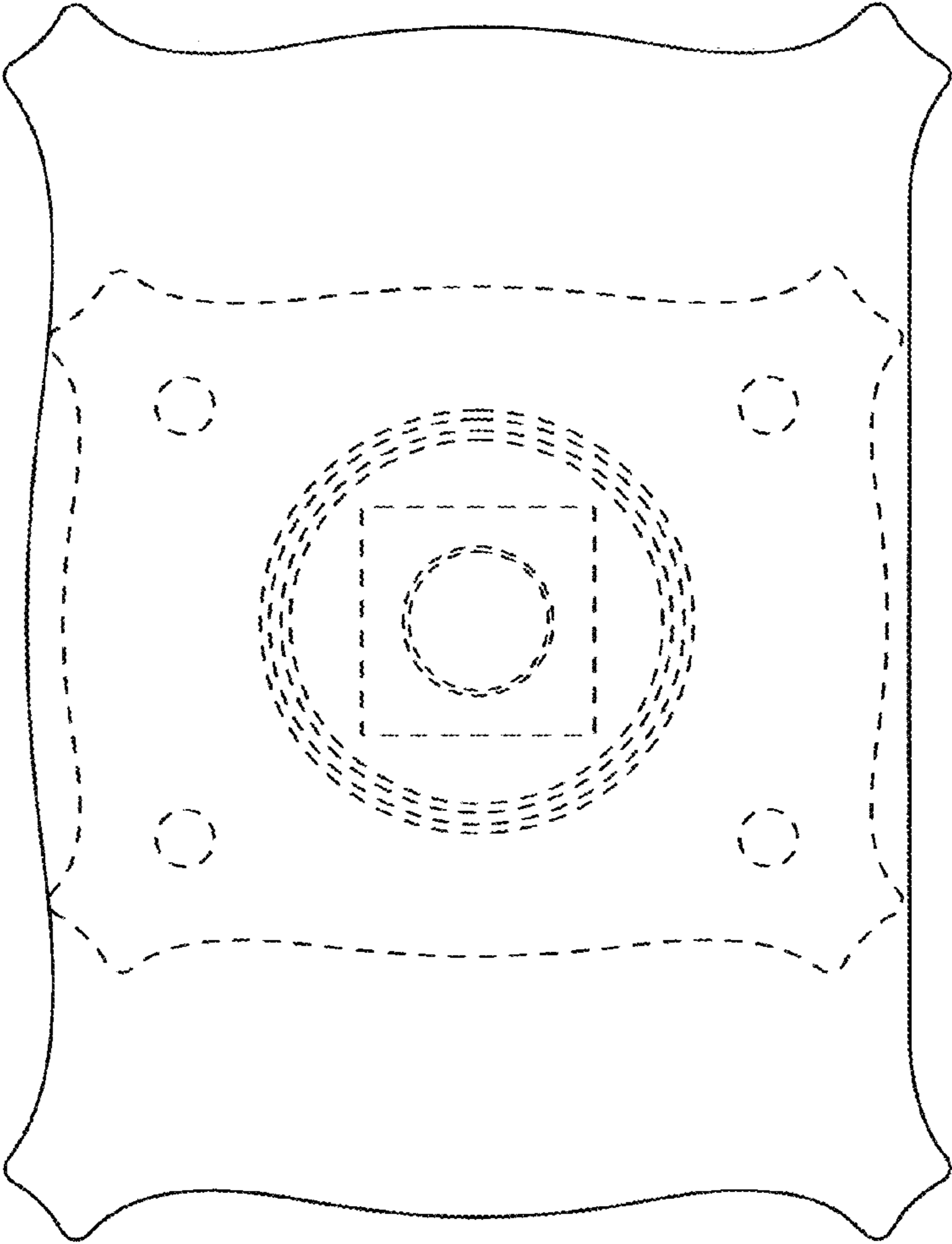

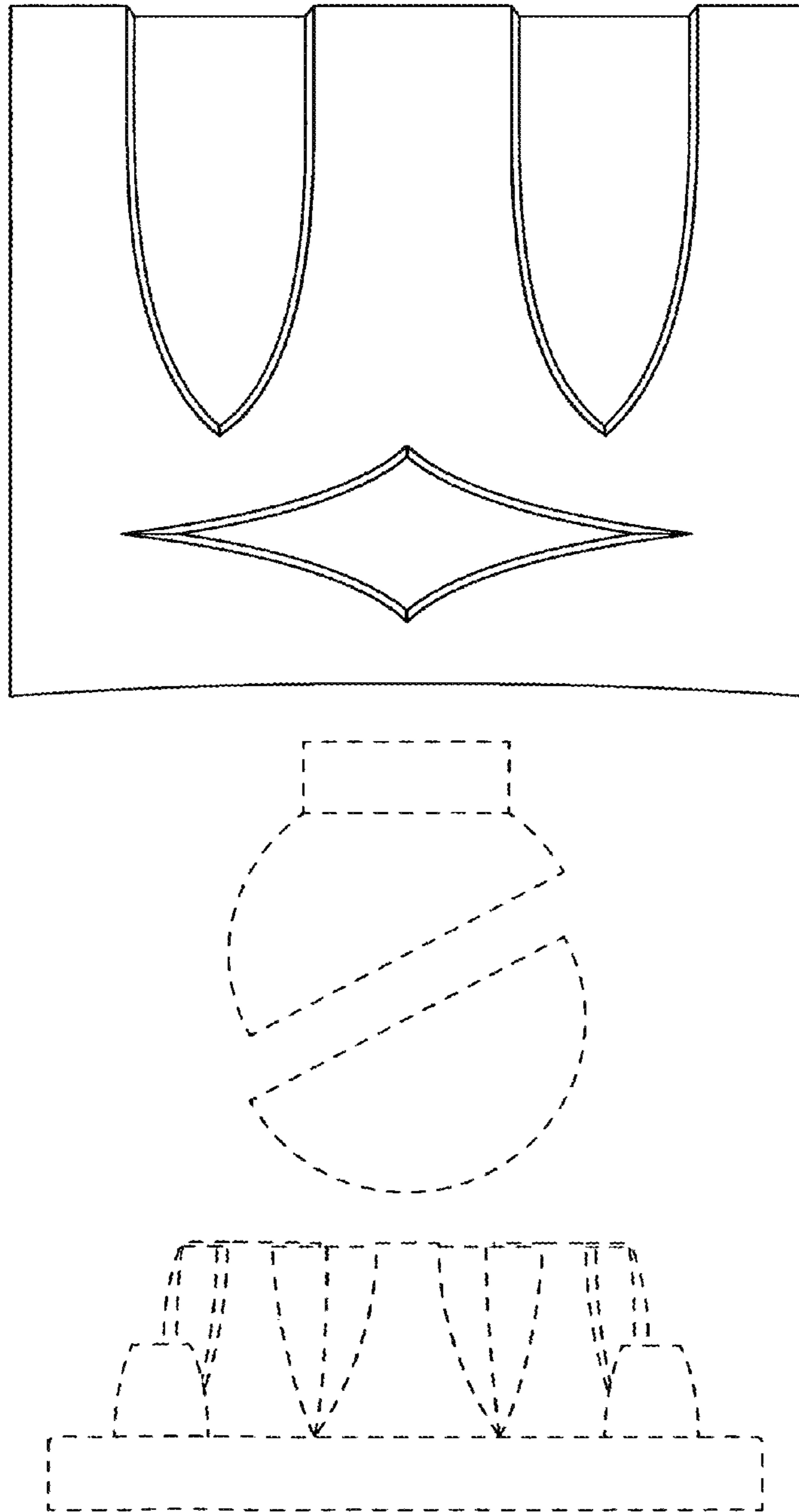

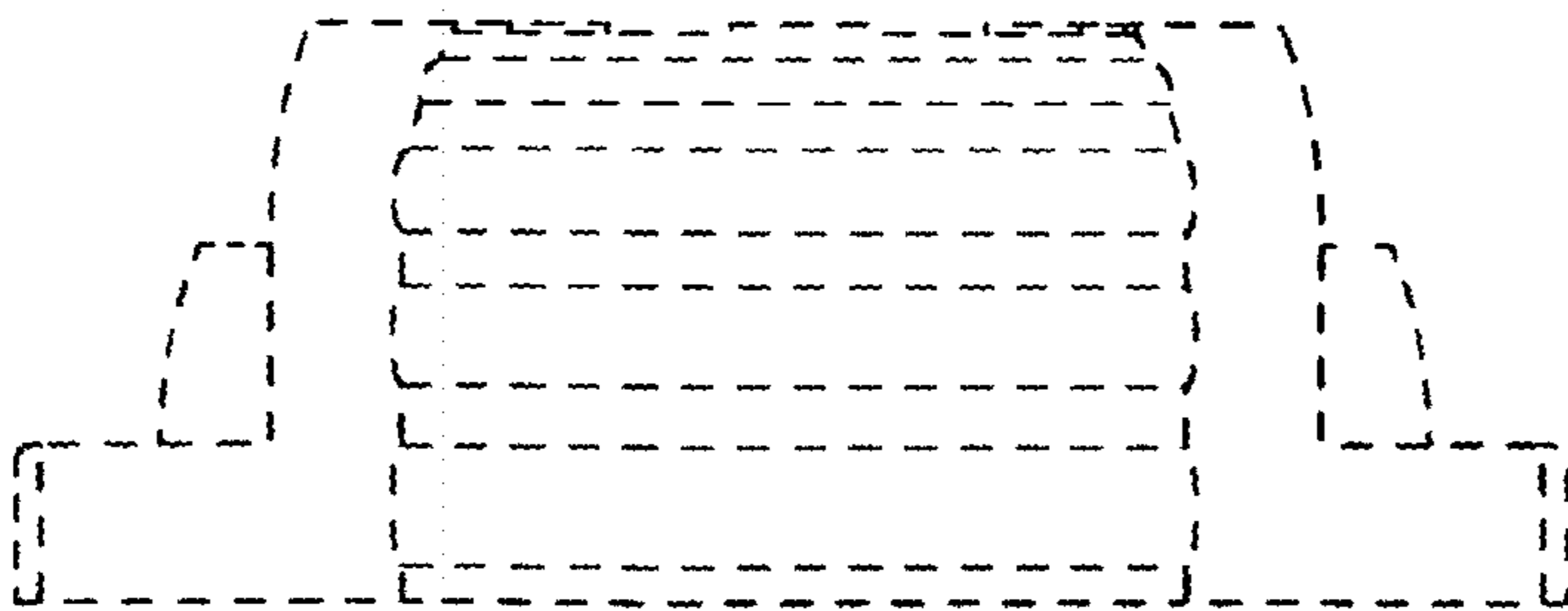
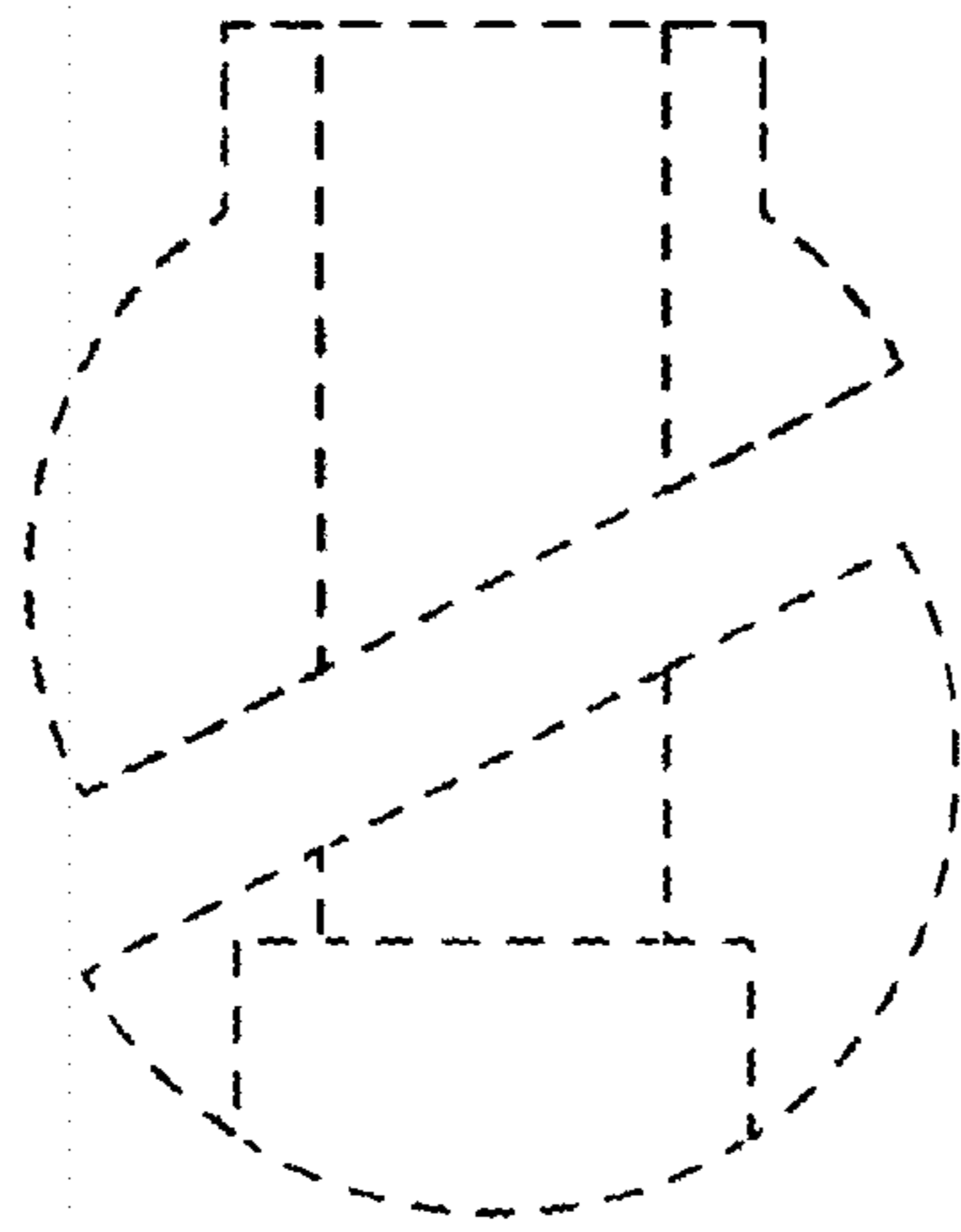
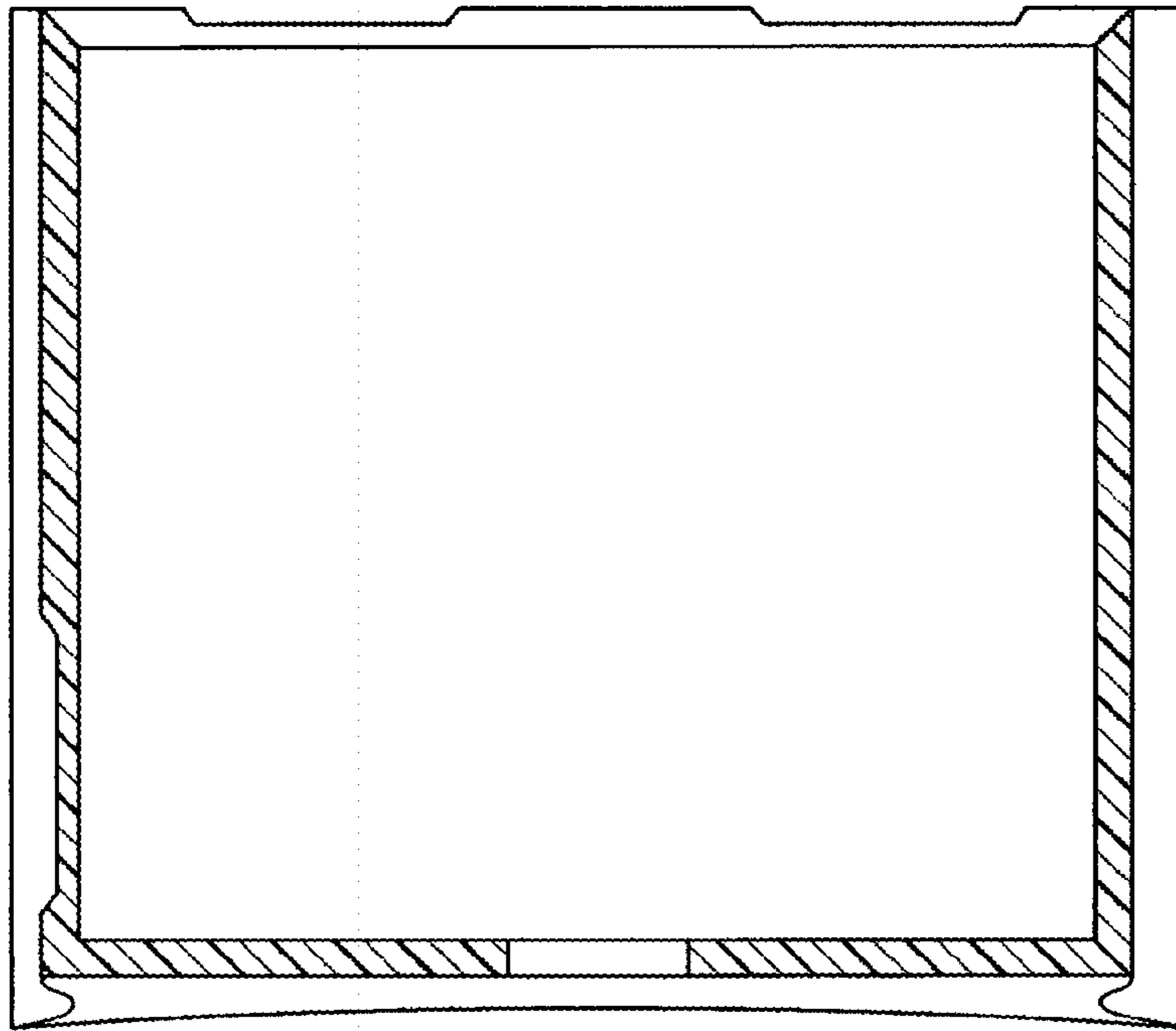
