The ornamental design for a vehicle rear taillamp, as shown and described.

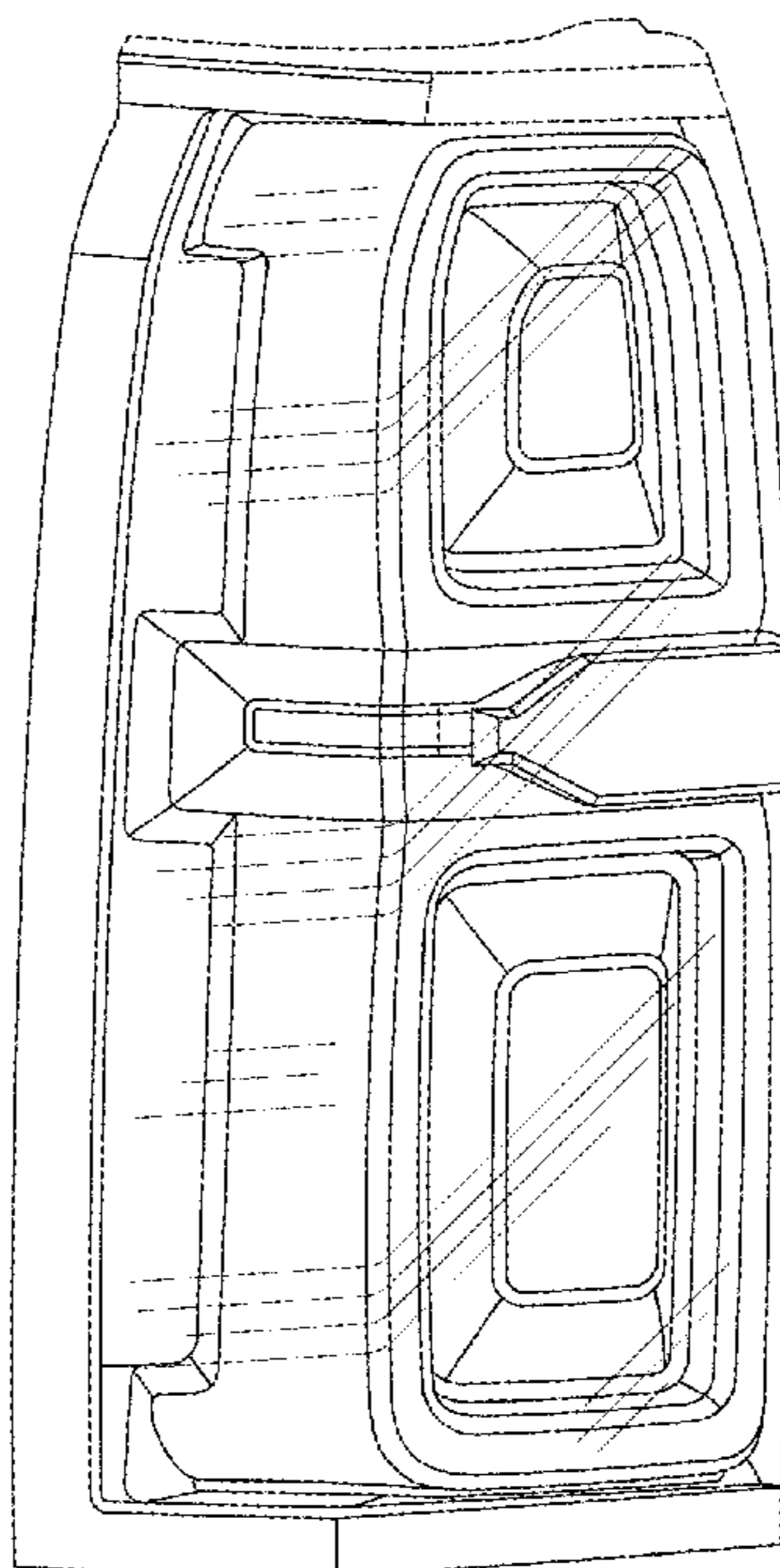

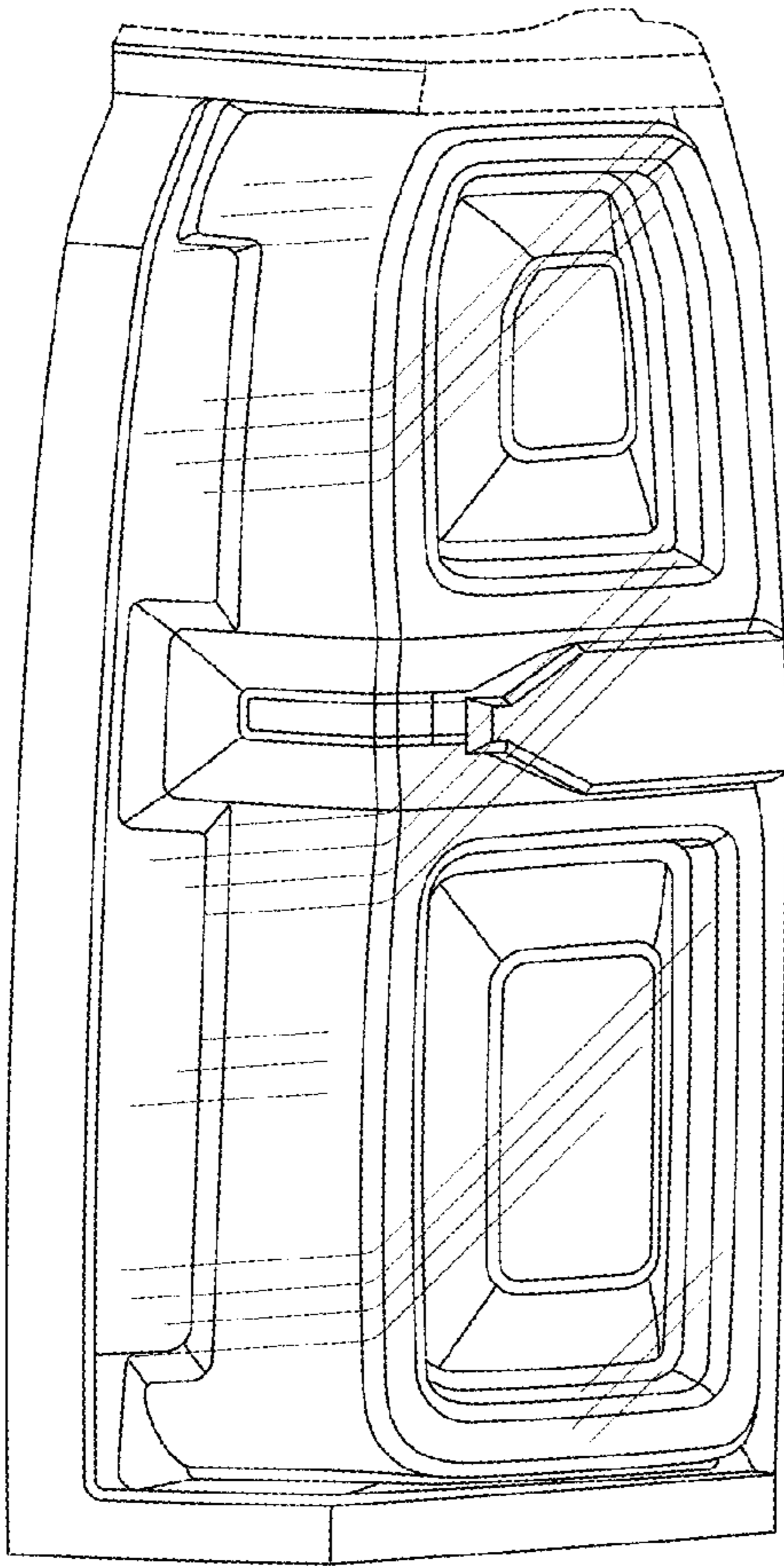

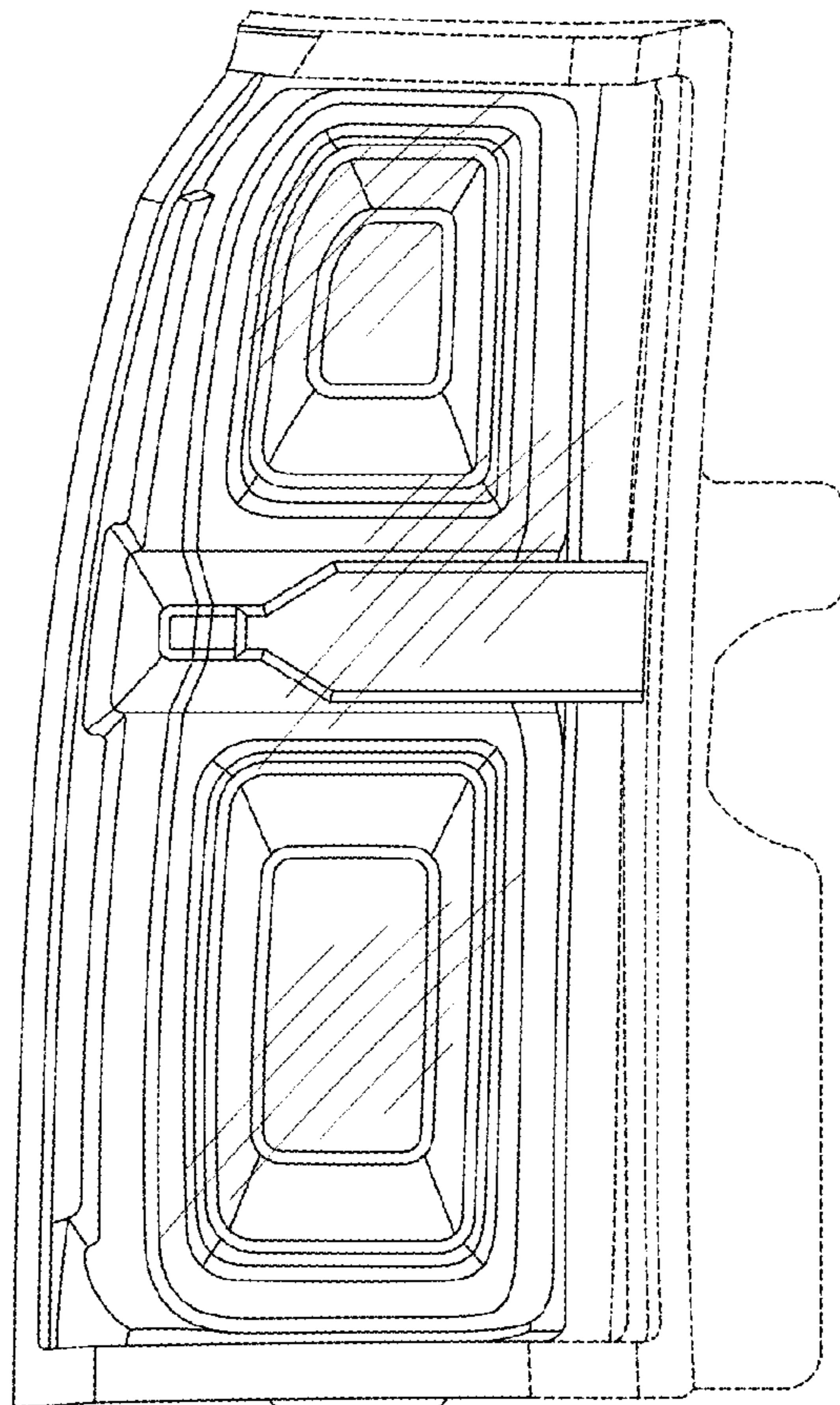

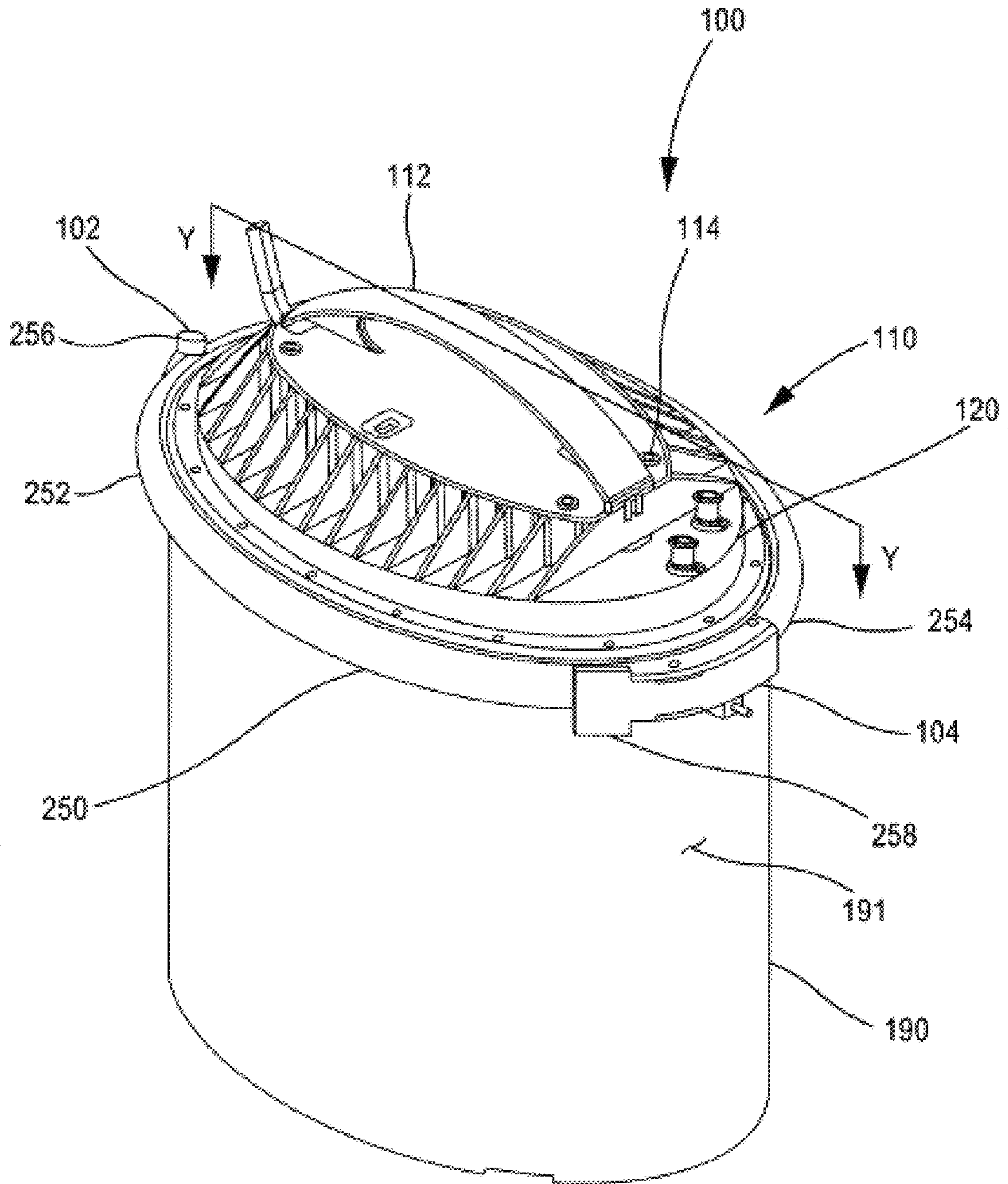
