**DESCRIPTION**

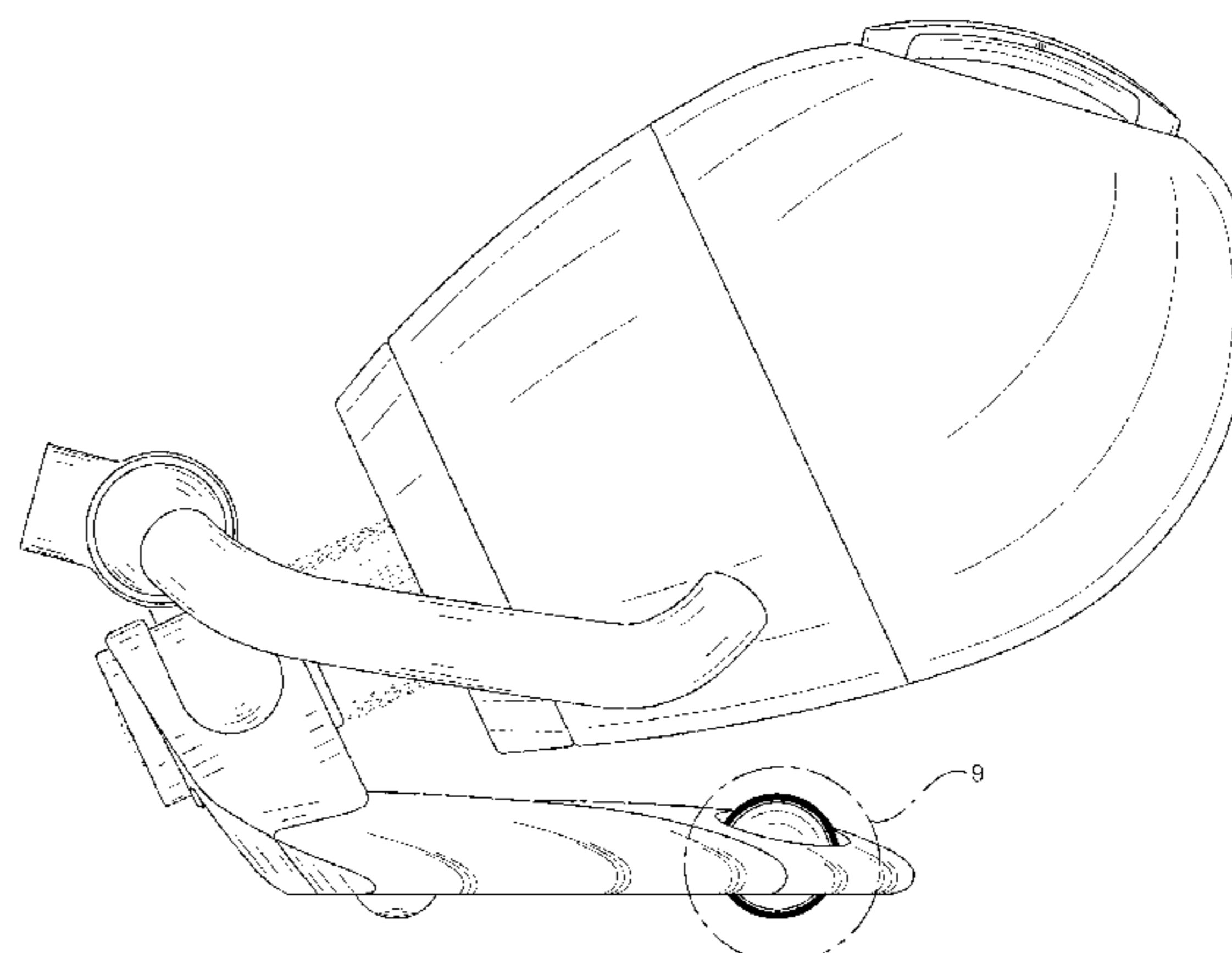
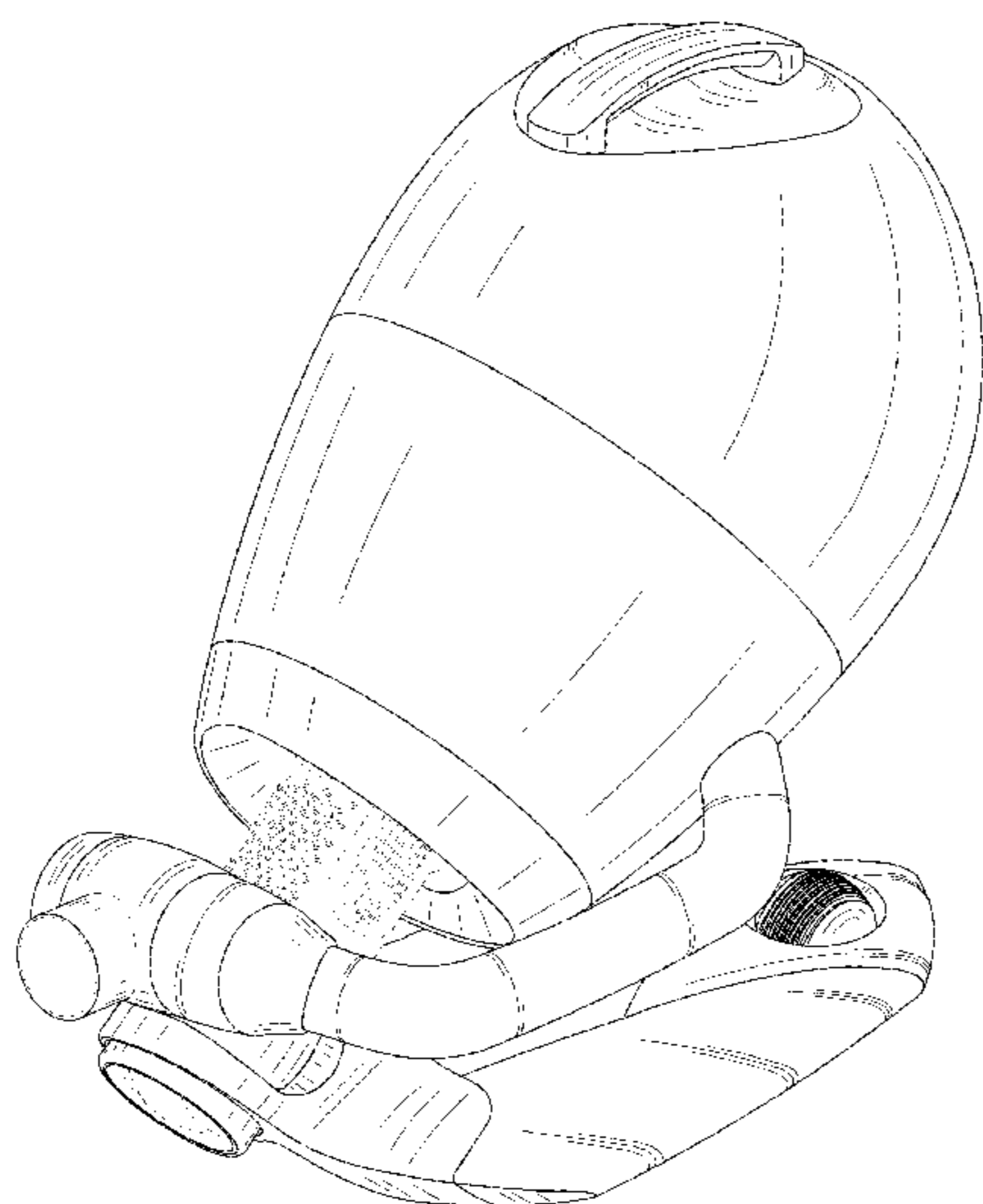

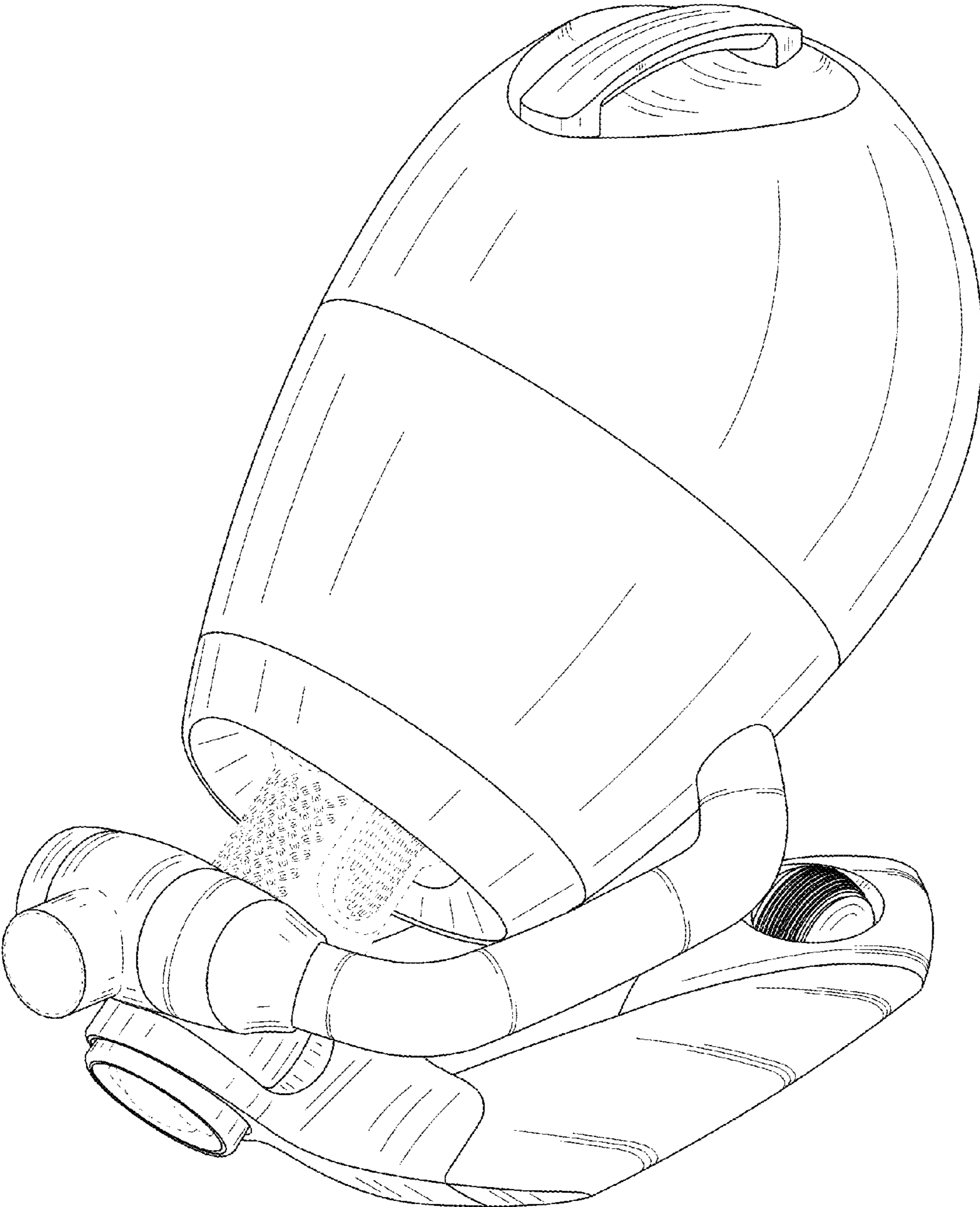

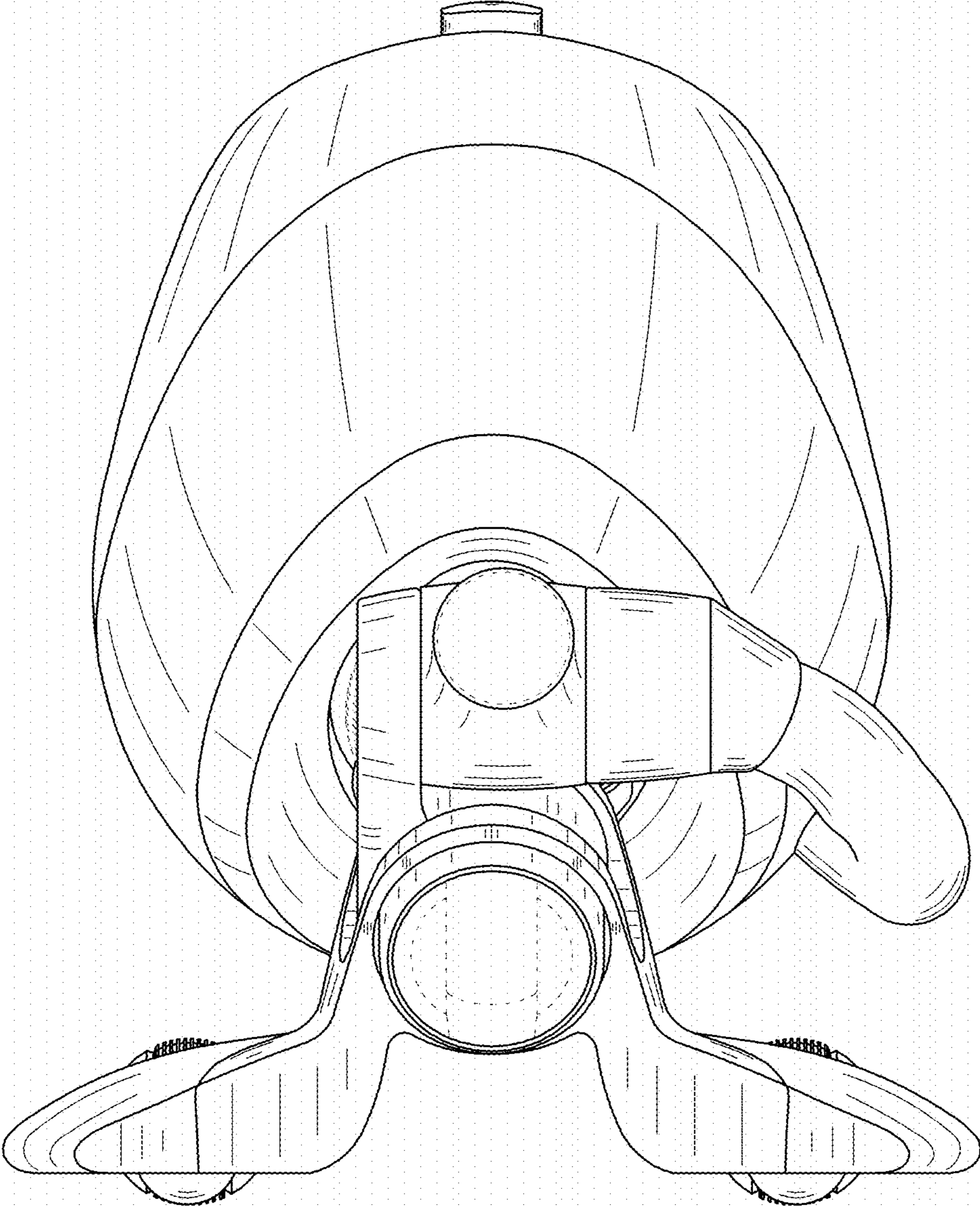

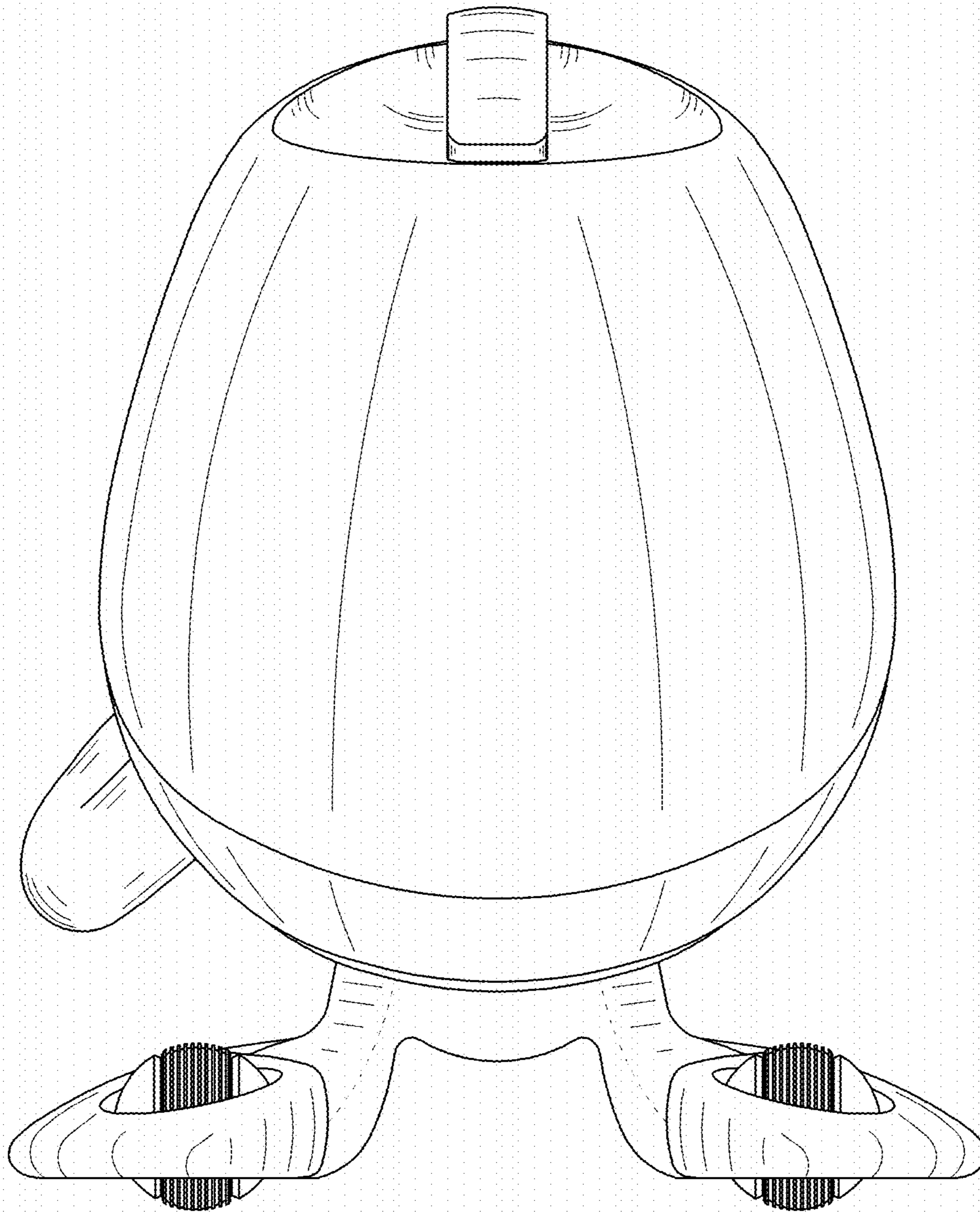

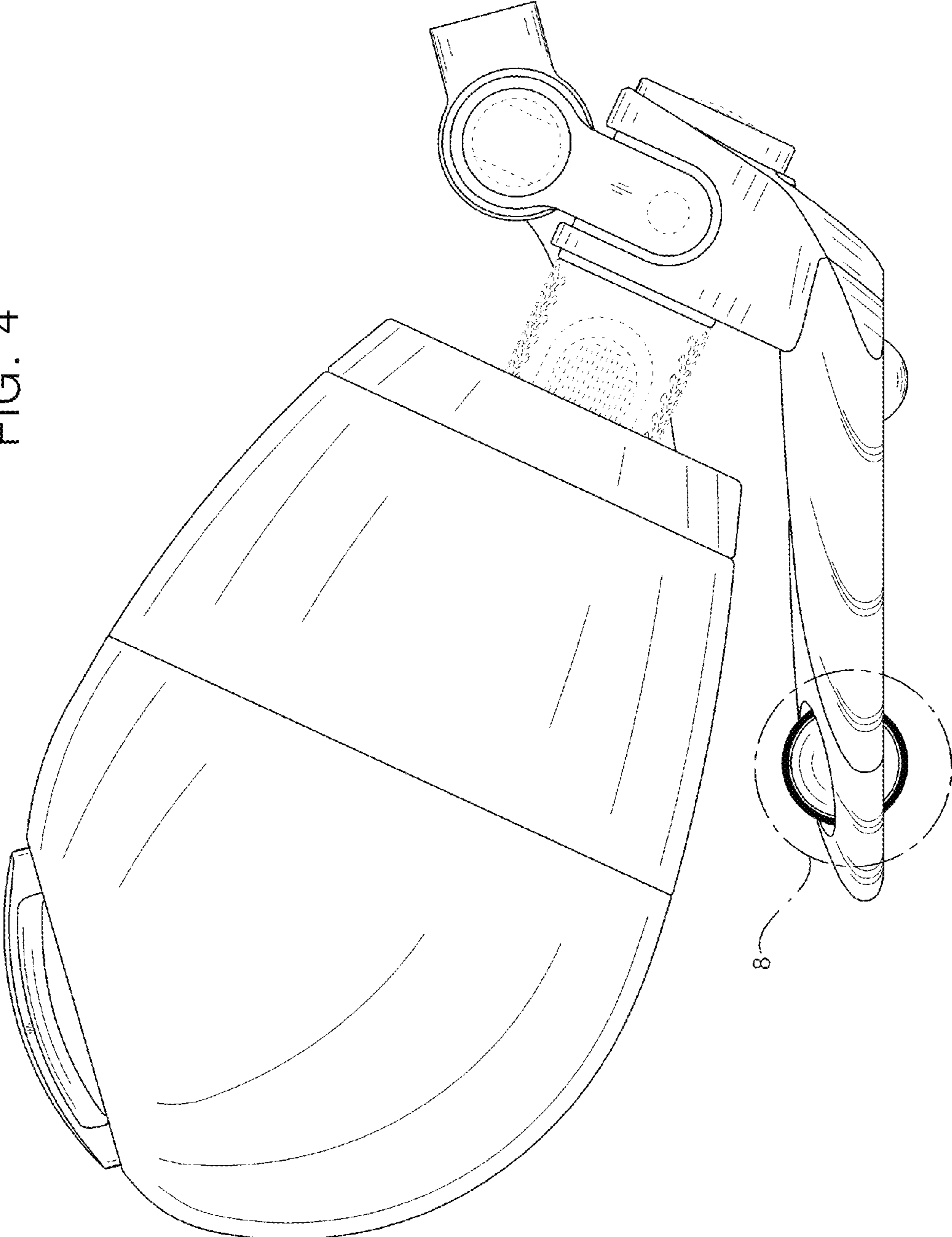

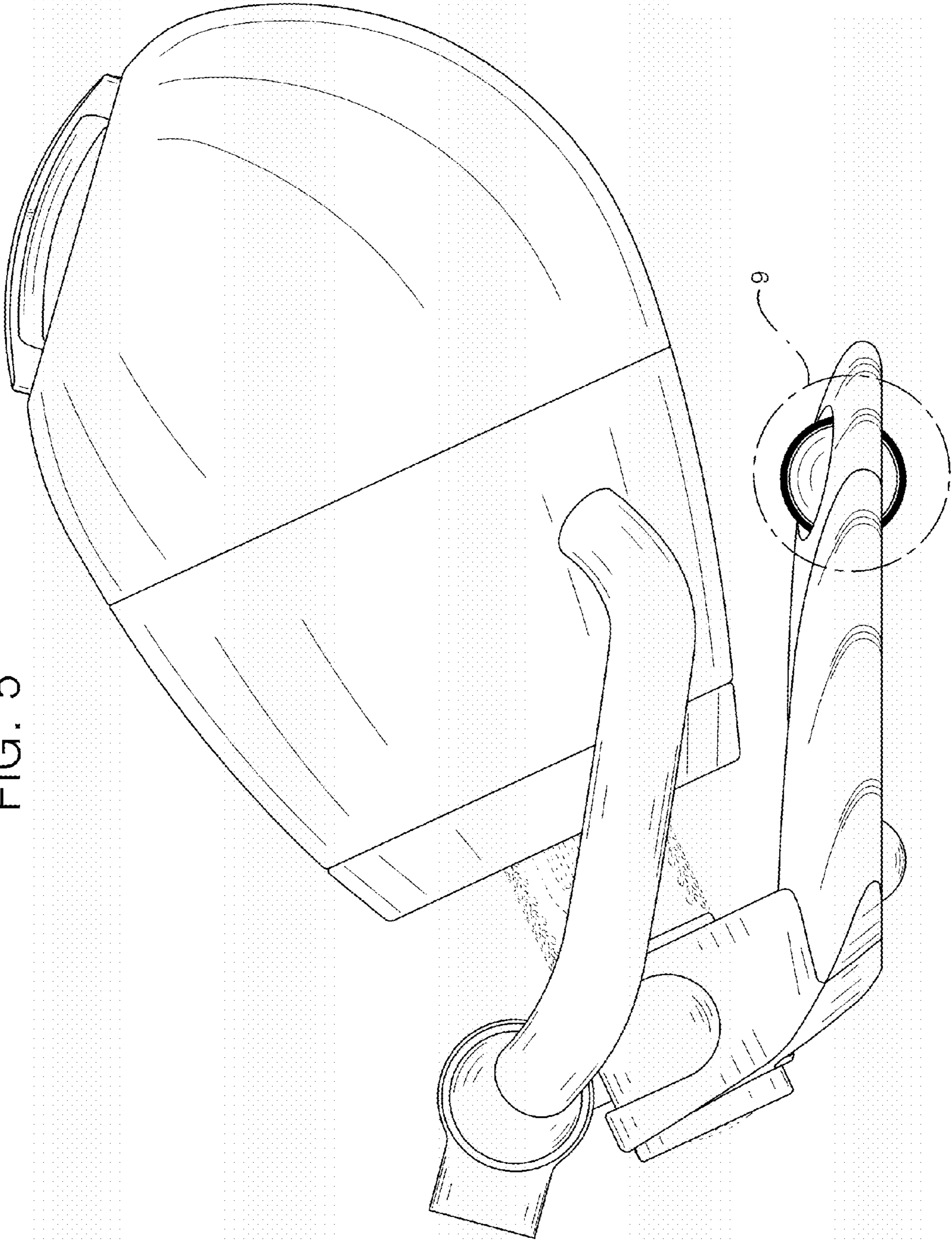

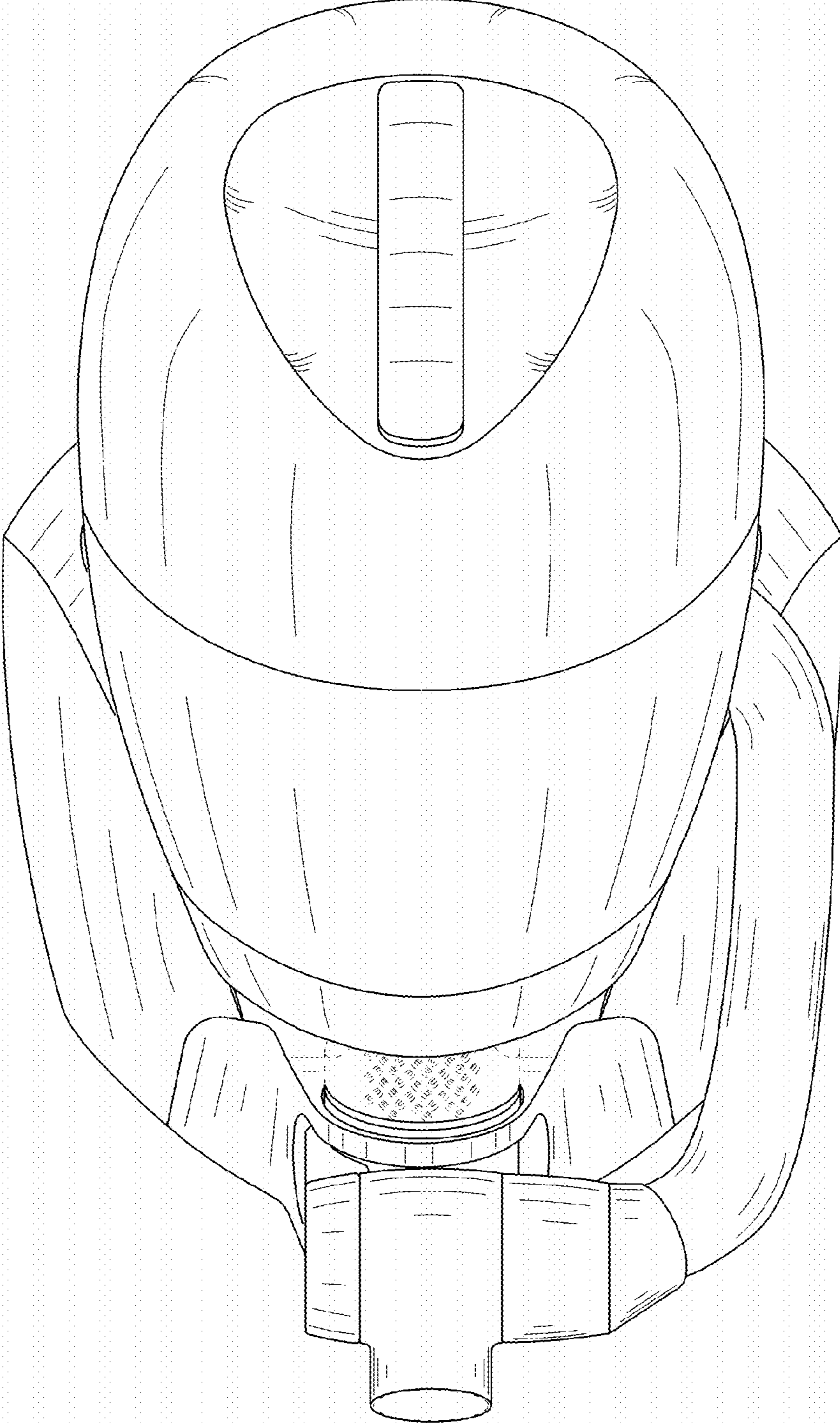

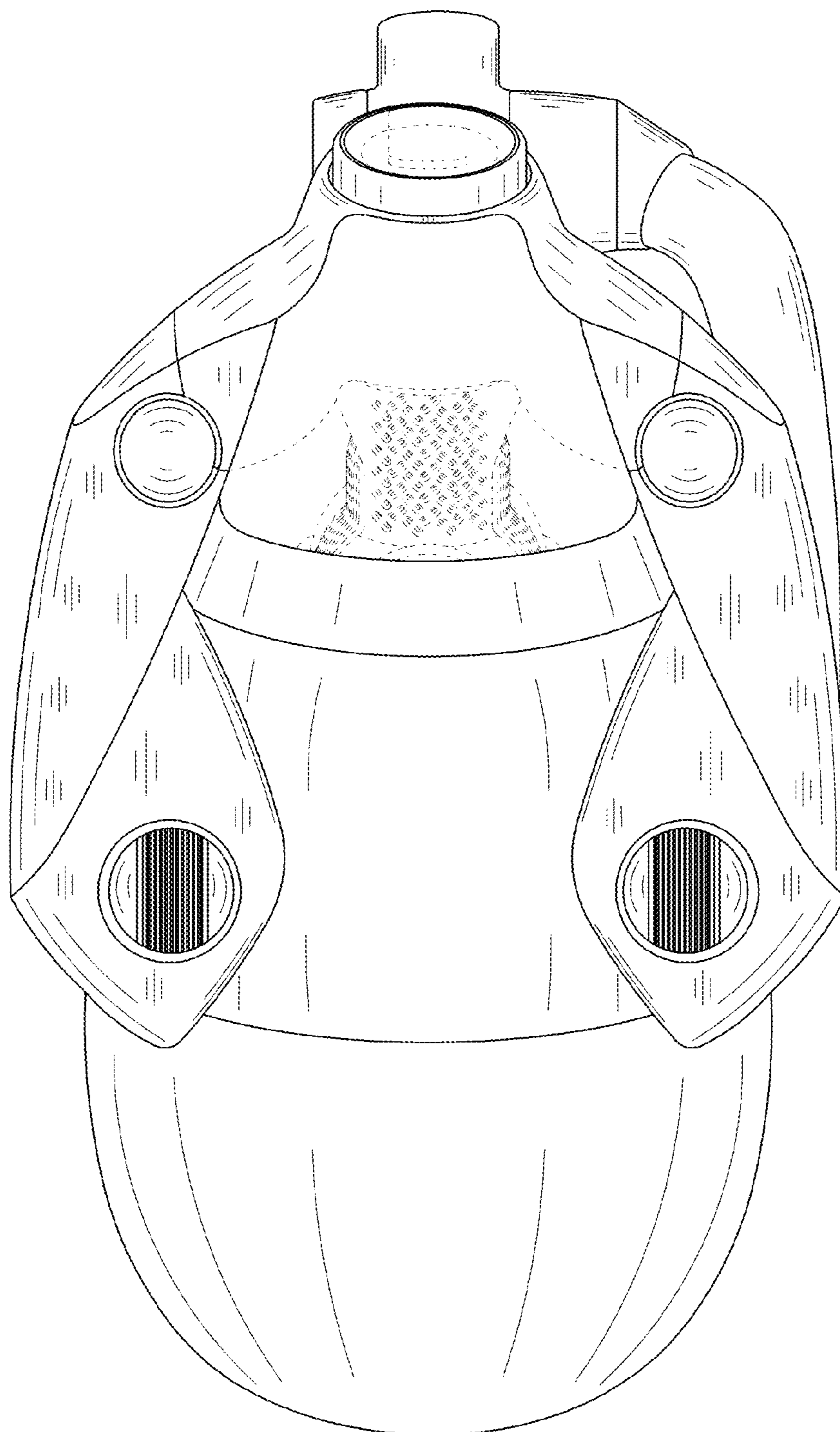

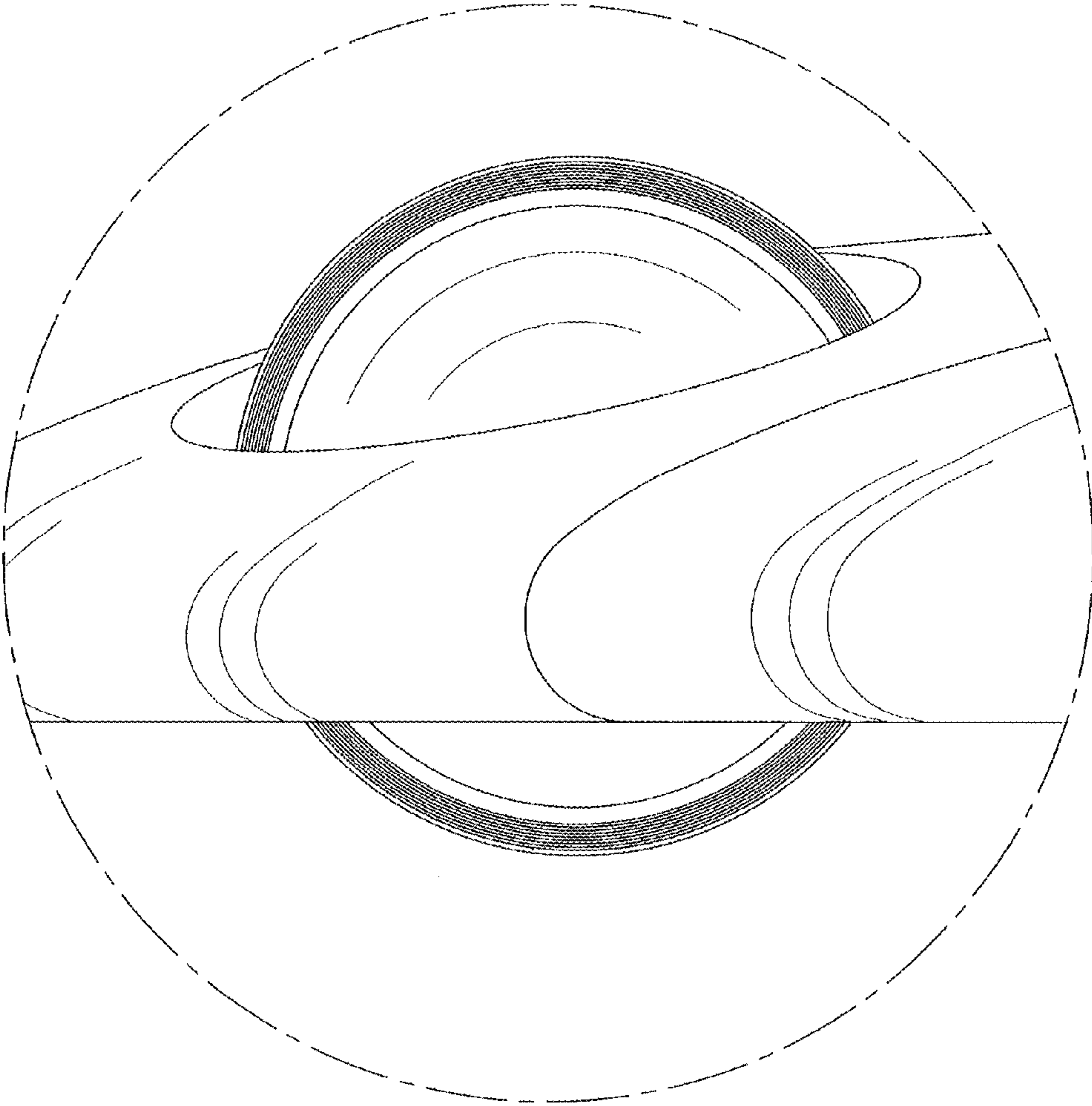
