DESCRIPTION

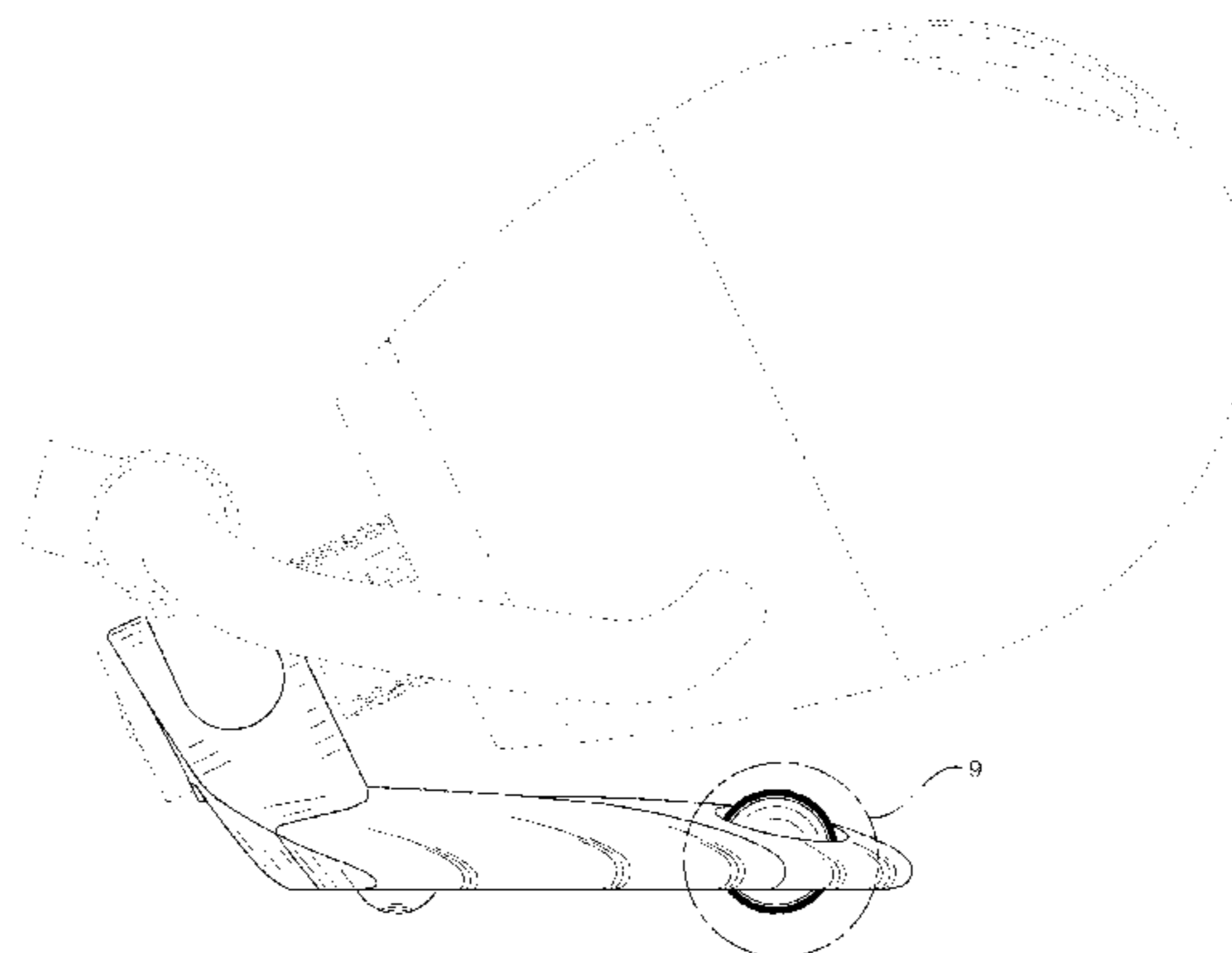
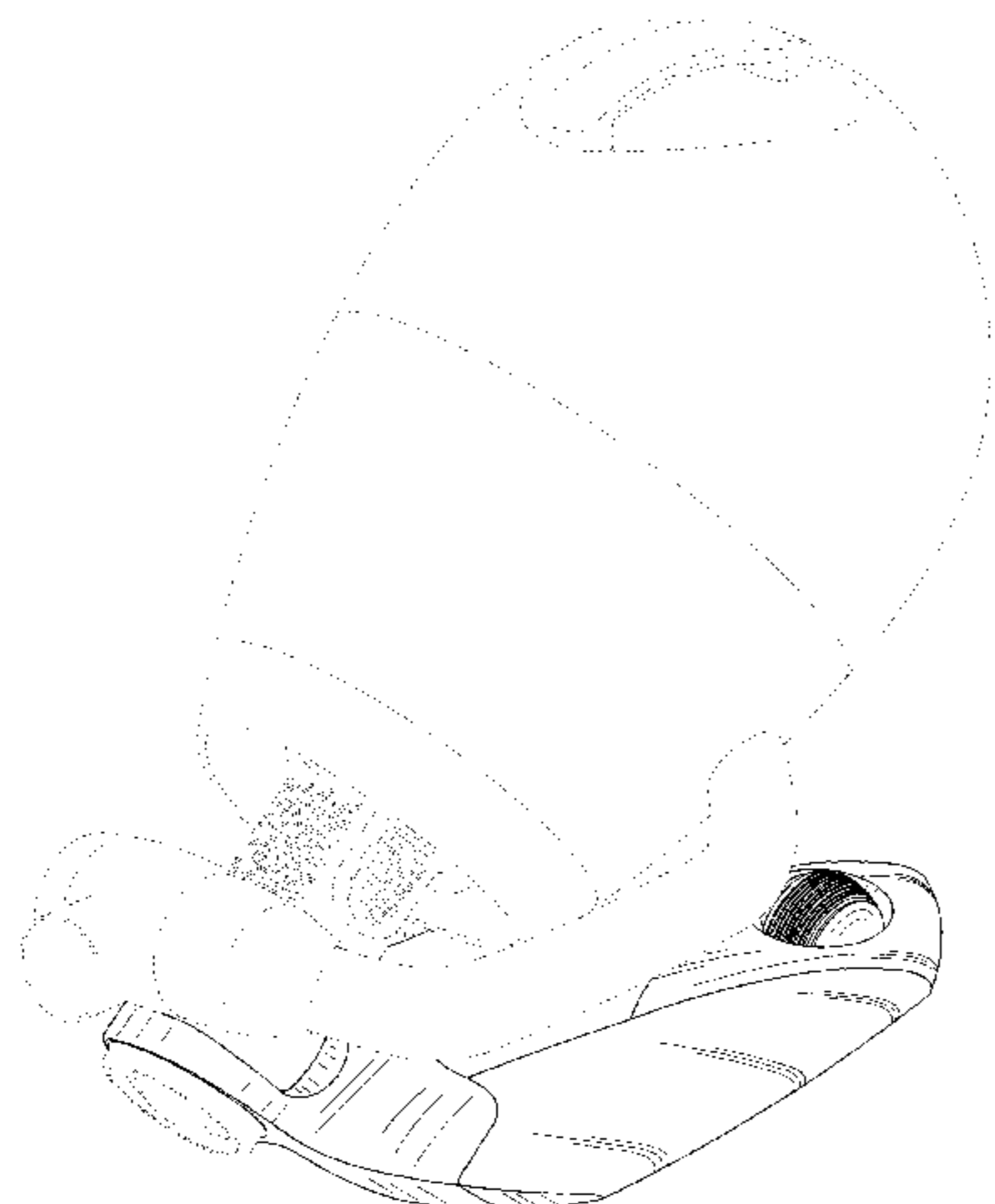

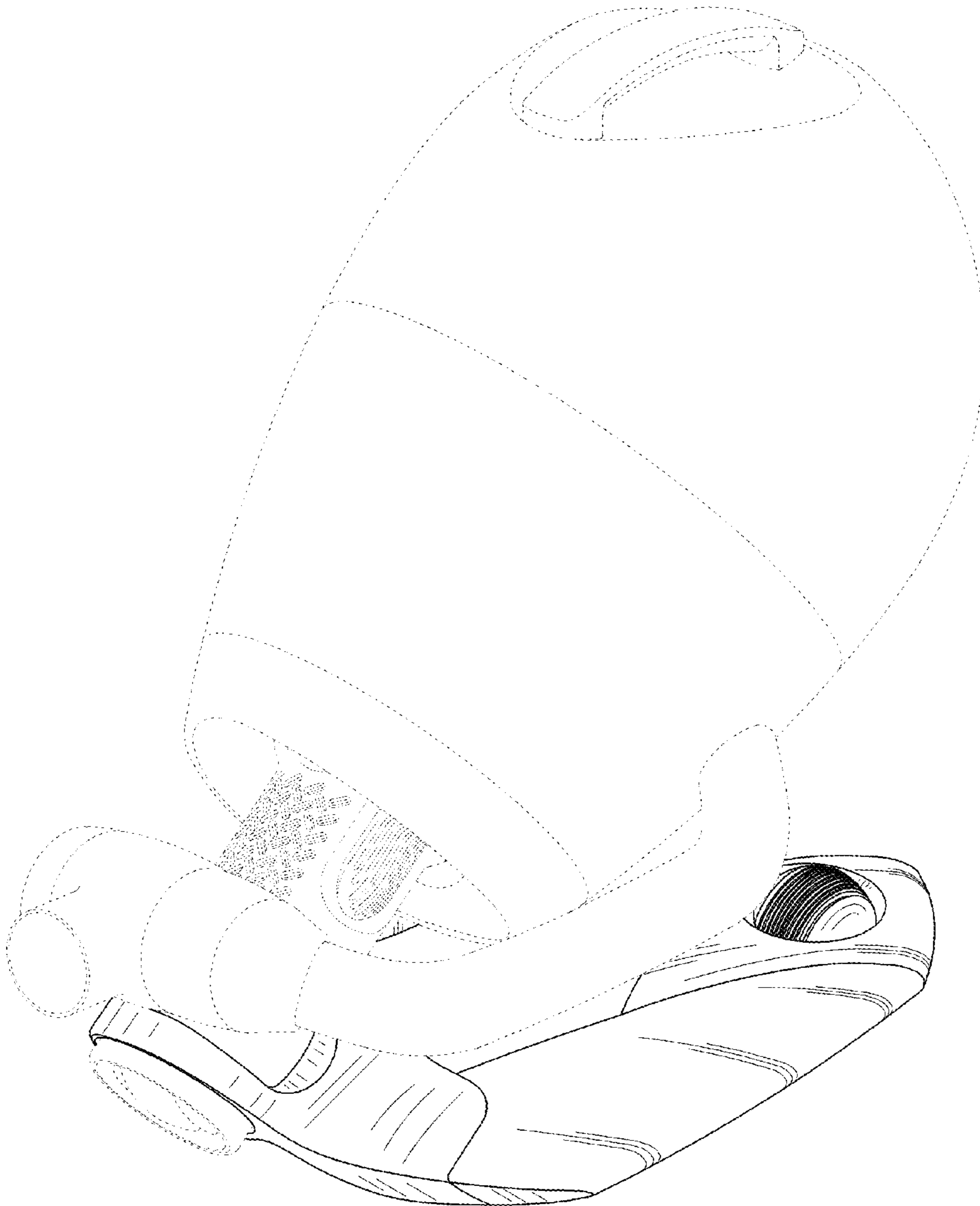

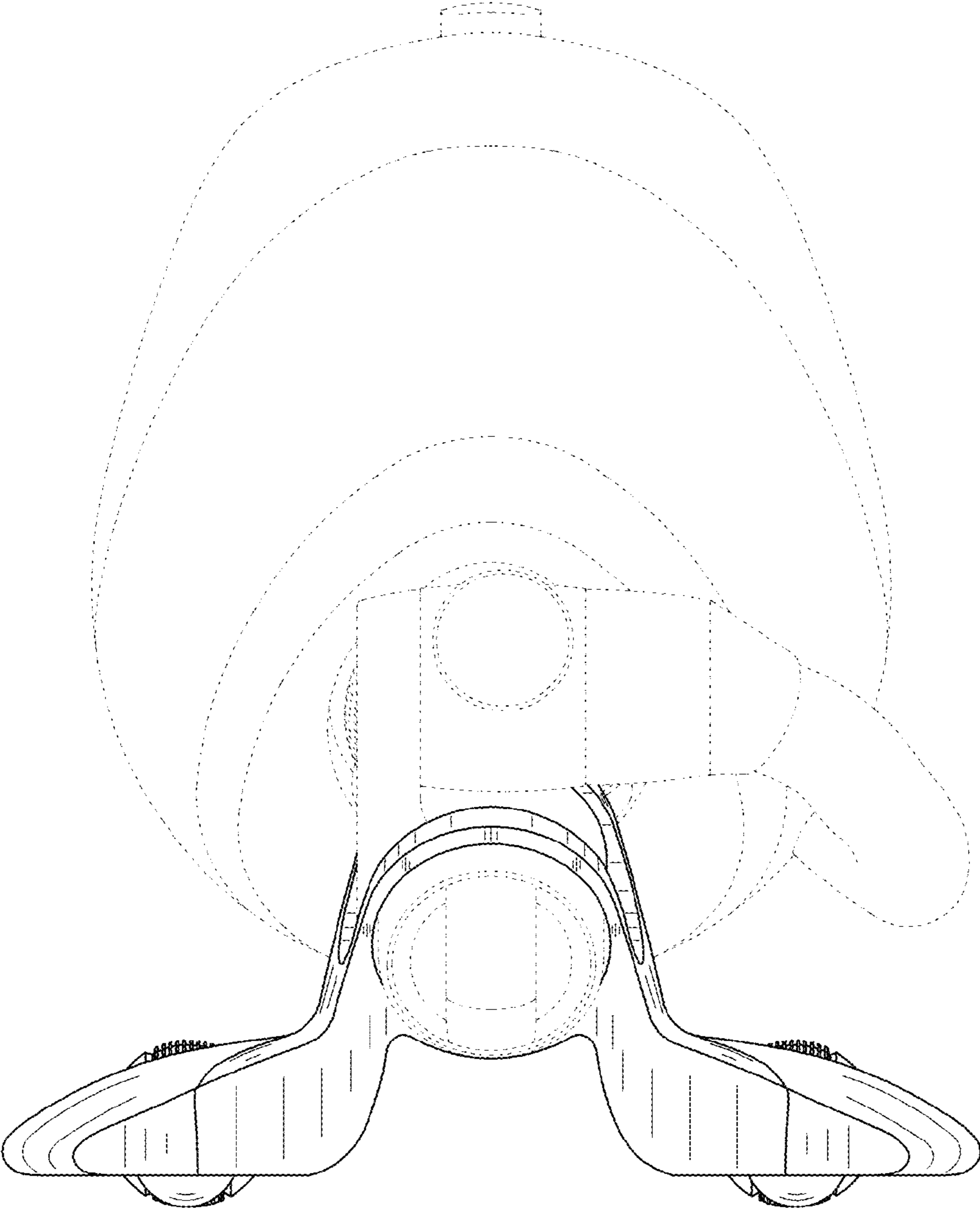

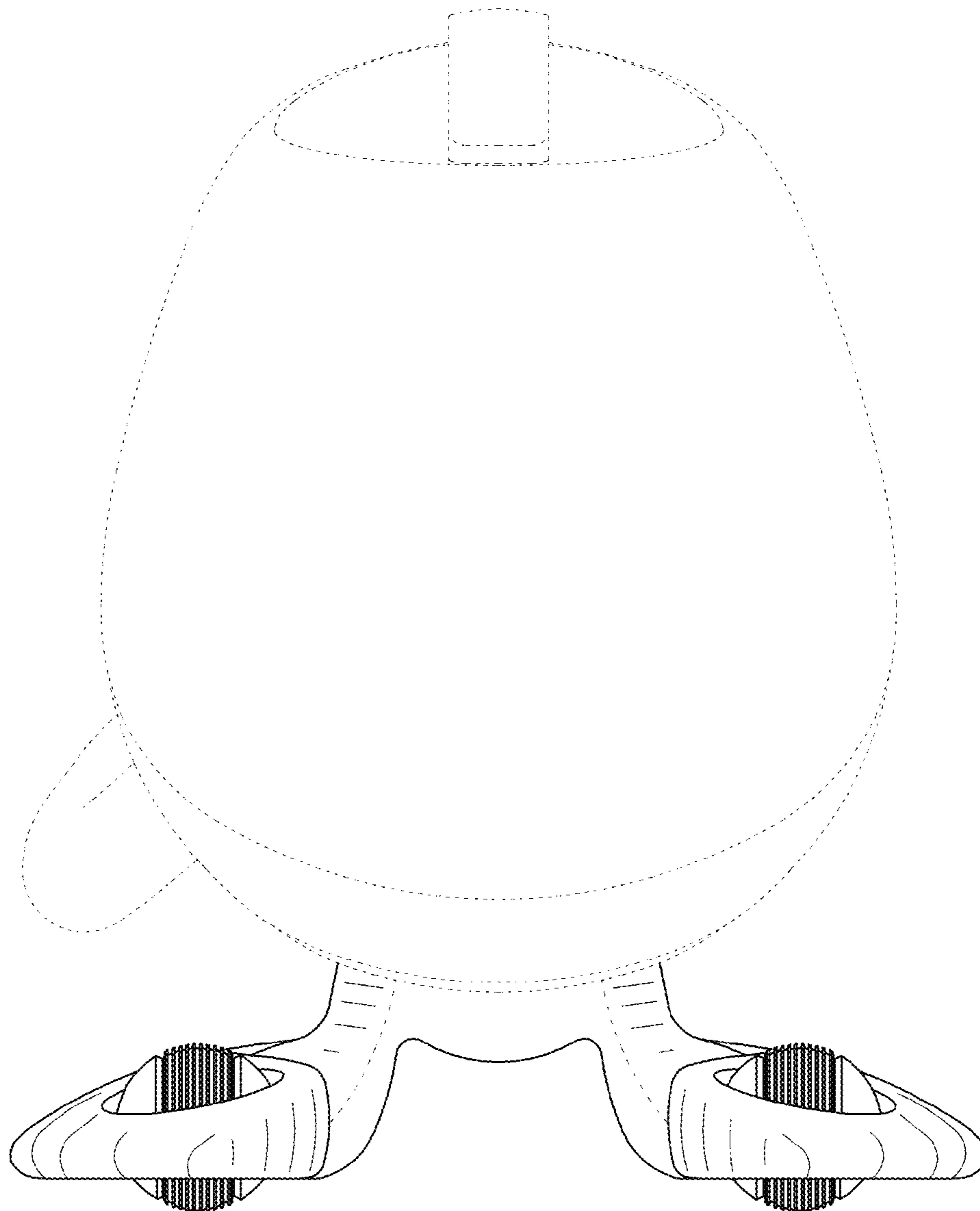

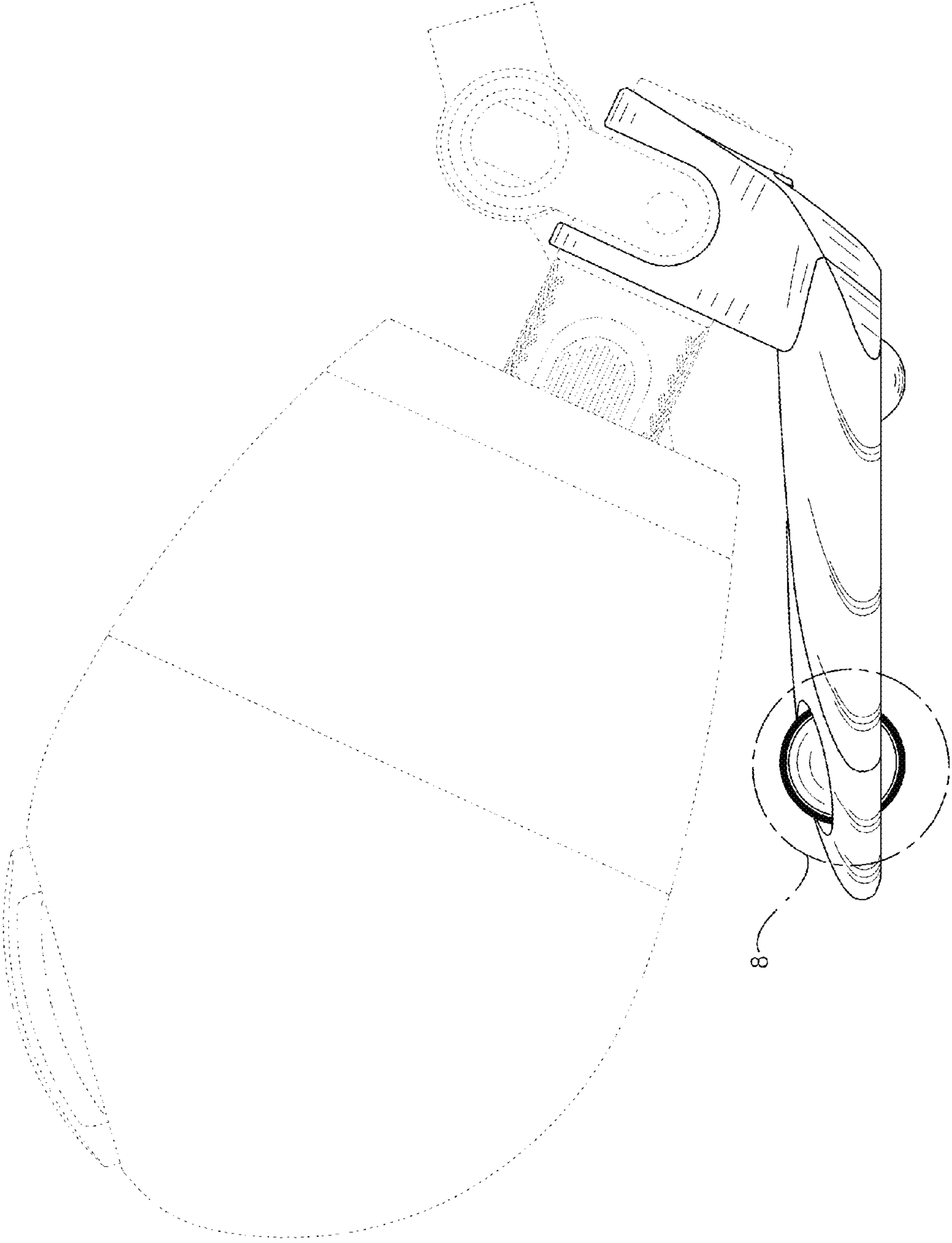

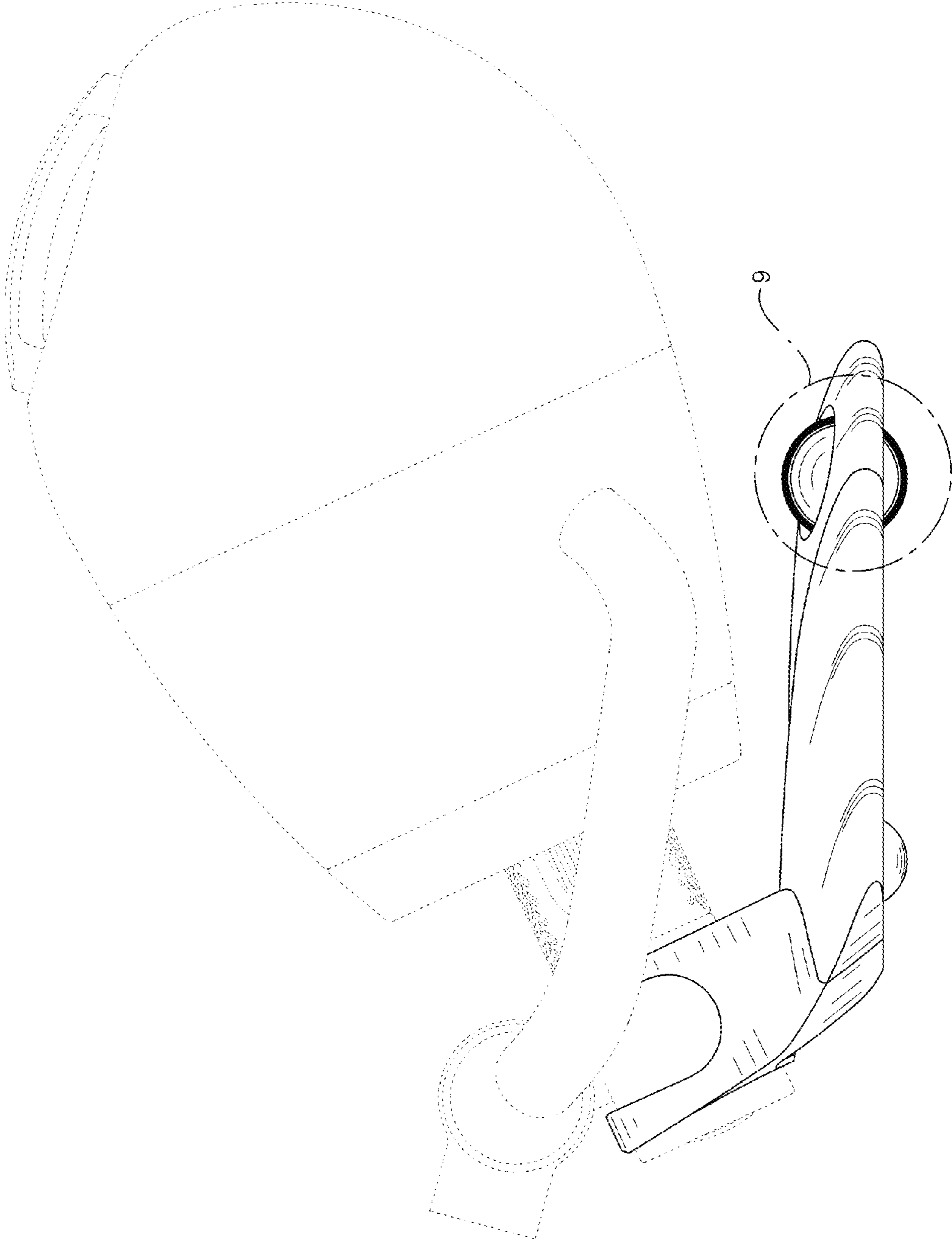

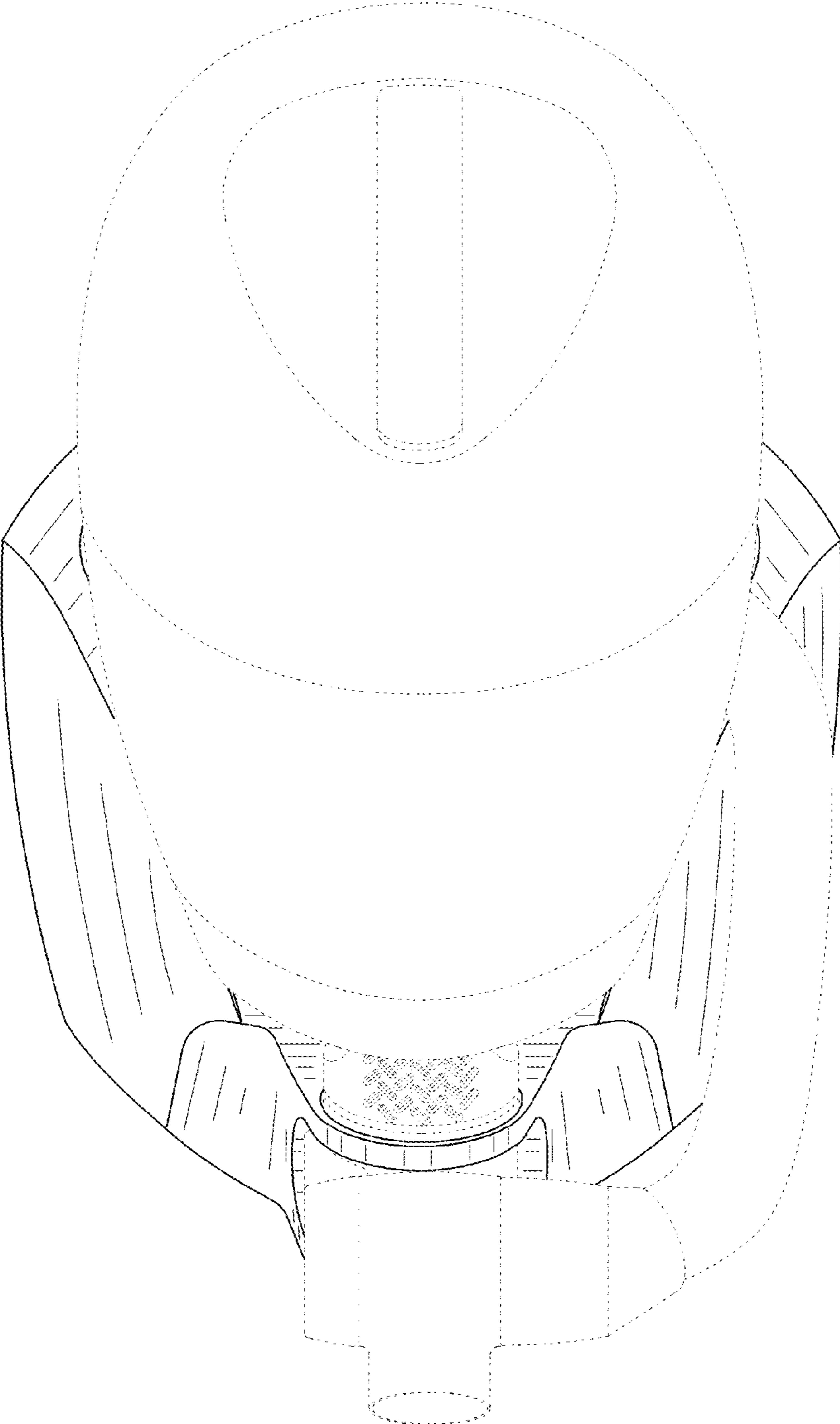

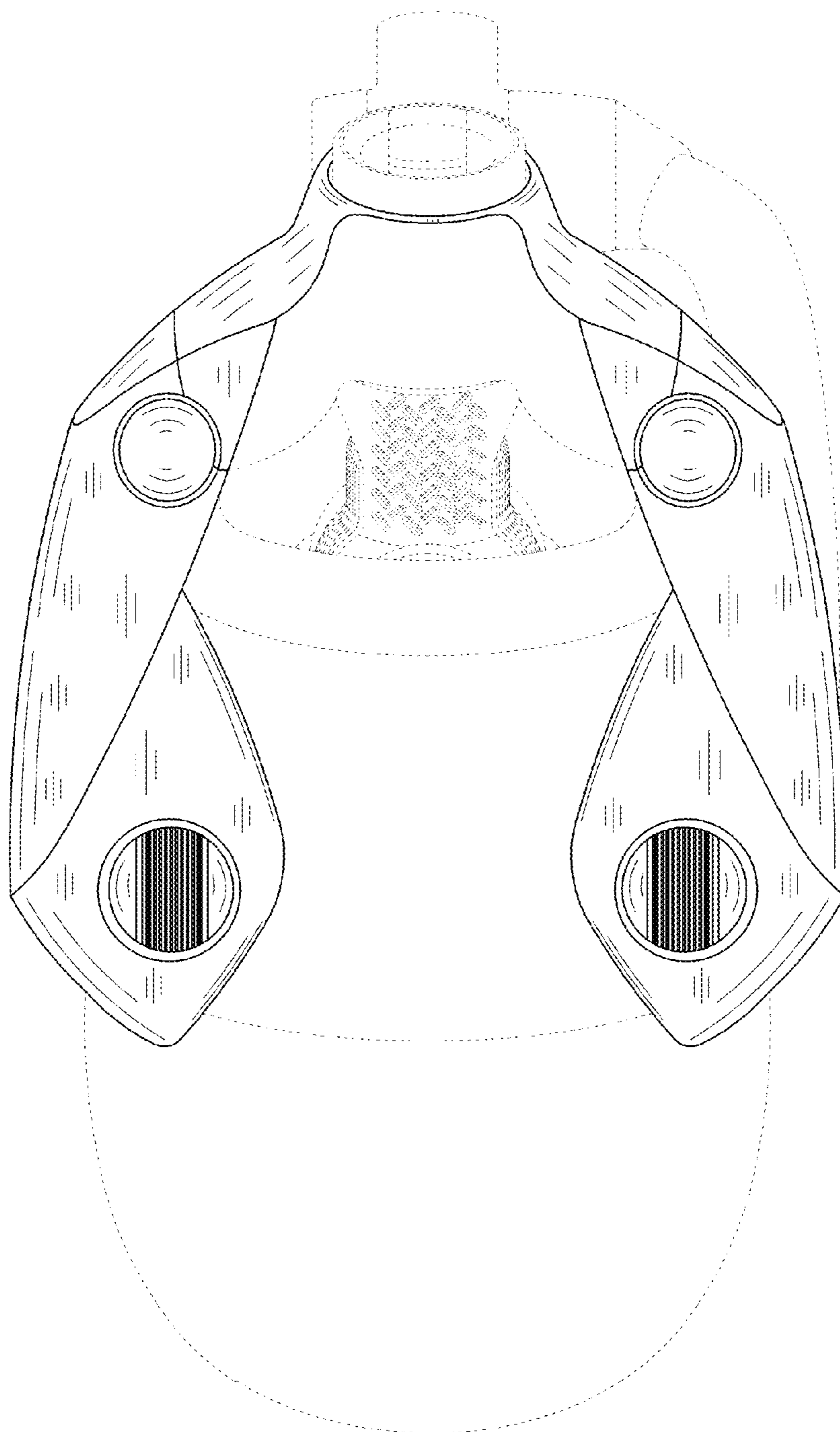

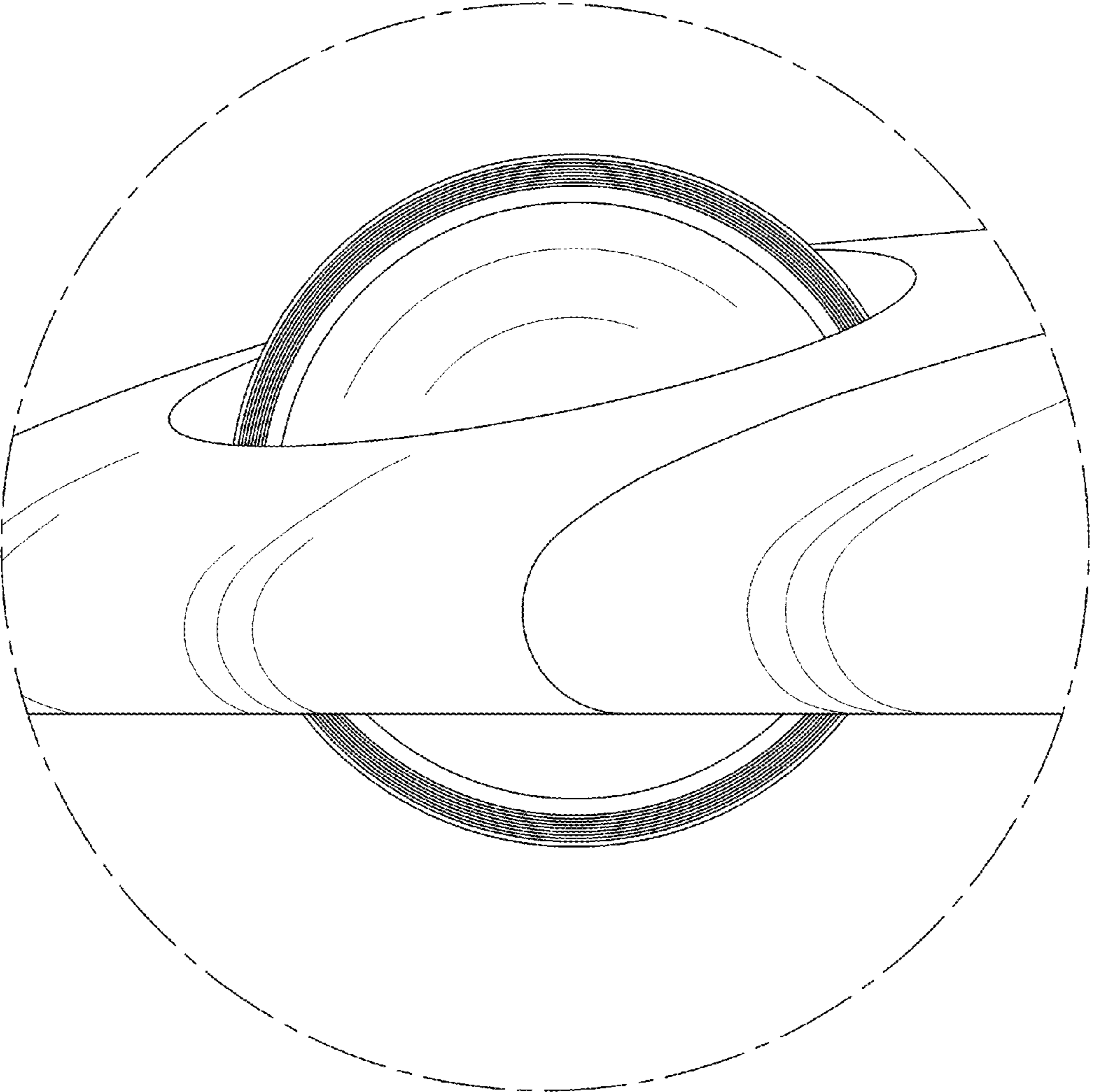
