**DESCRIPTION**

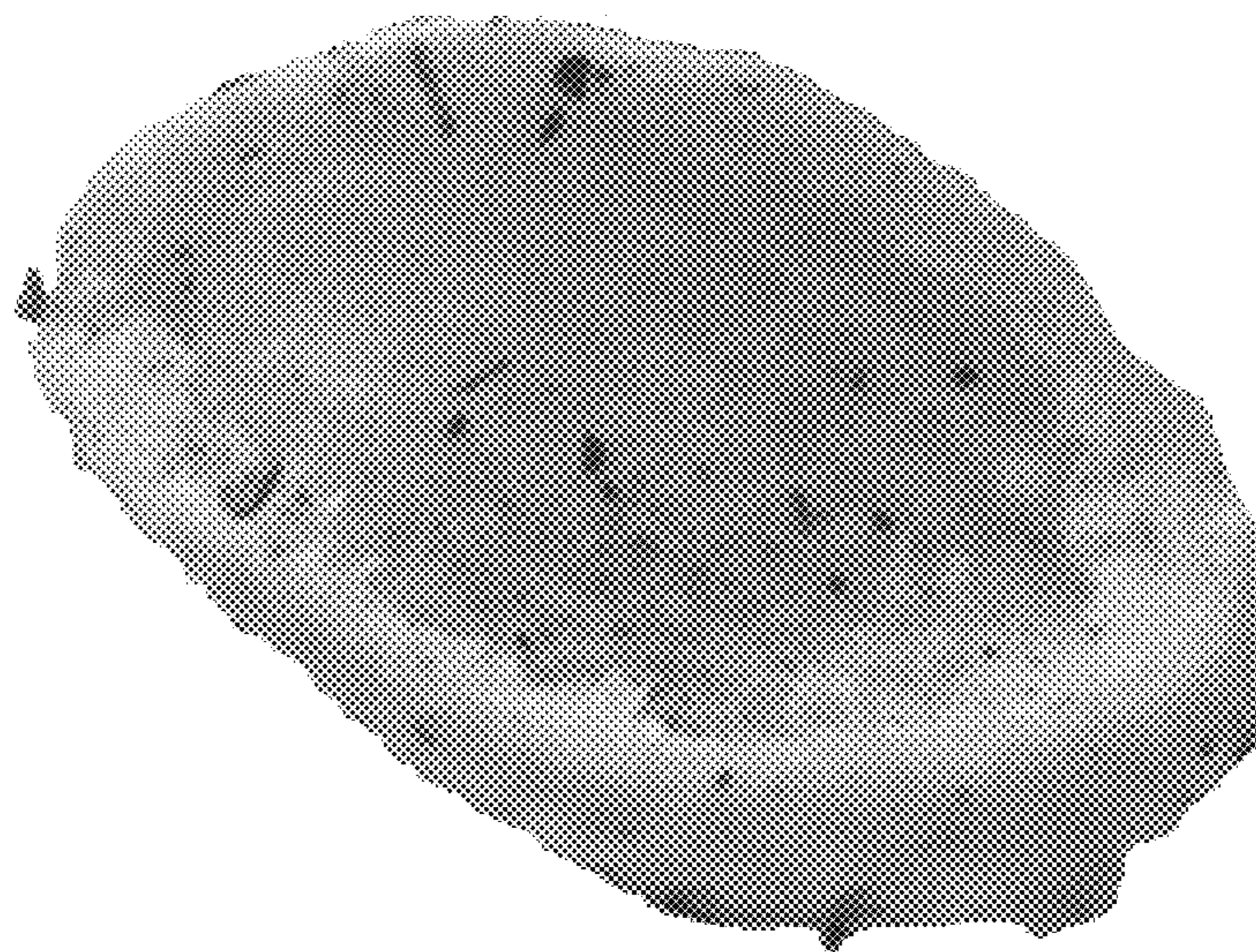
FIG. 1 is a top perspective view of the scoop shaped pita chip according to my new design;

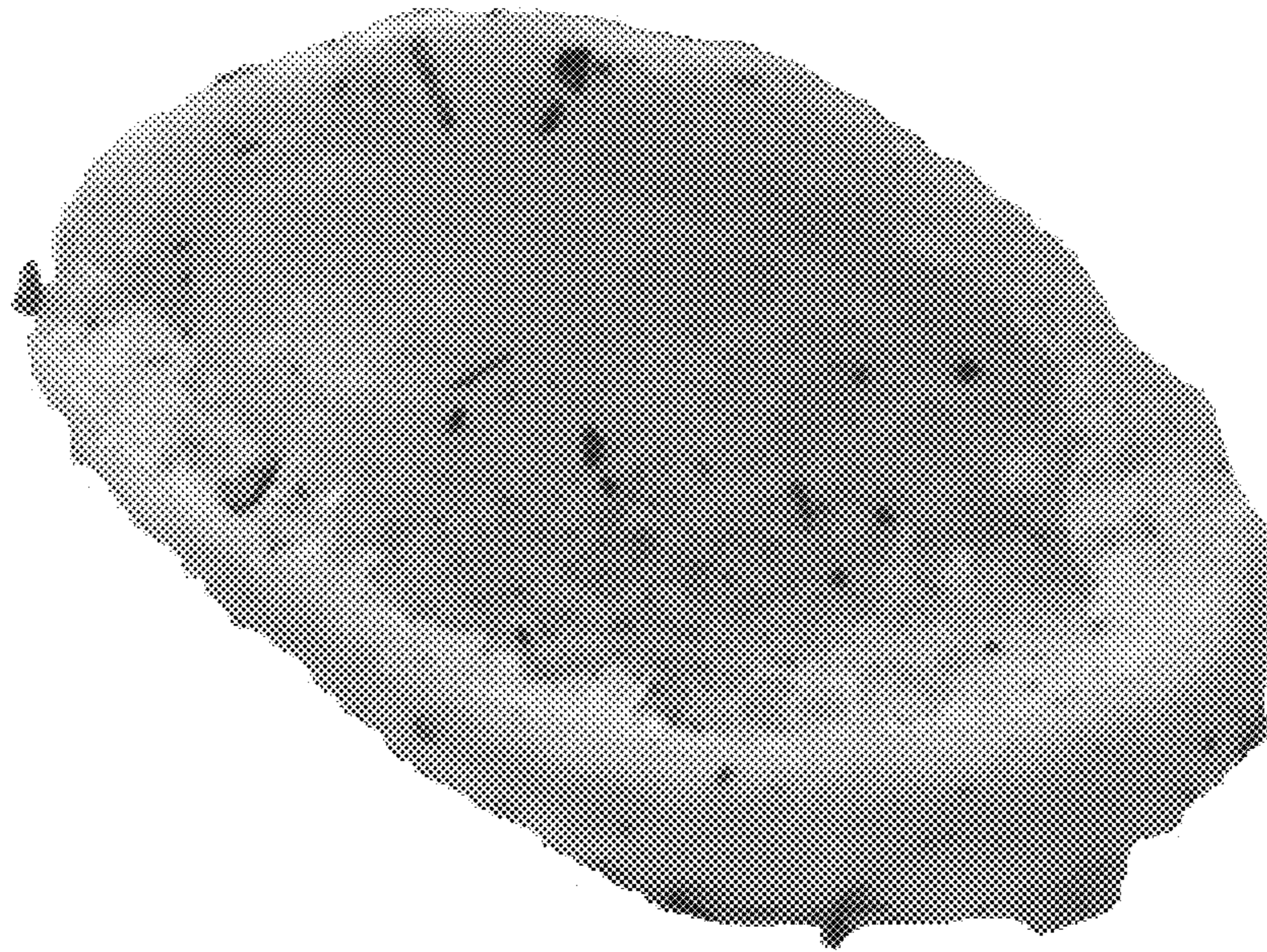
