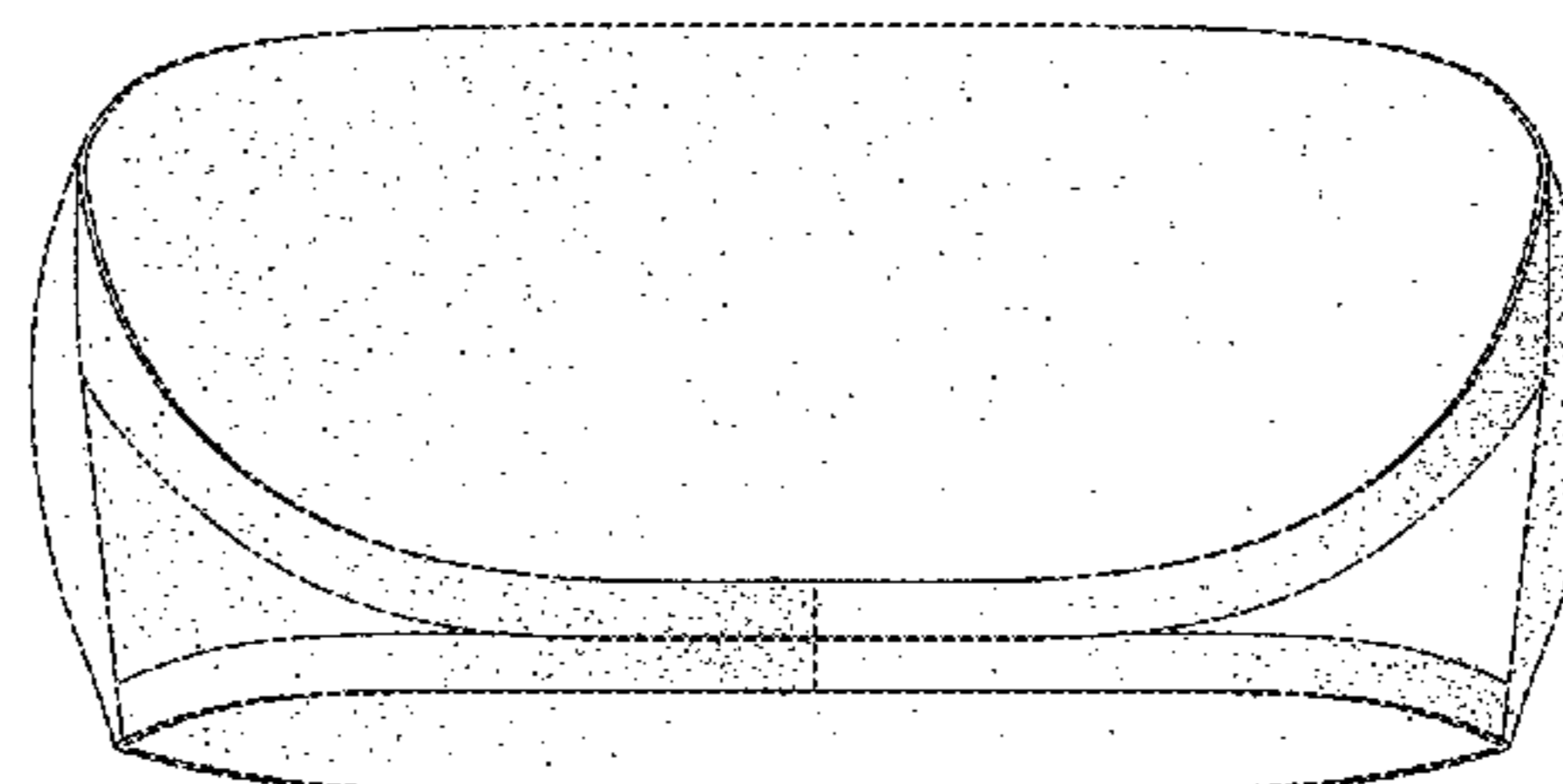
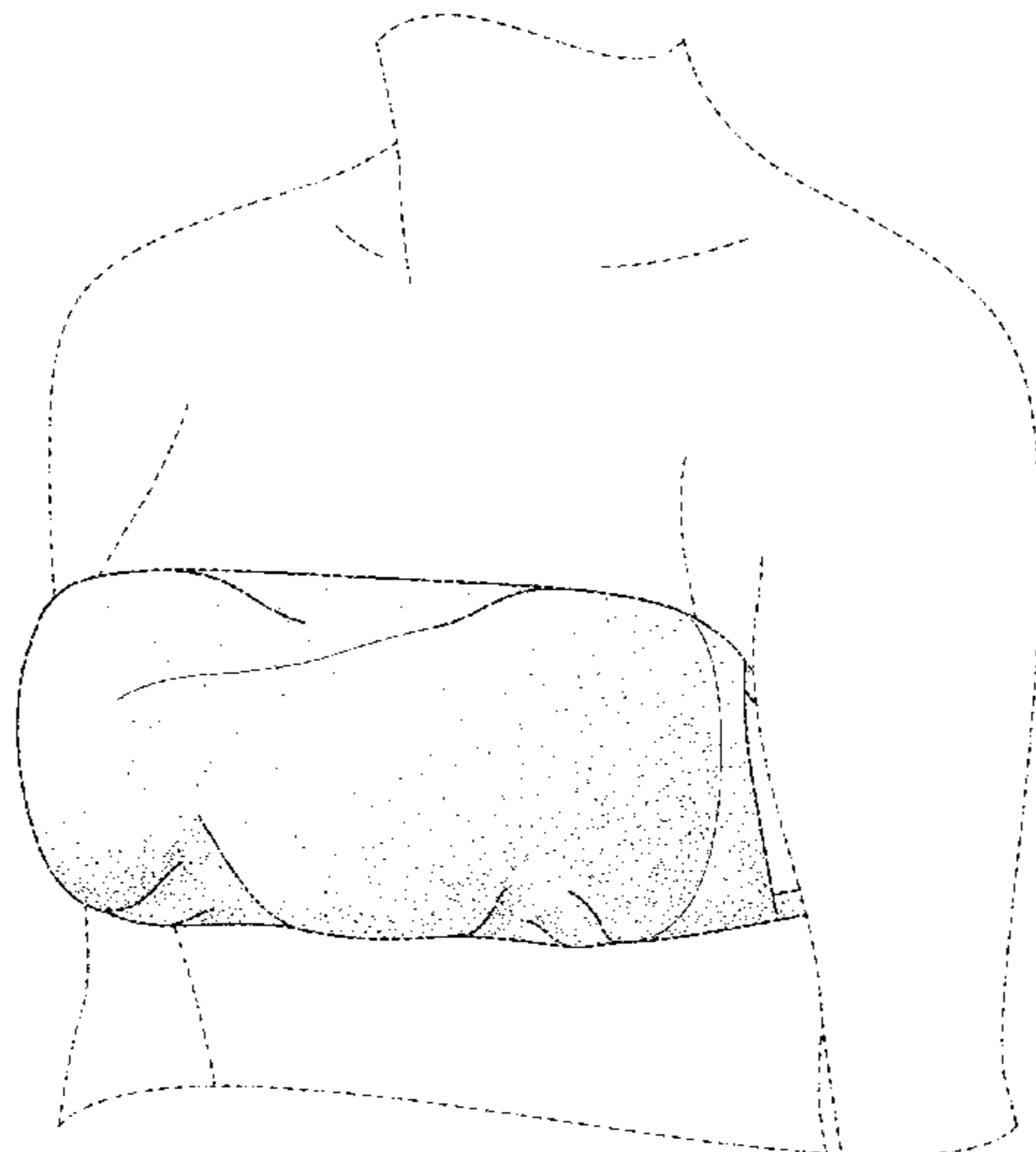
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front perspective view of a bandeau showing my new design as worn by a person;

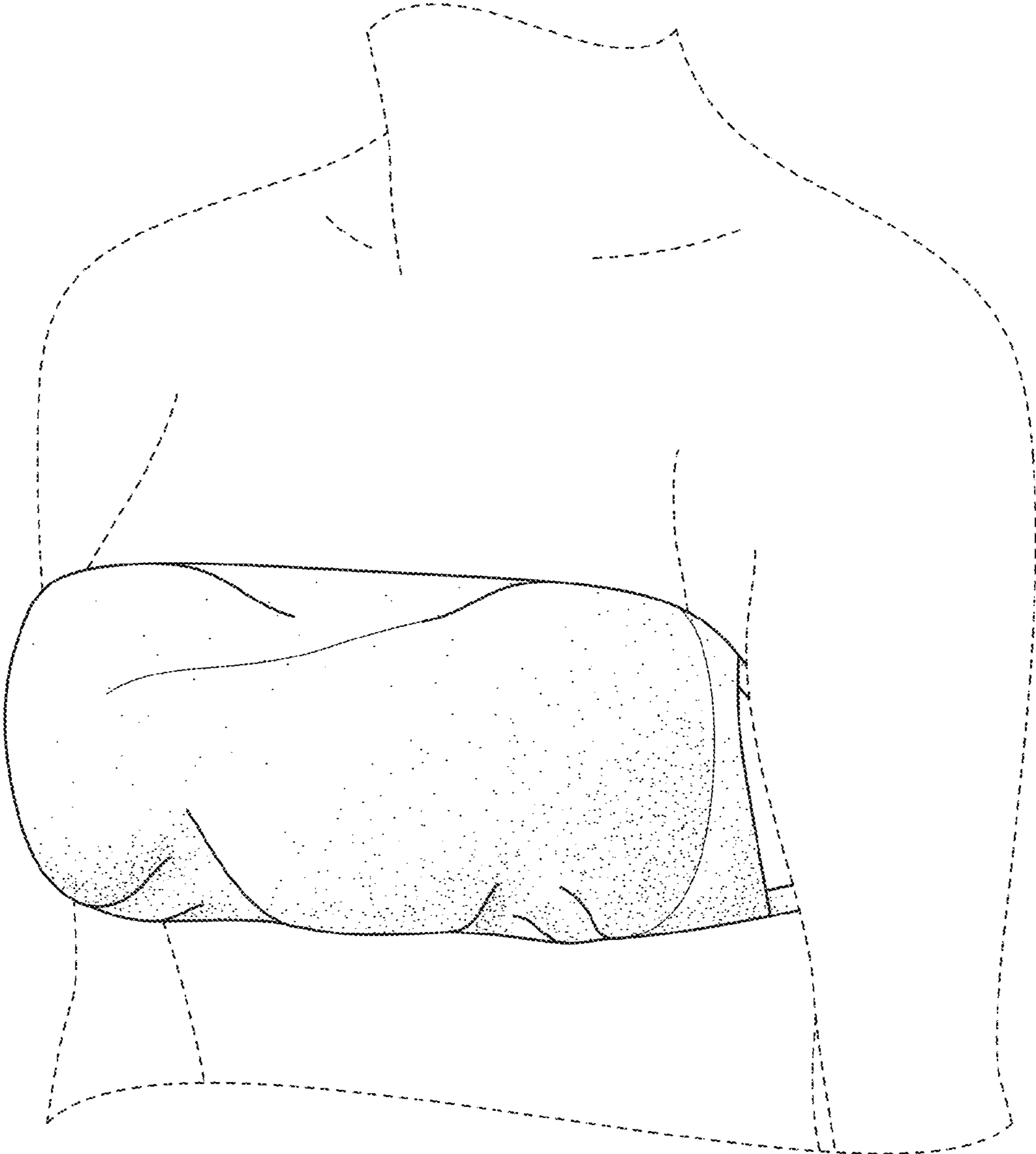

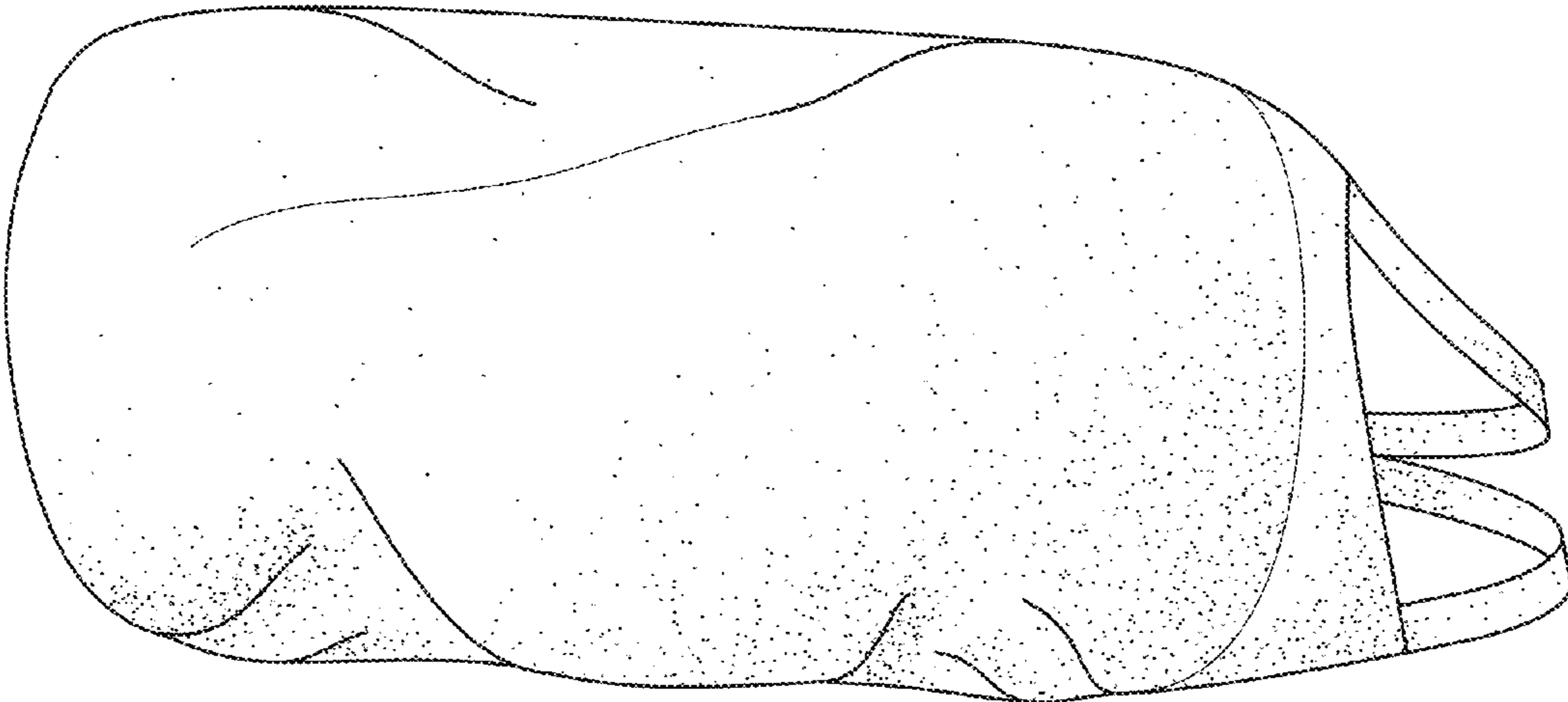

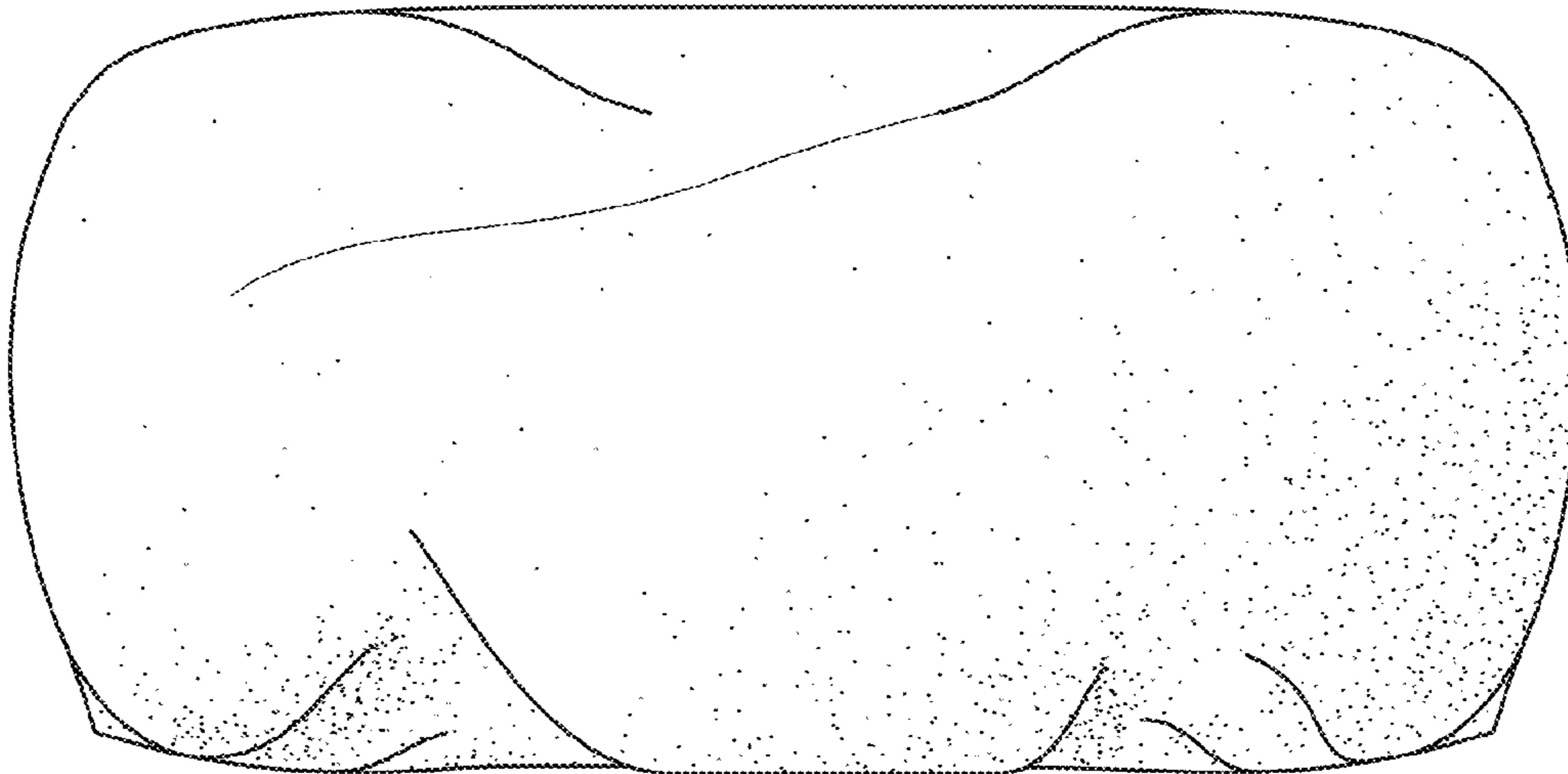

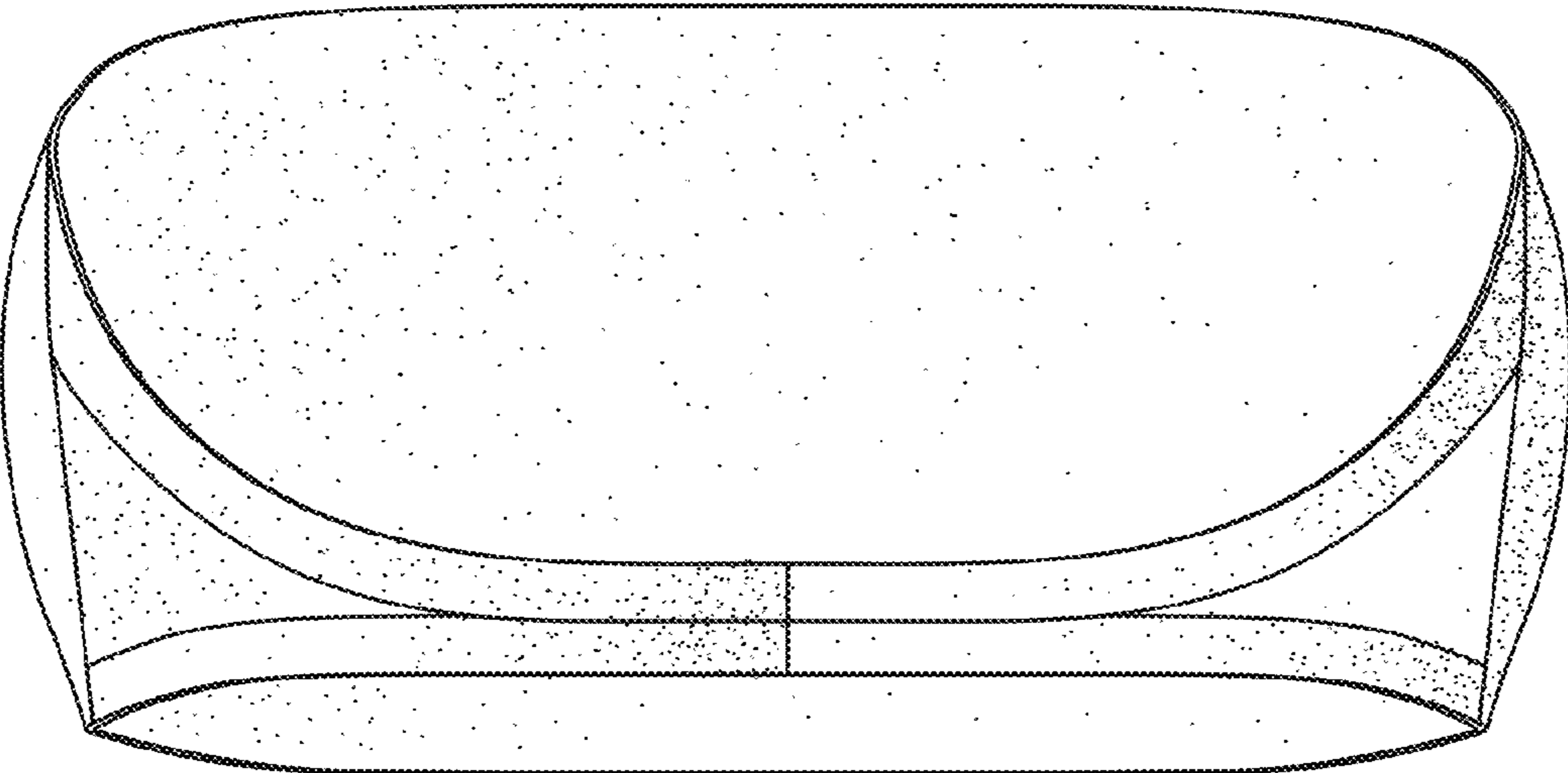

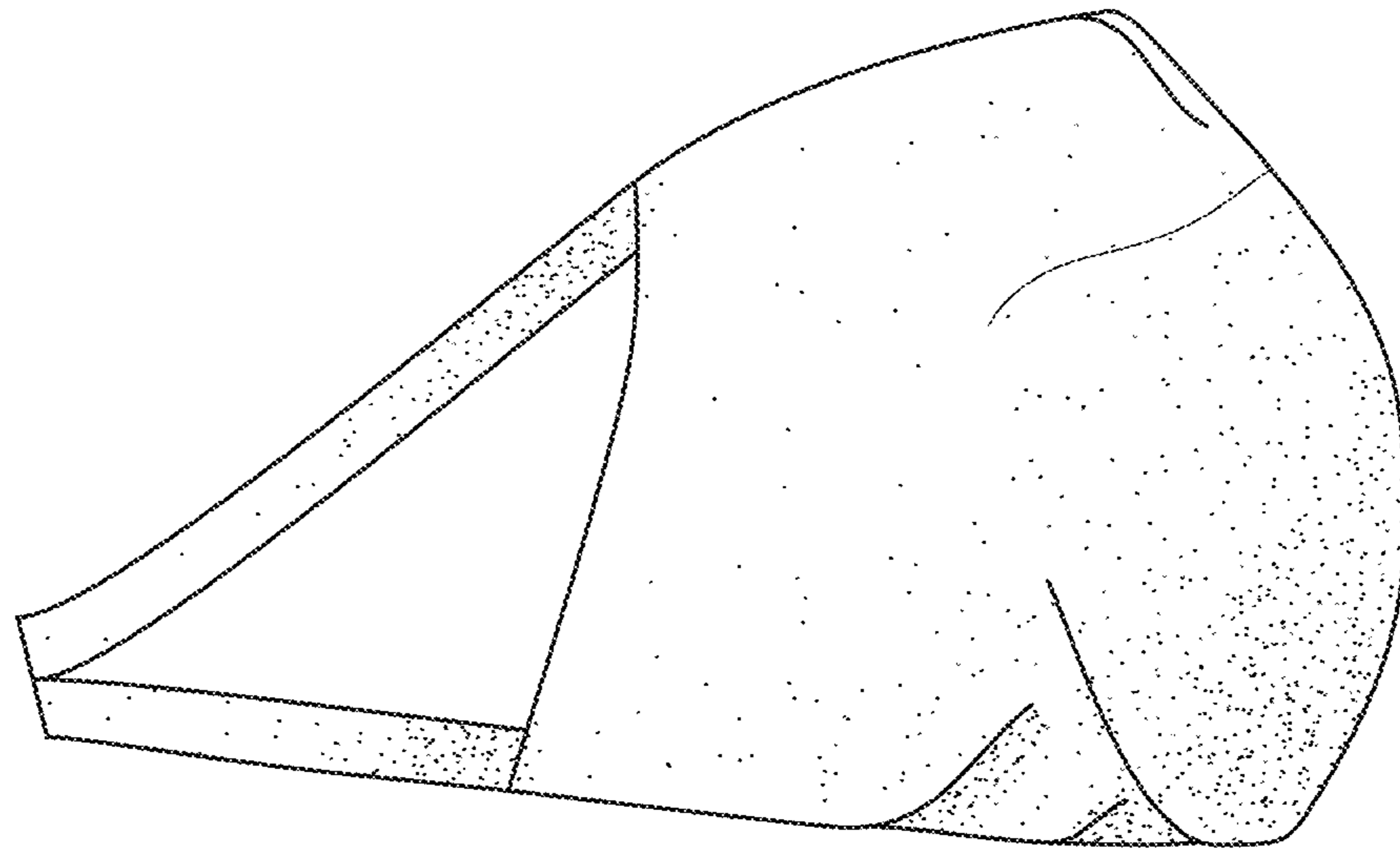

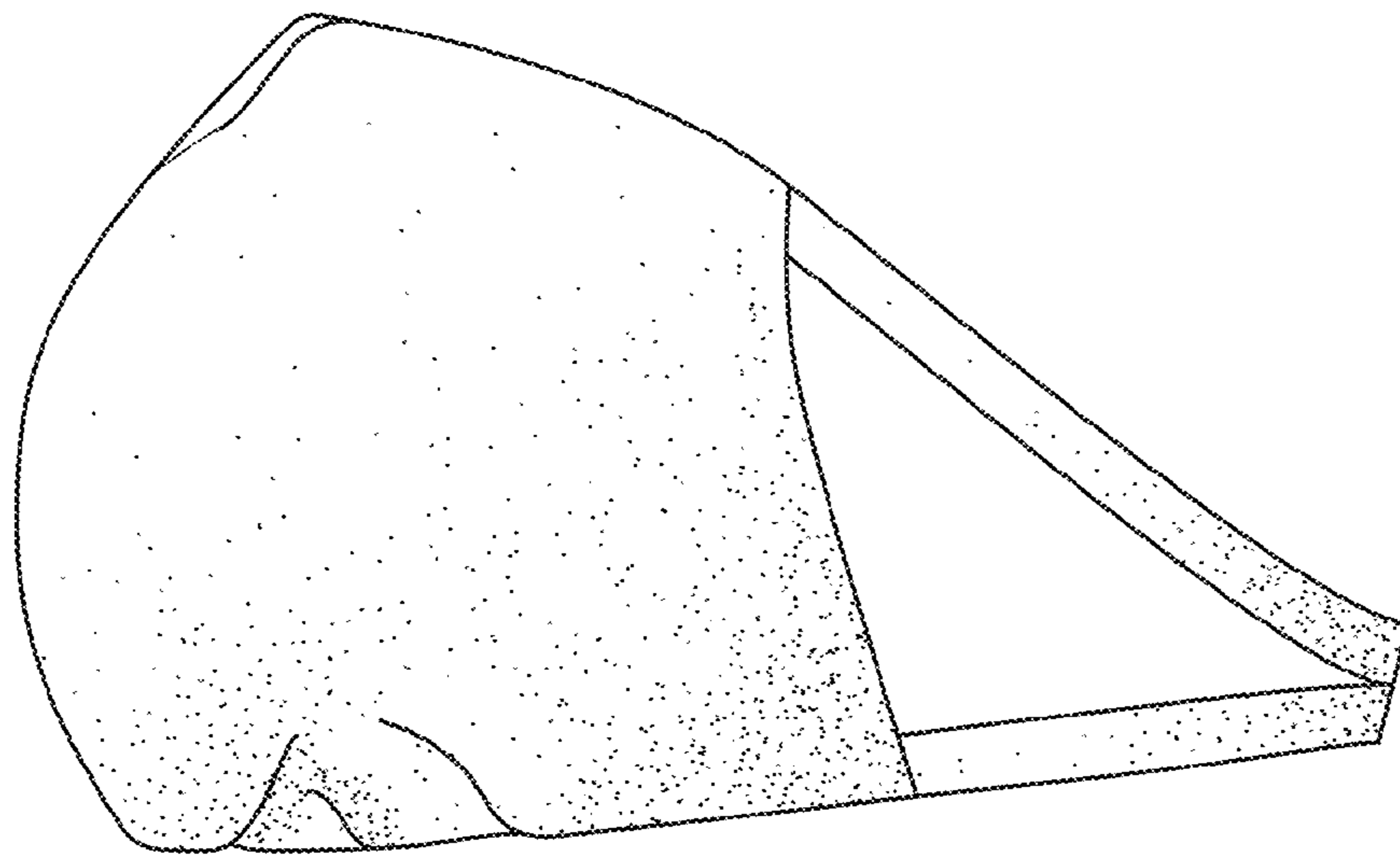

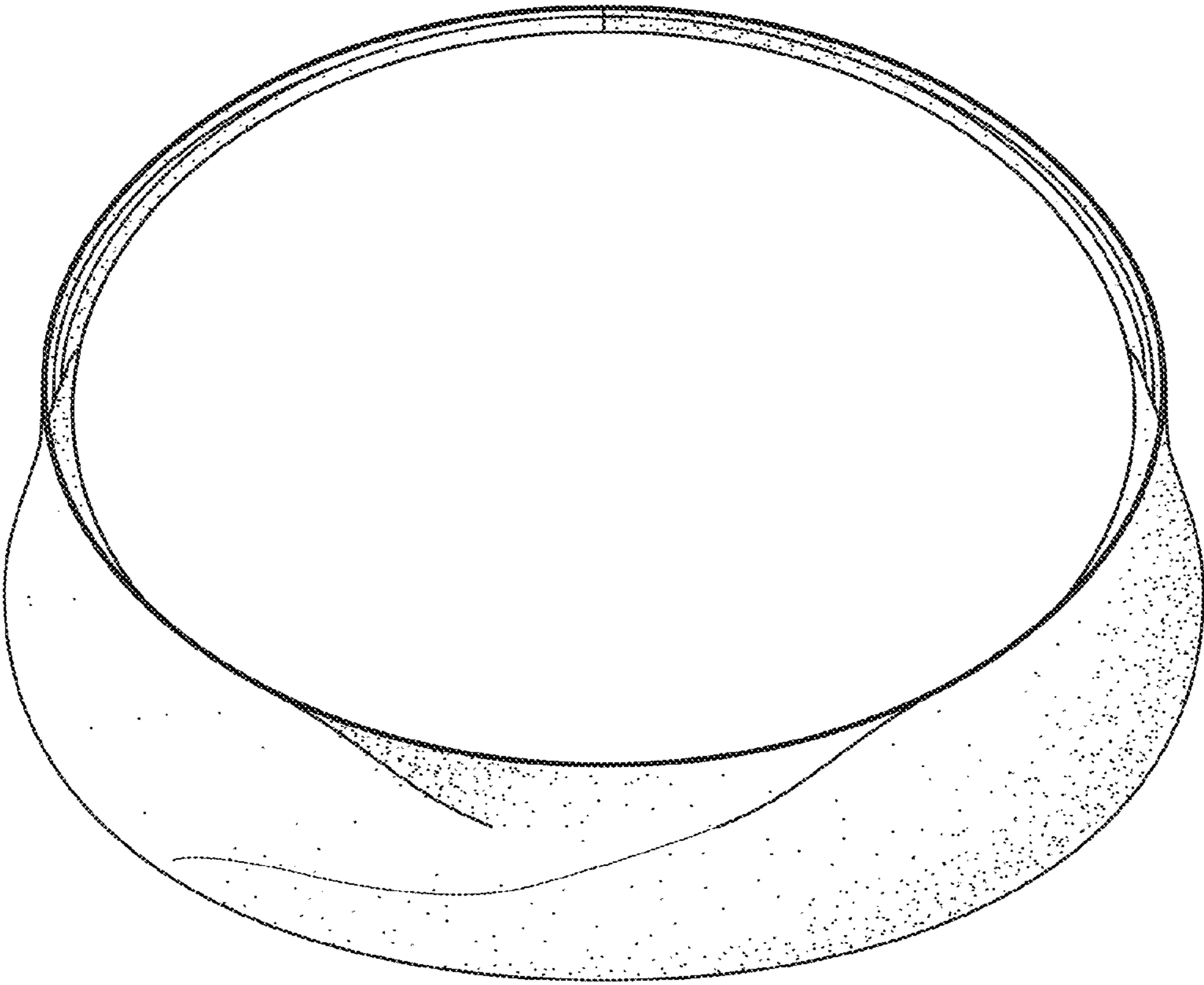

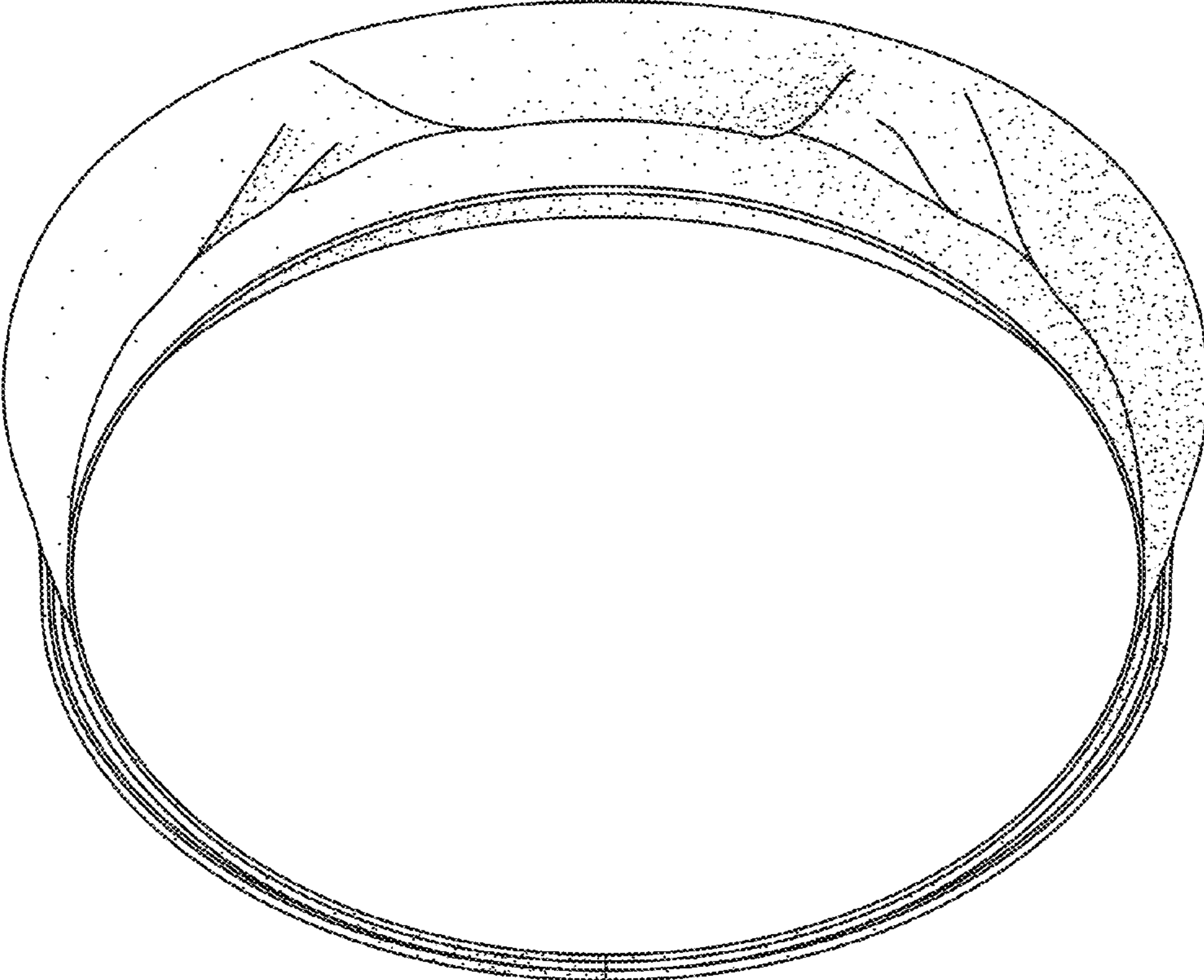
