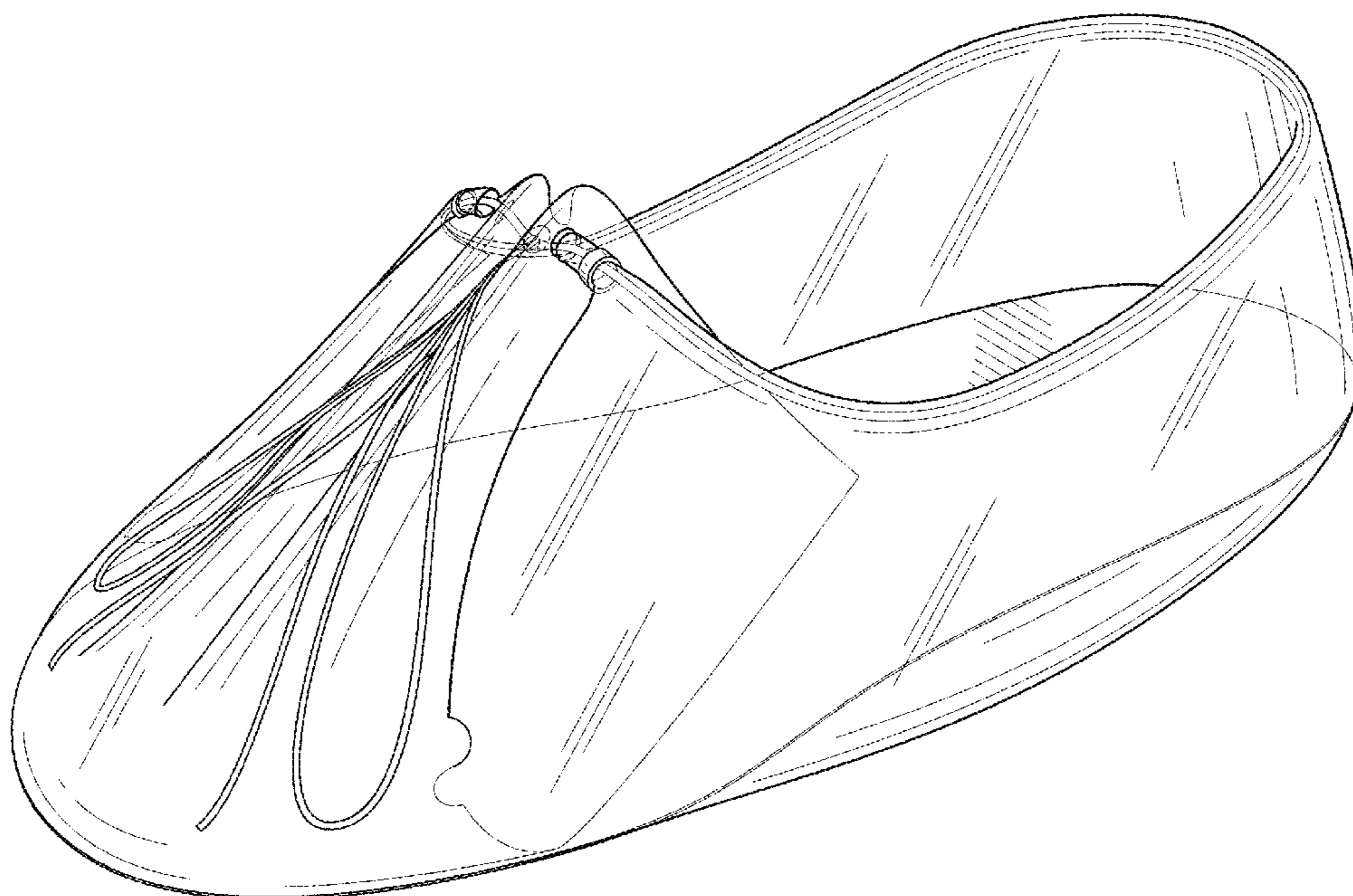

DESCRIPTION

FIG. 1 is a perspective view of a footwear for temporary use showing my new design;

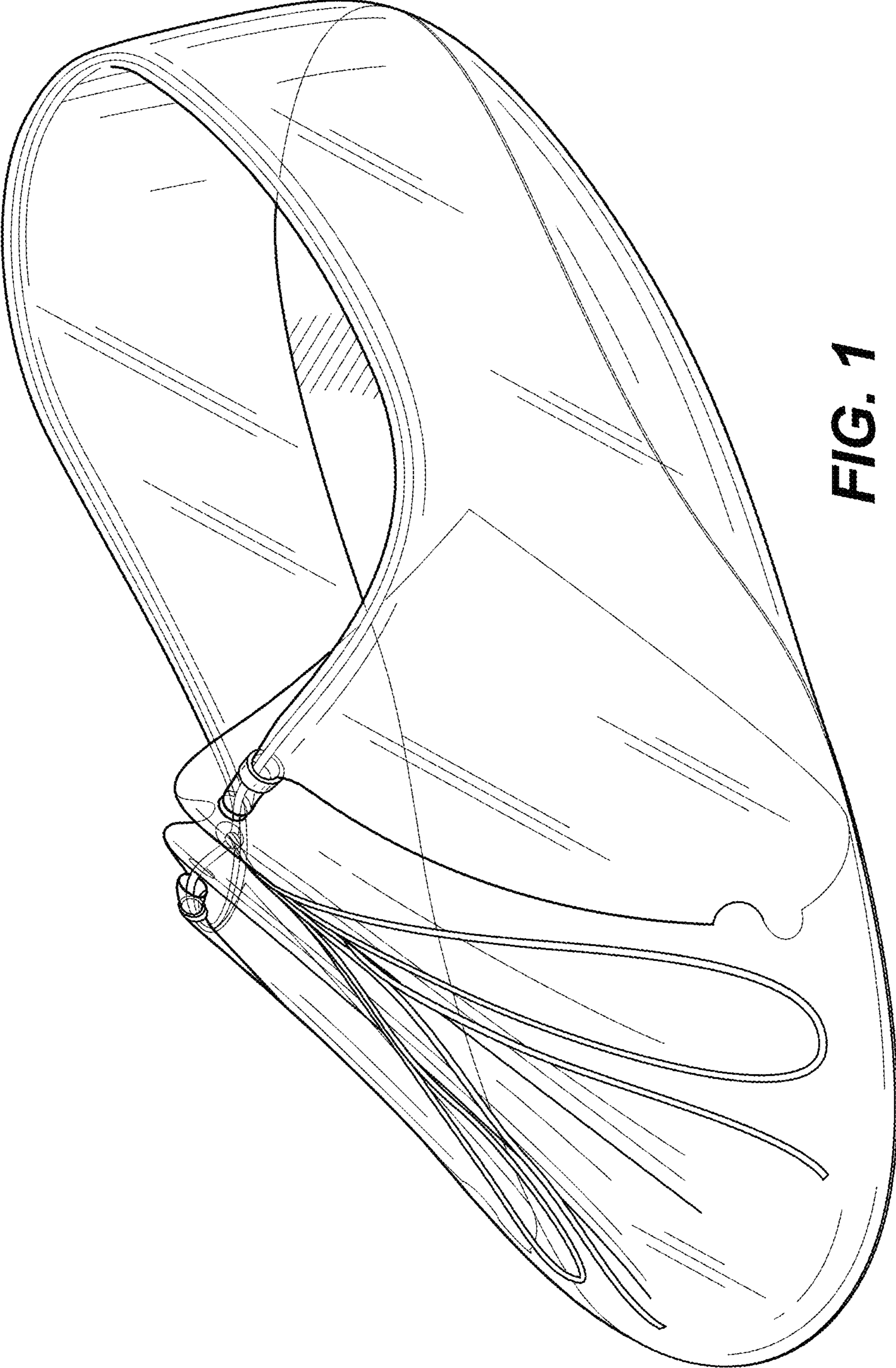

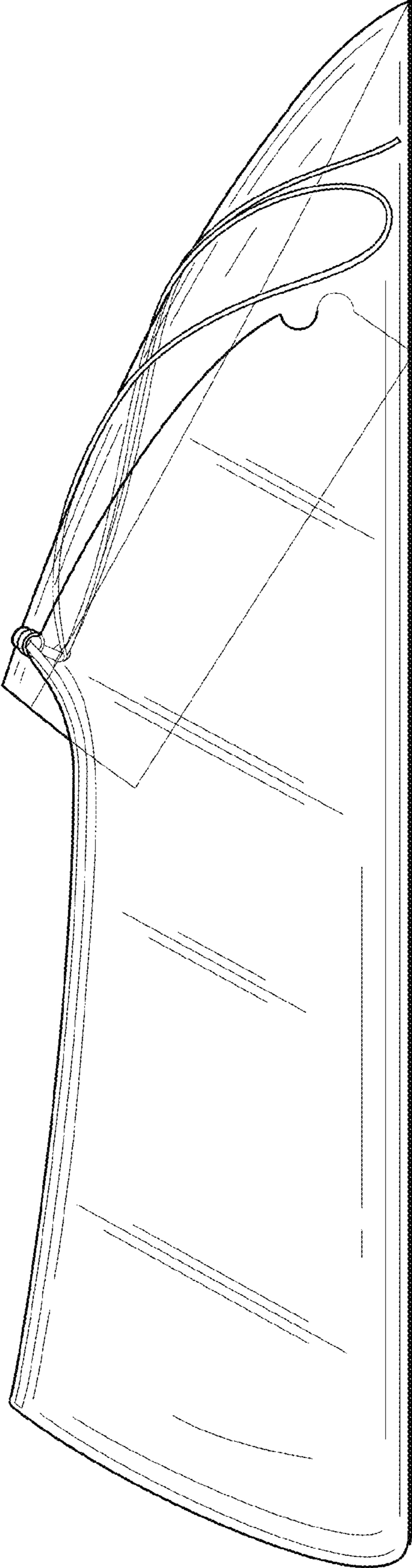

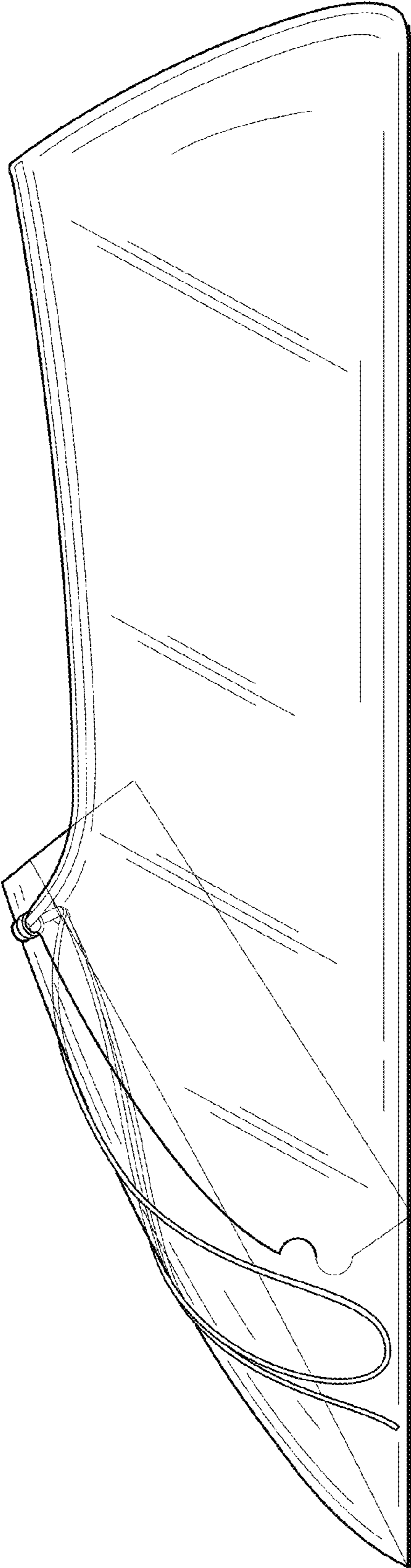

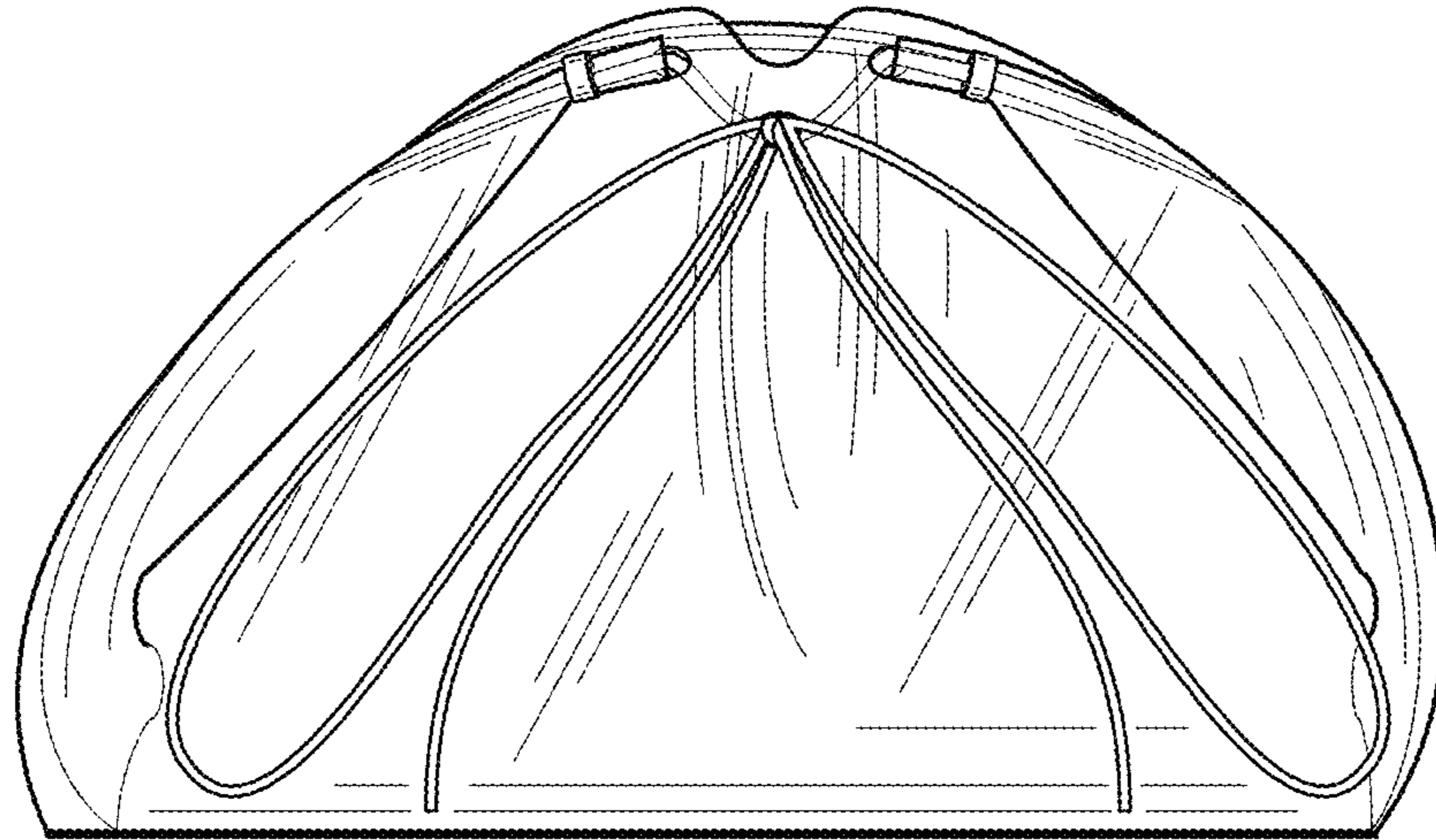

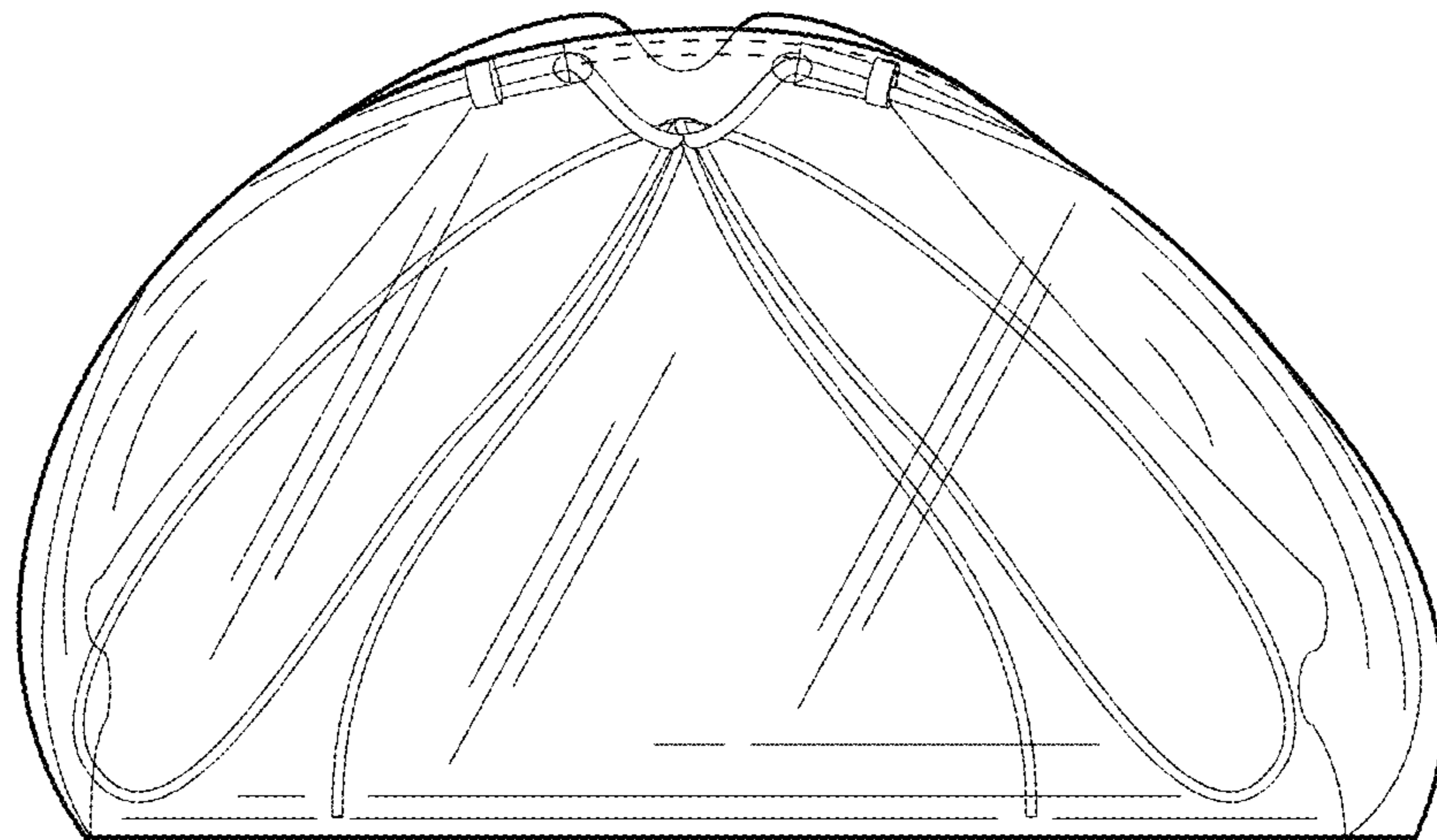

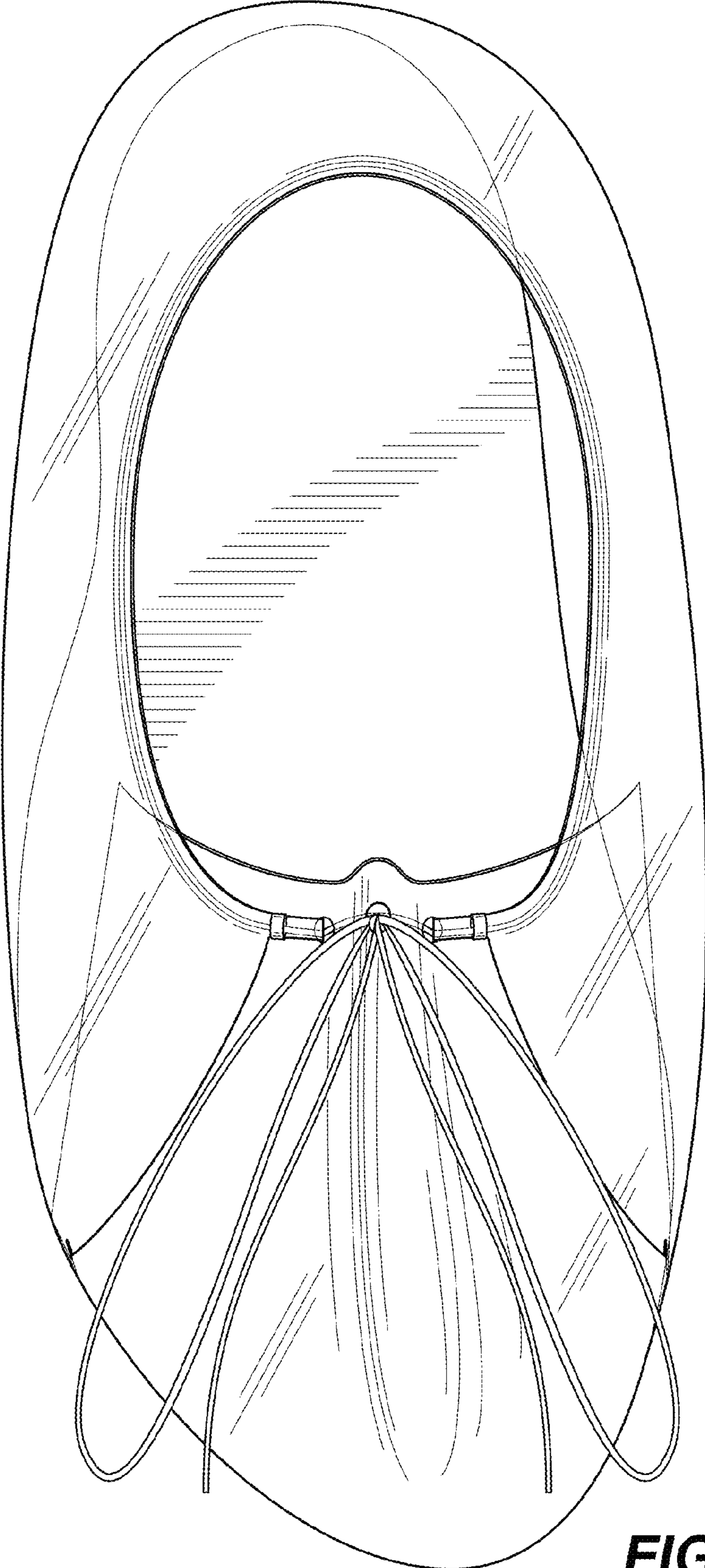

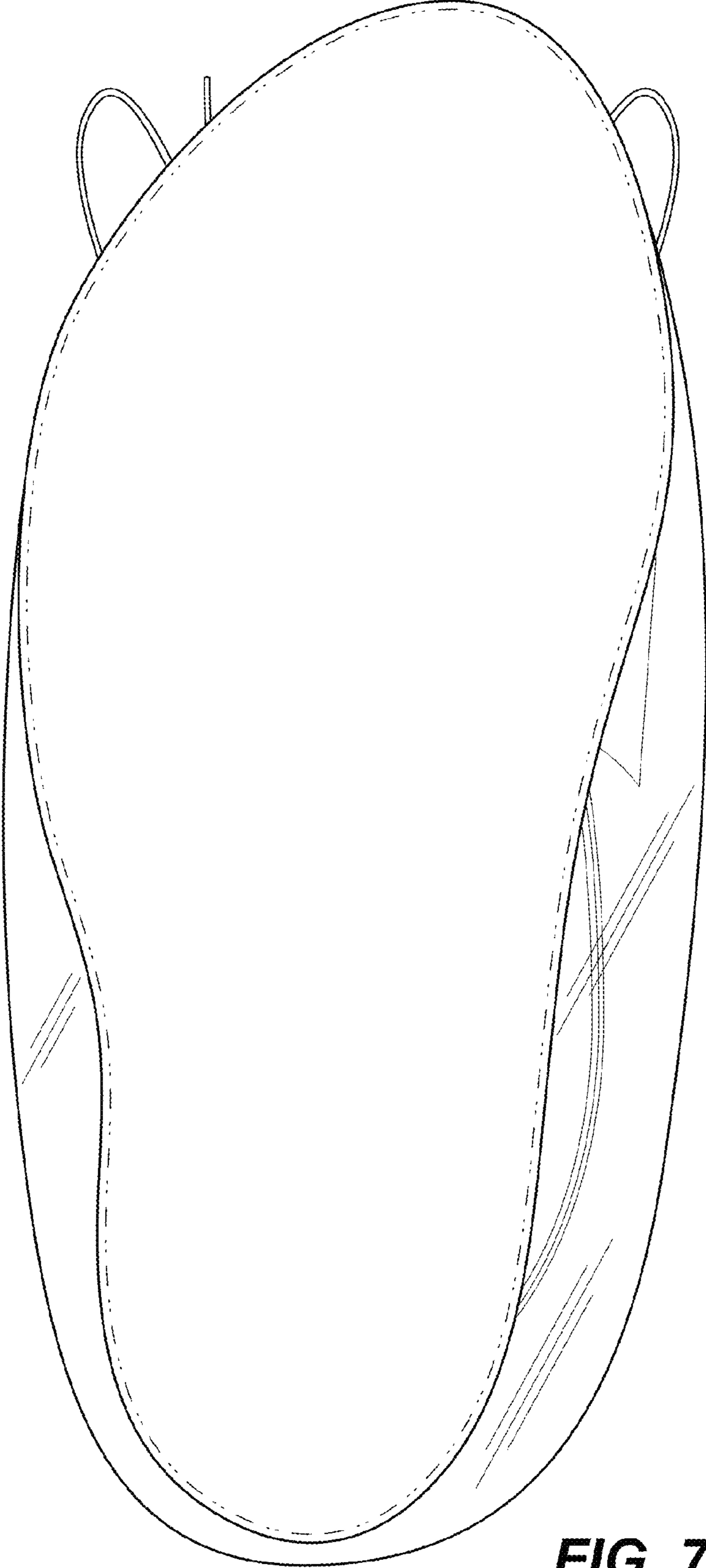
