FIG. 11 is a front view of the seat.

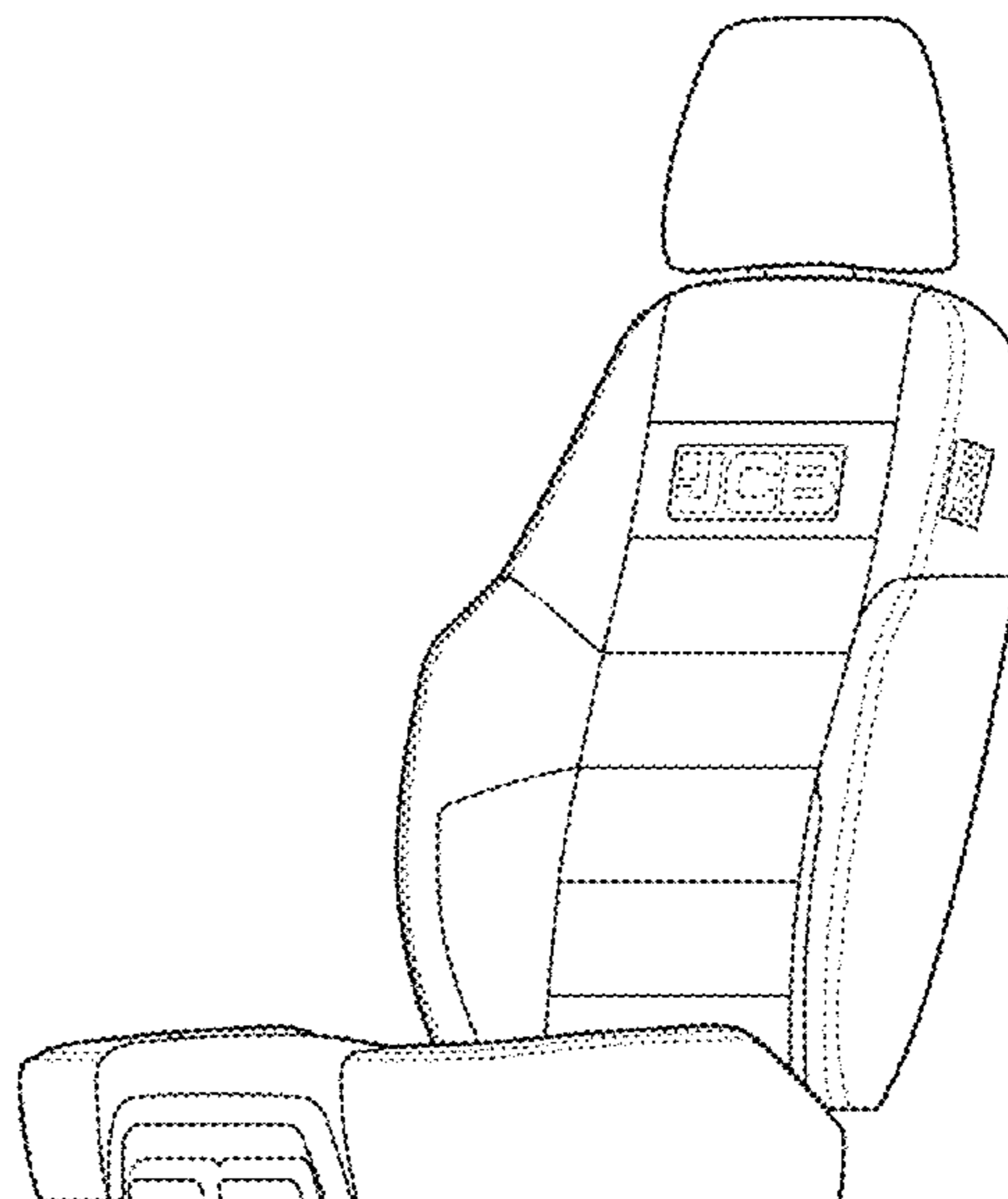
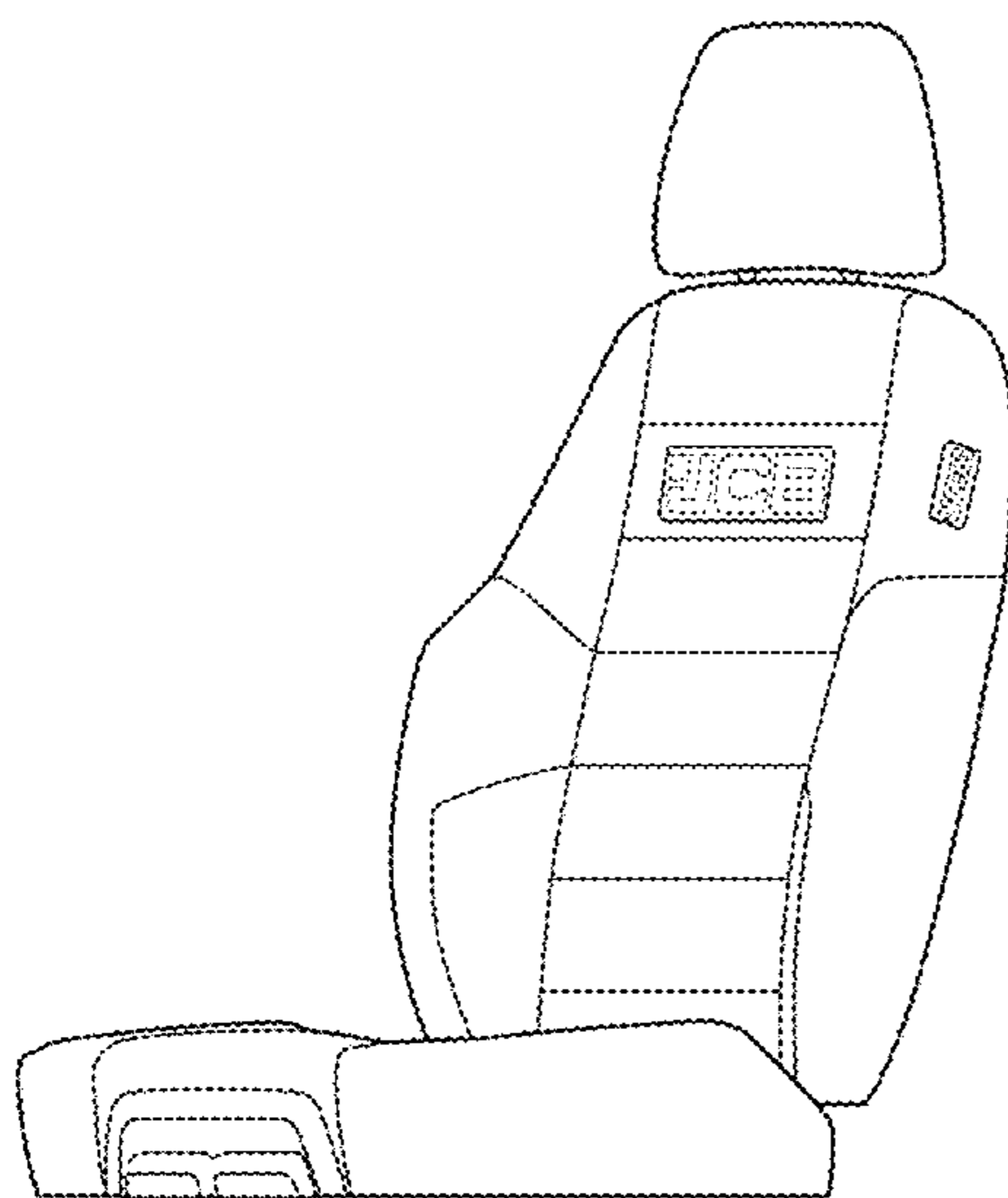
FIG. 12 is a back view of the seat.

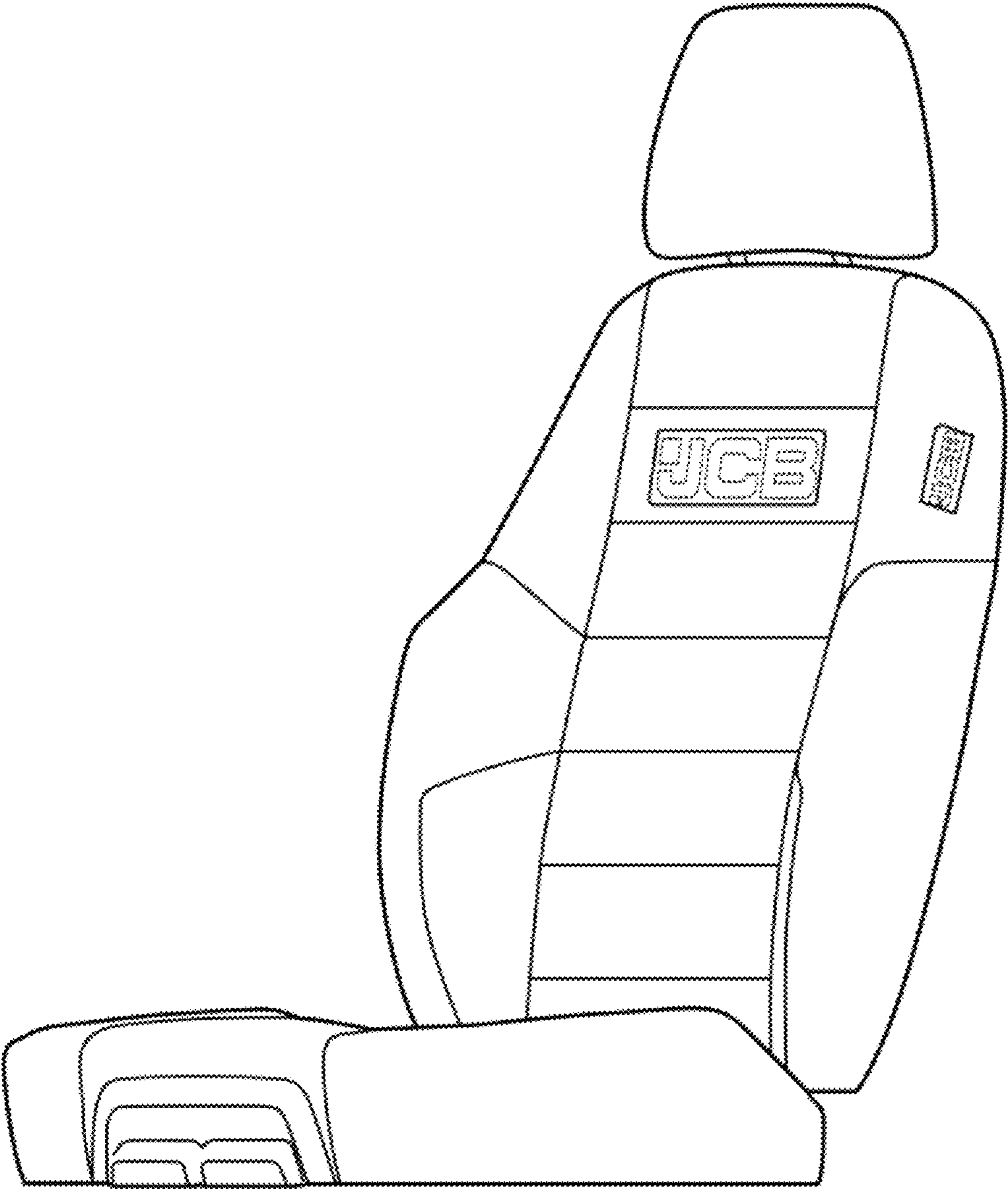

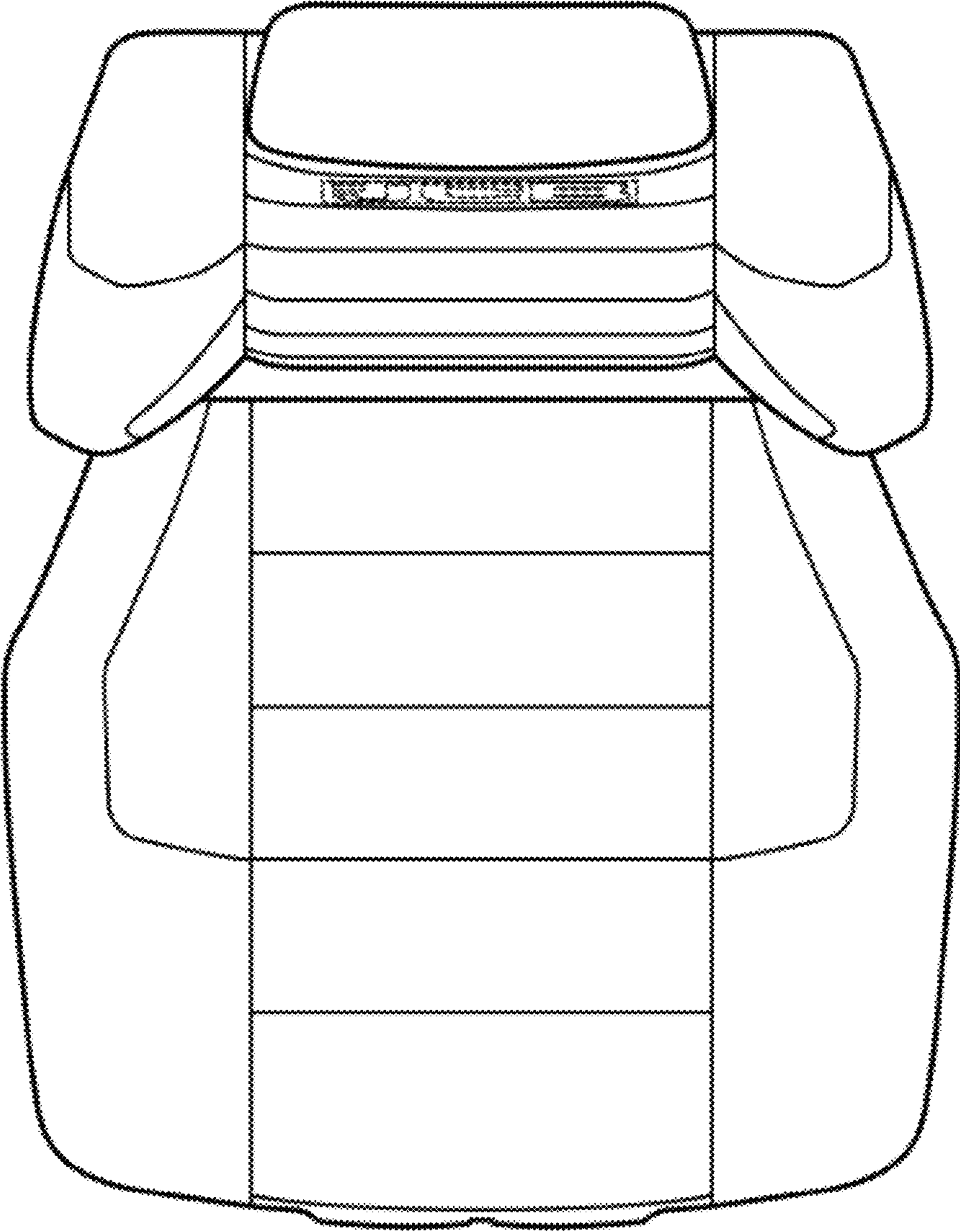

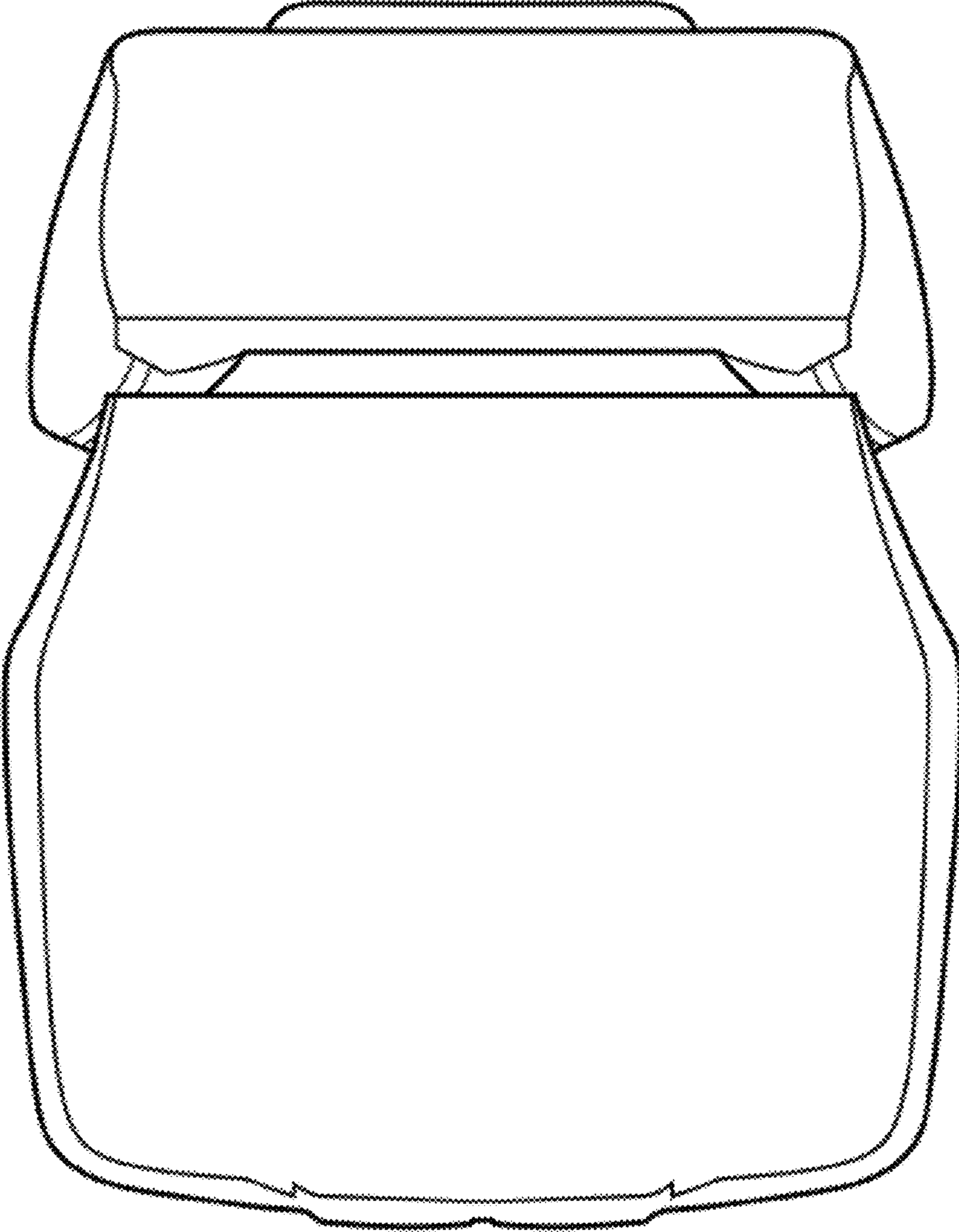

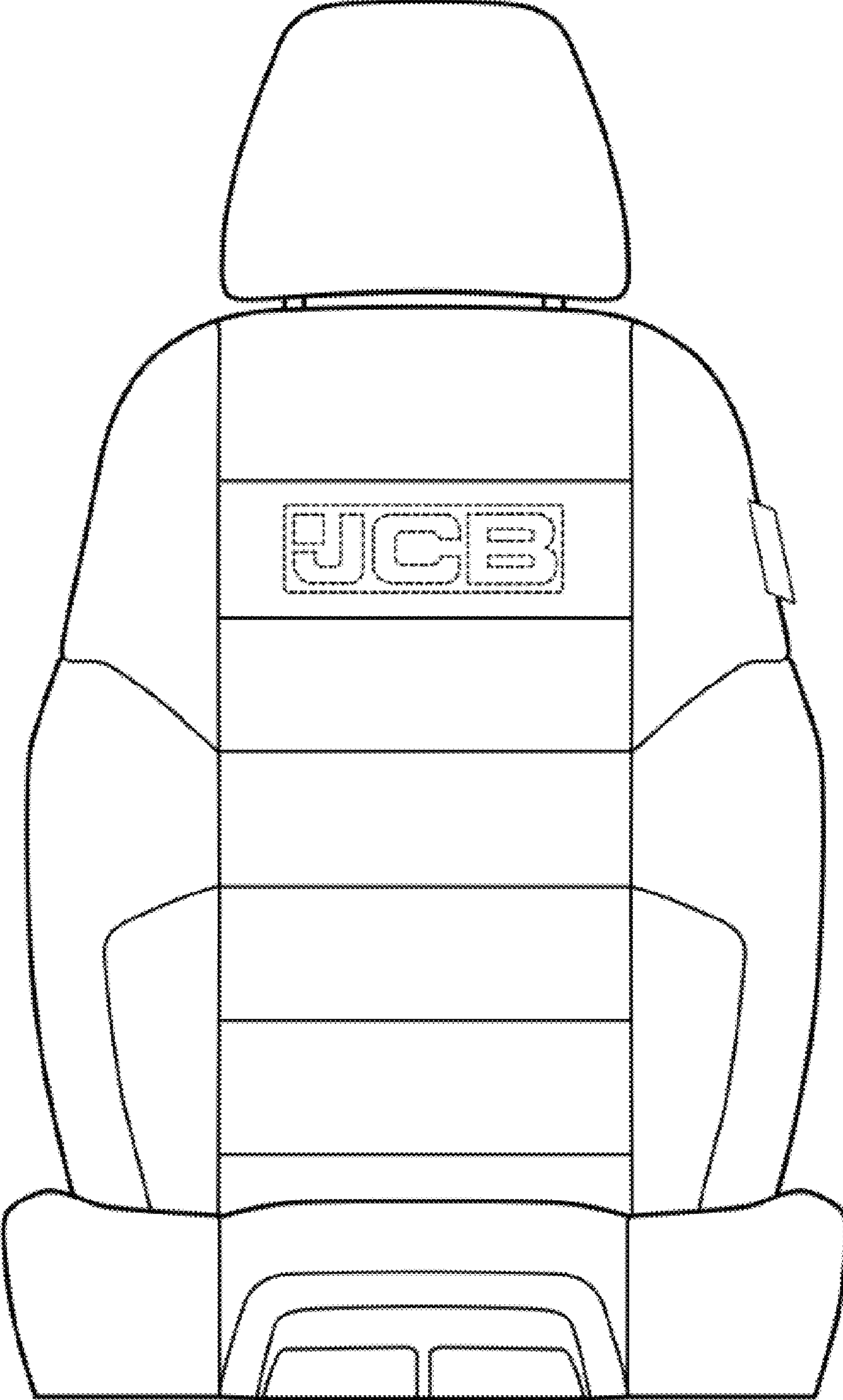

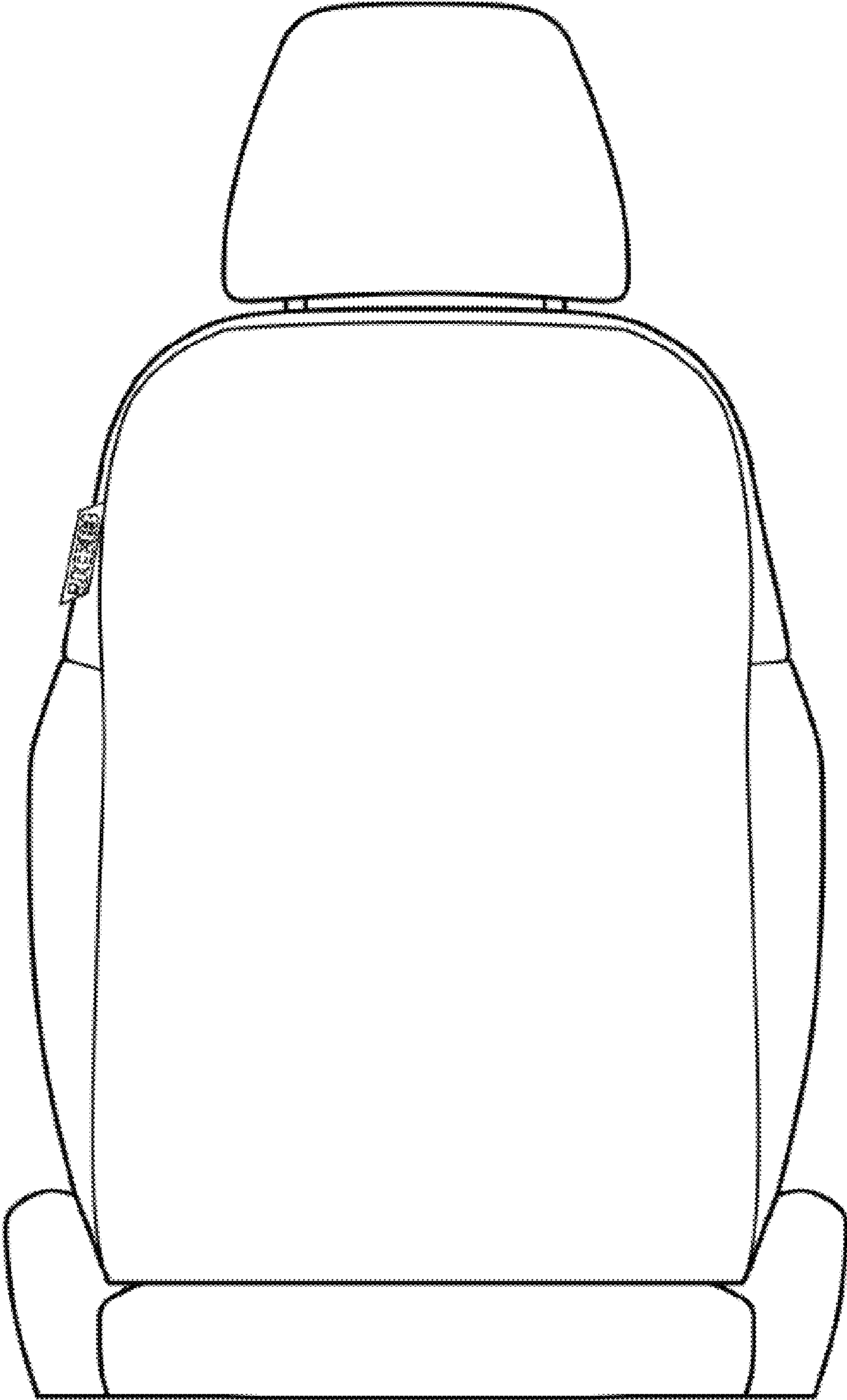

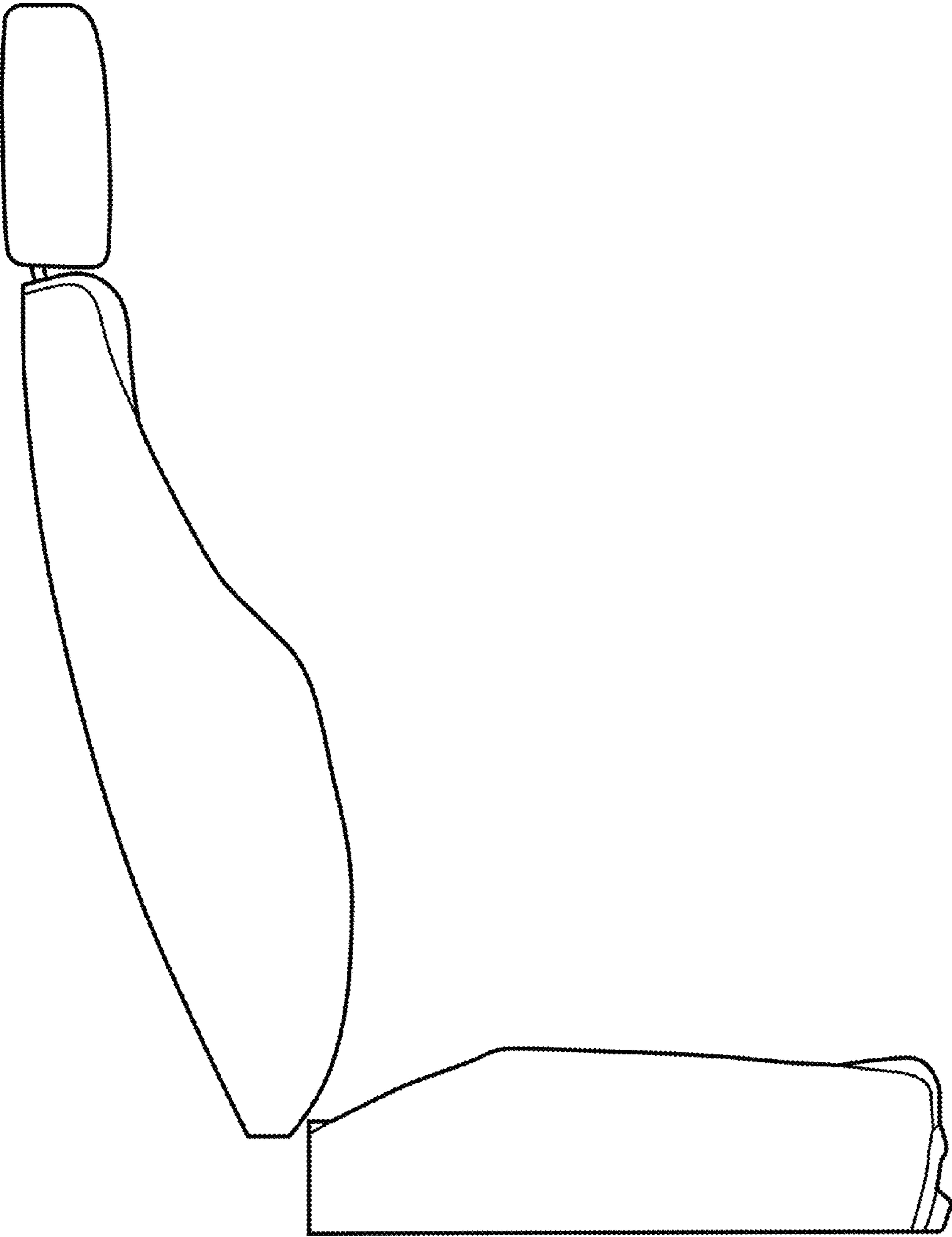

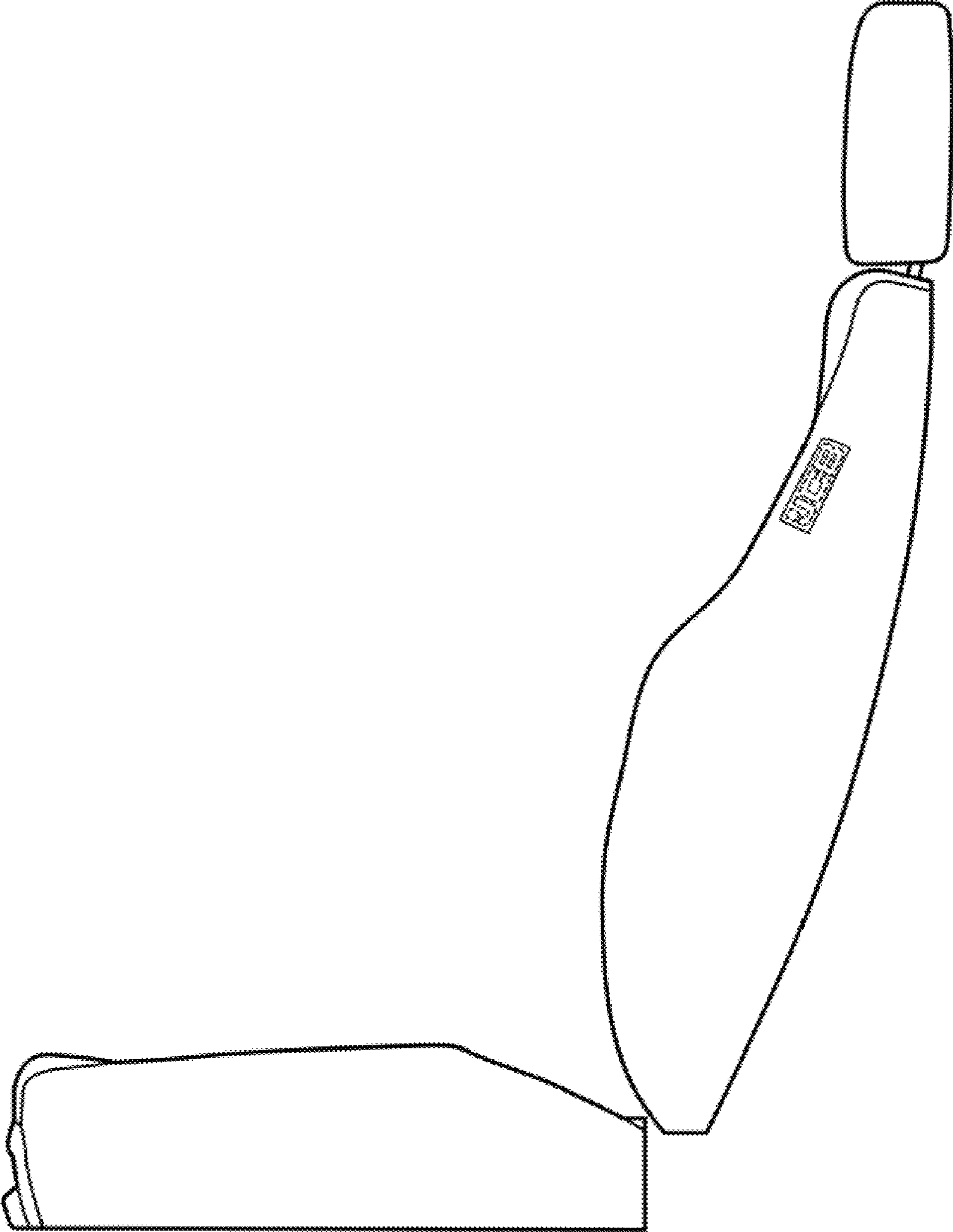

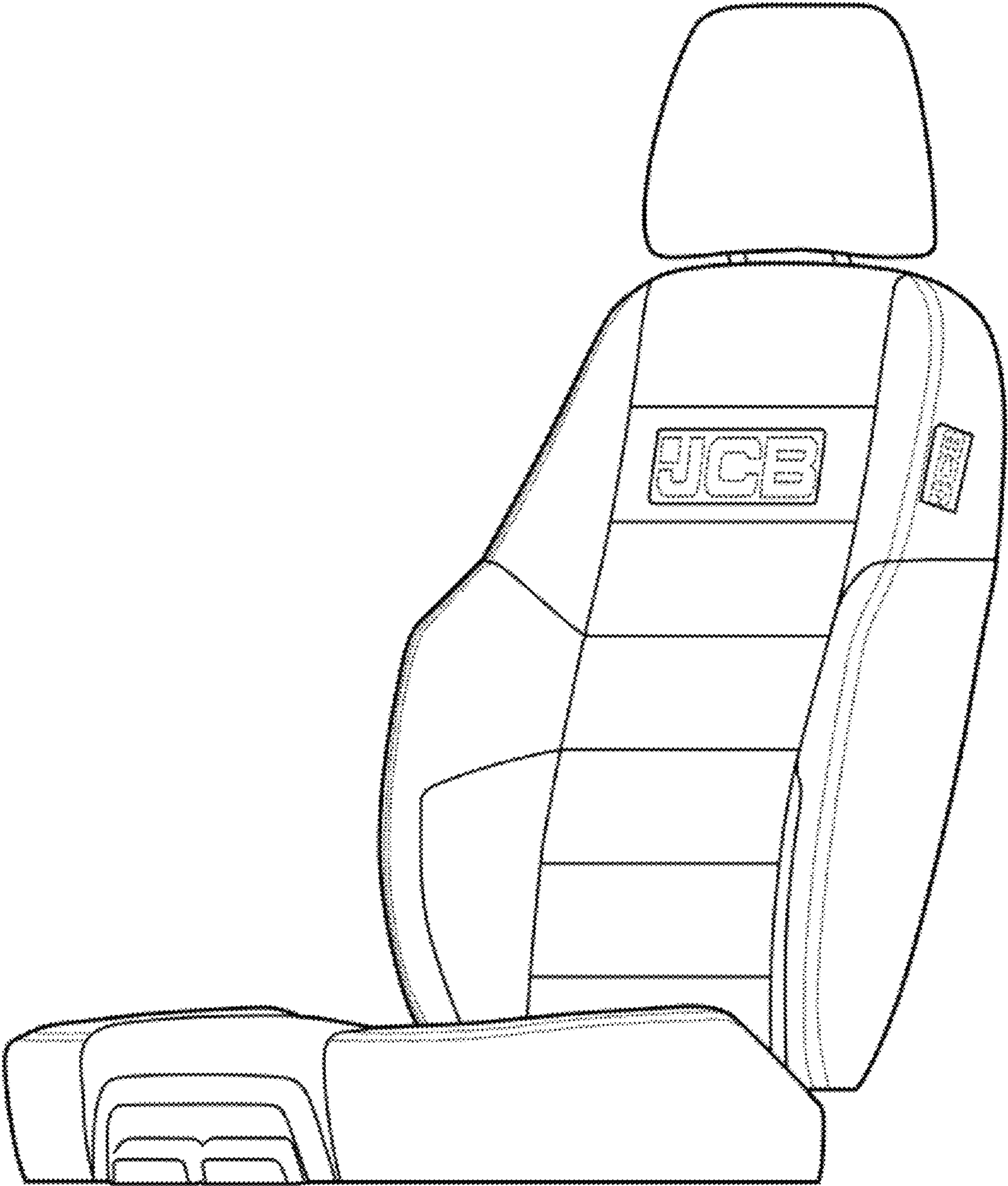

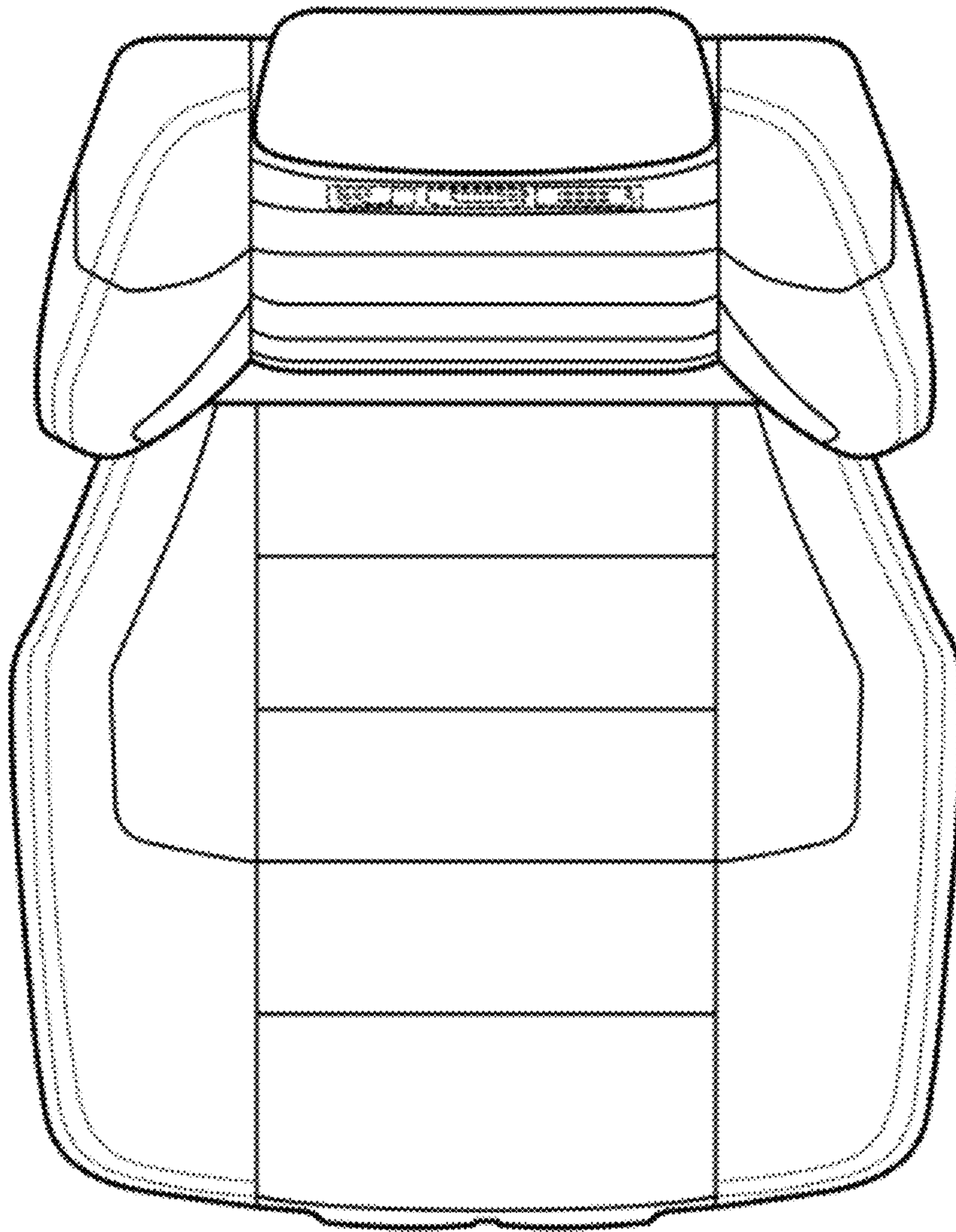

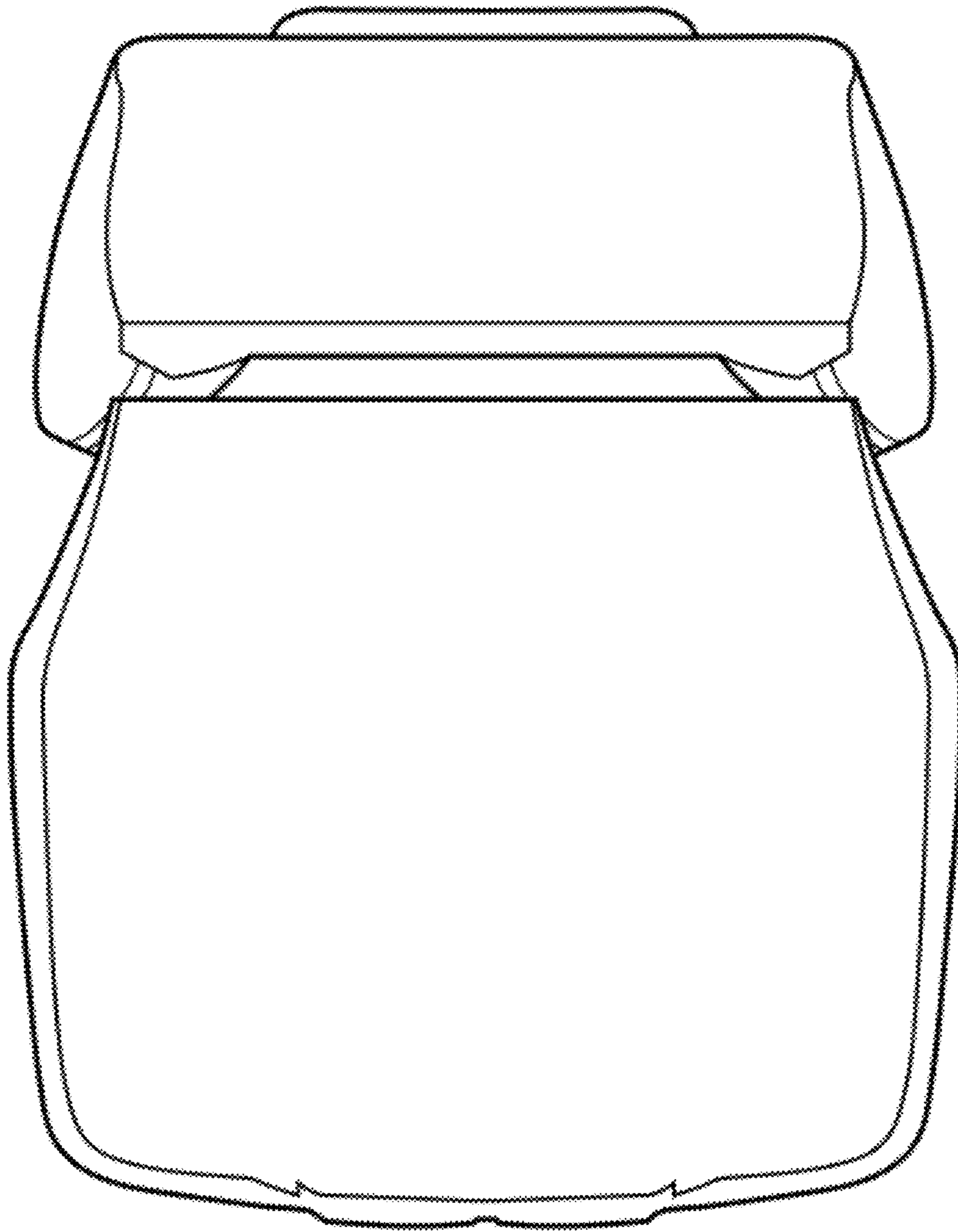

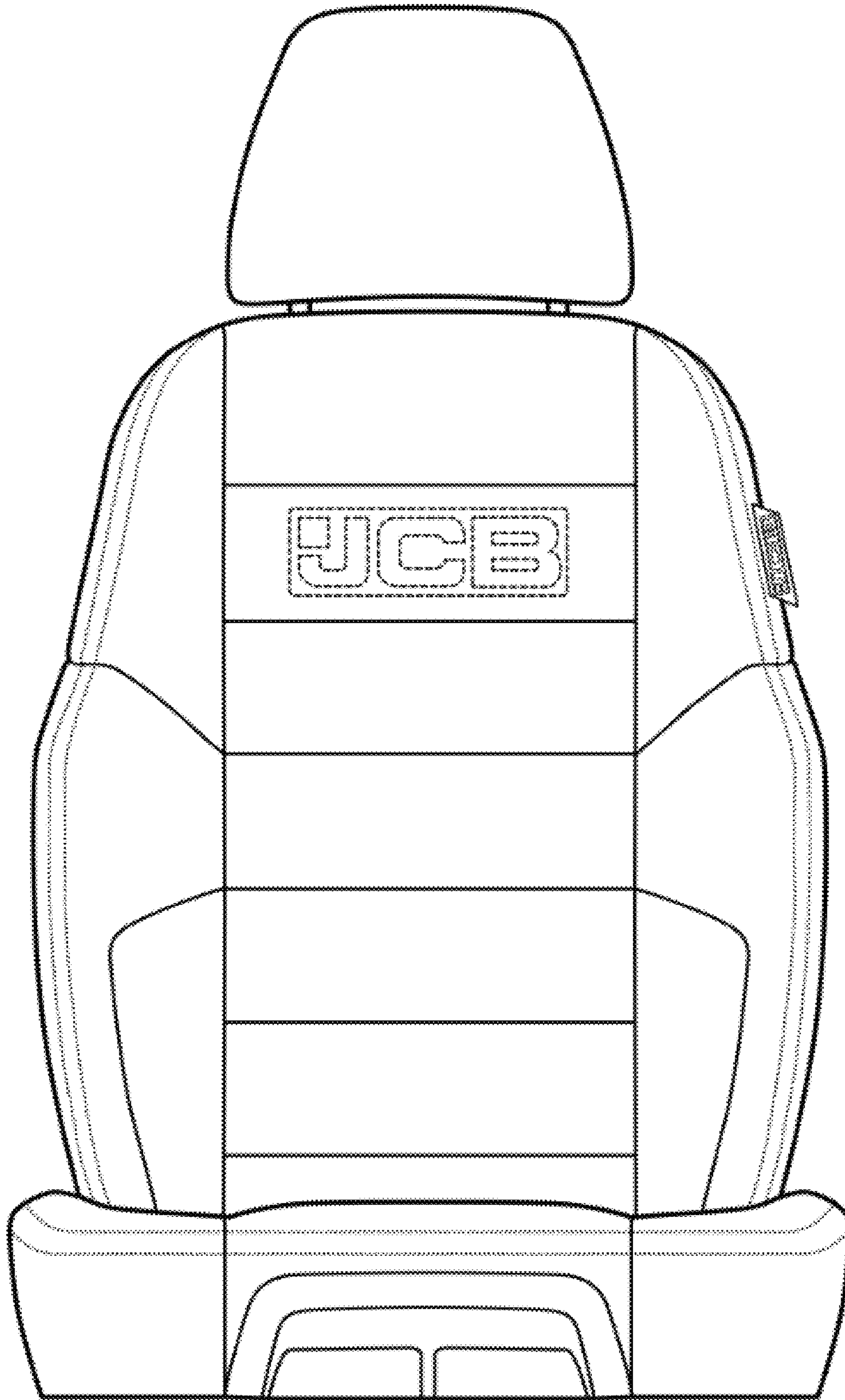

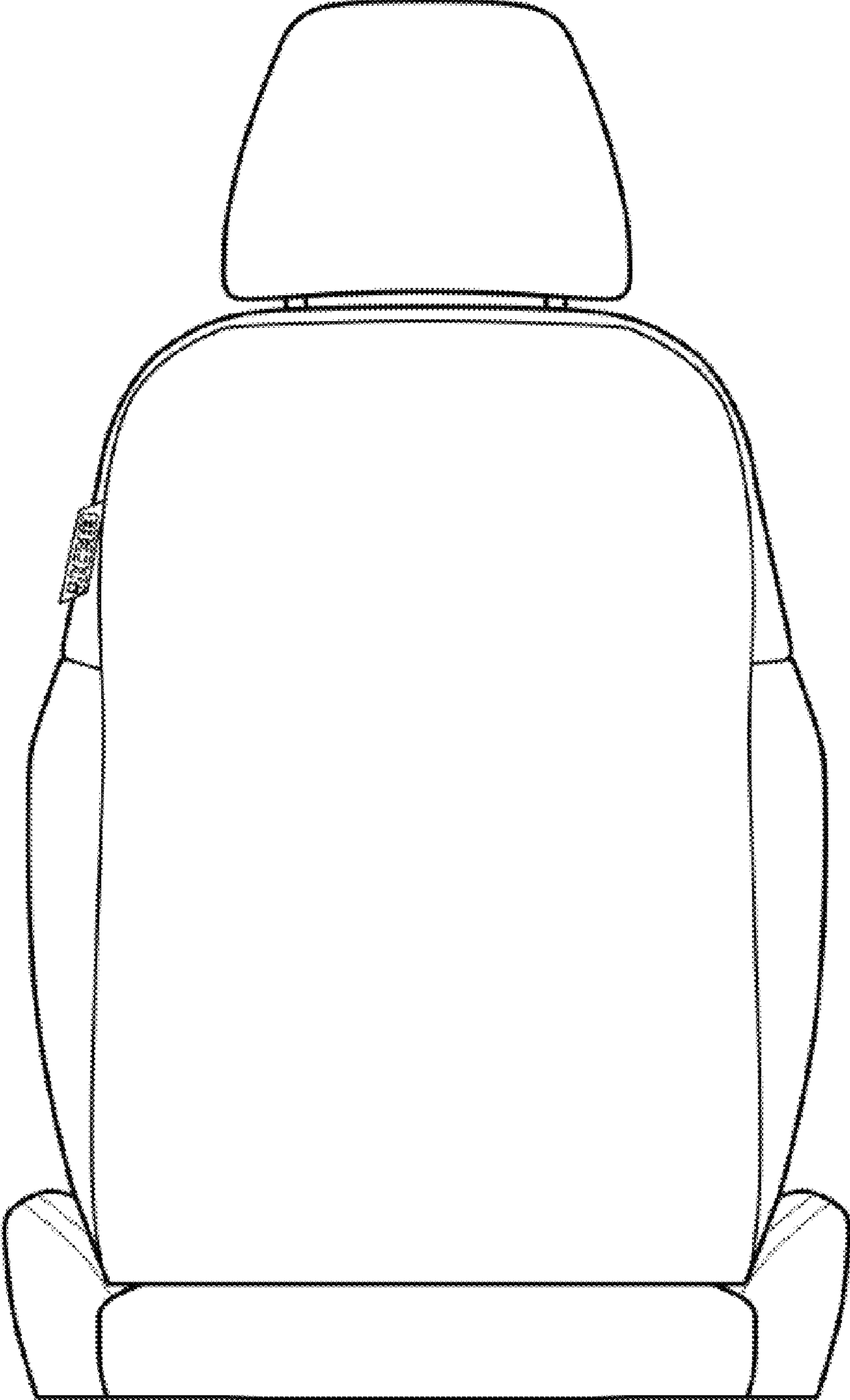

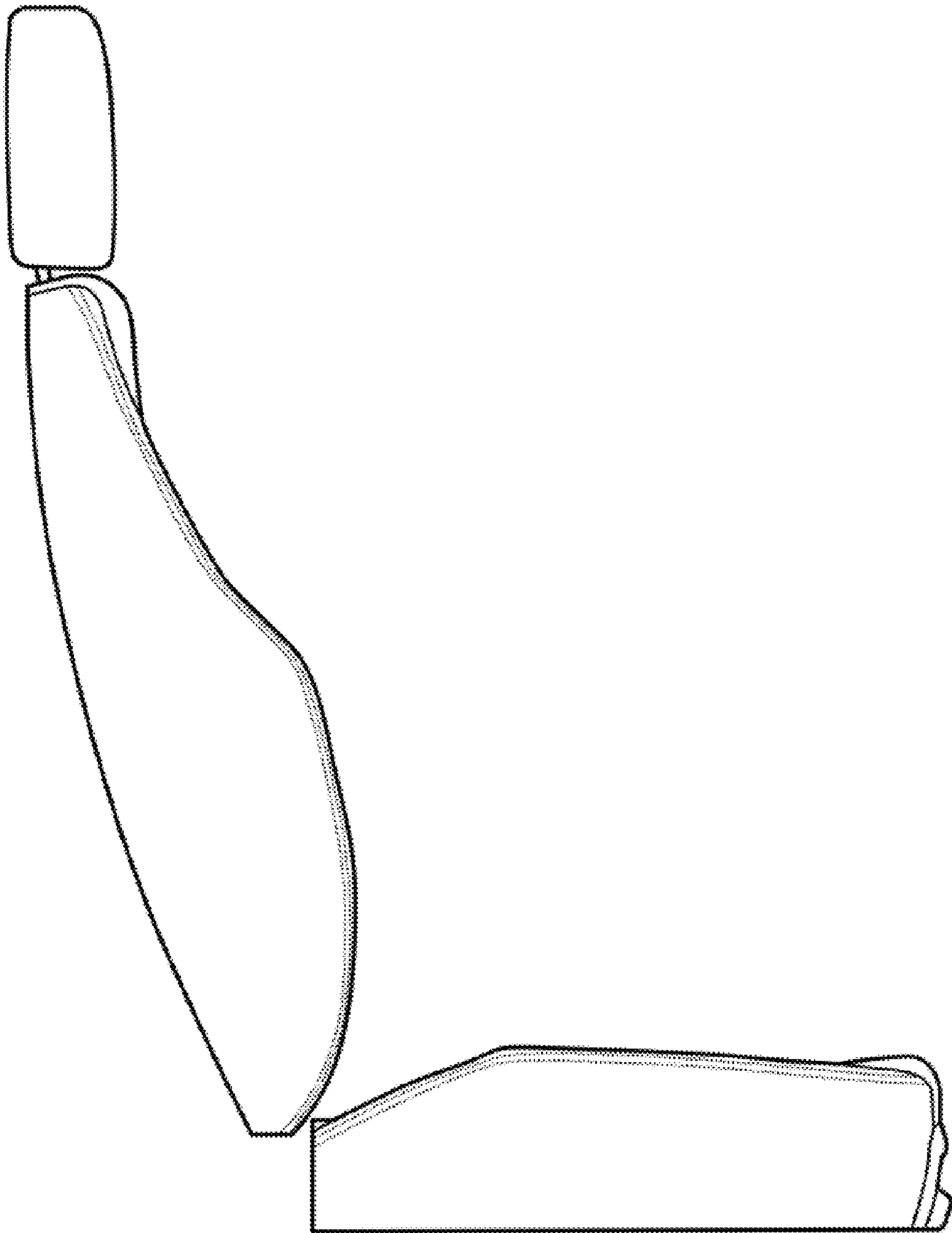

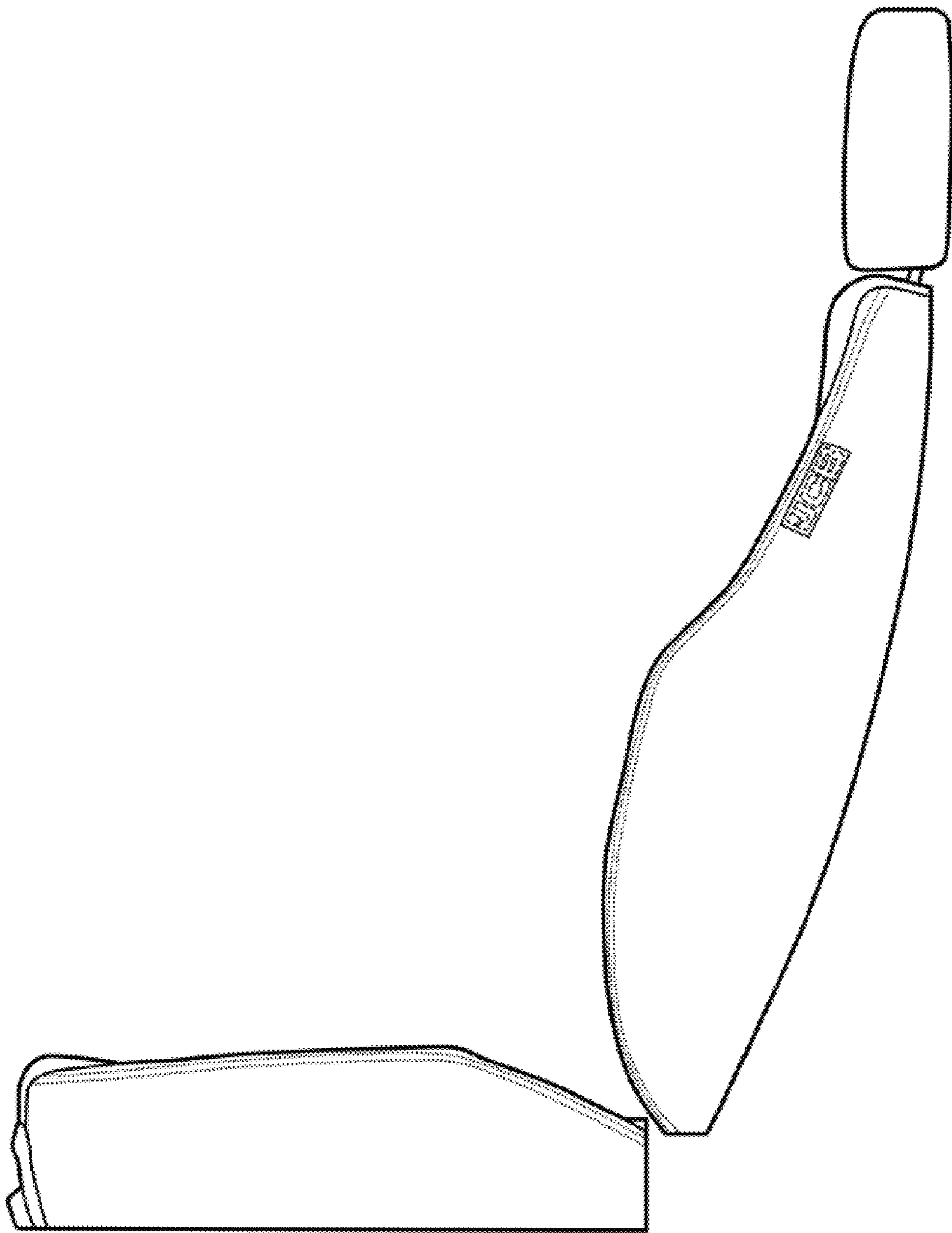
