DESCRIPTION

FIG. 1 is a right front perspective view of my invention;

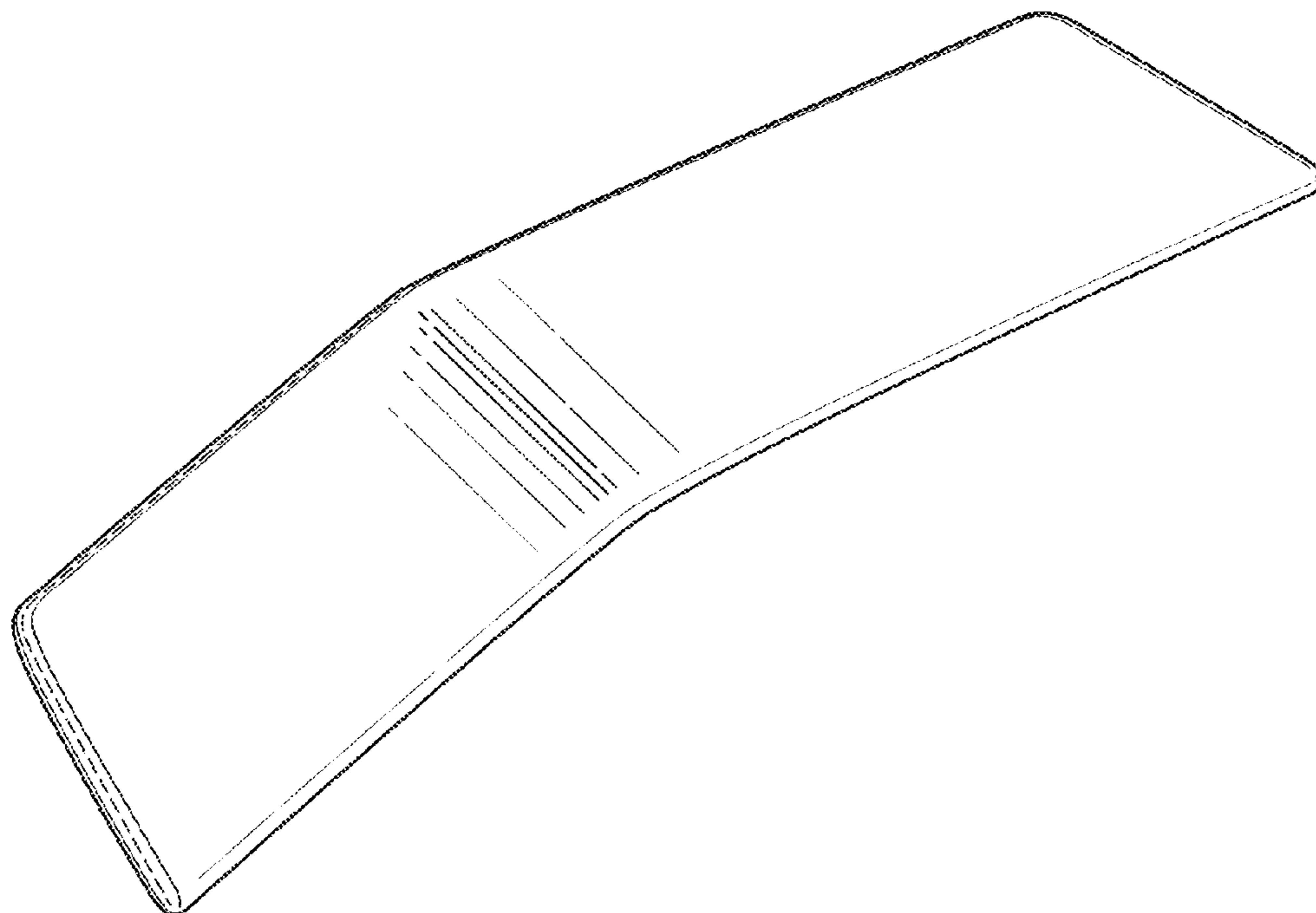

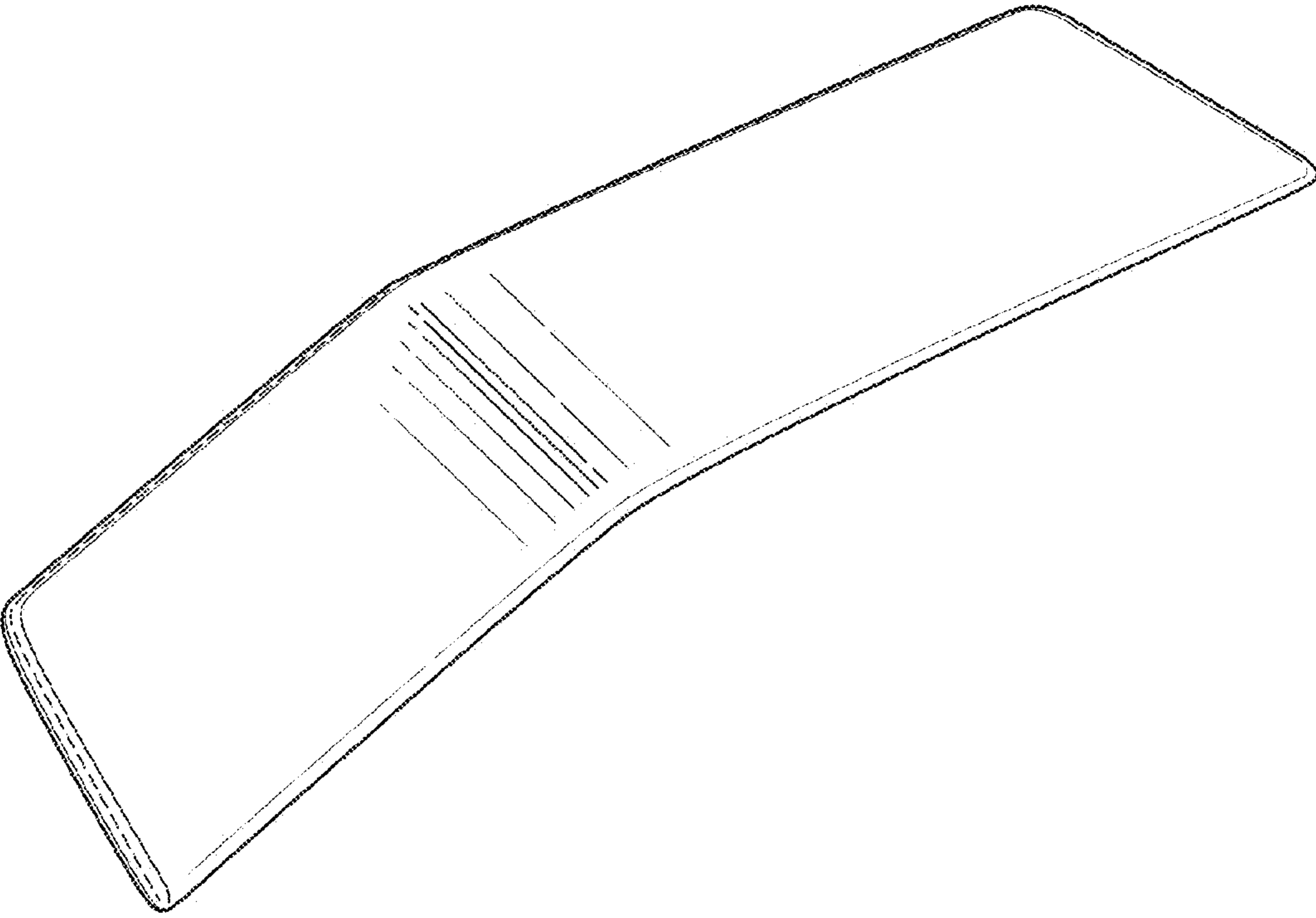

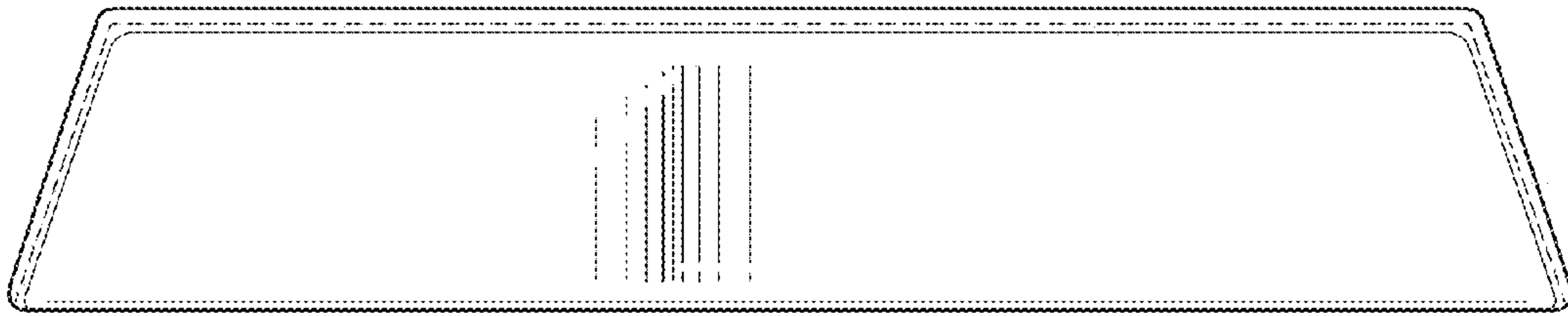

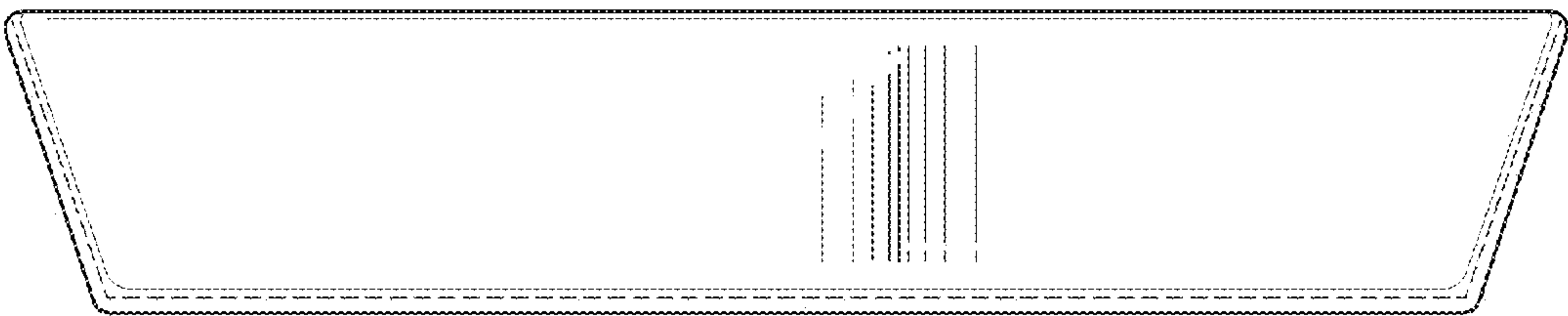

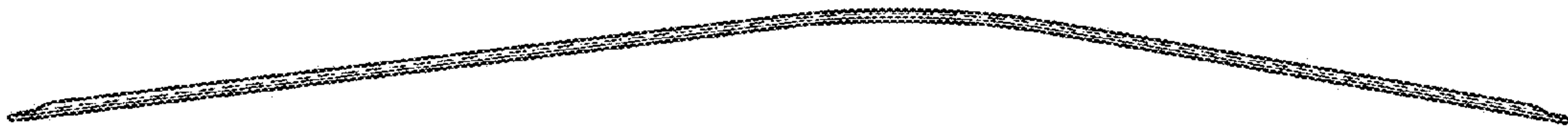

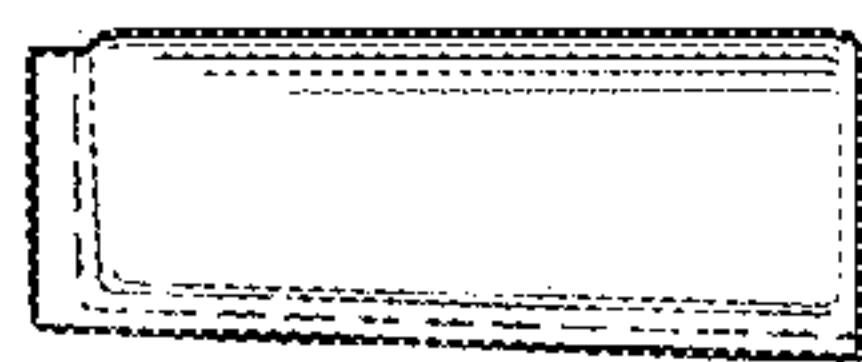
