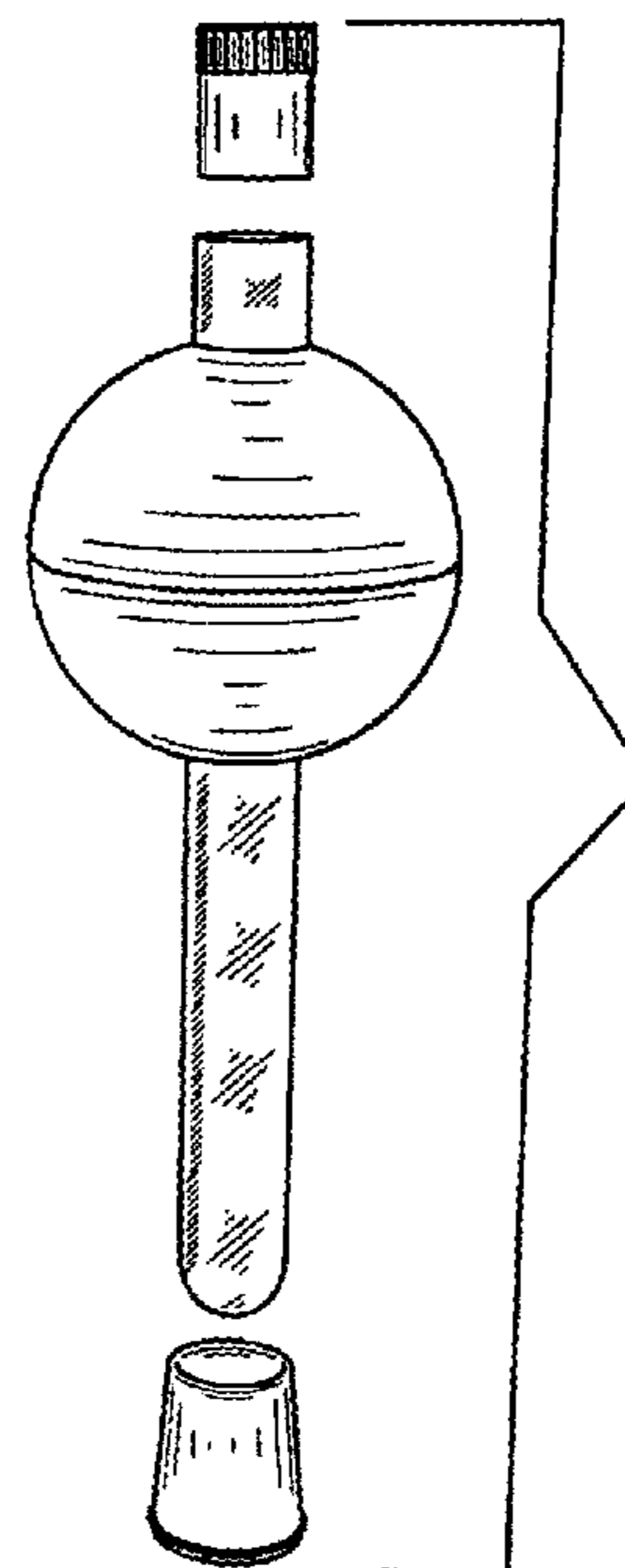
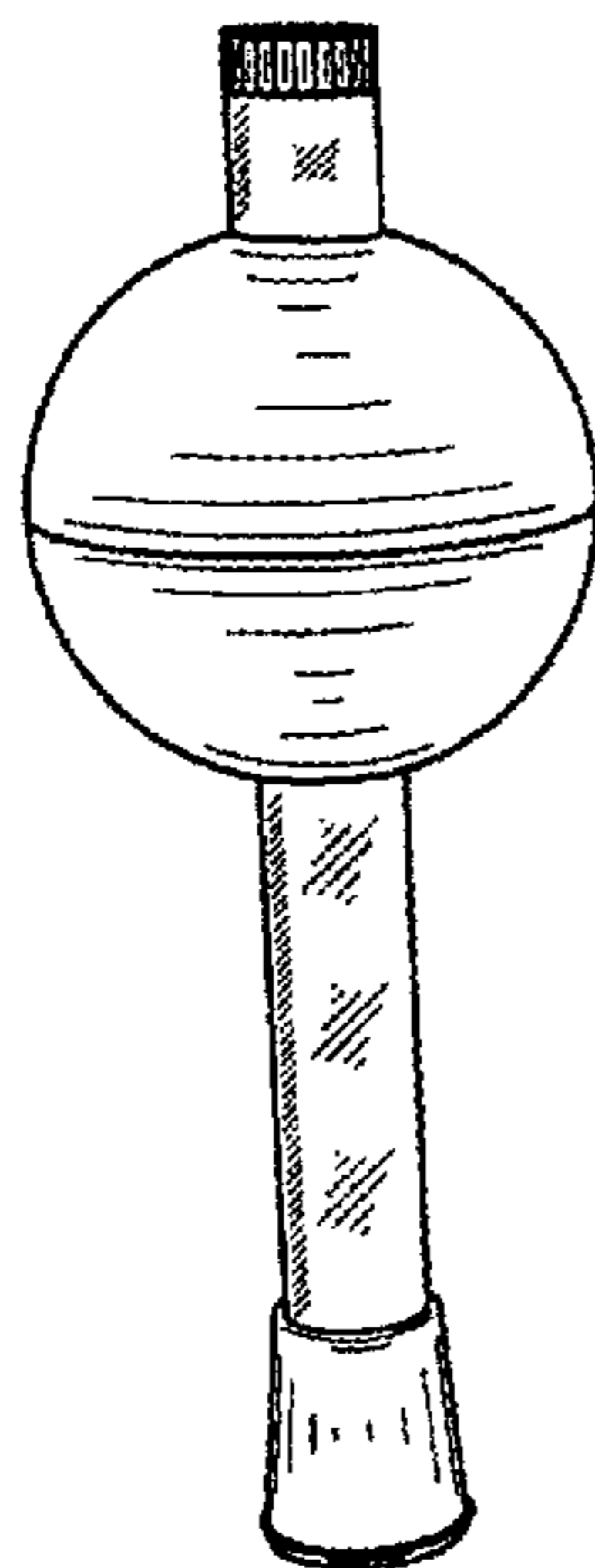
(57) **CLAIM**

The ornamental design for a floating beverage holder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the floating beverage holder in an inoperative position.
 FIG. 2 is an exploded perspective view of the floating beverage holder of FIG. 1.
 FIG. 3 is a front view, rear view, left side view, and right side view of the floating beverage holder of FIG. 1.
 FIG. 4 is a top view thereof; and,
 FIG. 5 is a bottom view thereof.
 The claimed floating beverage holder when in an inoperative position is supported by a stand and when in an operative position is removed from the stand and allowed to float in a body of water, such as a swimming pool.

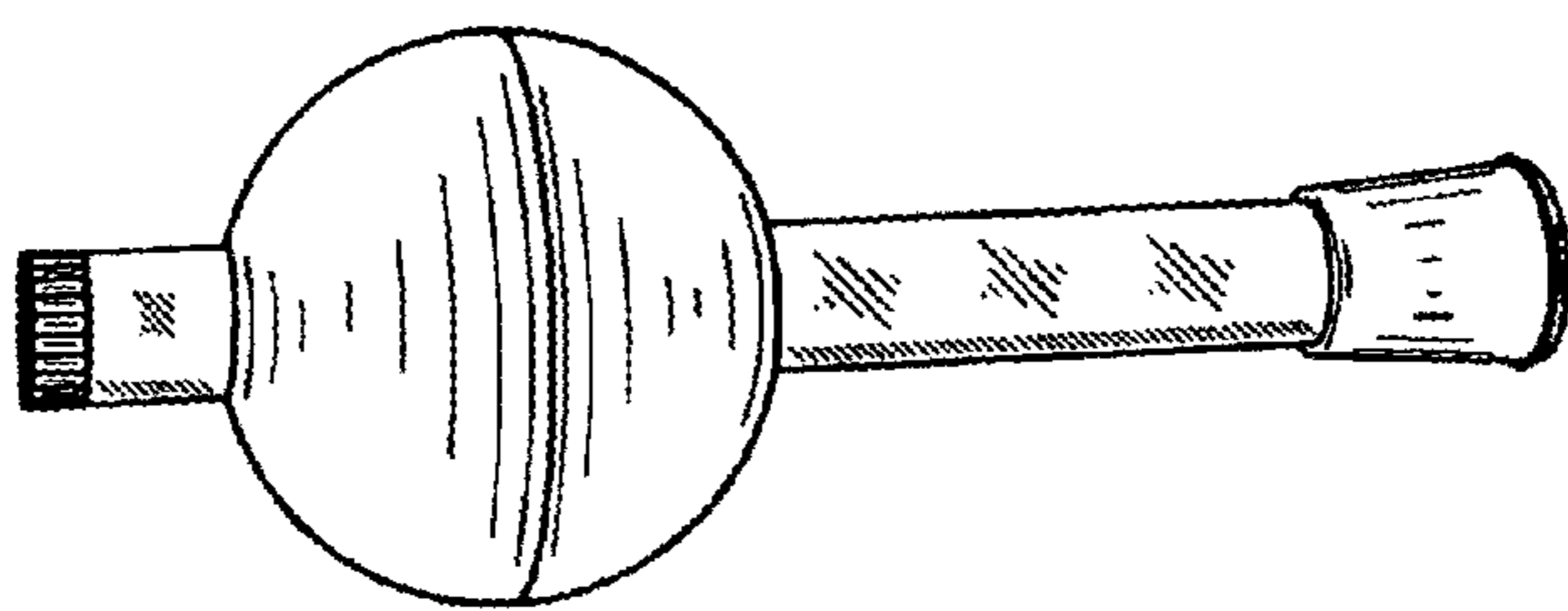

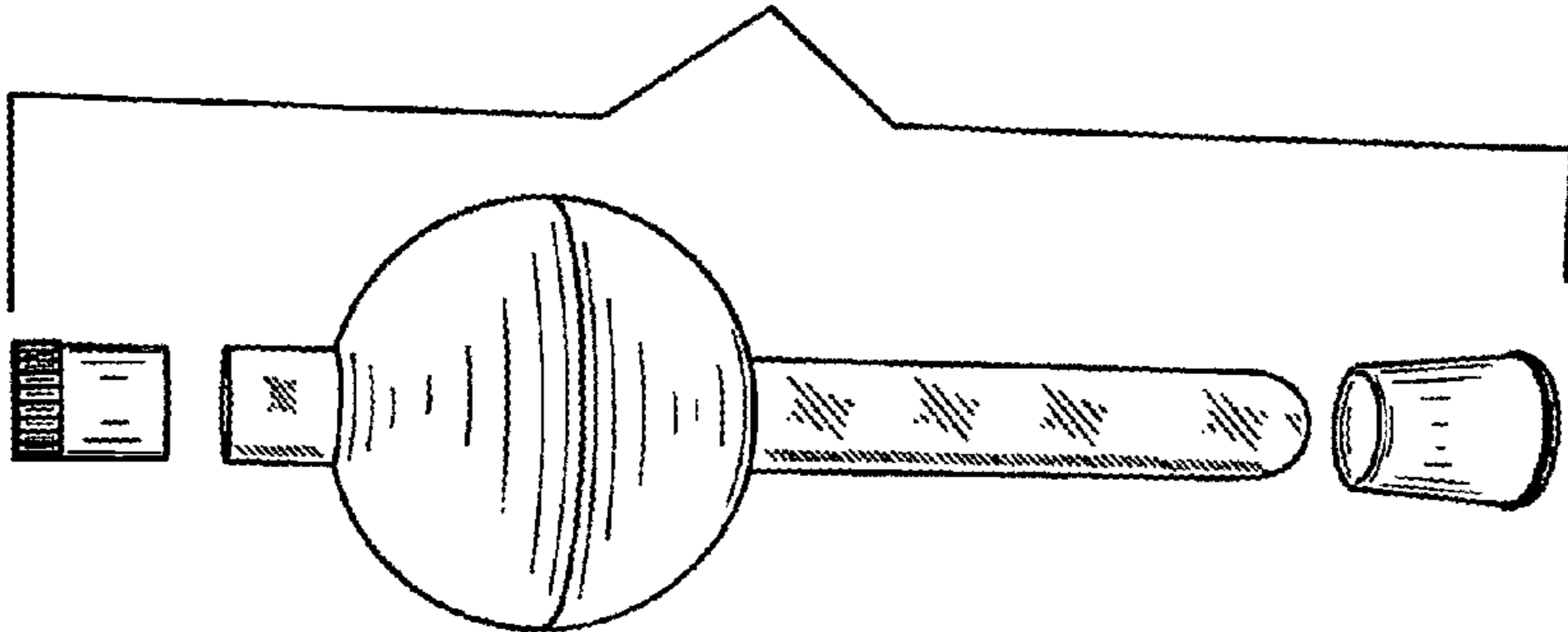

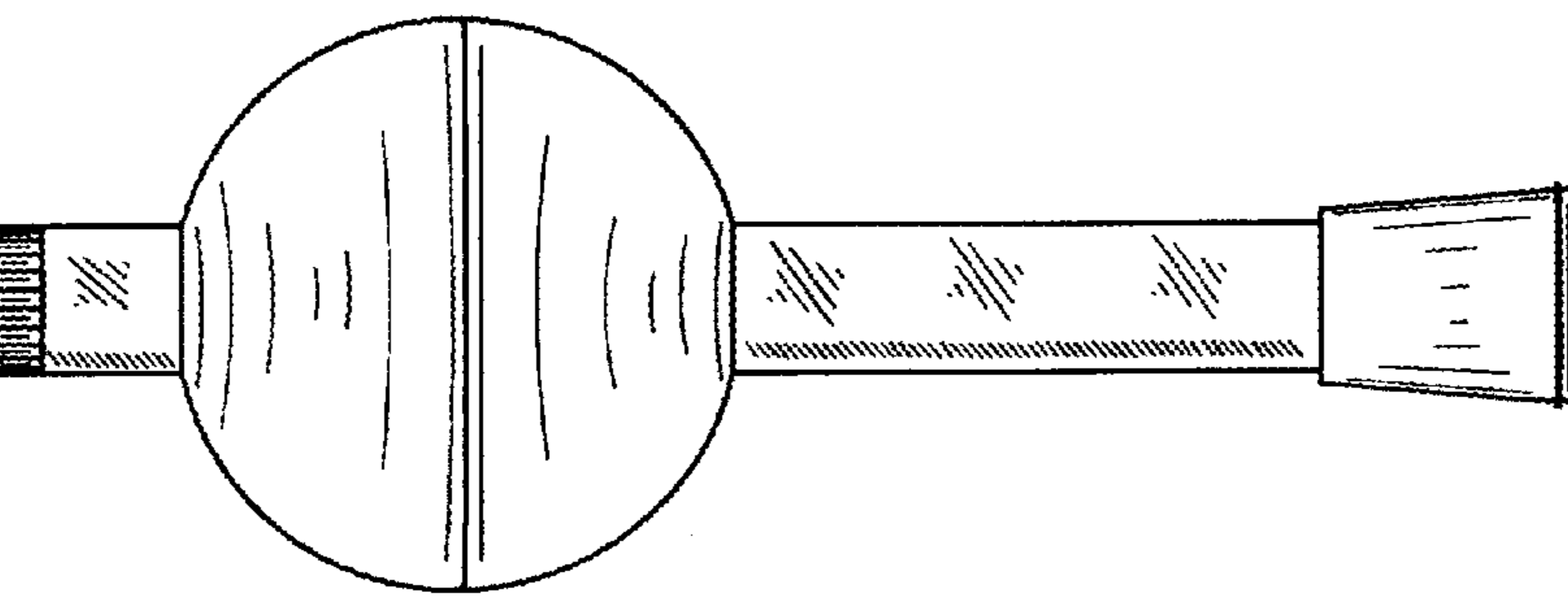

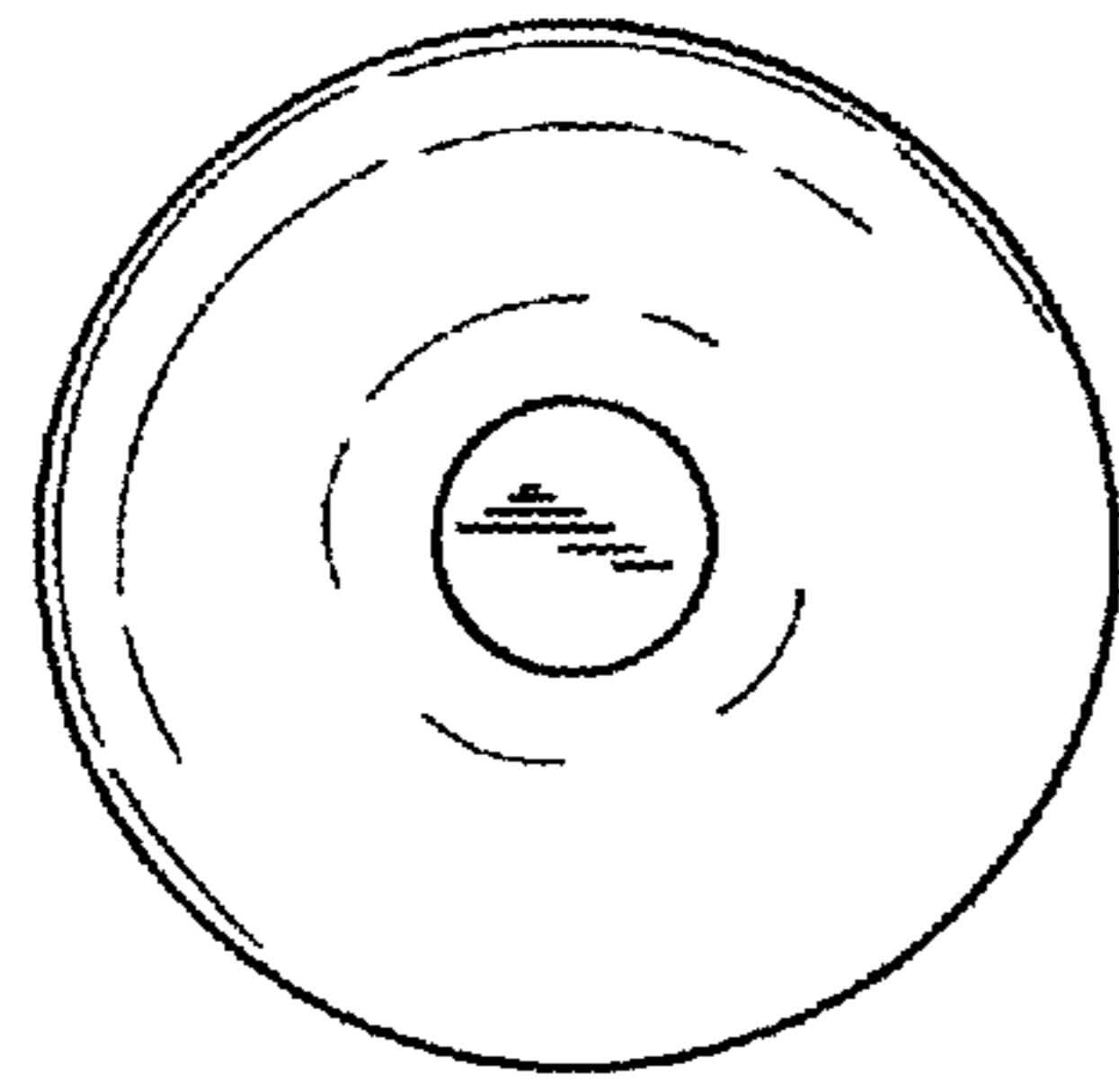

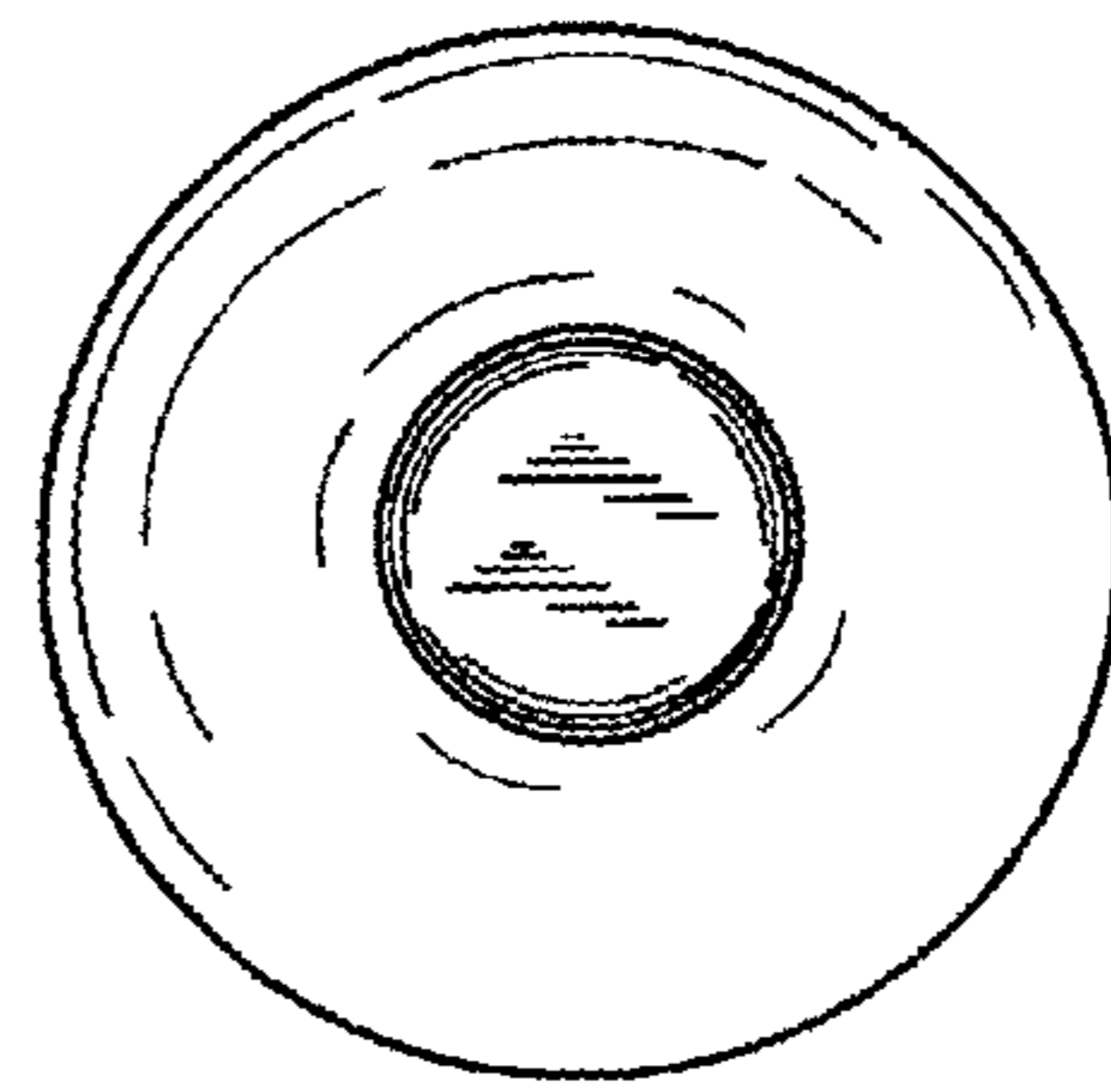
