DESCRIPTION

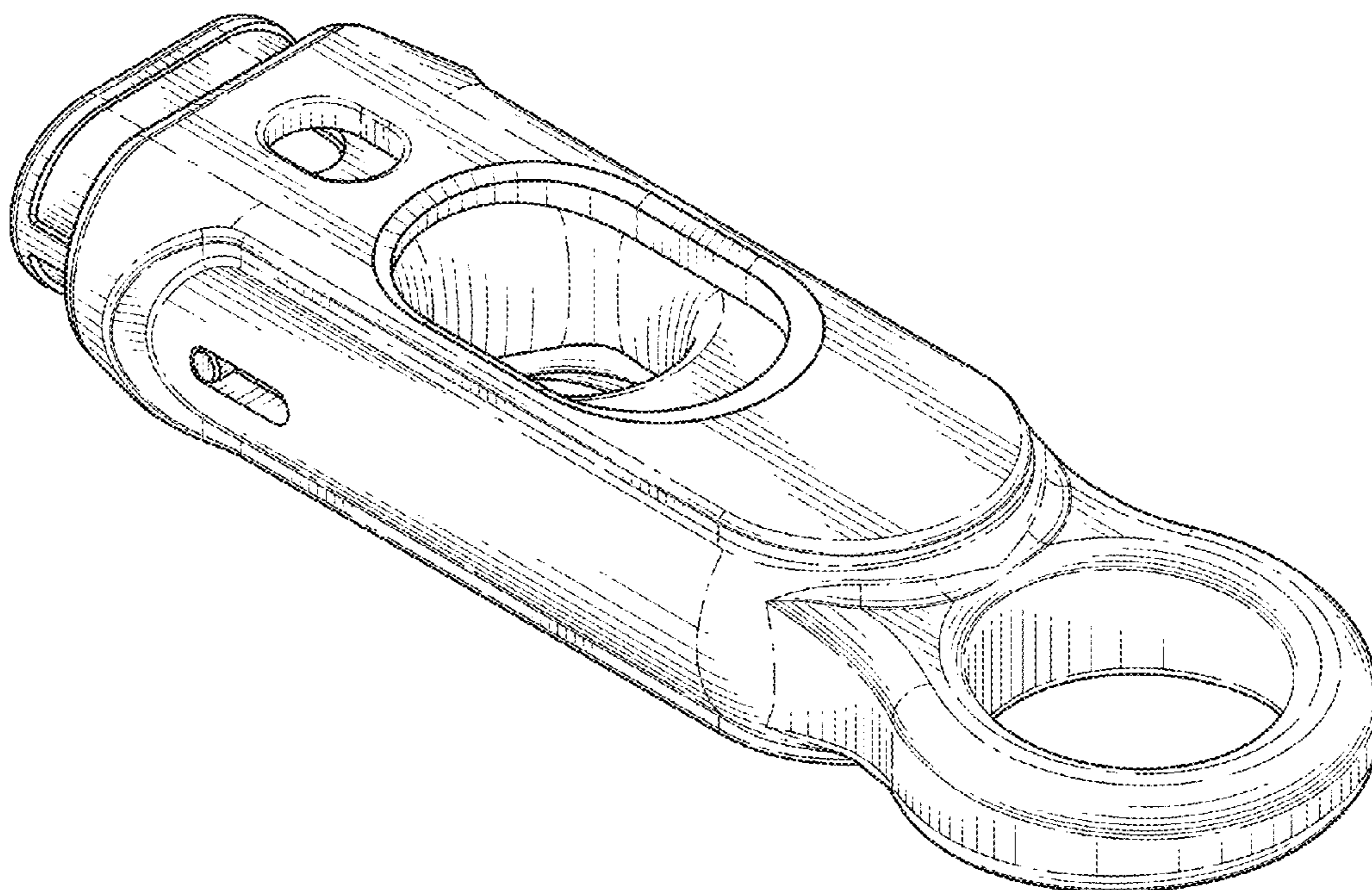
FIG. 1 is a perspective view of an embodiment of a wire stripper according to my design;

 FIG. 6 is a top plan view thereof; and,
 FIG. 7 is a bottom plan view thereof.
 Broken lines having repeated short dashes in the Figures are for illustrative purposes only and form no part of the claimed design. Shade lines having a combination of long and short lines in the Figures show contour and not surface ornamentation.

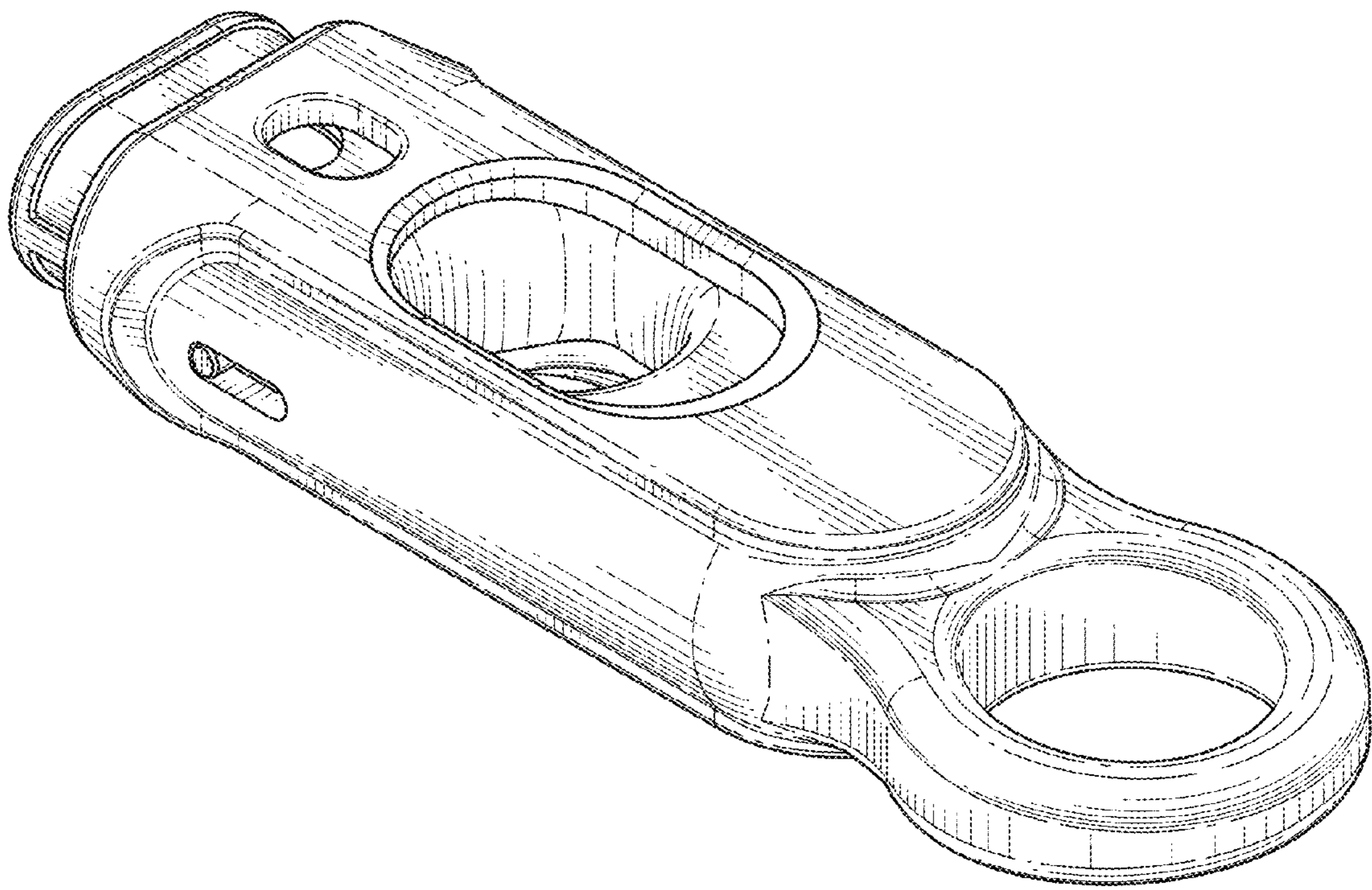

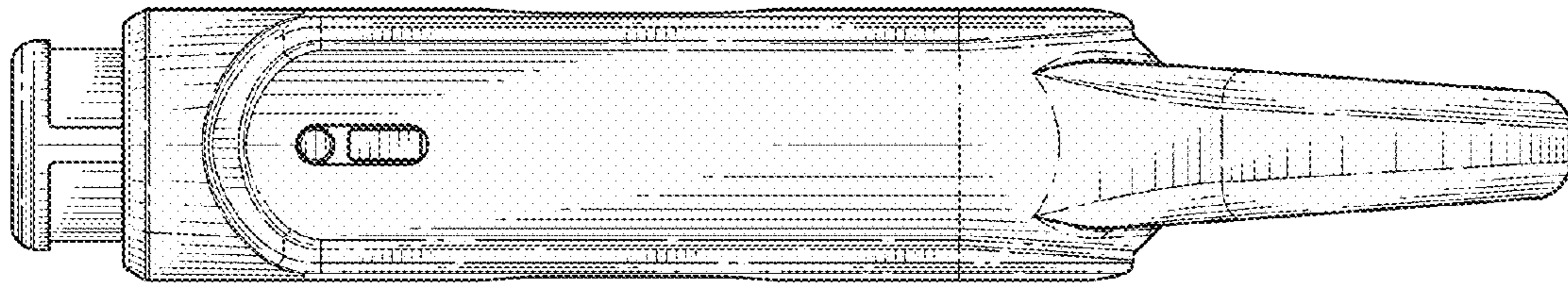

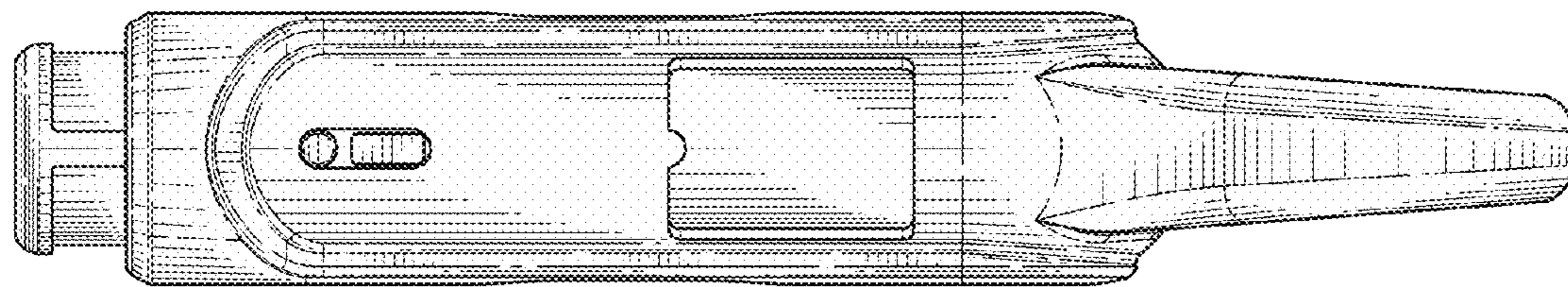

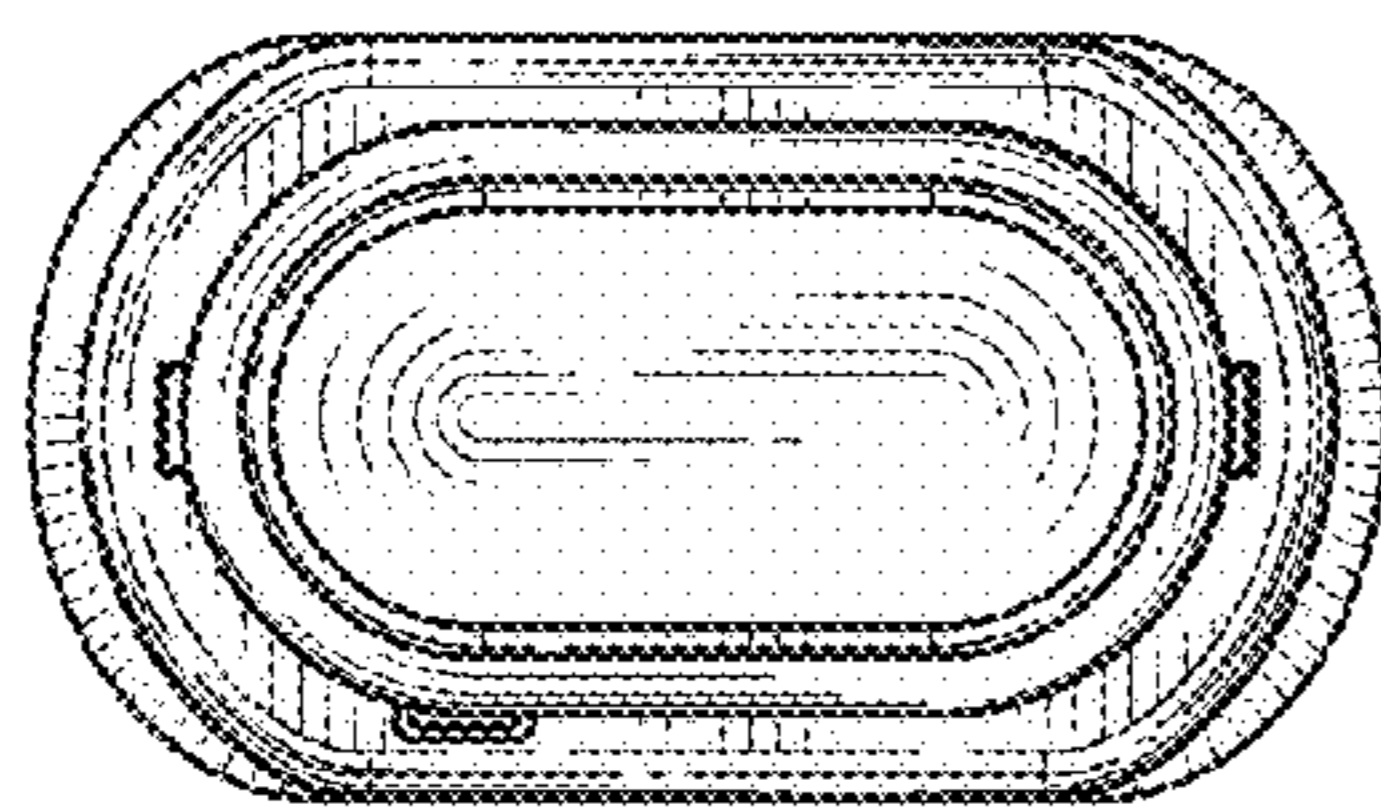

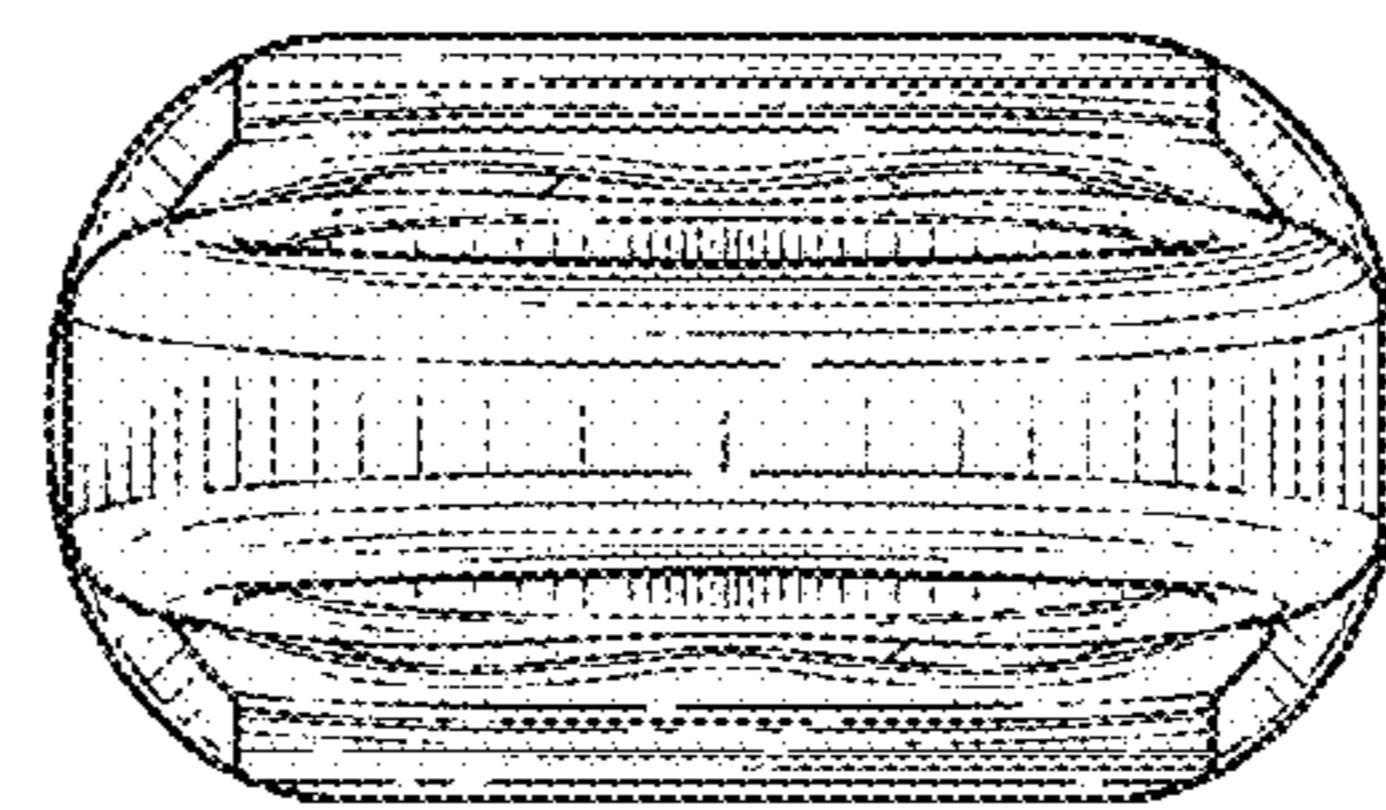

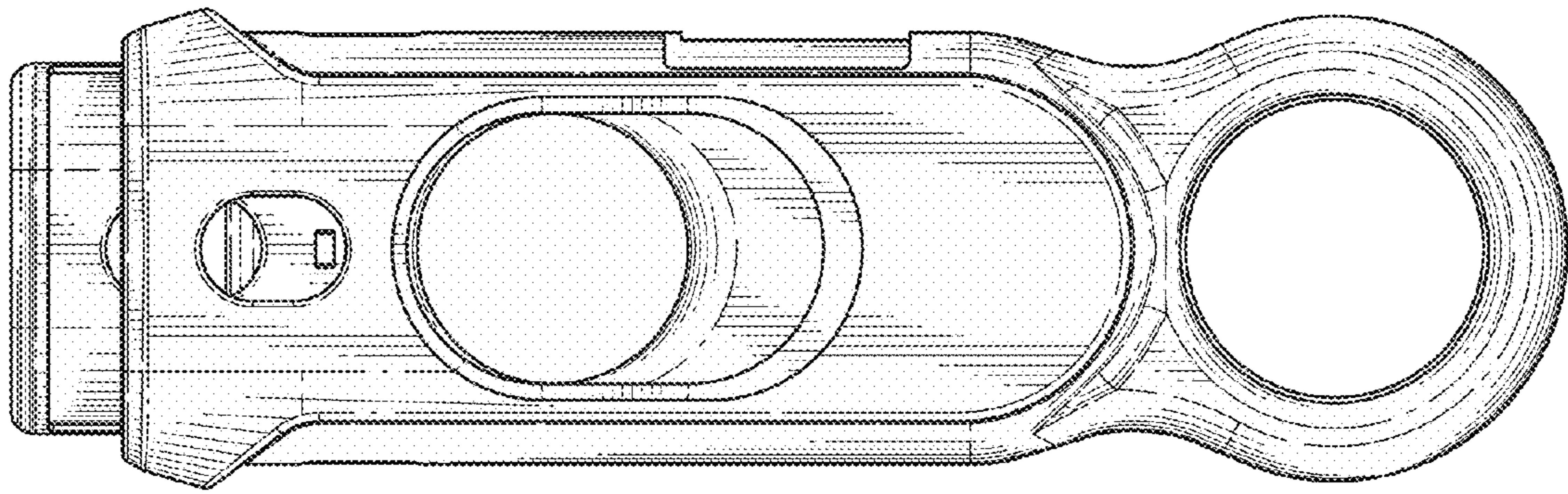

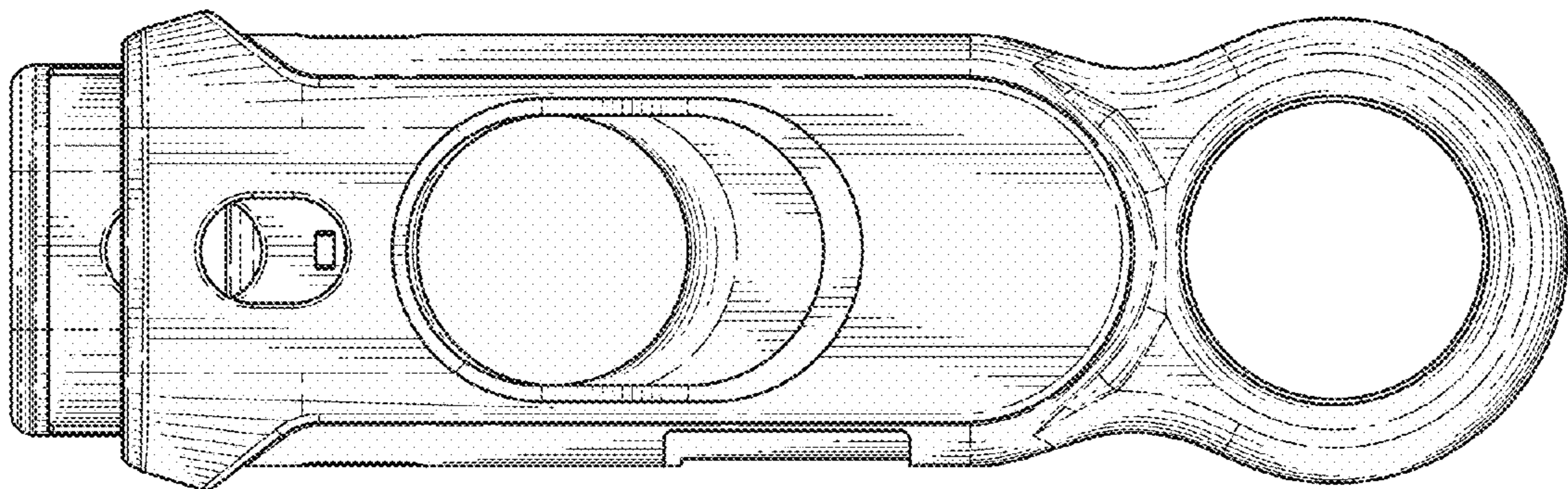
