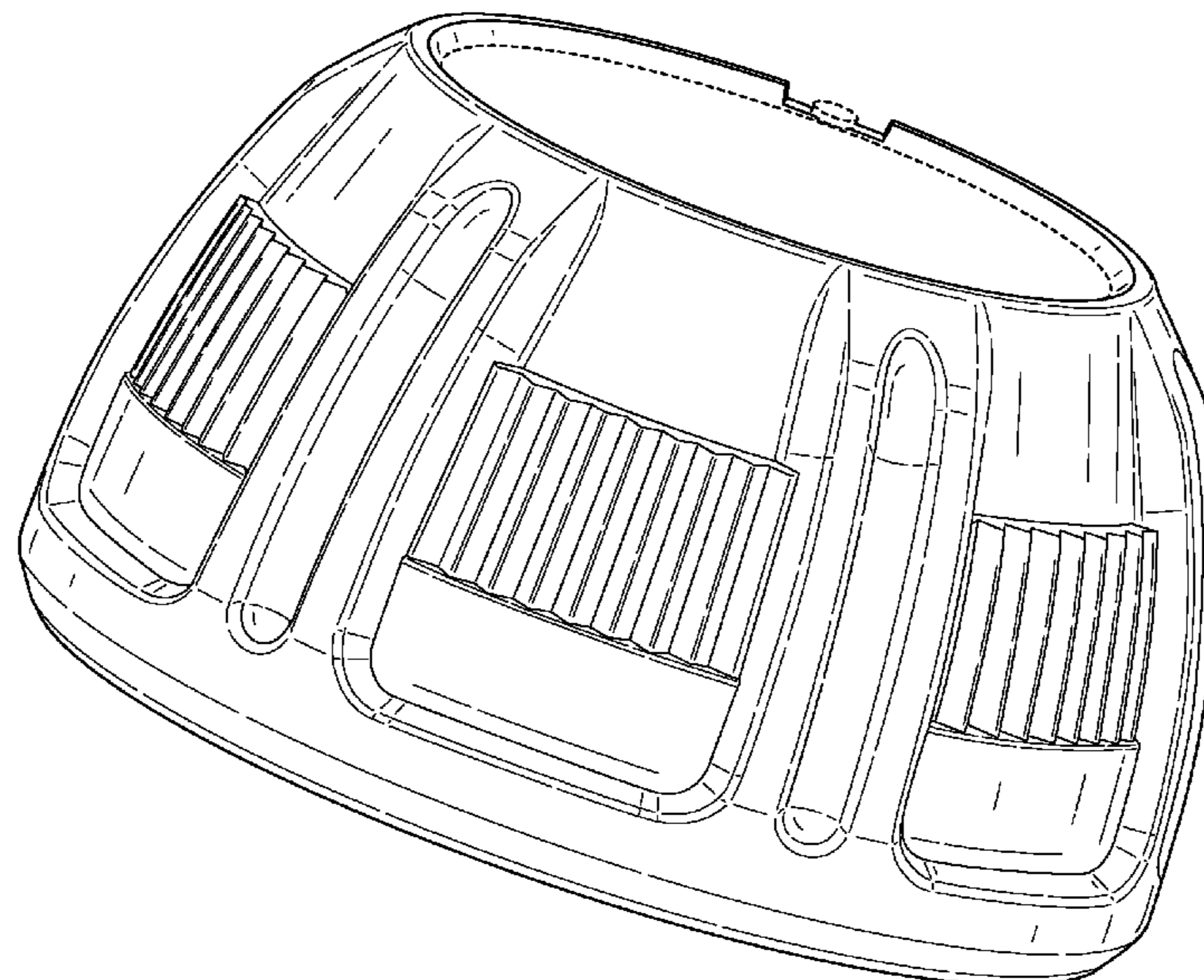
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a connector nut in accordance with the present invention;
FIG. 2 is a front view of the connector nut of FIG. 1;
FIG. 3 is a back view of the connector nut of FIG. 1;
FIG. 4 is a left side view of the connector nut of FIG. 1;
FIG. 5 is a right side view of the connector nut of FIG. 1;
FIG. 6 is a top view of the connector nut of FIG. 1; and,
FIG. 7 is a bottom view of the connector nut of FIG. 1.

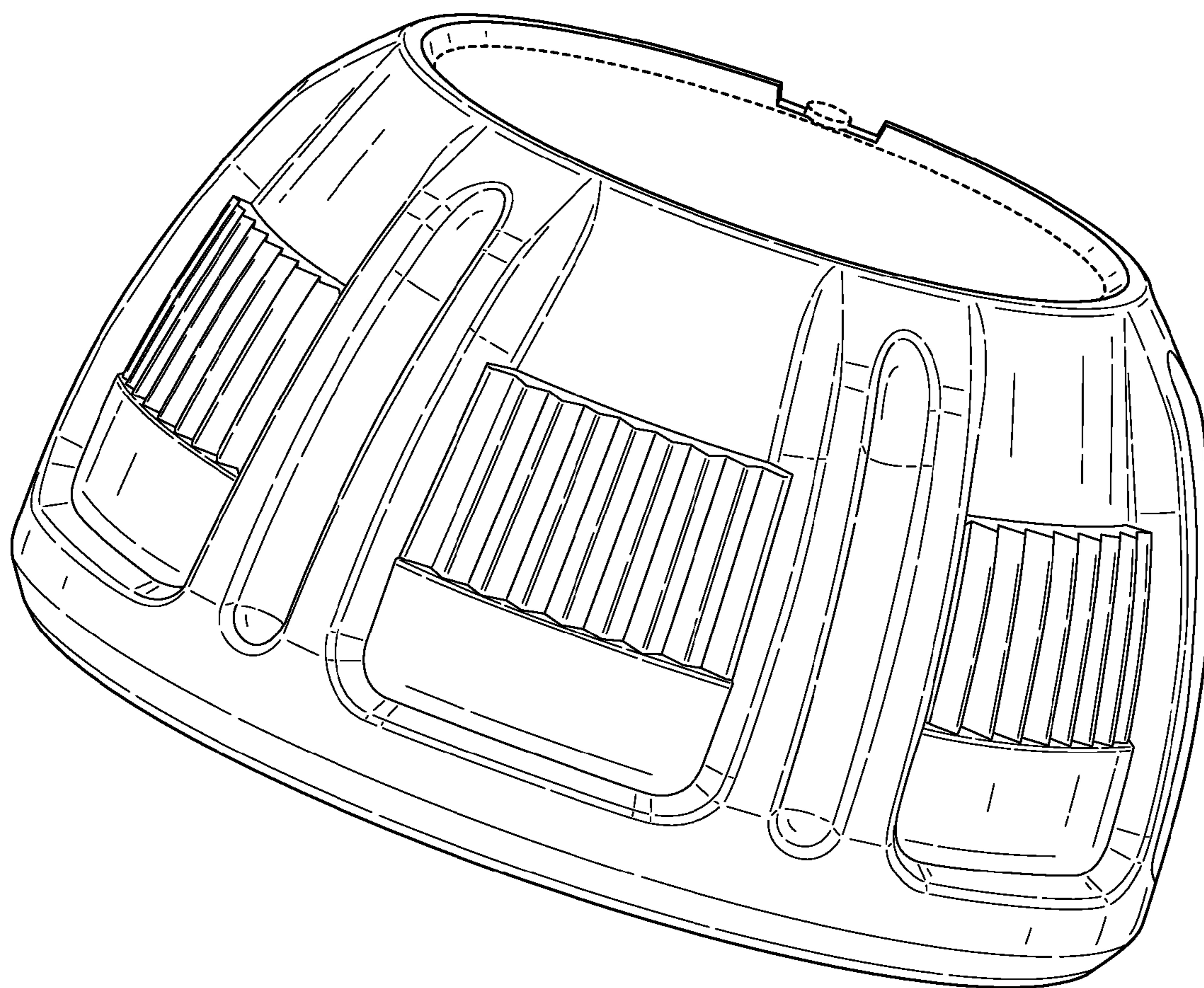

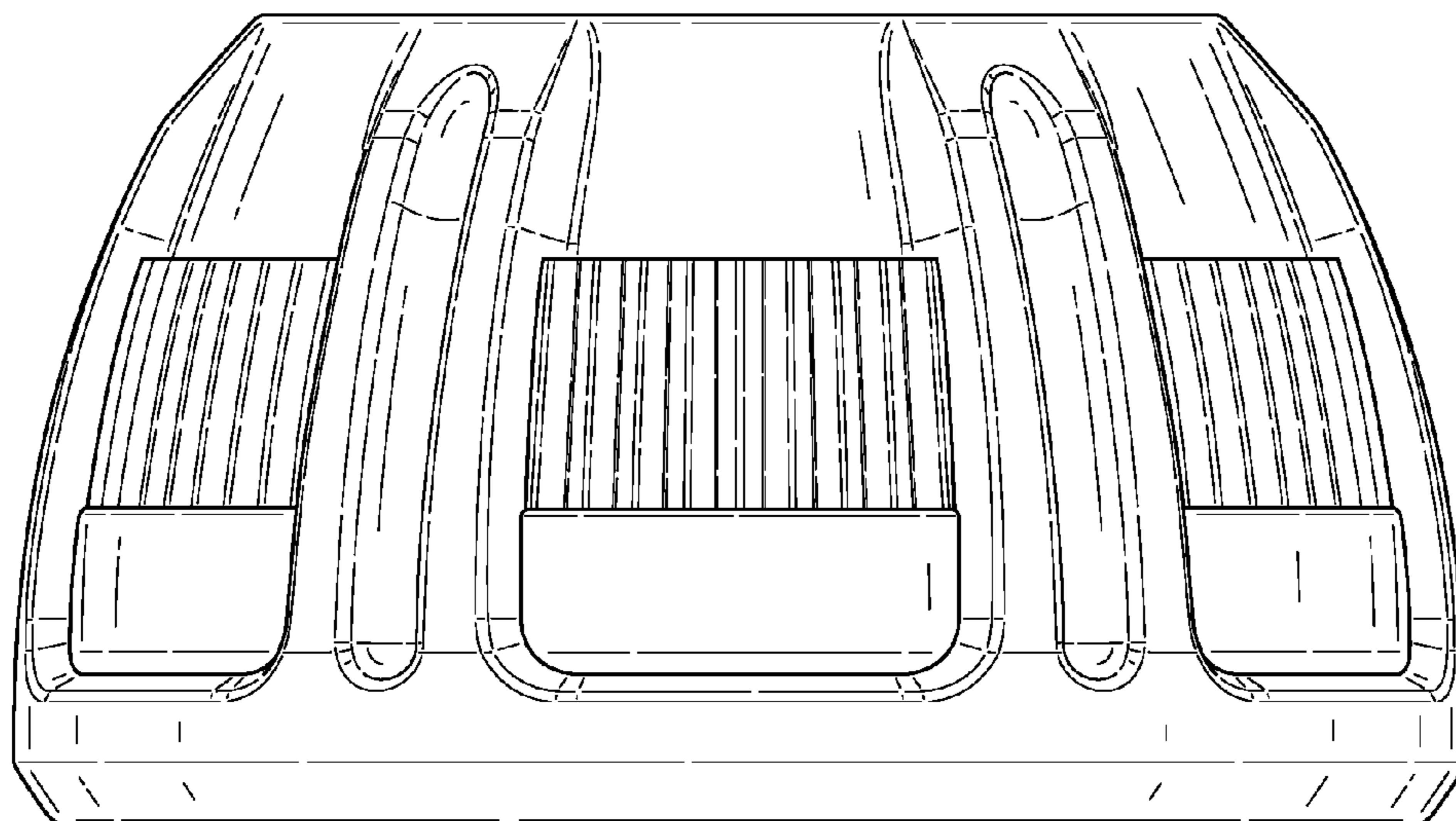

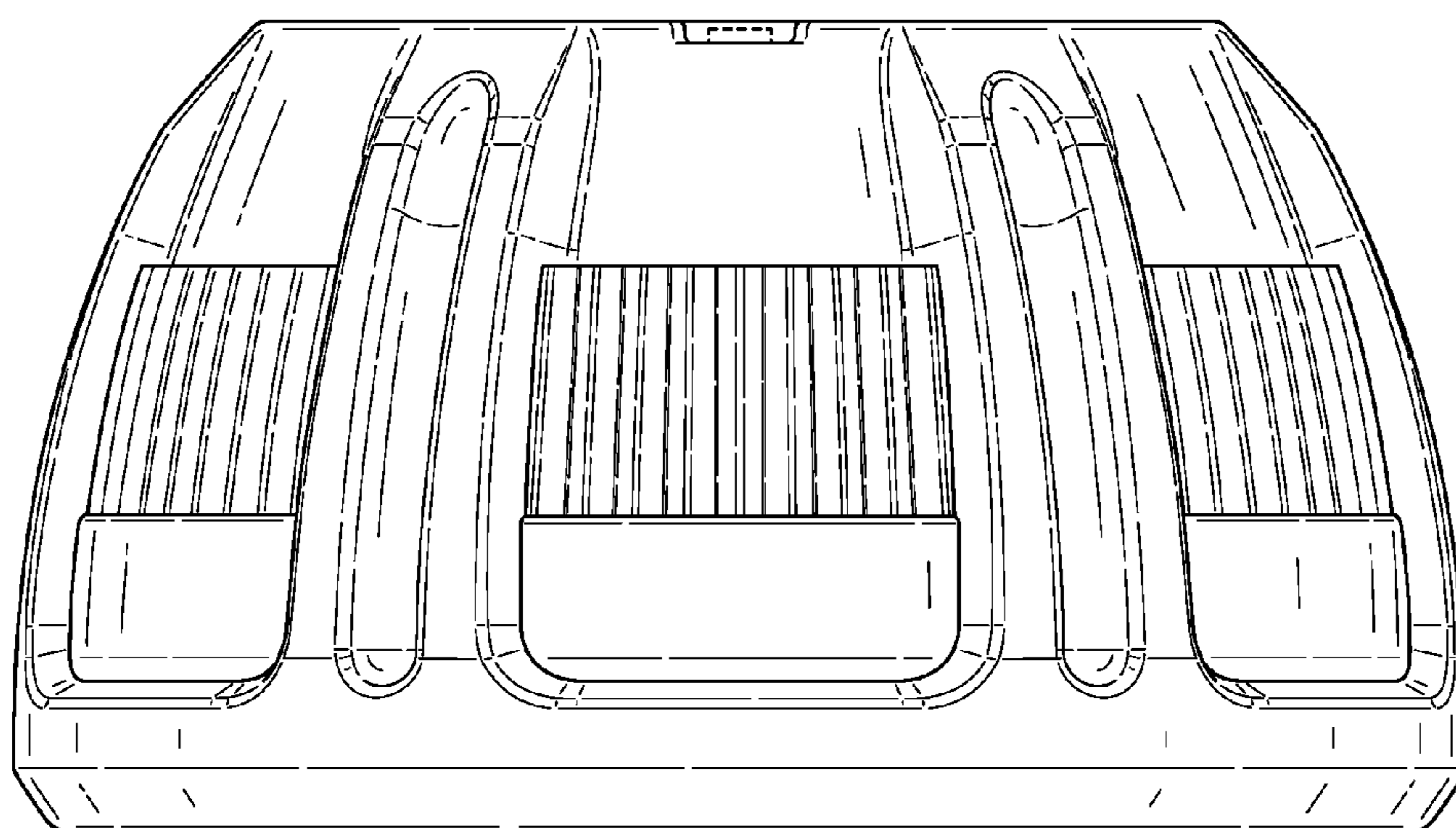

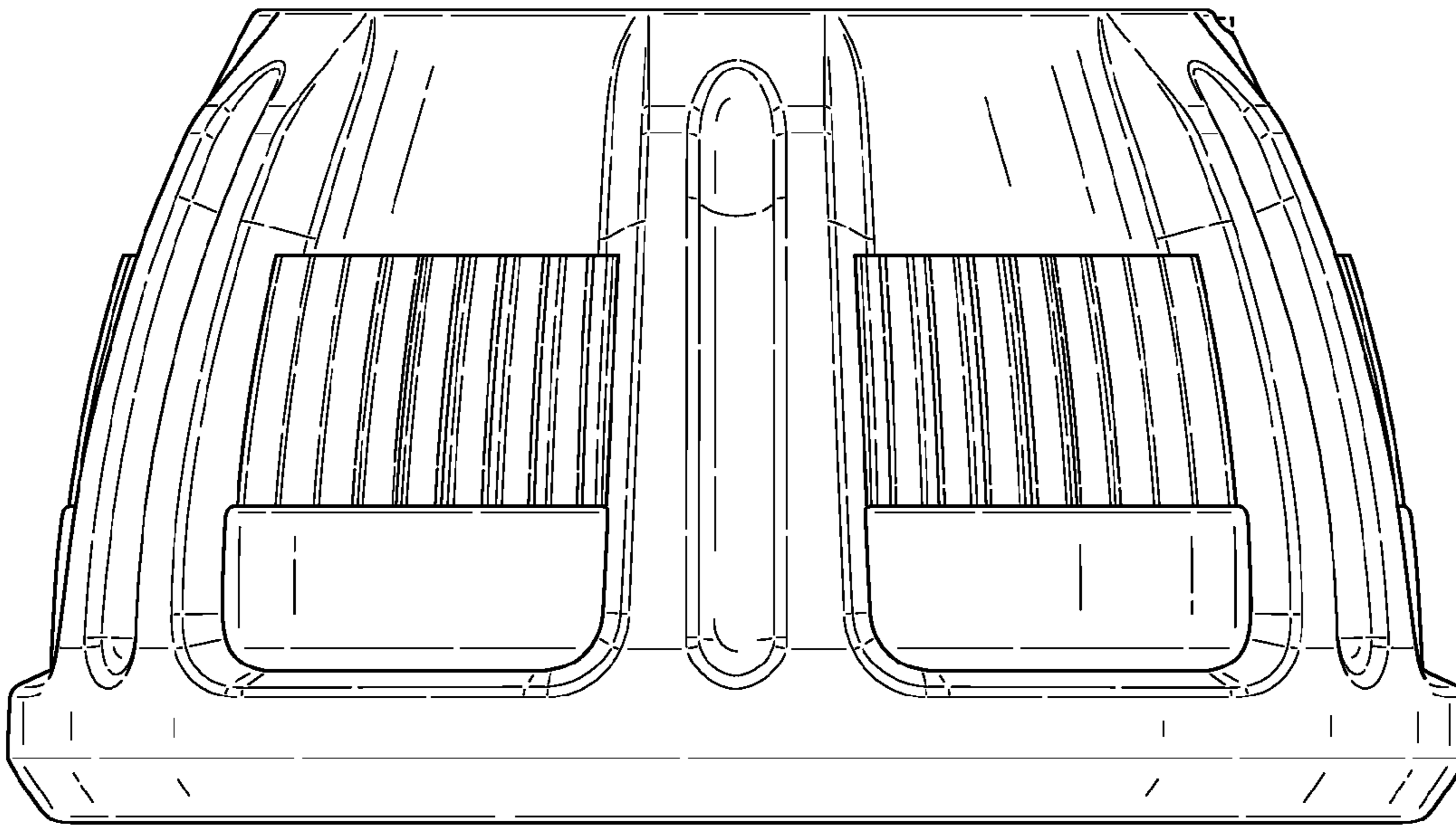

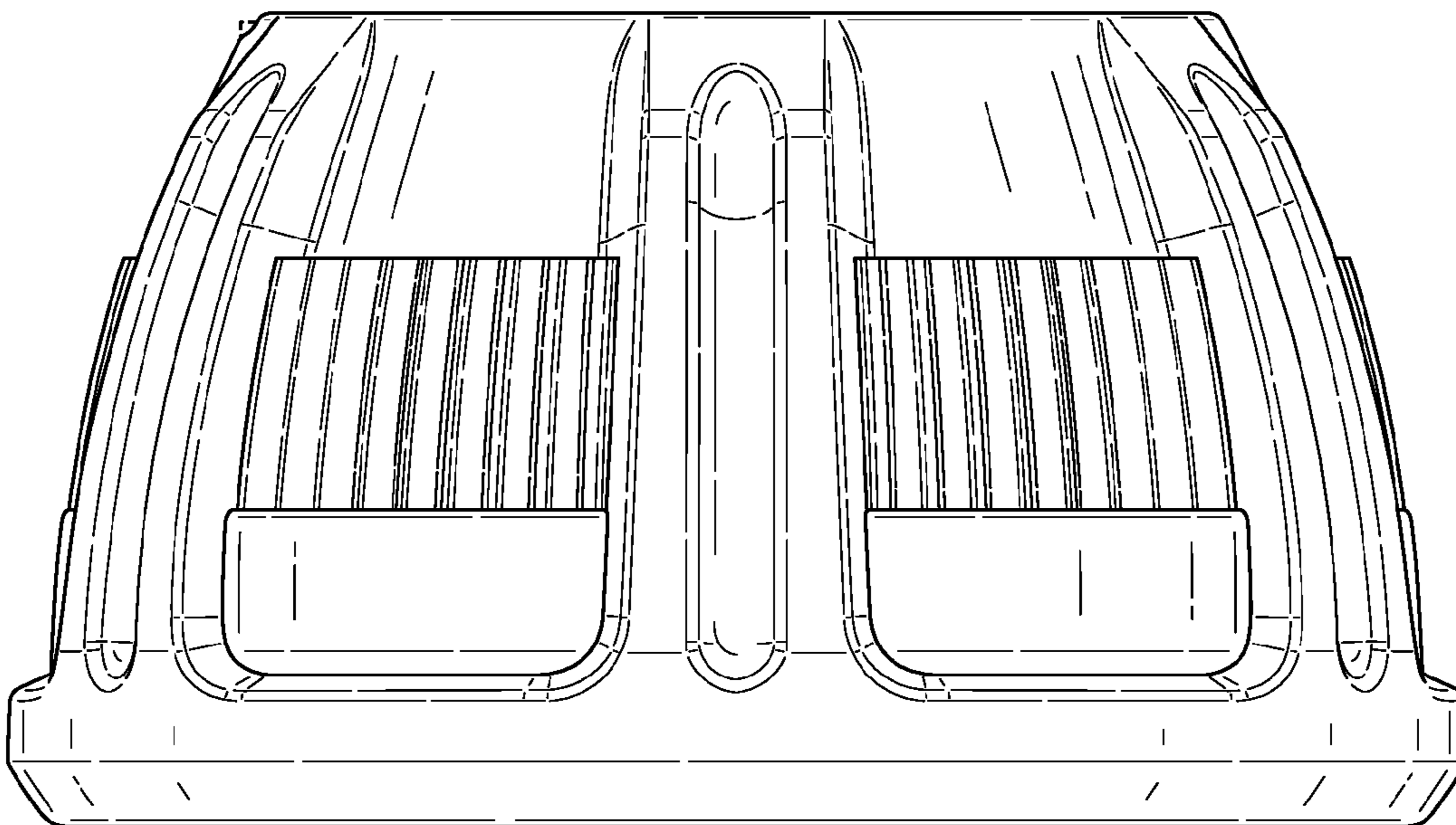

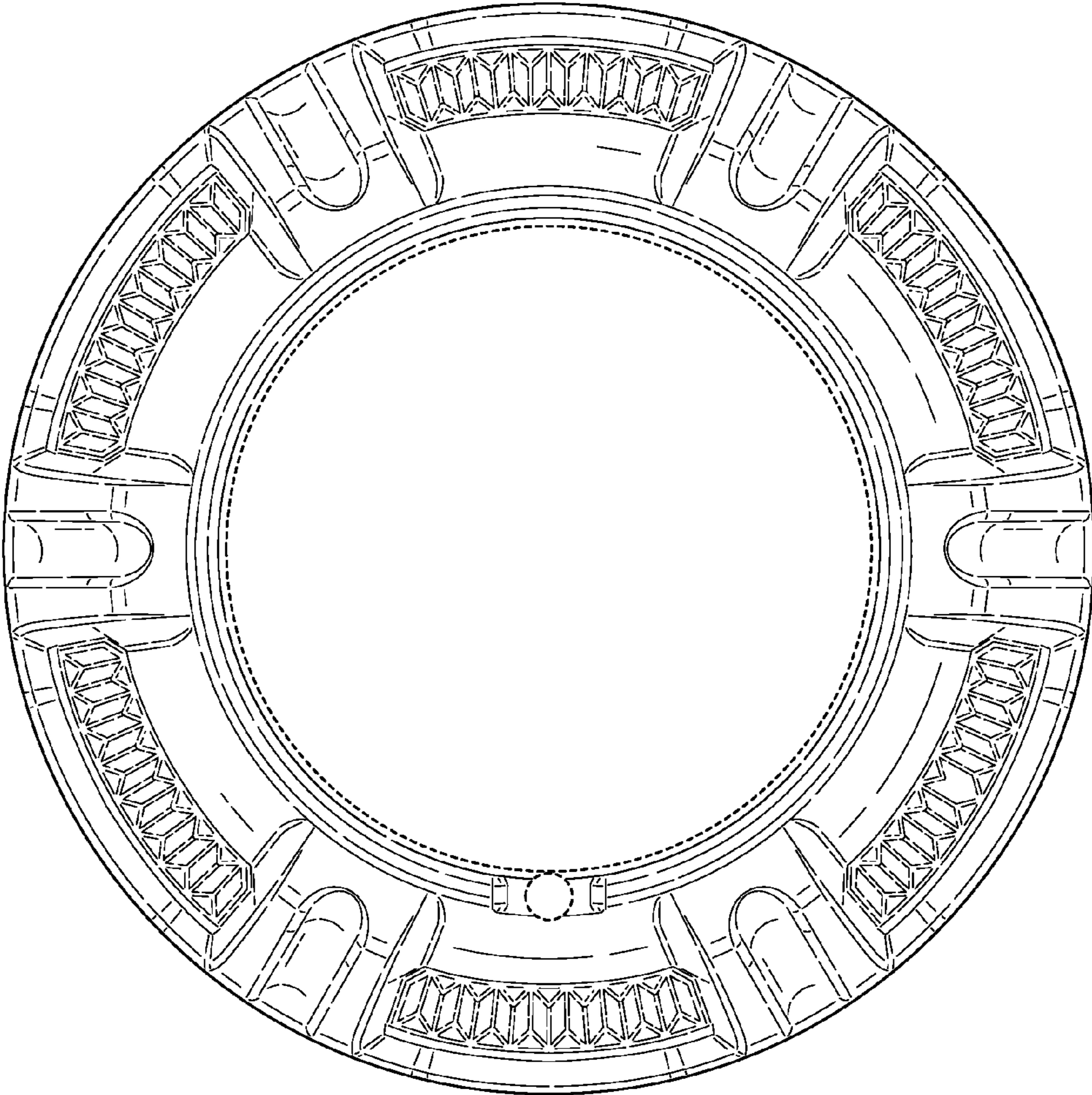

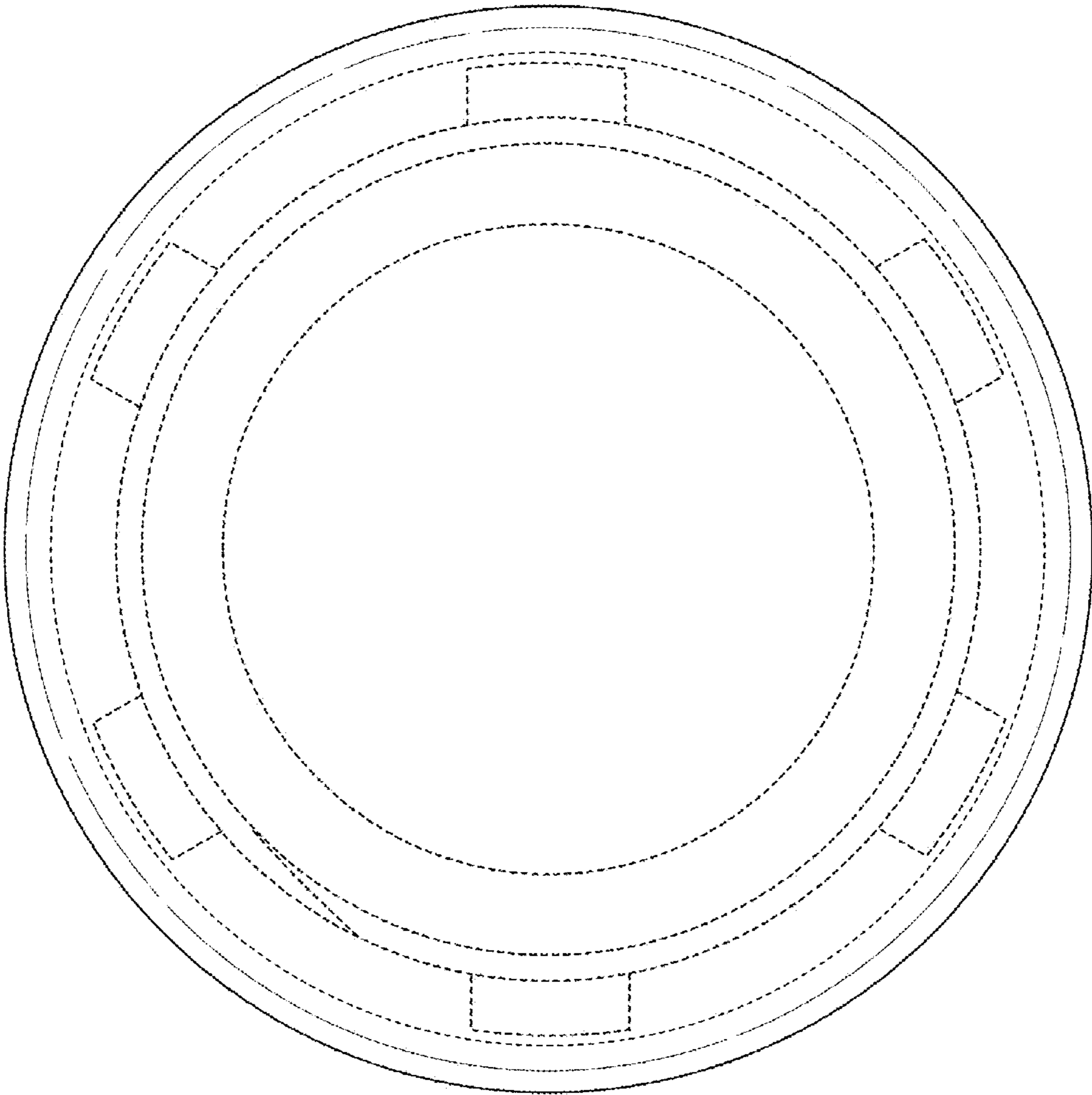
