(57) **CLAIM**

The ornamental design for a RFID tag, as shown and described.

DESCRIPTION

FIG. 1 is the front perspective view of a RFID tag showing our new design;

FIG. 2 is the front view thereof;

FIG. 3 is the rear view thereof;

FIG. 4 is the left-side view thereof;

FIG. 5 is the right-side view thereof;

FIG. 6 is the top-side plan view thereof;

FIG. 7 is the bottom-side plan view thereof;

FIG. 8 is a top isometric view of an alternate embodiment thereof; and,

FIG. 9 is a top isometric view of a second alternate embodiment thereof.

The broken line showing of a cord mount and cord, a clip, a wrist strap, and a central opening in the main body of the design is included for the purpose of illustrating portions of the “article” and forms no part of the claimed design.

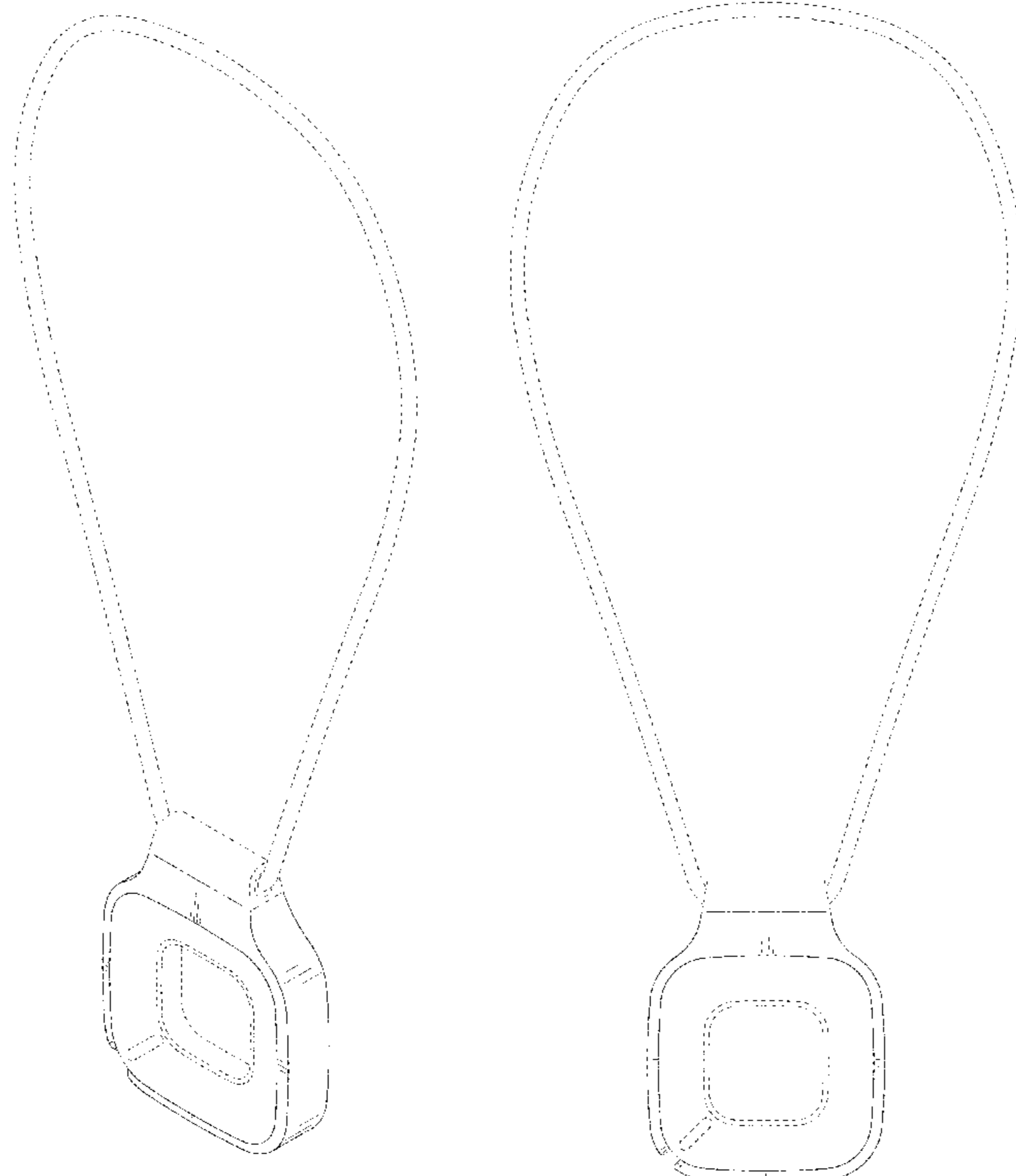

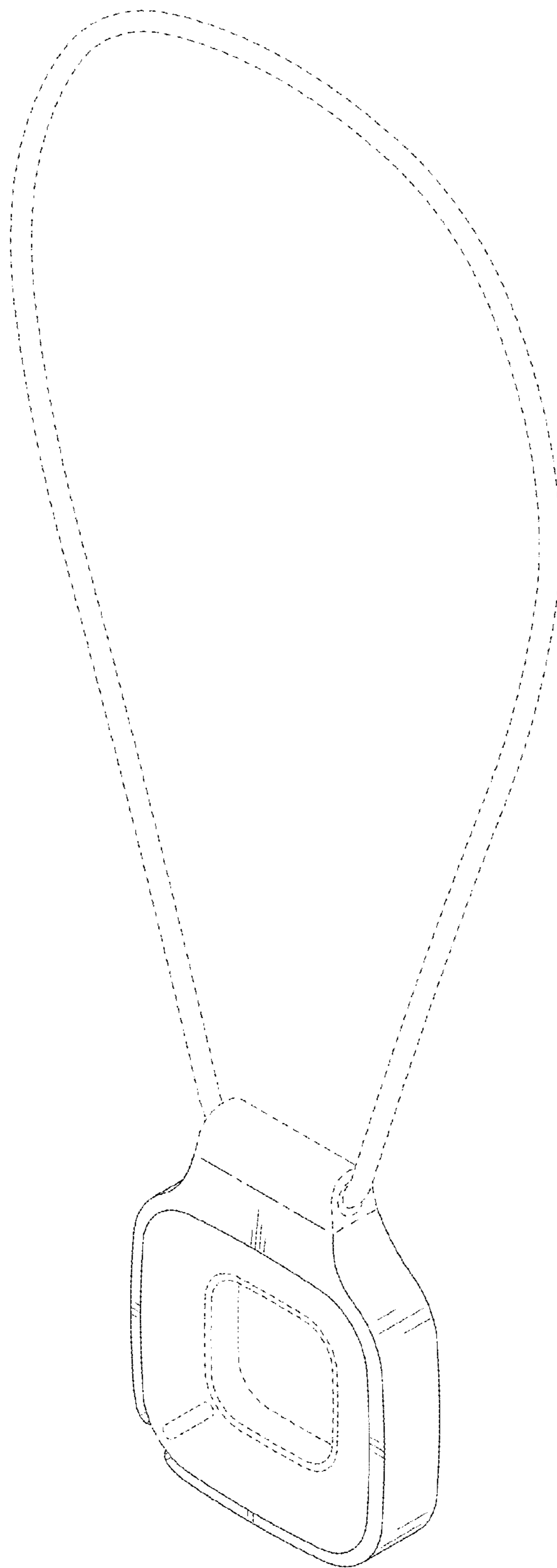

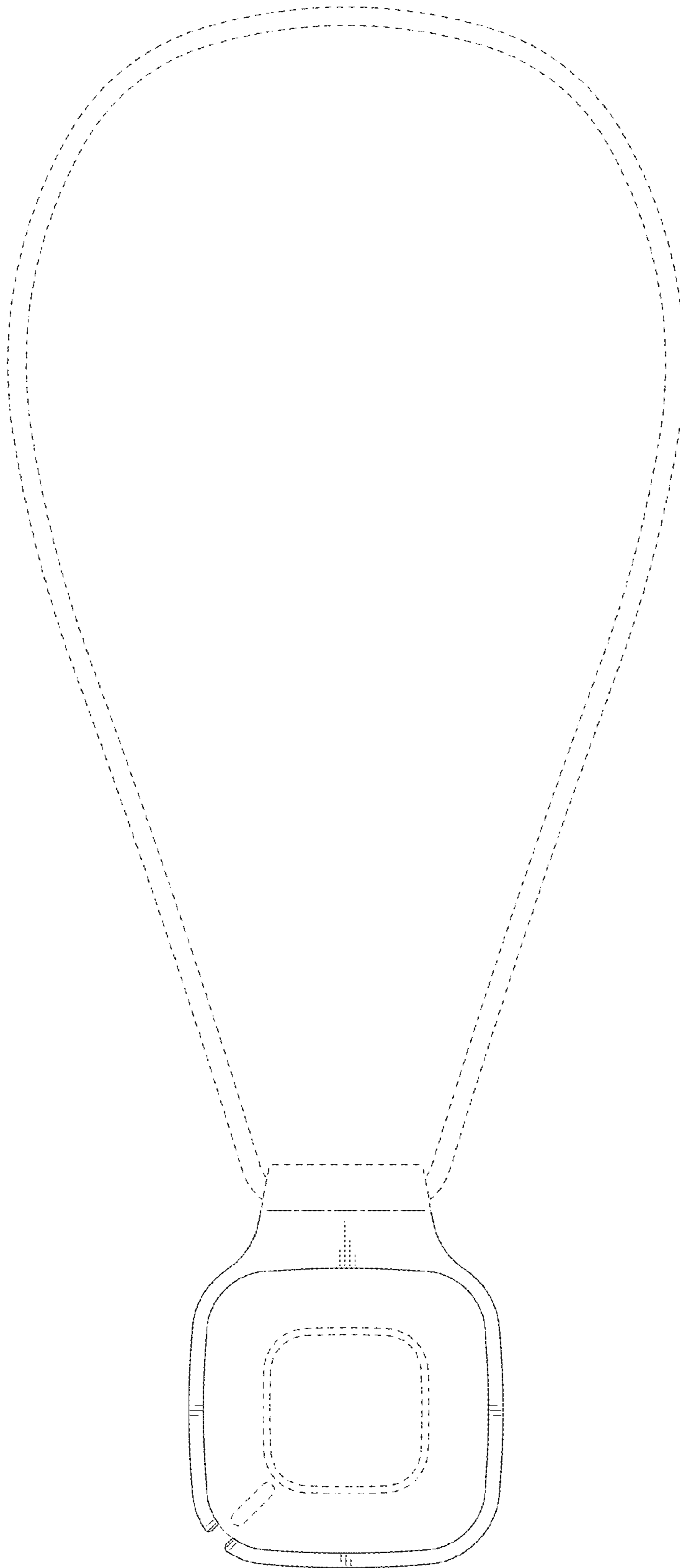

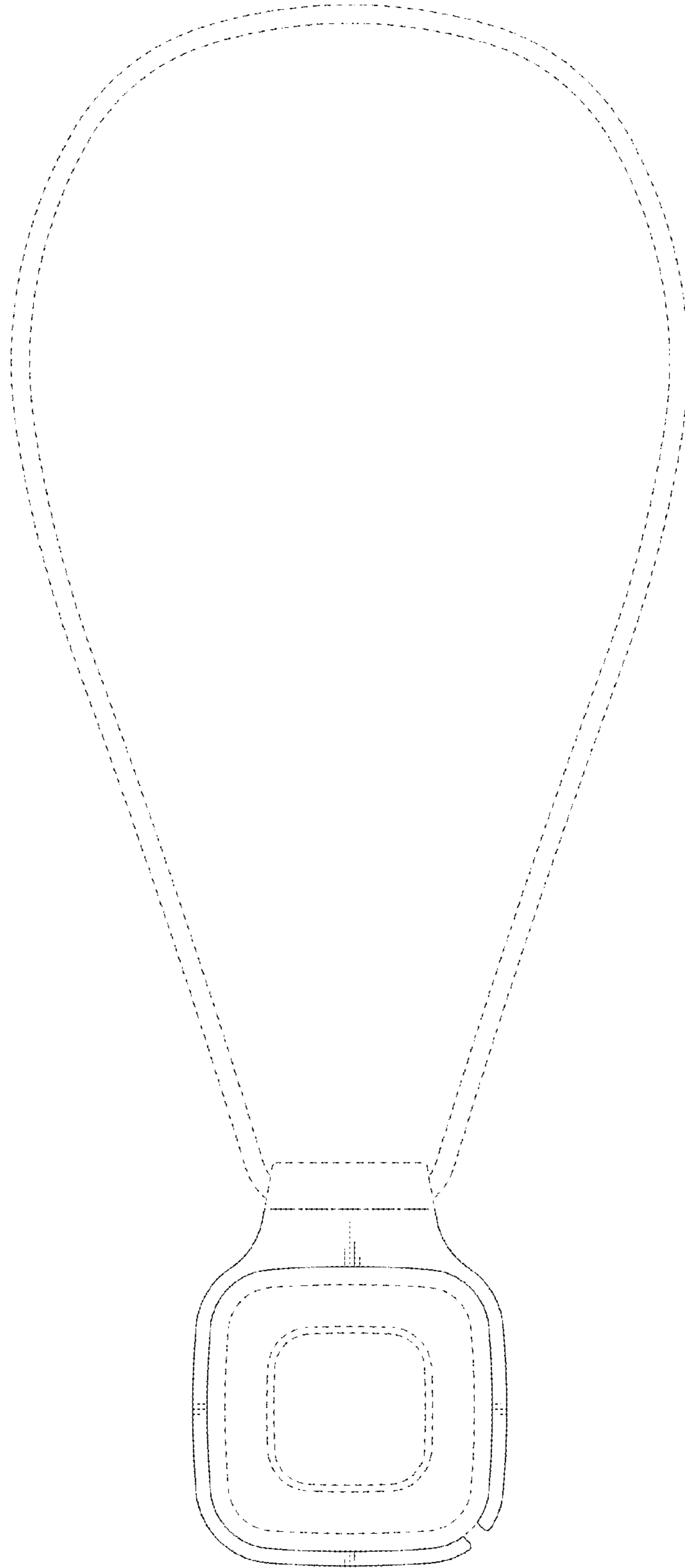

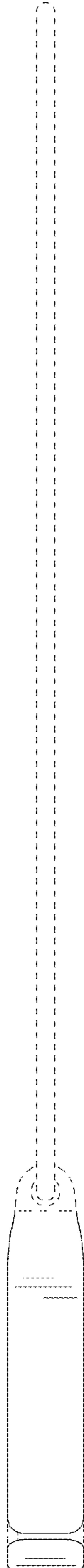

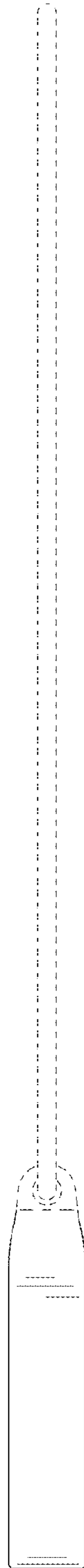

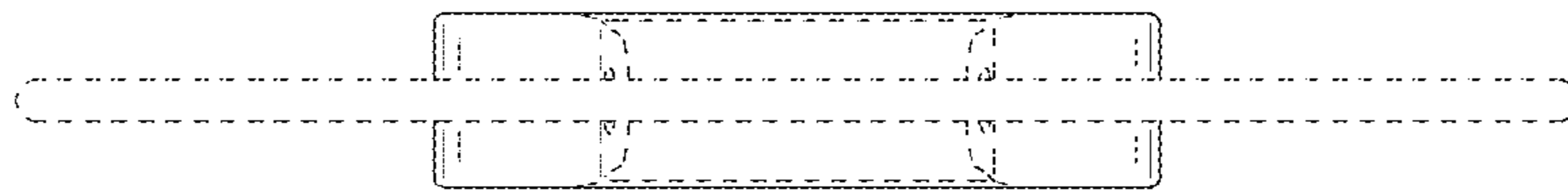

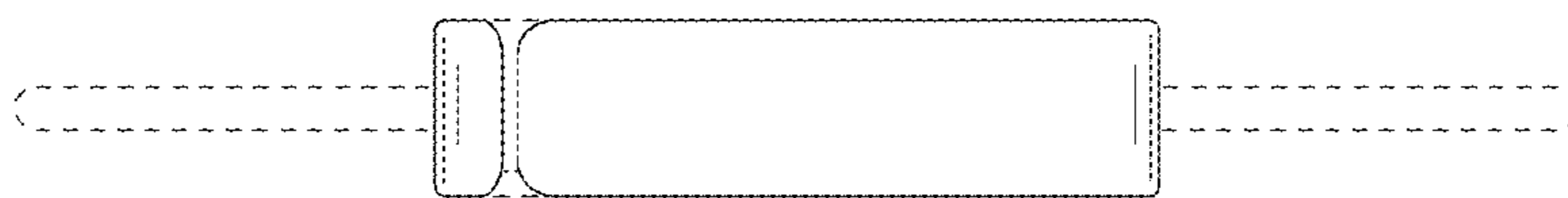

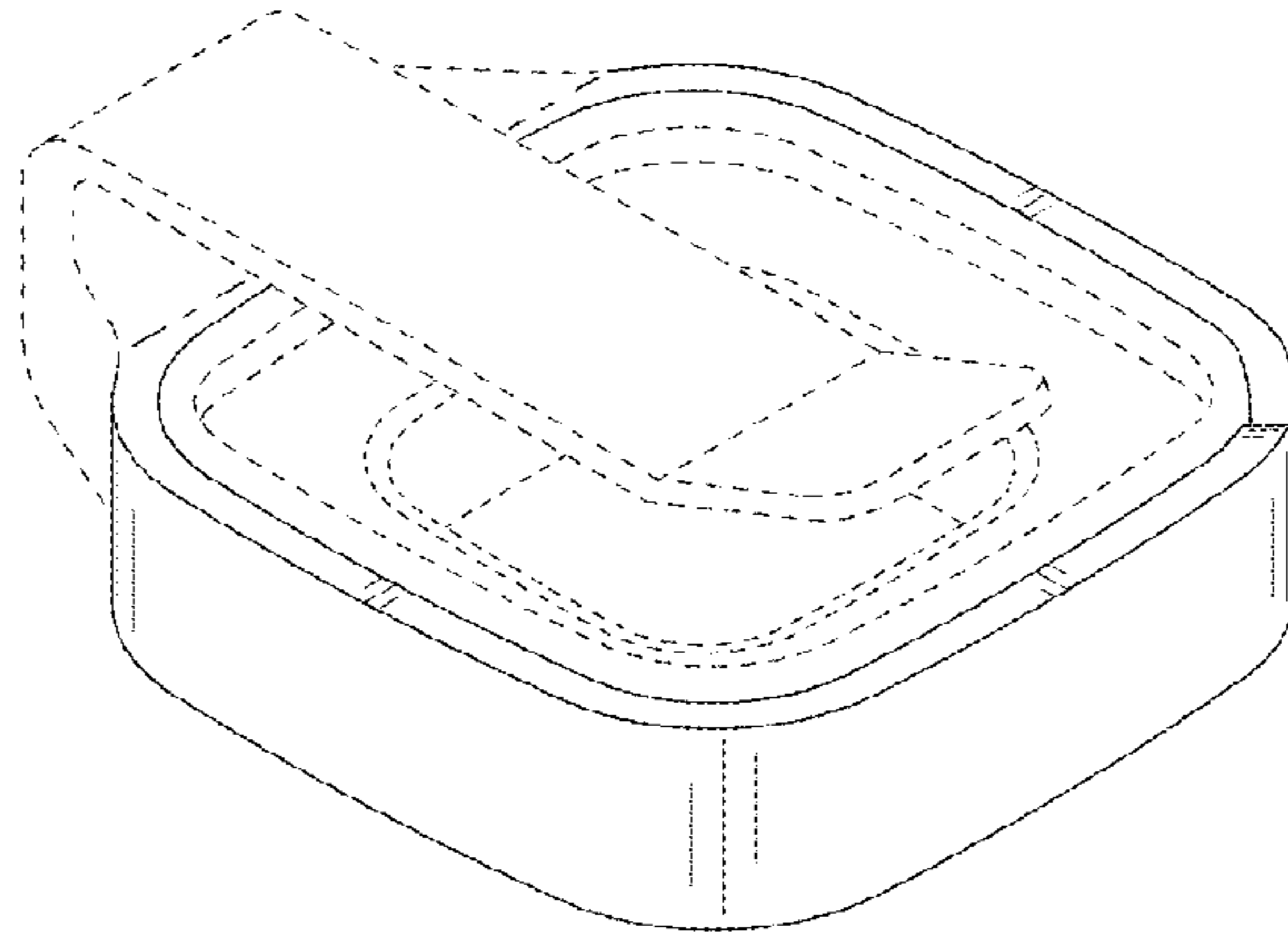
