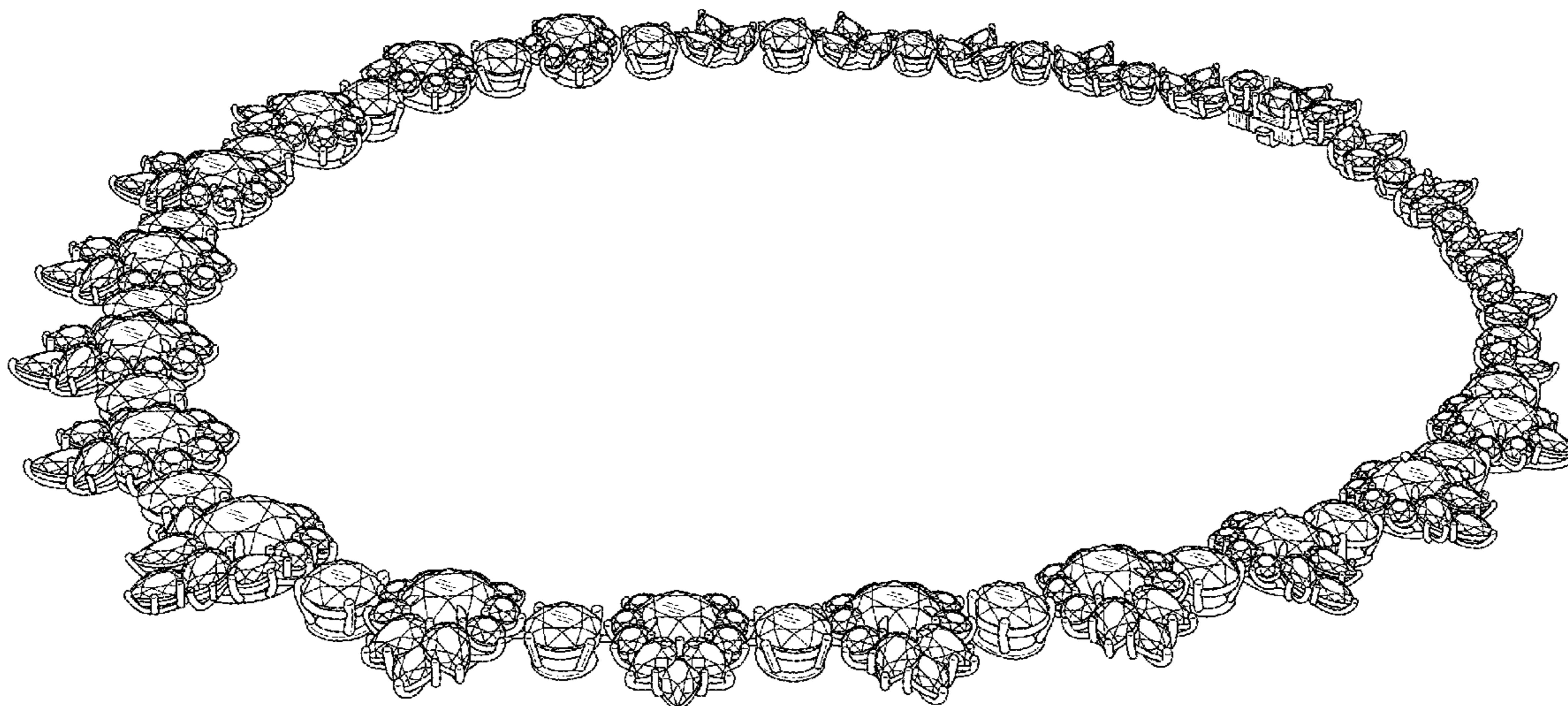
FIG. 1 is a front perspective view of a necklace showing my new design;

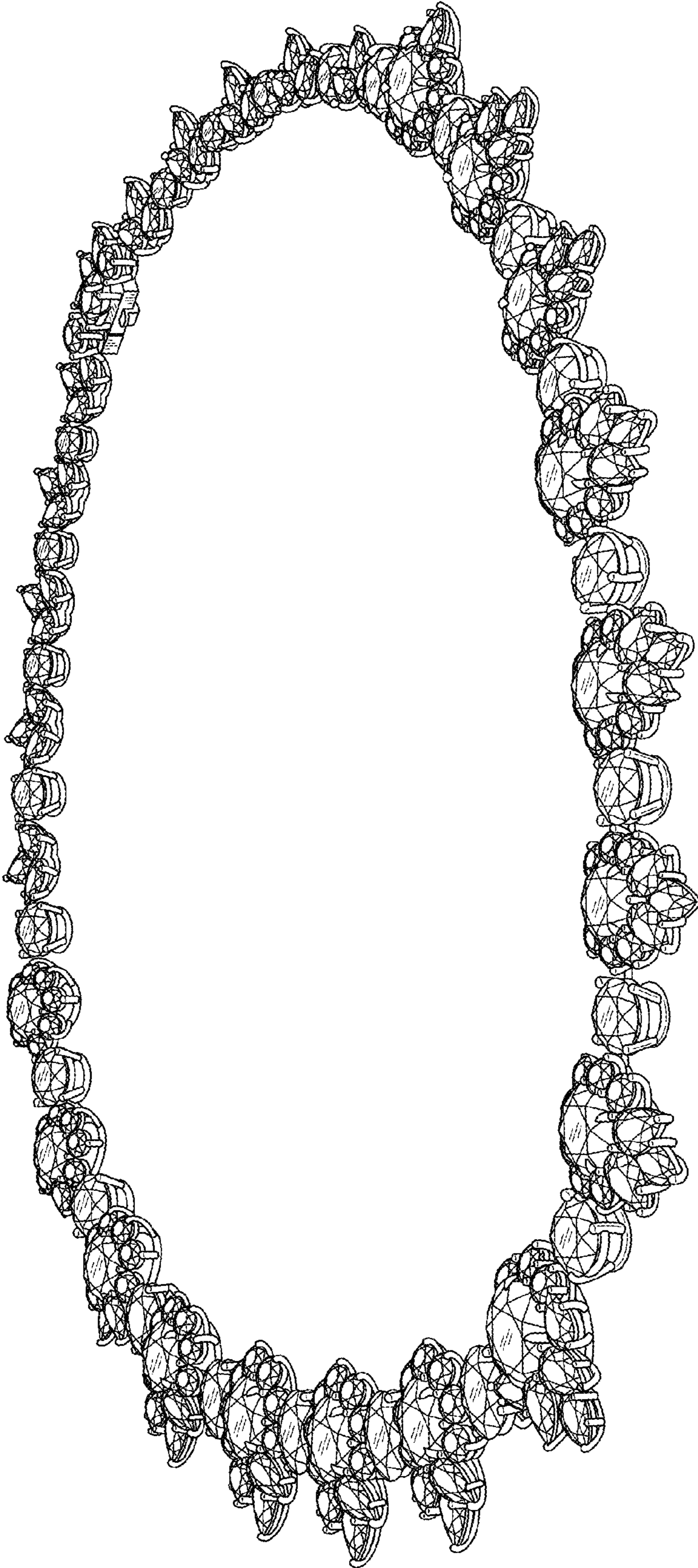

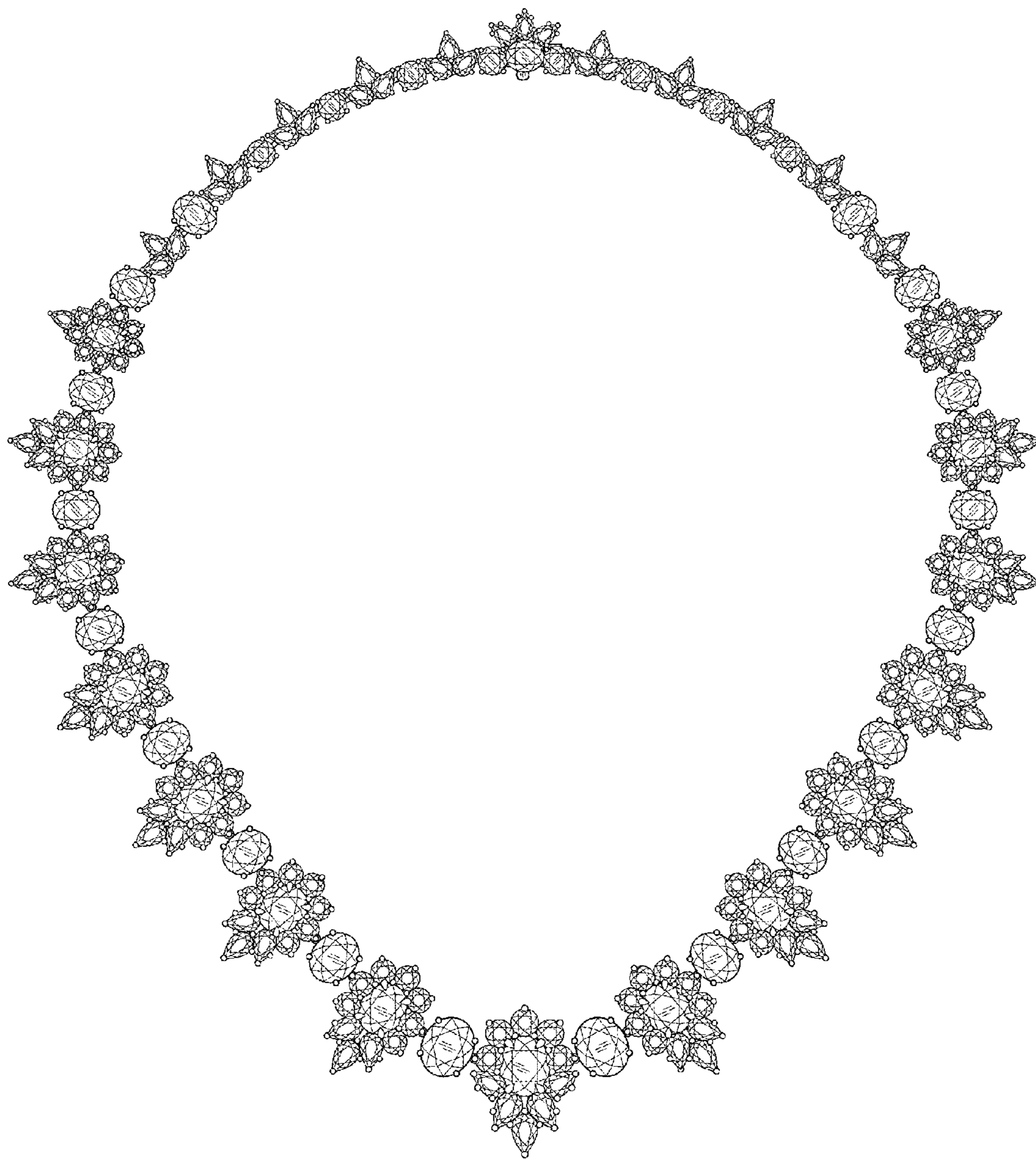

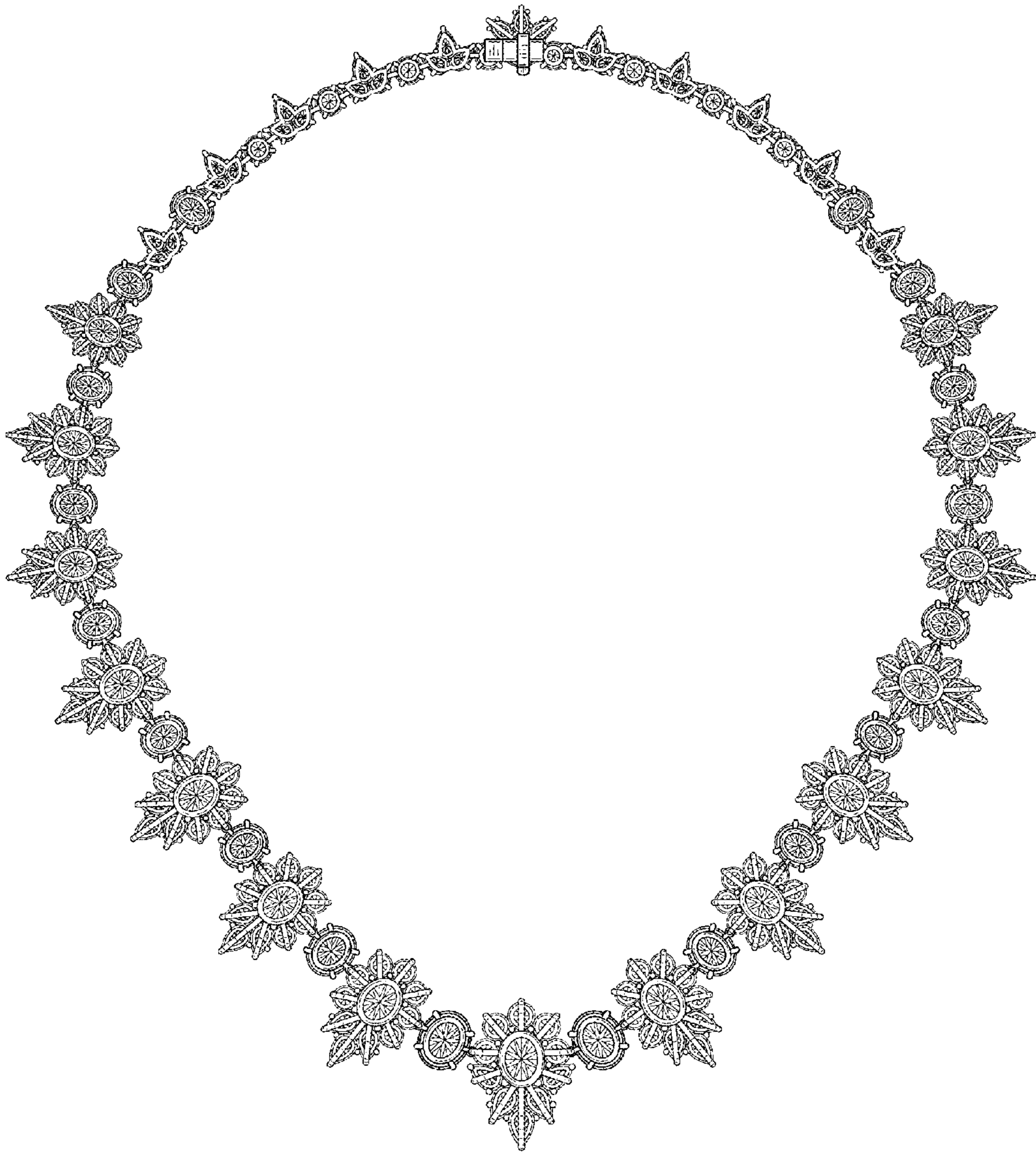

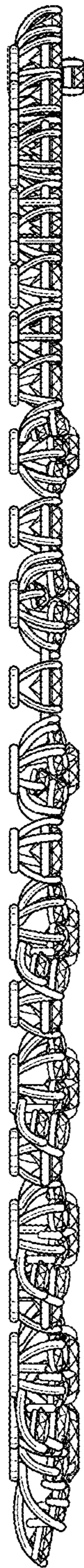

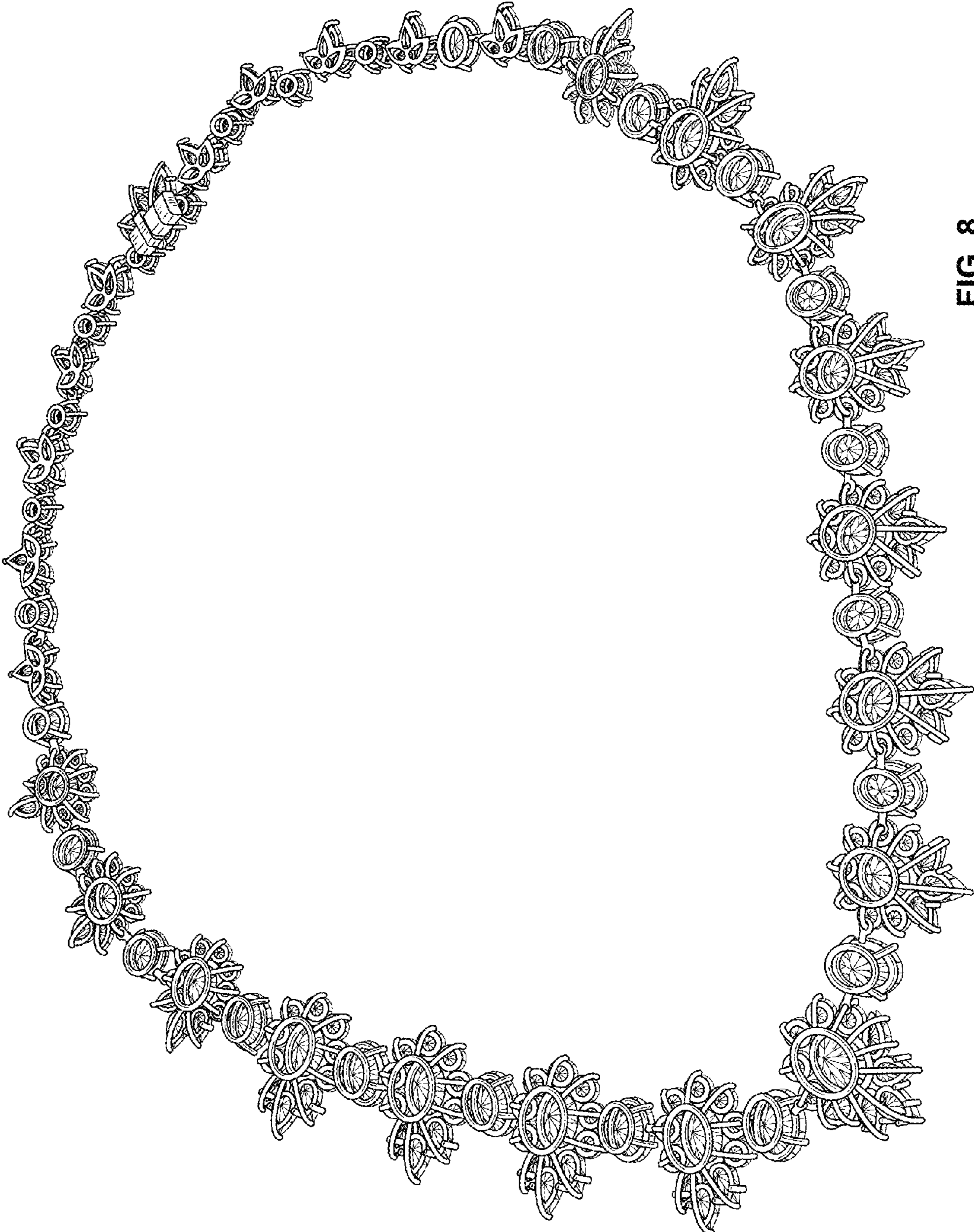
