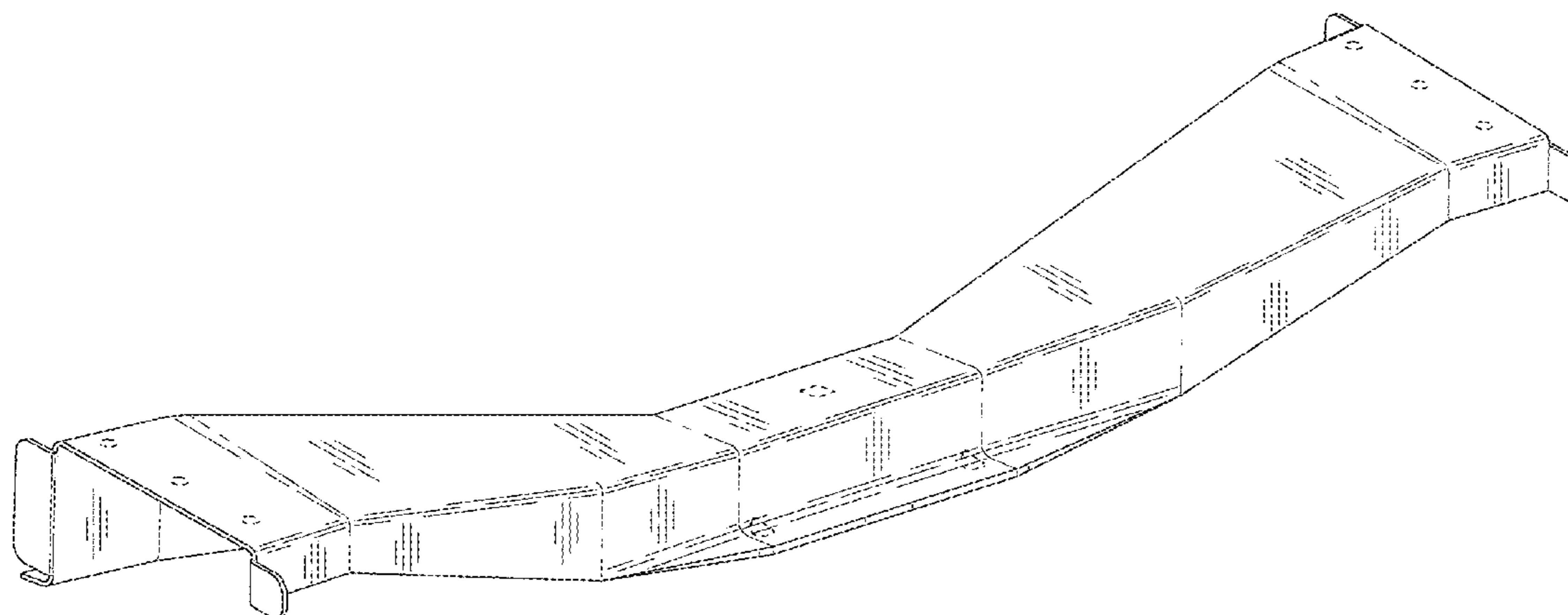
(57) **CLAIM**

The ornamental design for a passenger vehicle chassis rear crossmember, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, rear, left perspective view of a passenger vehicle chassis rear crossmember, showing my new design; FIG. 2 is a rear elevational view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a bottom plan view thereof; and, FIG. 7 is a top plan view thereof. The broken lines illustrate portions of the passenger vehicle chassis rear crossmember that form no part of the claimed design.

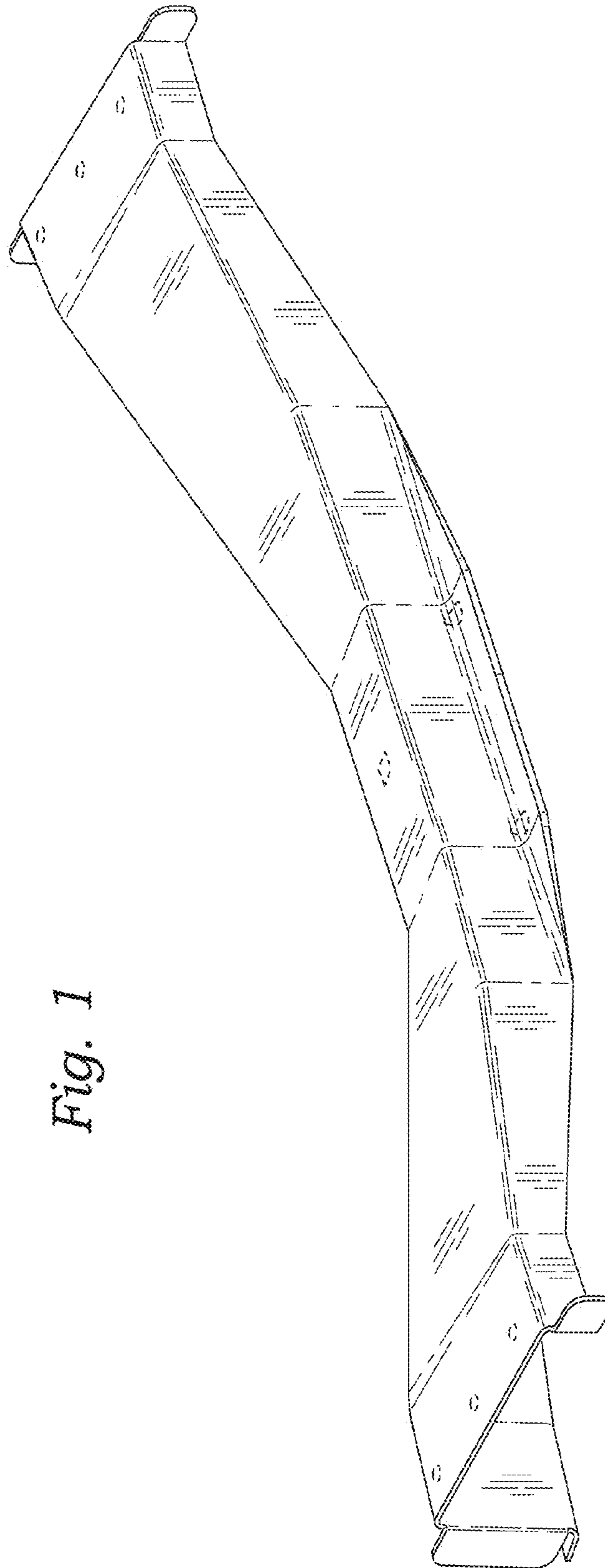

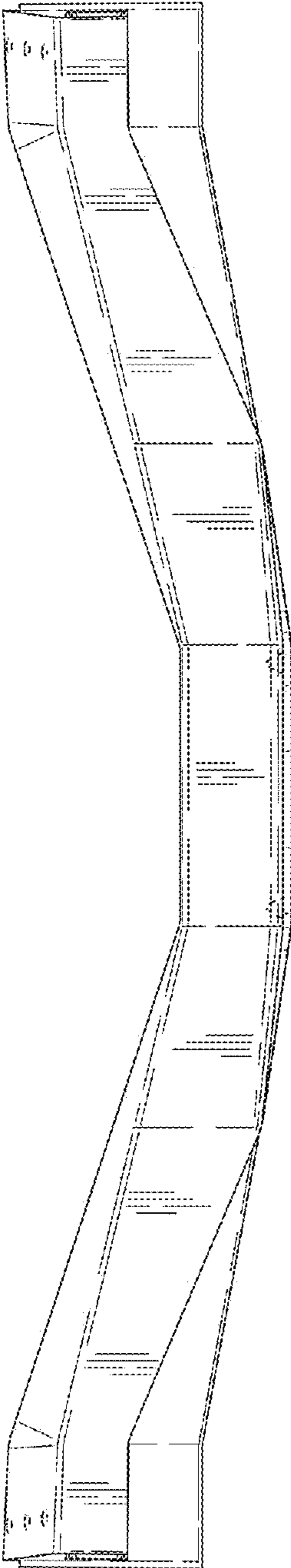

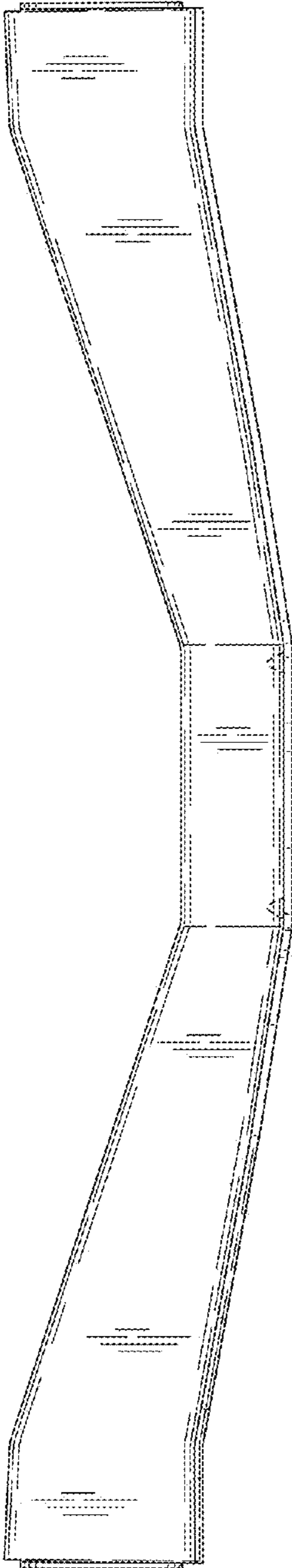

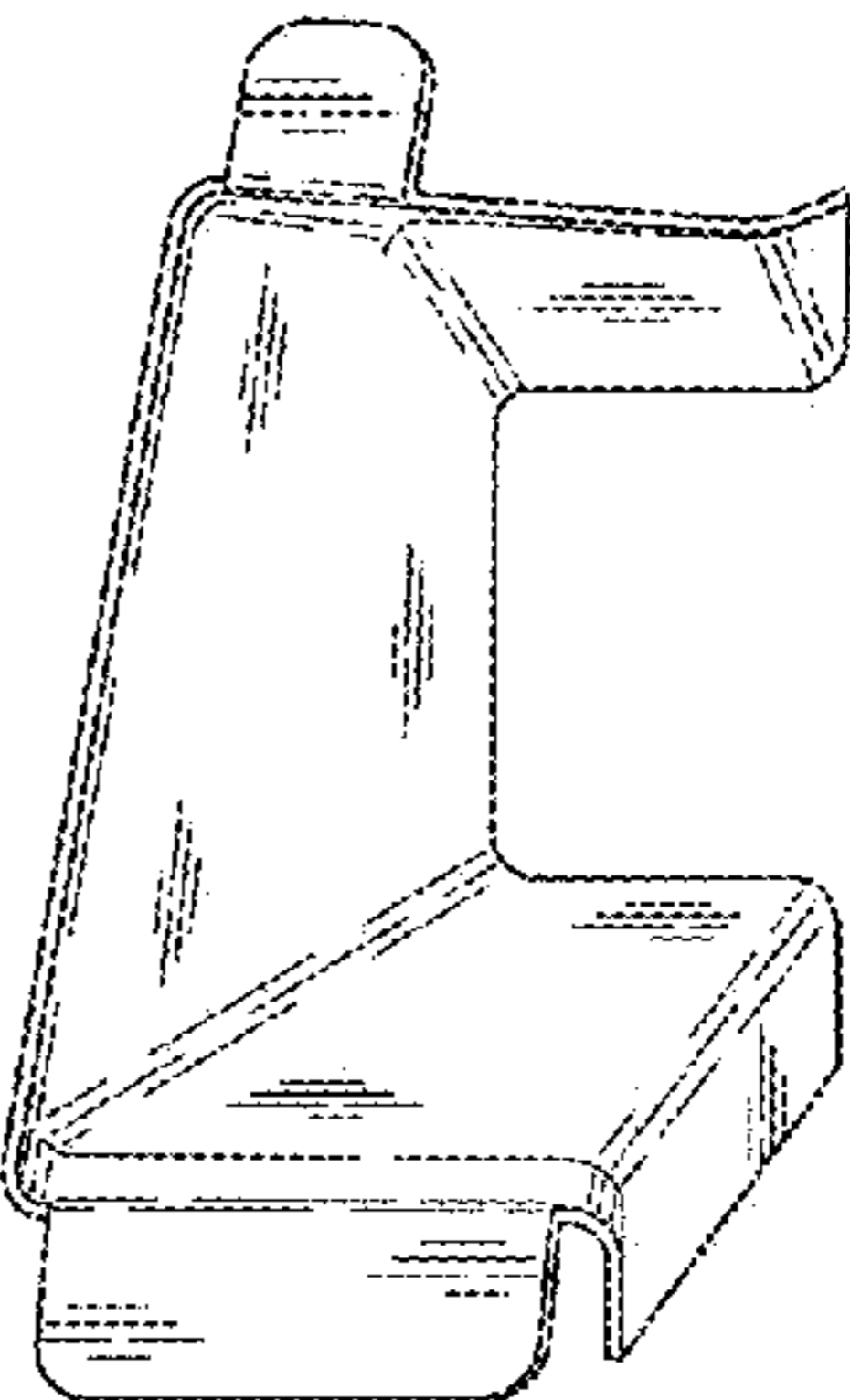
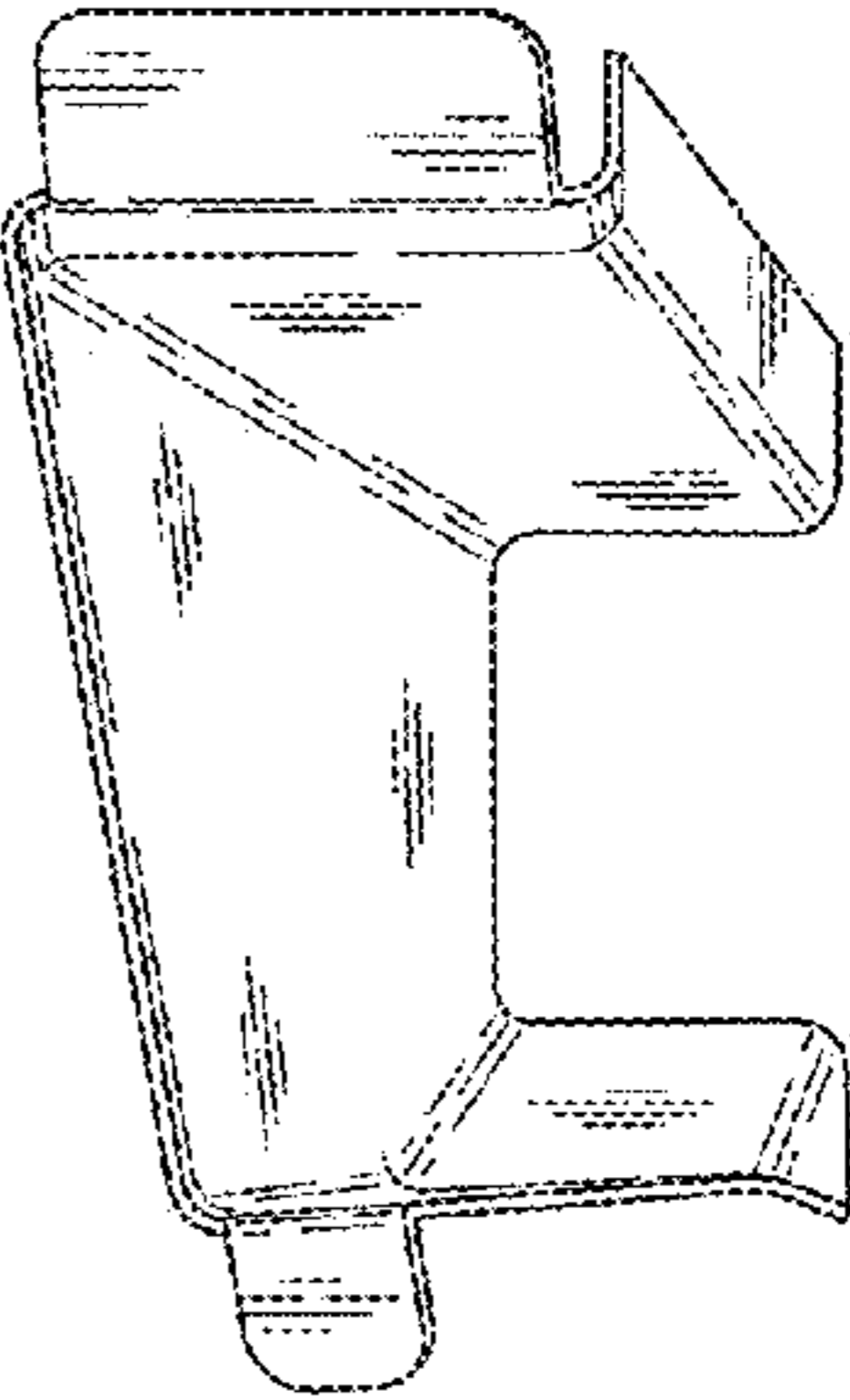
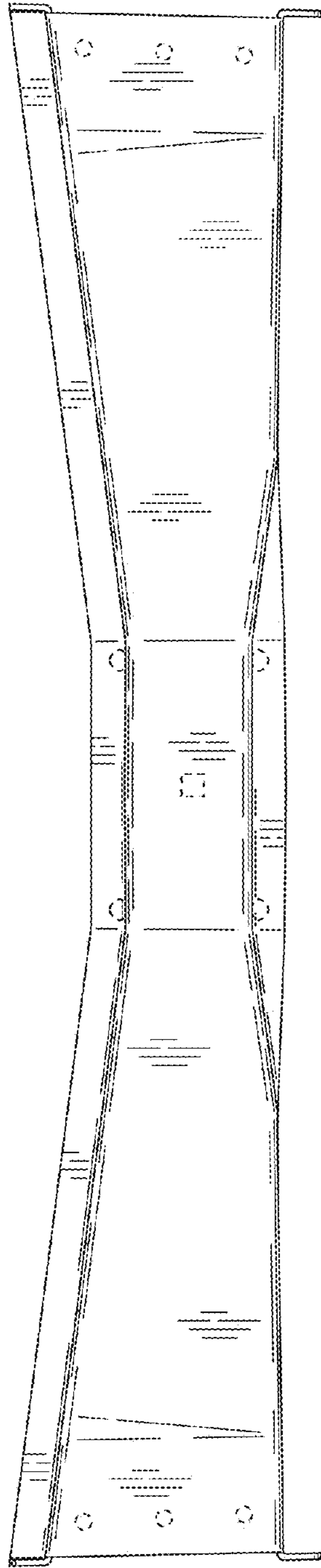
