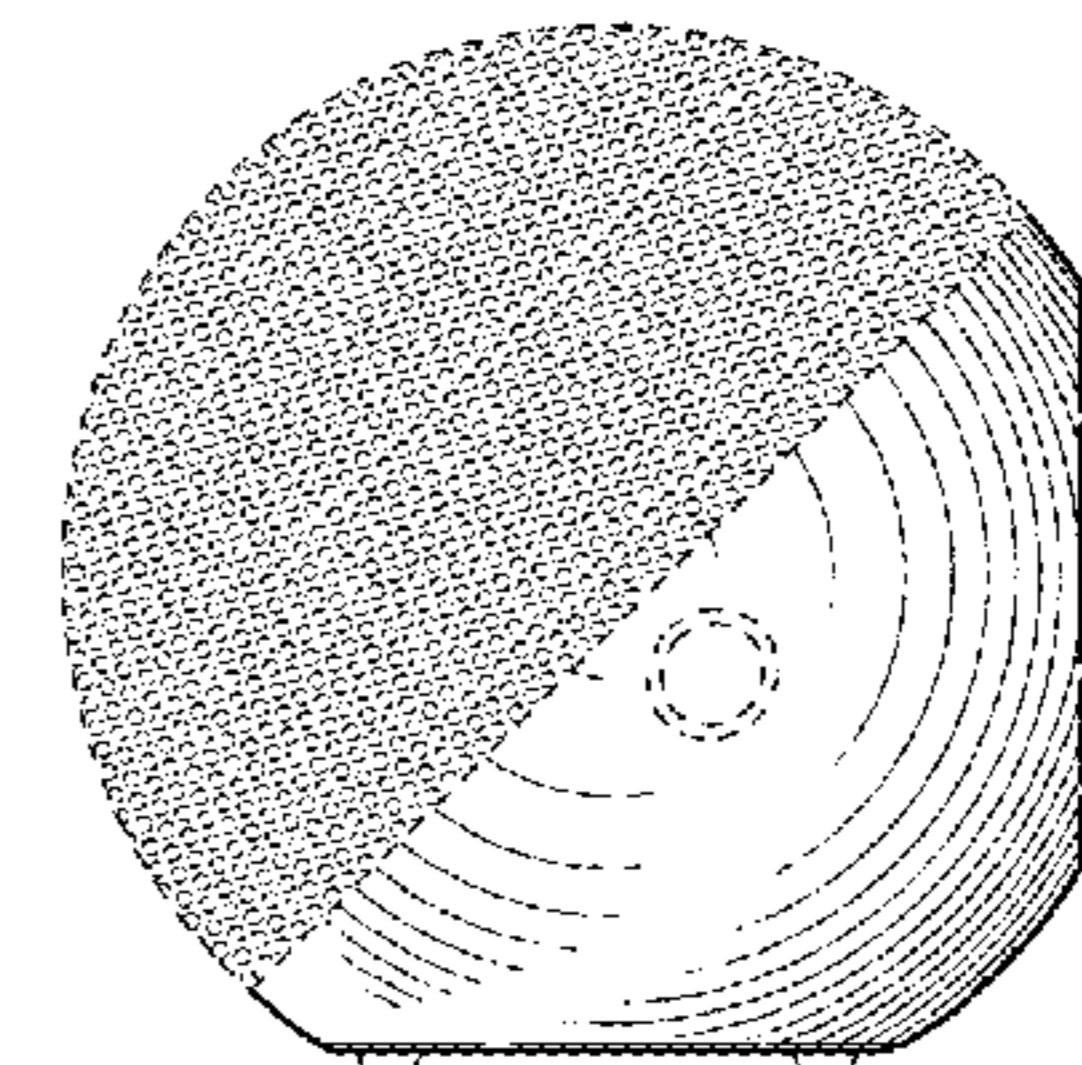
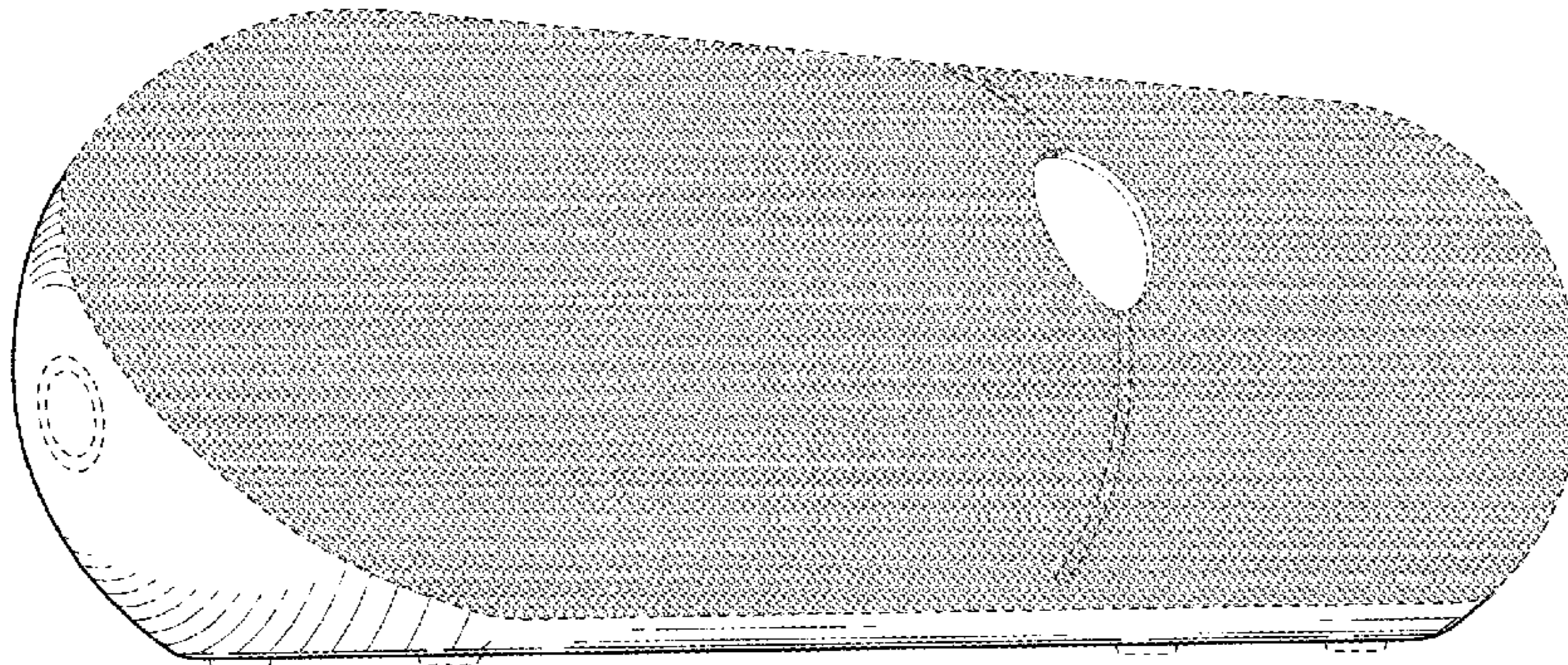
The ornamental design for an audio speaker system, as shown and described.

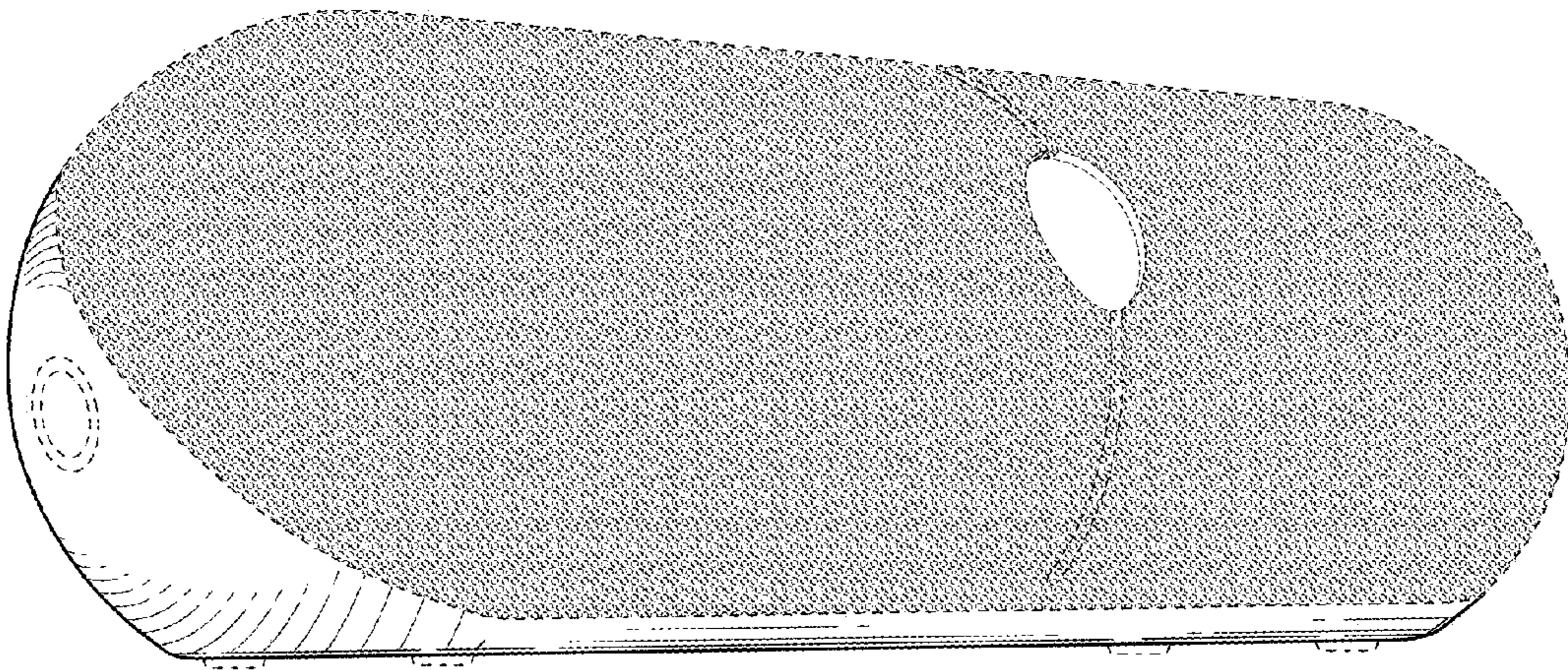

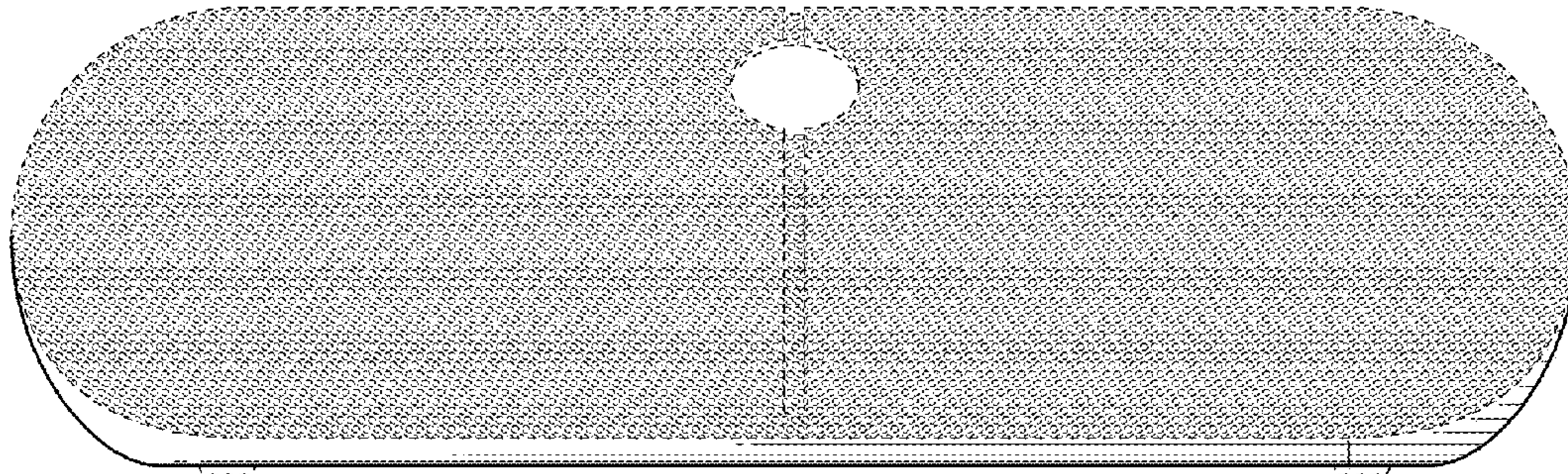

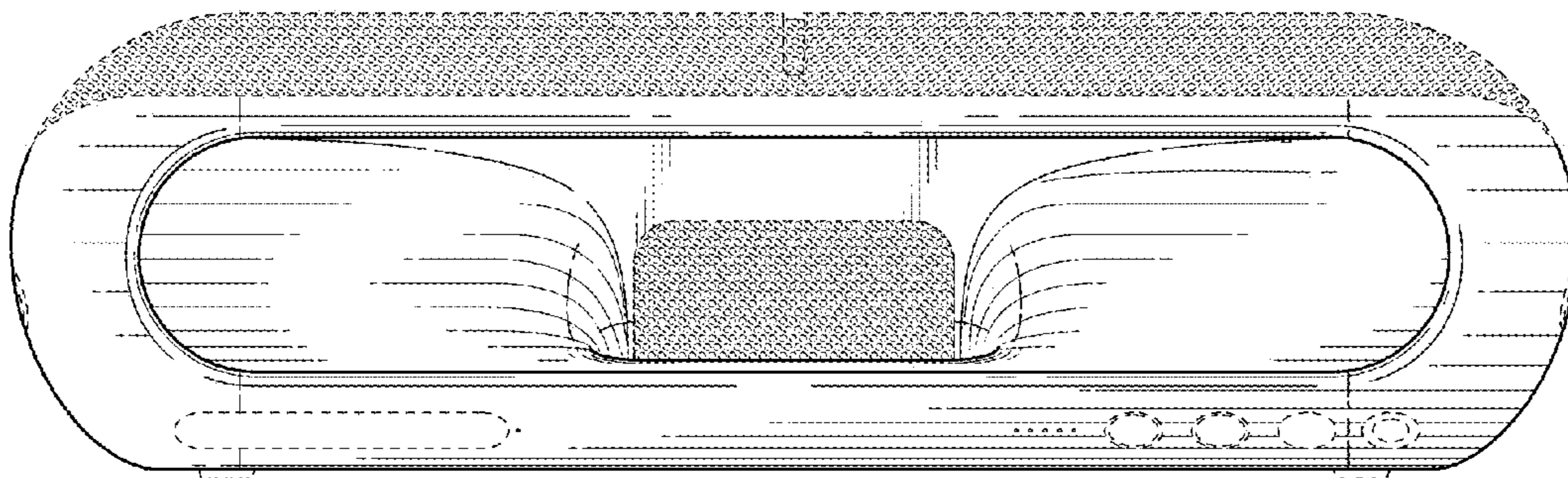

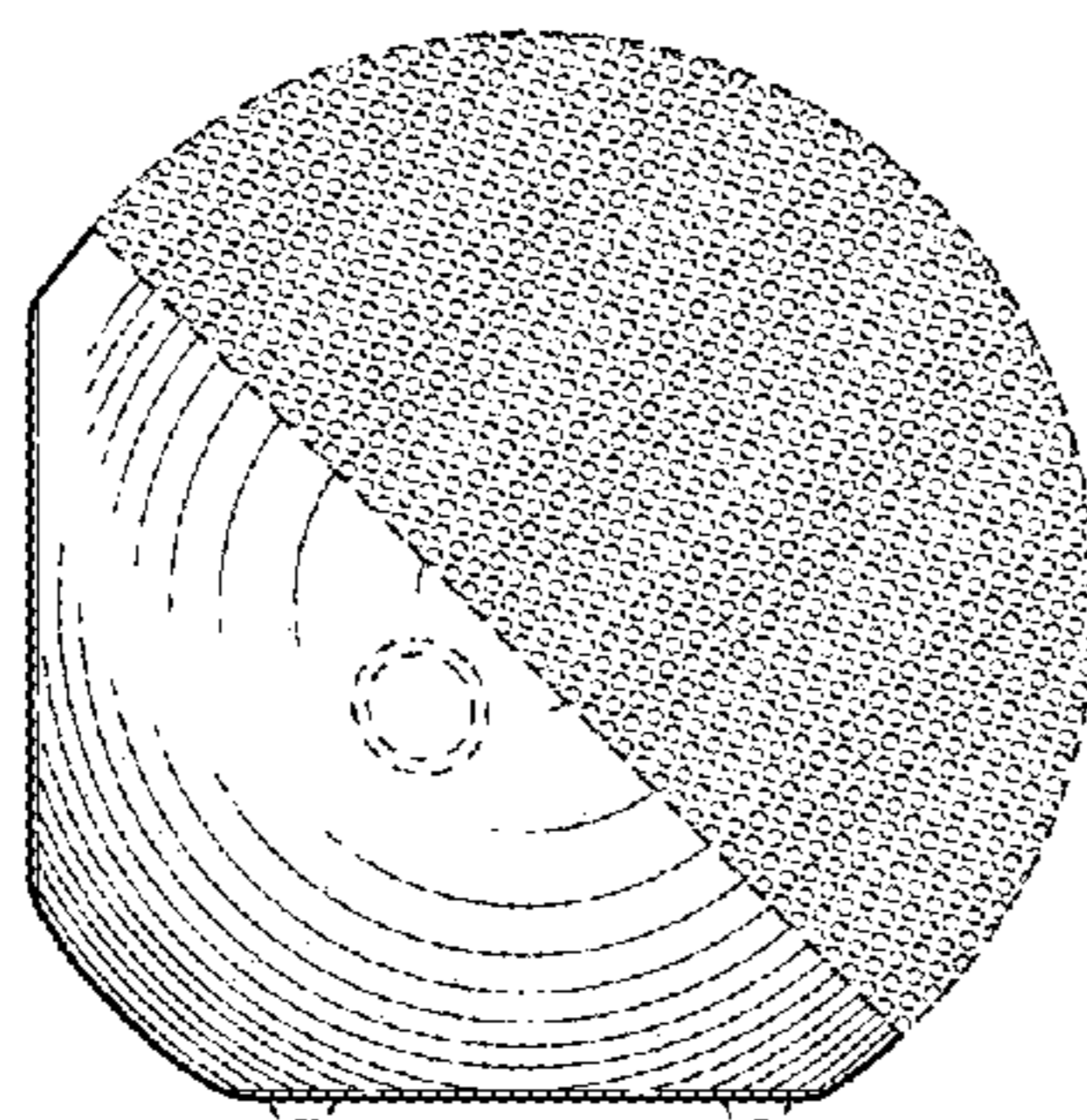

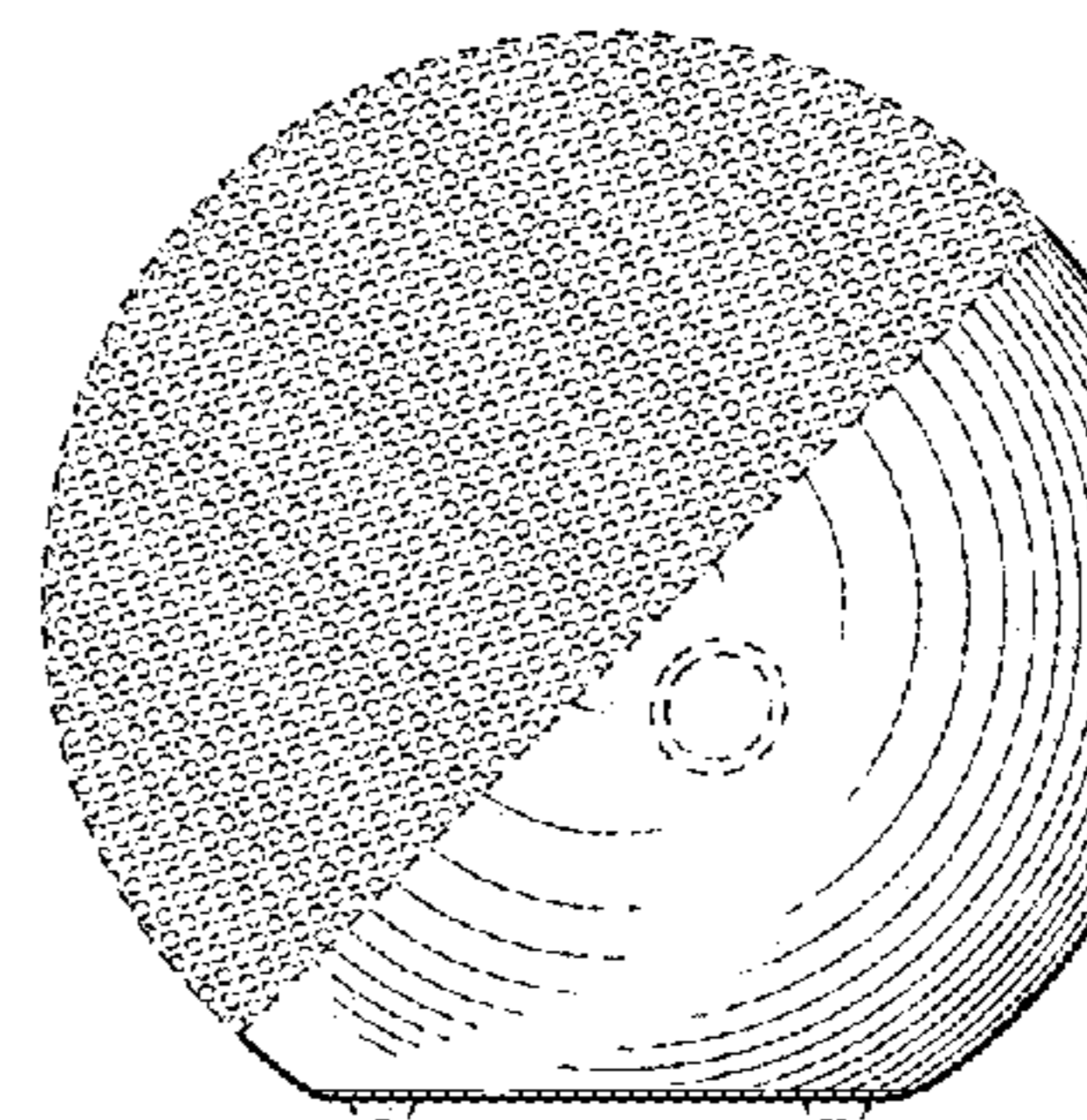

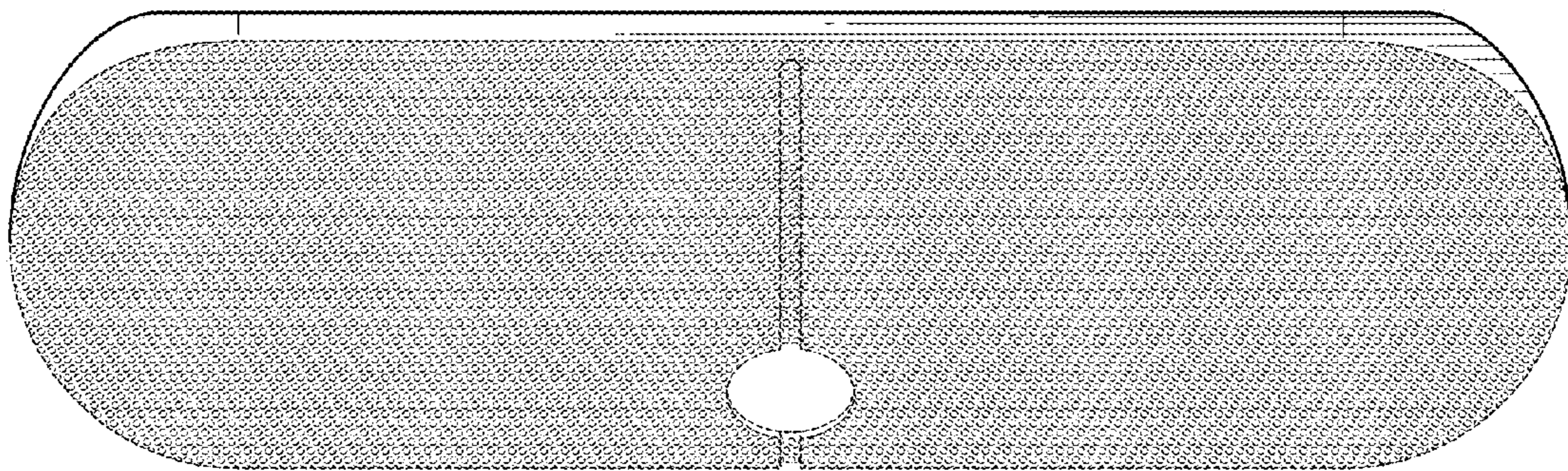

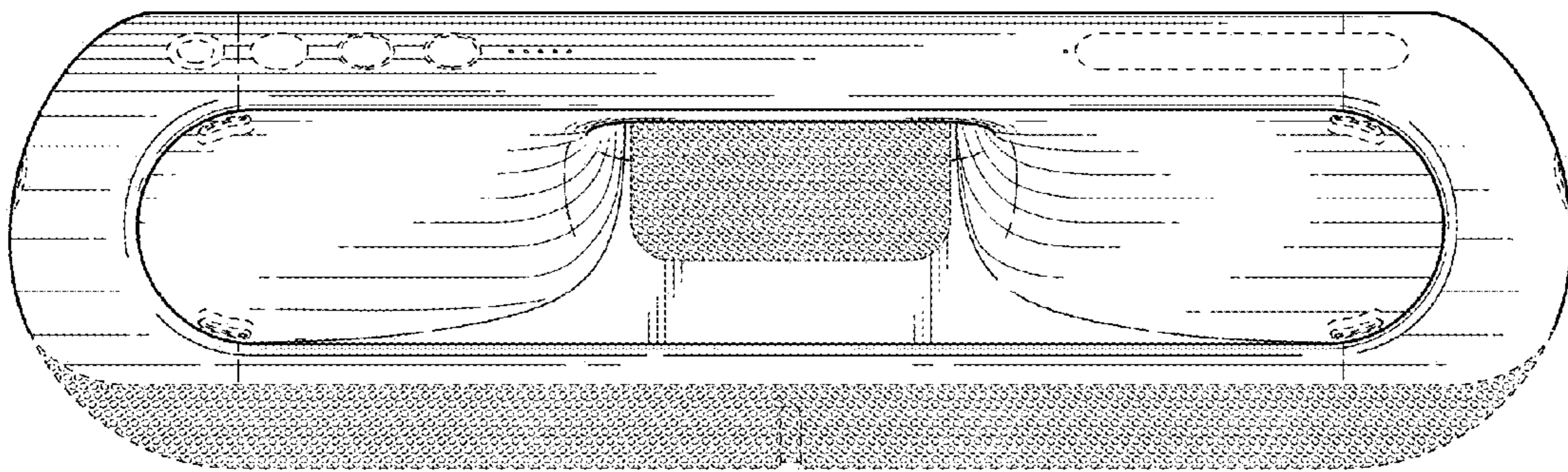

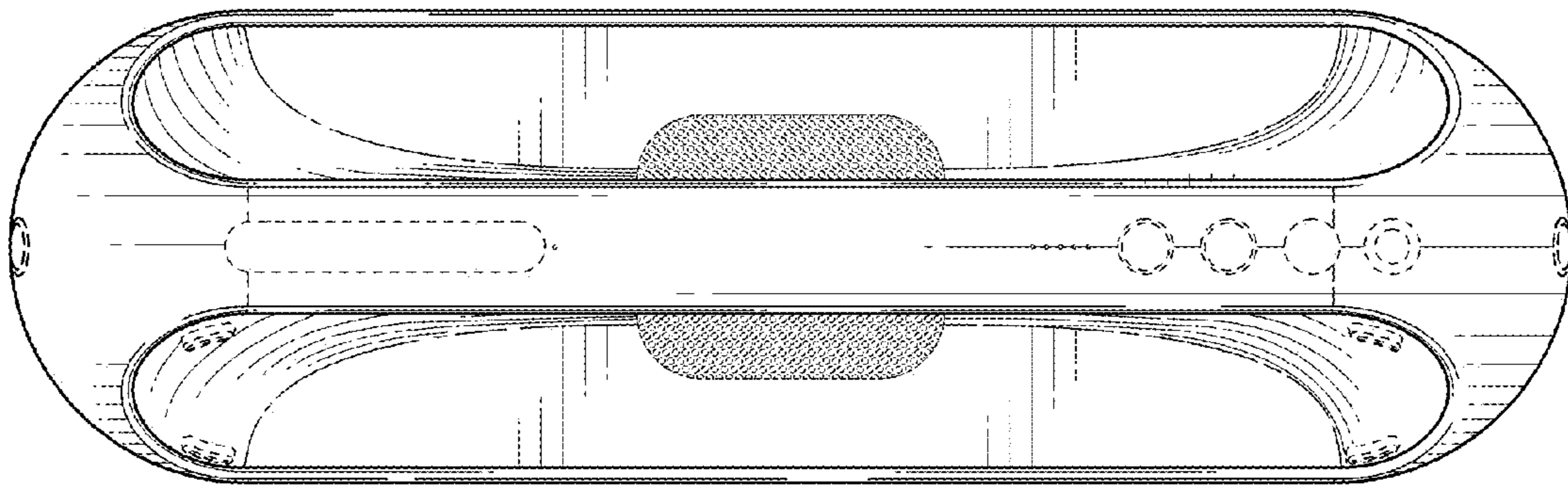

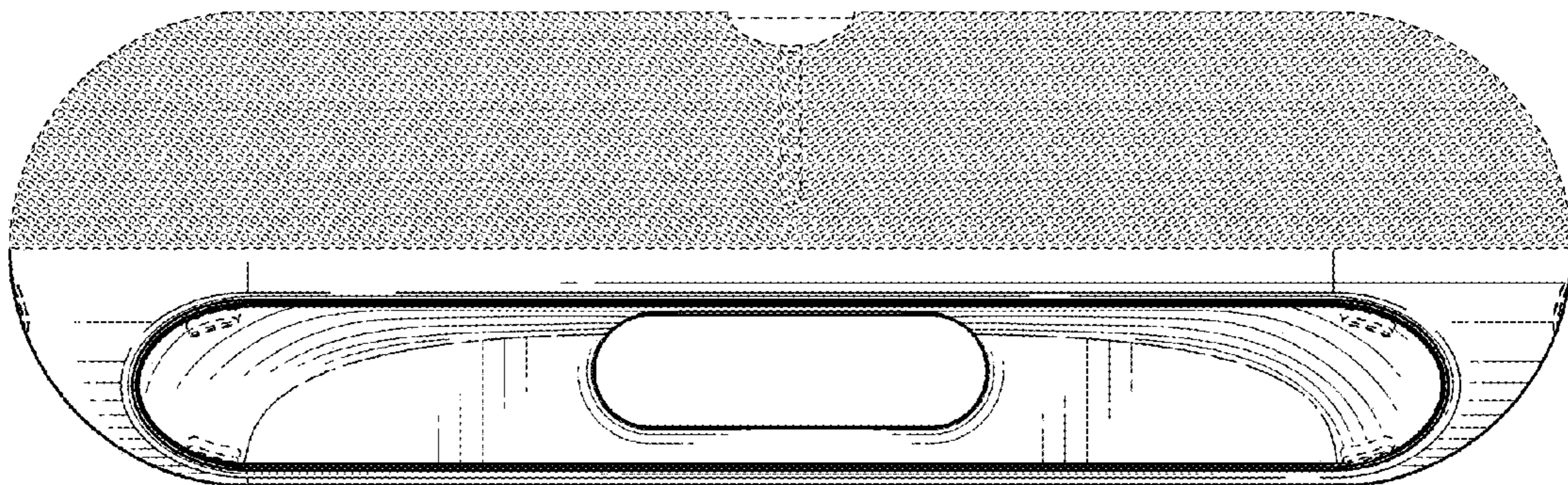
