**DESCRIPTION**

FIG. 1 is a front perspective view of a case for electronic device, showing our new design;

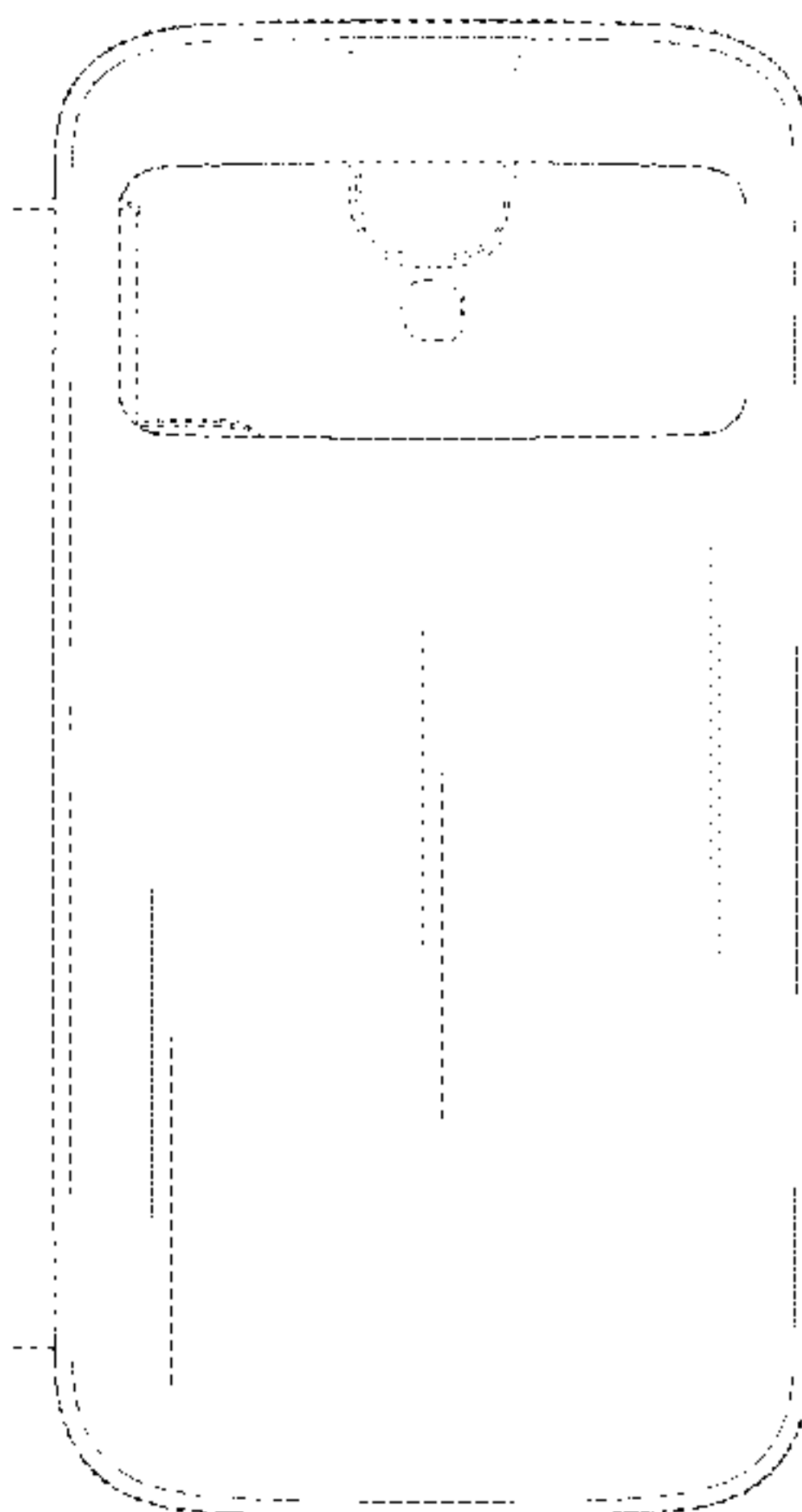
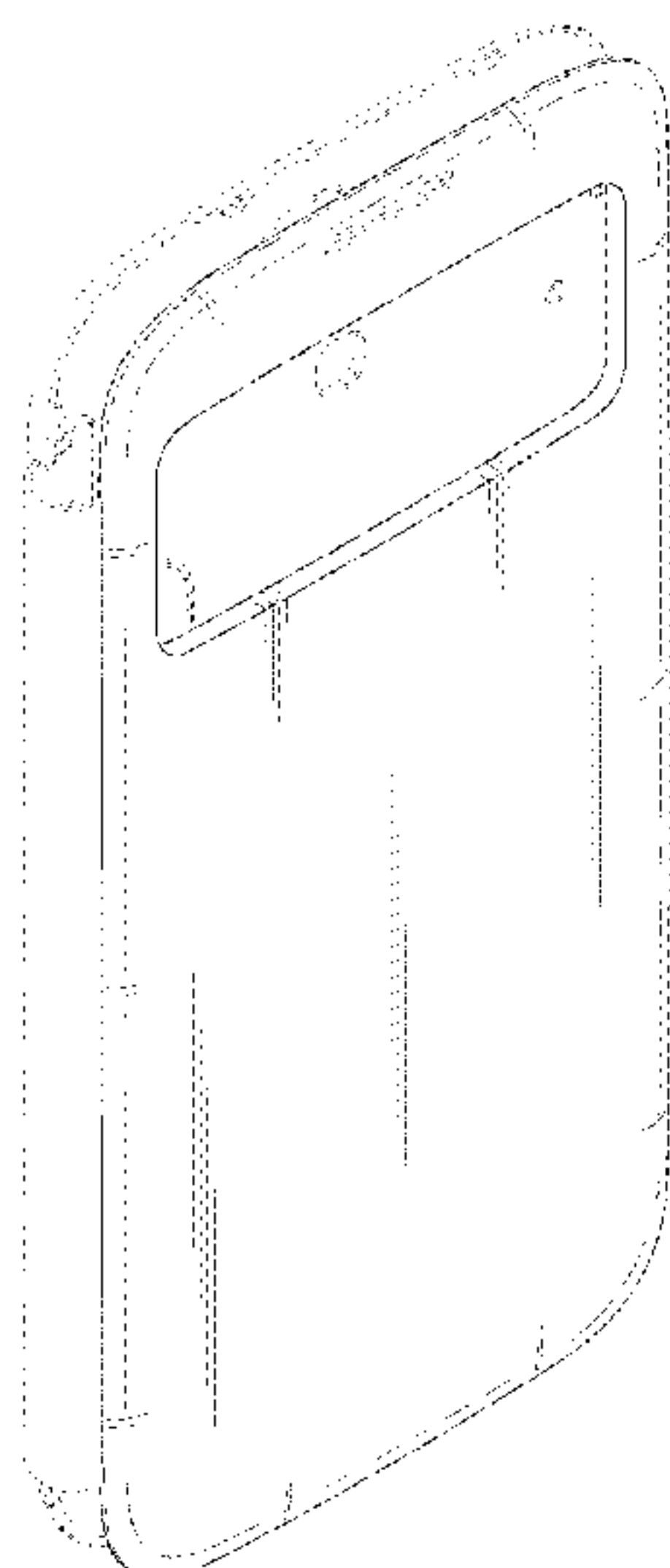

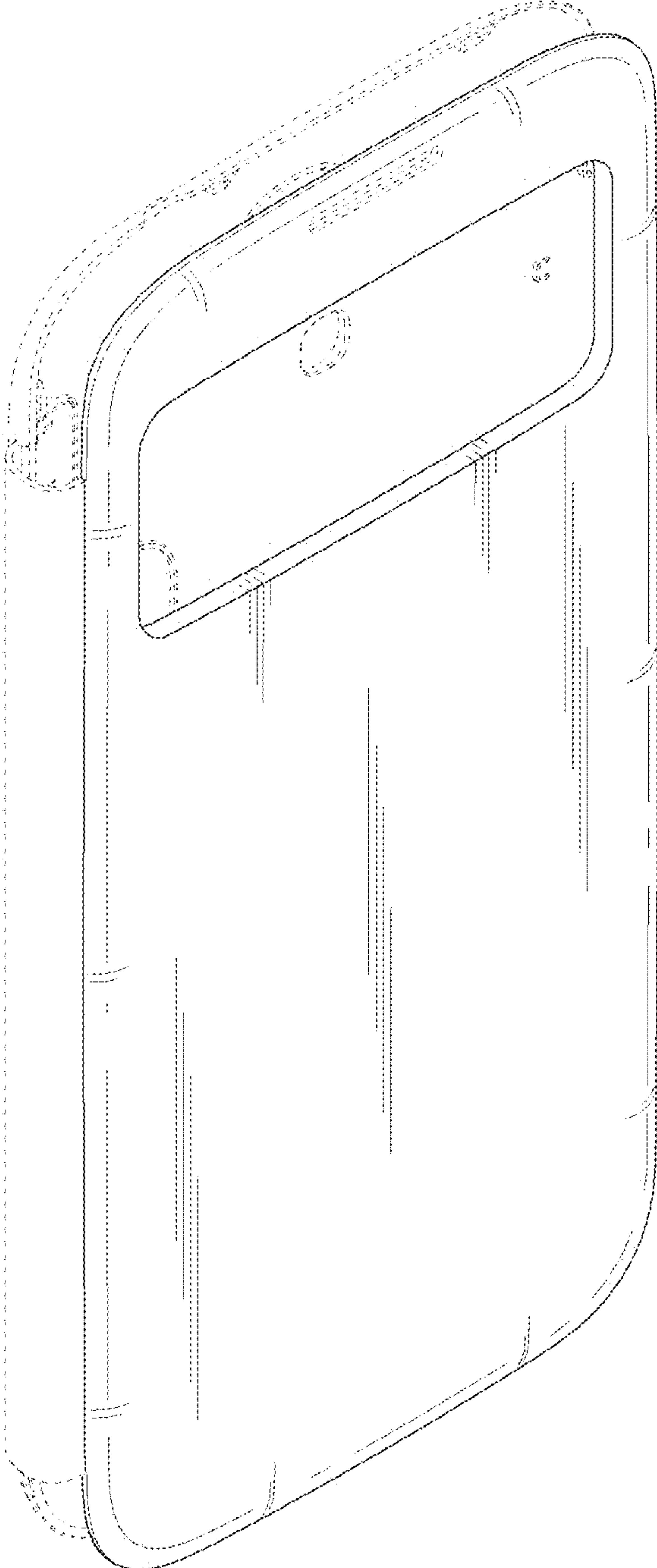

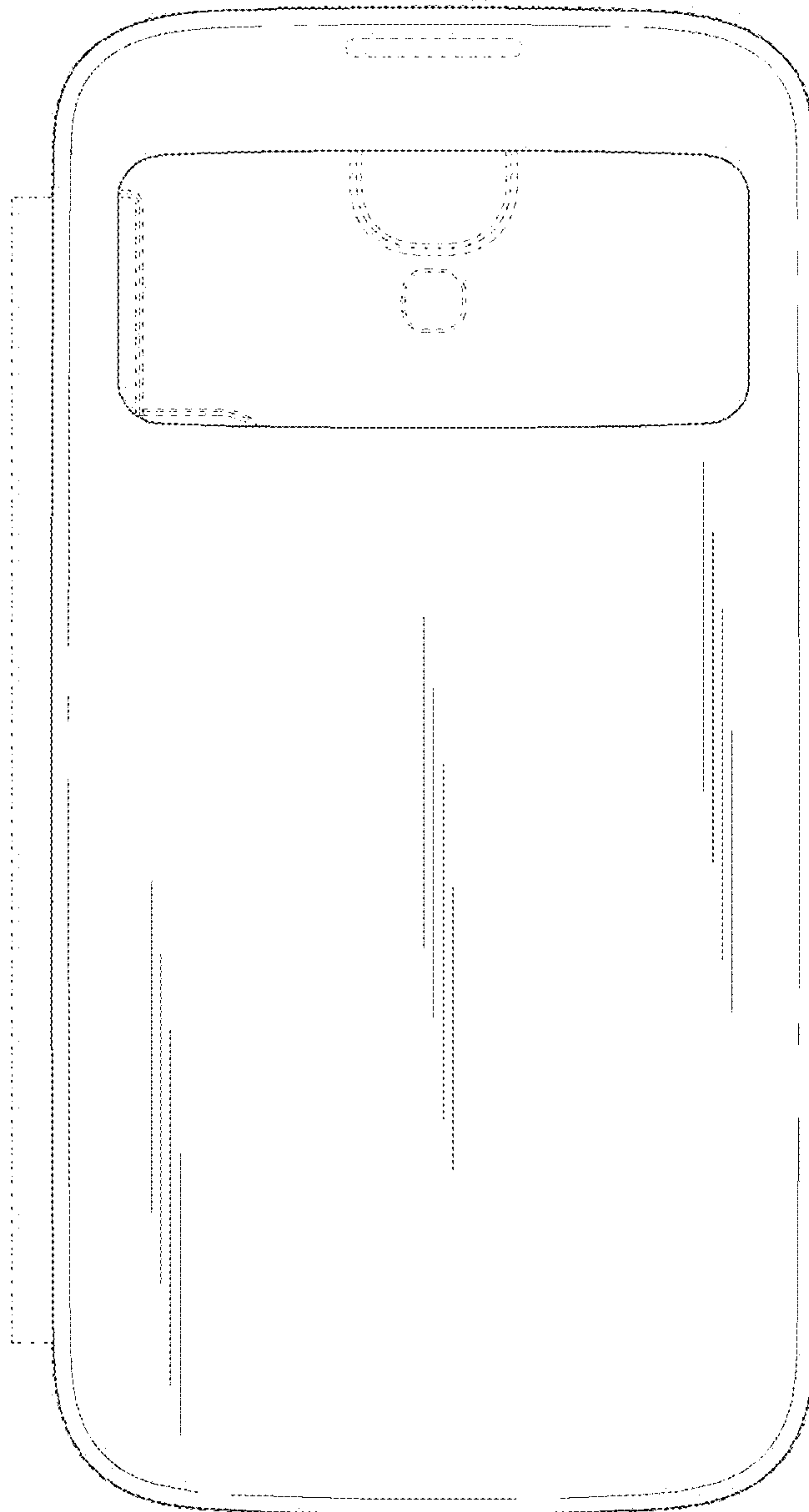

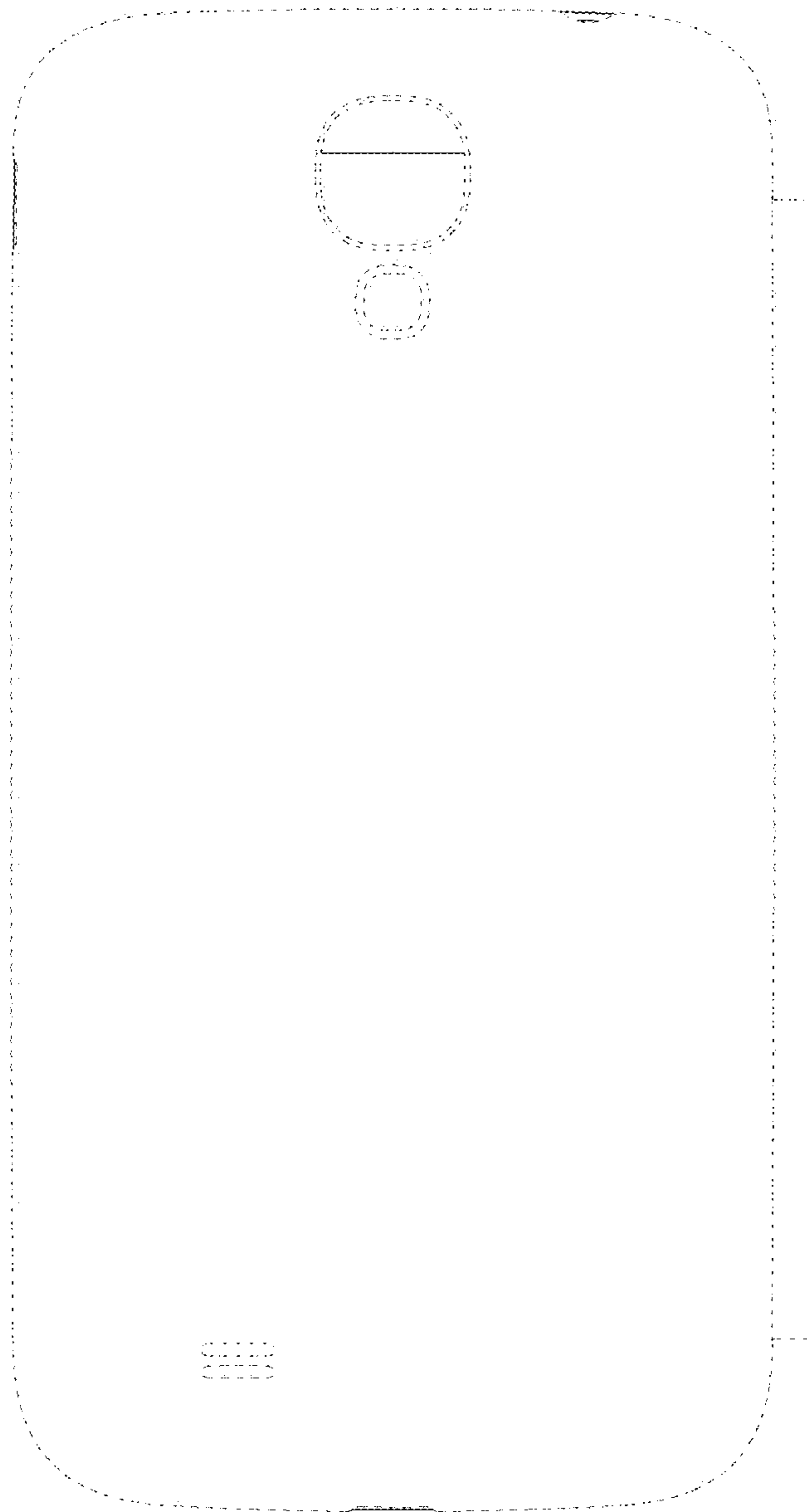

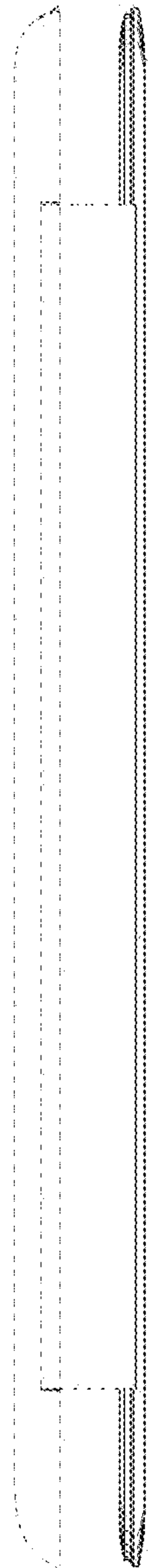

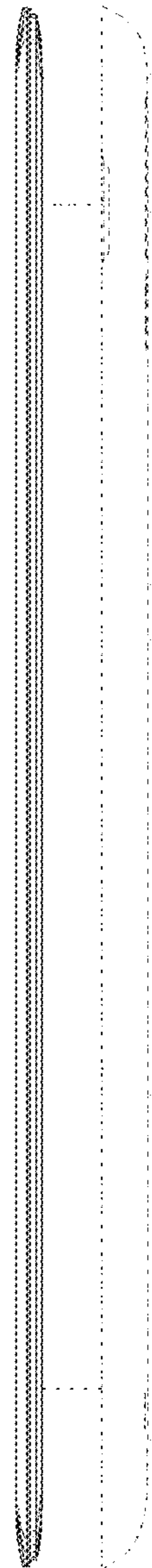

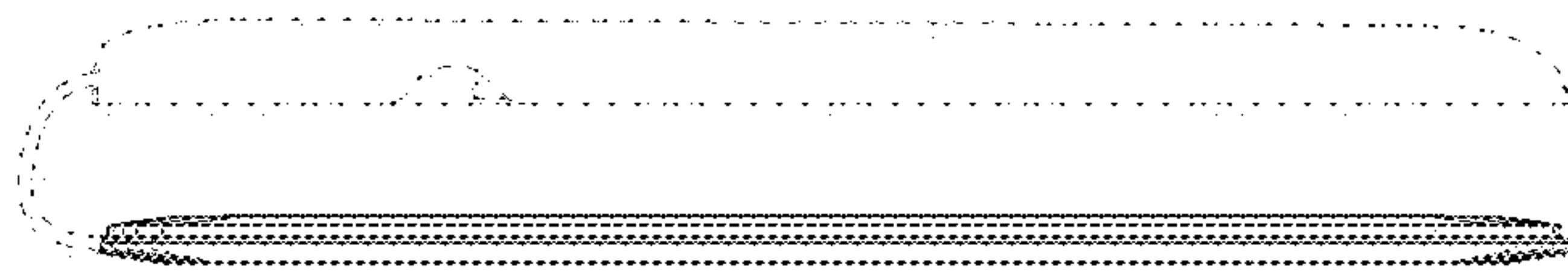
