DESCRIPTION

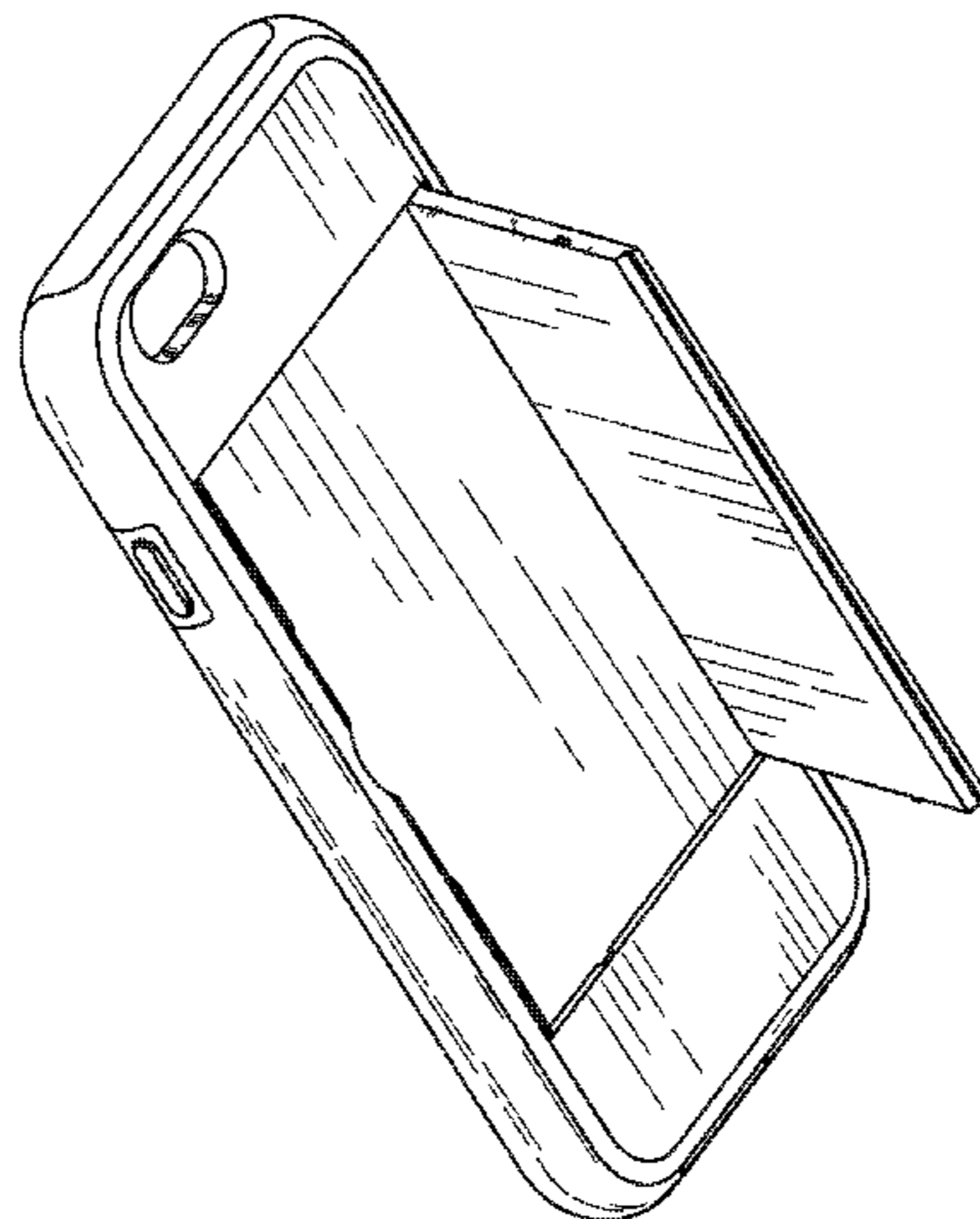
FIG. 1 is a first perspective view of a mobile phone case showing my new design;

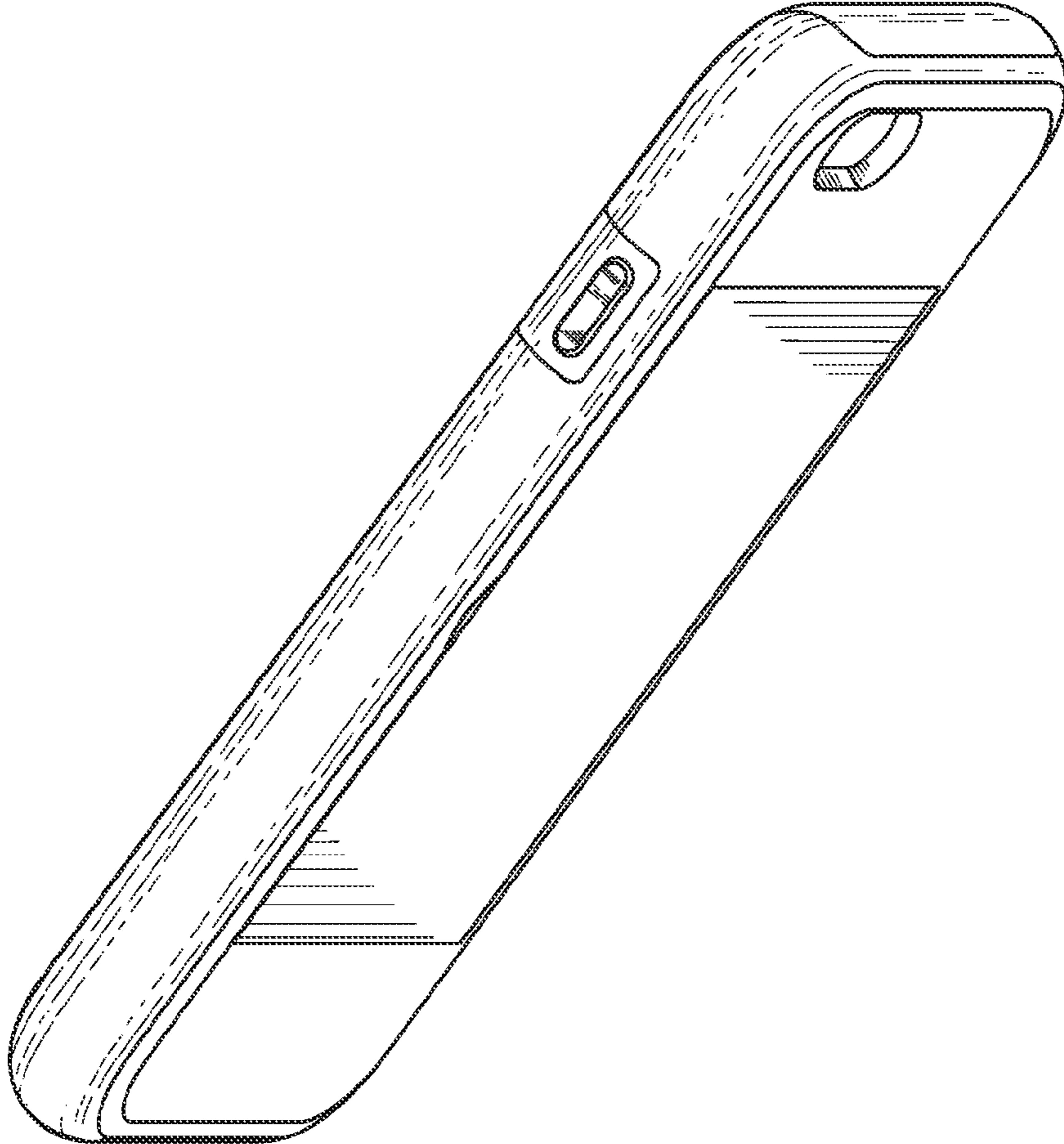

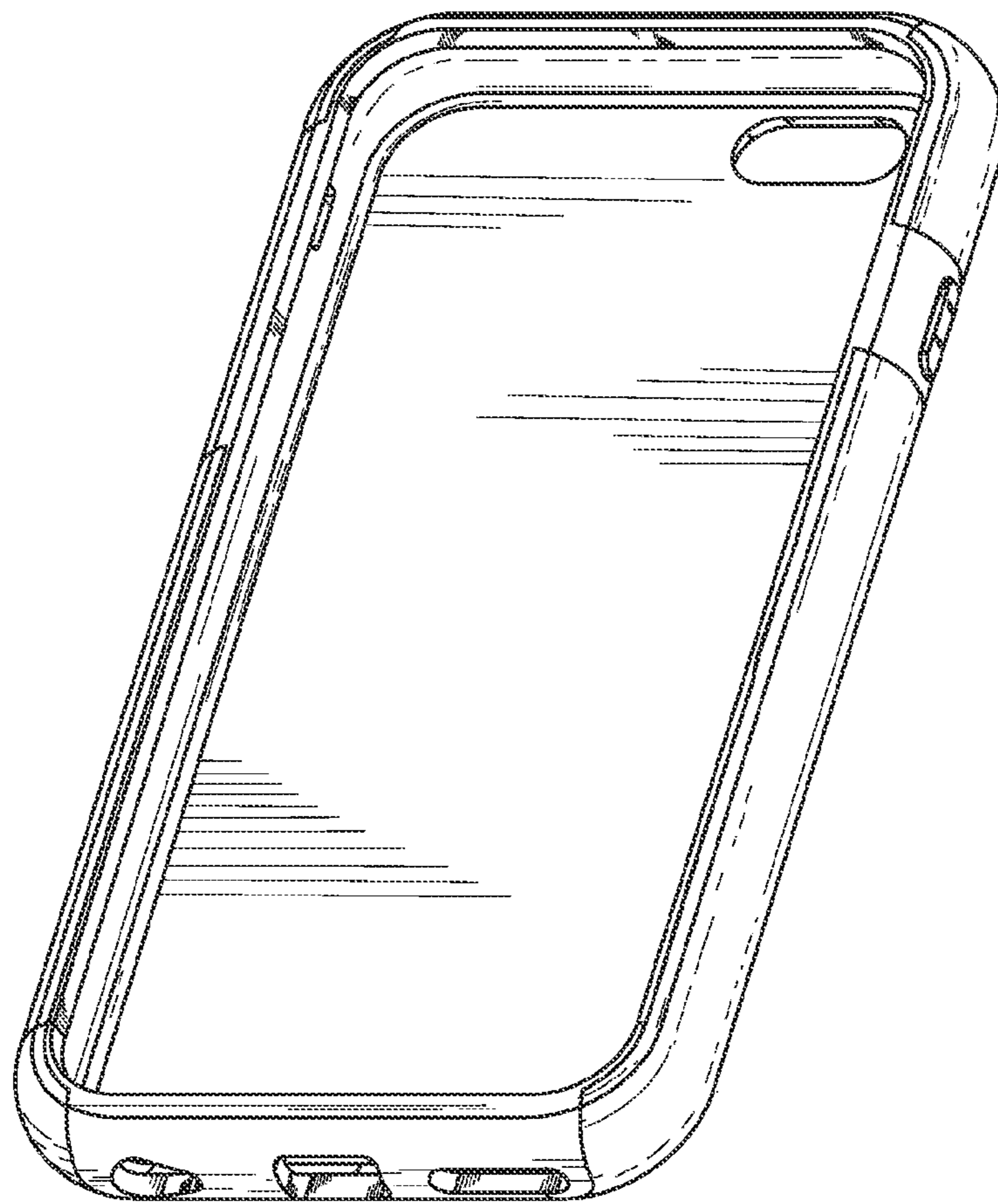

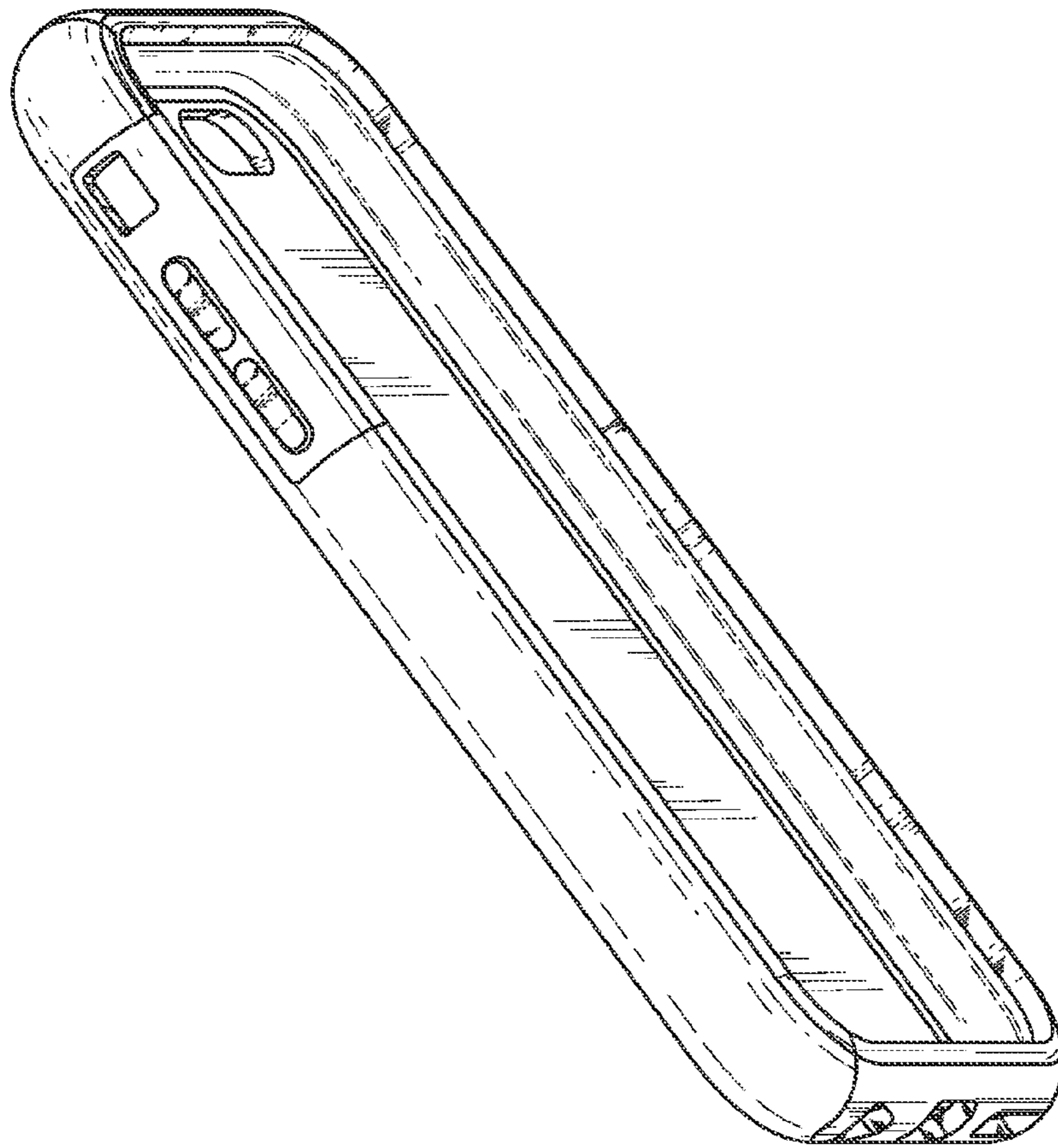

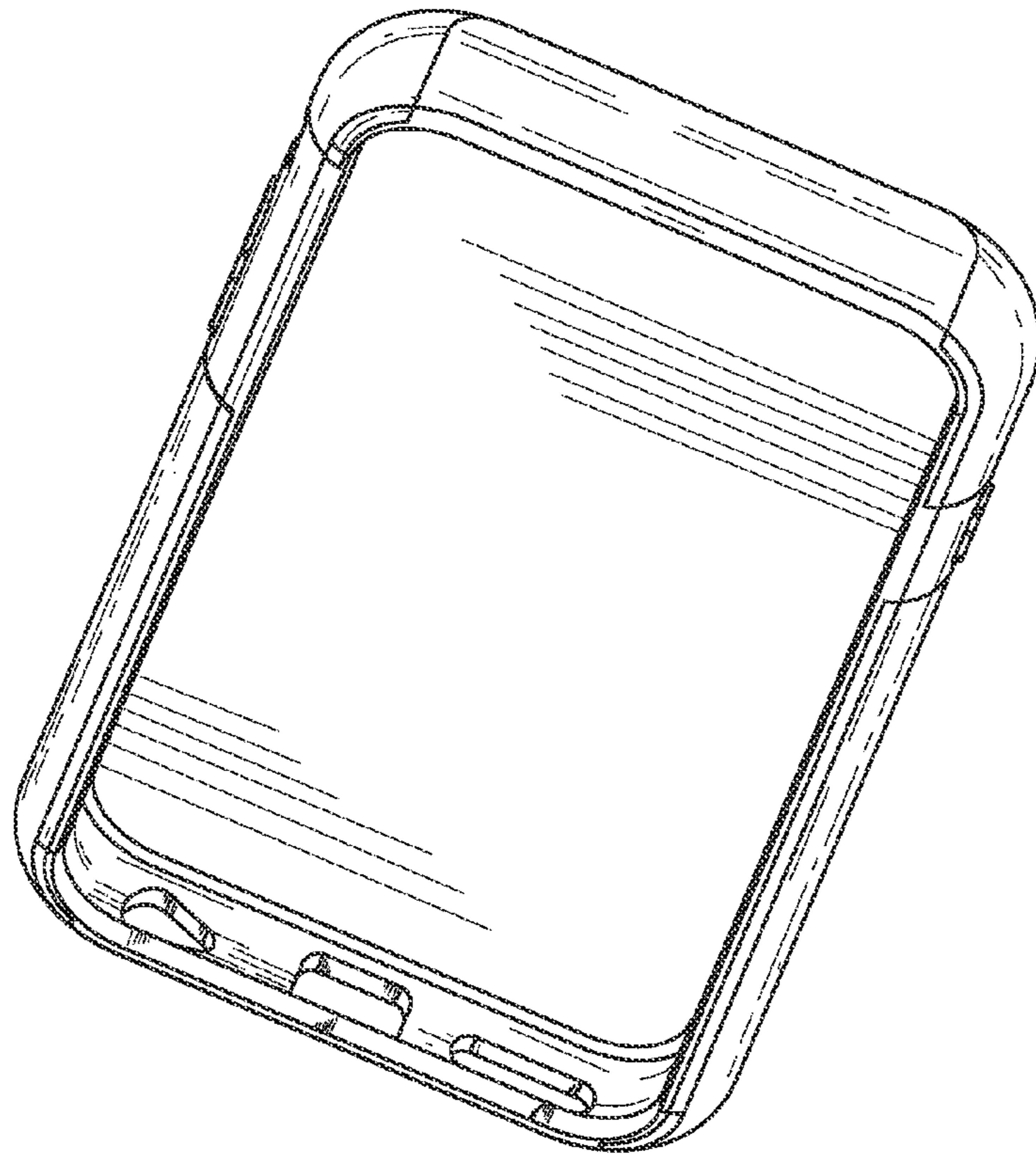

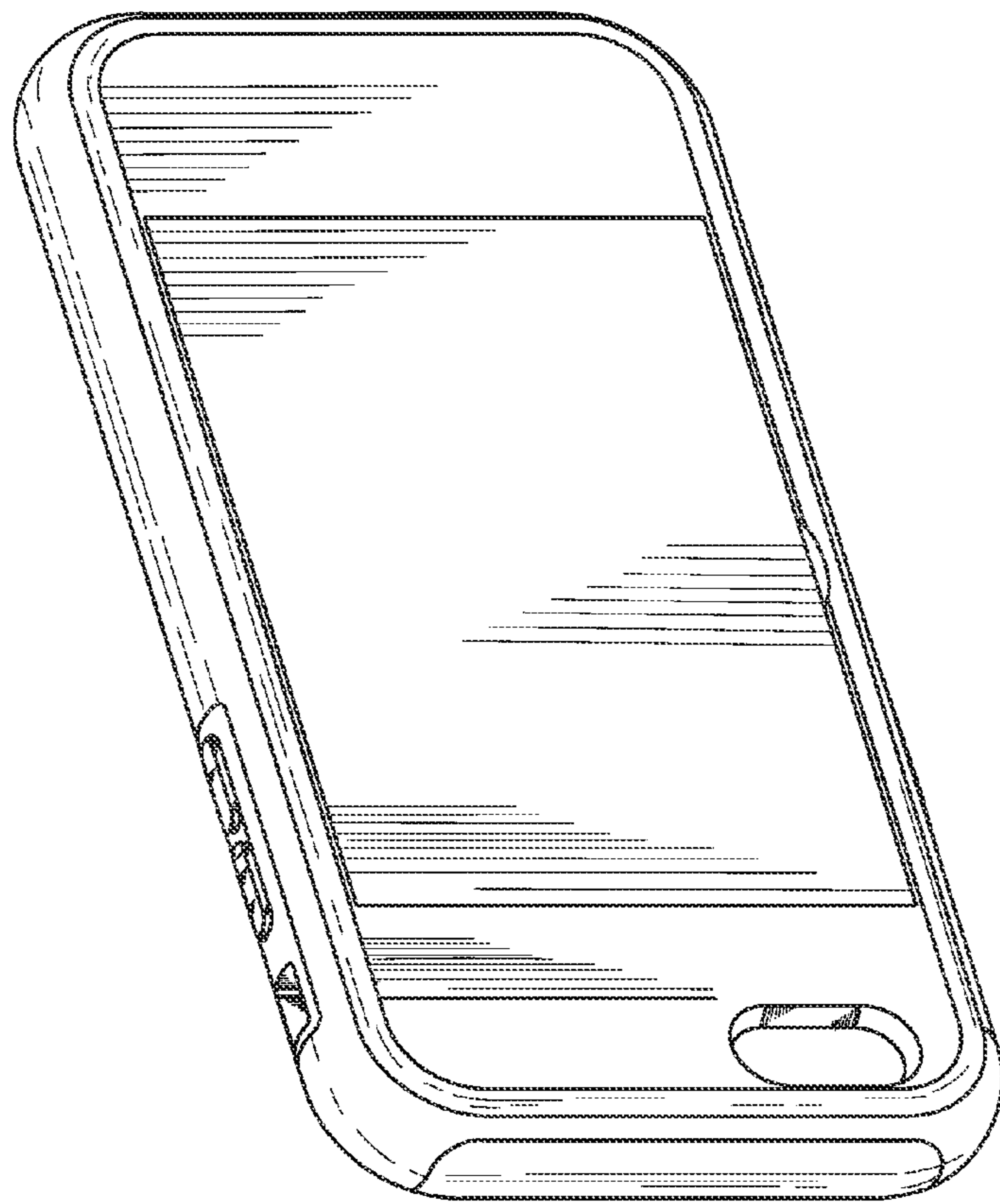

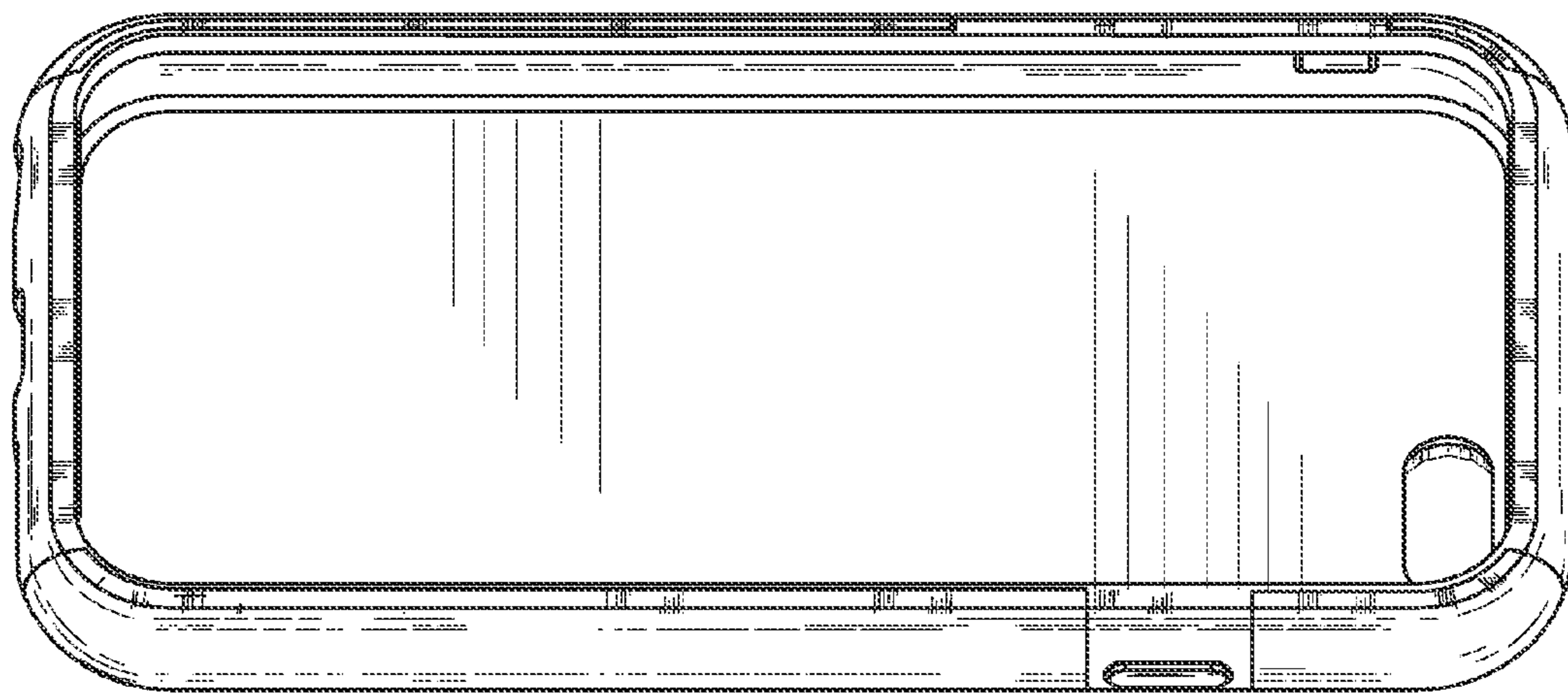

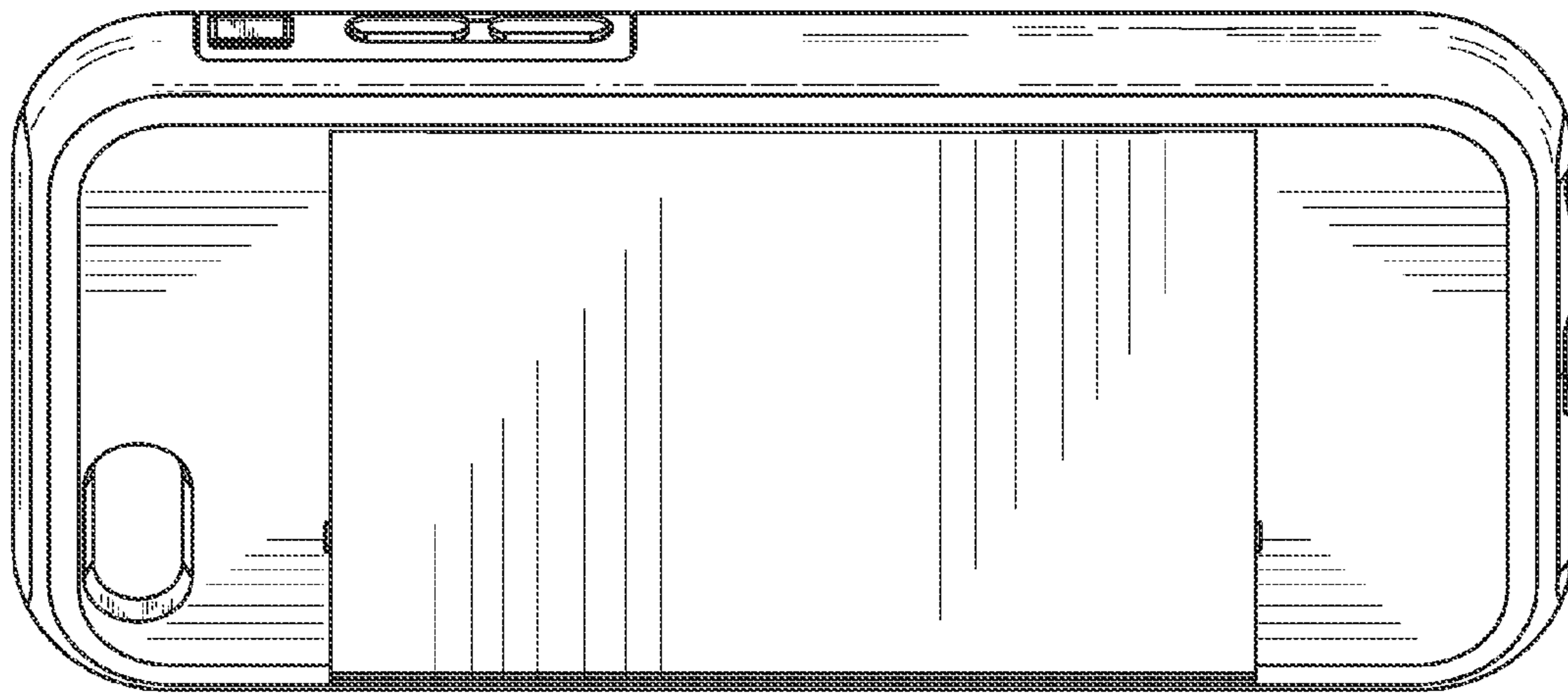

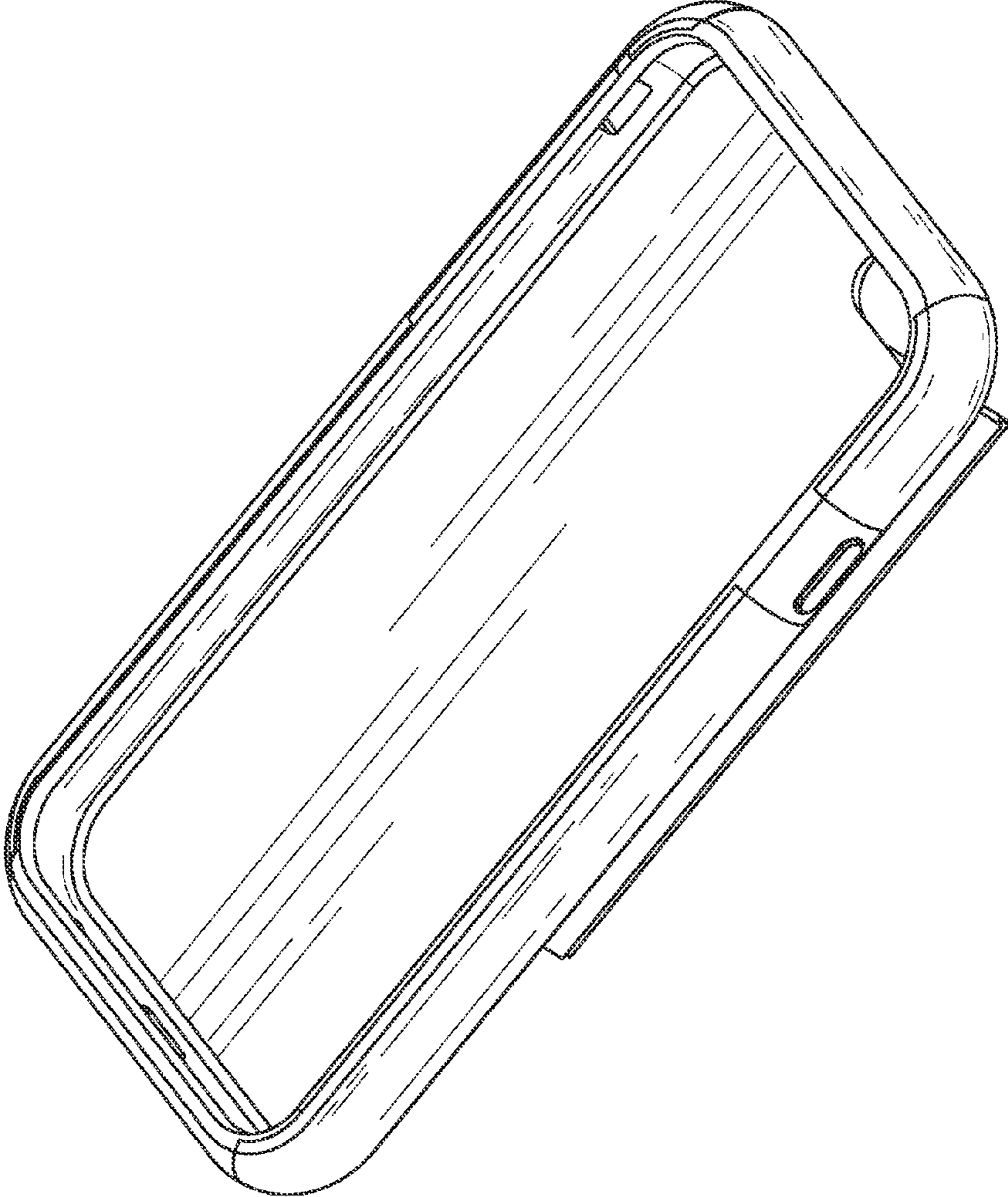

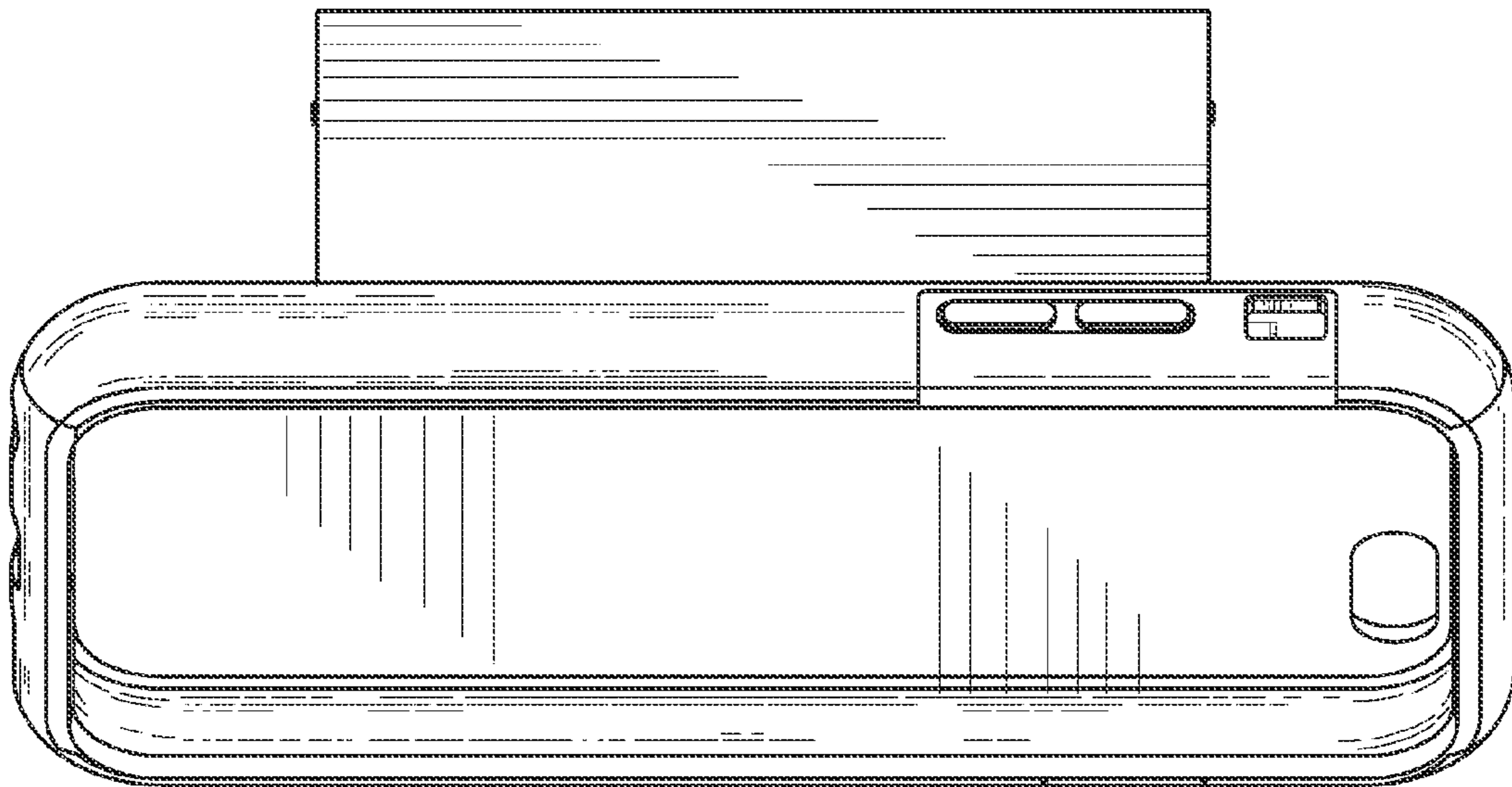

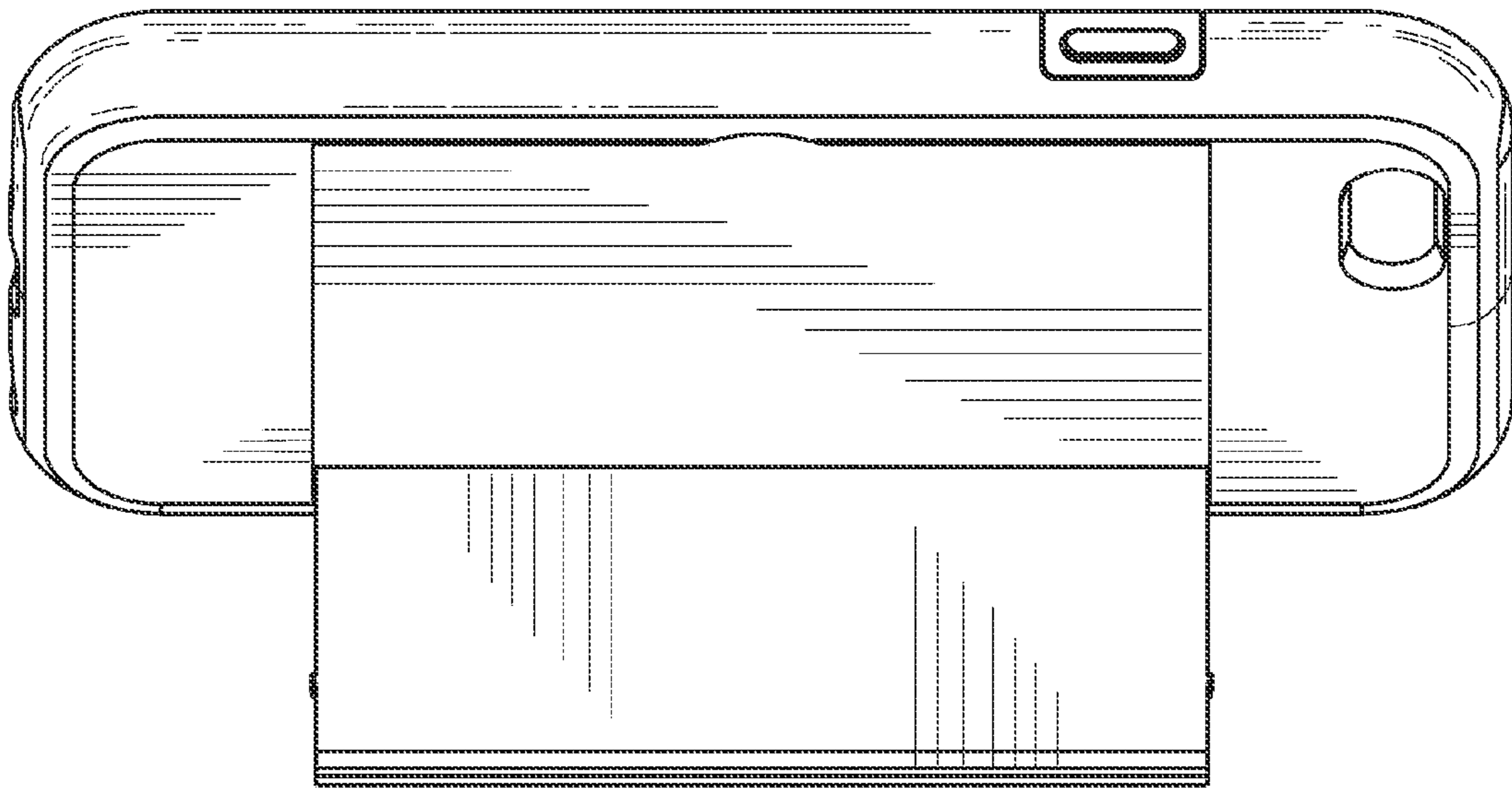

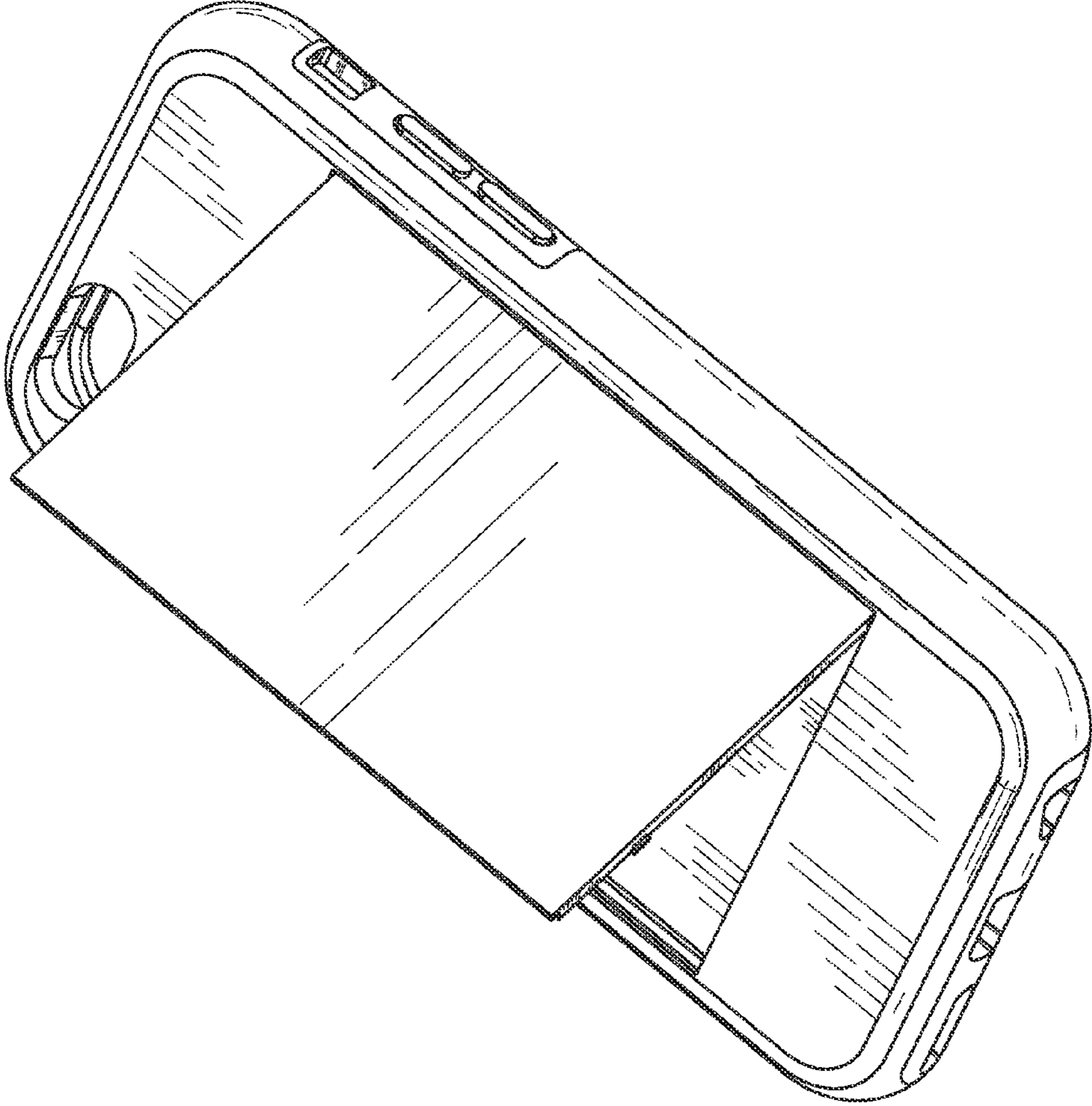

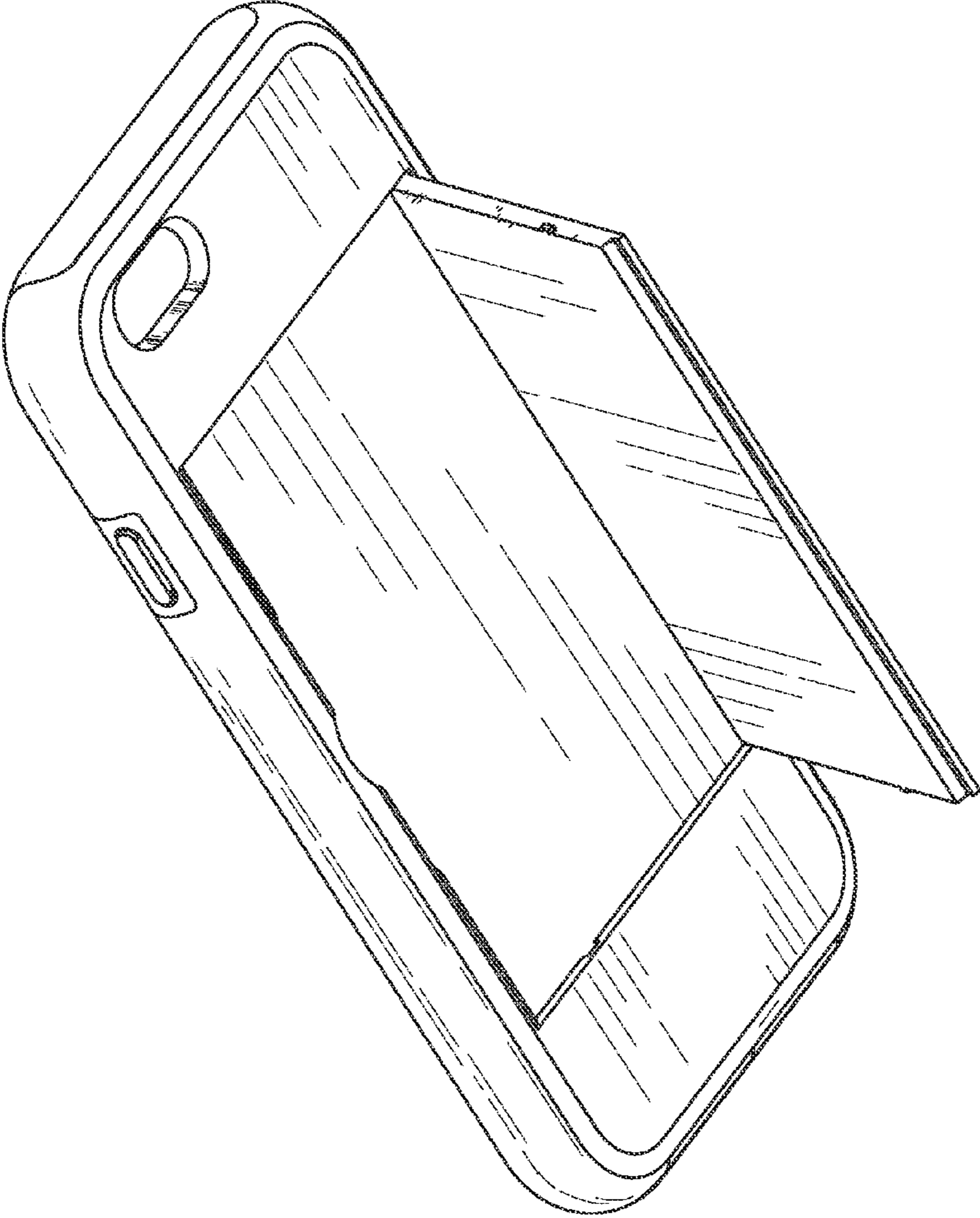

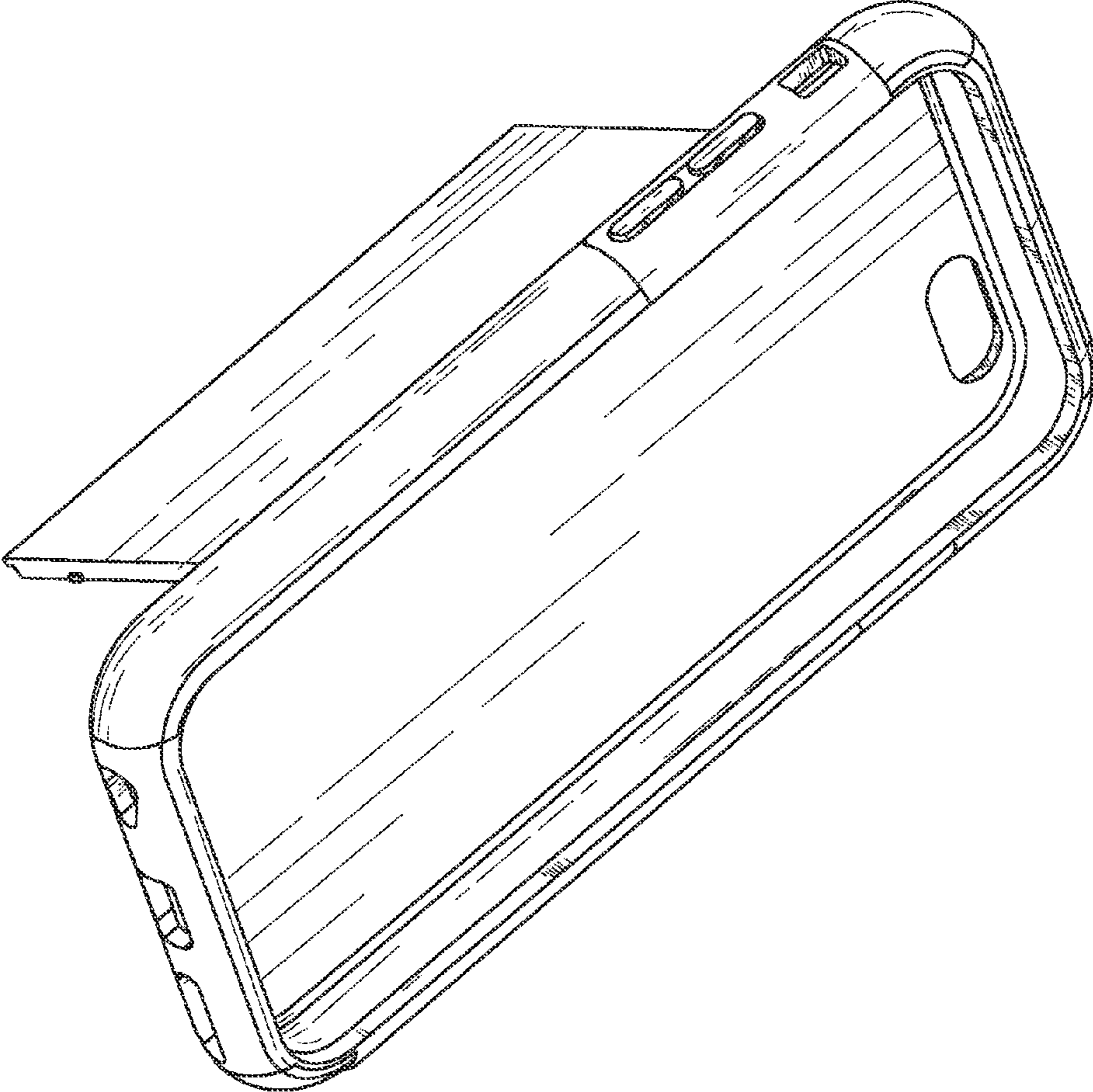

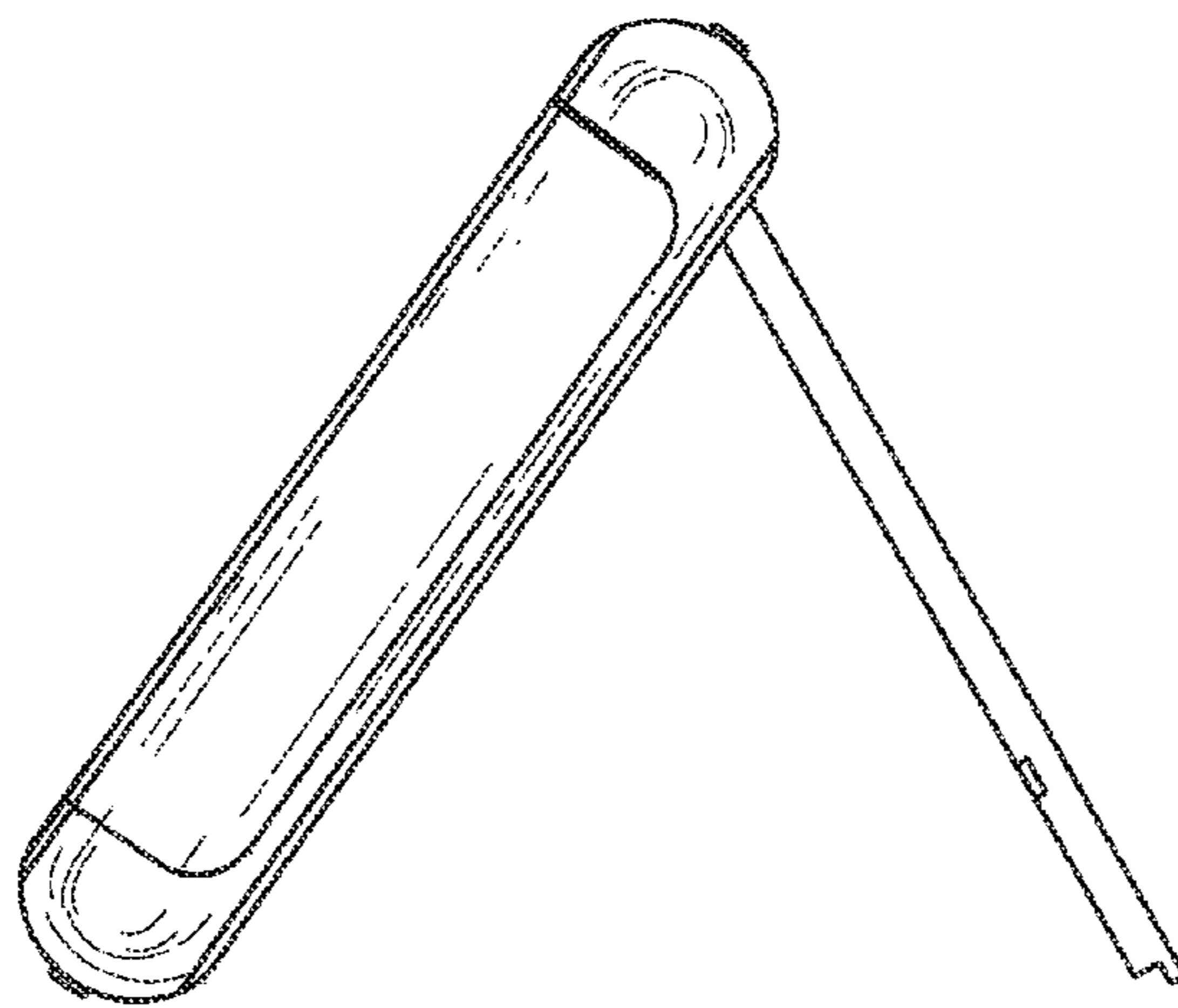

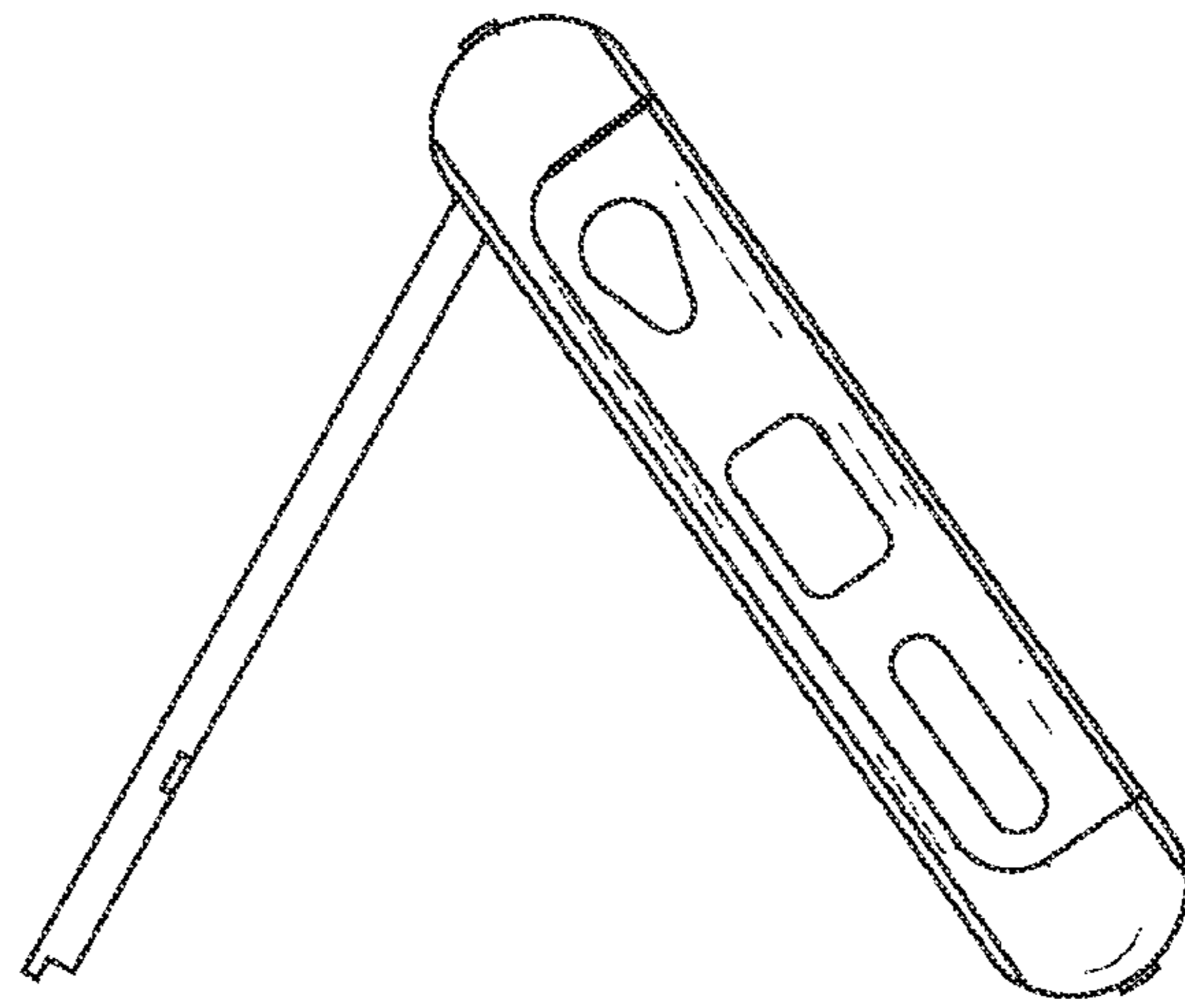
