(57) **CLAIM**

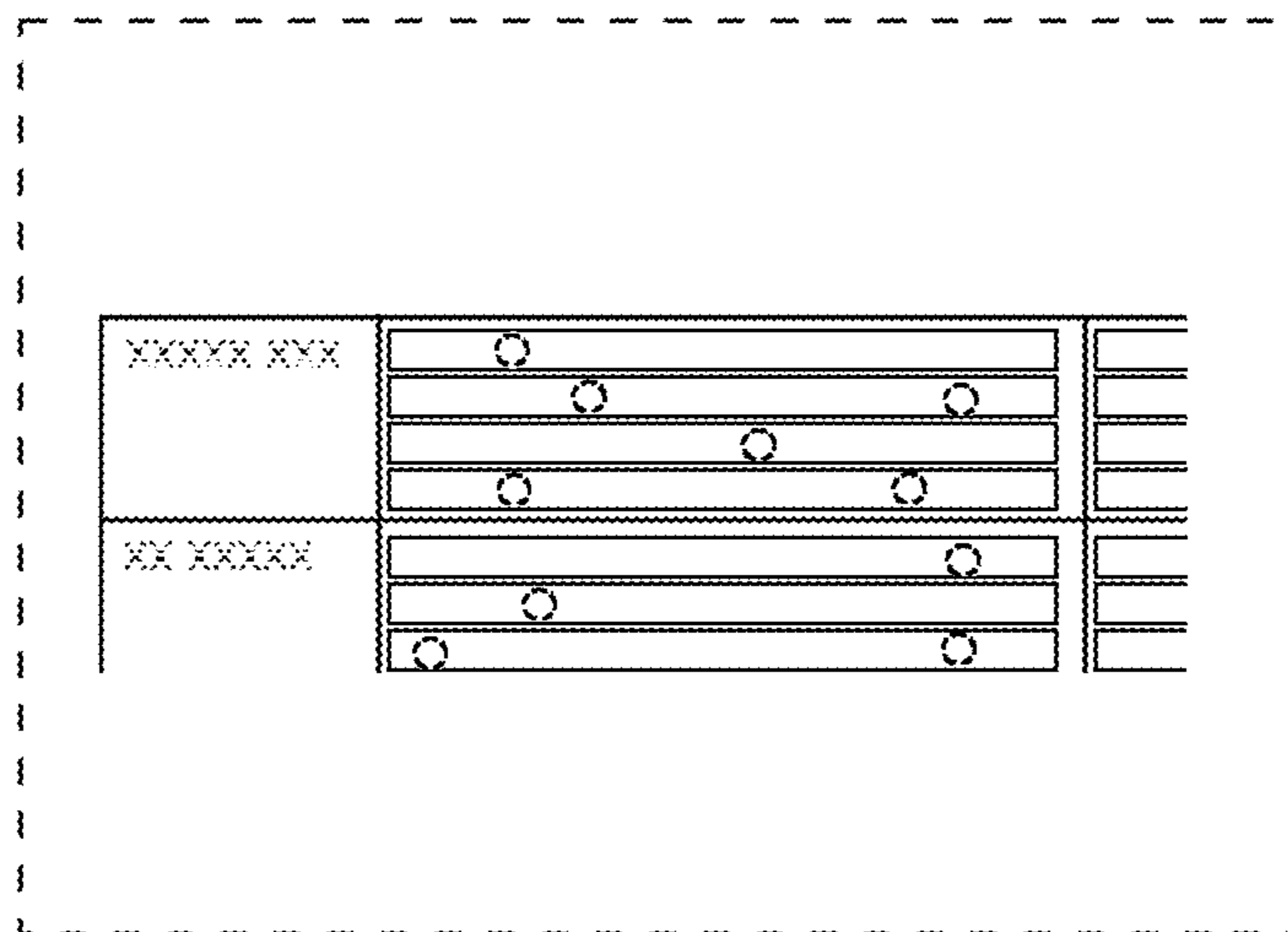
The ornamental design for a portion of display screen with graphical user interface for visualizing data, as shown and described.
