The ornamental design for a display screen with graphical user interface for a furnace monitoring system, as shown and described.

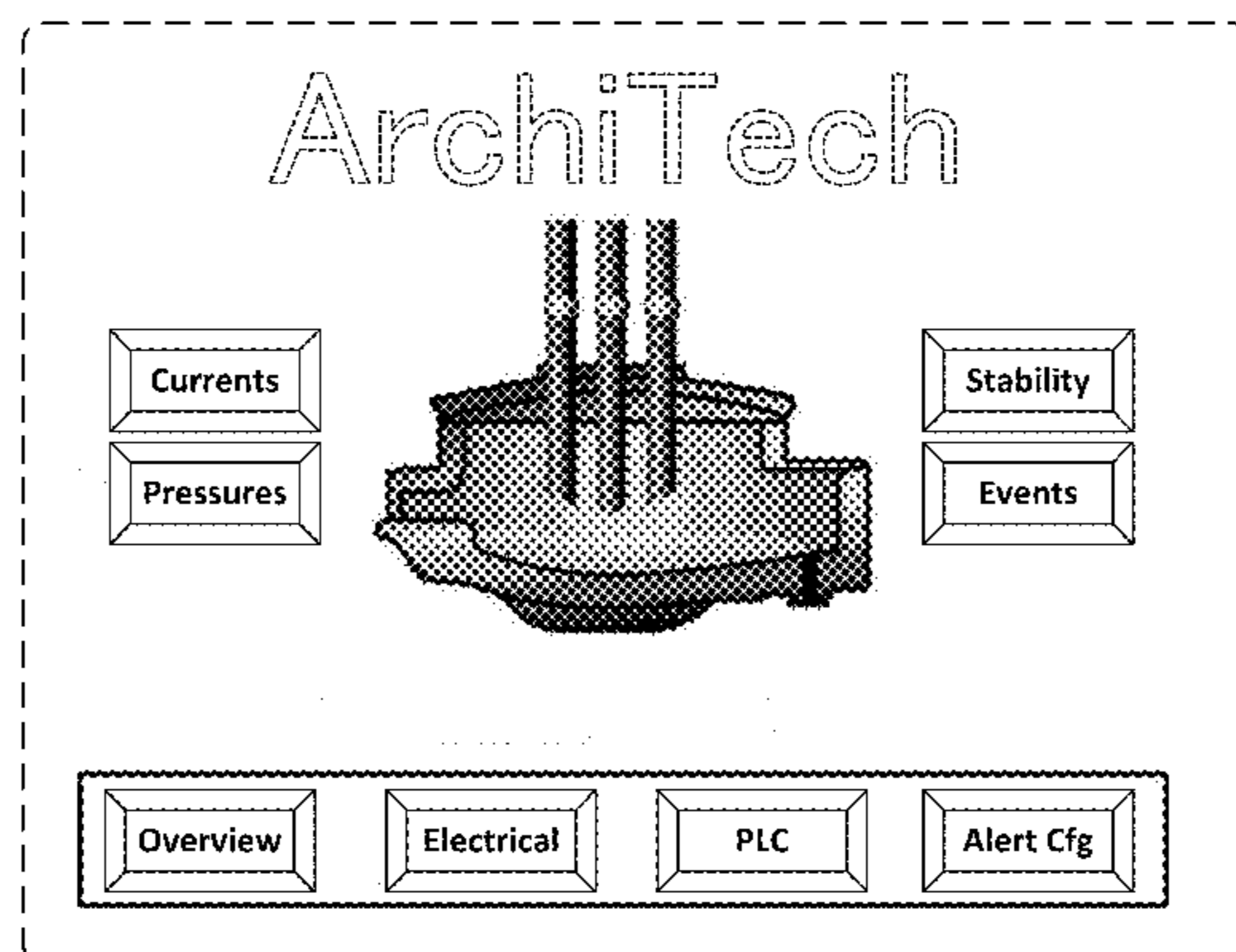
**DESCRIPTION**
