(57) **CLAIM**

The ornamental design for a fishing lure, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a first lateral side of a fishing lure in accordance with the present invention.

FIG. 2 is a top perspective view of a second lateral side of the fishing lure of FIG. 1.

FIG. 3 is a bottom perspective view of the second lateral side of the fishing lure of FIG. 1.

FIG. 4 is a bottom perspective view of the first lateral side of the fishing lure of FIG. 1.

FIG. 5 is a top plan view of the fishing lure of FIG. 1.

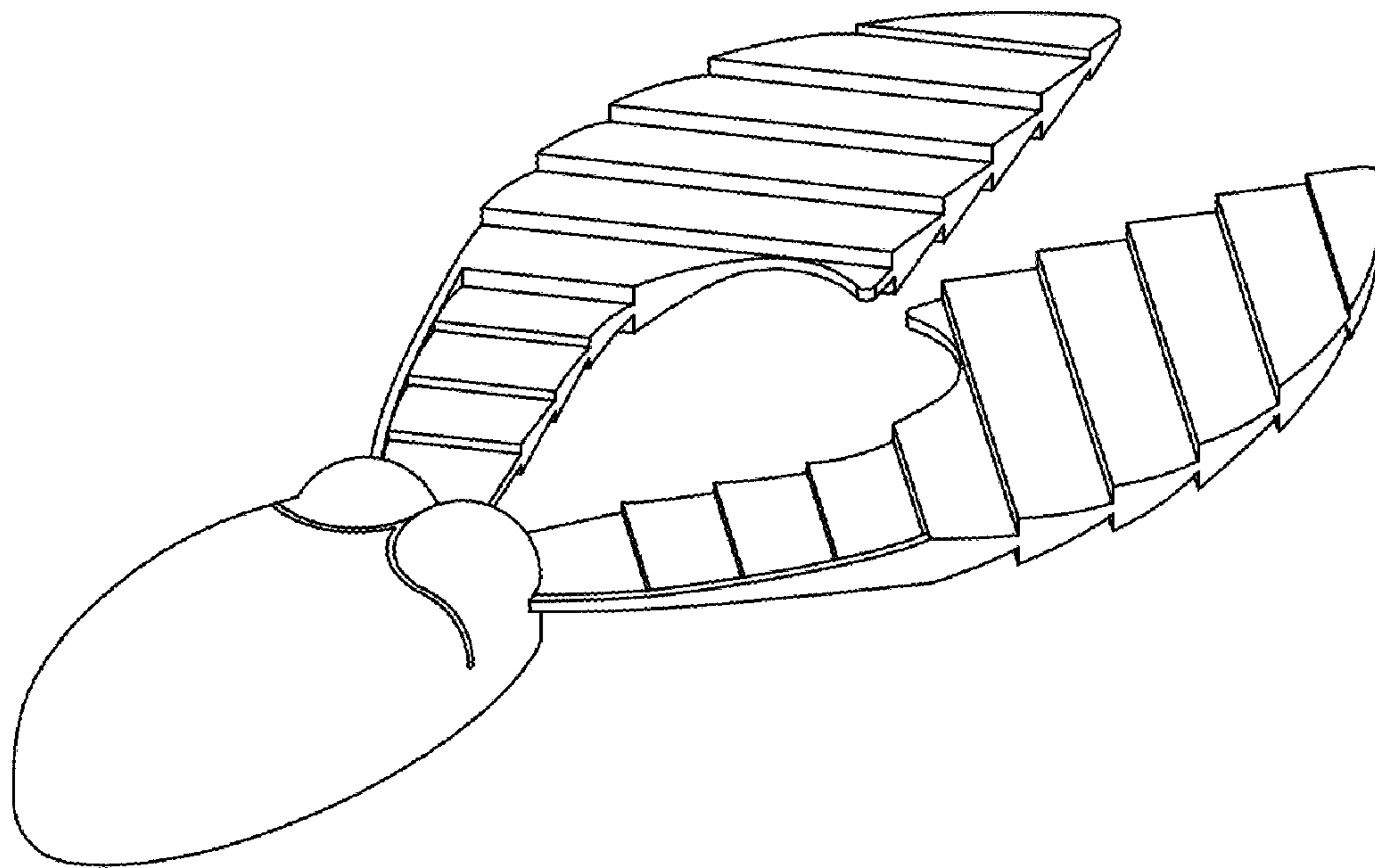
FIG. 6 is a bottom plan view of the fishing lure of FIG. 1.

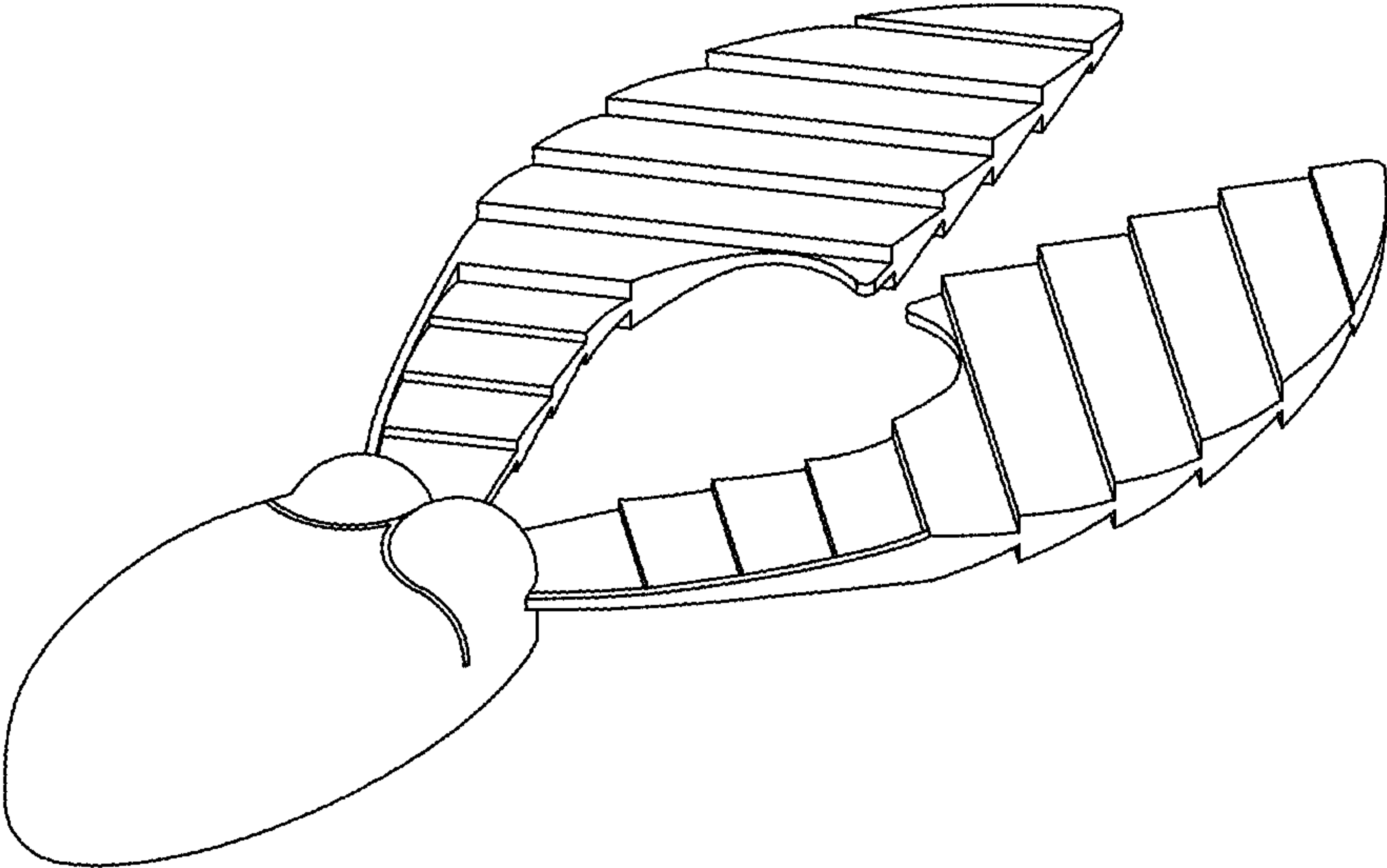

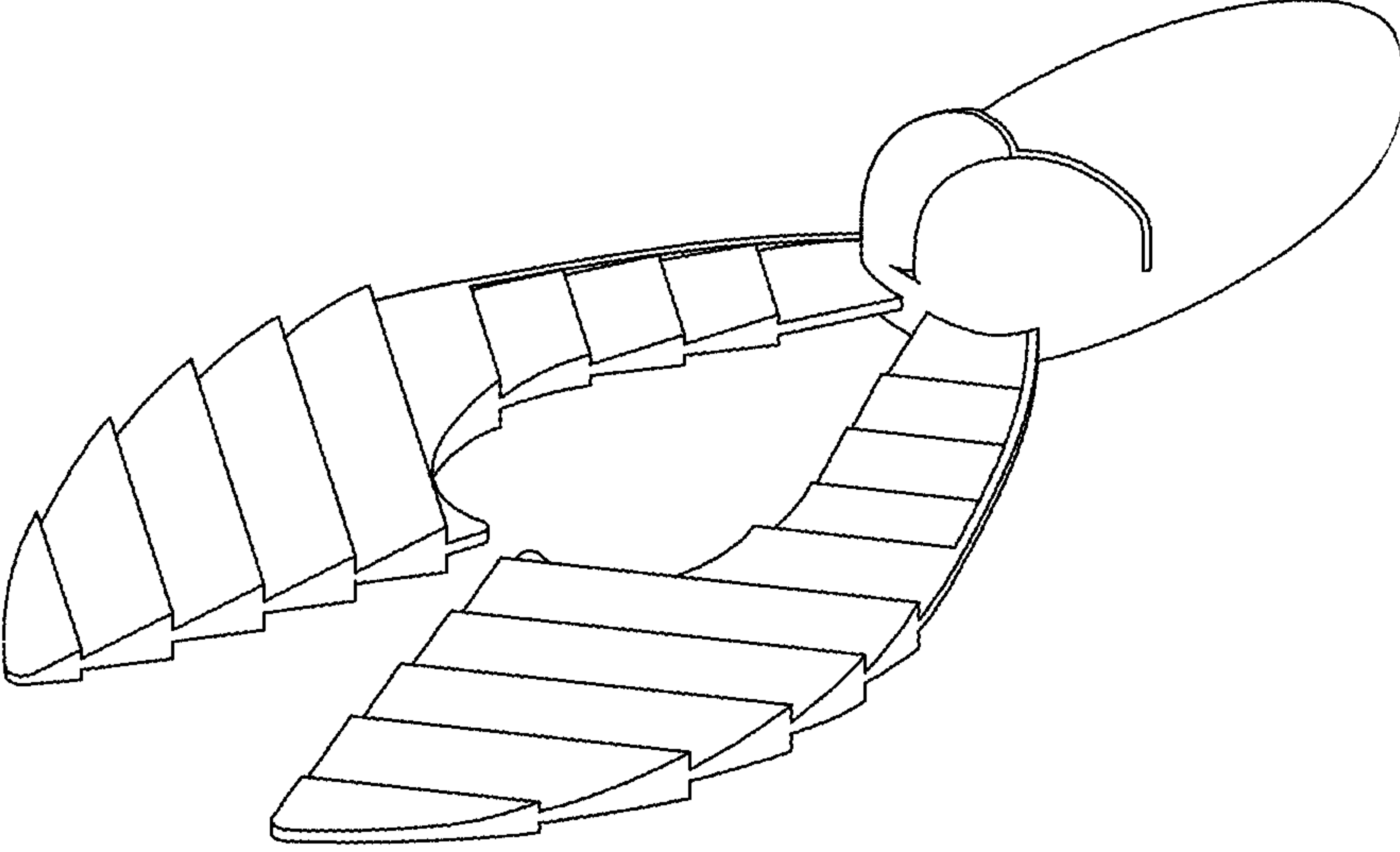

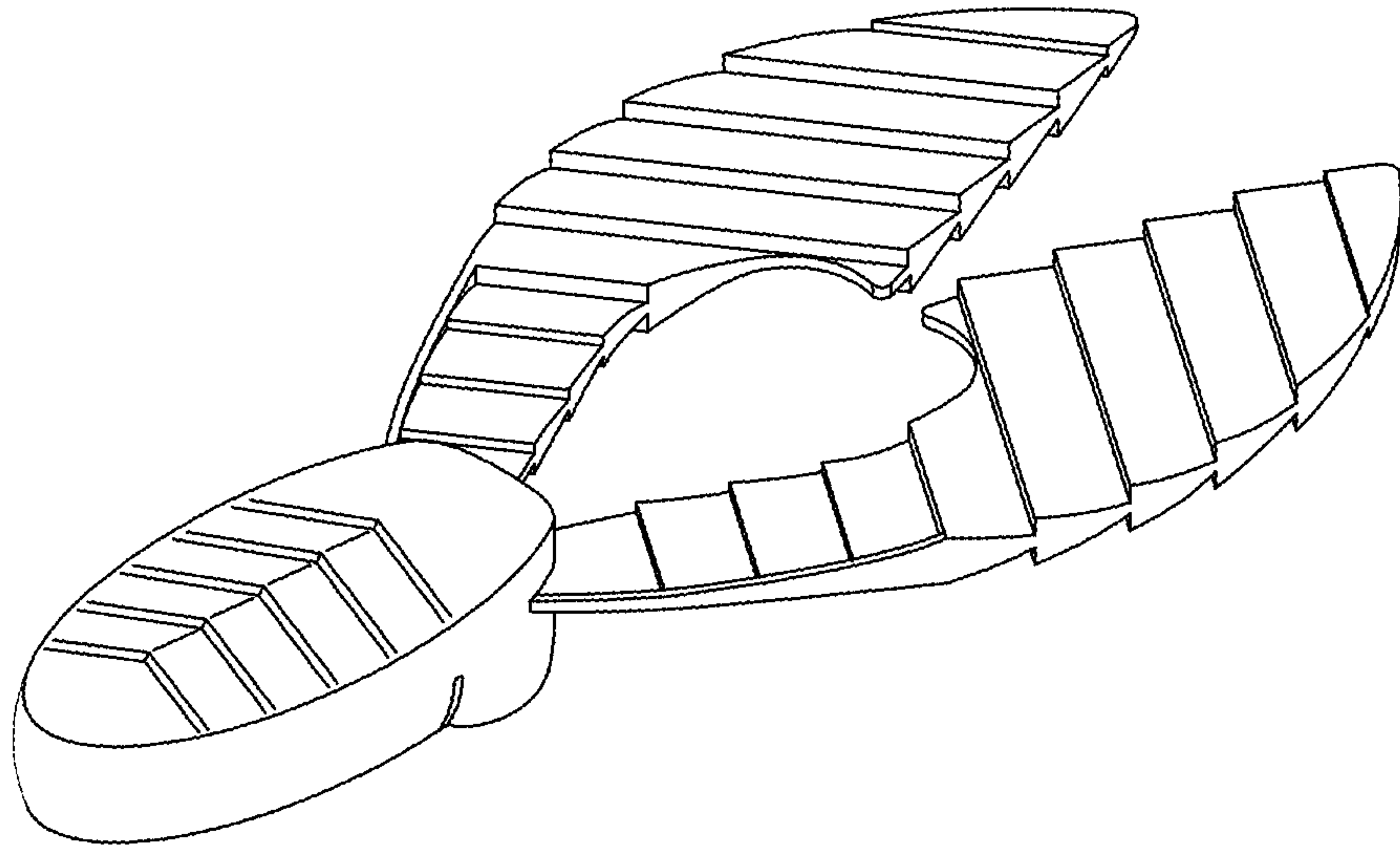

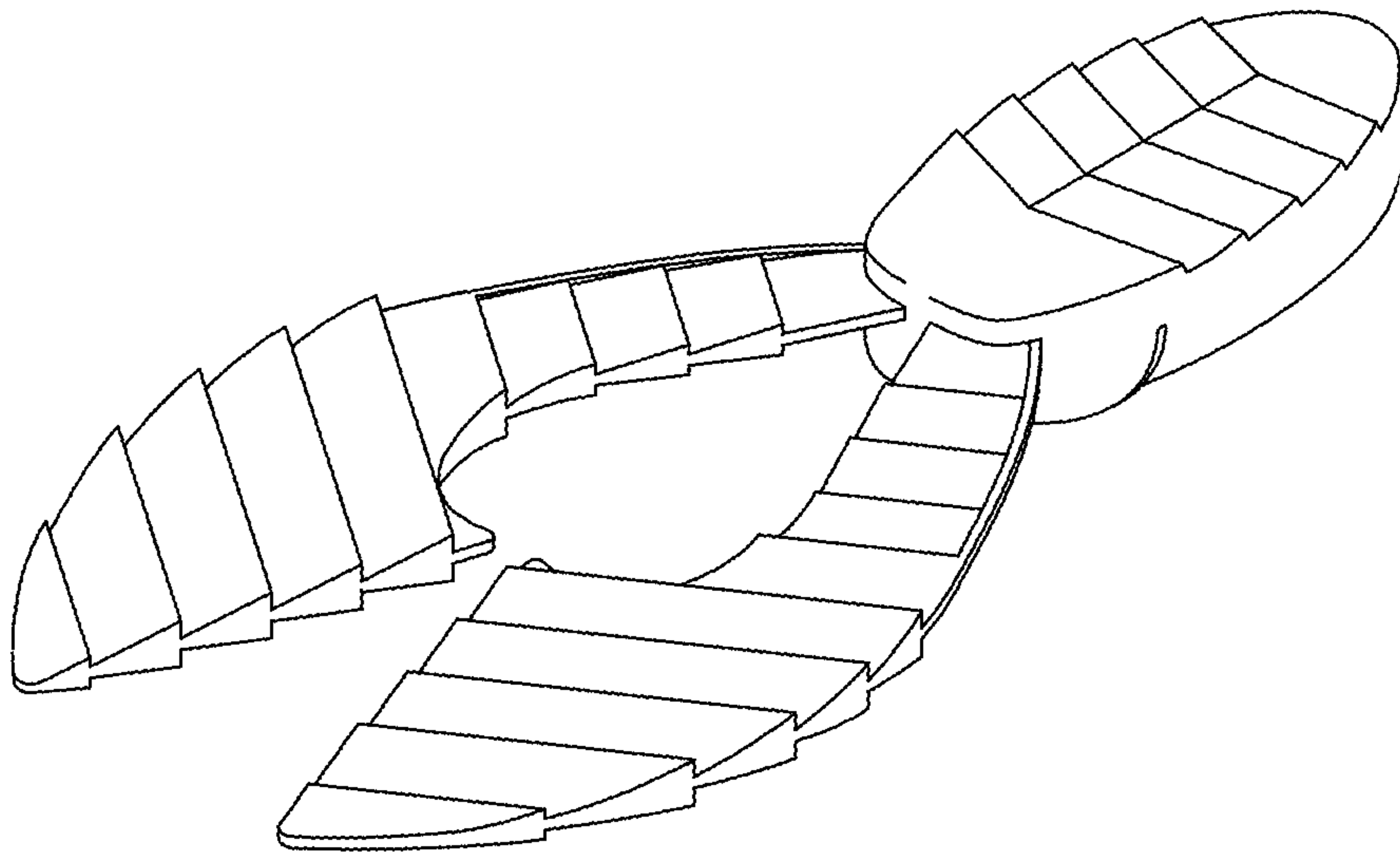

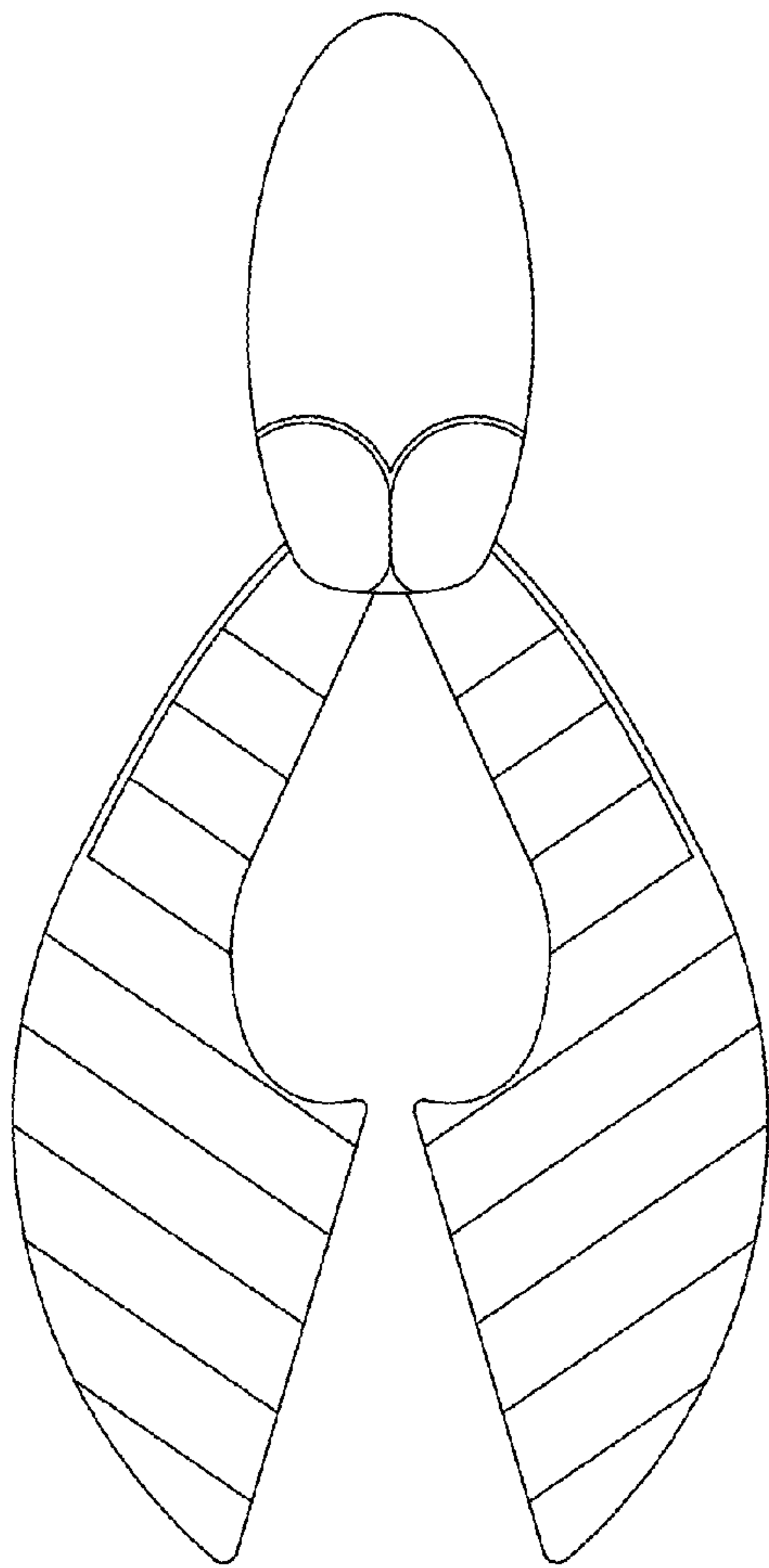

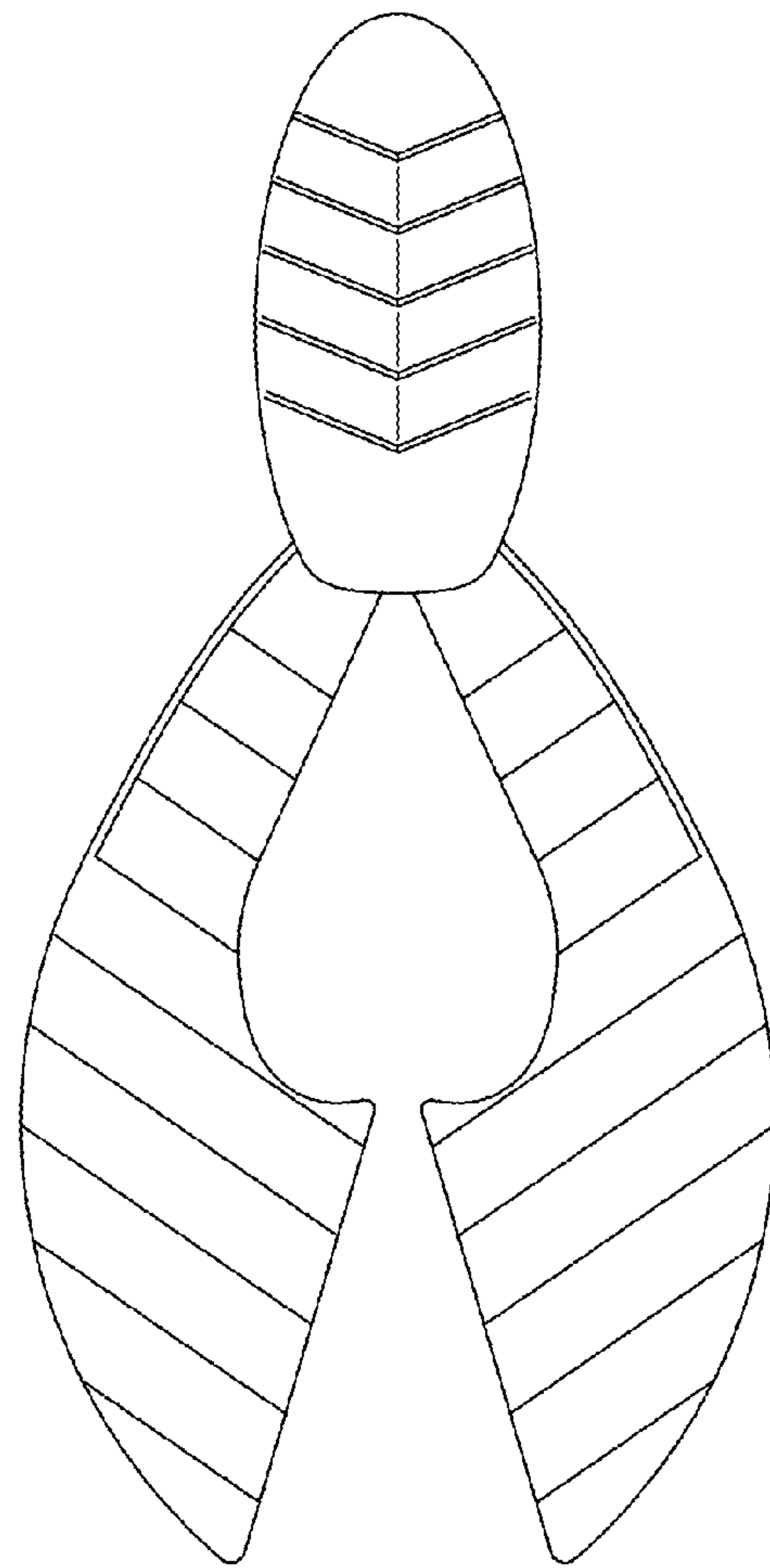

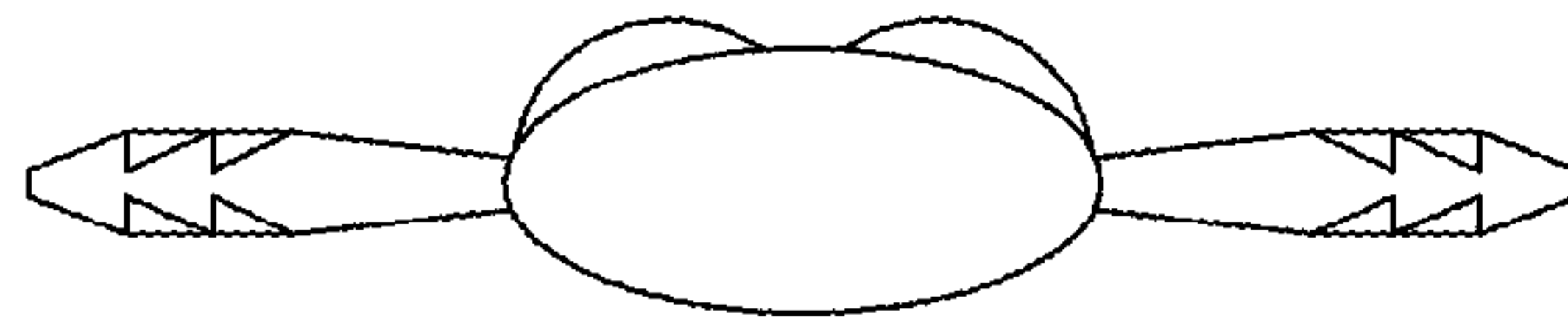

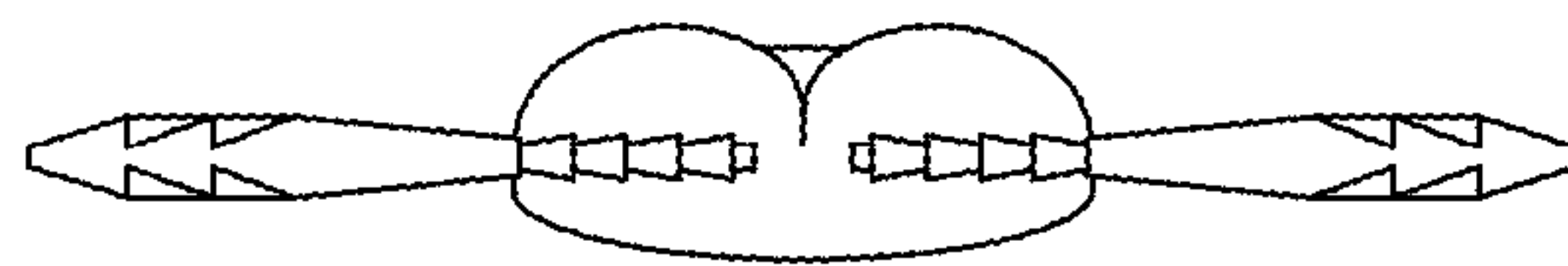

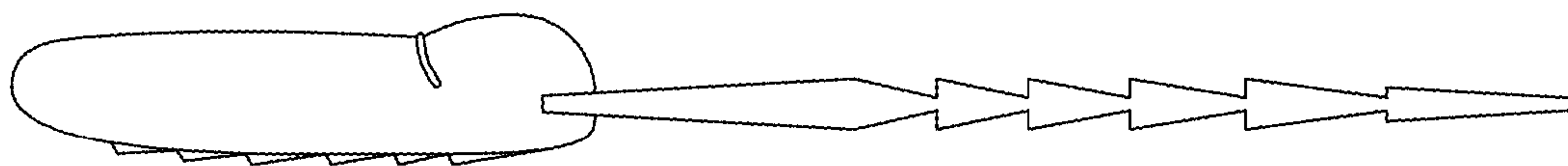
