(57) **CLAIM**
The ornamental design for an atomizer for inhaler, as shown and described.

DESCRIPTION

FIG. 1 is a rear, top, and left side perspective view of an atomizer for inhaler showing our new design;
FIG. 2 is a rear, bottom, and left side perspective view thereof;
FIG. 3 is a rear, top, and right side perspective view thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a rear view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof;
FIG. 8 is a right side view thereof; and,
FIG. 9 is a left side view thereof.
The atomizer for inhaler is fabricated from translucent materials. The dark background in FIGS. 1-9 is used for contrast only and does not constitute any portion of the claimed design.

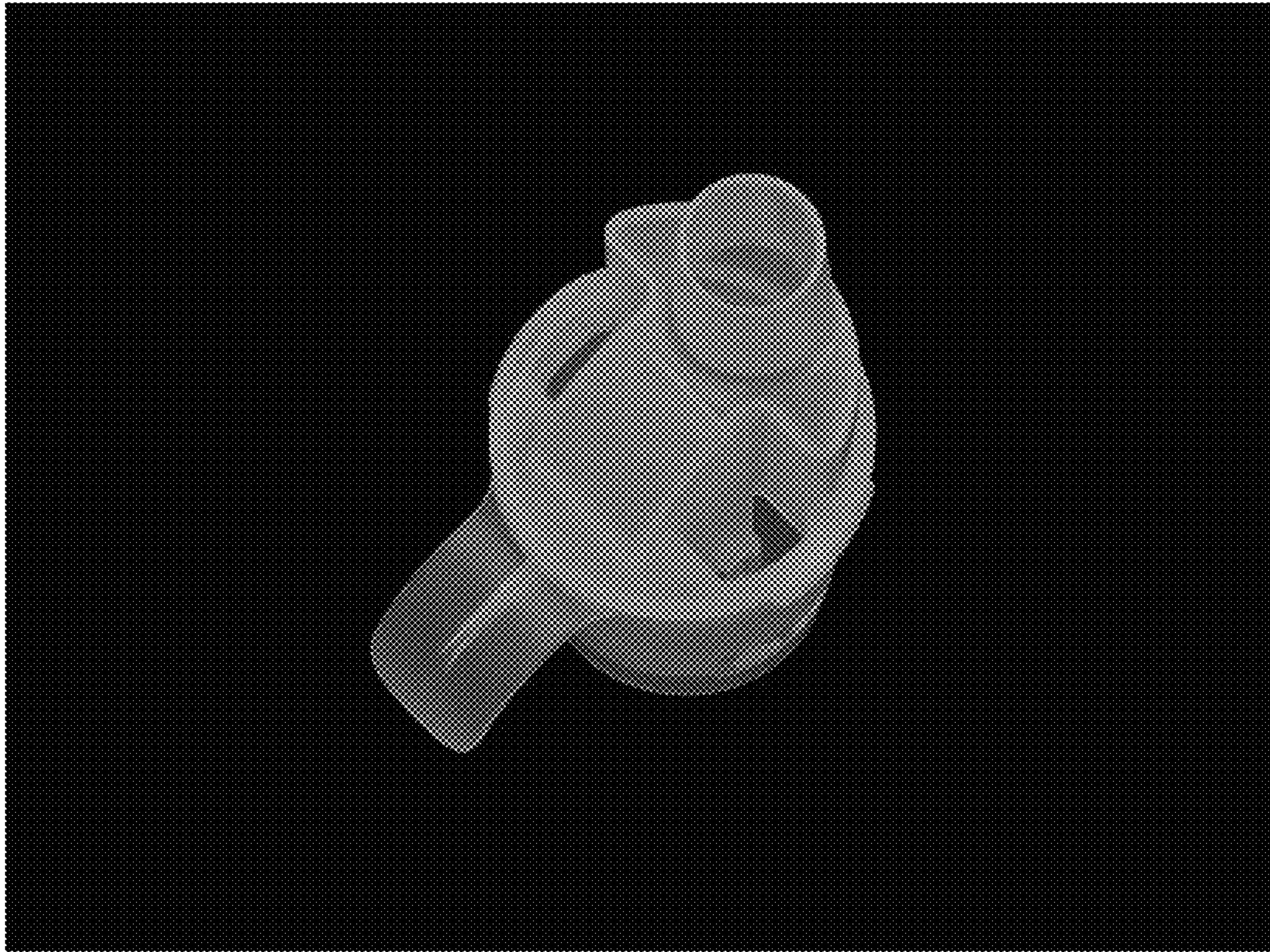

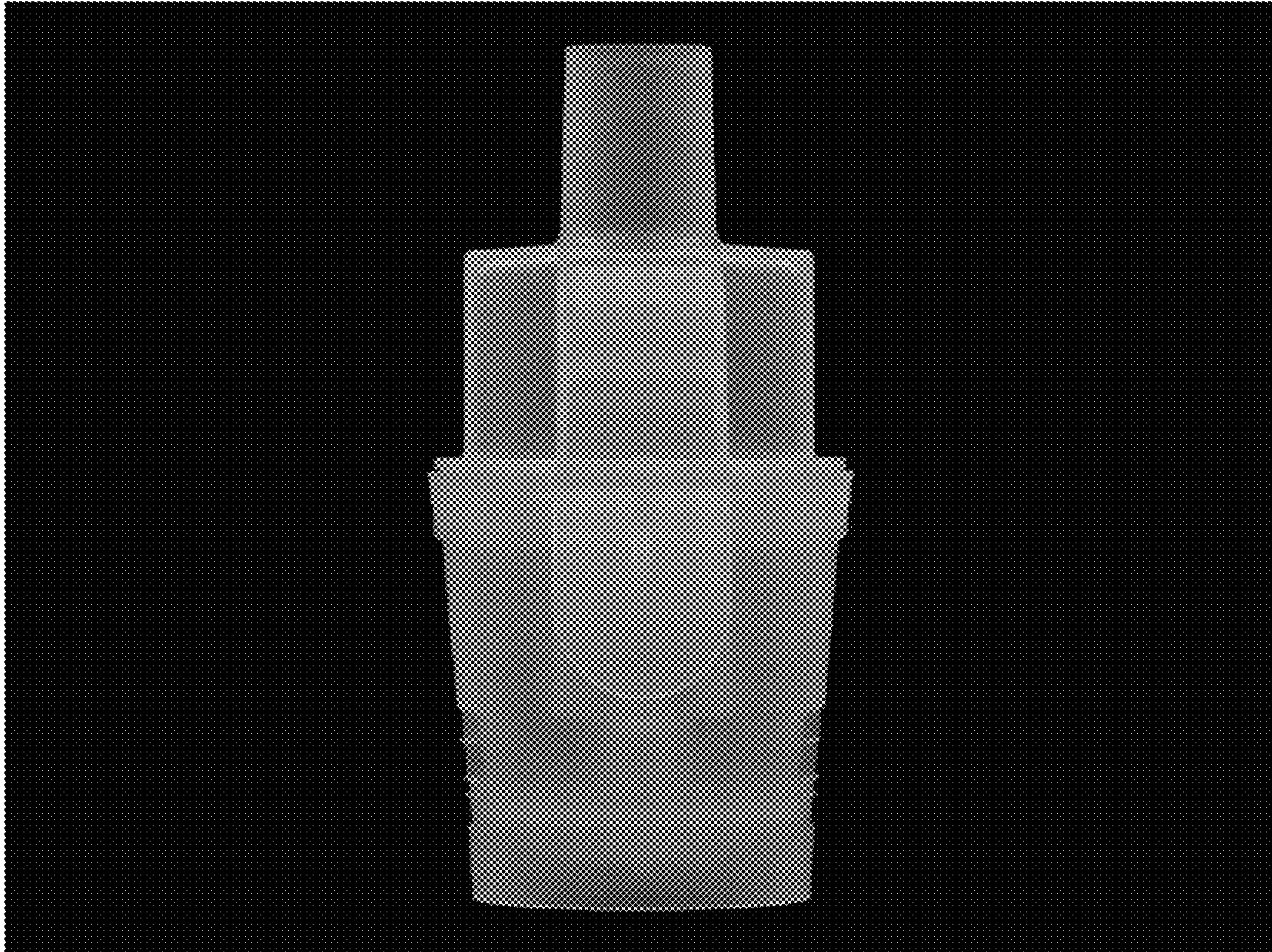

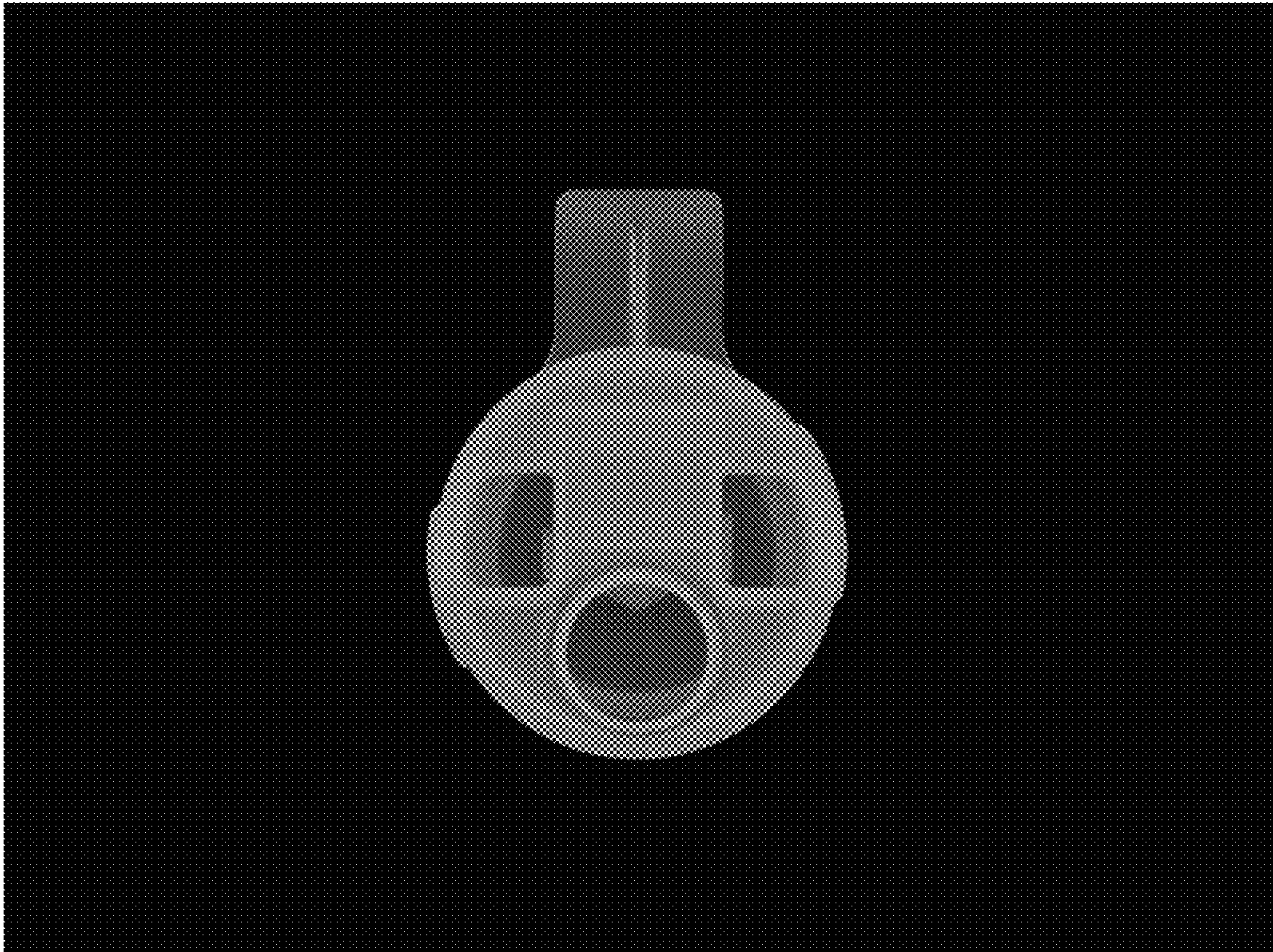

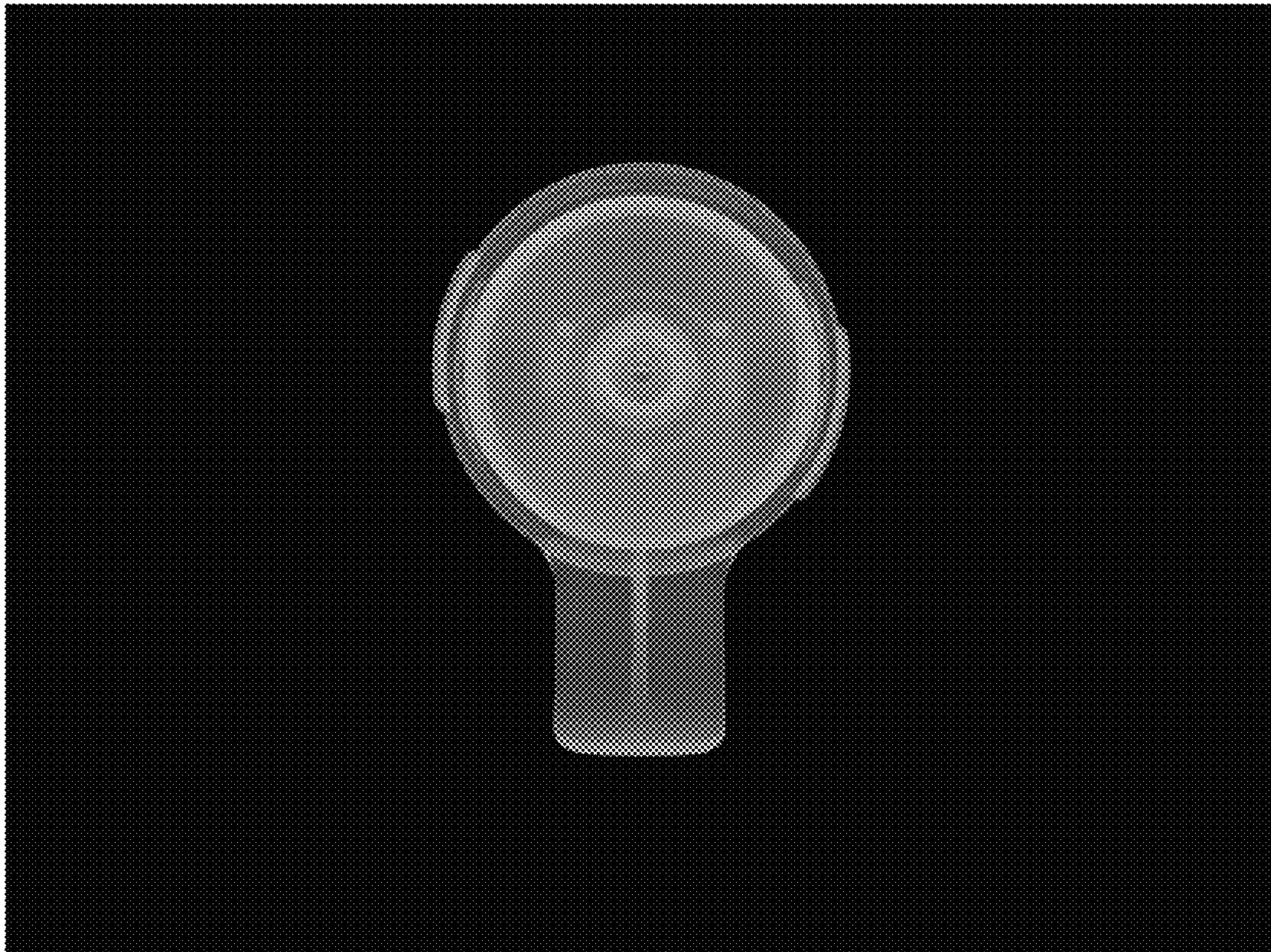

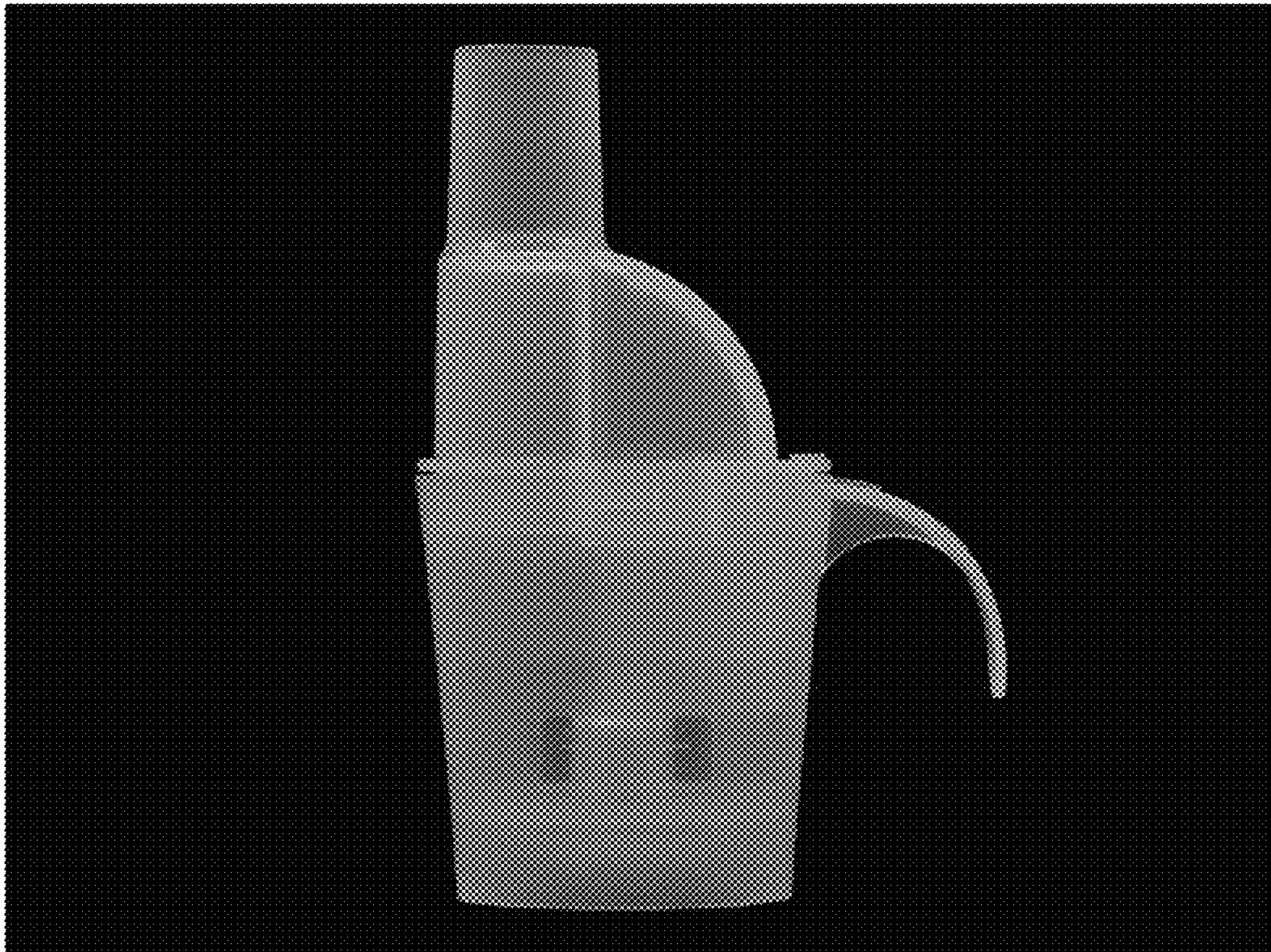
