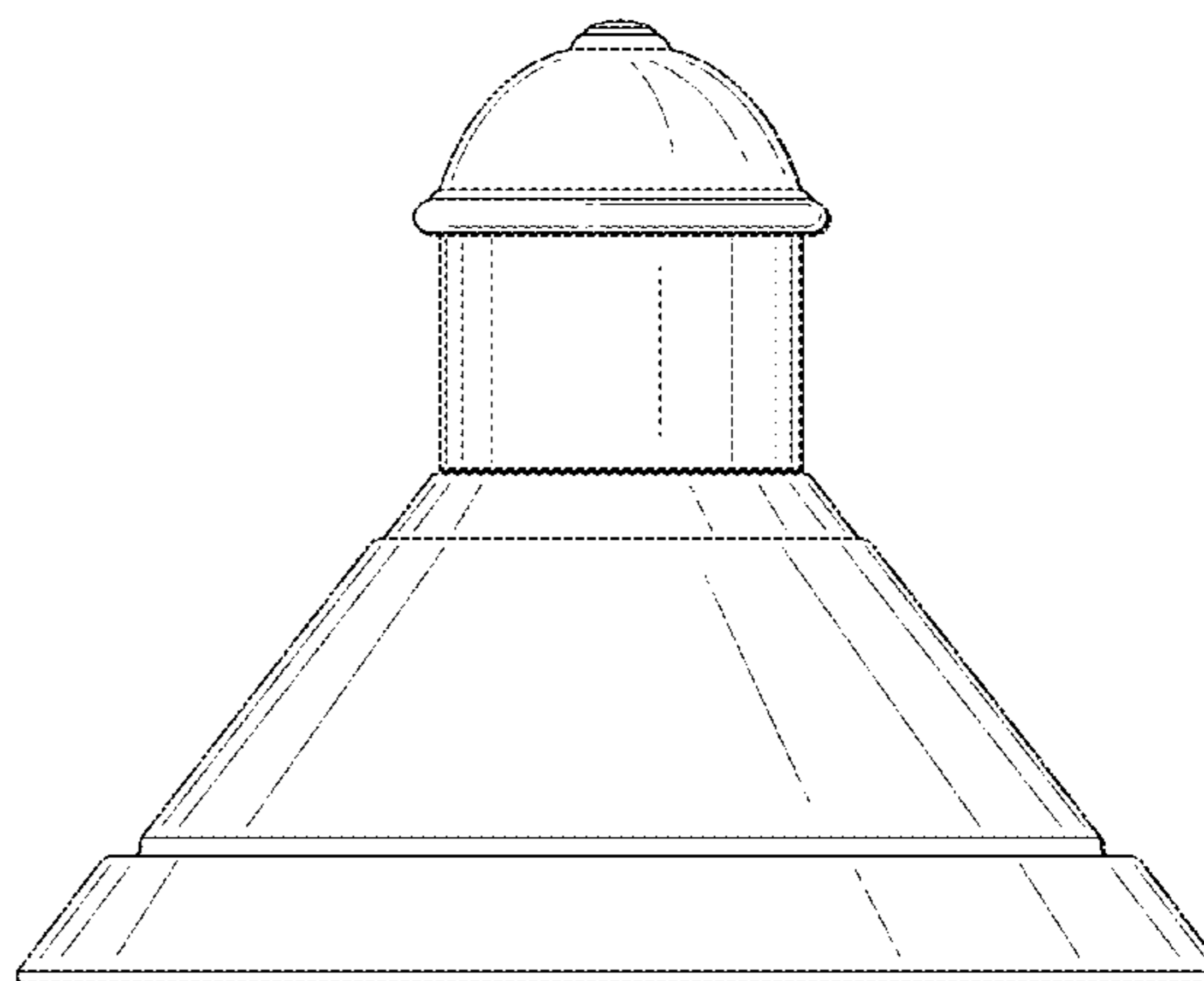
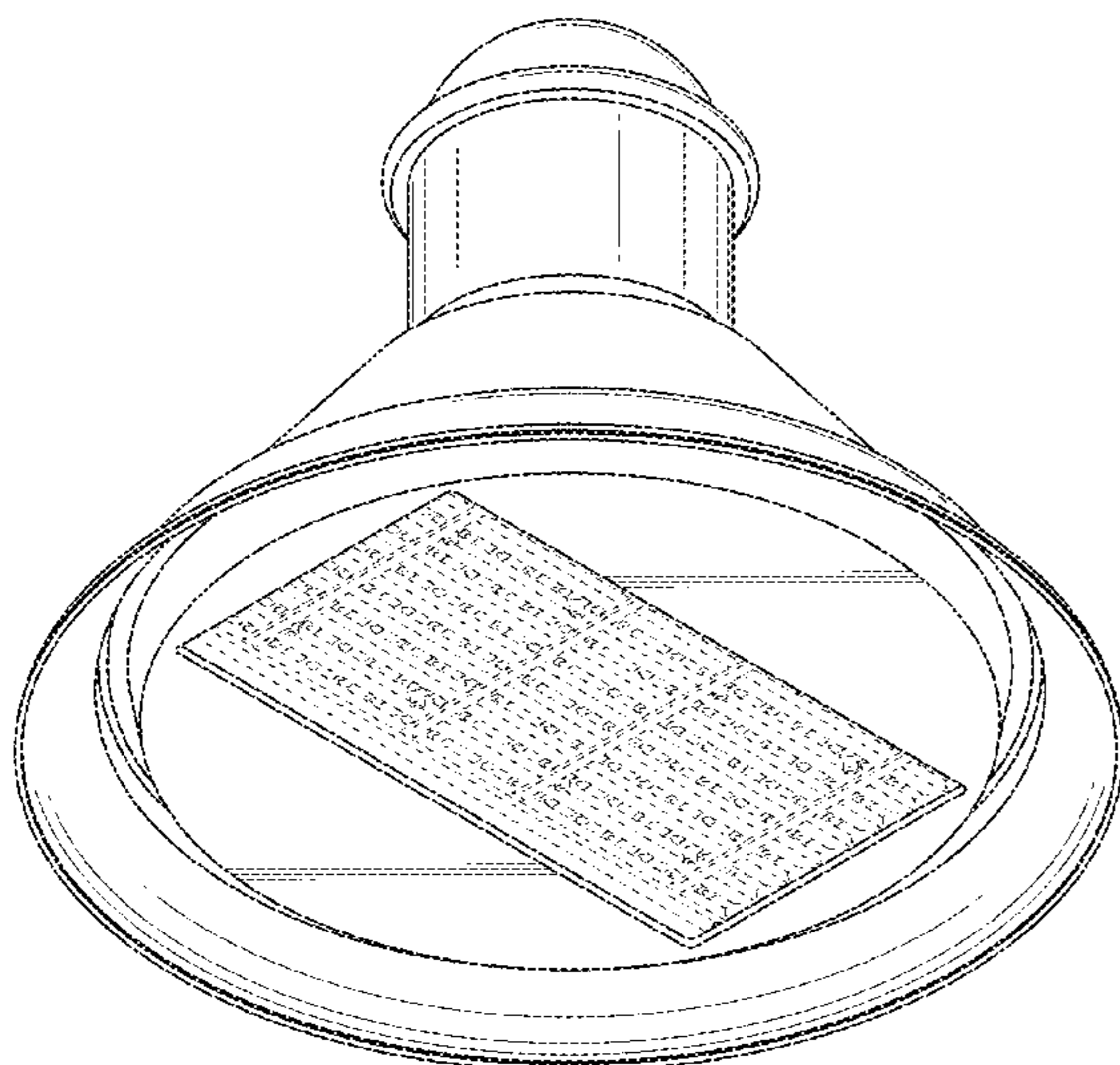
The ornamental design for a lighting fixture, as shown and described.

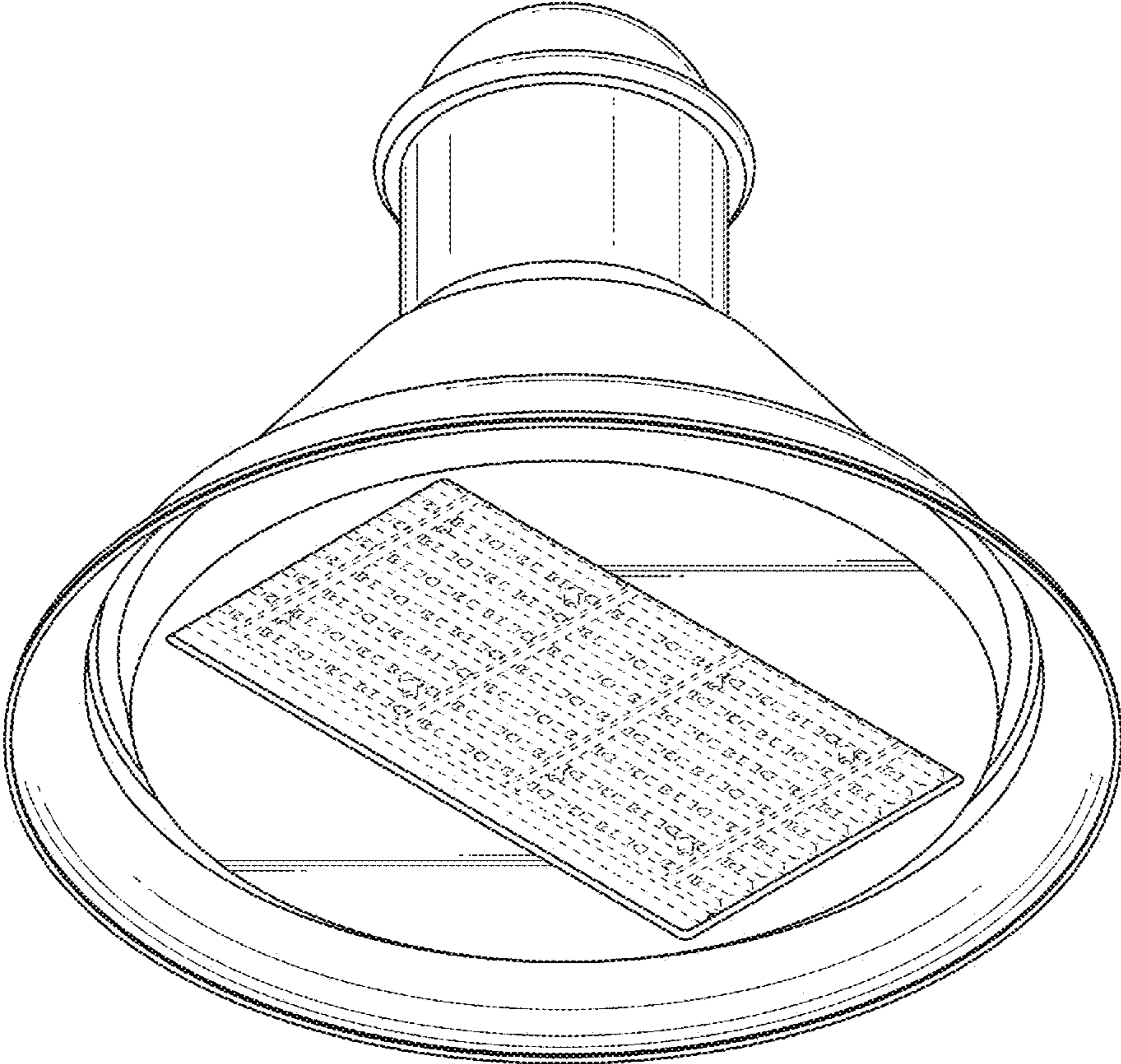

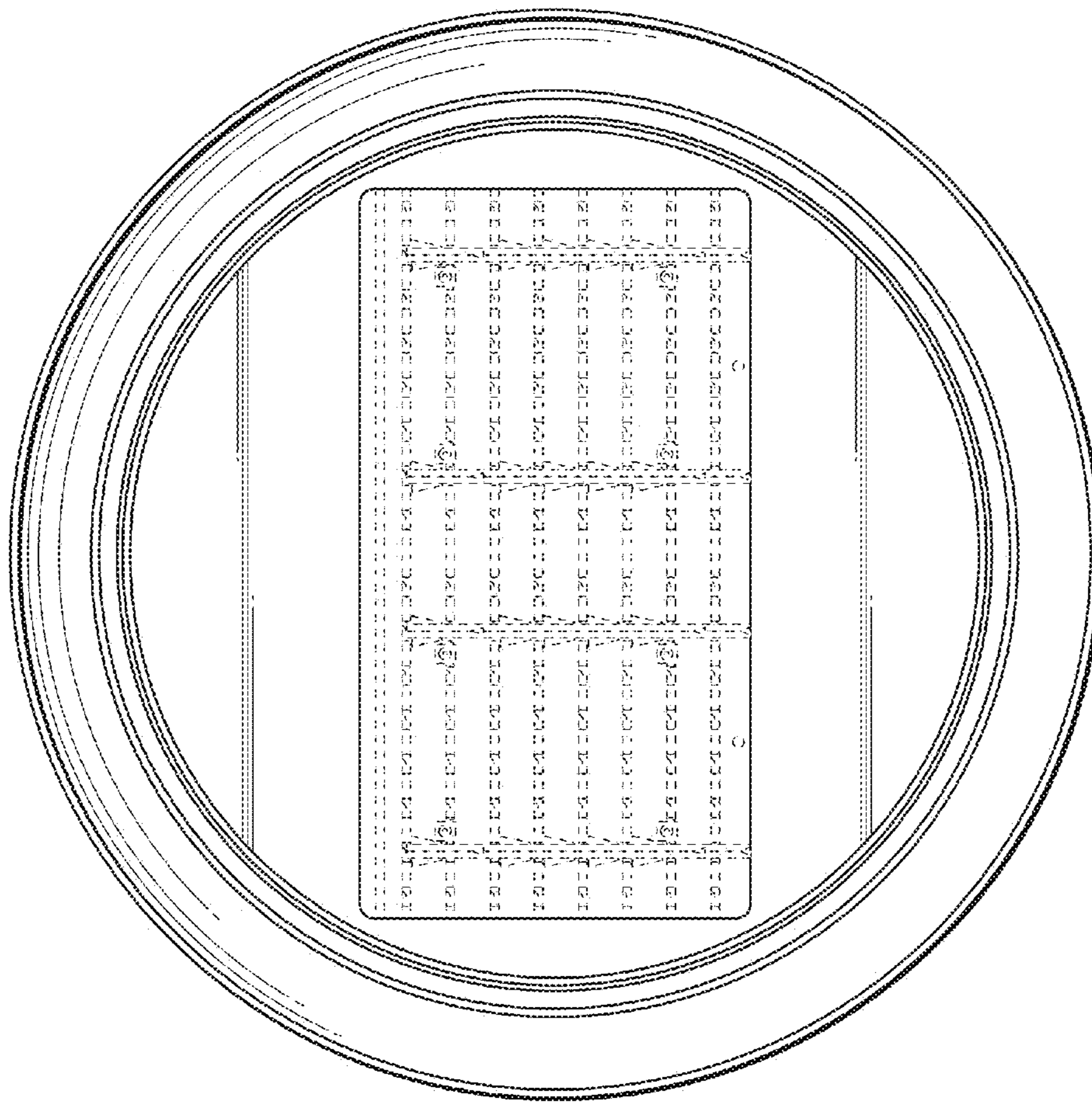

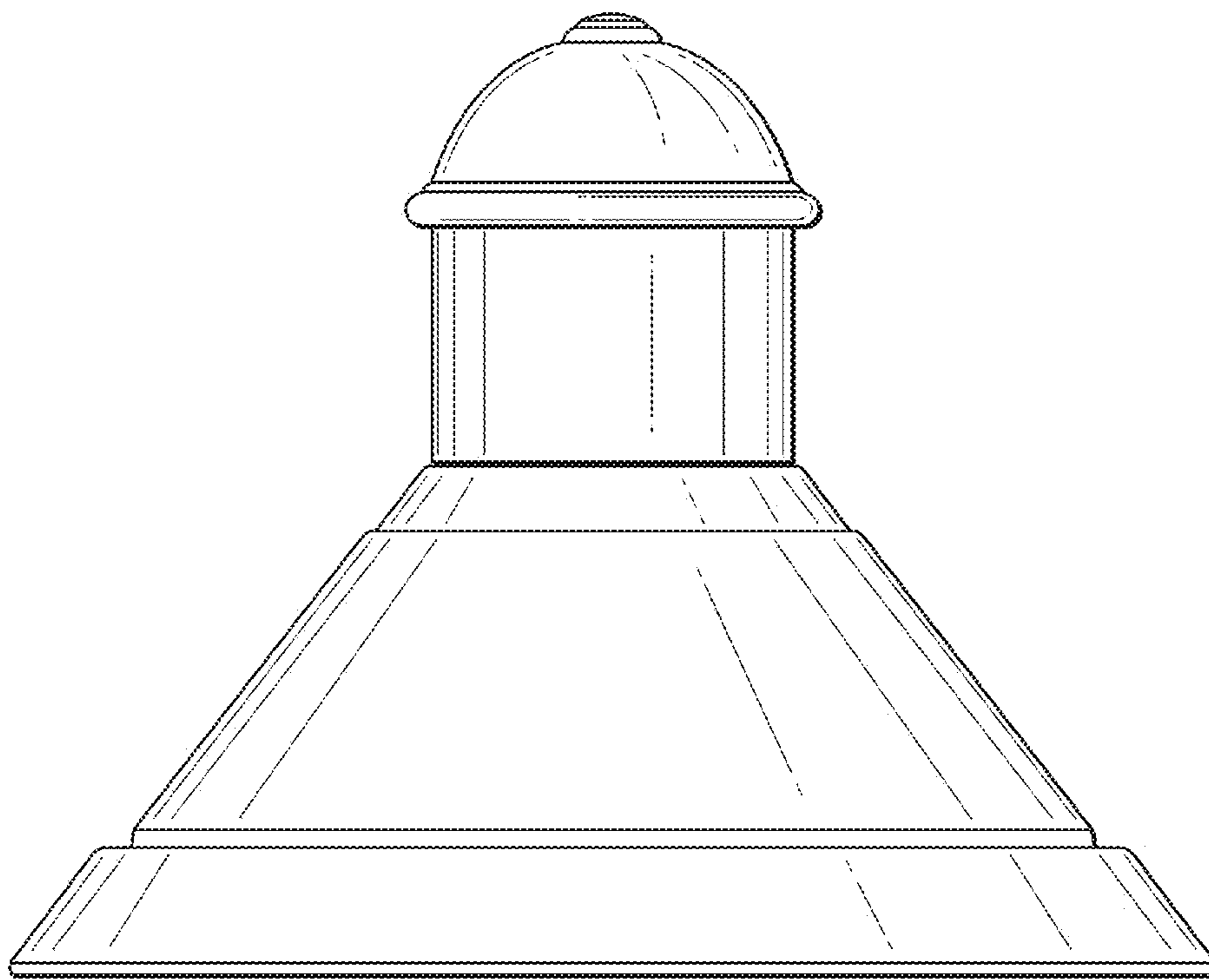

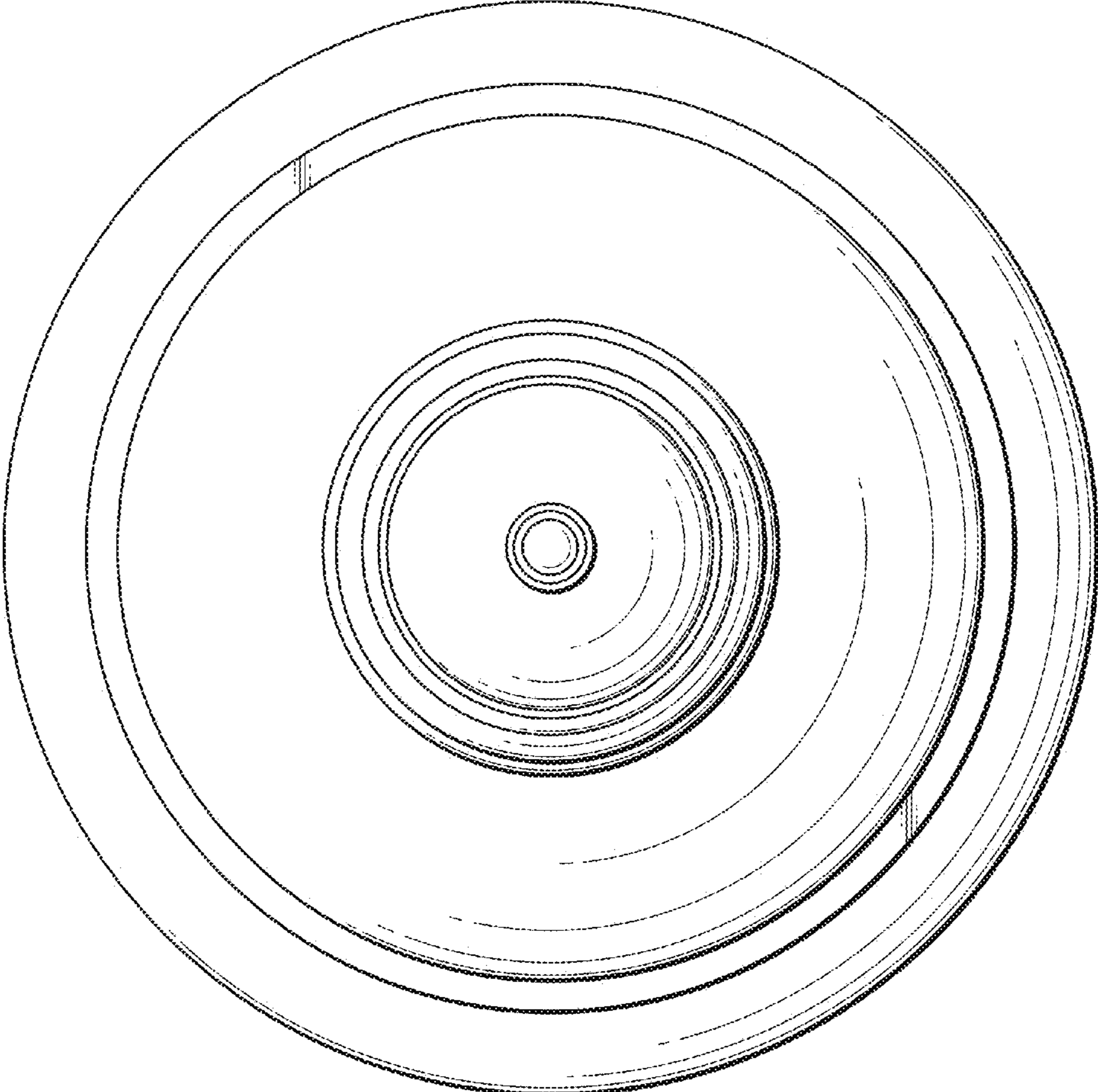
