DESCRIPTION

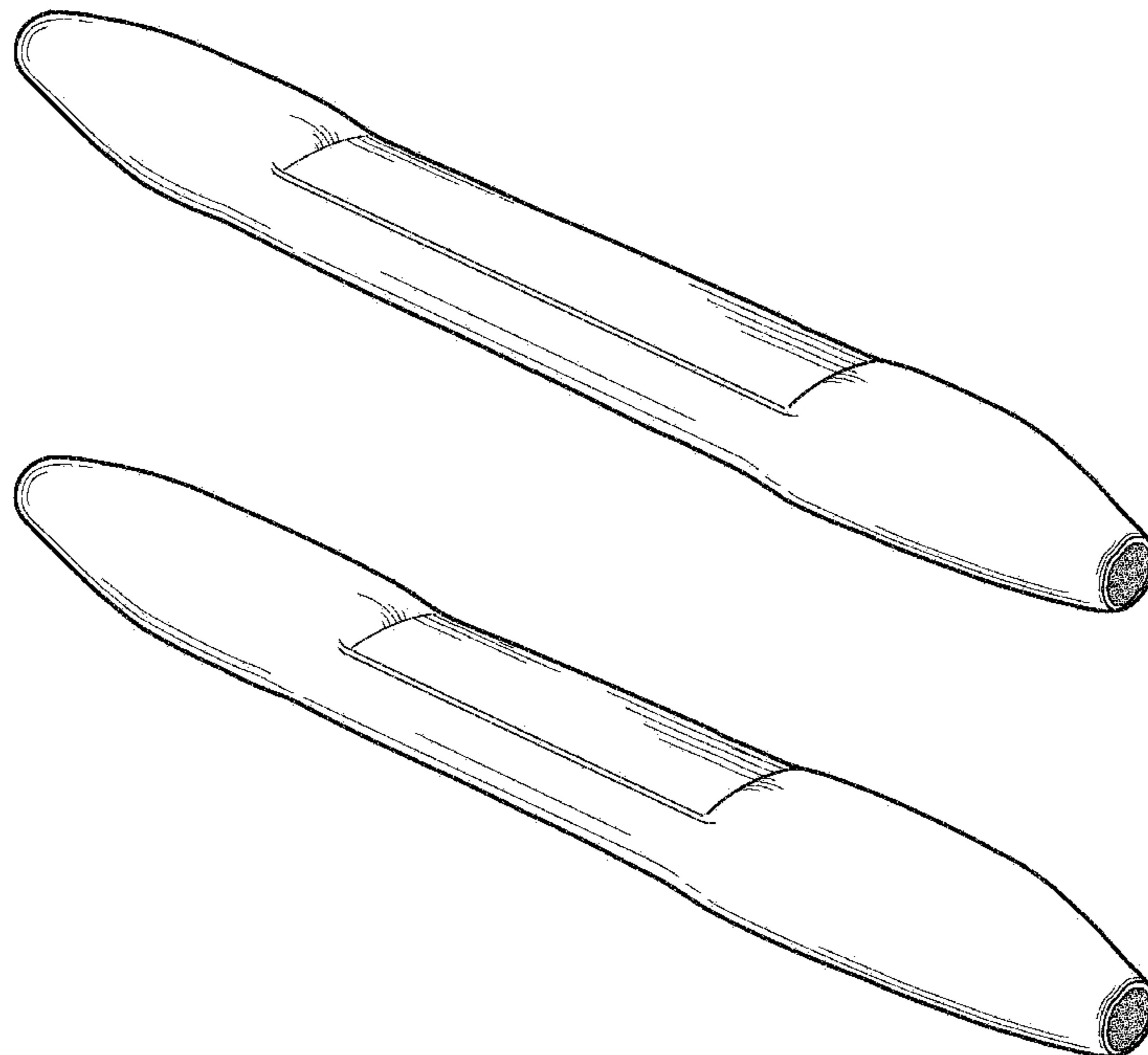
FIG. 1 is a top left perspective view of the first embodiment of a pressed cigar, showing my new design;

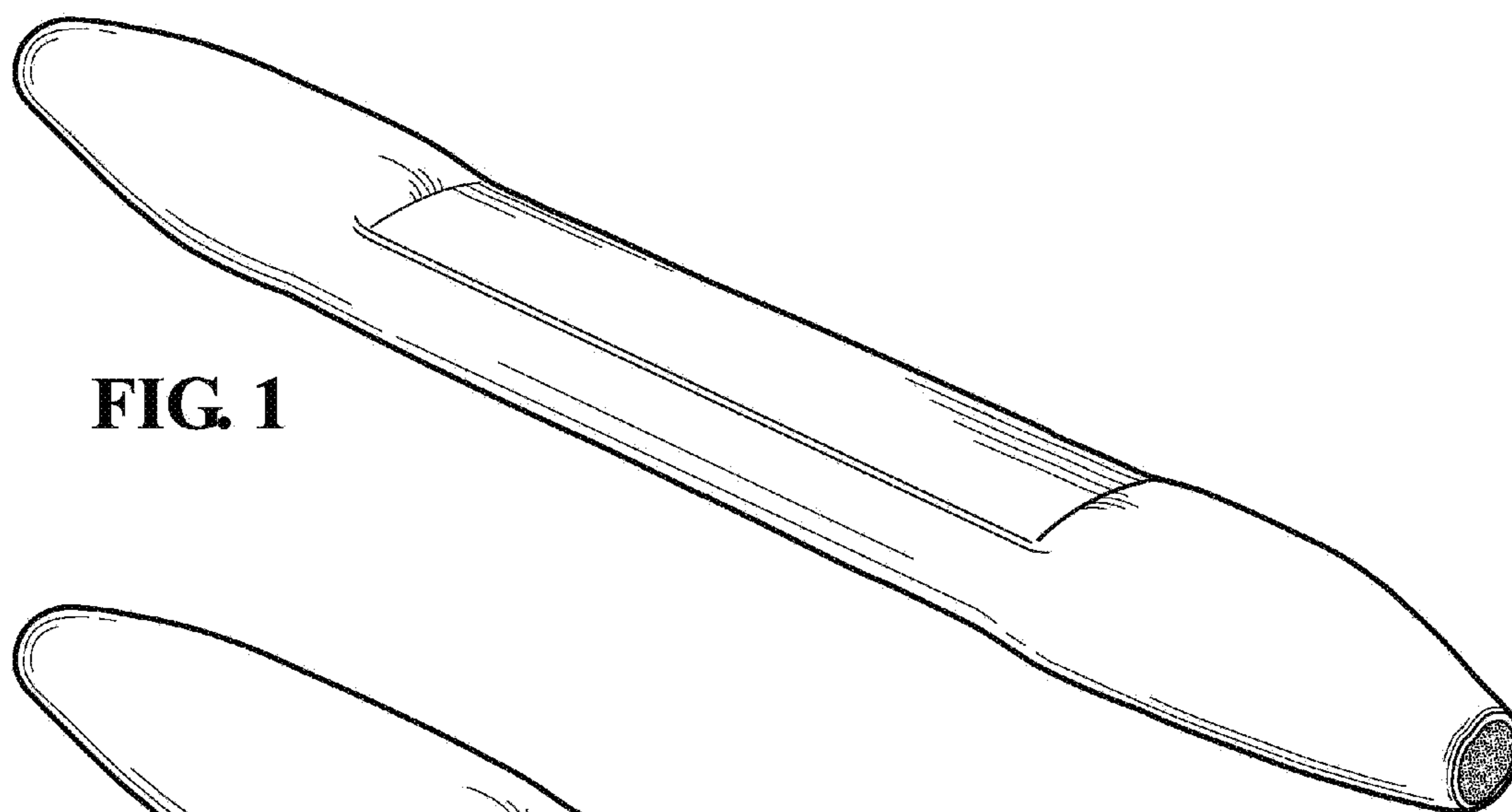

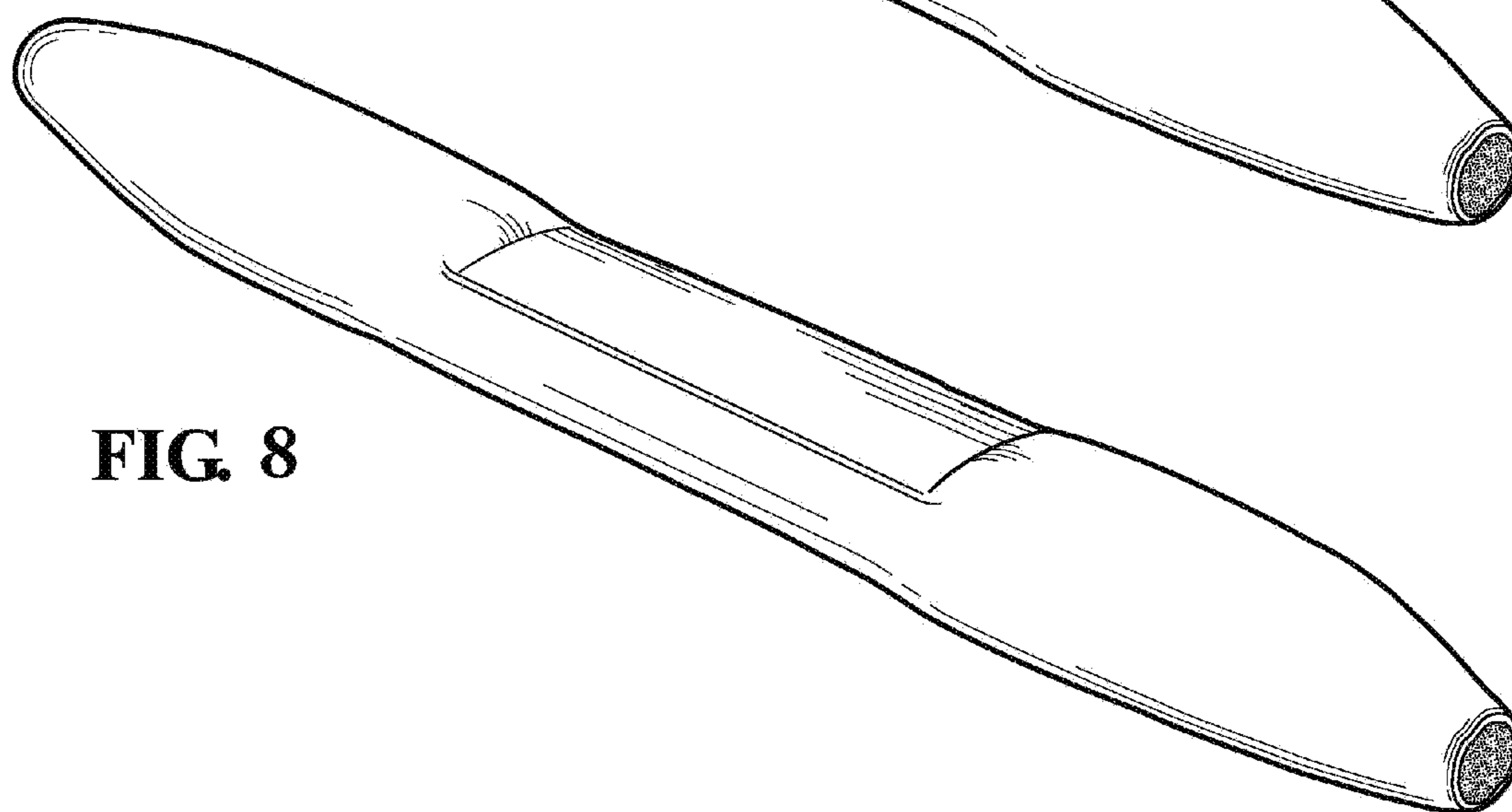

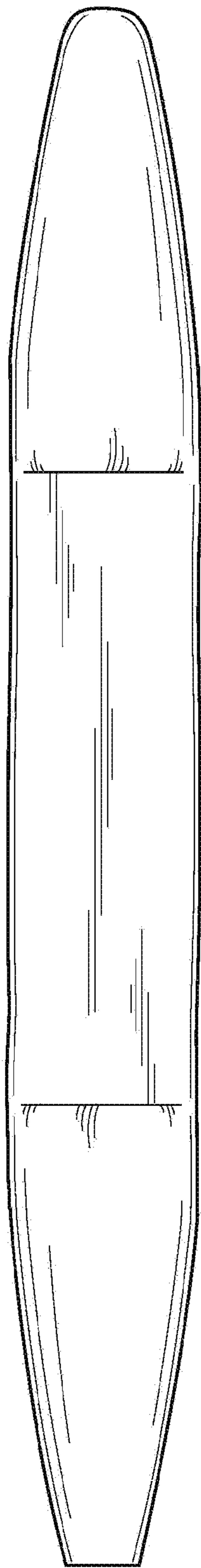

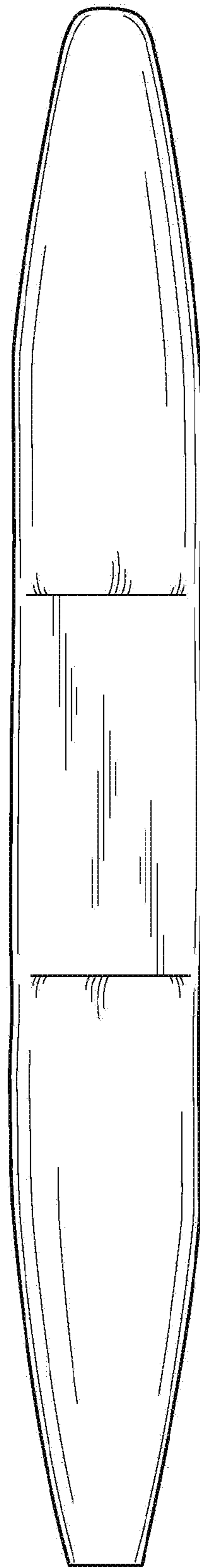

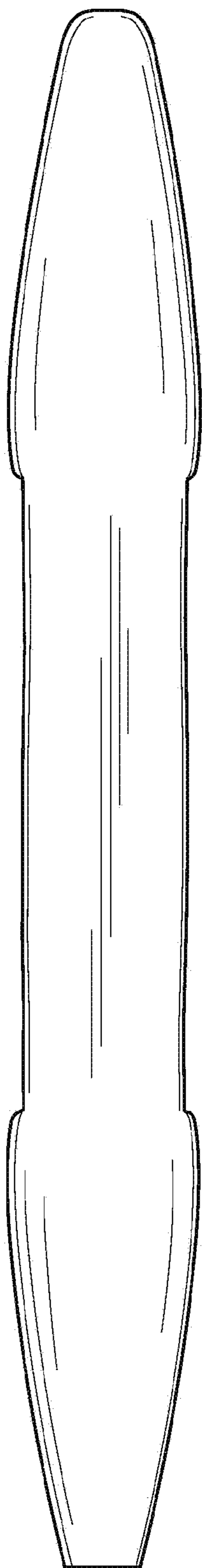

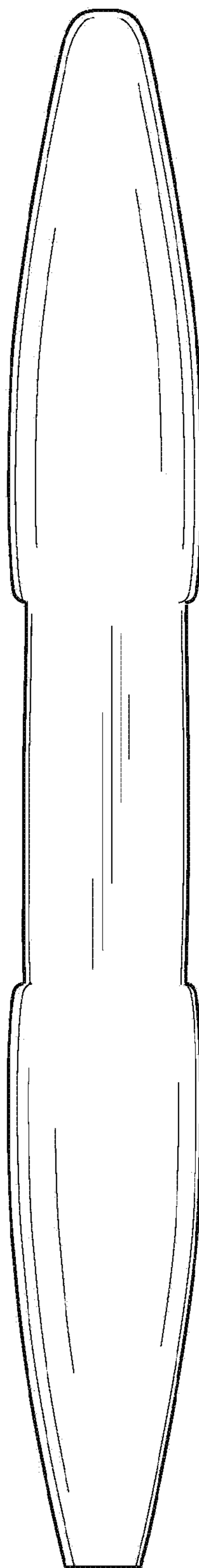

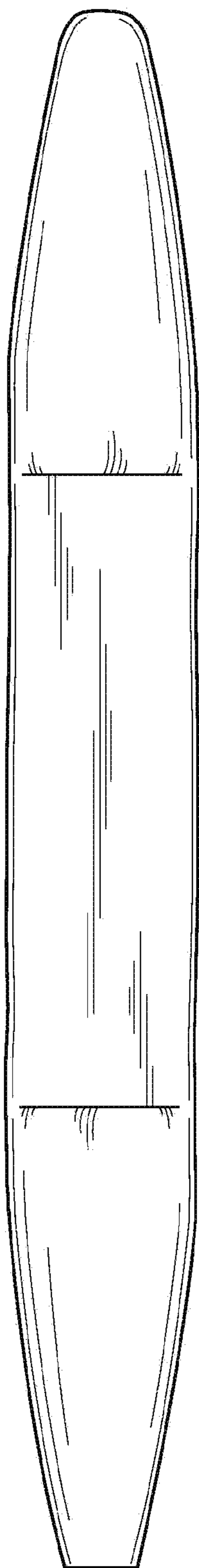

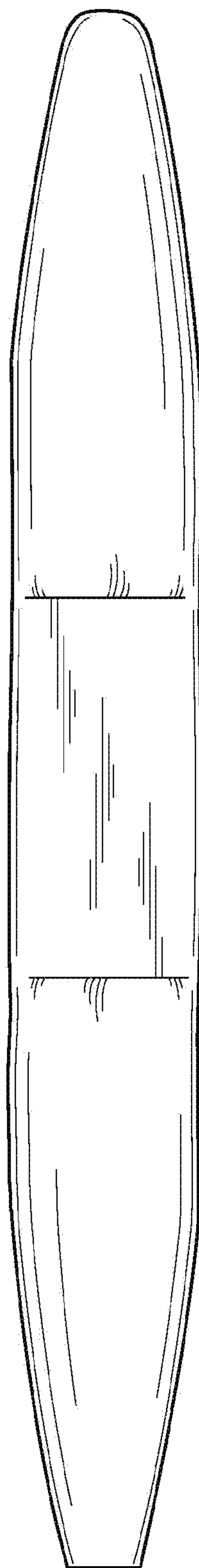

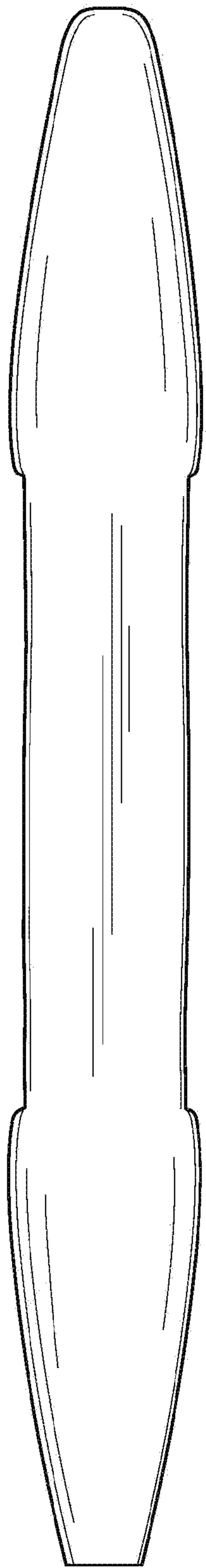

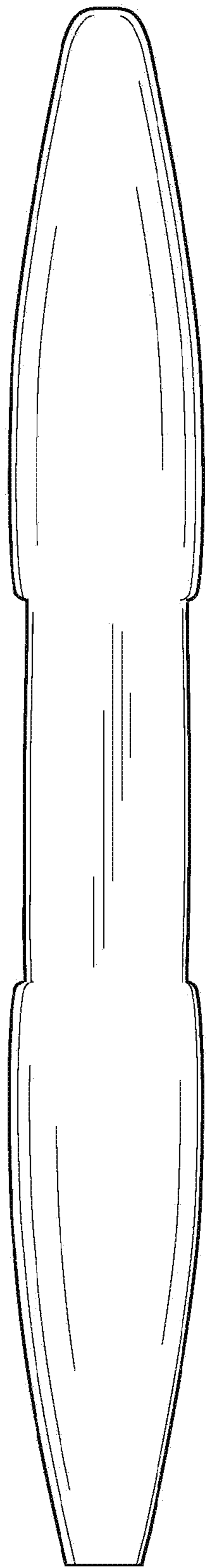

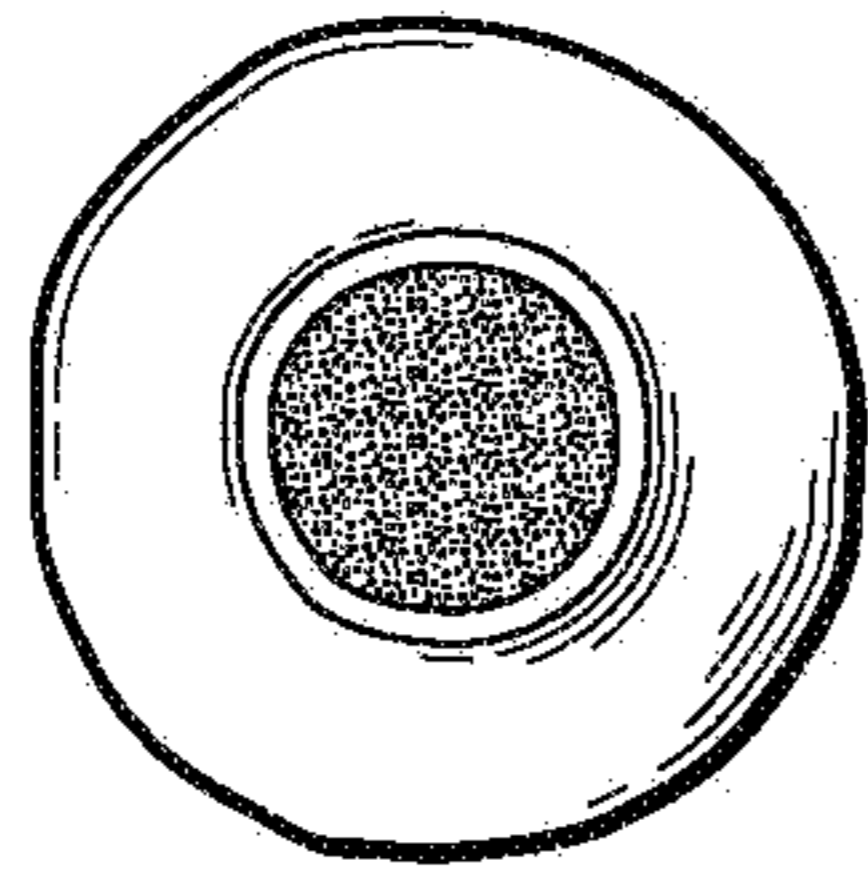

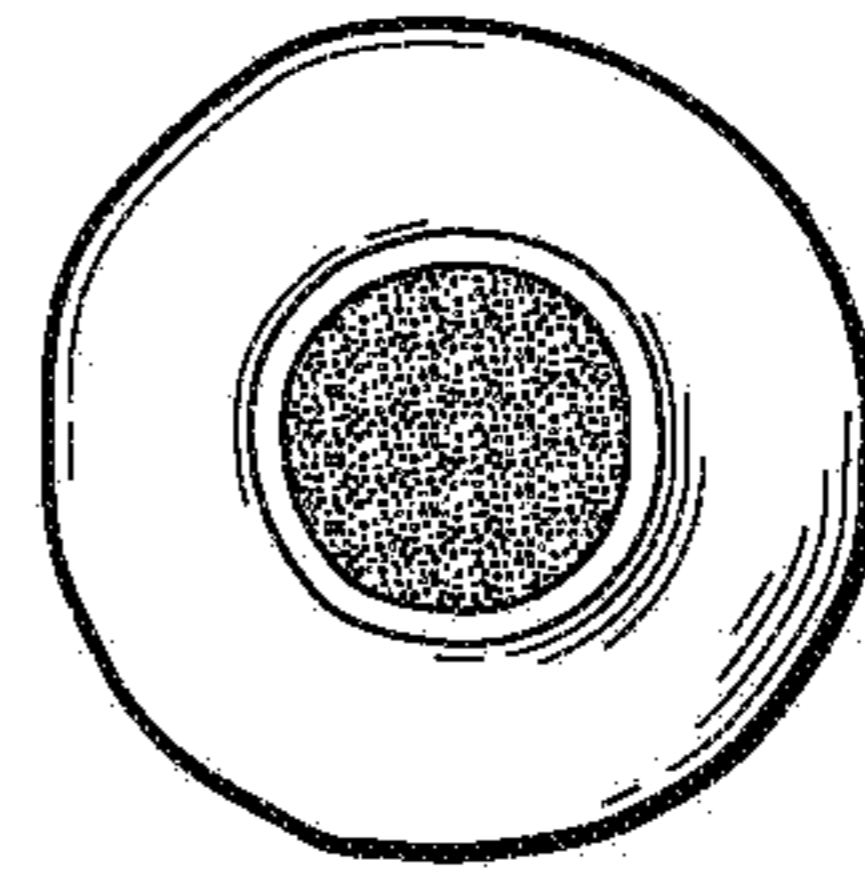

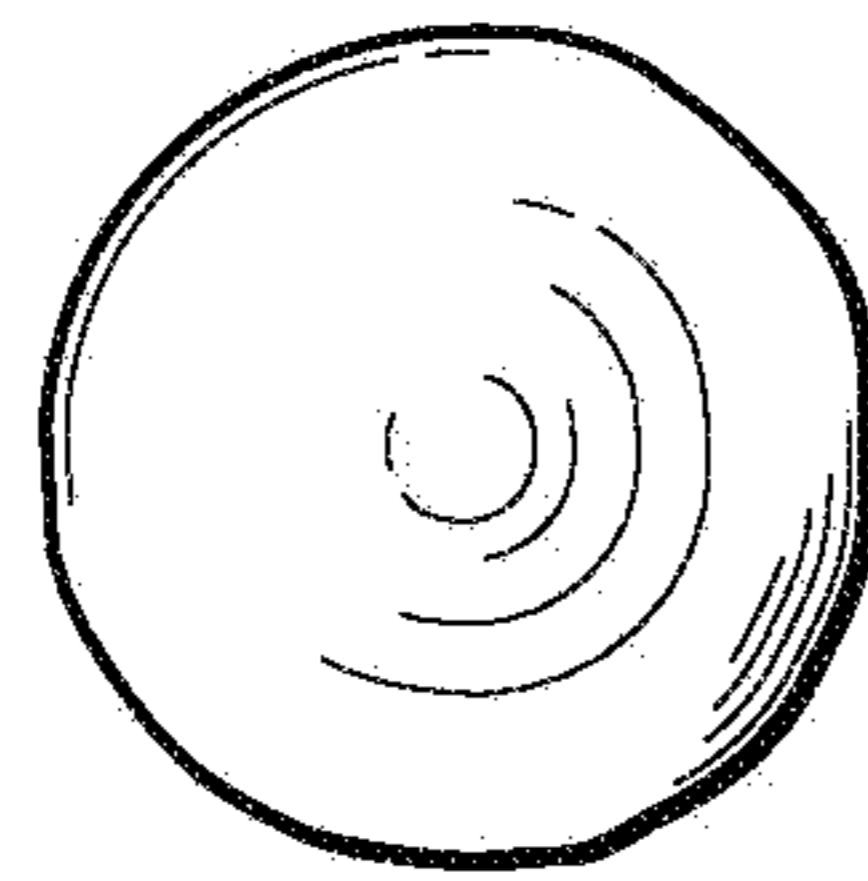

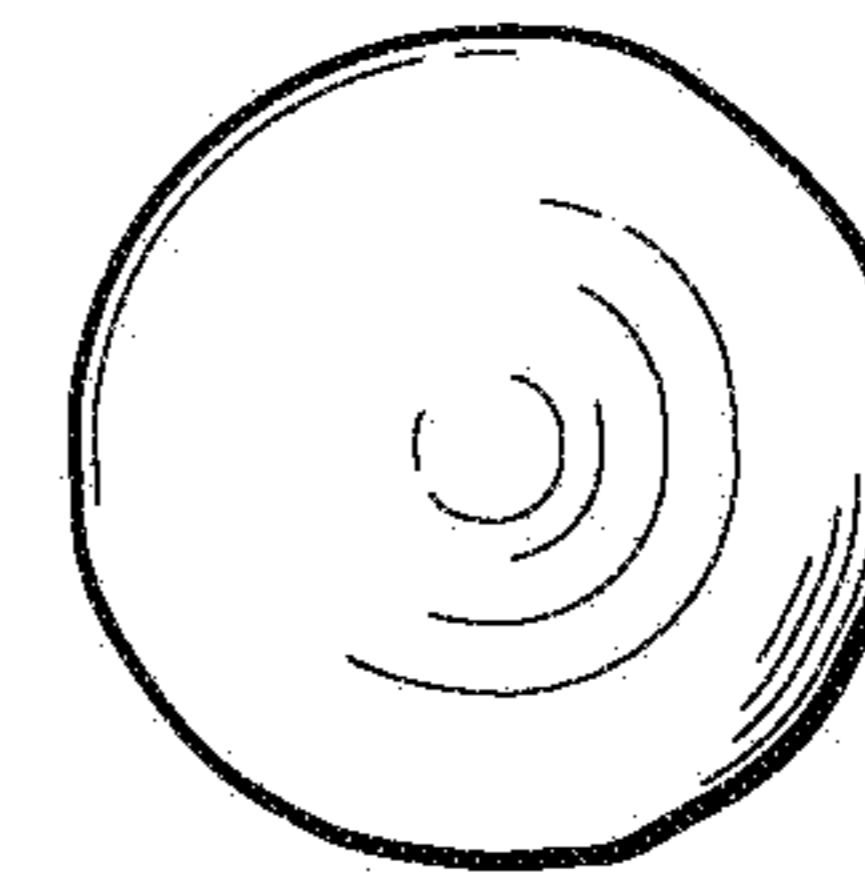
