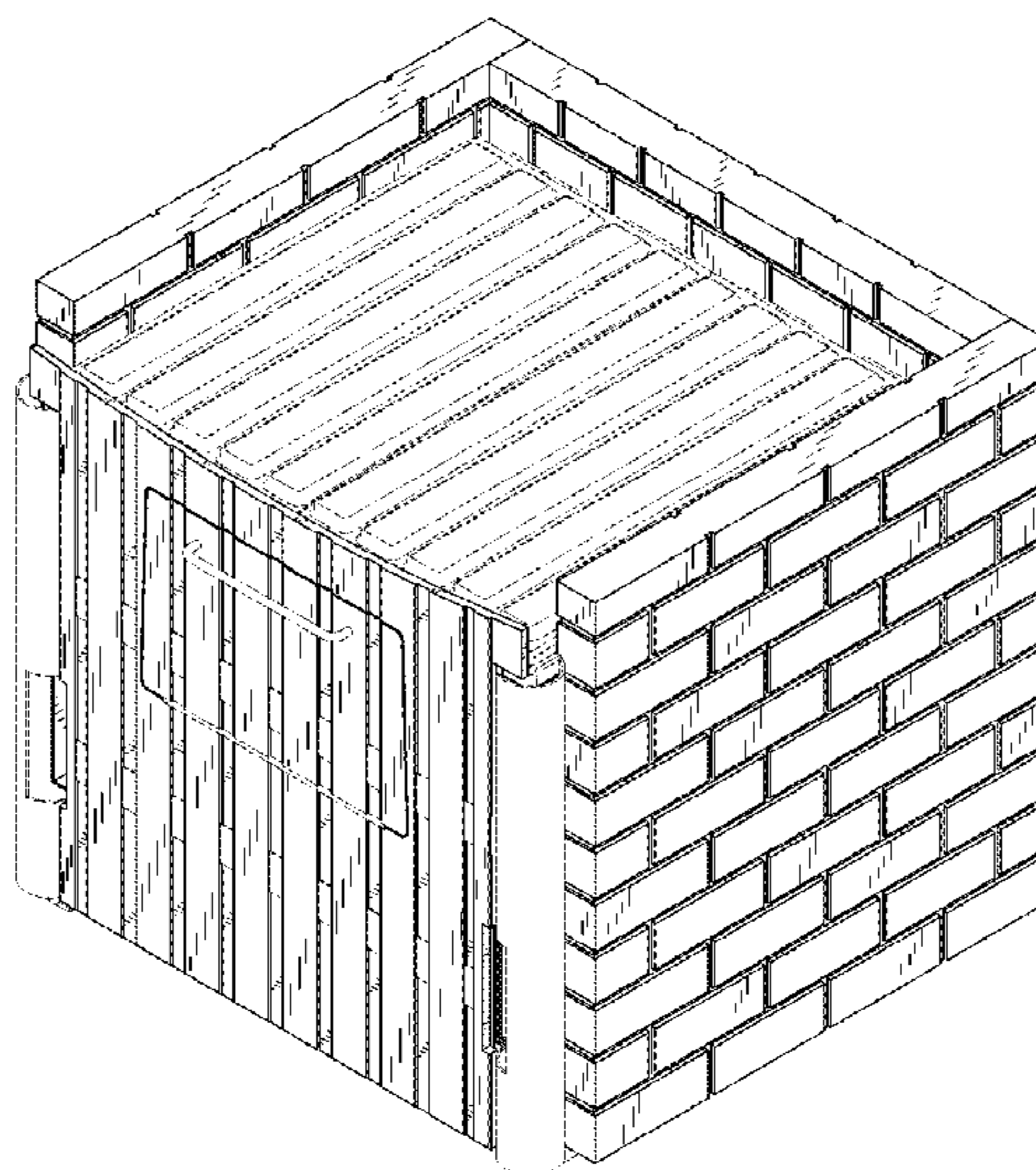
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front-top-right perspective view of a refuse con-
tainer showing my new design;
FIG. 2 is a front elevational view thereof;

FIG. 4 is a right side elevational view thereof;
FIG. 5 is a top plan elevational view thereof;

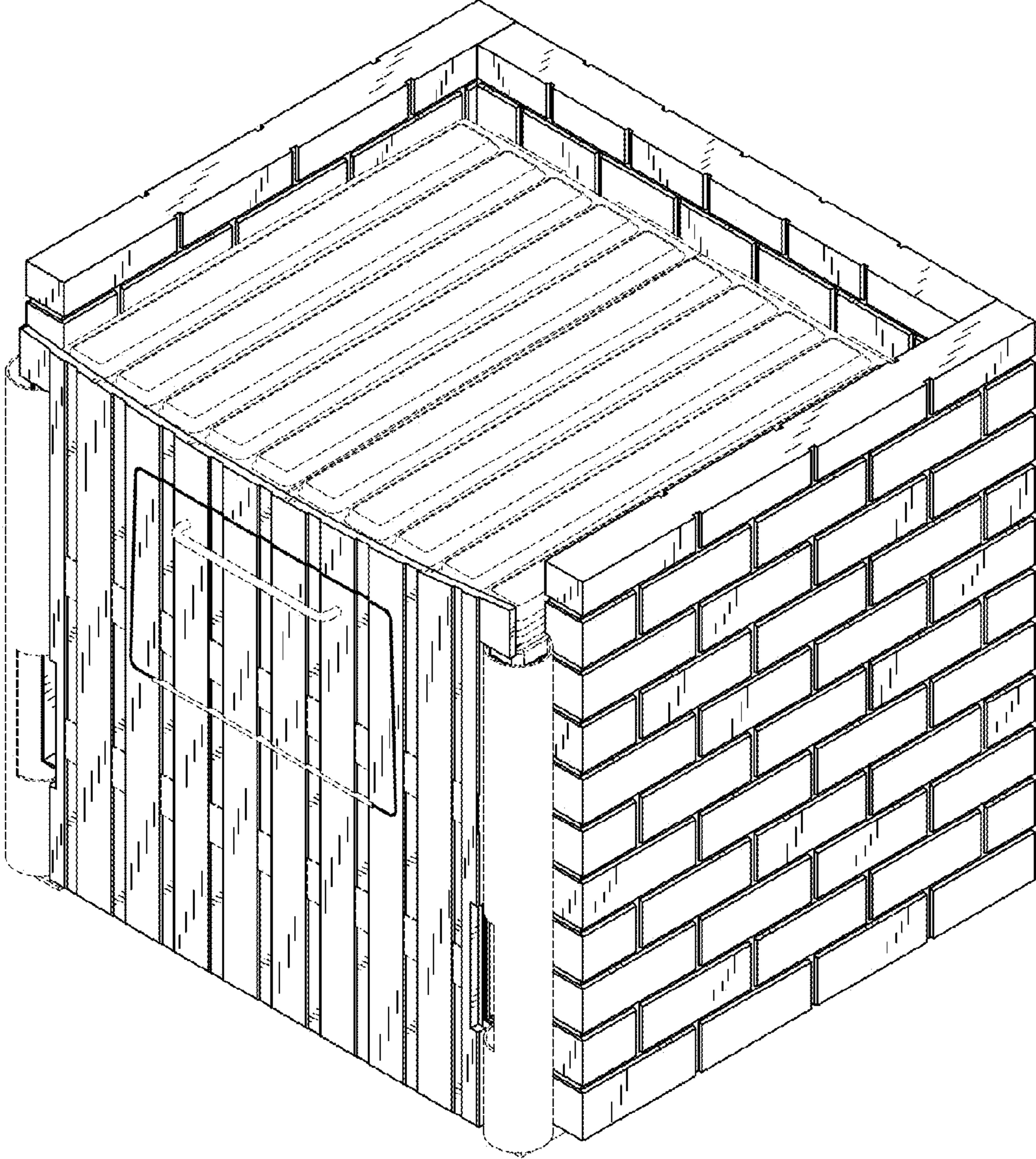

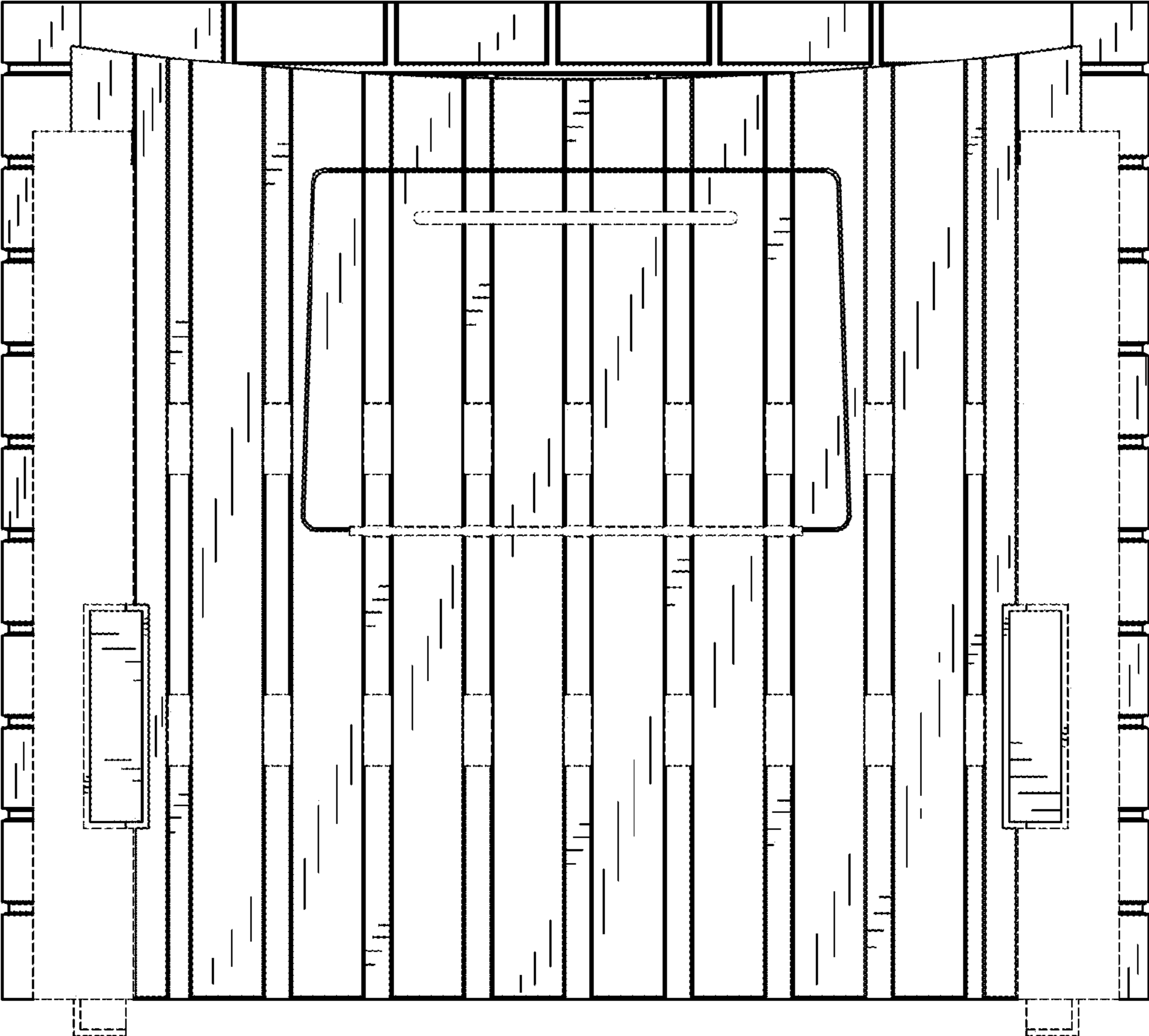

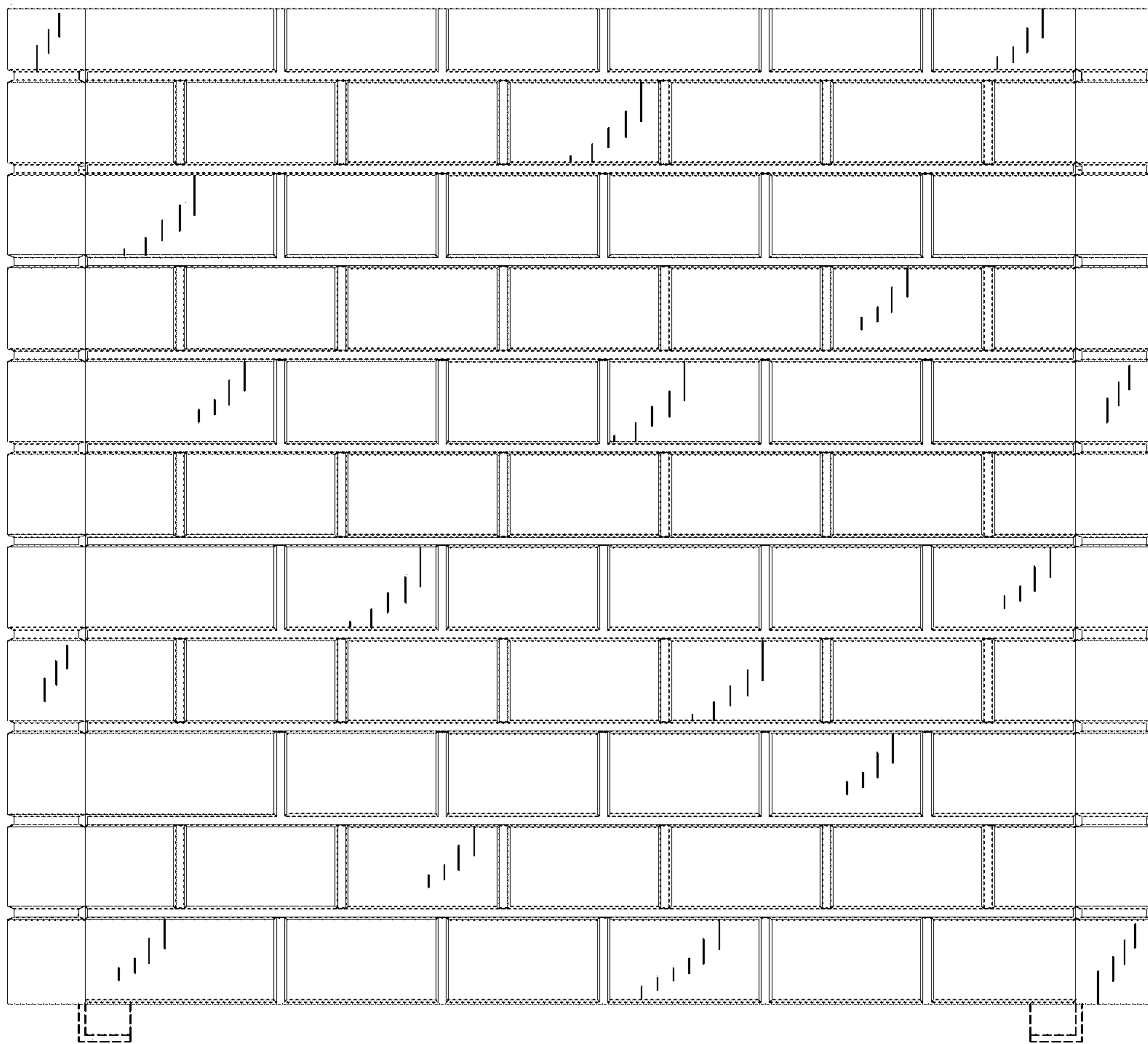

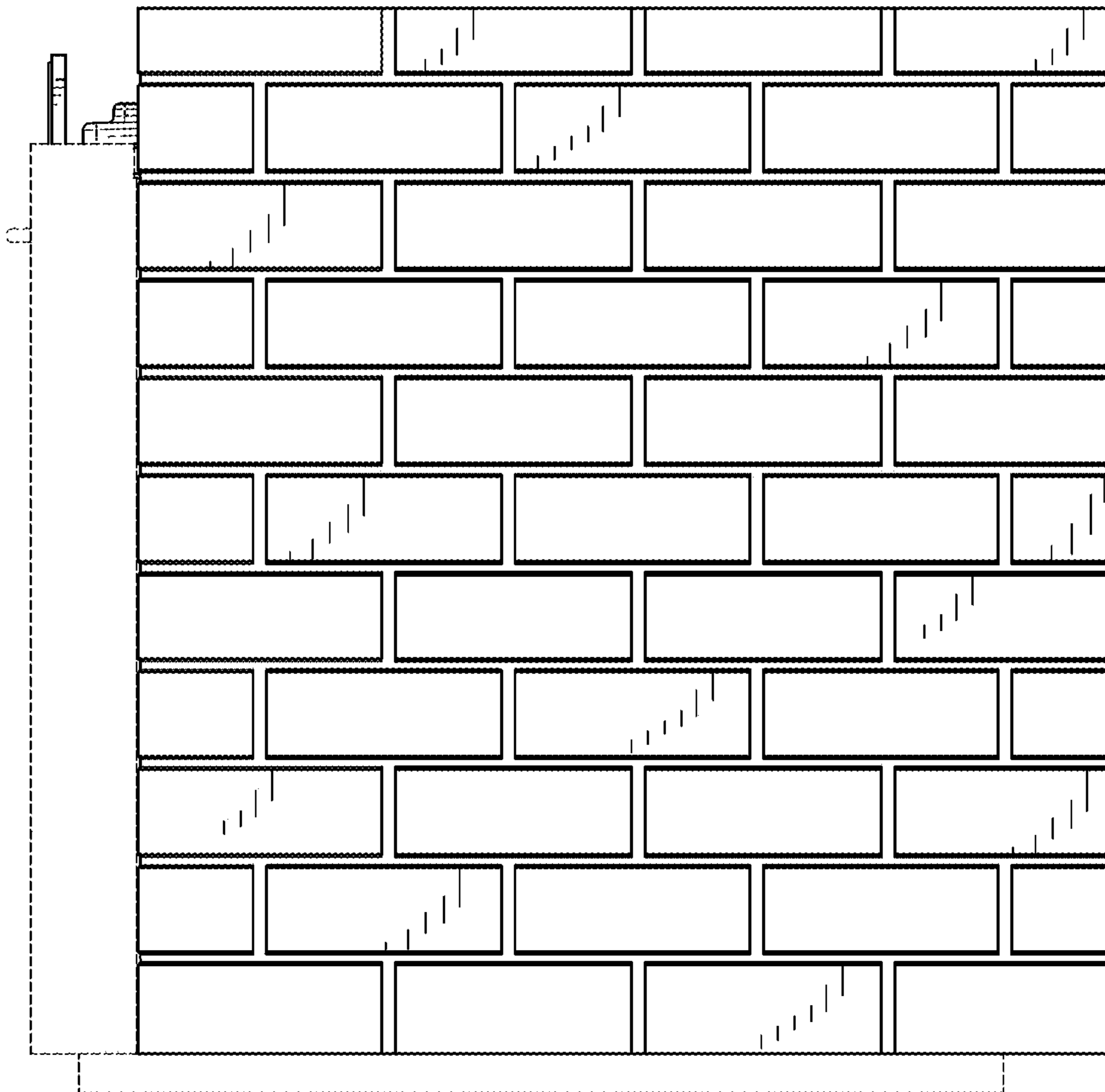

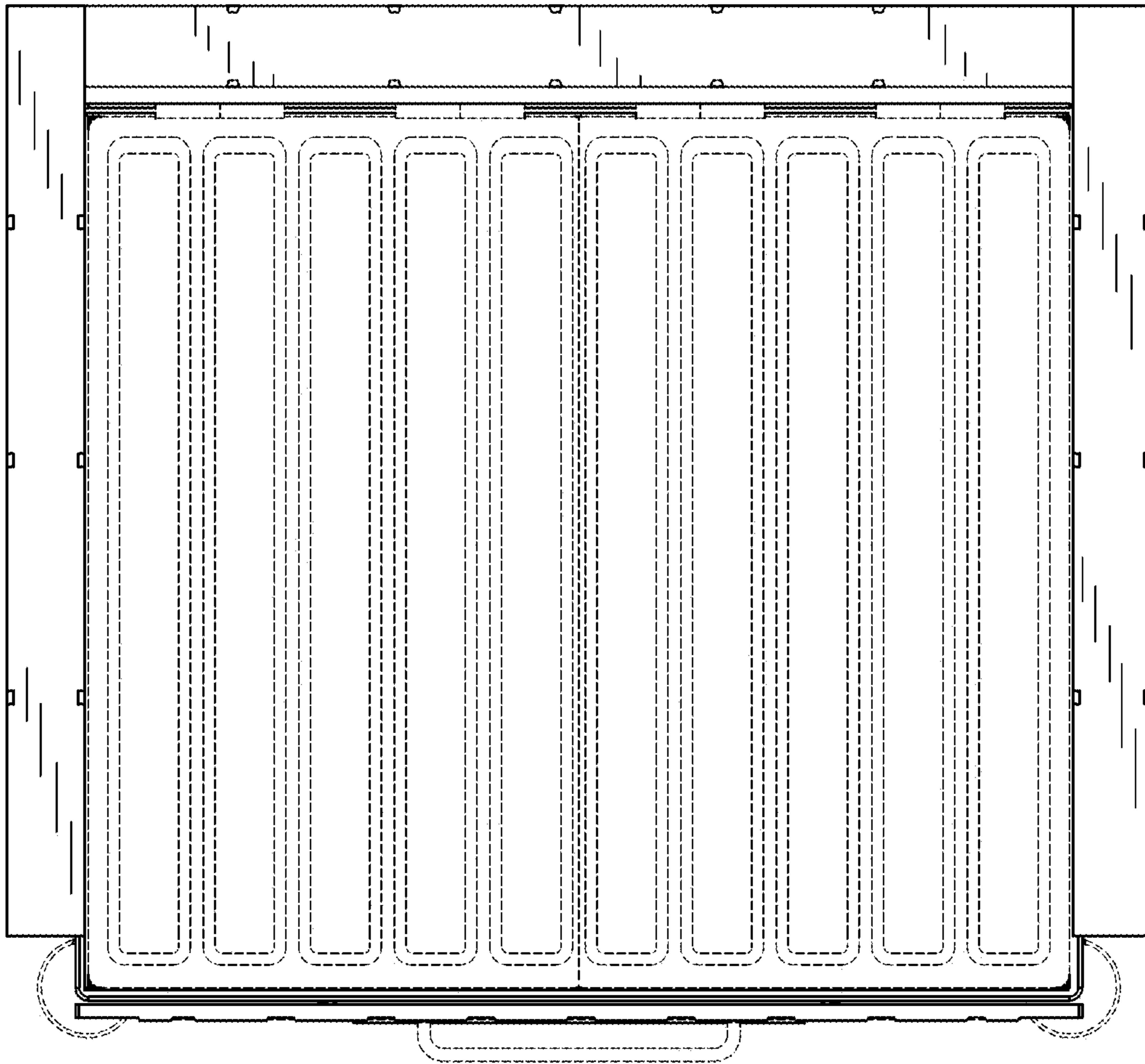

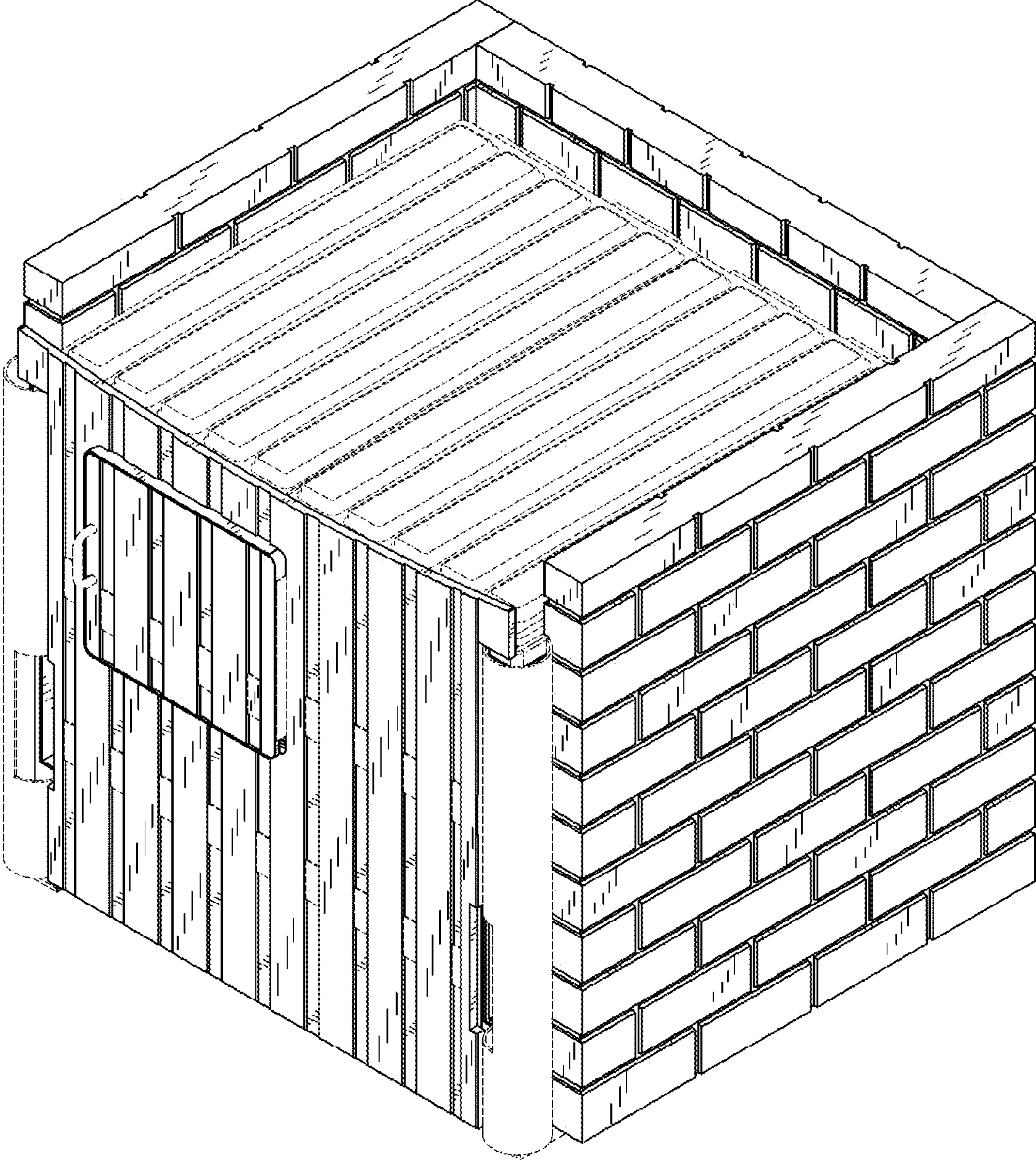

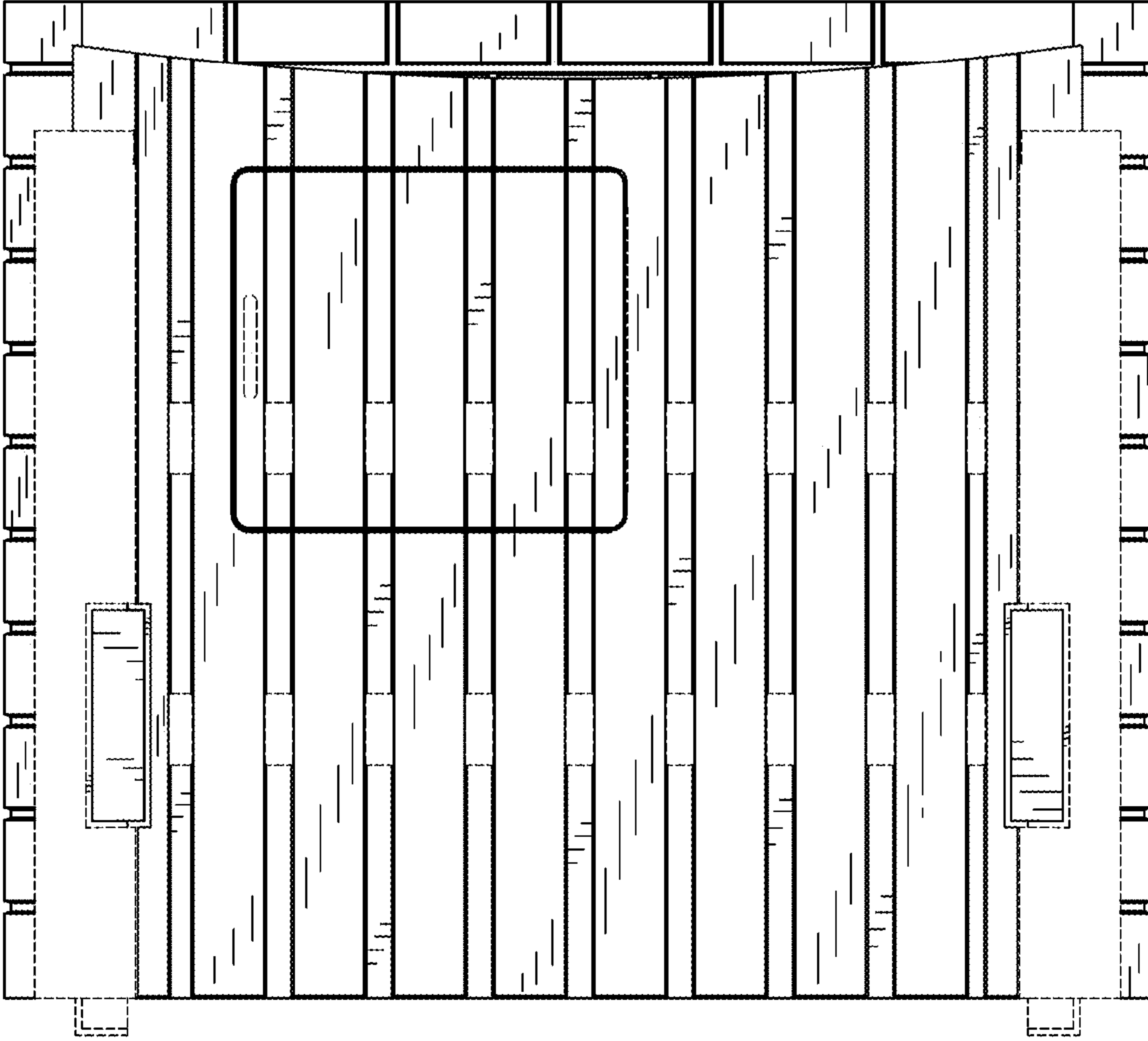

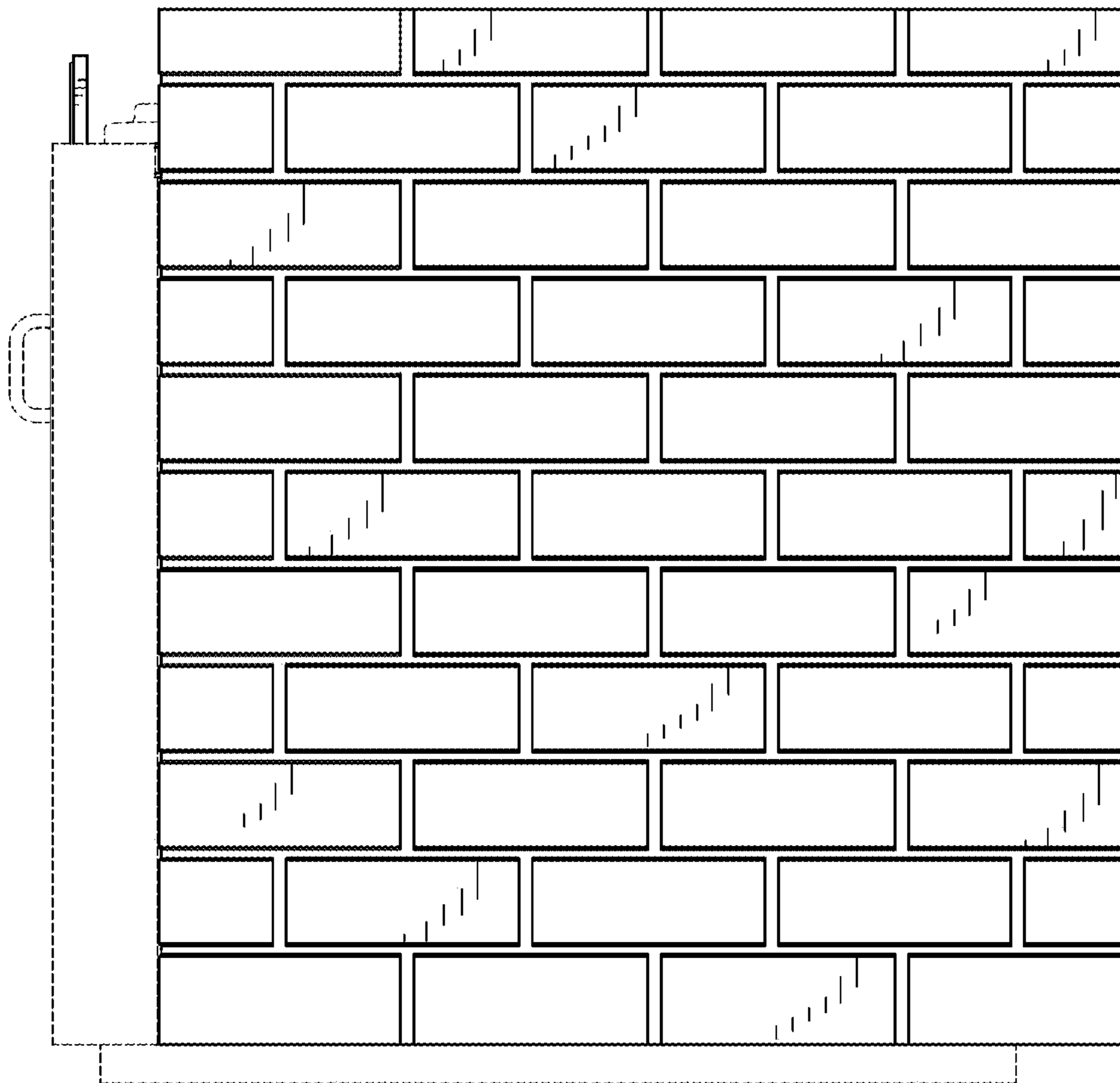

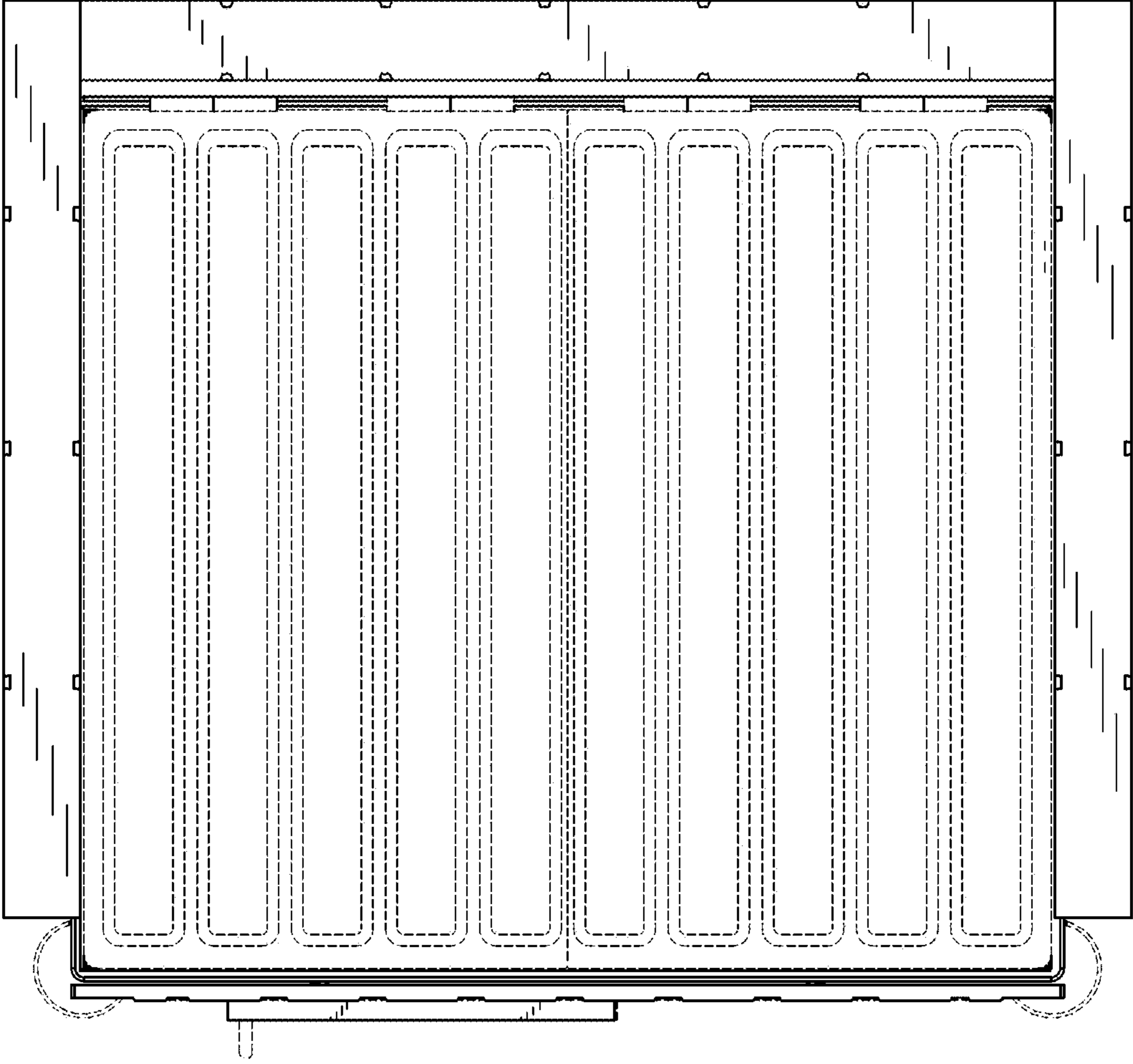
