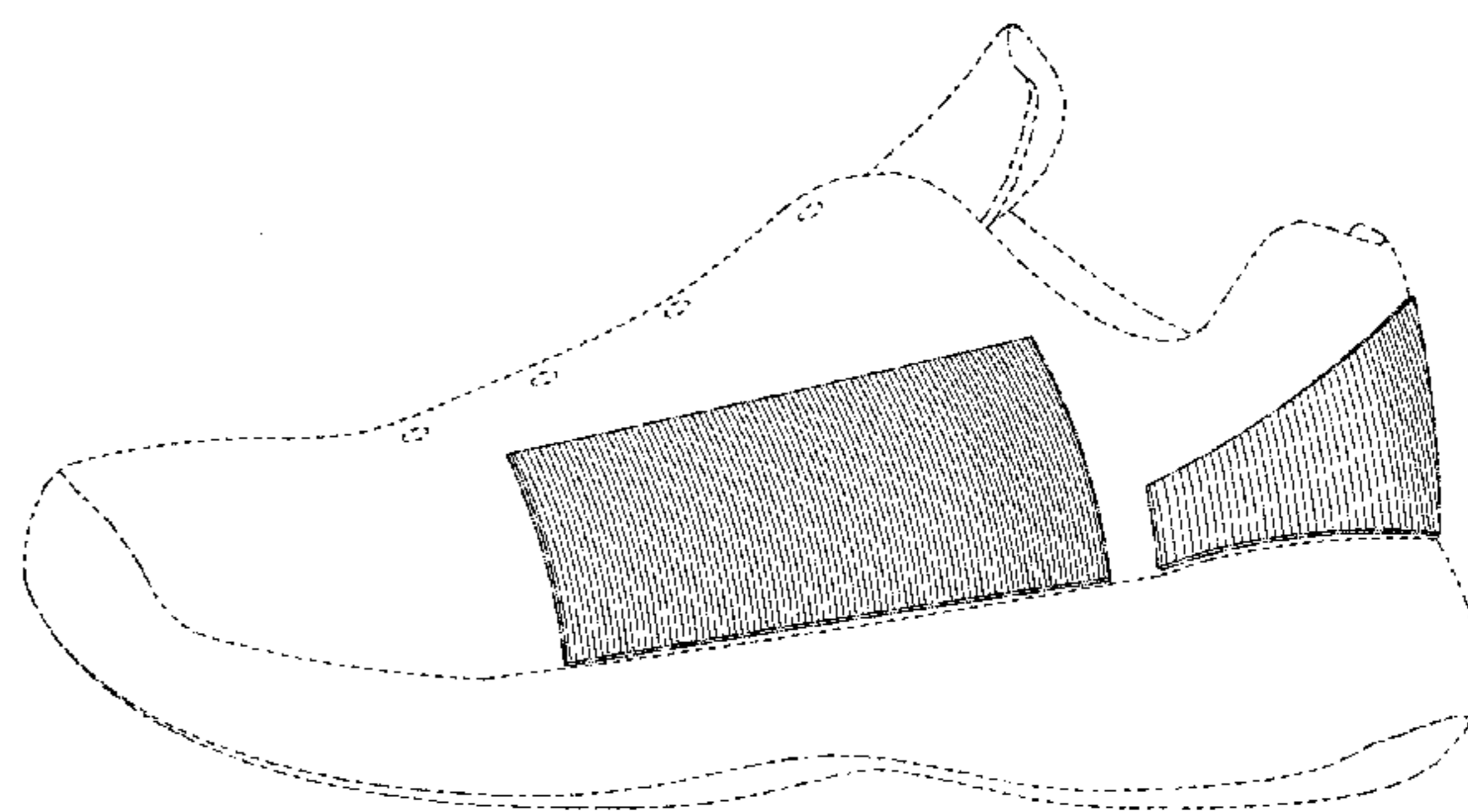
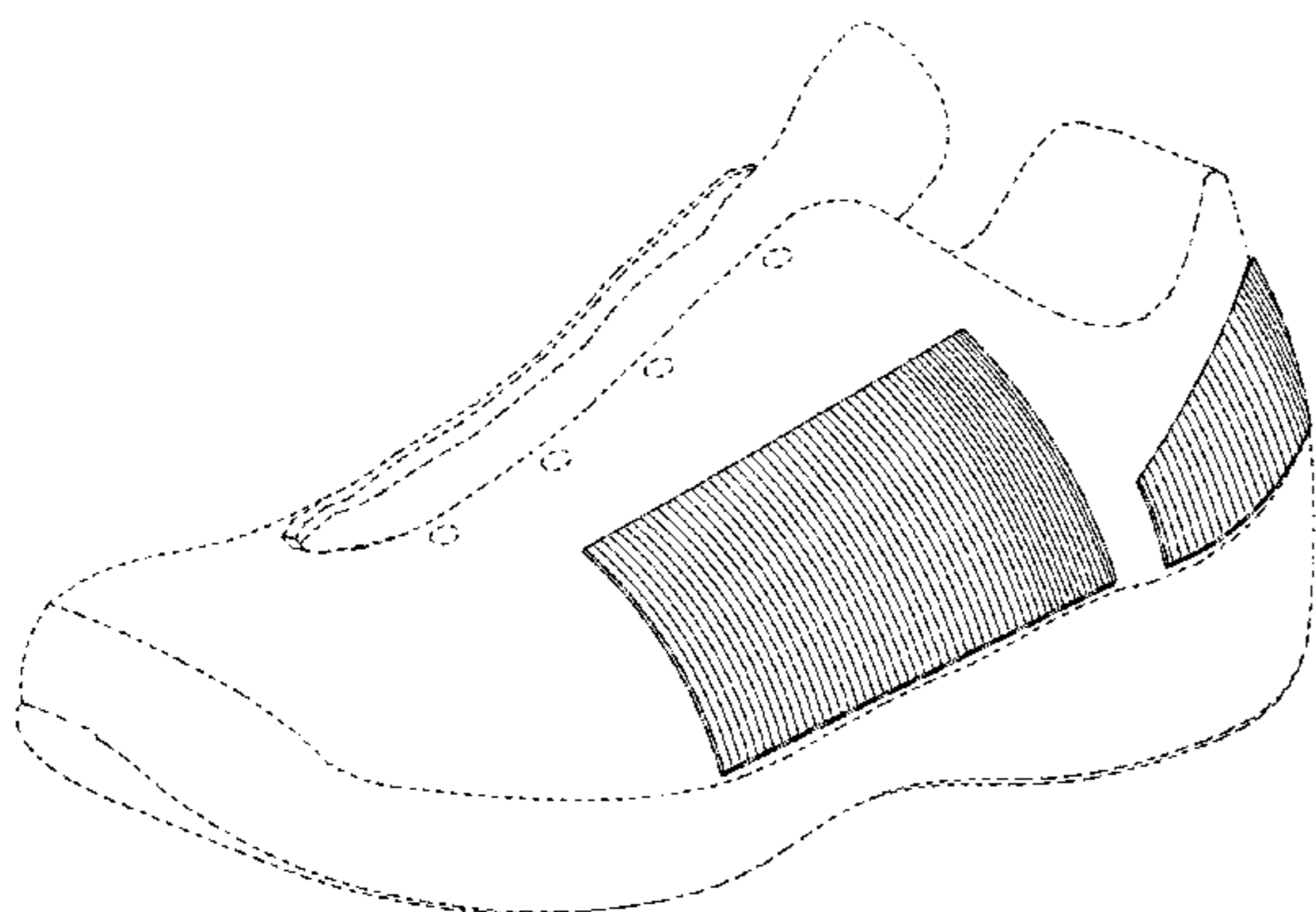
The ornamental design for lenticular panels for a shoe, as shown and described.

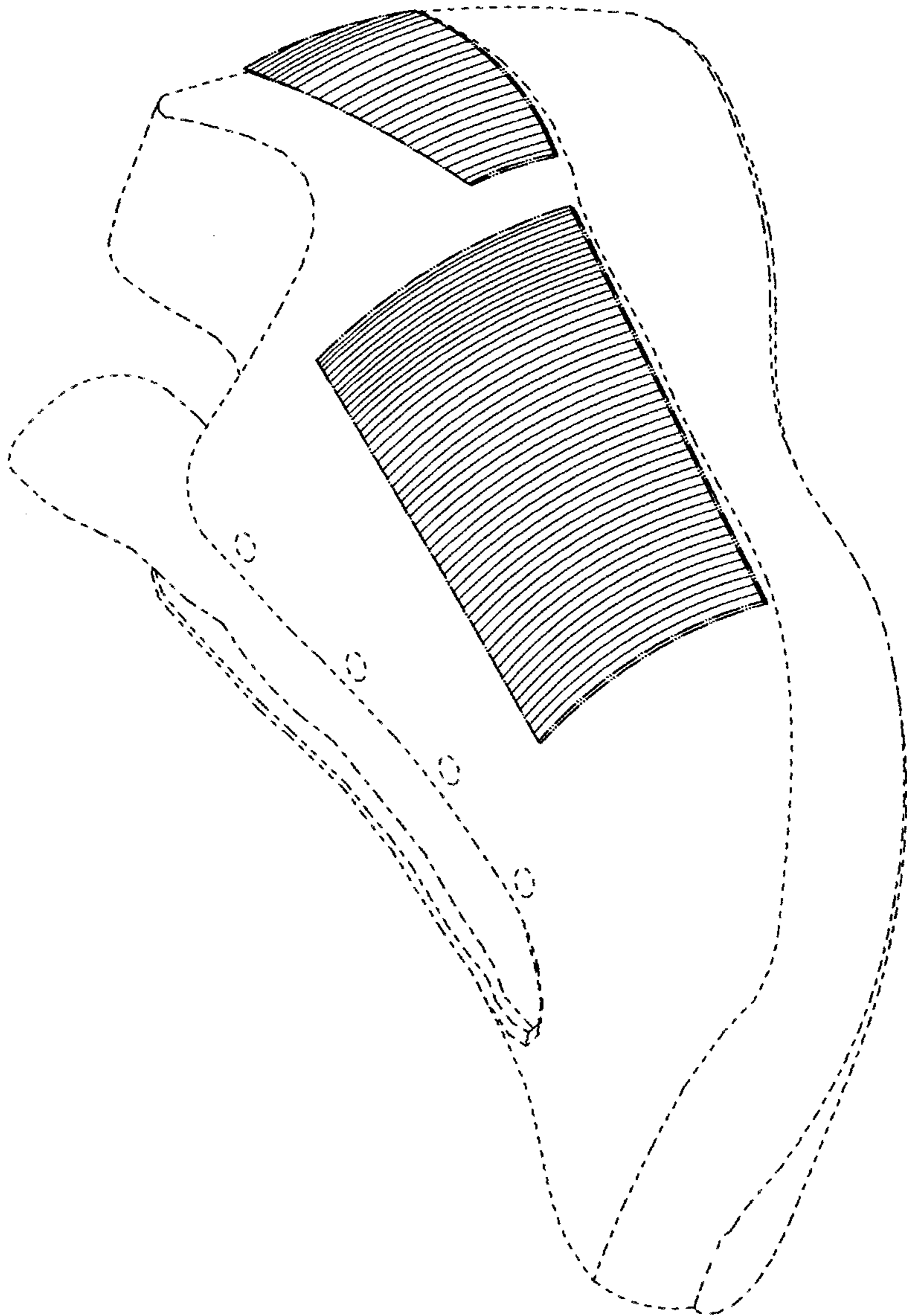

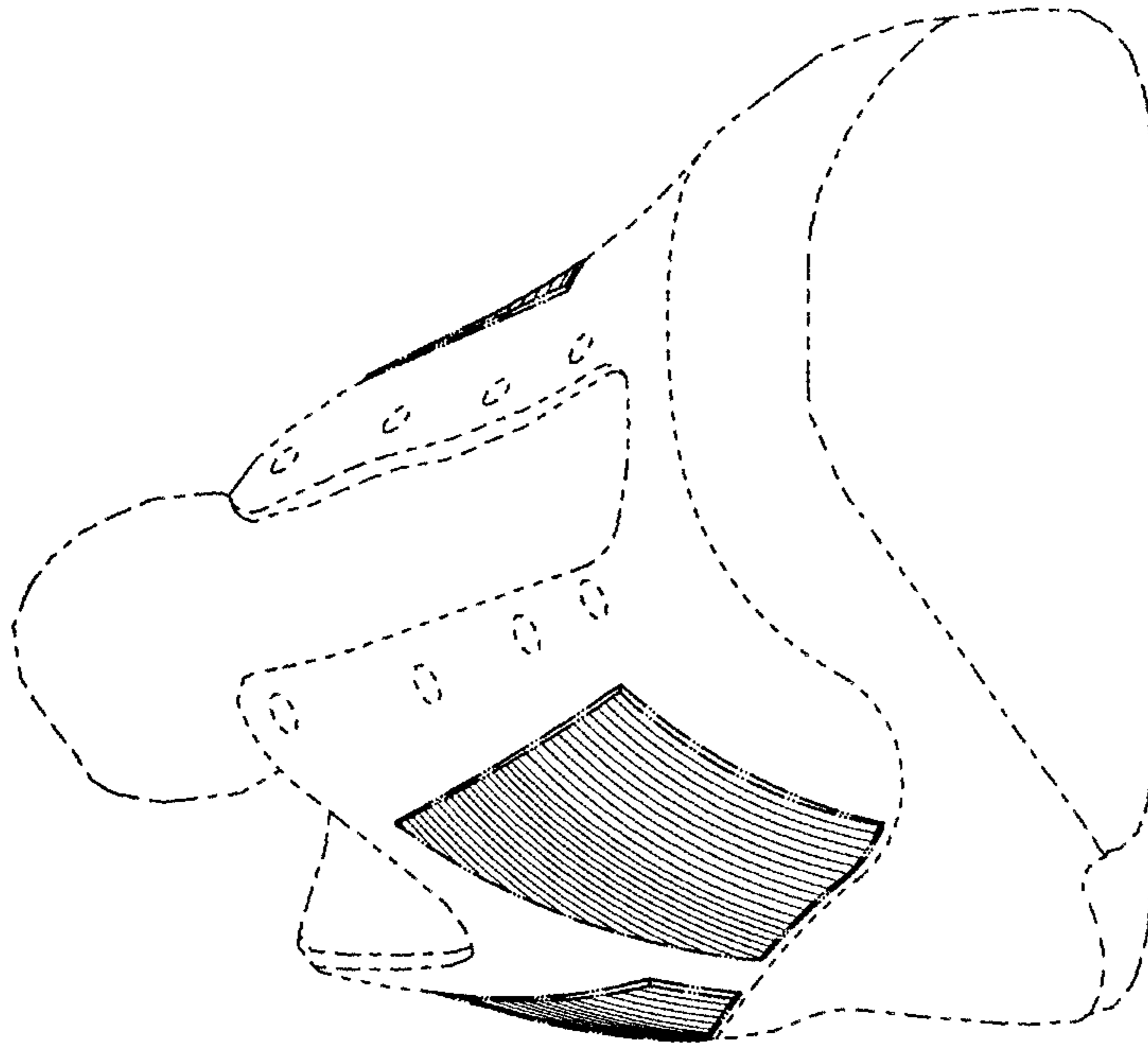

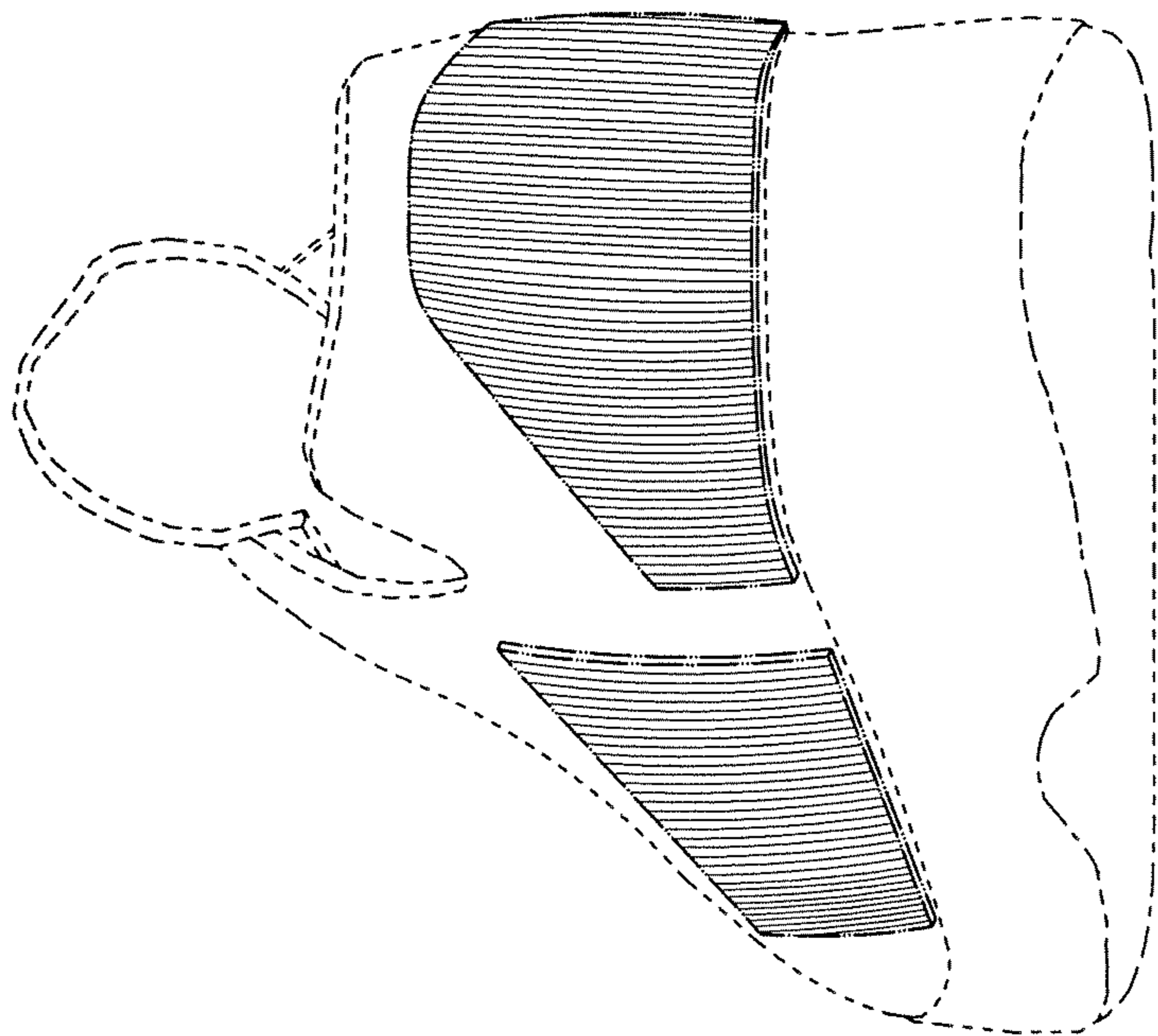

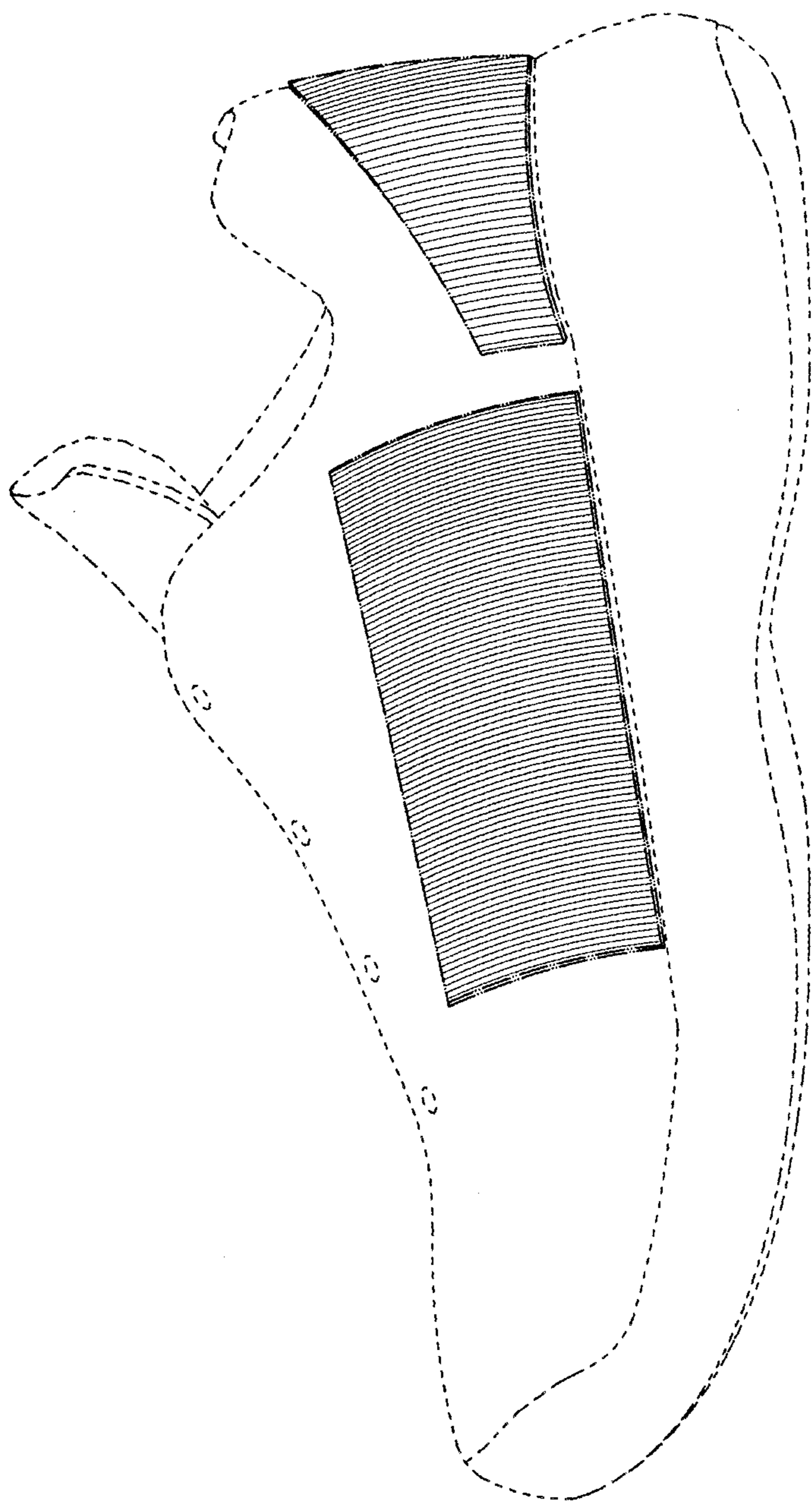

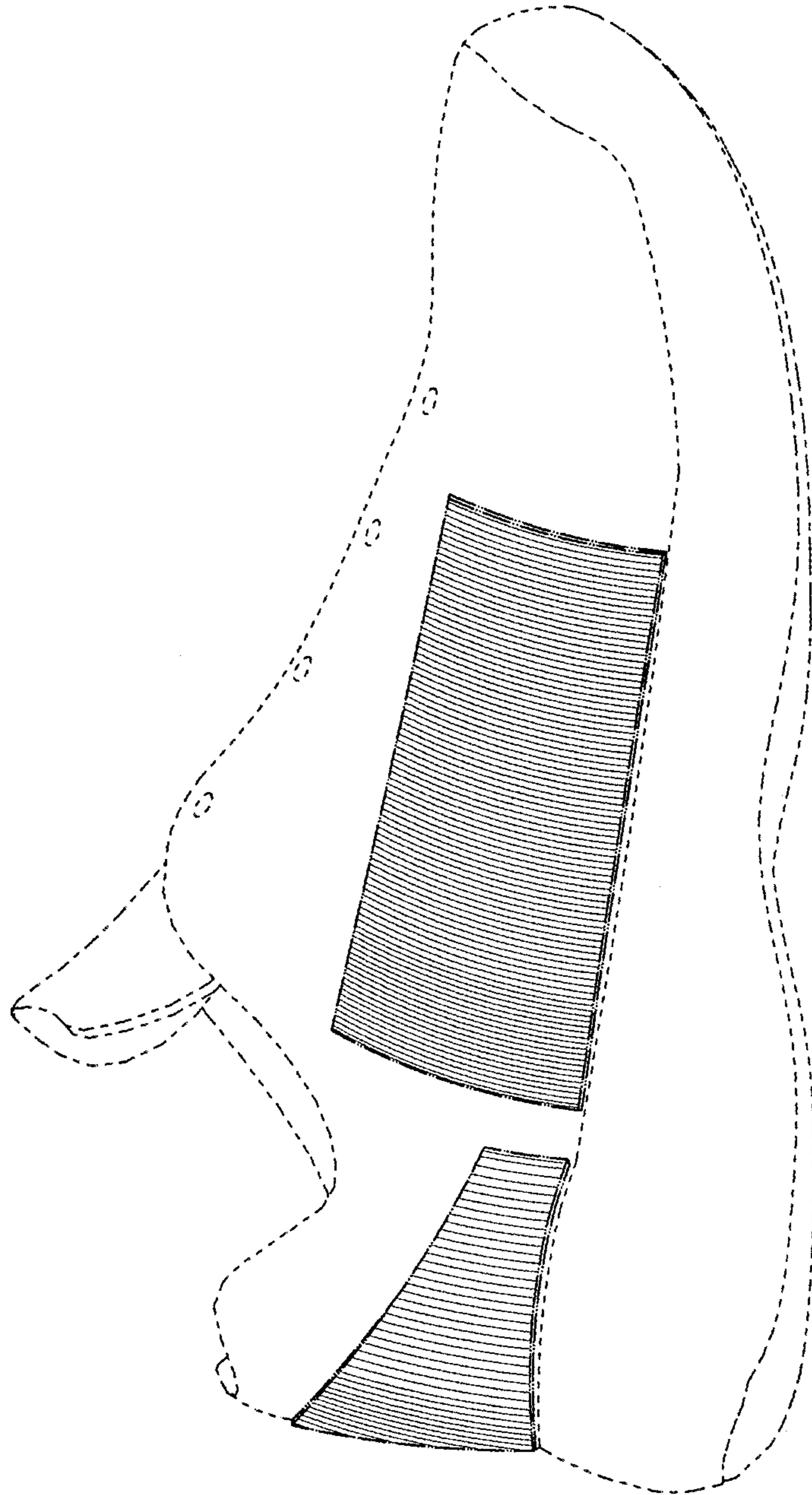

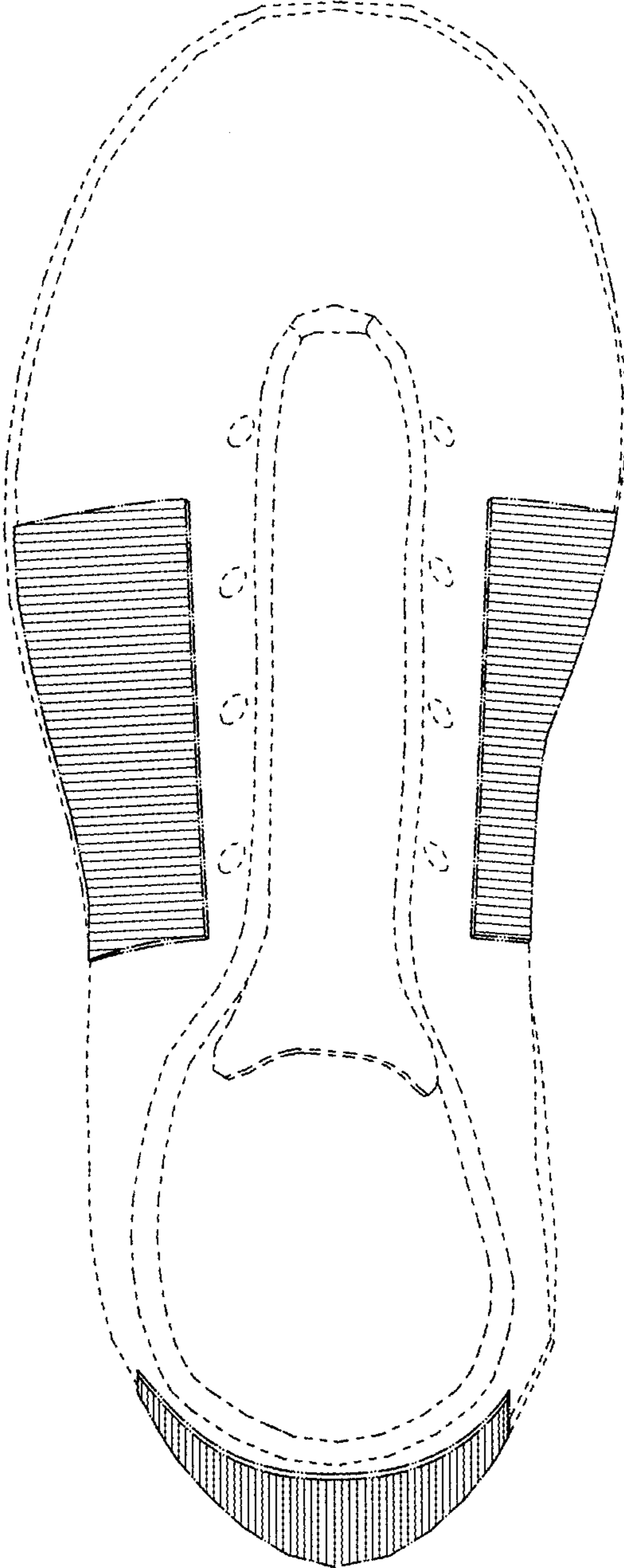

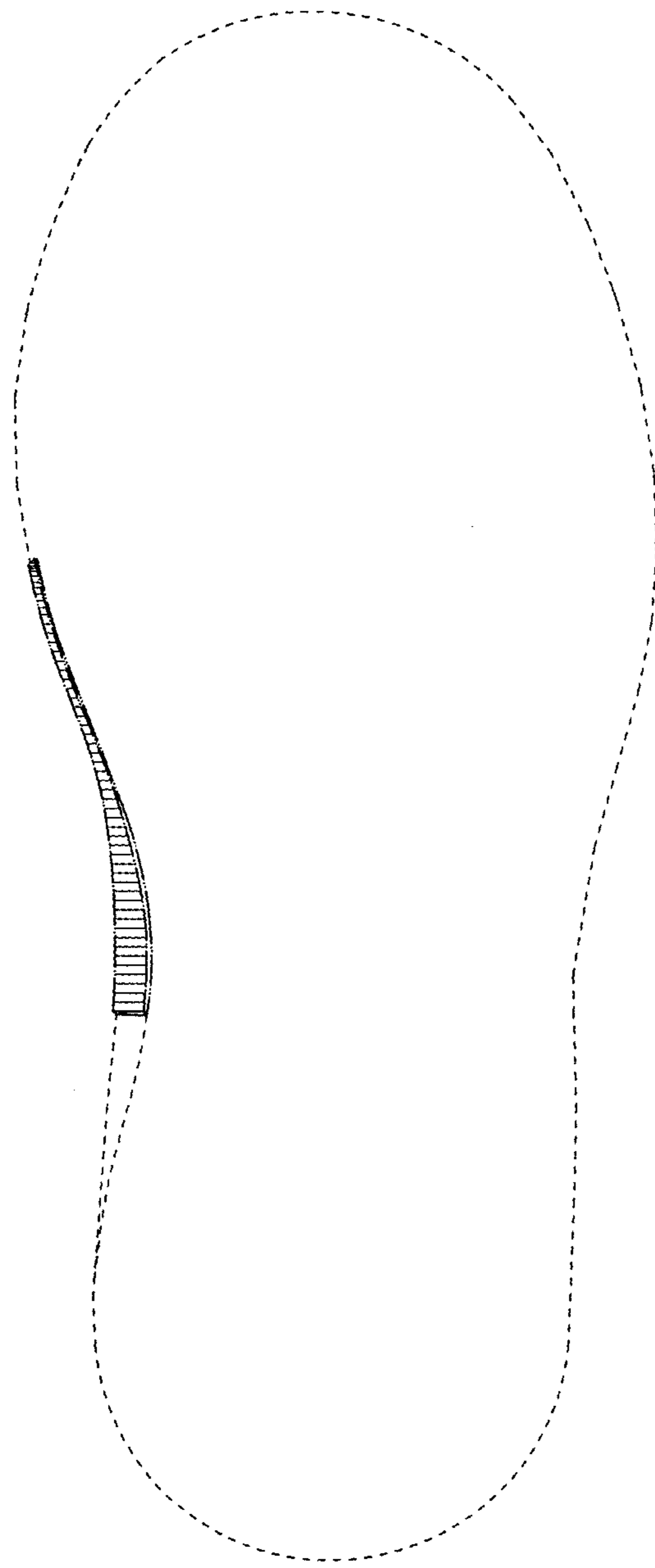
