The ornamental design for a utility and magazine carrier, as shown and described.

**DESCRIPTION**

FIG. 1 is a top front perspective view of a utility and magazine carrier, showing the new design;  
FIG. 2 is a bottom front perspective view of the utility and magazine carrier of FIG. 1;  
FIG. 3 is a right rear view of the utility and magazine carrier of FIG. 1;  
FIG. 4 is rear view of the utility and magazine carrier of FIG. 1; and,  
FIG. 5 is a right side view of the utility and magazine carrier of FIG. 1.

The left side view of the utility and magazine carrier is not shown, as it is substantially similar with regards to thicknesses of components of the carrier and features of the design to the right side view.

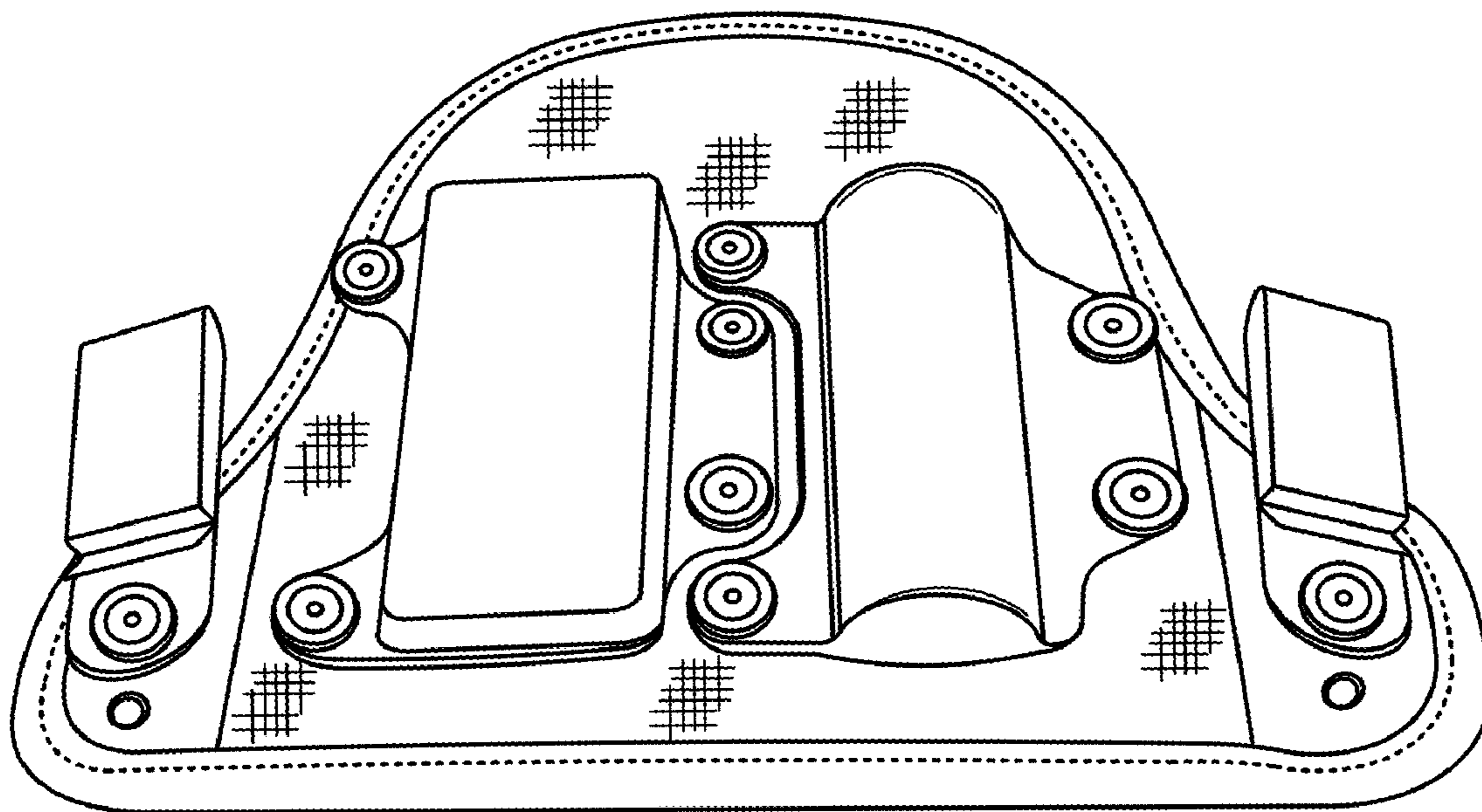

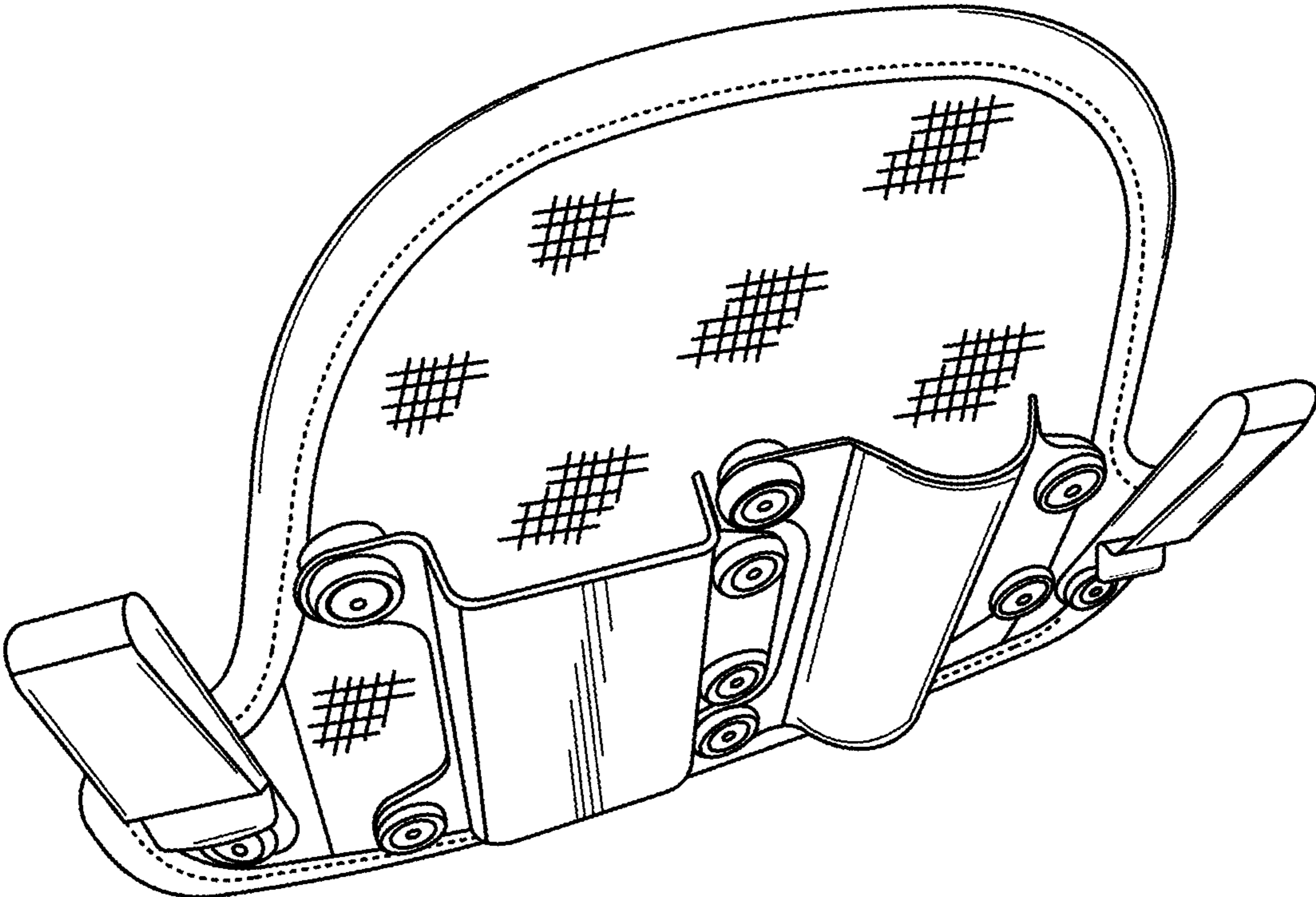

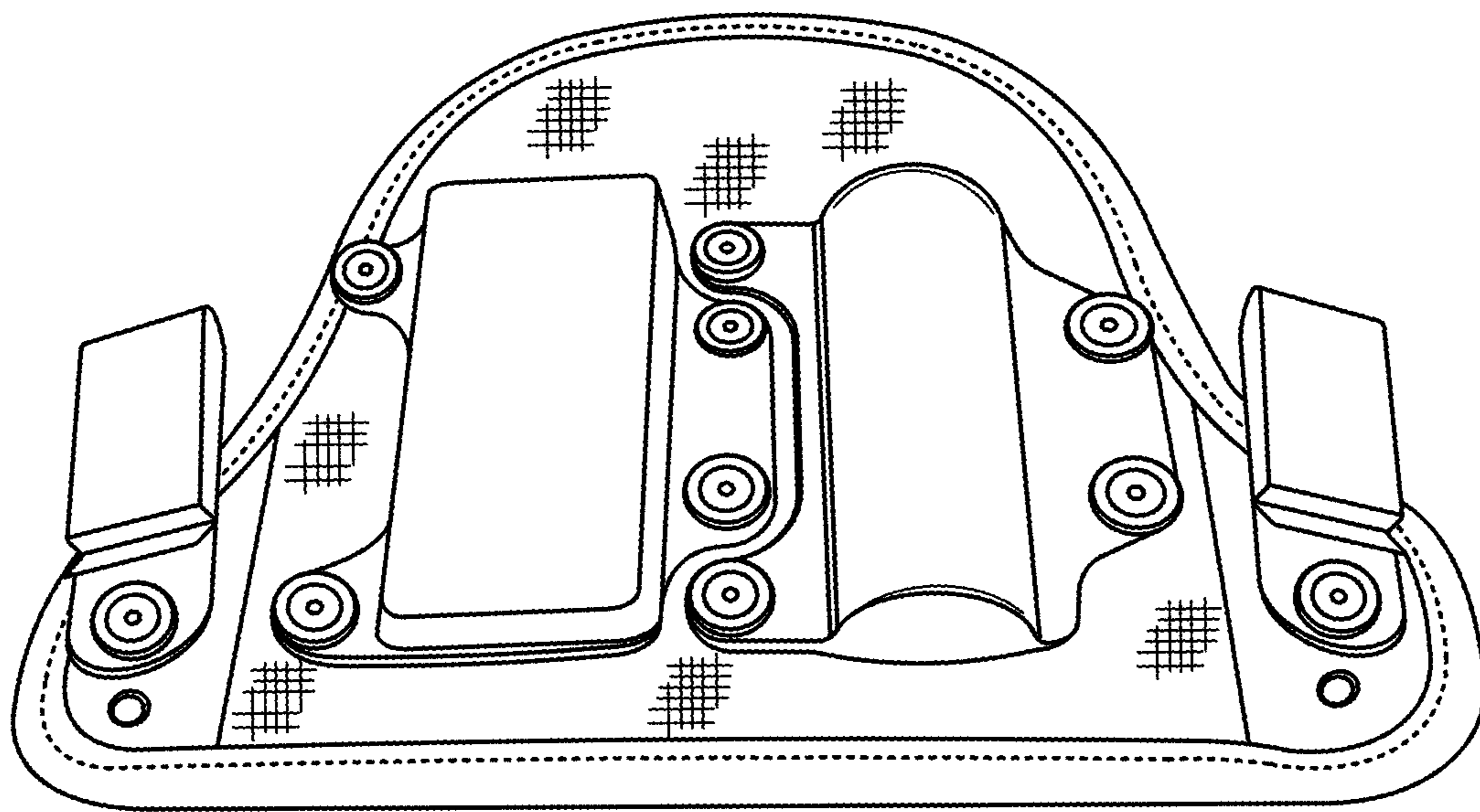

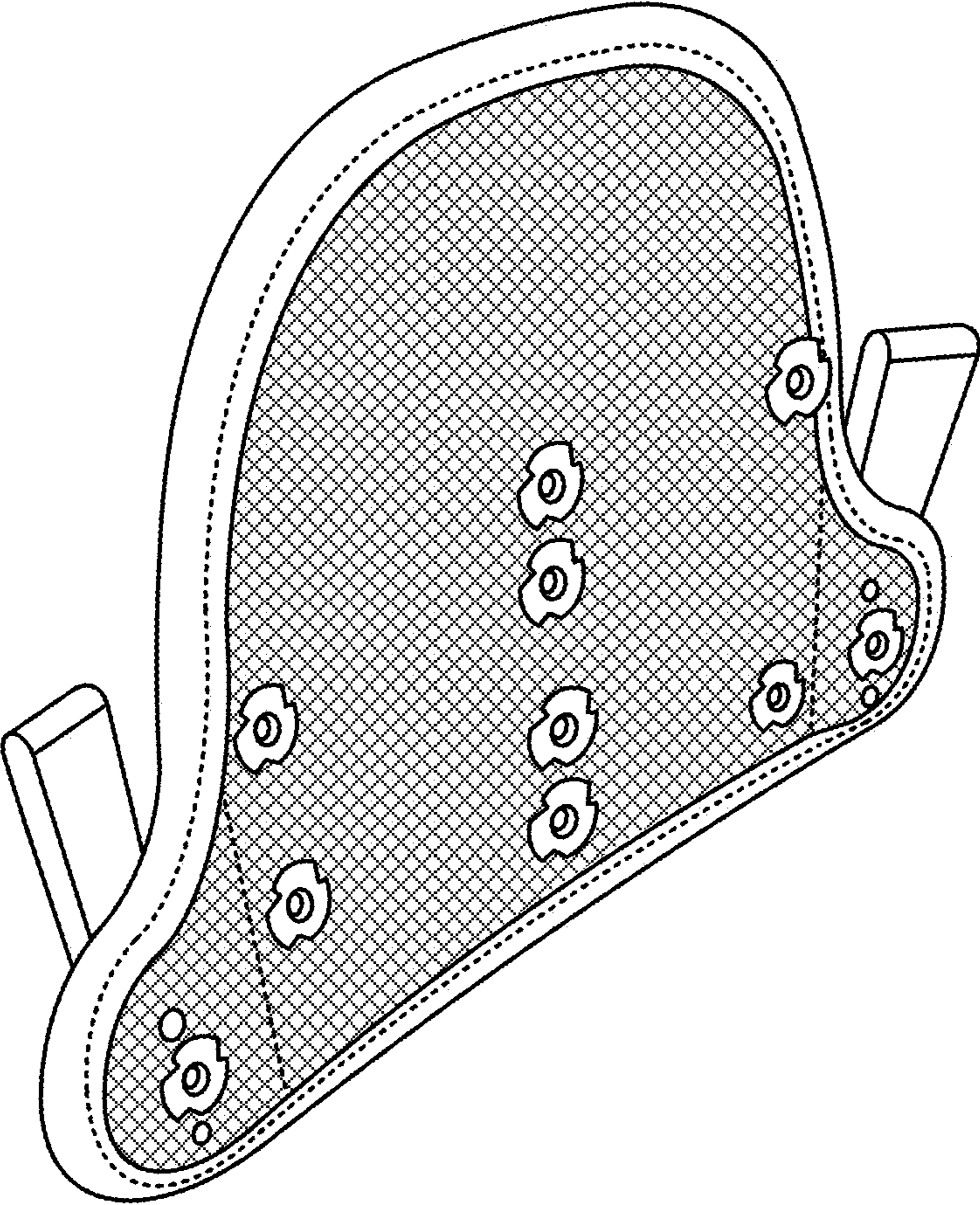

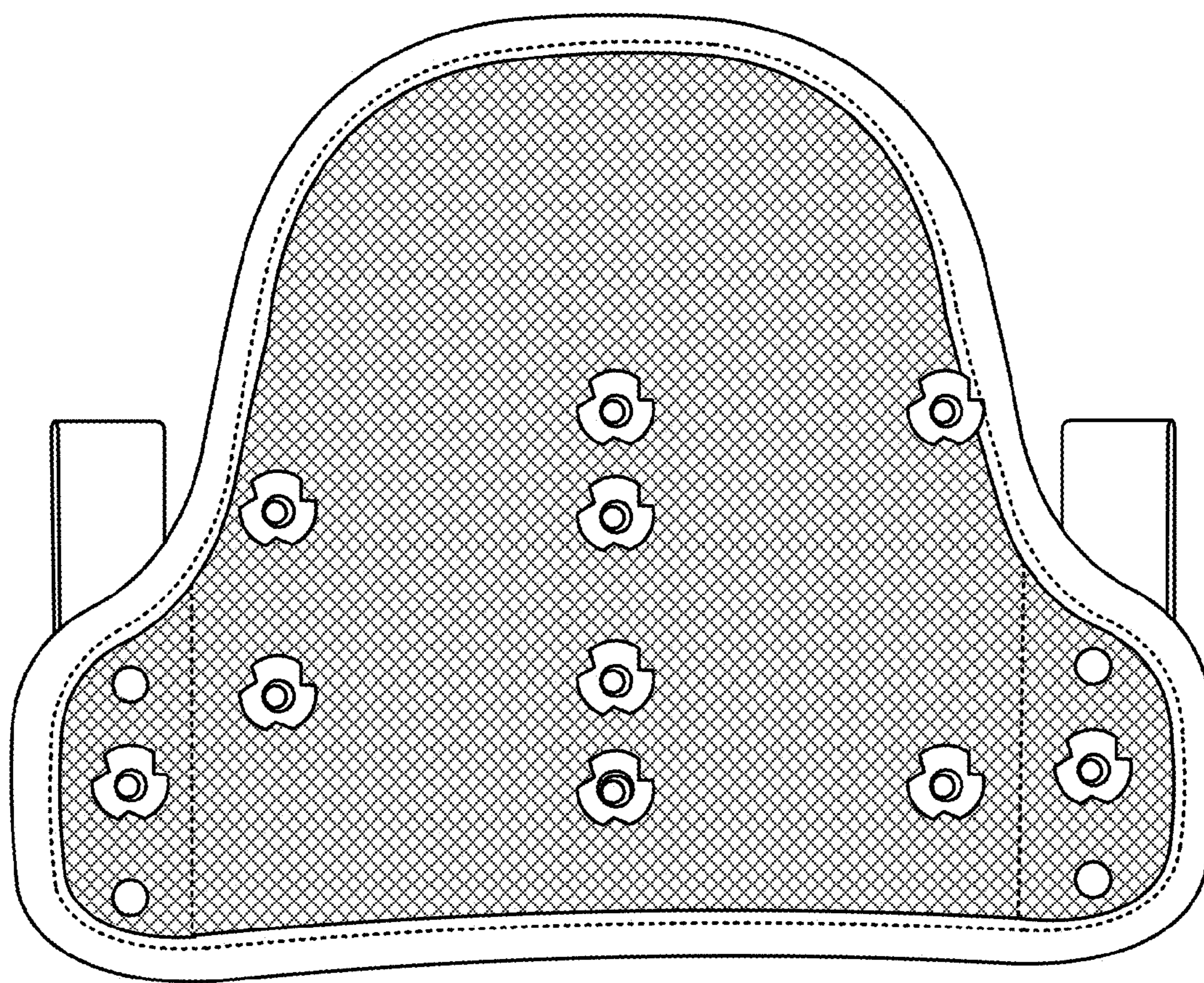
