(57) **CLAIM**

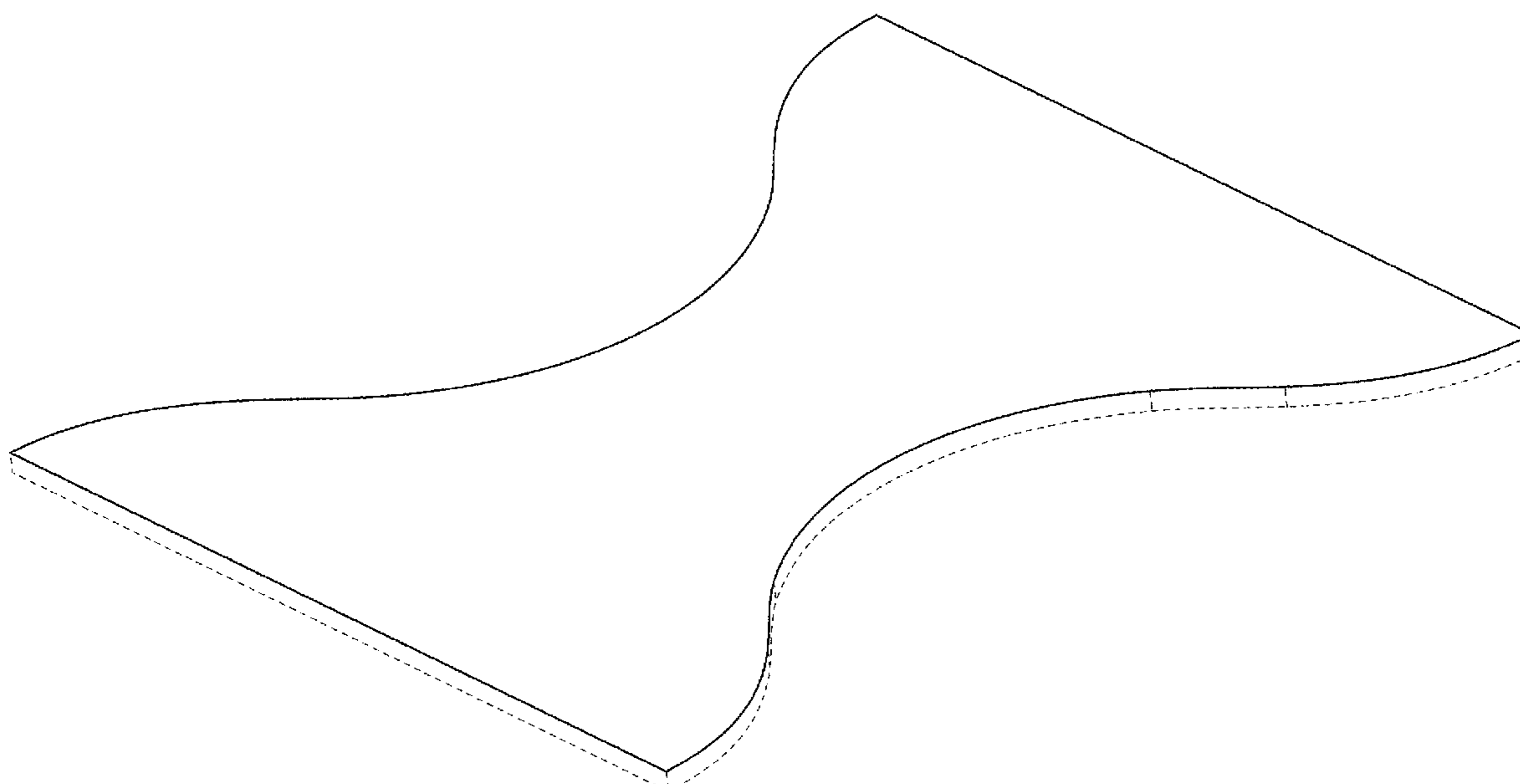
The ornamental design for a golf towel, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the golf towel;

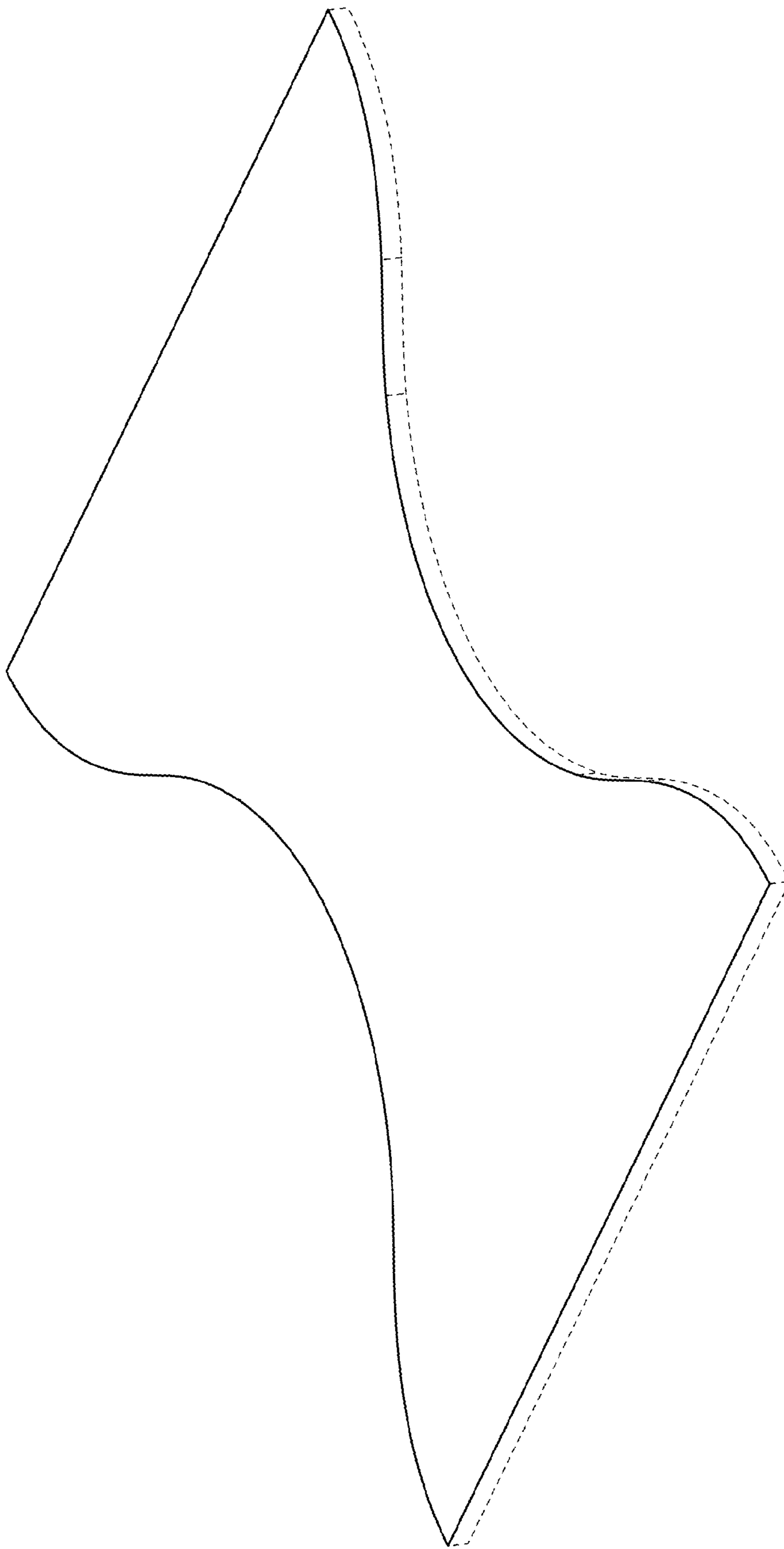

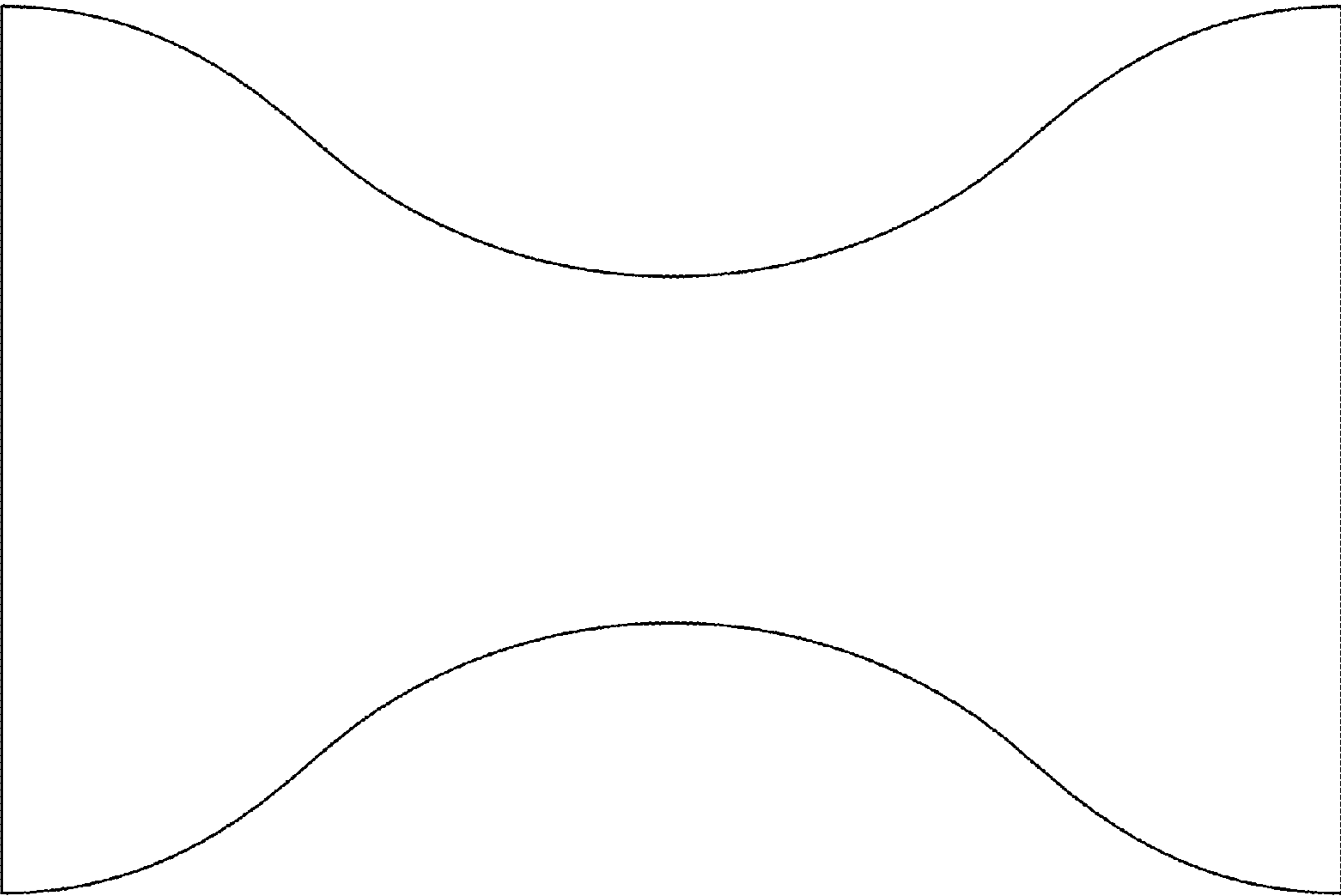

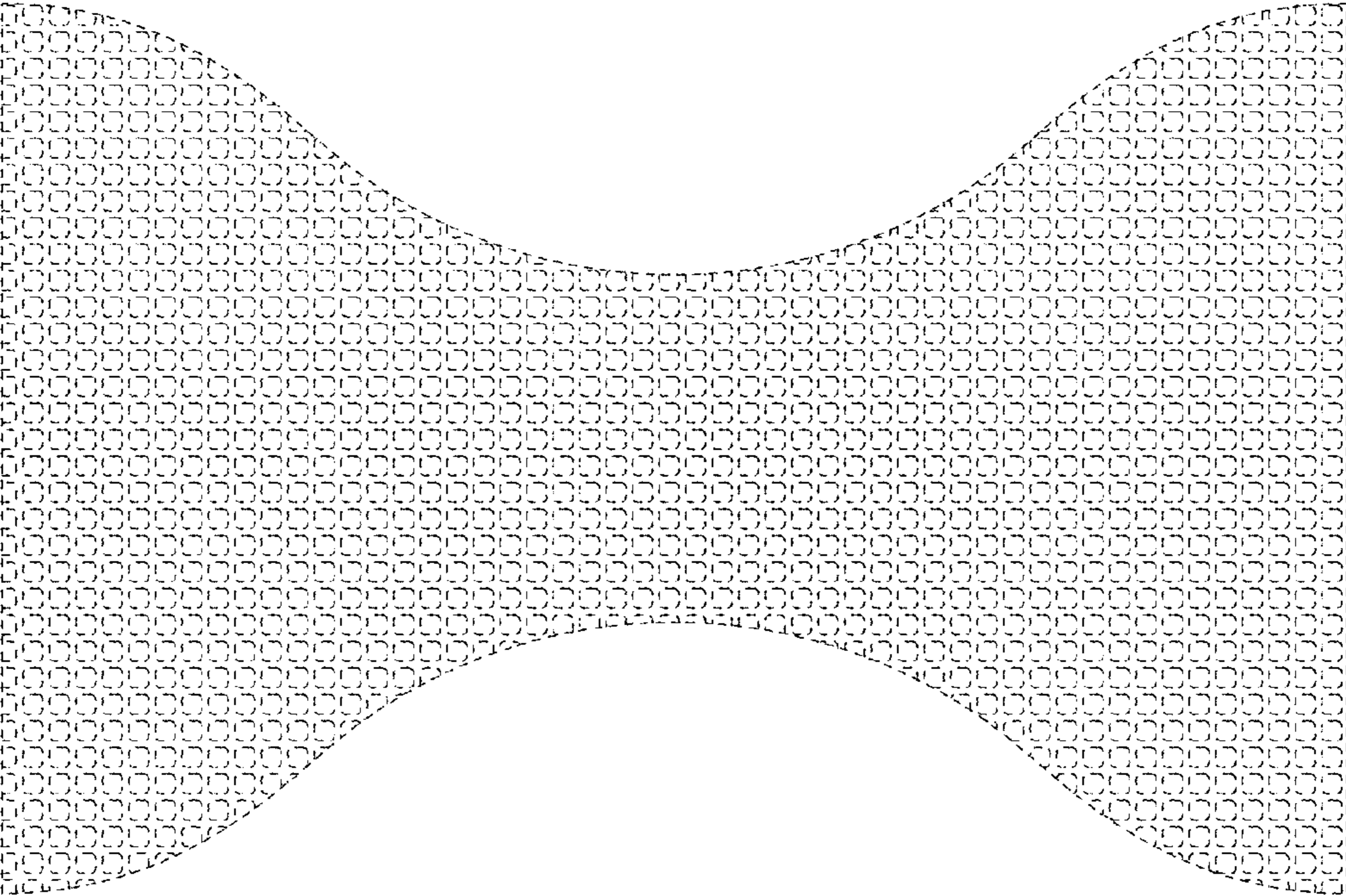

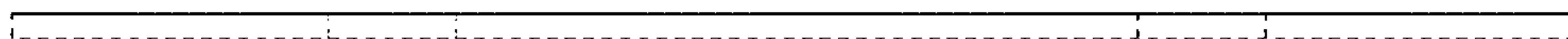

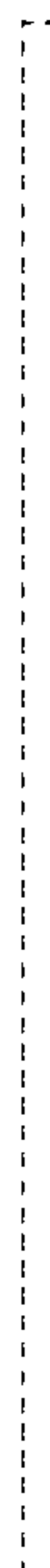
