(57) **CLAIM**

We claim the ornamental design for a handle for home appliance, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a handle for home appliance showing our new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a left-side view thereof; FIG. 5 is a right-side view thereof; FIG. 6 is a top view thereof; FIG. 7 is a bottom thereof; and, FIG. 8 is another front perspective view thereof, in which a home appliance is shown in broken lines to illustrate an example environment. The broken lines in the figures show portions of the handle for home appliance which form no part of the claimed design. The broken lines shown in FIG. 8 are for environmental purposes only and form no part of the claimed design. The dash dot broken lines in the figures represent an unclaimed boundary line and form no part of the claimed design.

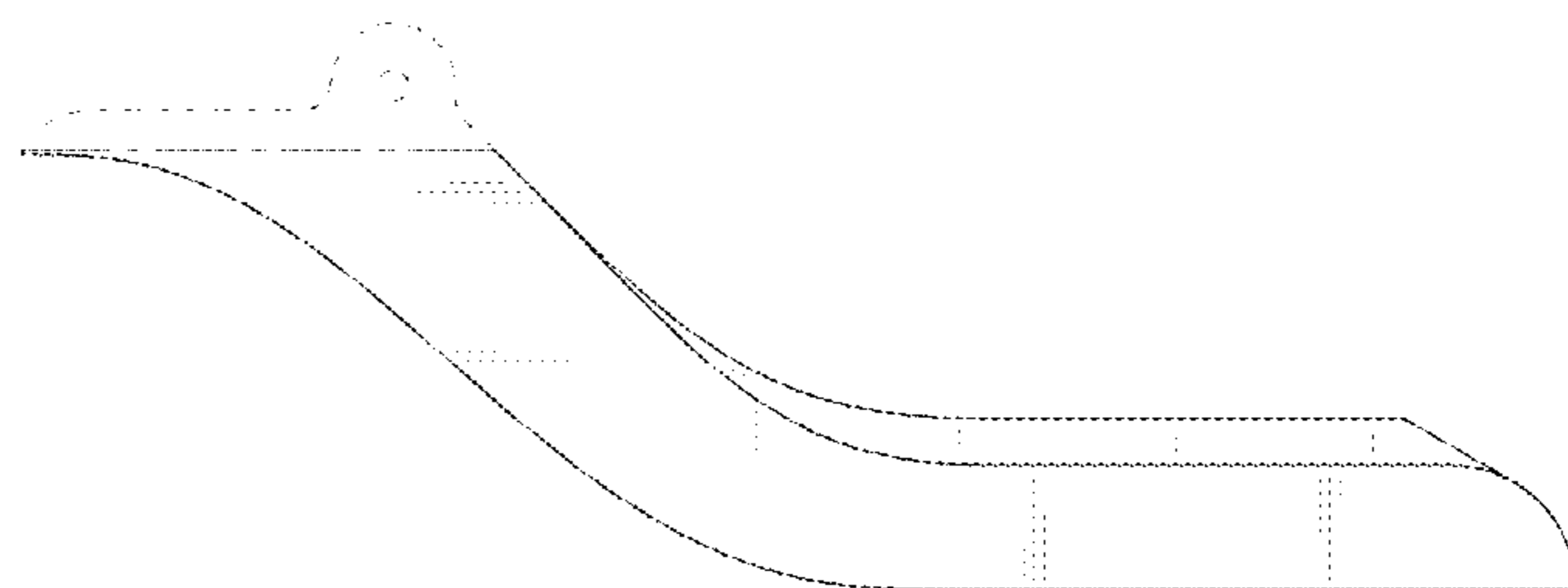
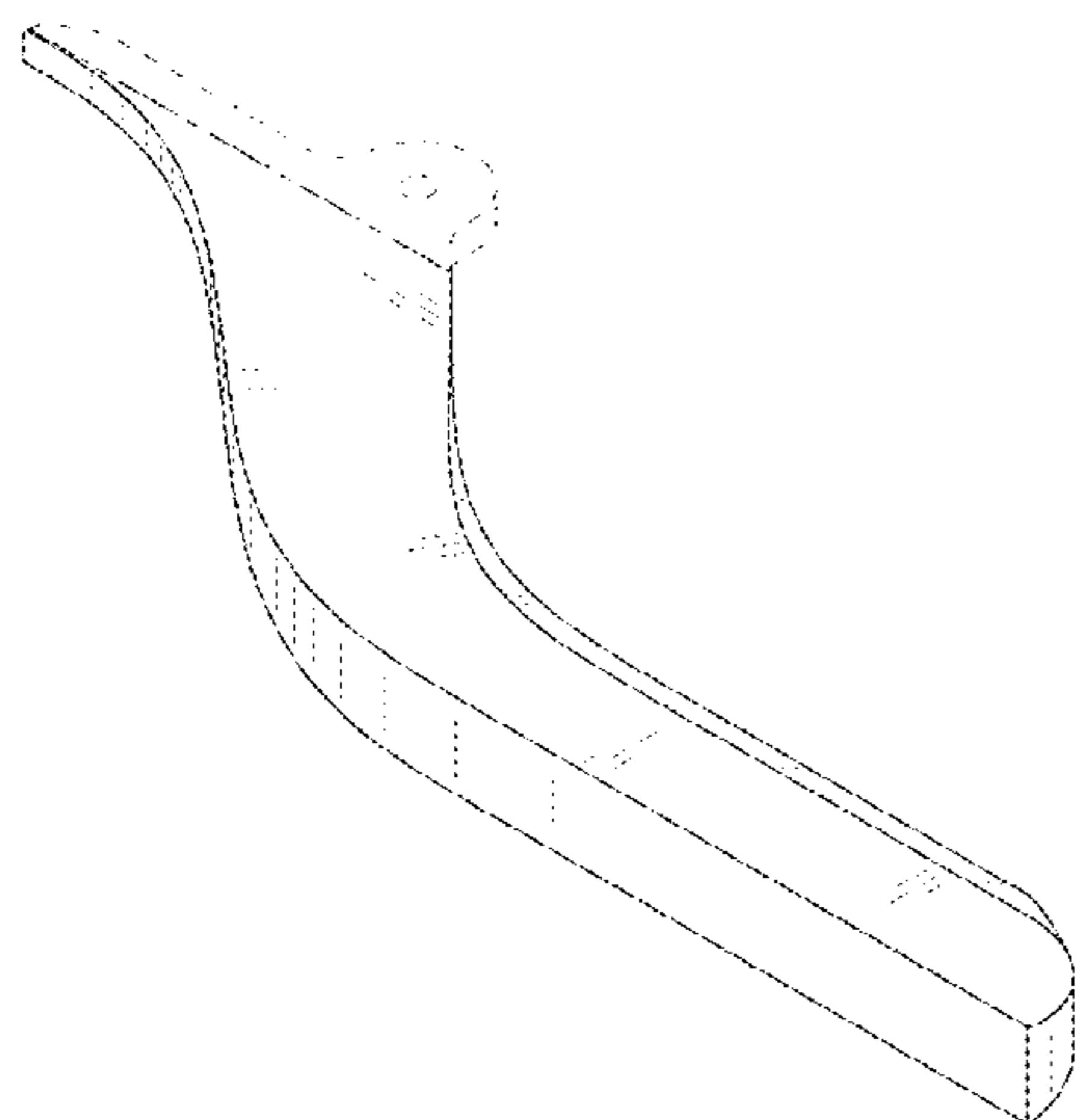

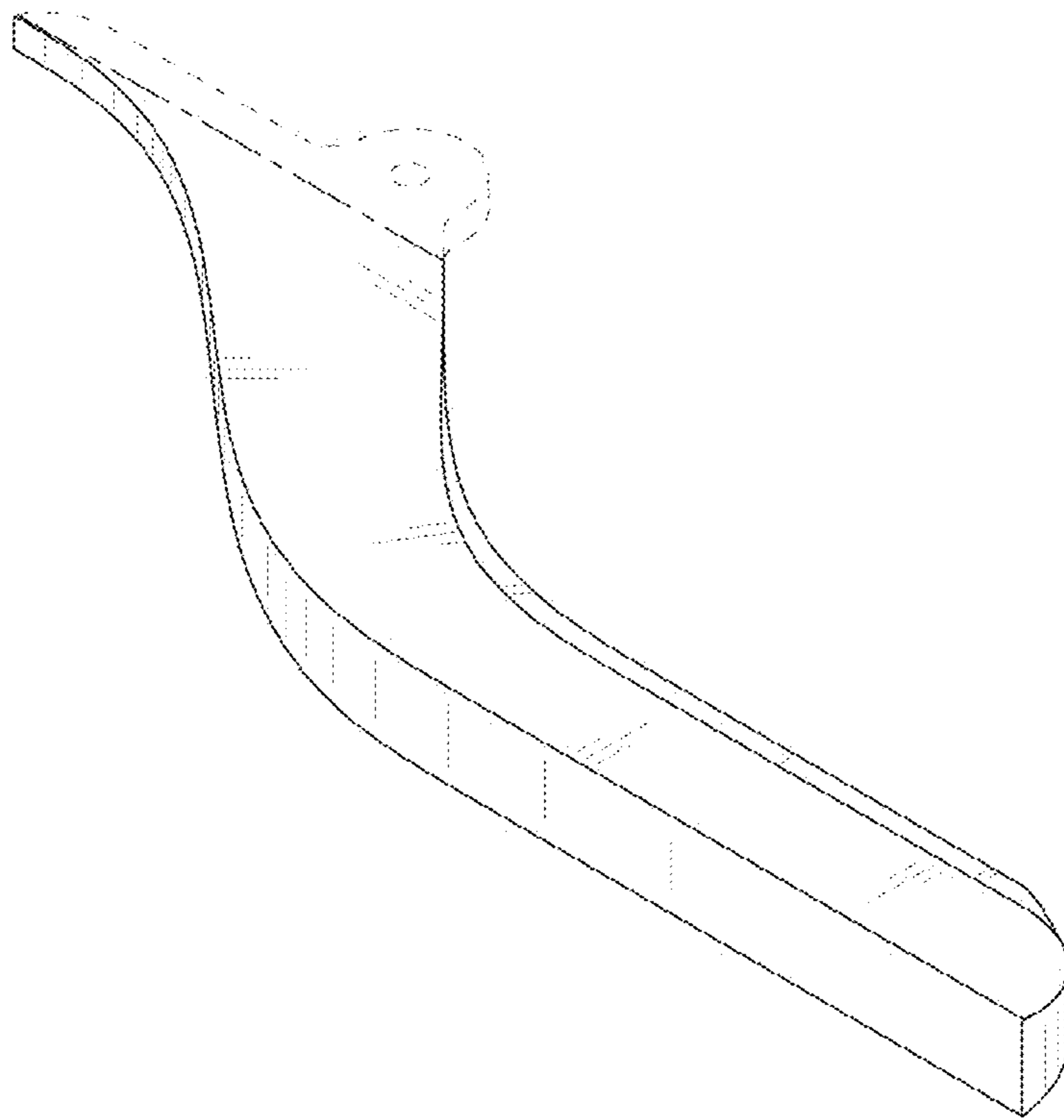

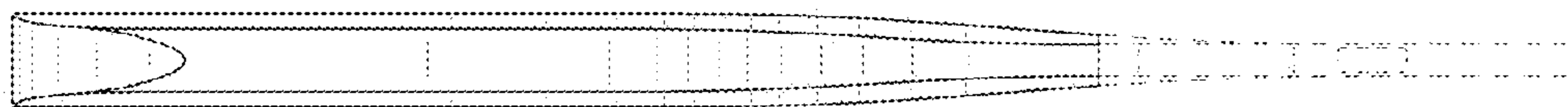

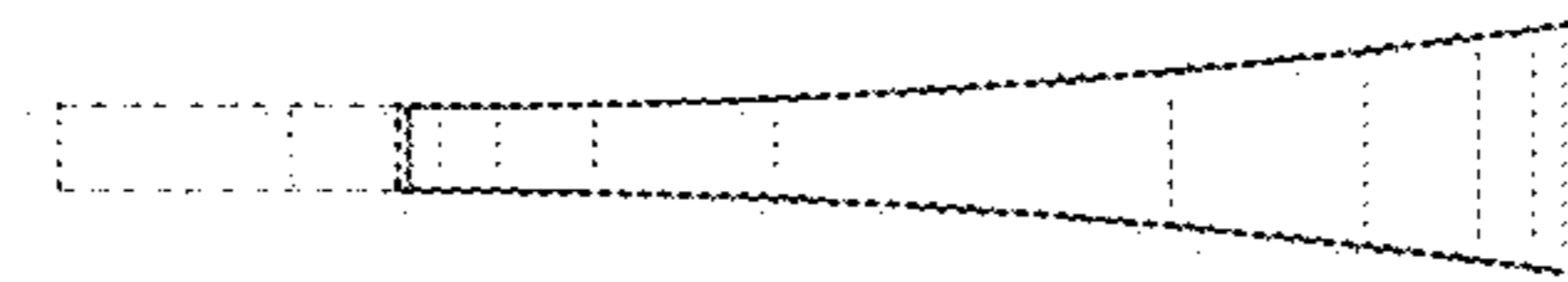

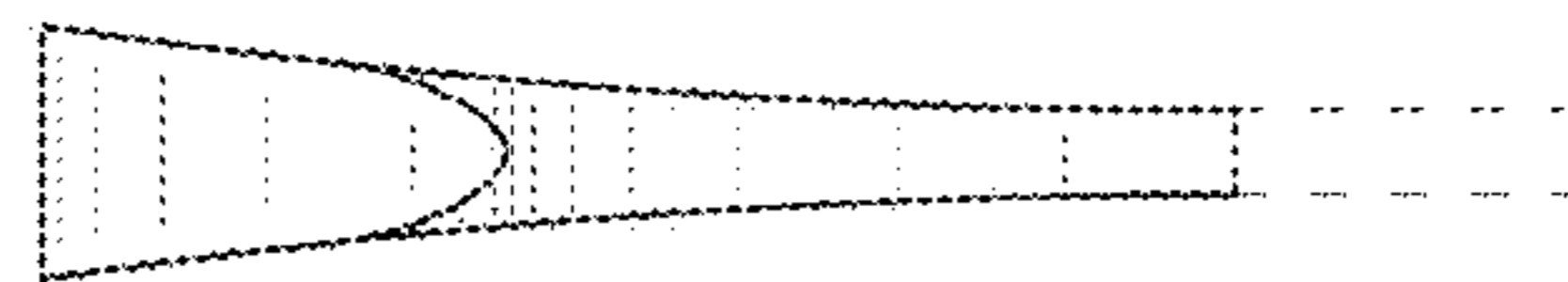

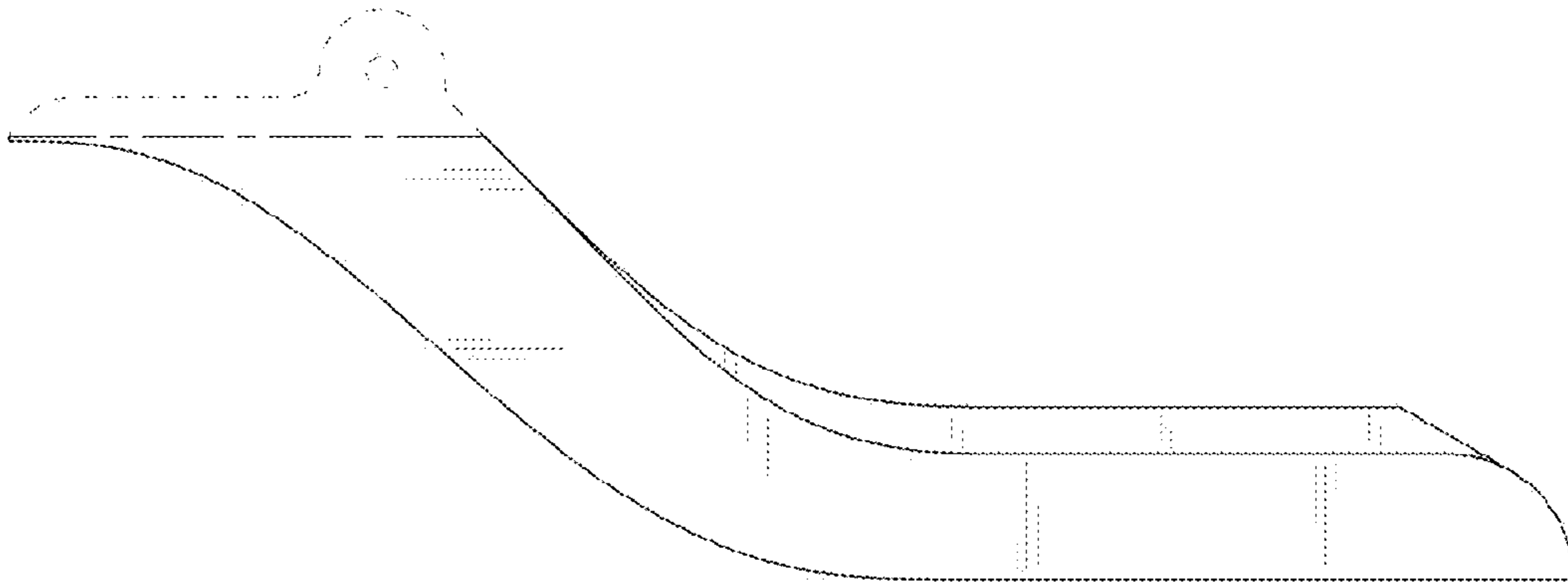

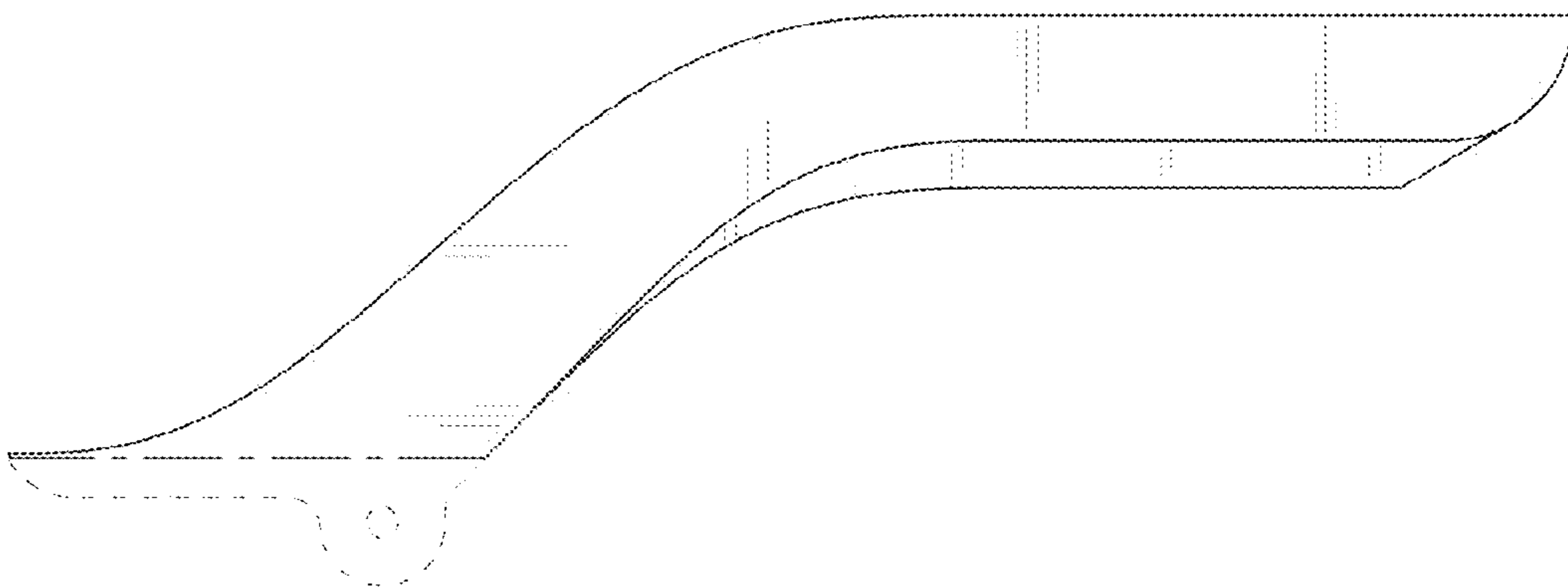
