**DESCRIPTION**

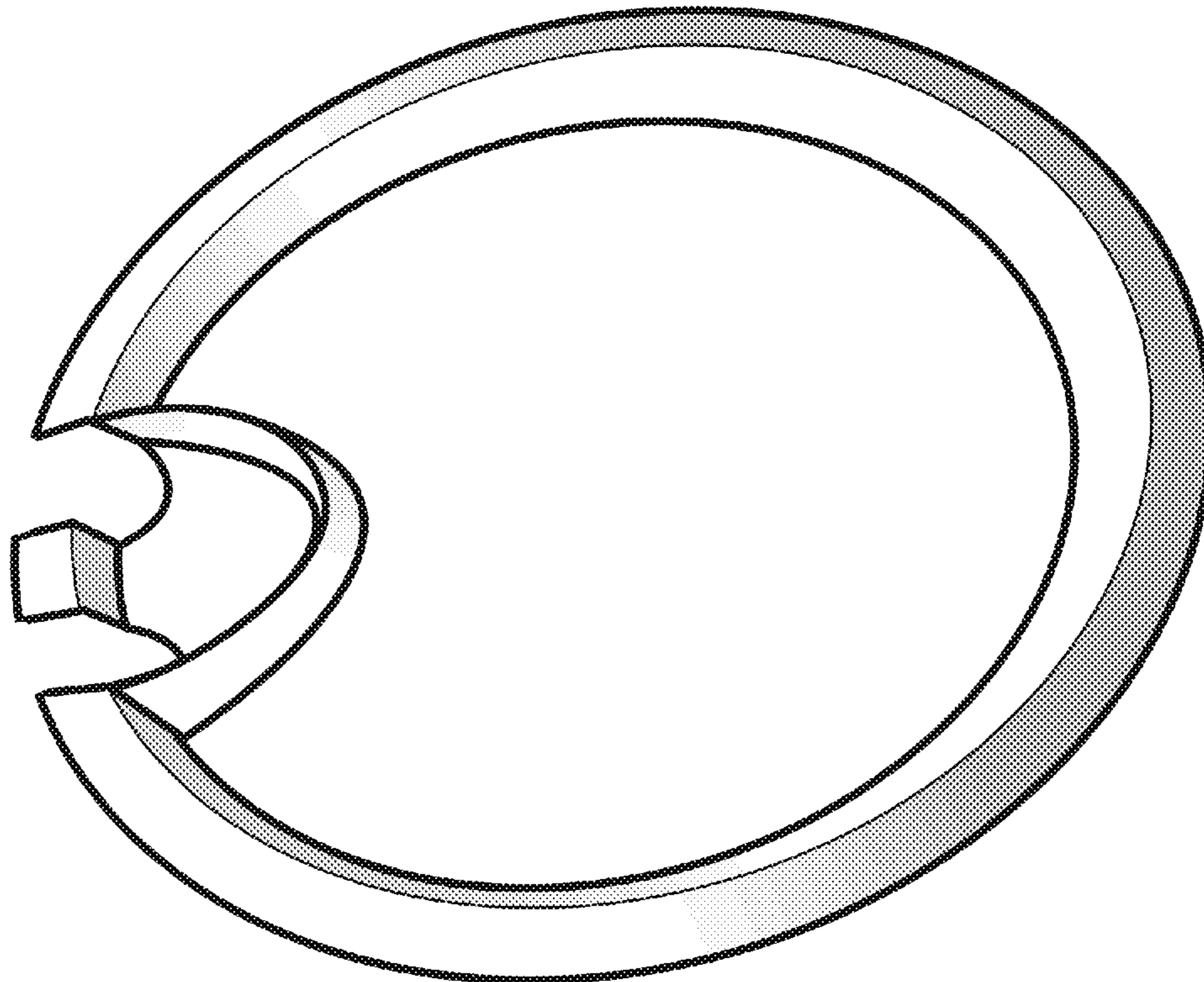
FIG. 1 is a top side isometric view of a food plate of the present invention; and

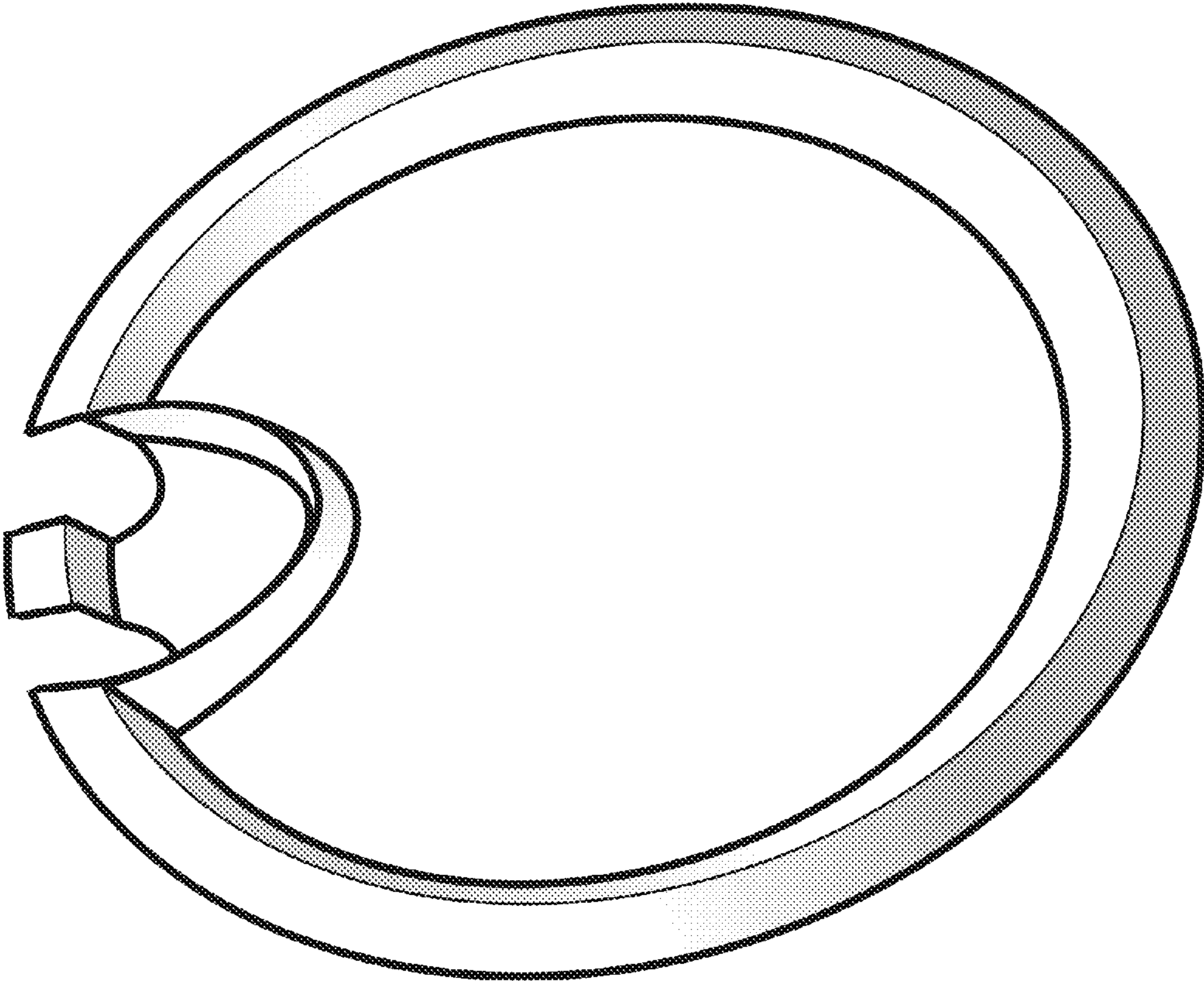

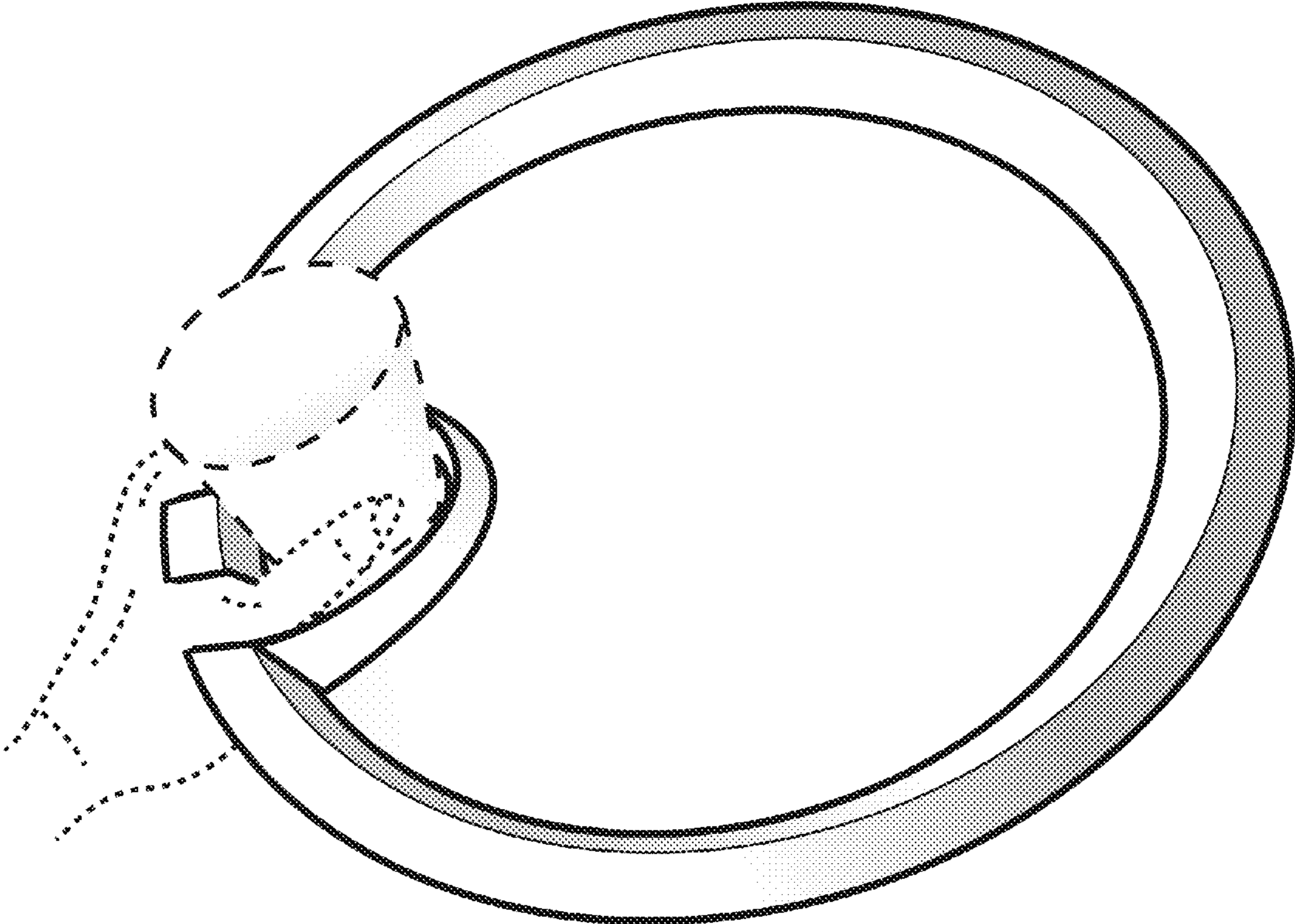

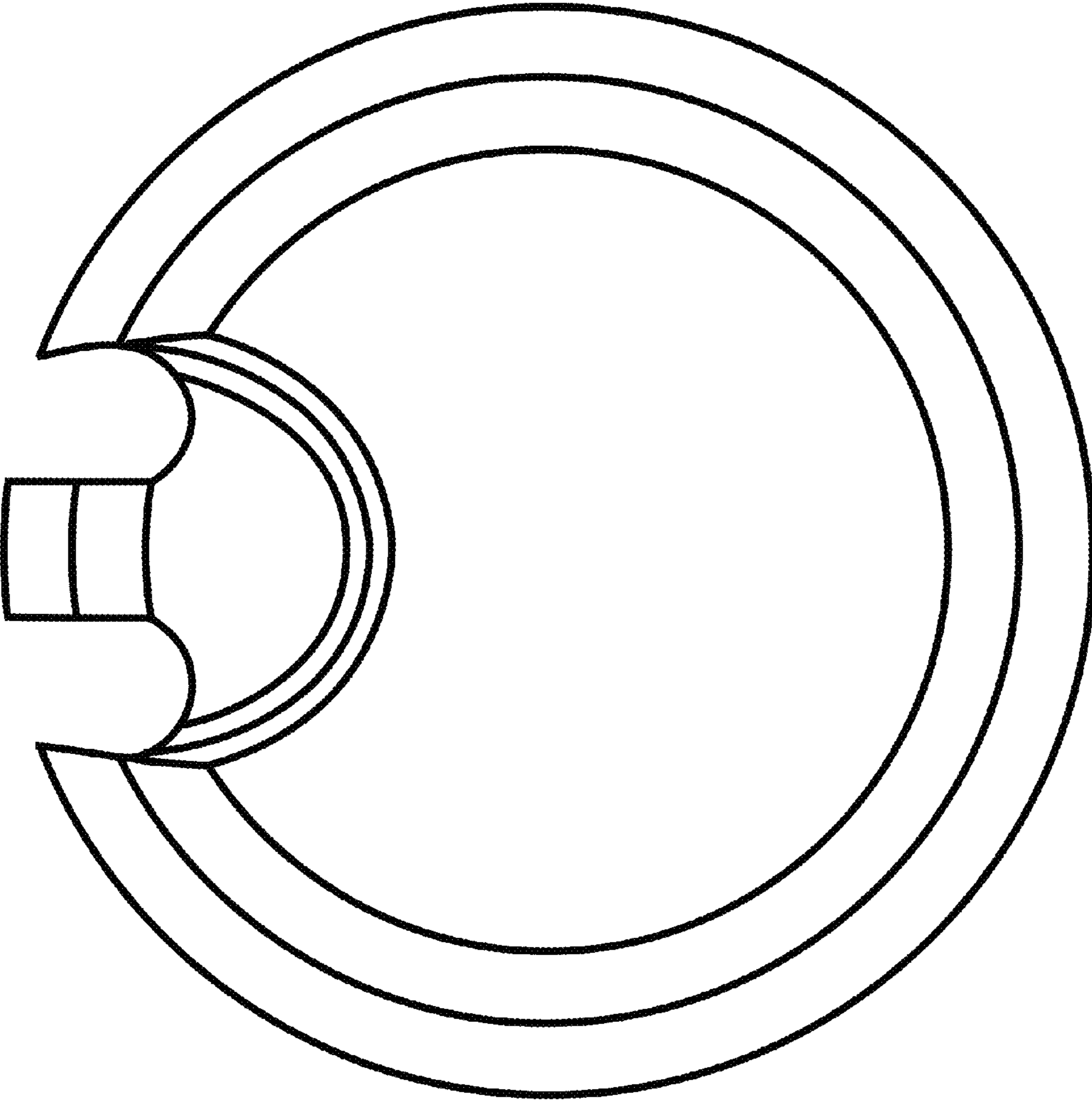
