DESCRIPTION

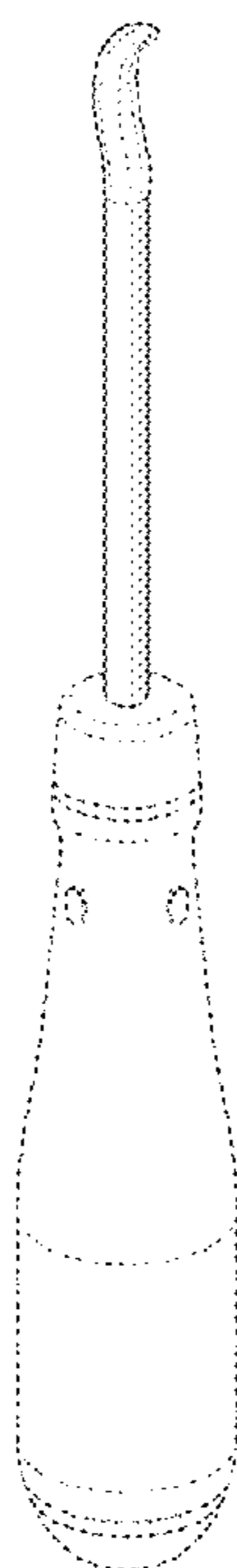
FIG. 1 is a perspective view of a casting flash removal tool showing my new design;

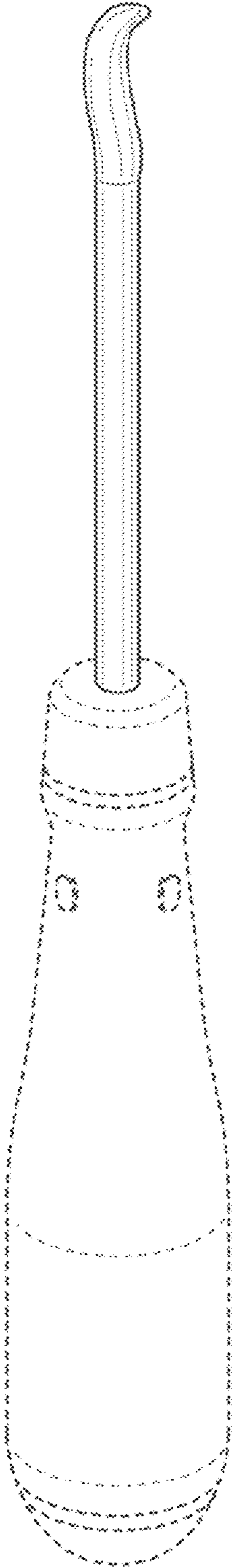

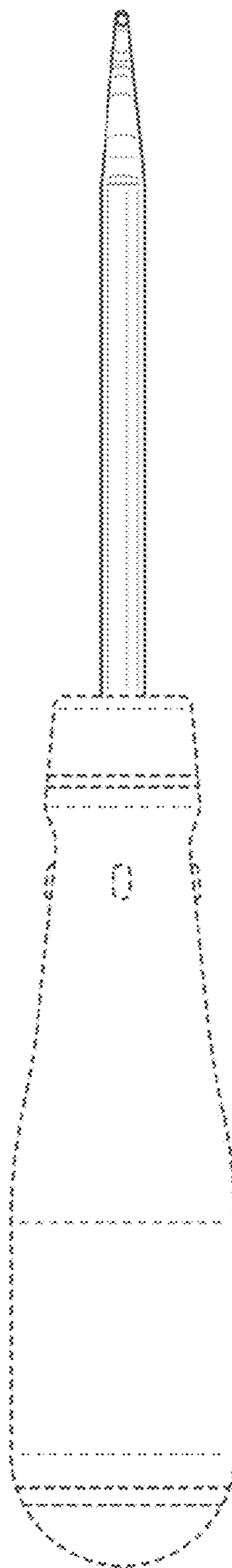

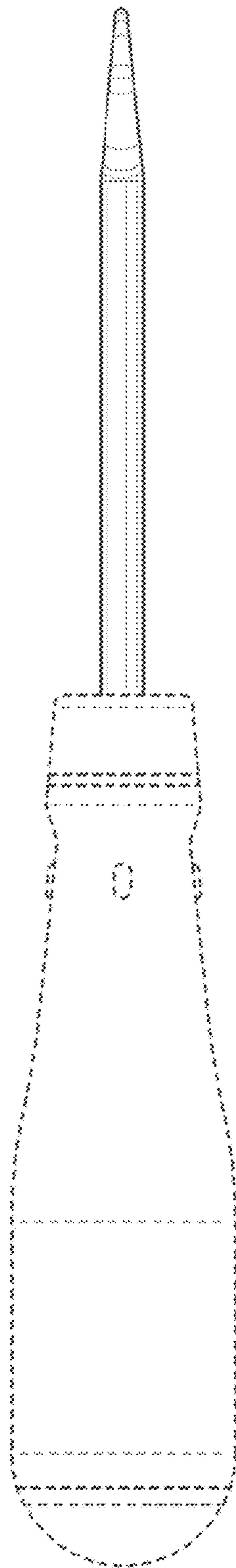

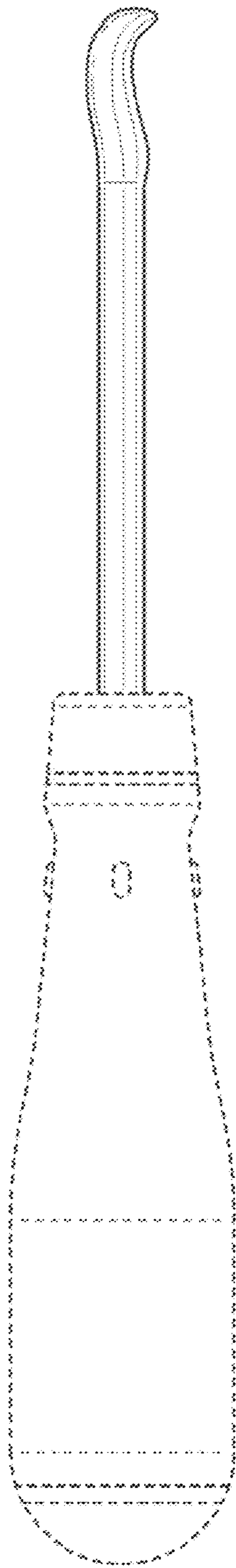

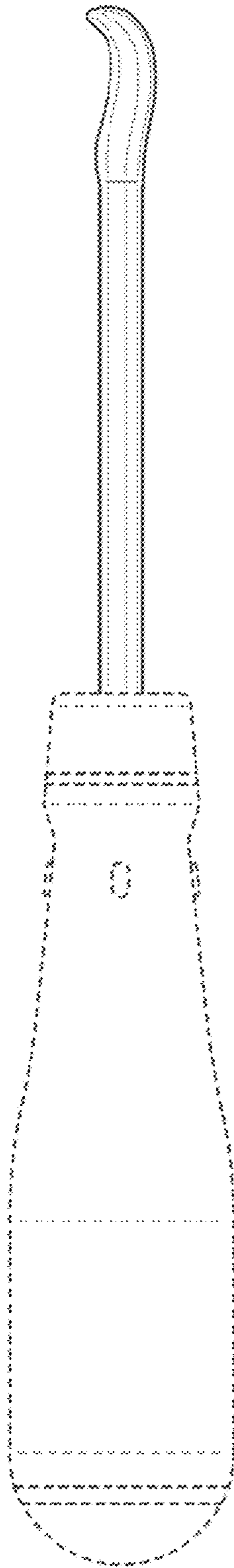

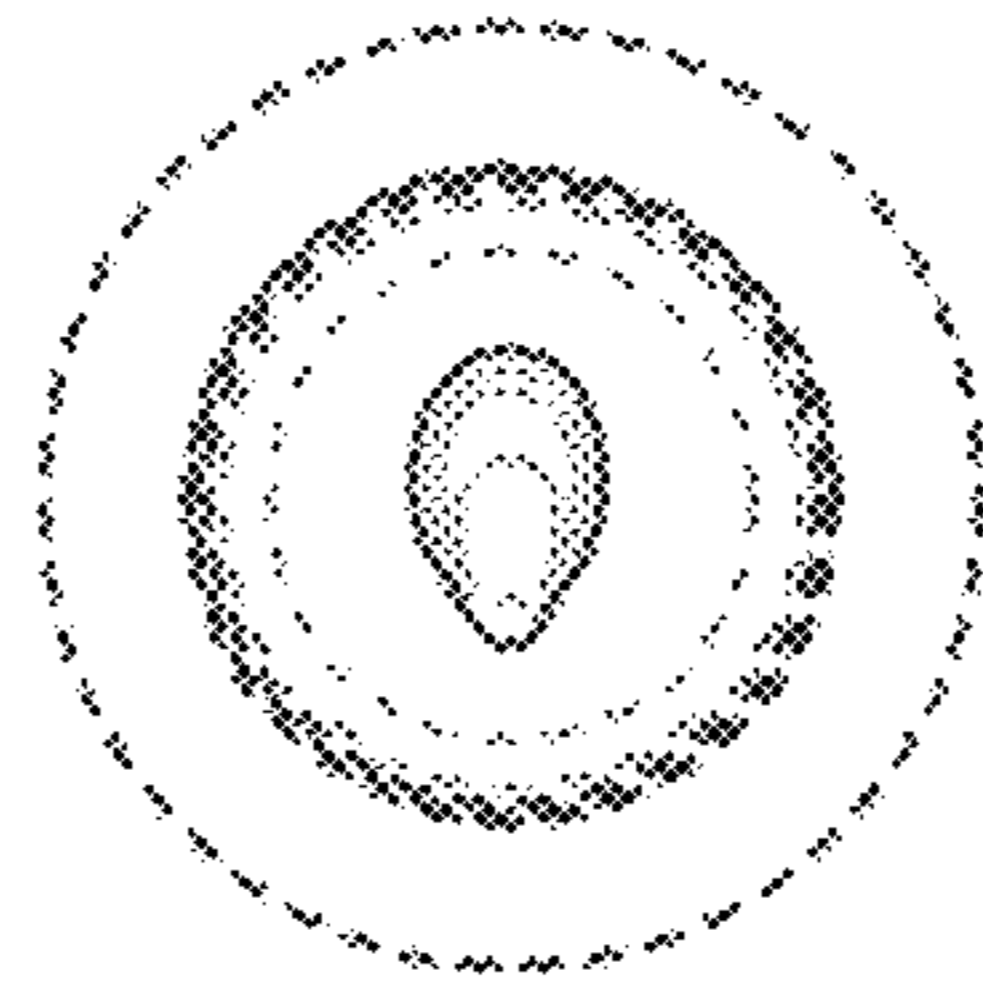

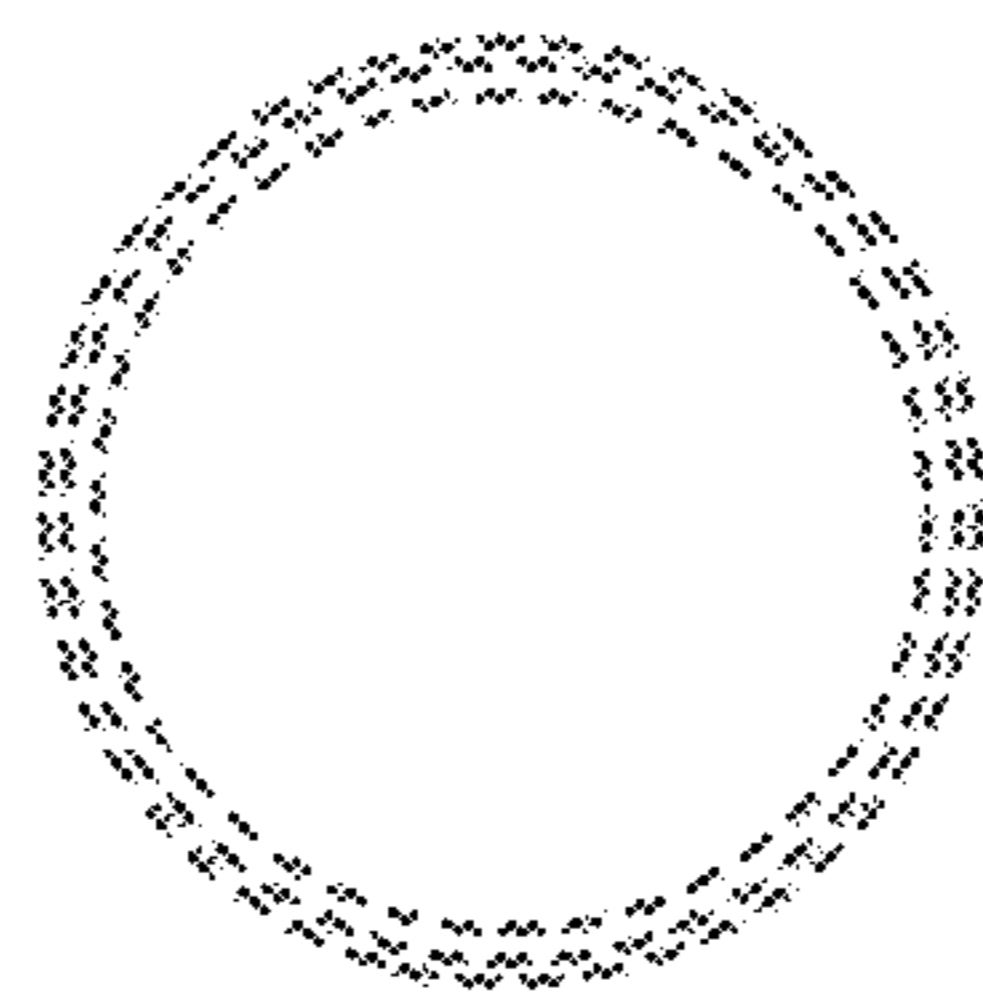
