We claim the ornamental design for set of package windows, as shown and described.

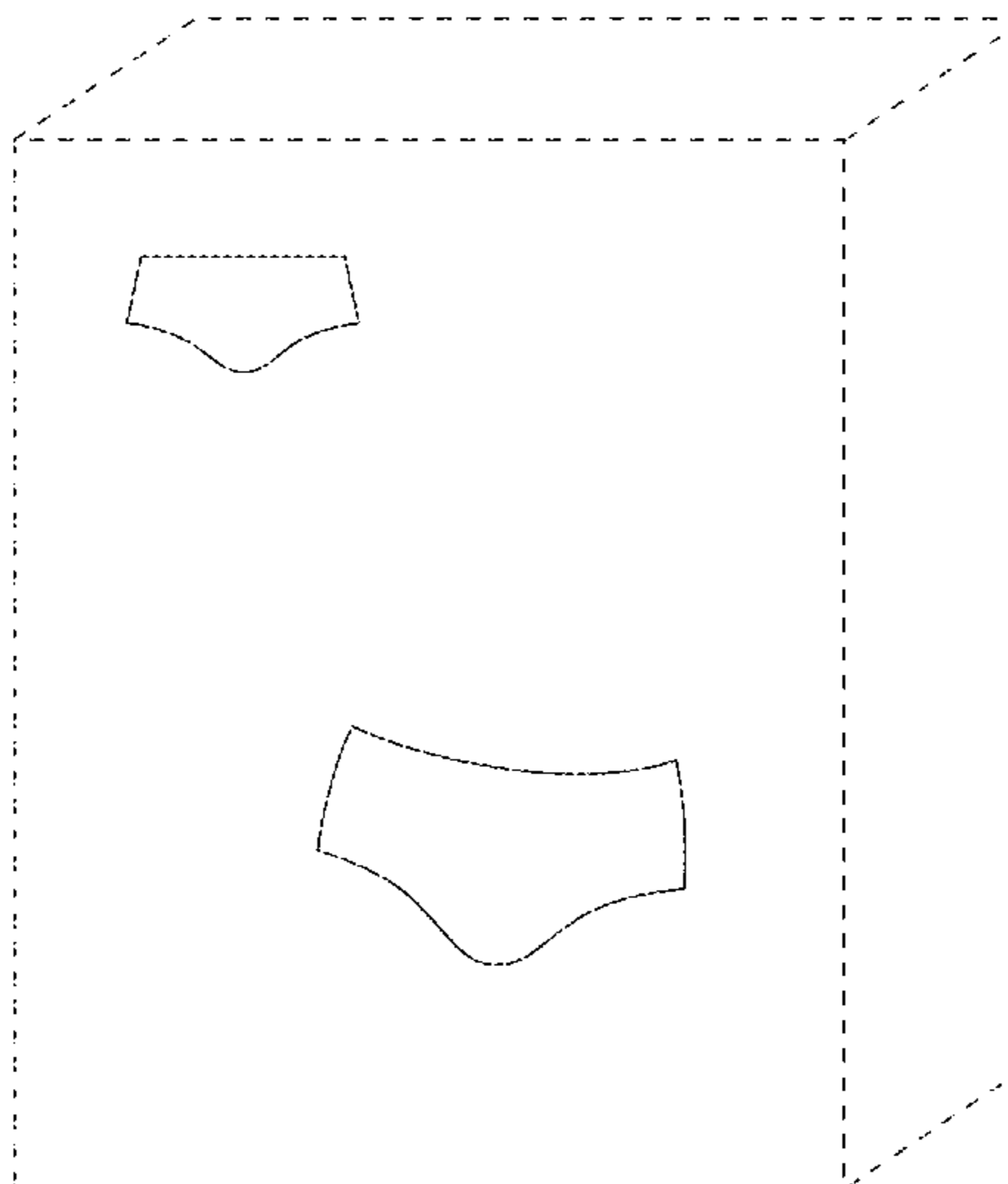
DESCRIPTION

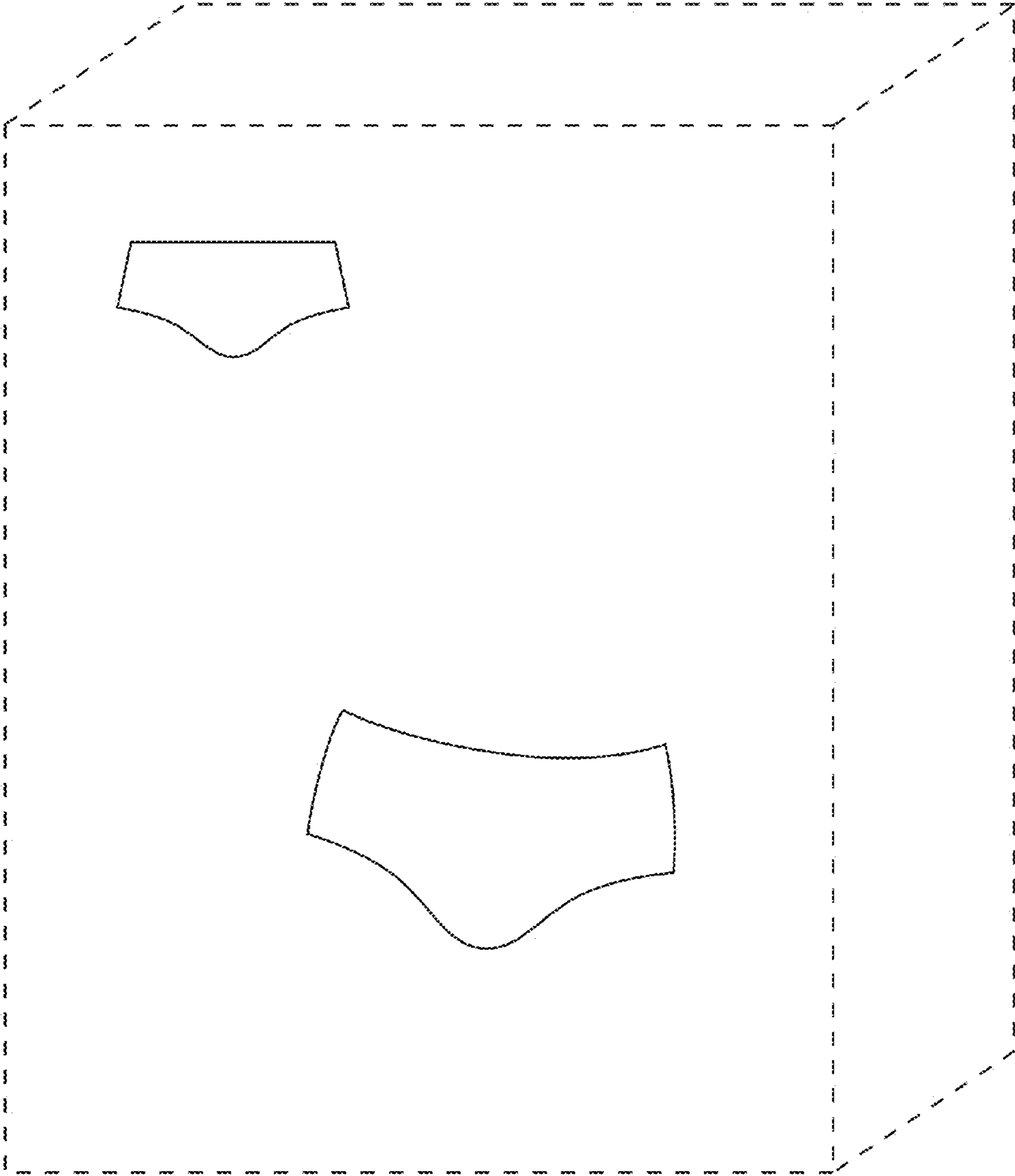

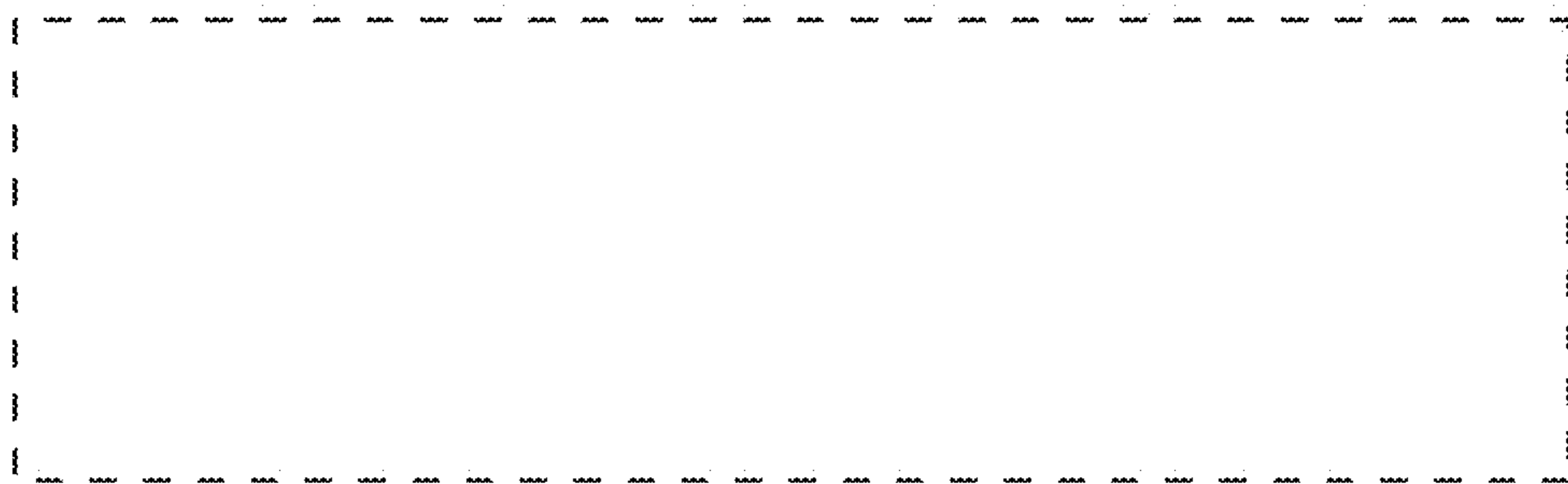

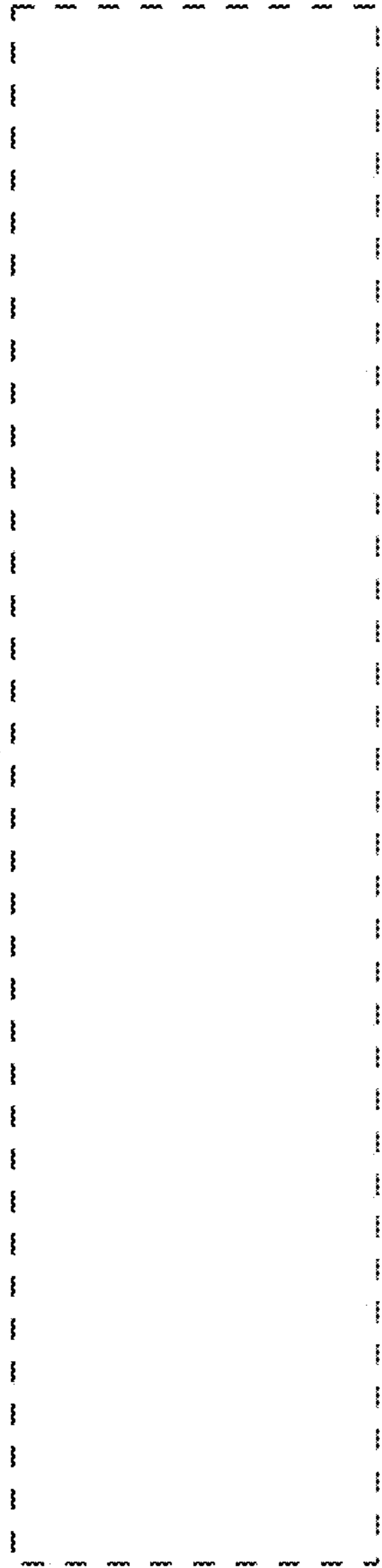

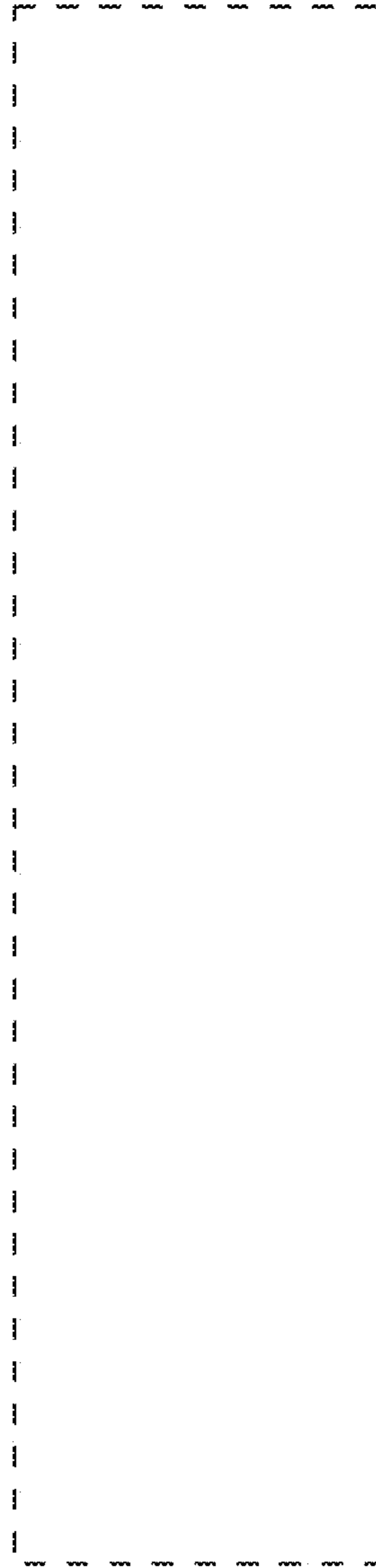

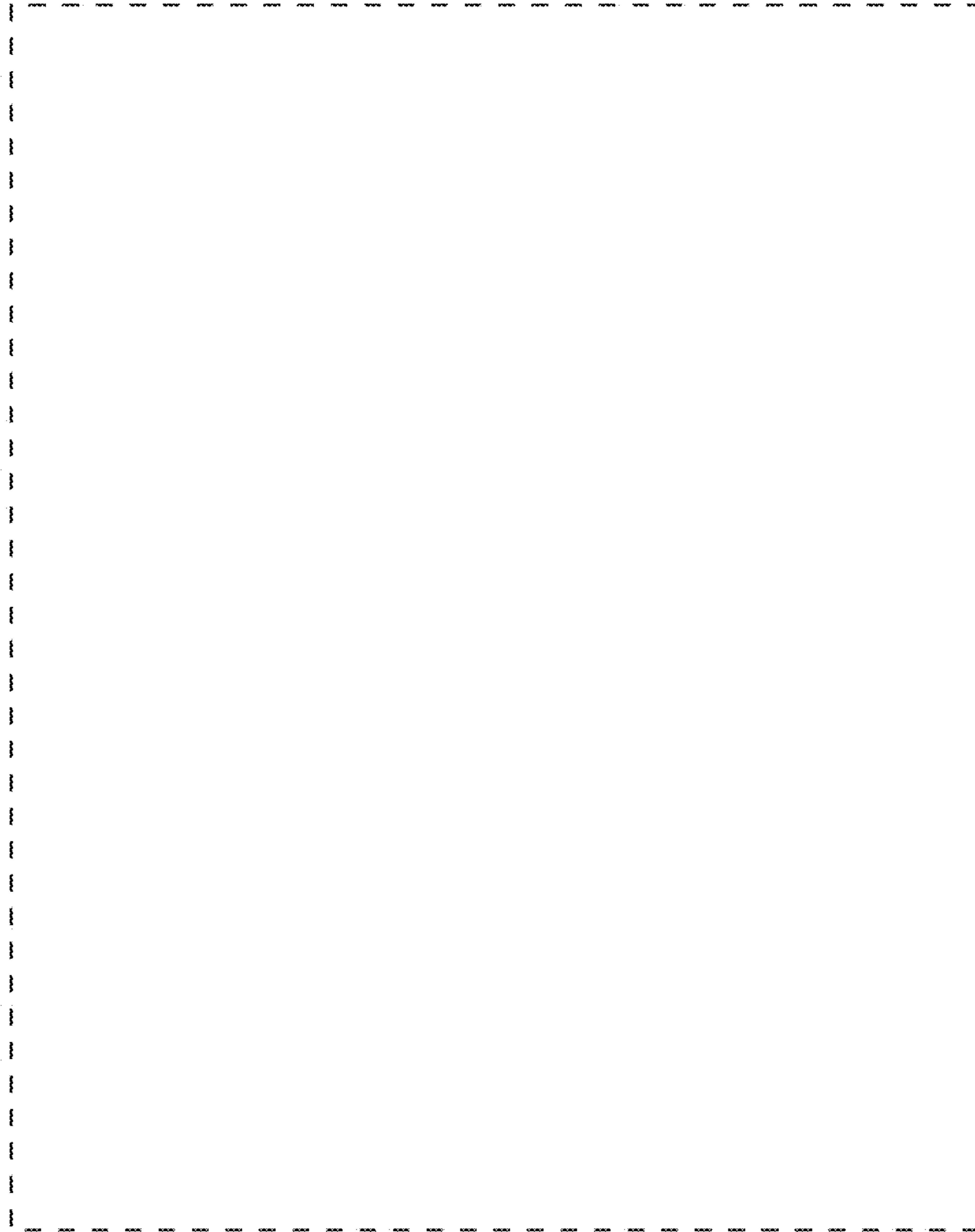
