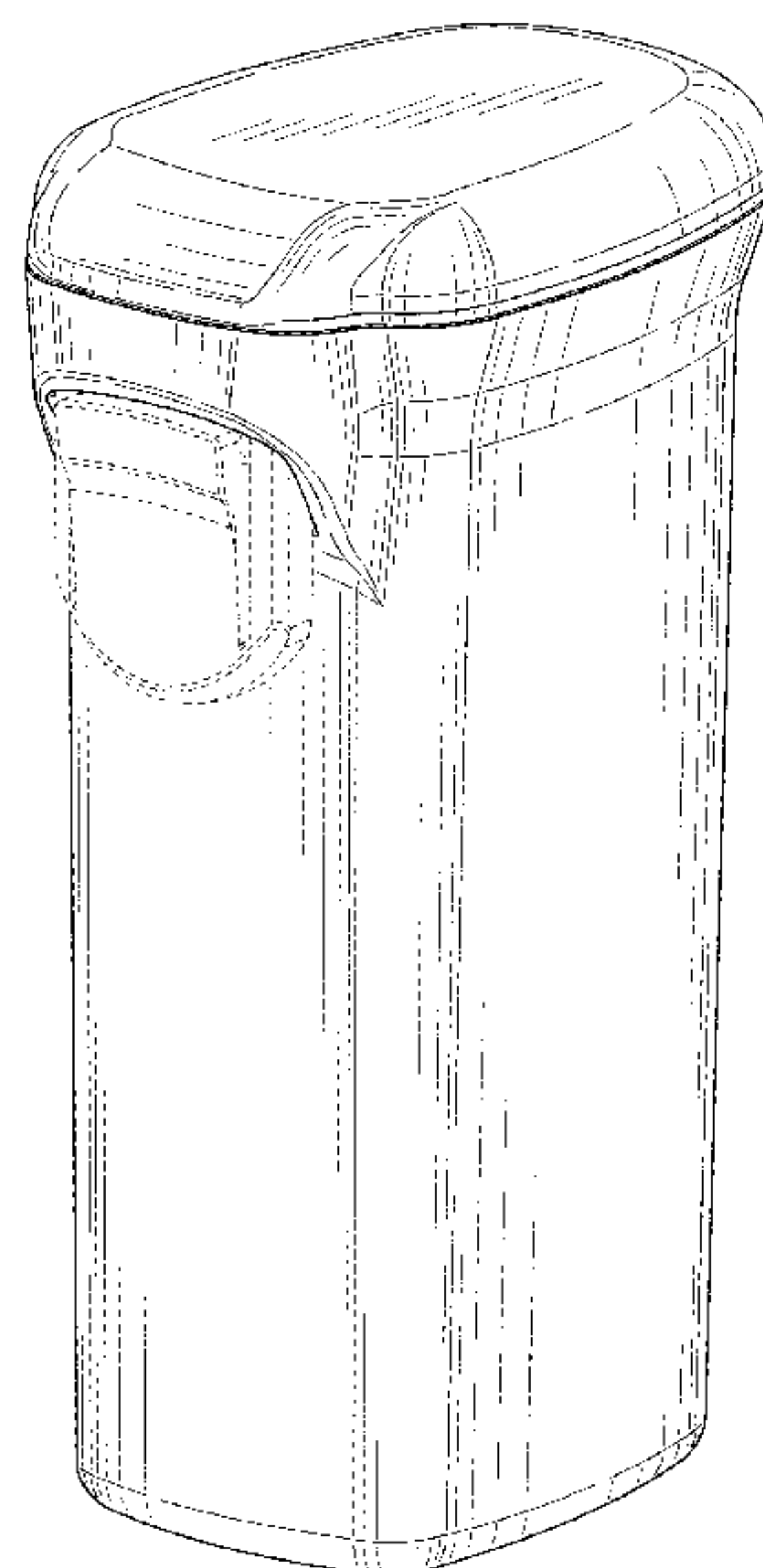
(57) **CLAIM**

The ornamental design for a container with lid, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a container with lid, in accordance with a closed condition.
FIG. 2 is a front view of the container with lid of FIG. 1.
FIG. 3 is a rear view of the container with lid of FIG. 1.
FIG. 4 is a right side view of the container with lid of FIG. 1.
FIG. 5 is a left side view of the container with lid of FIG. 1.
FIG. 6 is a top view of the container with lid of FIG. 1; and, FIG. 7 is a bottom view of the container with lid of FIG. 1.
The dash-dash broken lines shown are included for the purpose of illustrating portions of the combined container and lid that form no part of the claimed design.

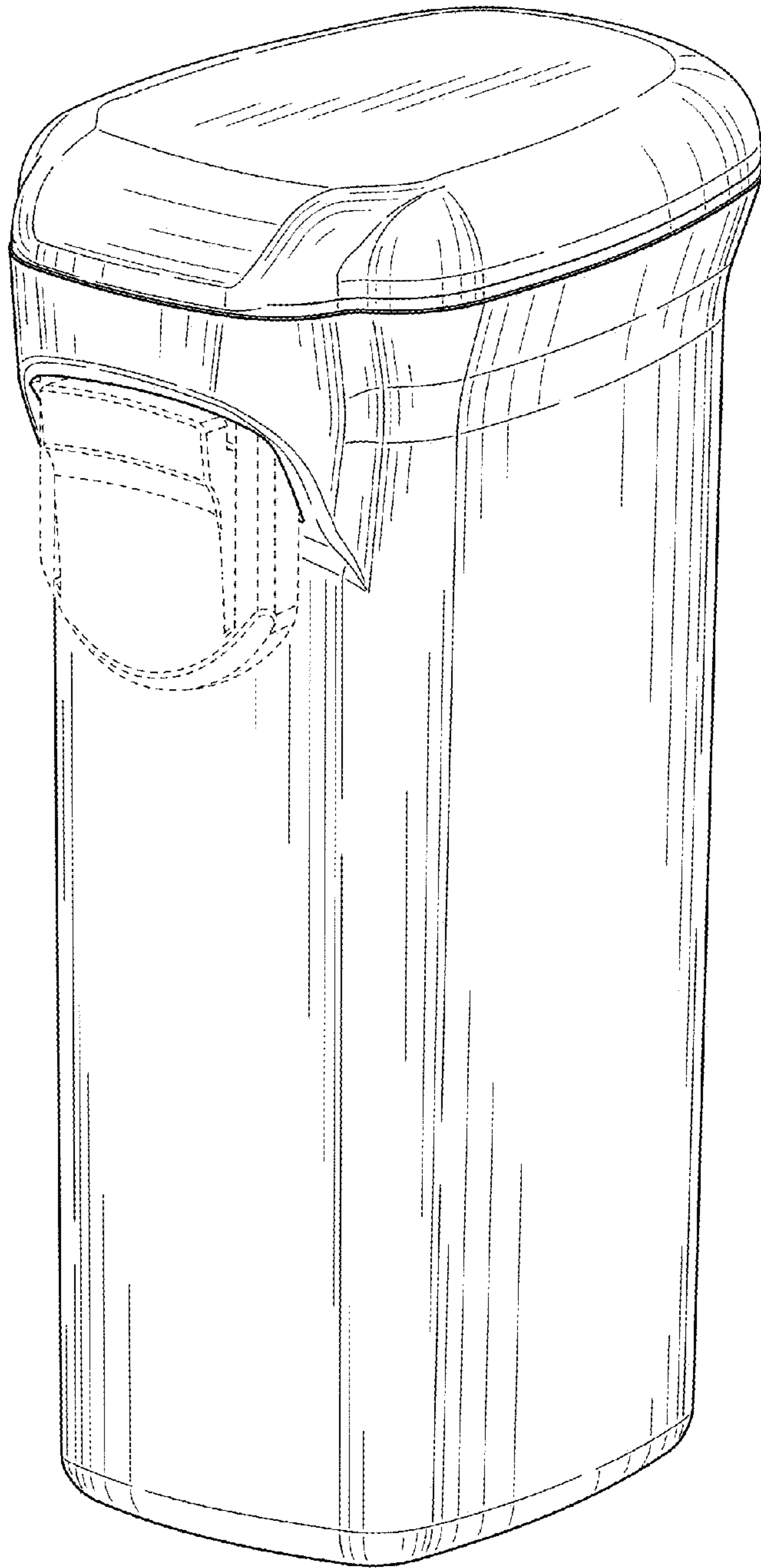

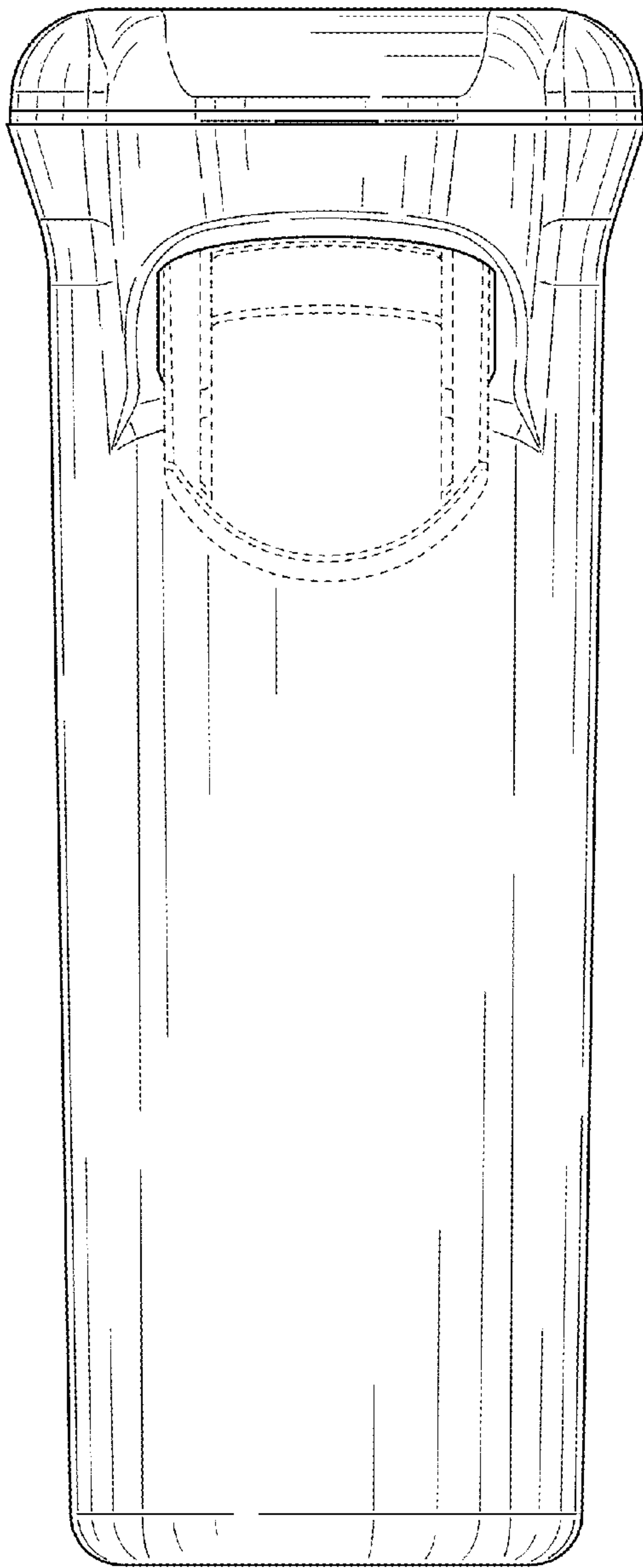

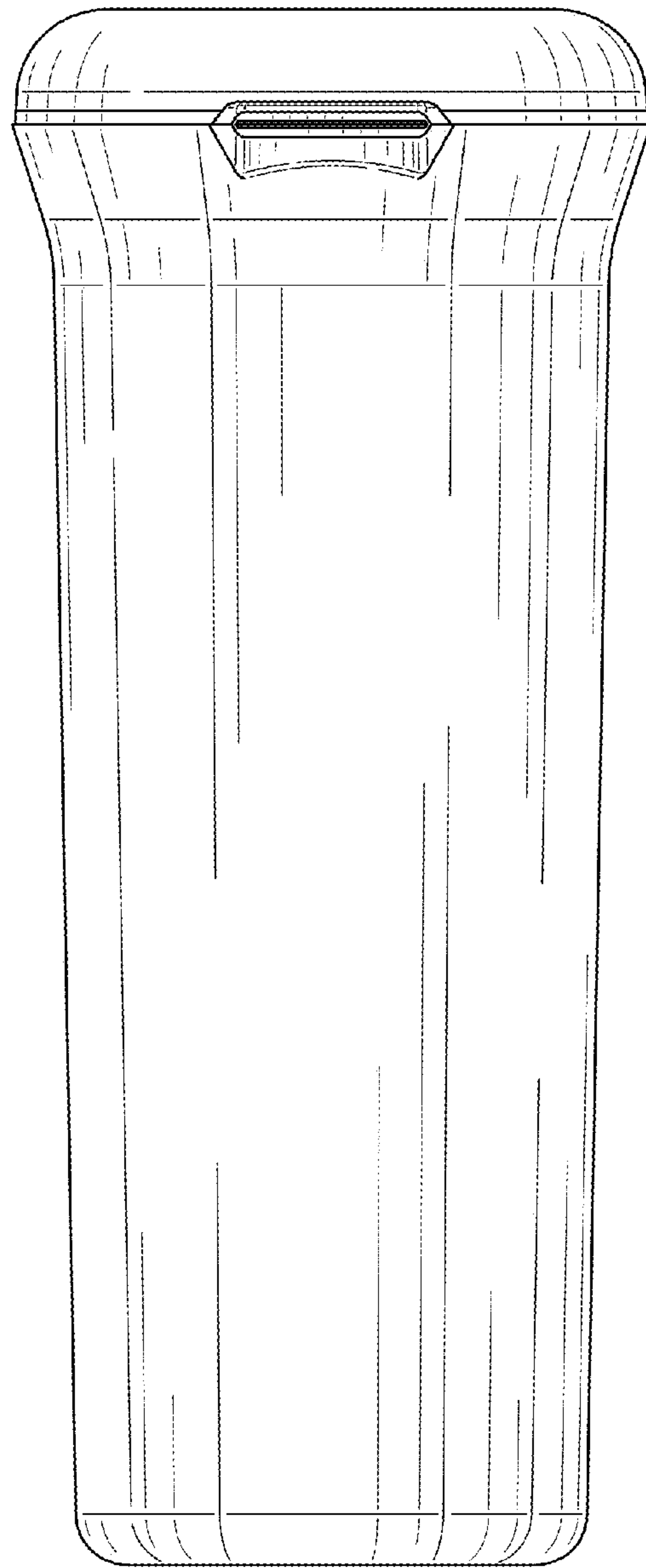

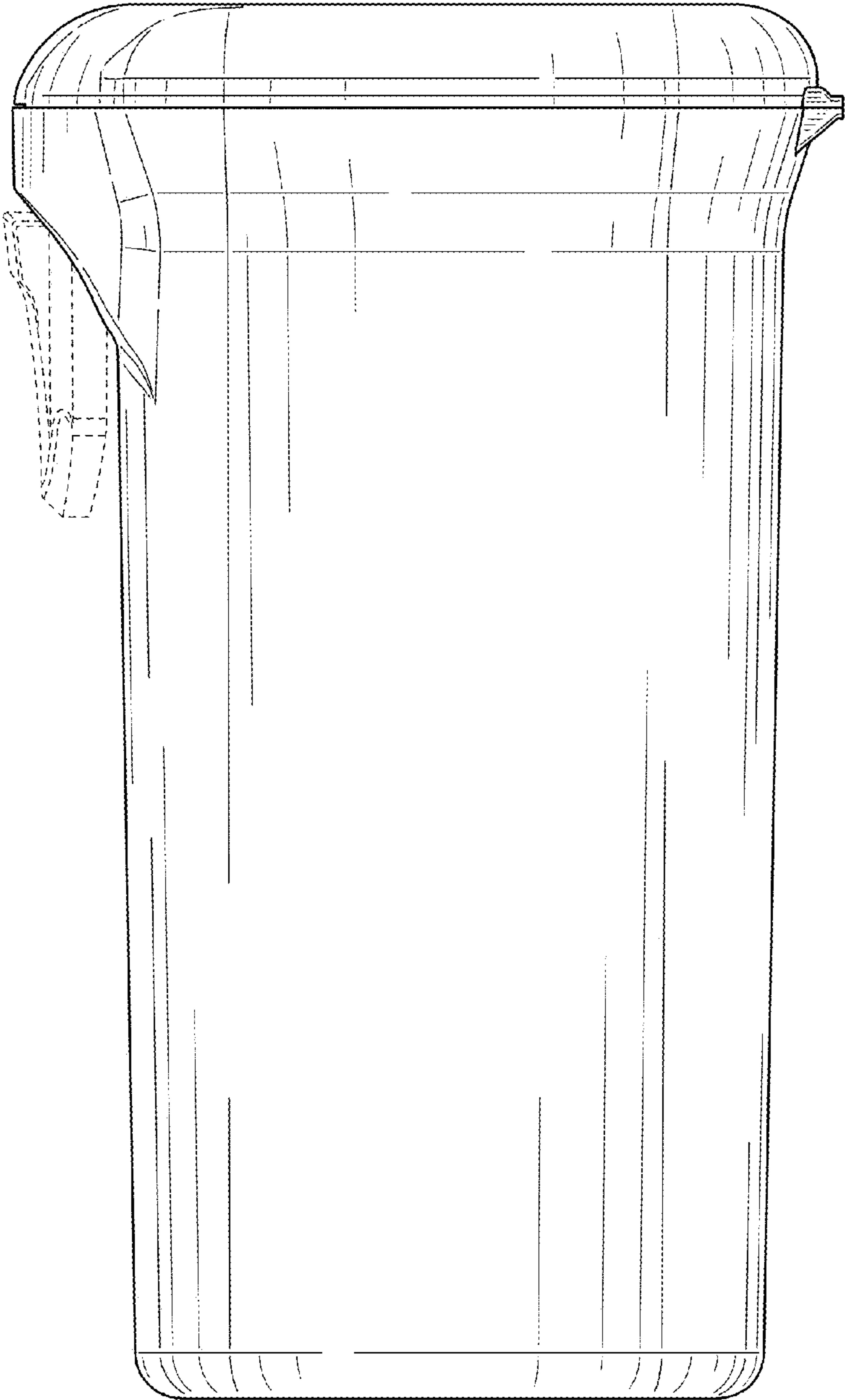

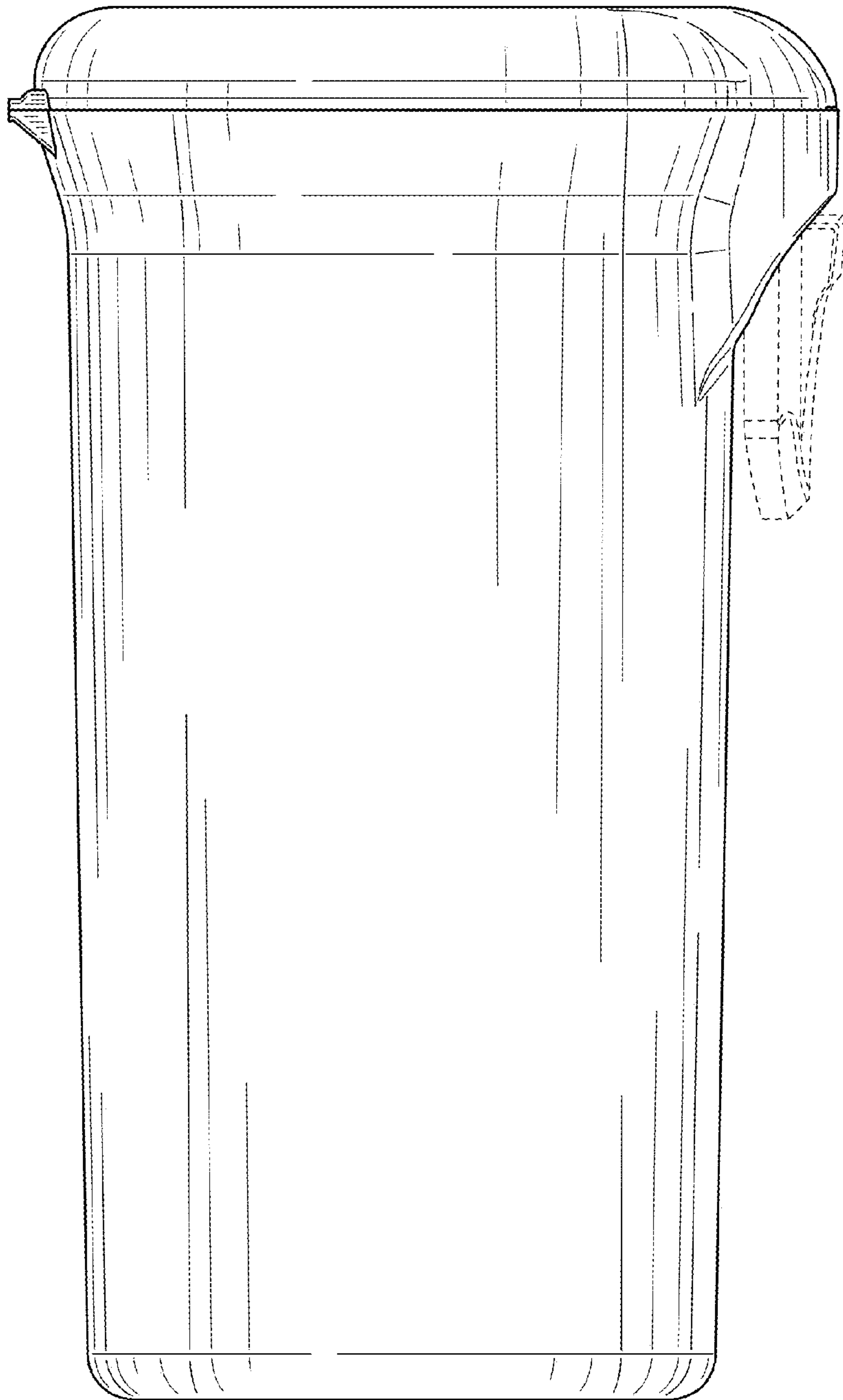

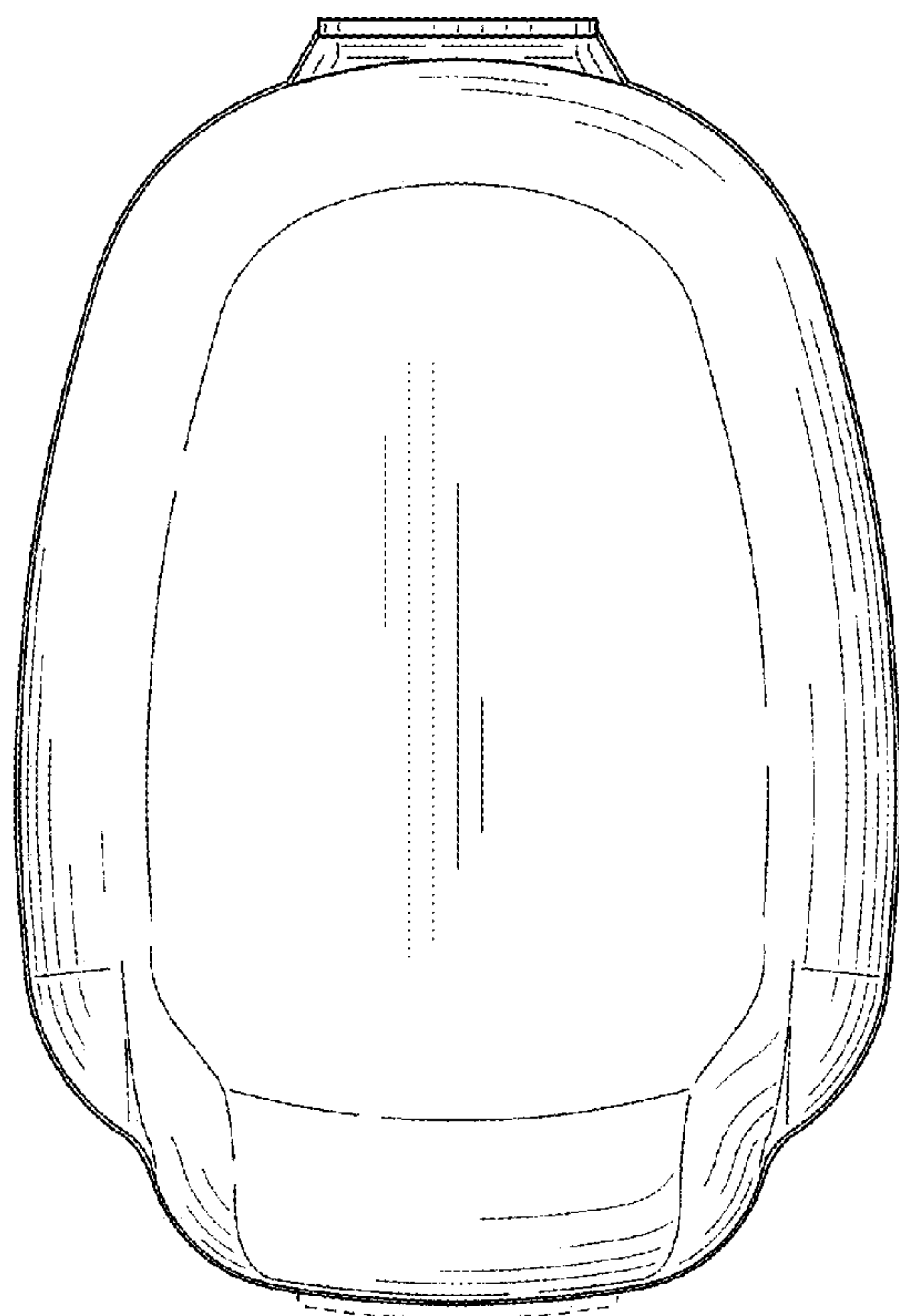

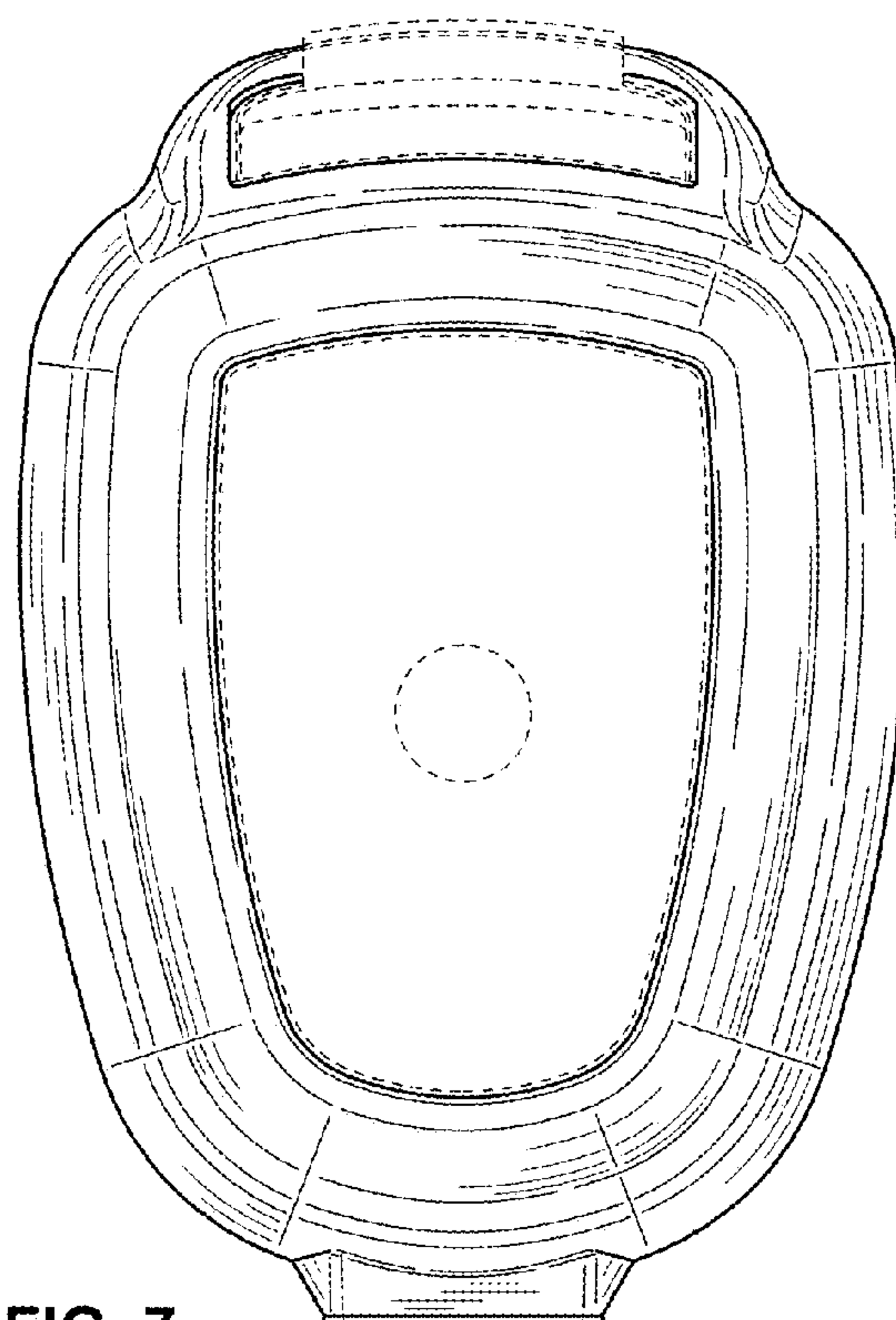
