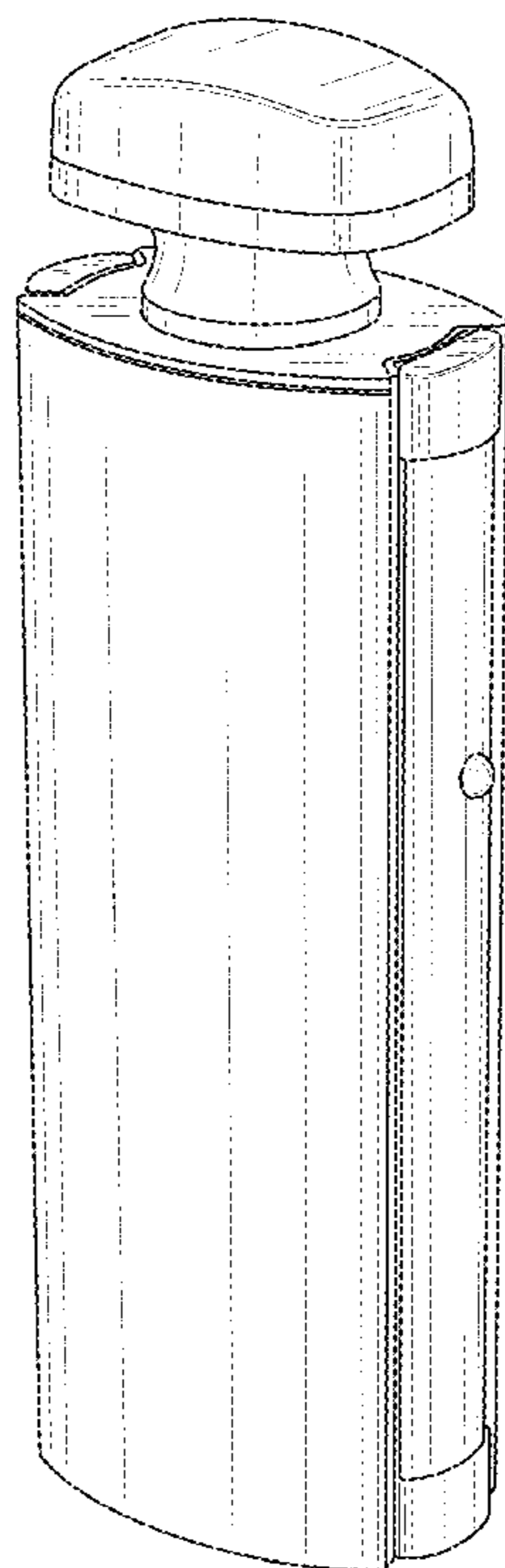
(57) **CLAIM**

The ornamental design for a perfume bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a perfume bottle, showing my new design;
FIG. 2 is a front elevational view thereof, and the rear elevational view being a mirror image thereof;
FIG. 3 is a right side elevational view thereof, and the left side elevational view being a mirror image thereof;
FIG. 4 is a top plan view thereof; and,
FIG. 5 is a bottom plan view thereof.

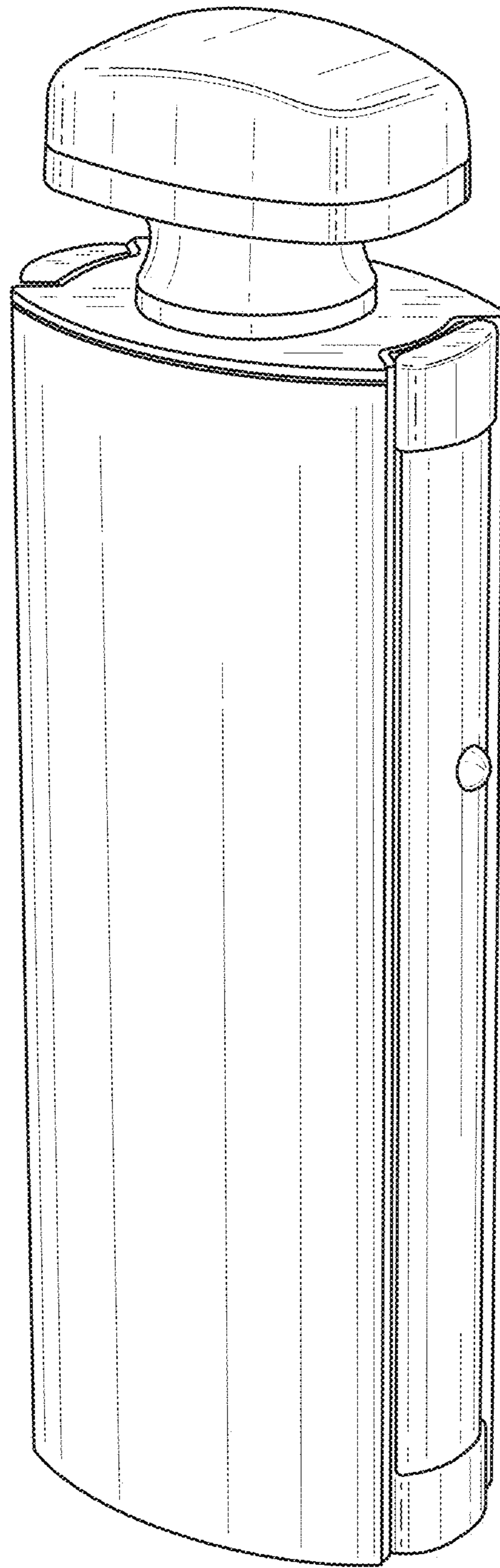

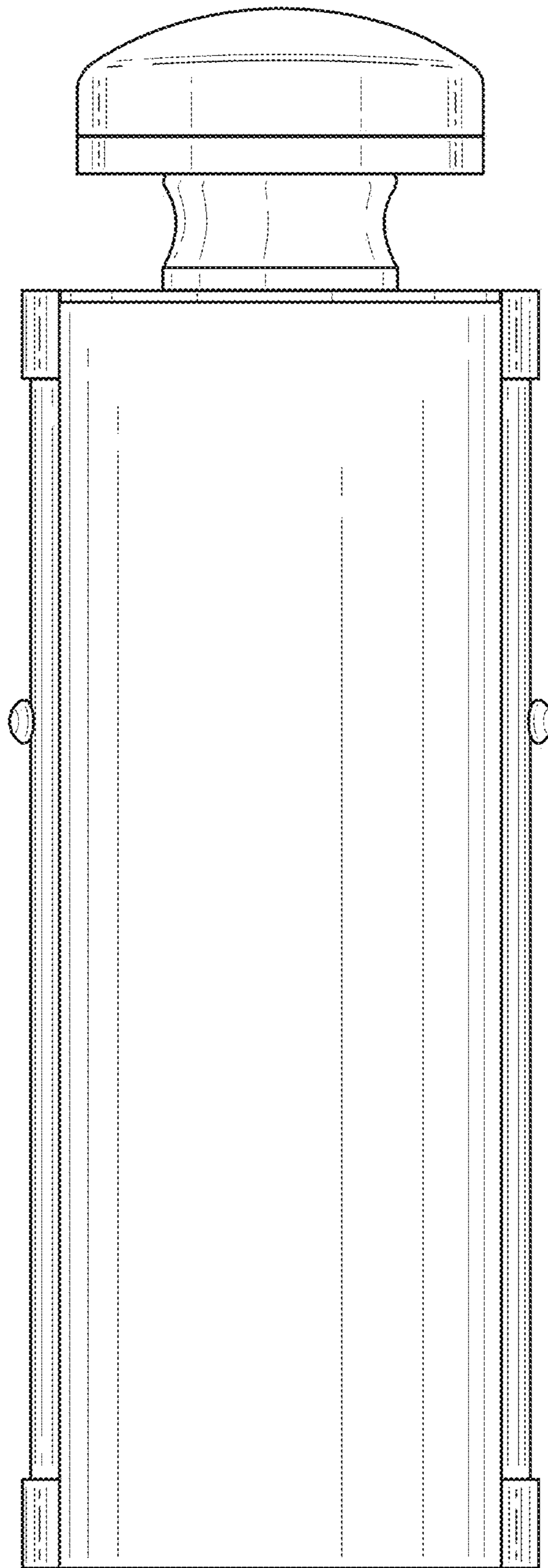

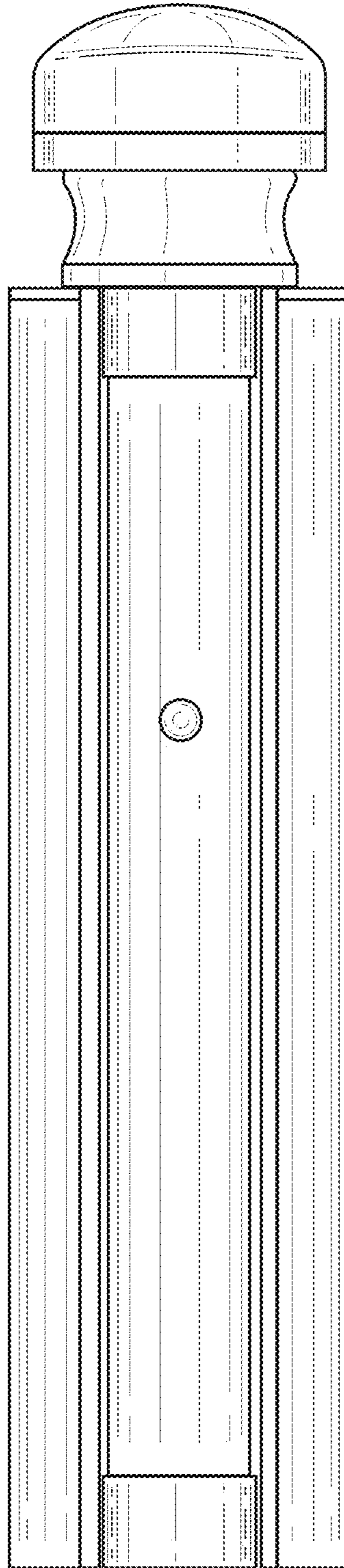

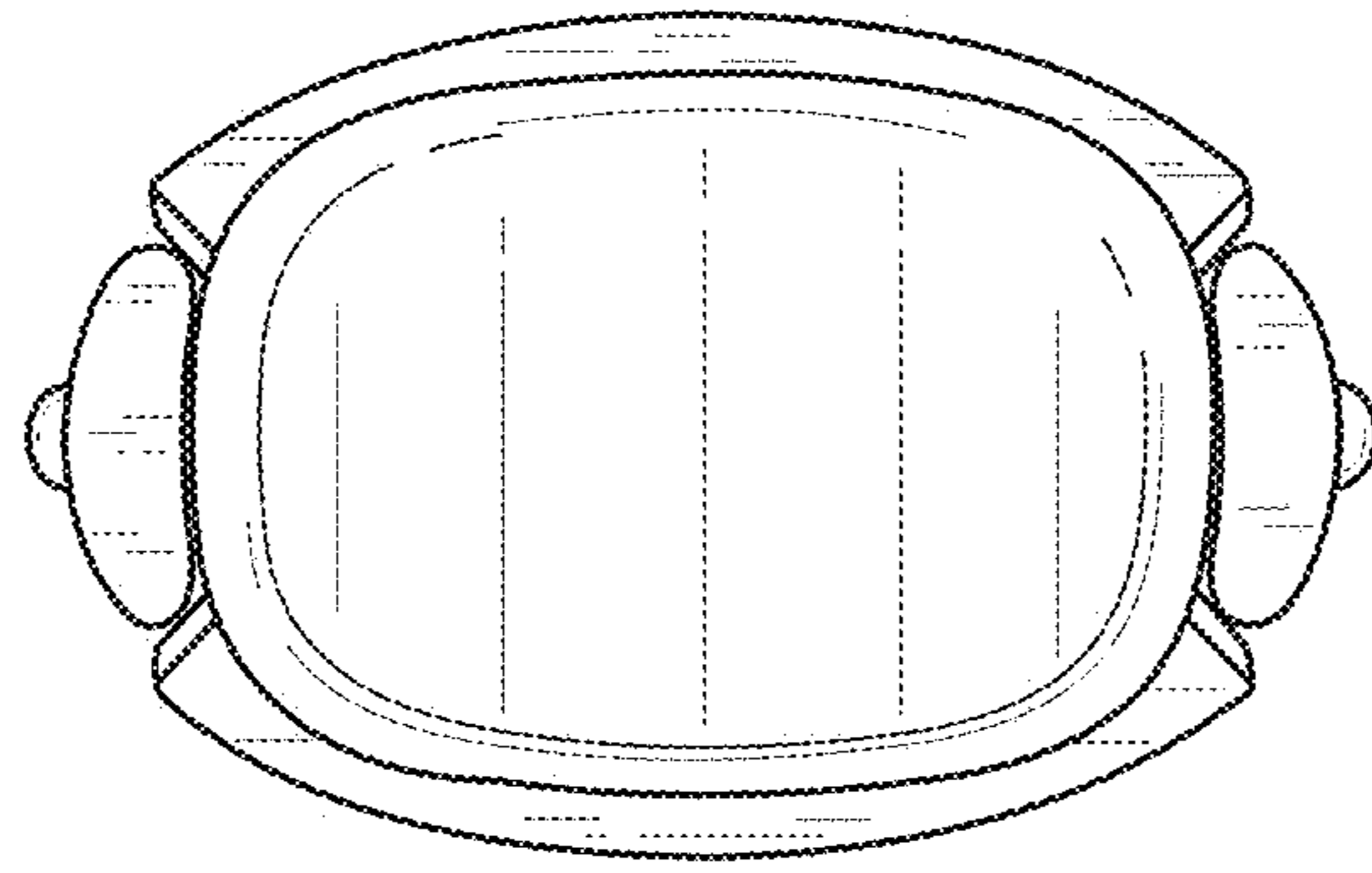

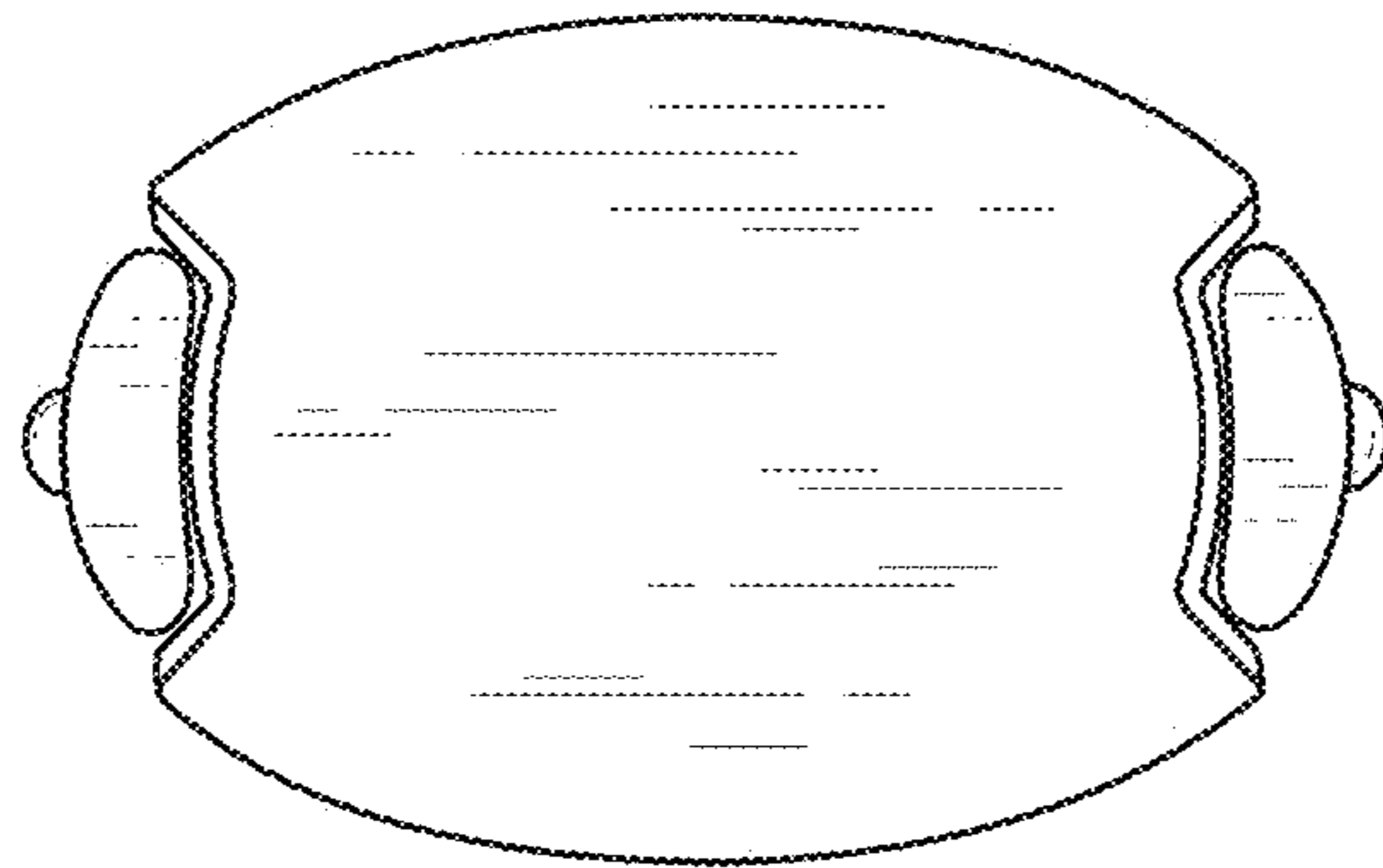
