(57) **CLAIM**

The ornamental design for a power indicator for portable
power charger, as shown and described.

DESCRIPTION

FIG. 1 is a front, top perspective view of a new, original and
ornamental design for a power indicator for portable power
charger, with the portable power charger shown in broken
lines;

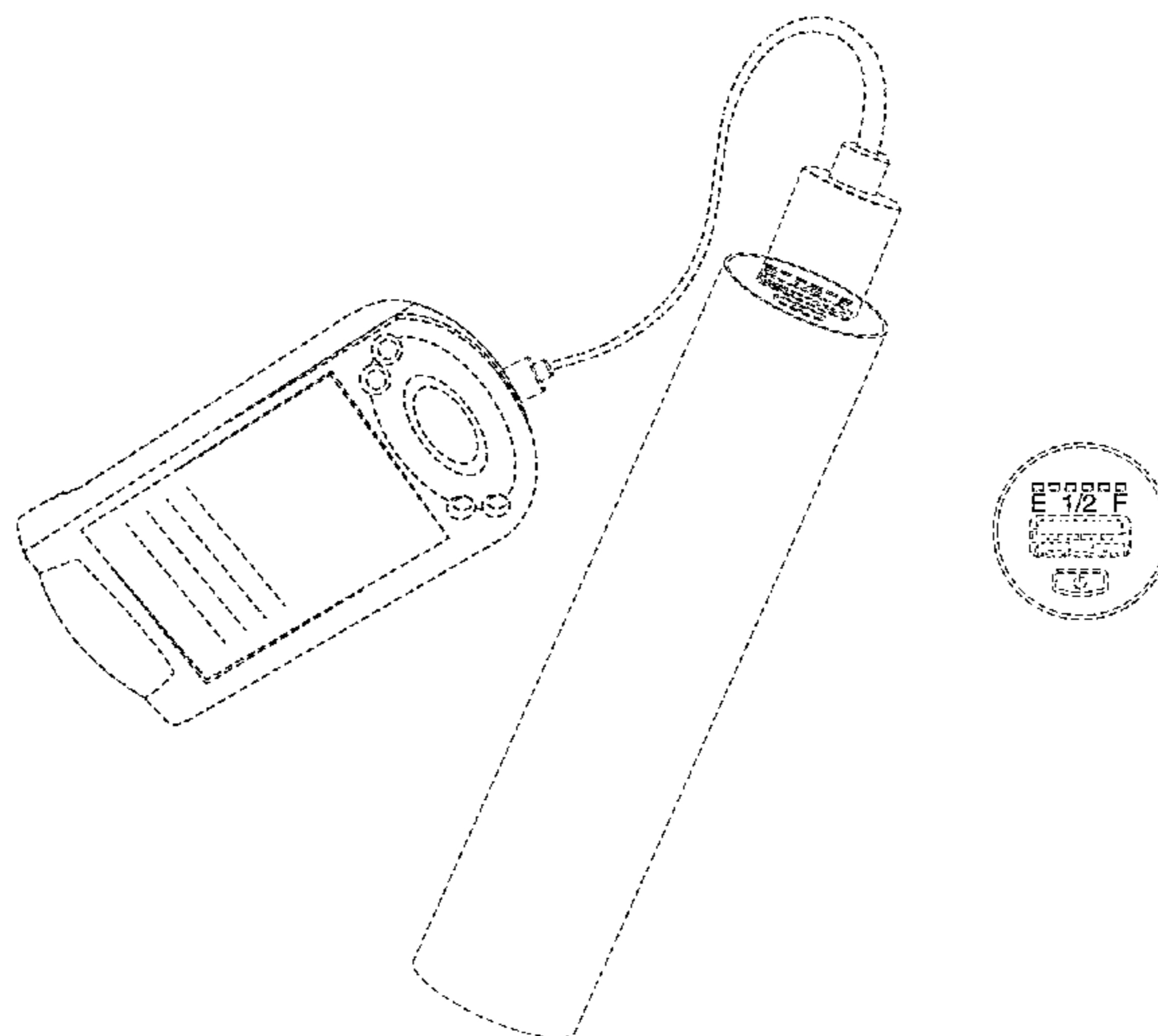
FIG. 2 is a front view of the power indicator for portable
power charger of FIG. 1, with the right-hand side, left-hand
side and rear view being mirror images thereof;

FIG. 3 is a top view of the portable power charger of FIG. 1
showing a first embodiment of the new, original and orna-
mental design for the power indicator; and,

FIG. 4 is a top view of the portable power charger of FIG. 1
showing a second embodiment of the new, original and orna-
mental design for the power indicator.

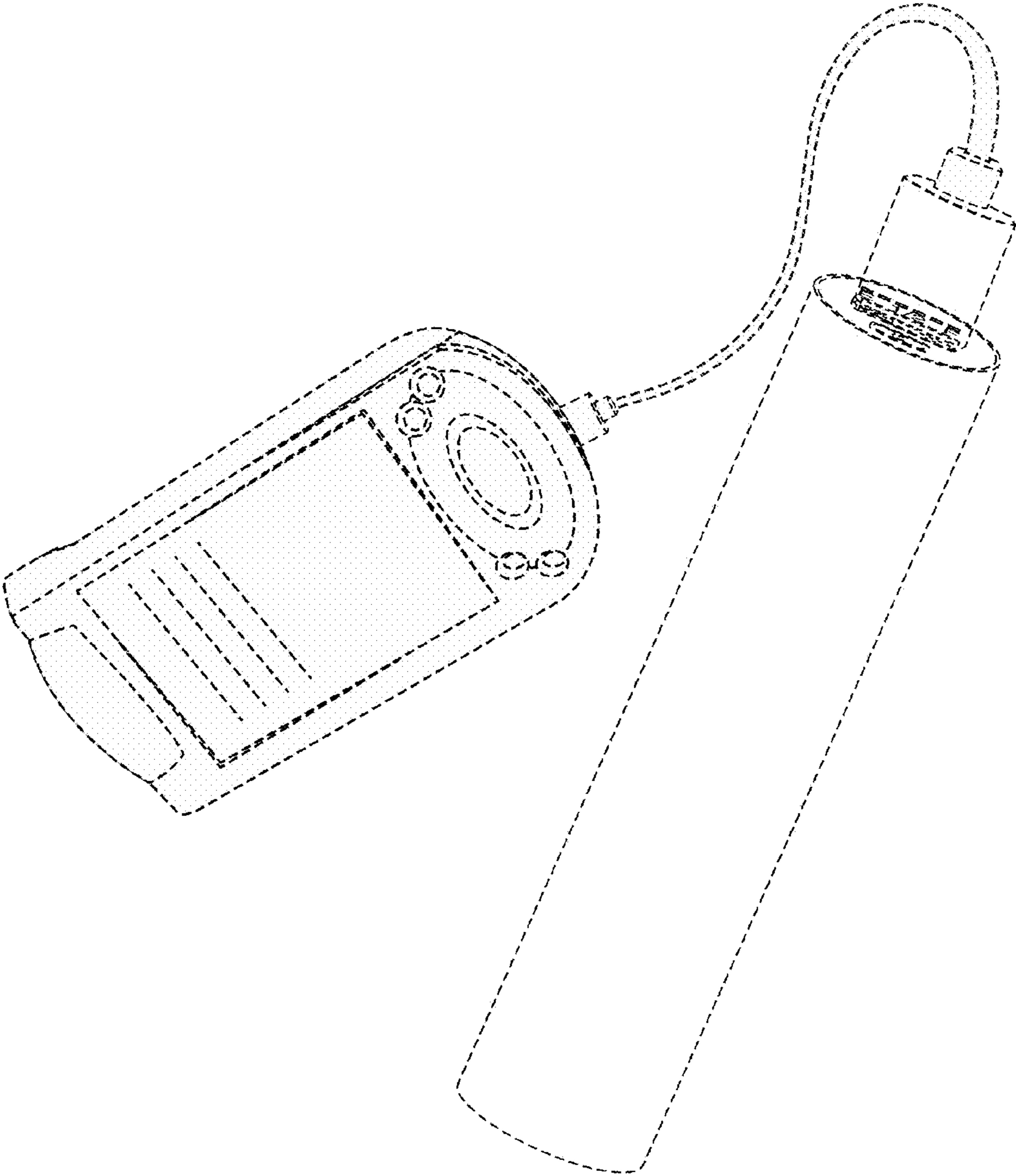

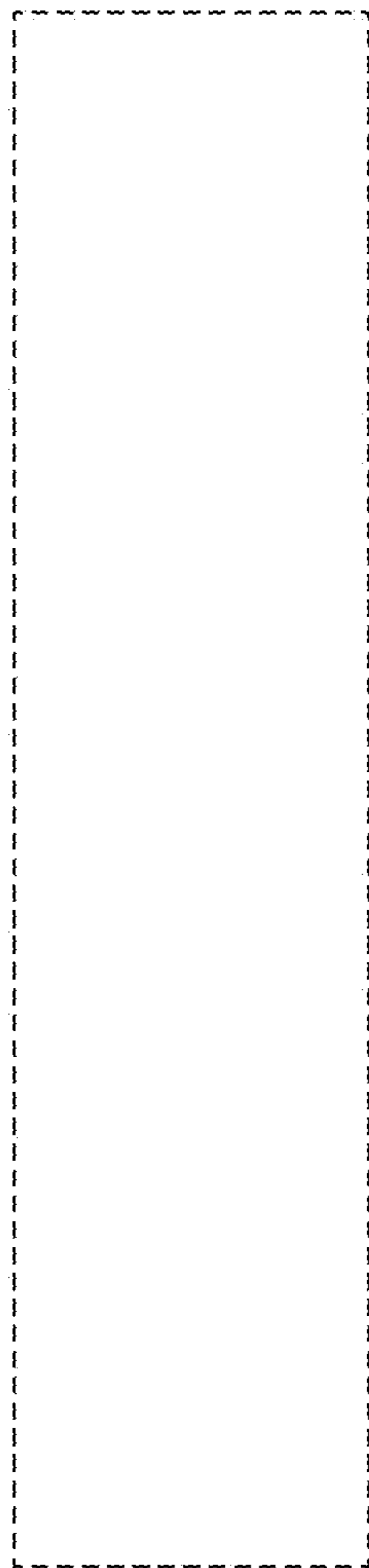

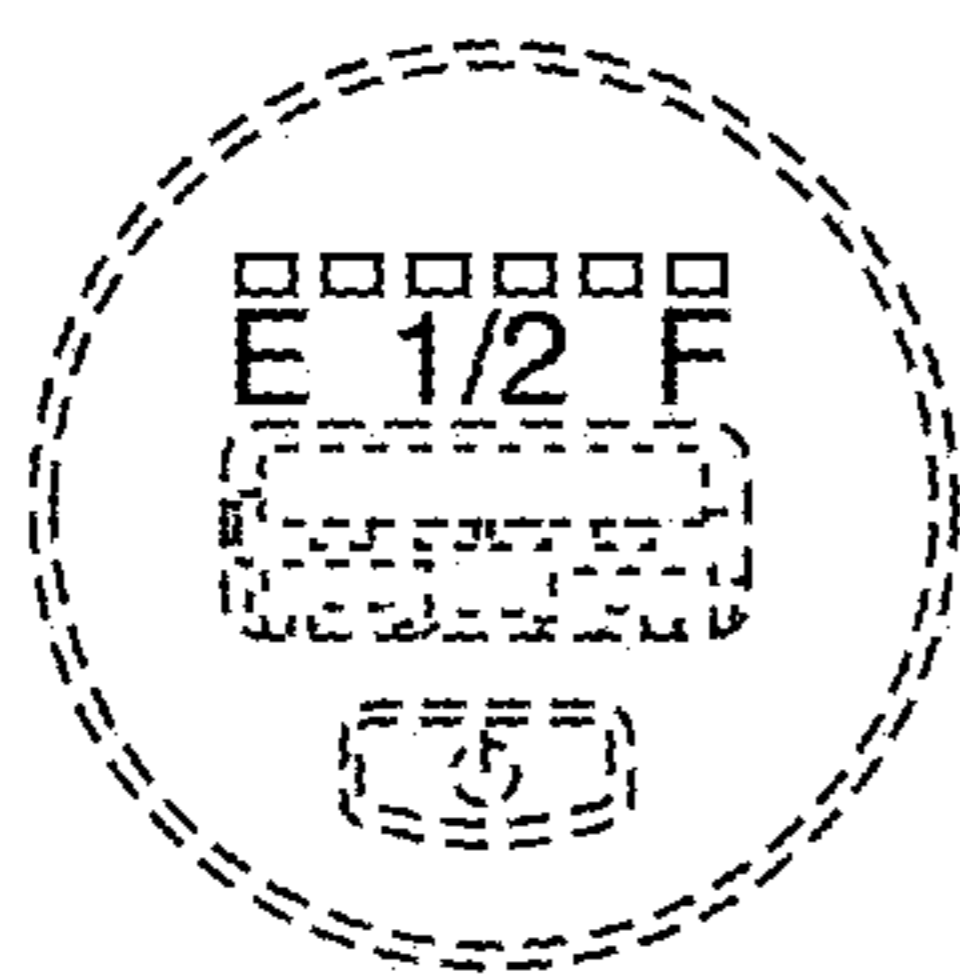

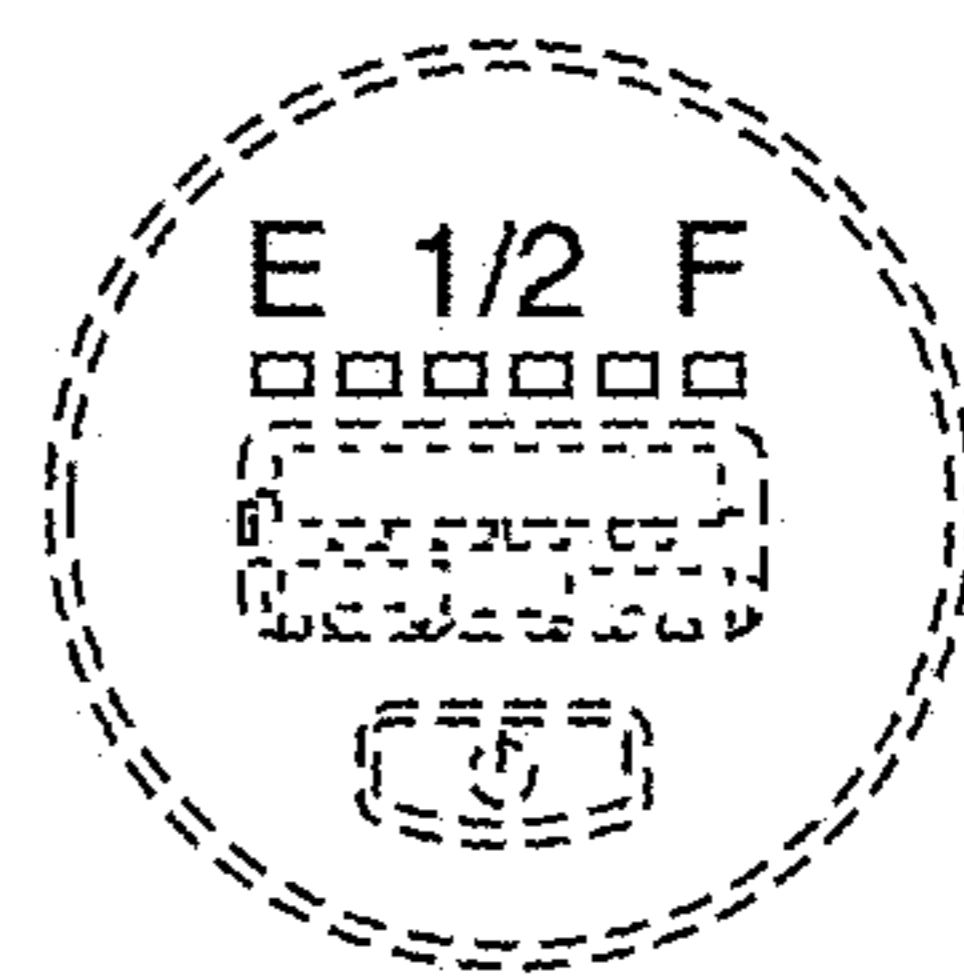
