FIG. 3 is a back view of the slide cutter with slant edge according to the present disclosure.


FIG. 4 is a right side end view of the slide cutter with slant edge according to the present disclosure.

FIG. 7 is a bottom view of the slide cutter with slant edge according to the present disclosure.


















