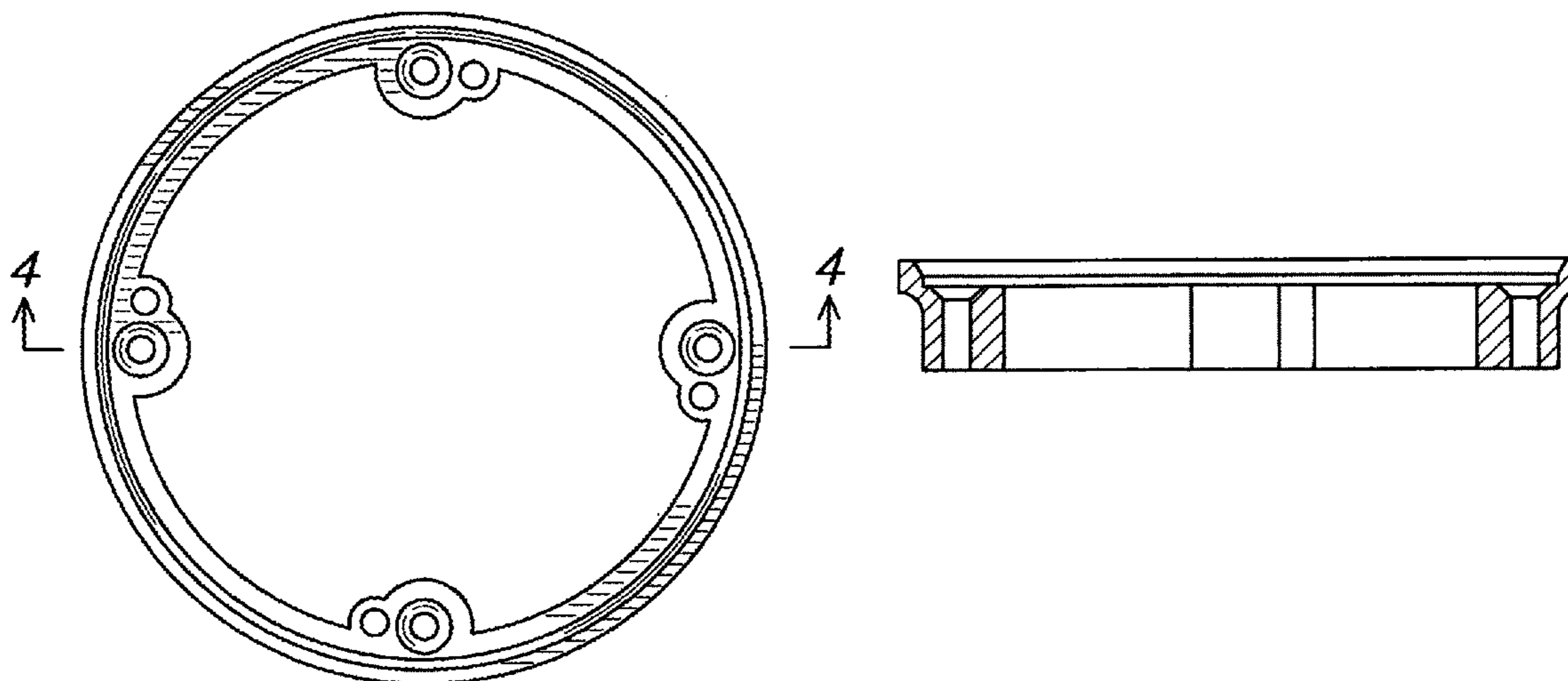

The ornamental design for a pool floor inlet extender, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of my new pool floor inlet extender; FIG. 2 is a bottom plan view thereof; FIG. 3 is a side elevational view thereof, it being understood that all side elevational views are identical thereto; and, FIG. 4 is a cross-sectional view taken along line 4-4 of FIG. 1.

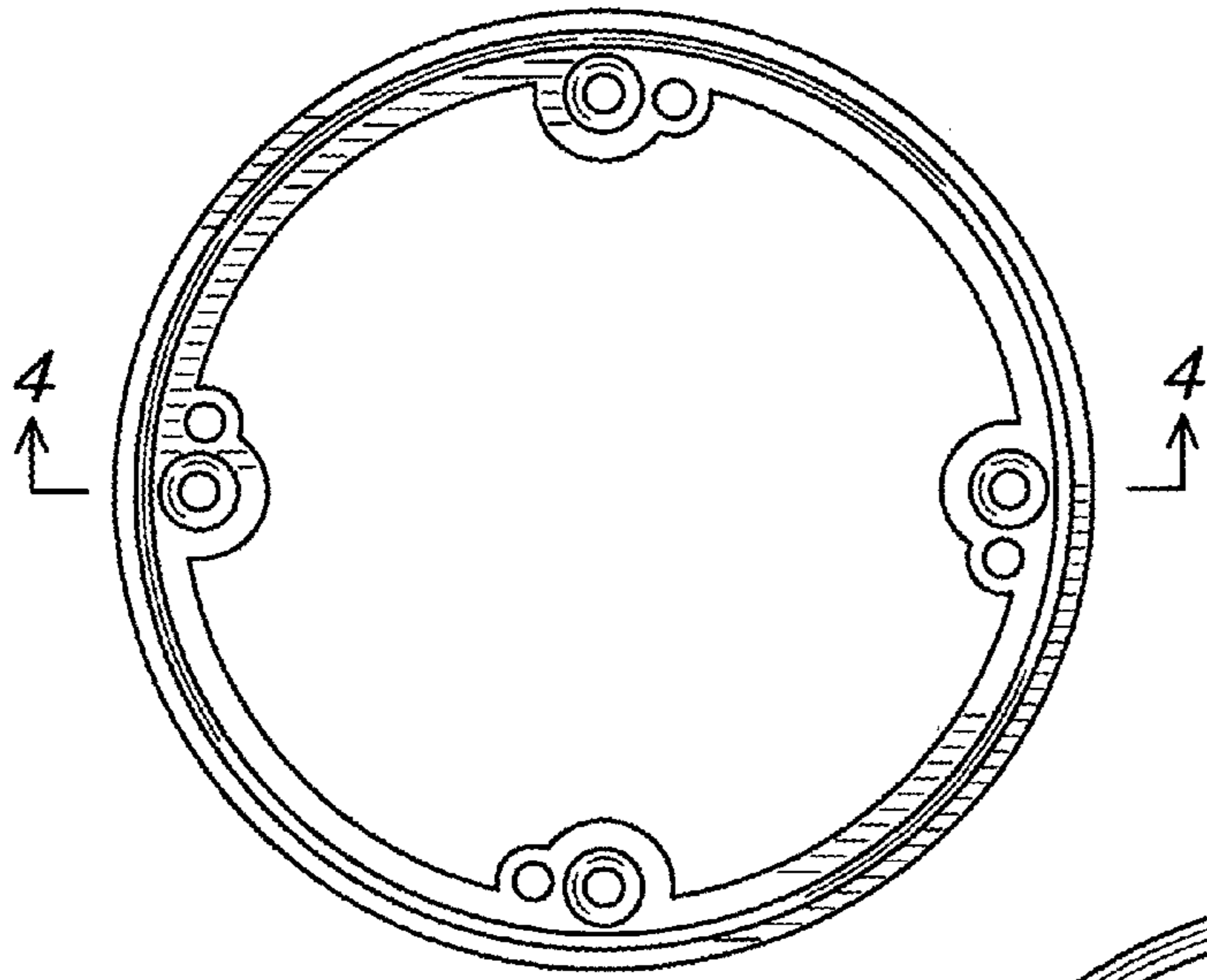

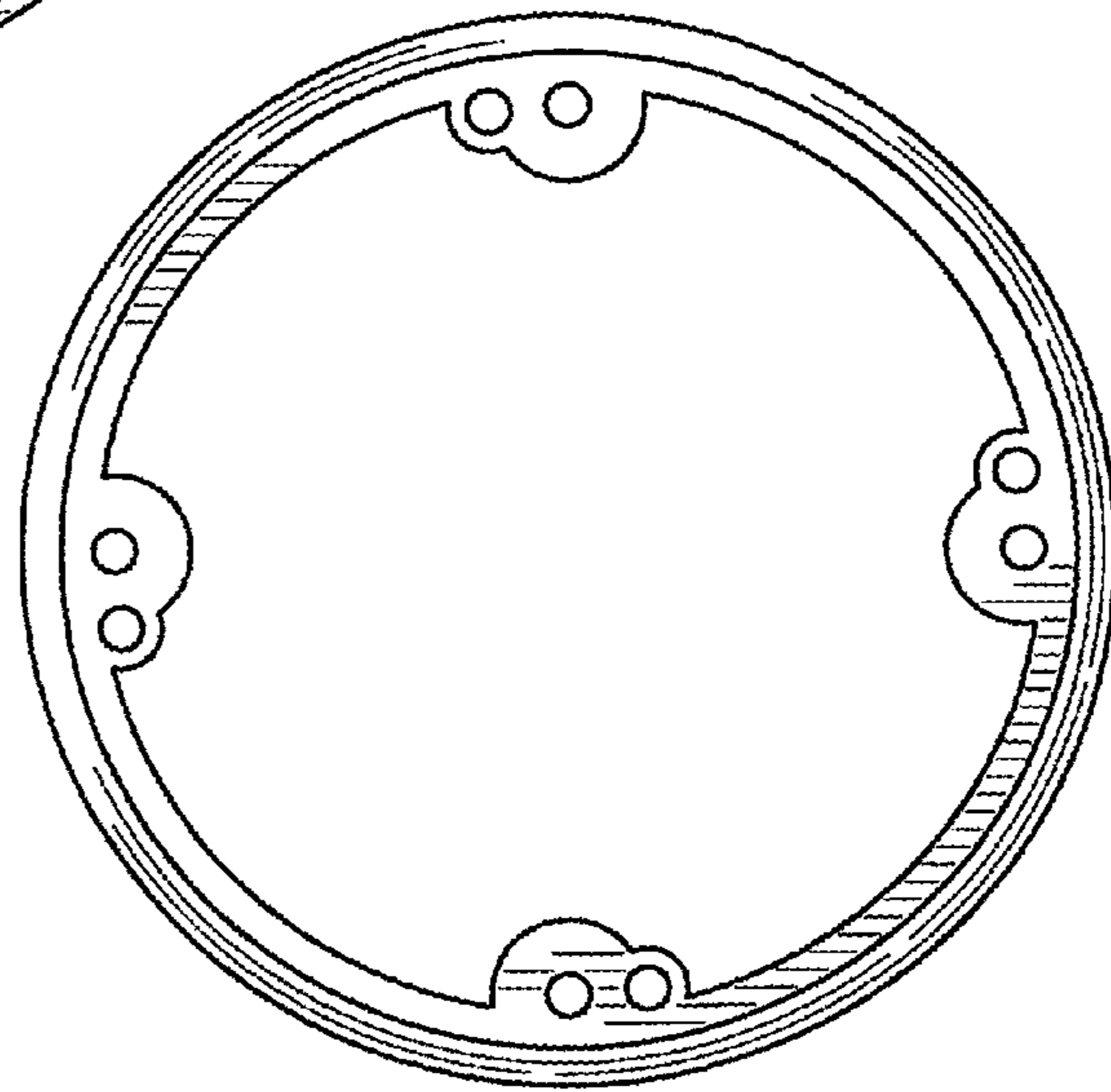

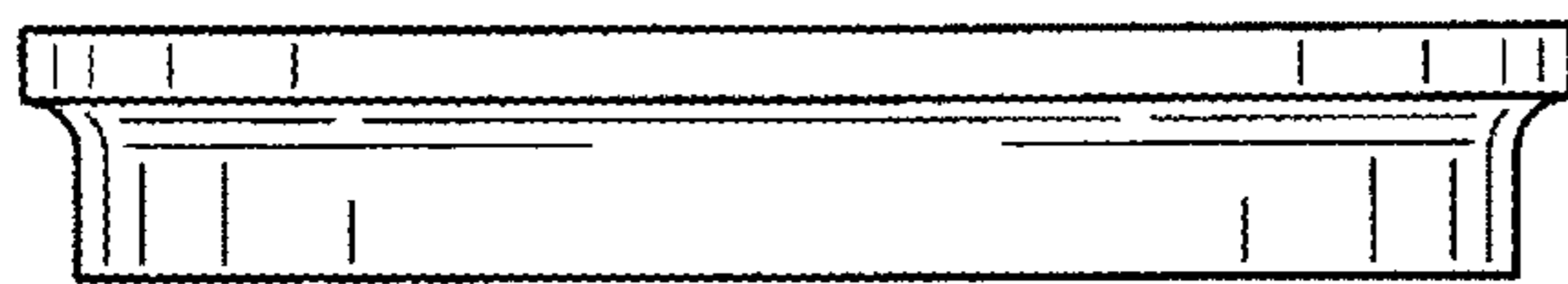

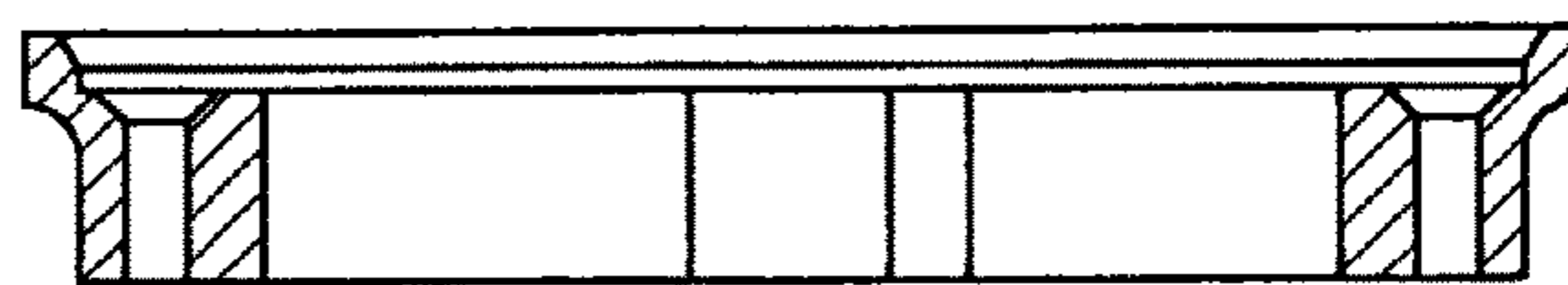
