FIG. 4 is a right-side view thereof;

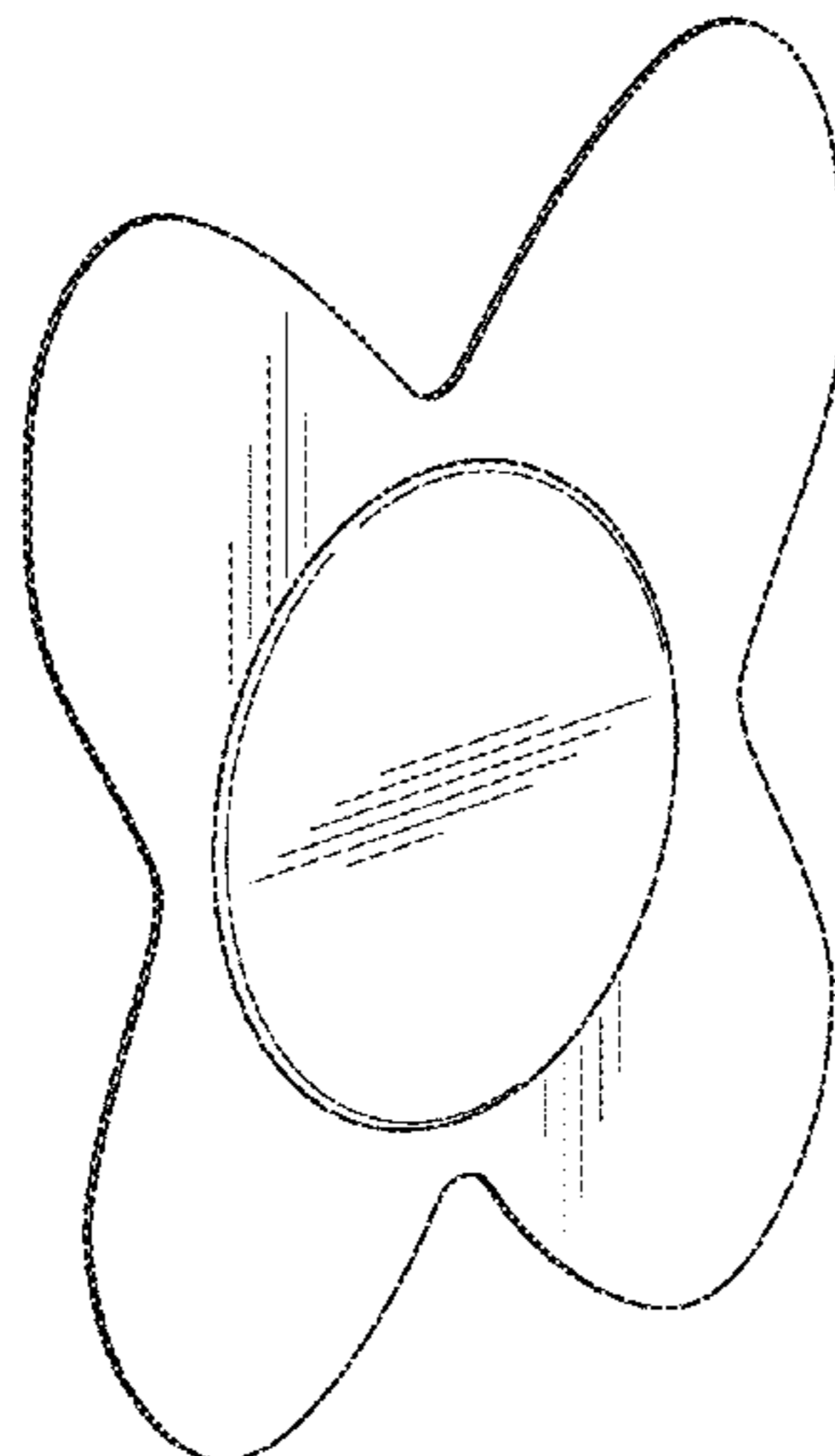
FIG. 5 is a left-side view thereof;

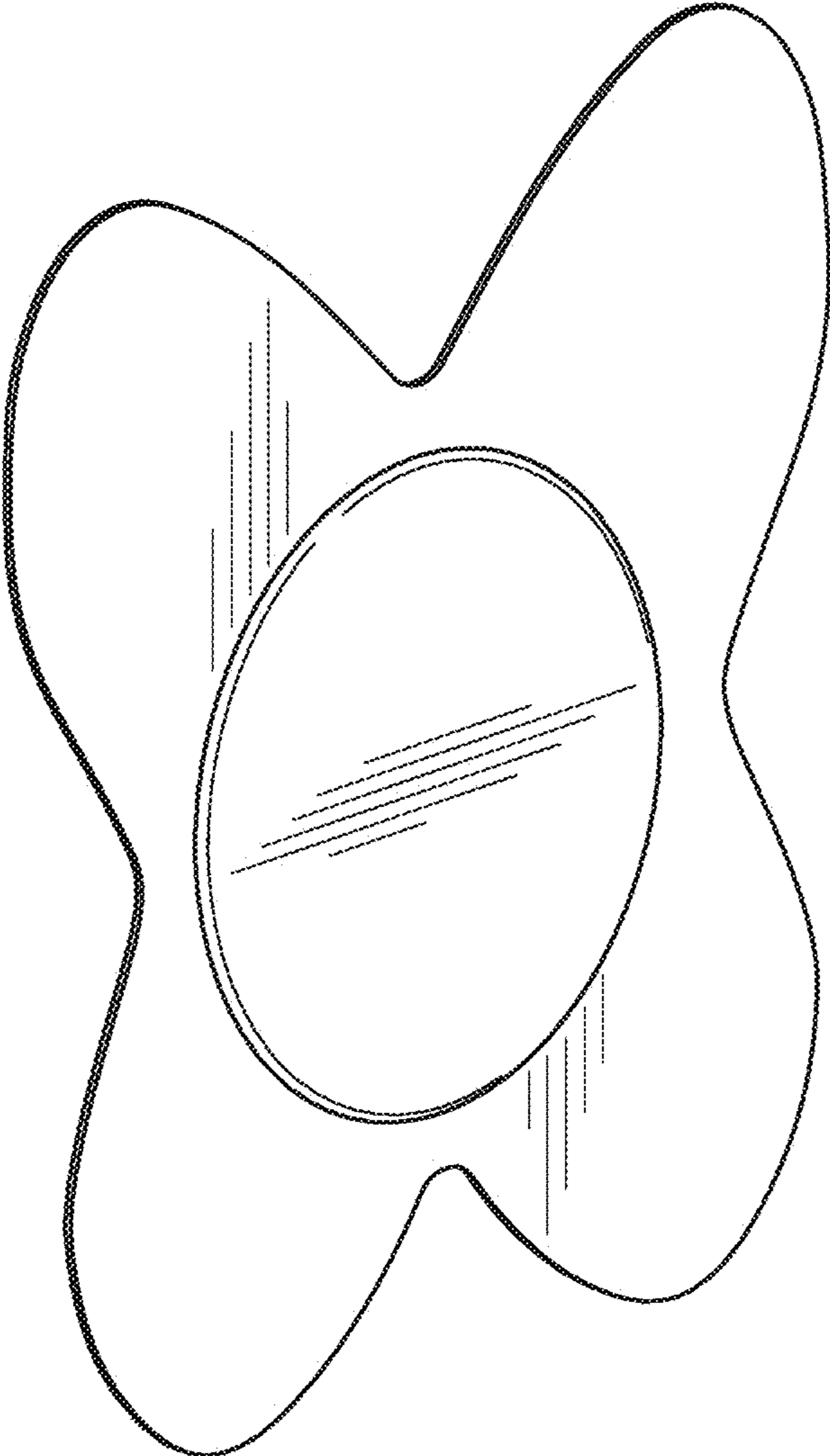

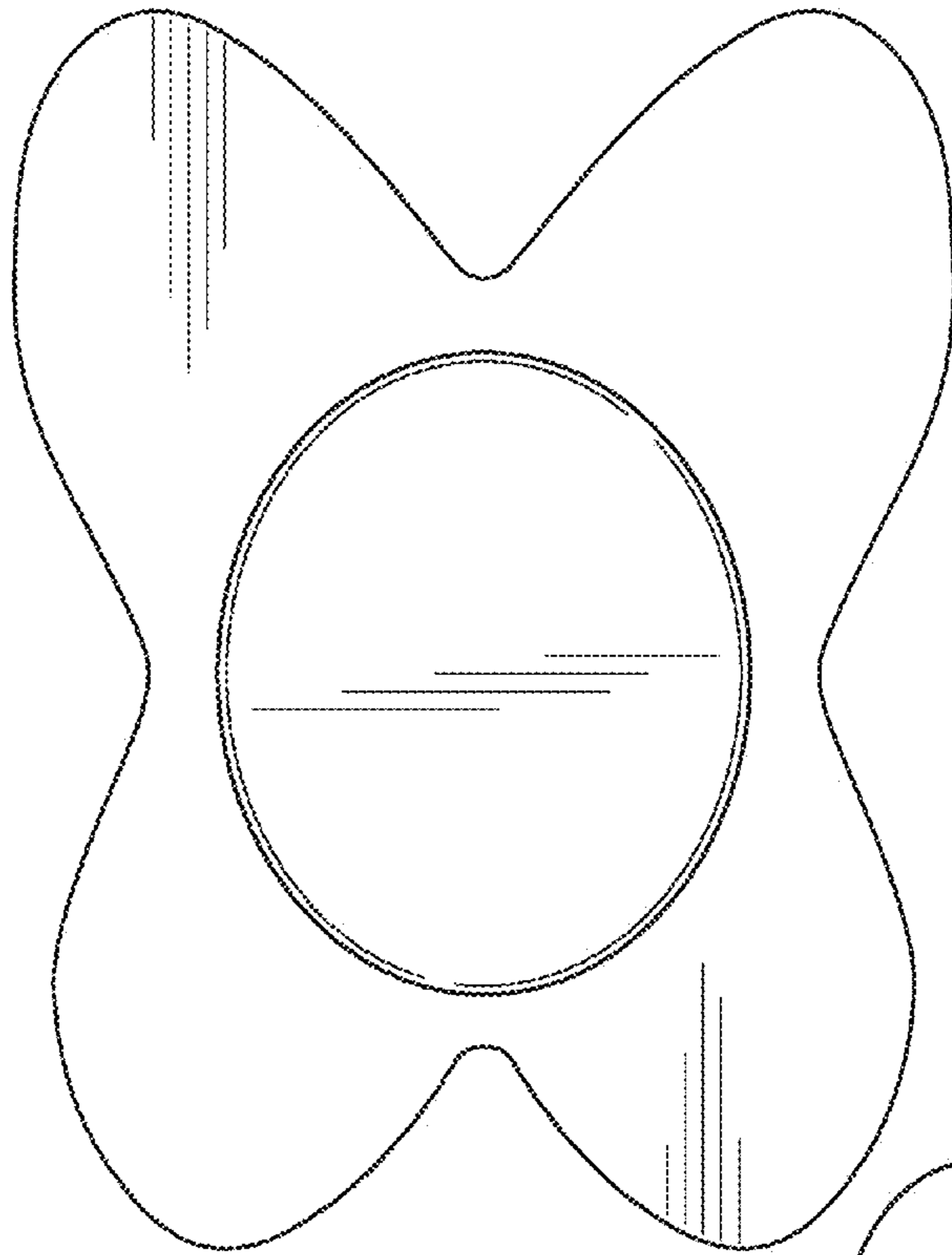

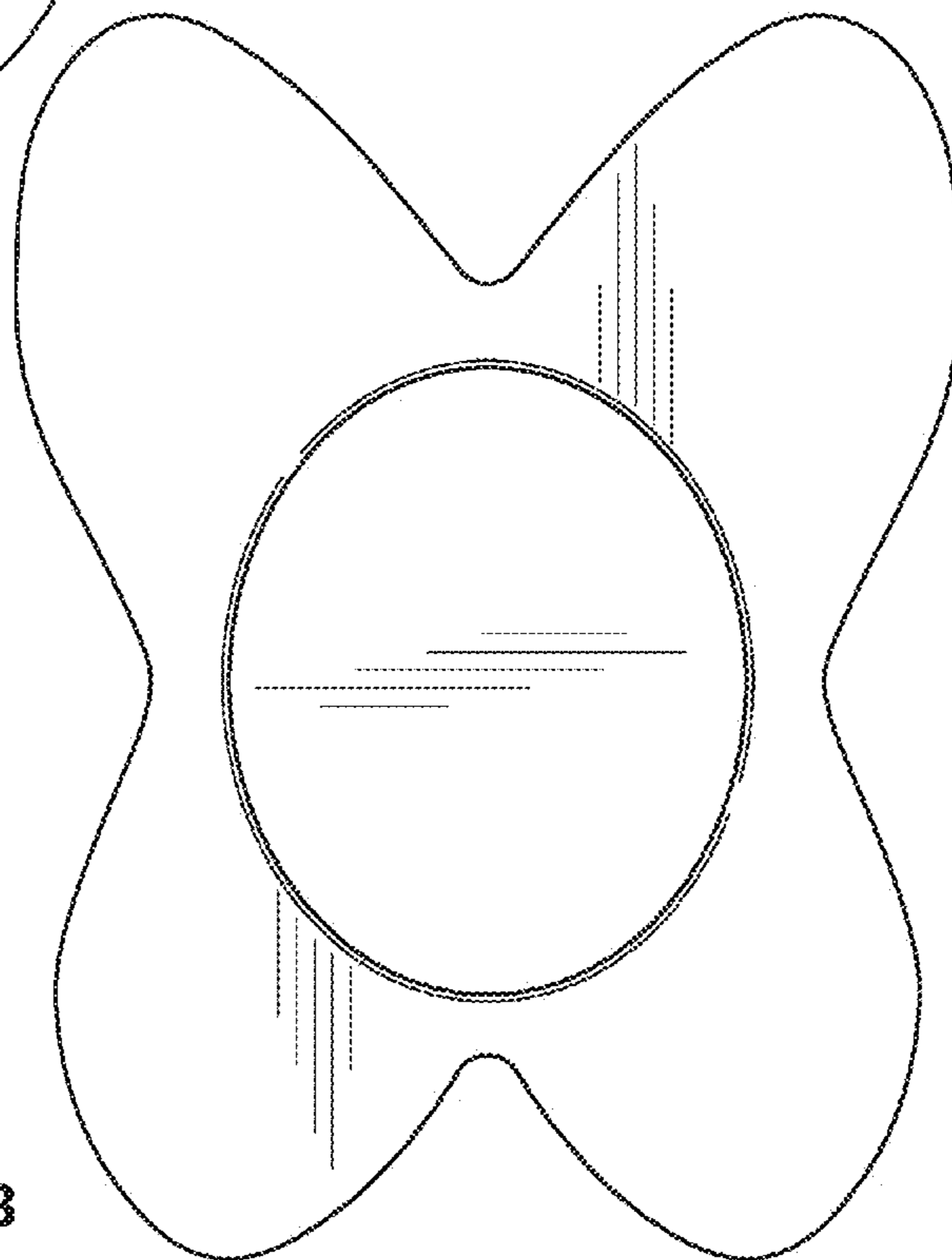

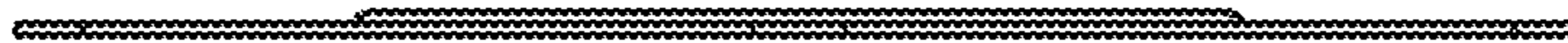
