FIG. 5 is another front elevation view thereof, with the transparent outer visor removed to show the transparent inner visor for ease of illustration.

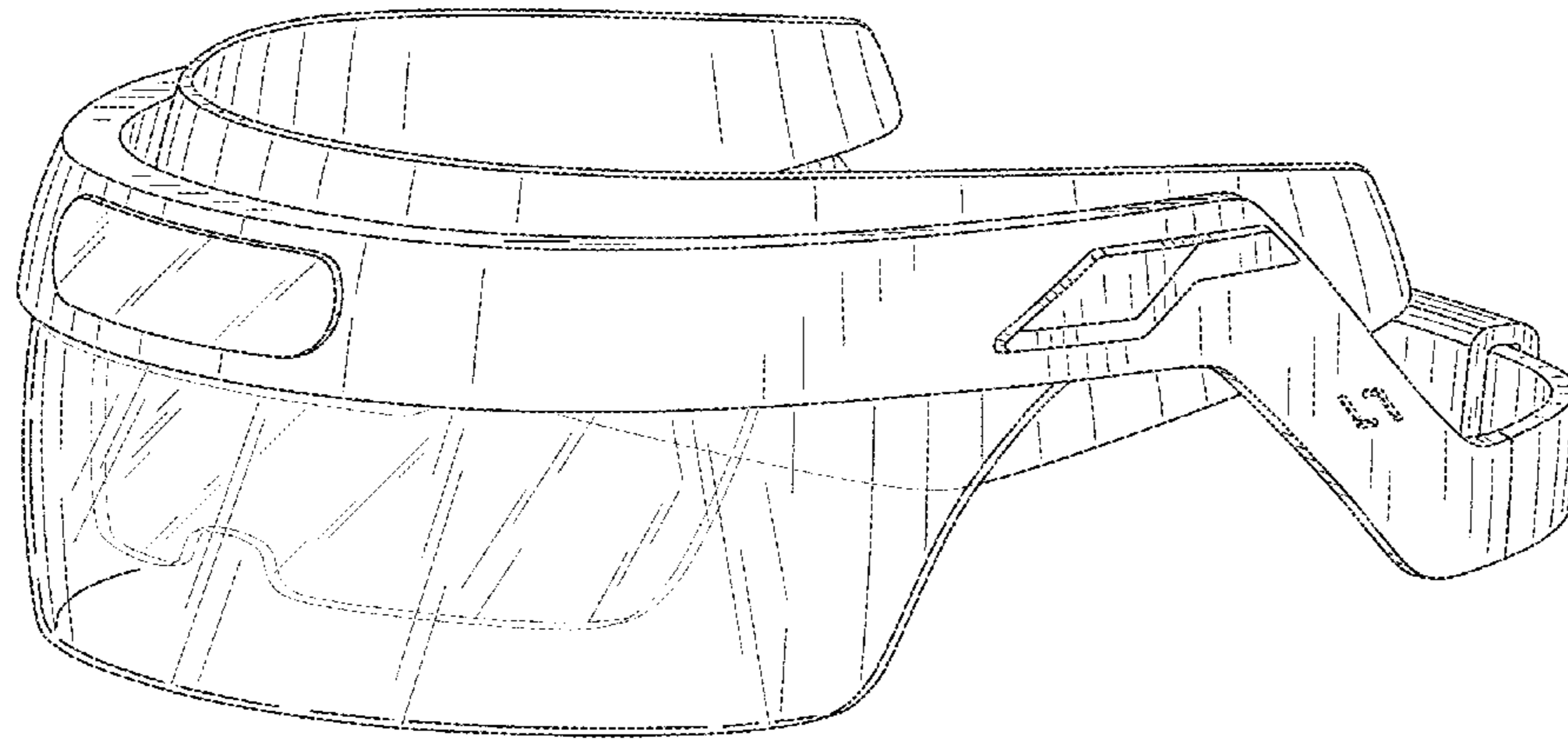


FIG. 6 is another front elevation view thereof, with the transparent inner visor removed to show the transparent outer visor for ease of illustration;

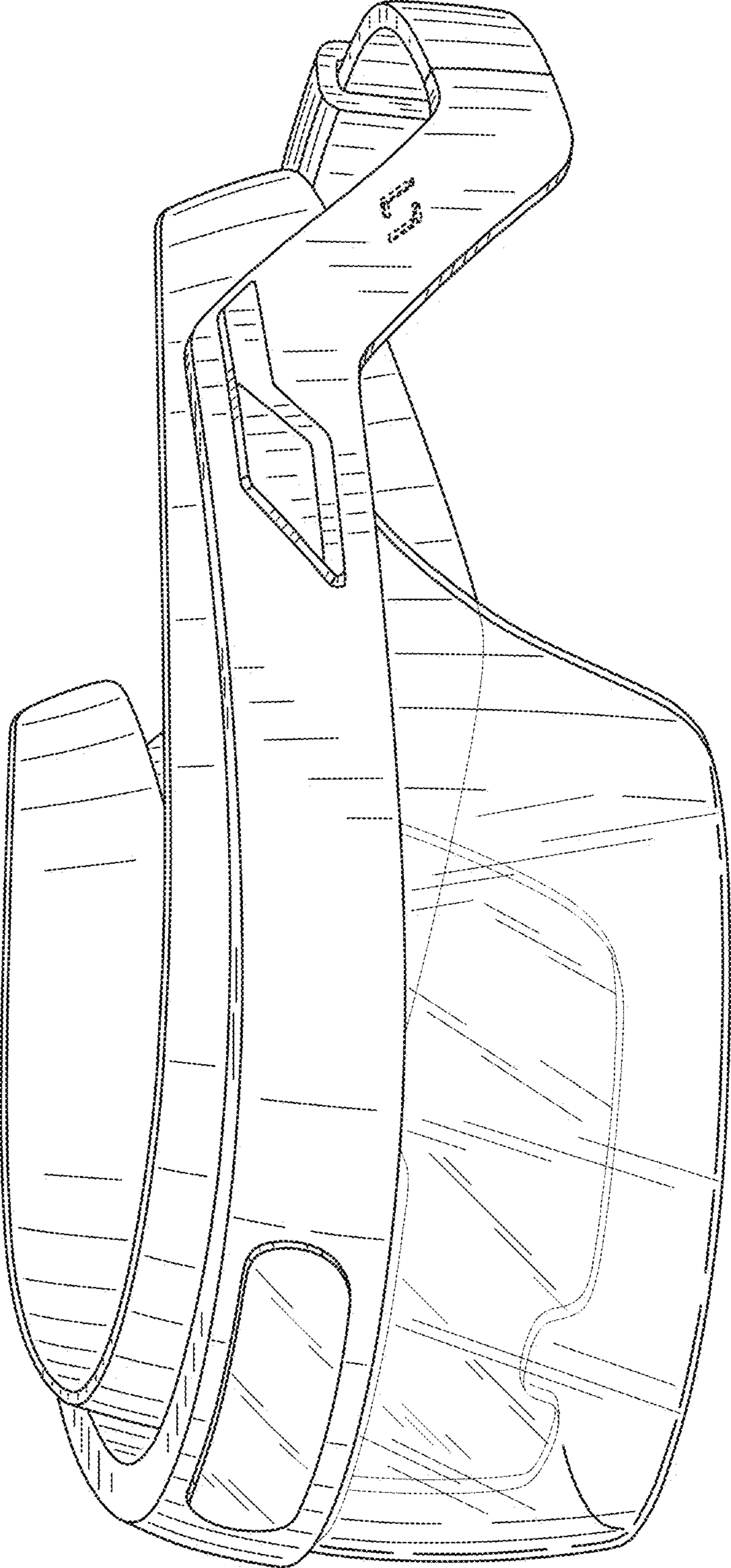

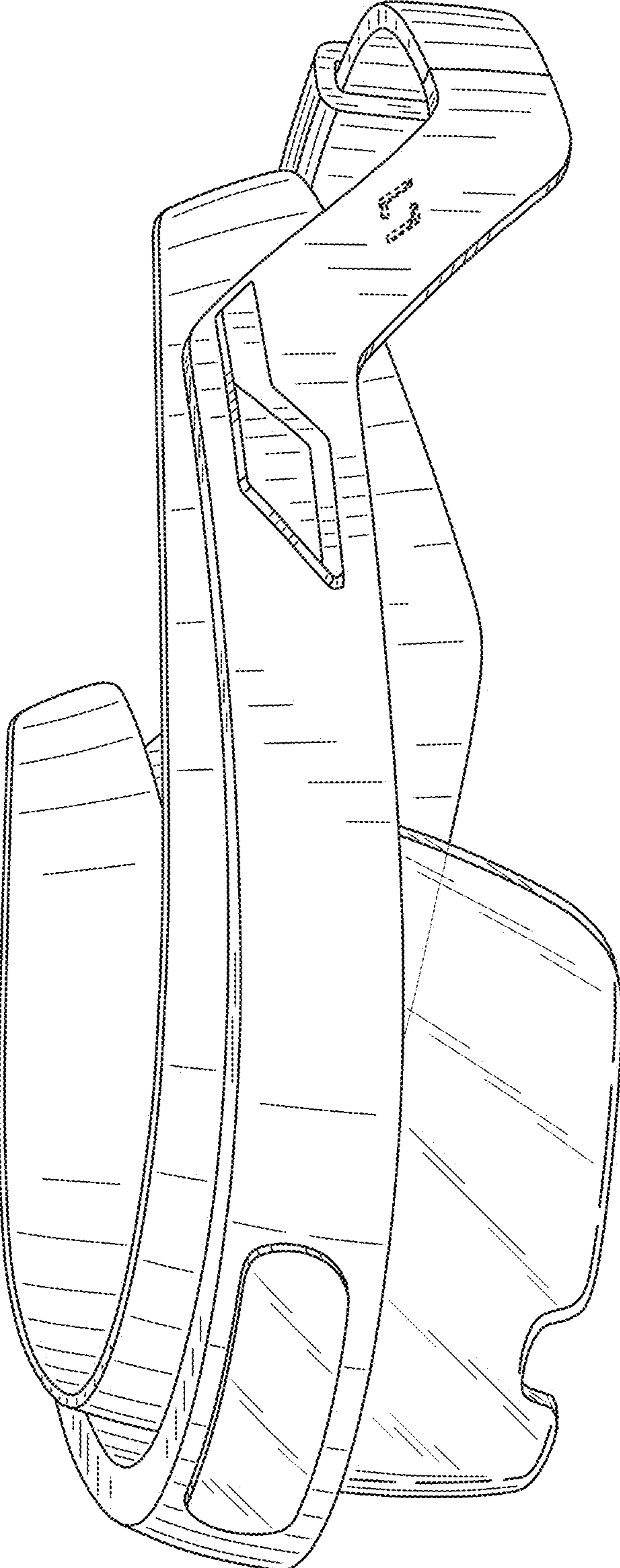

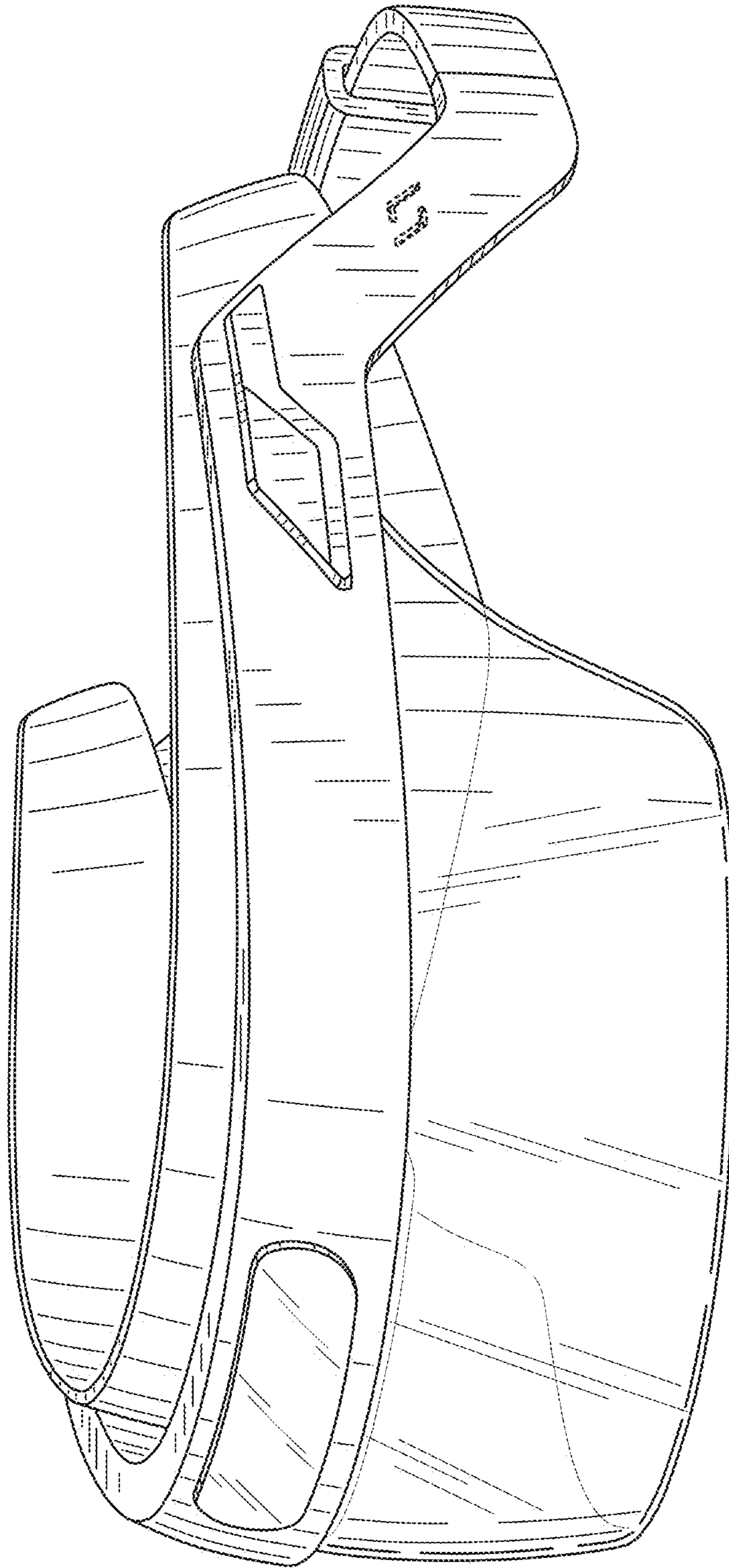

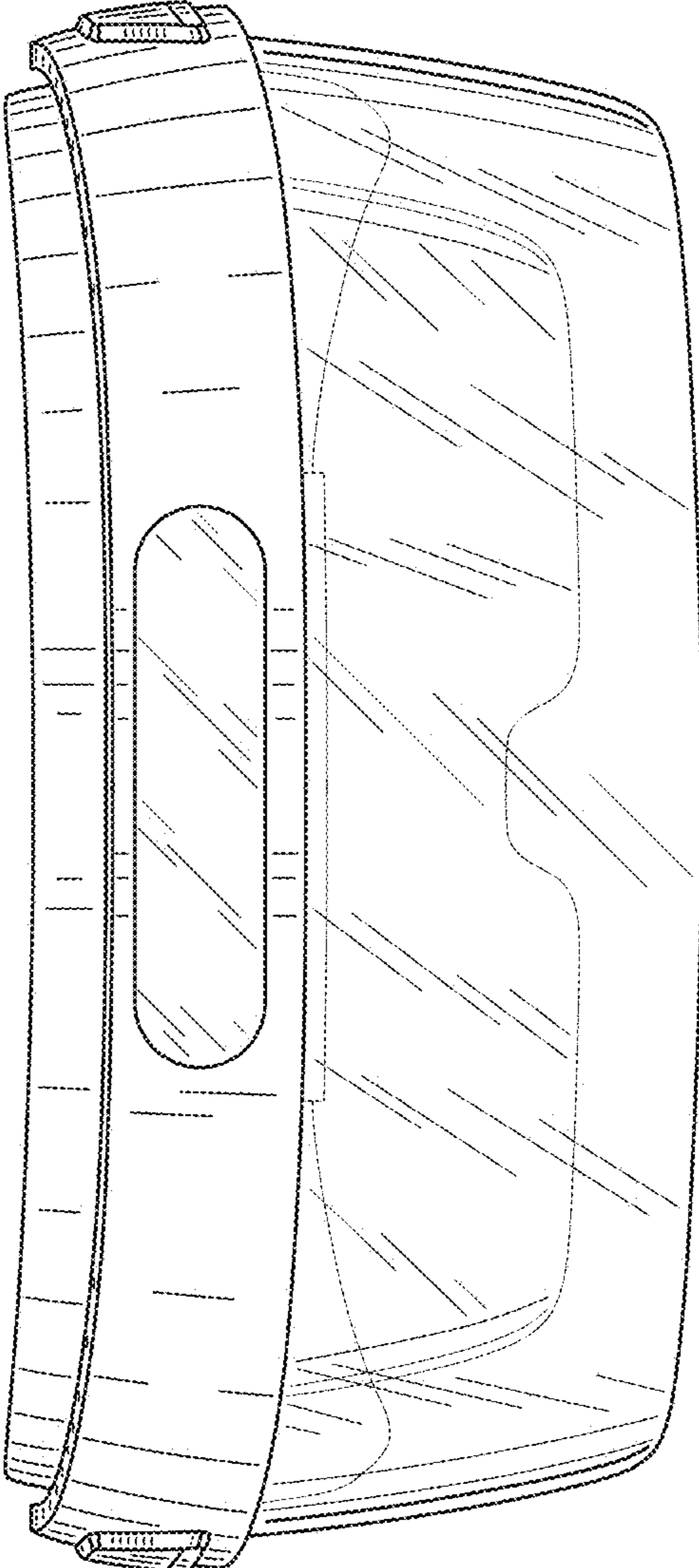

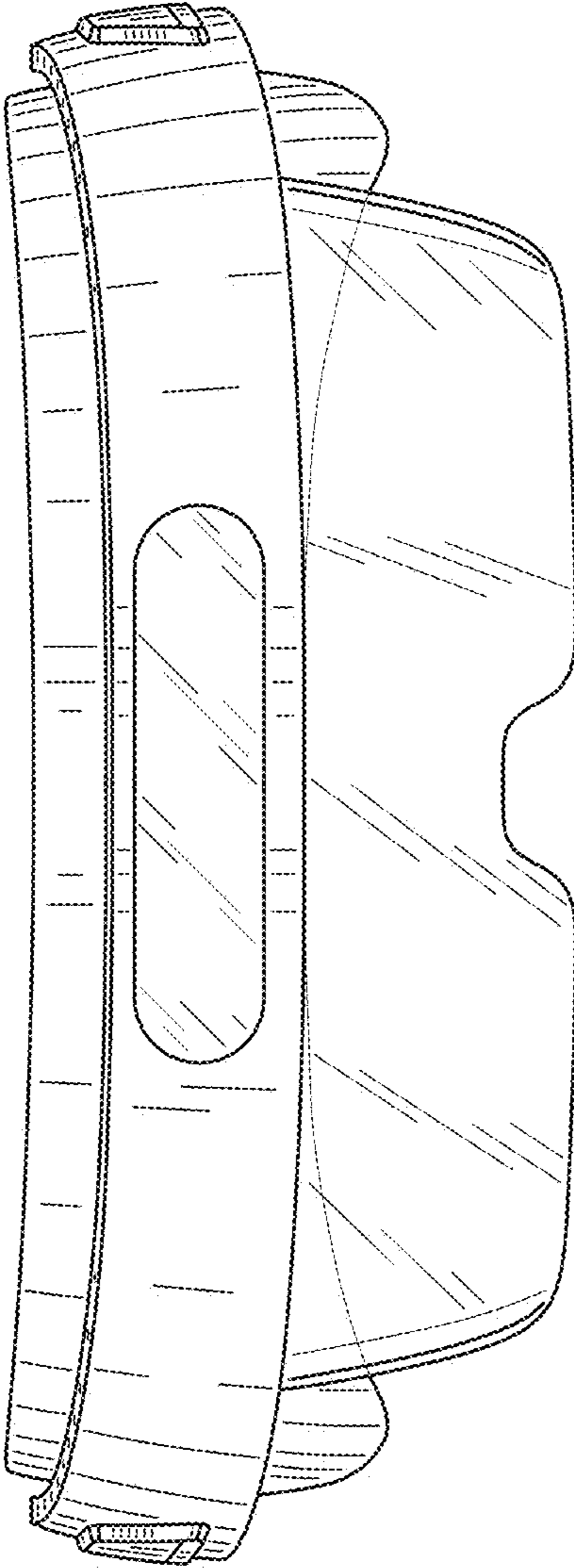

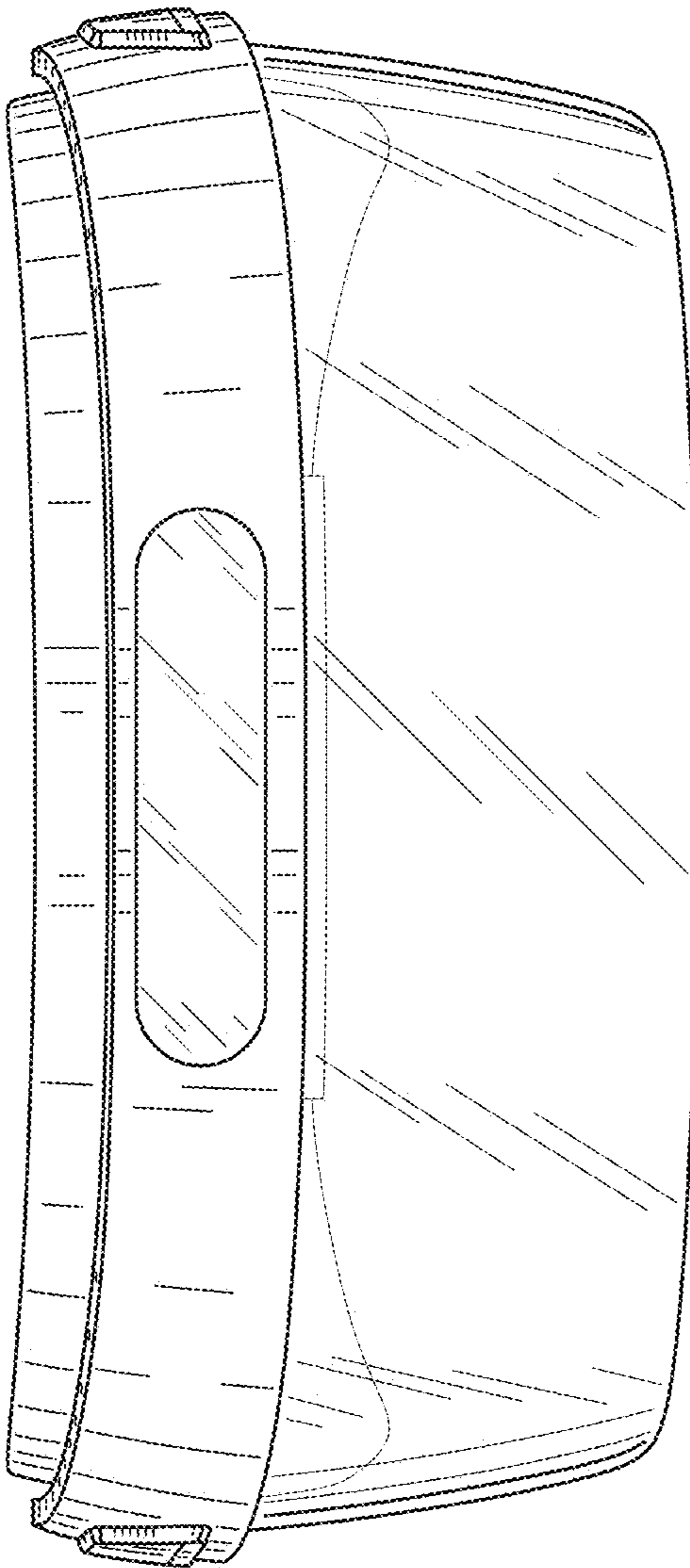

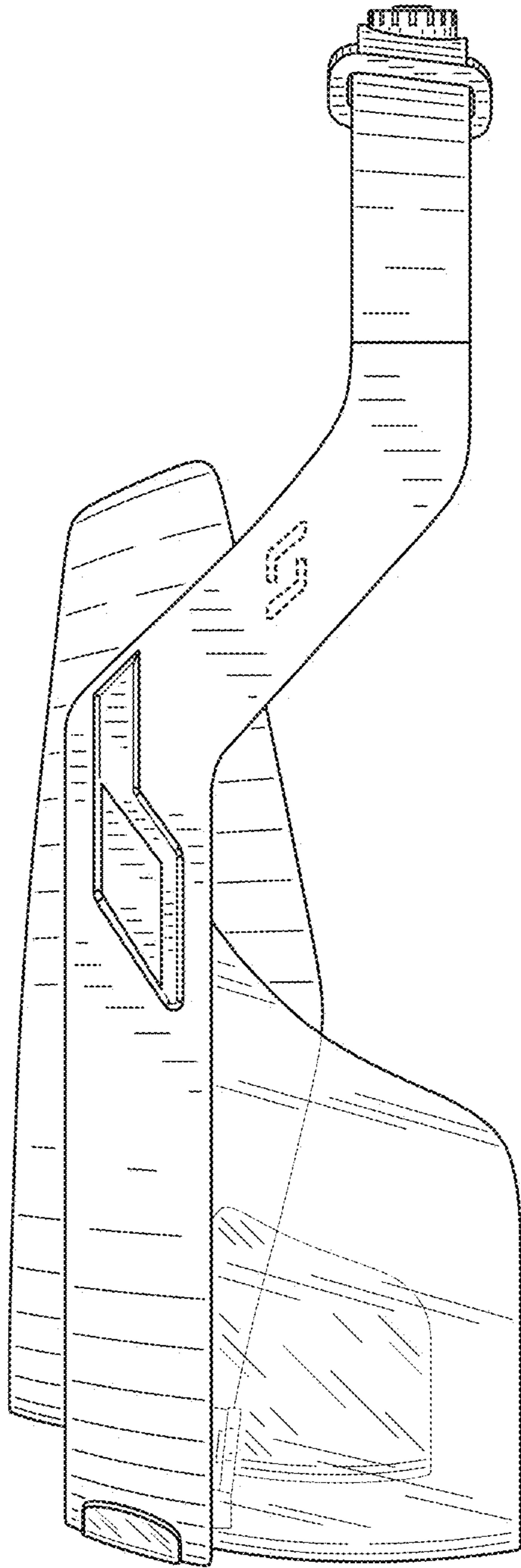

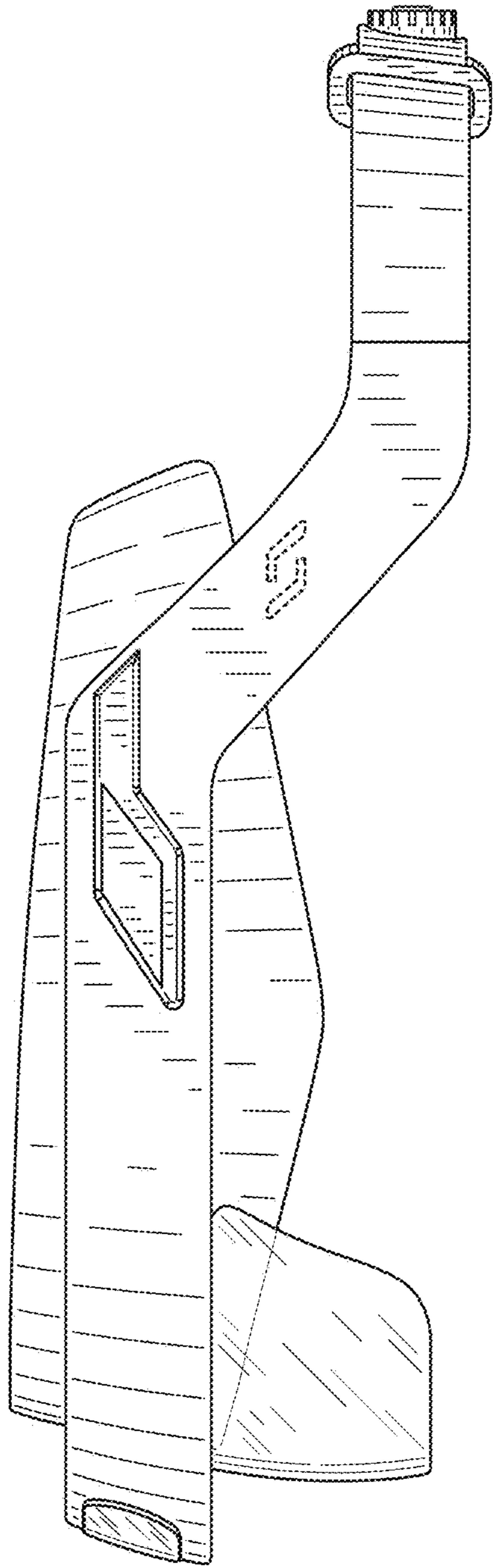

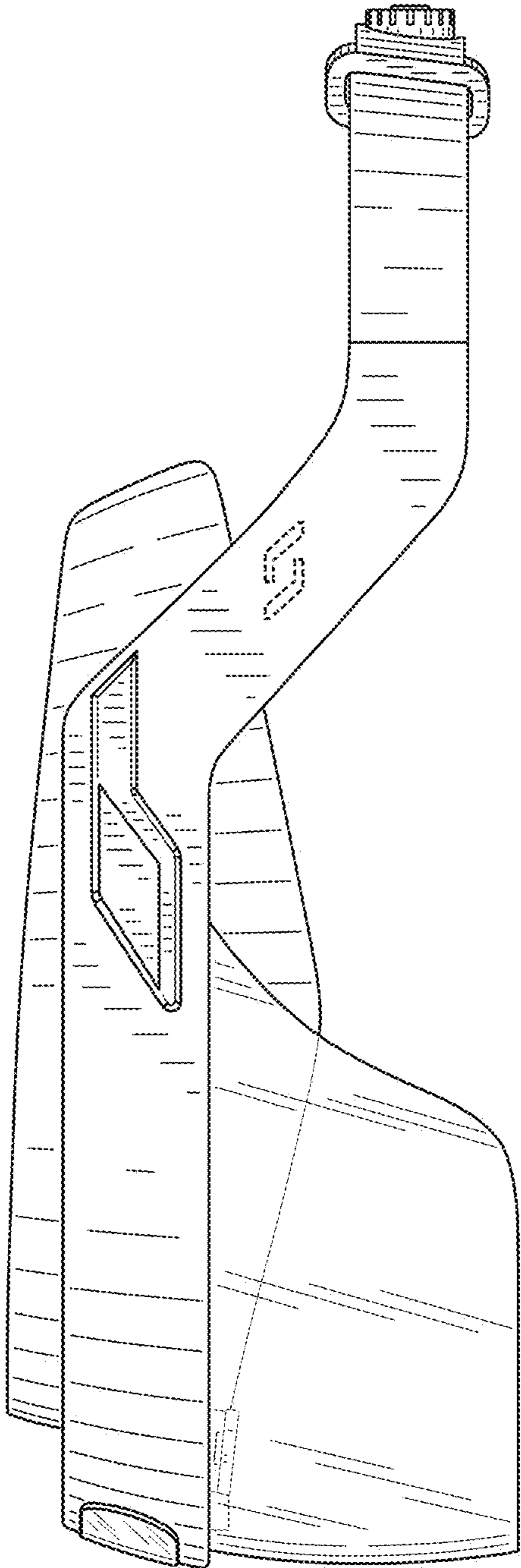

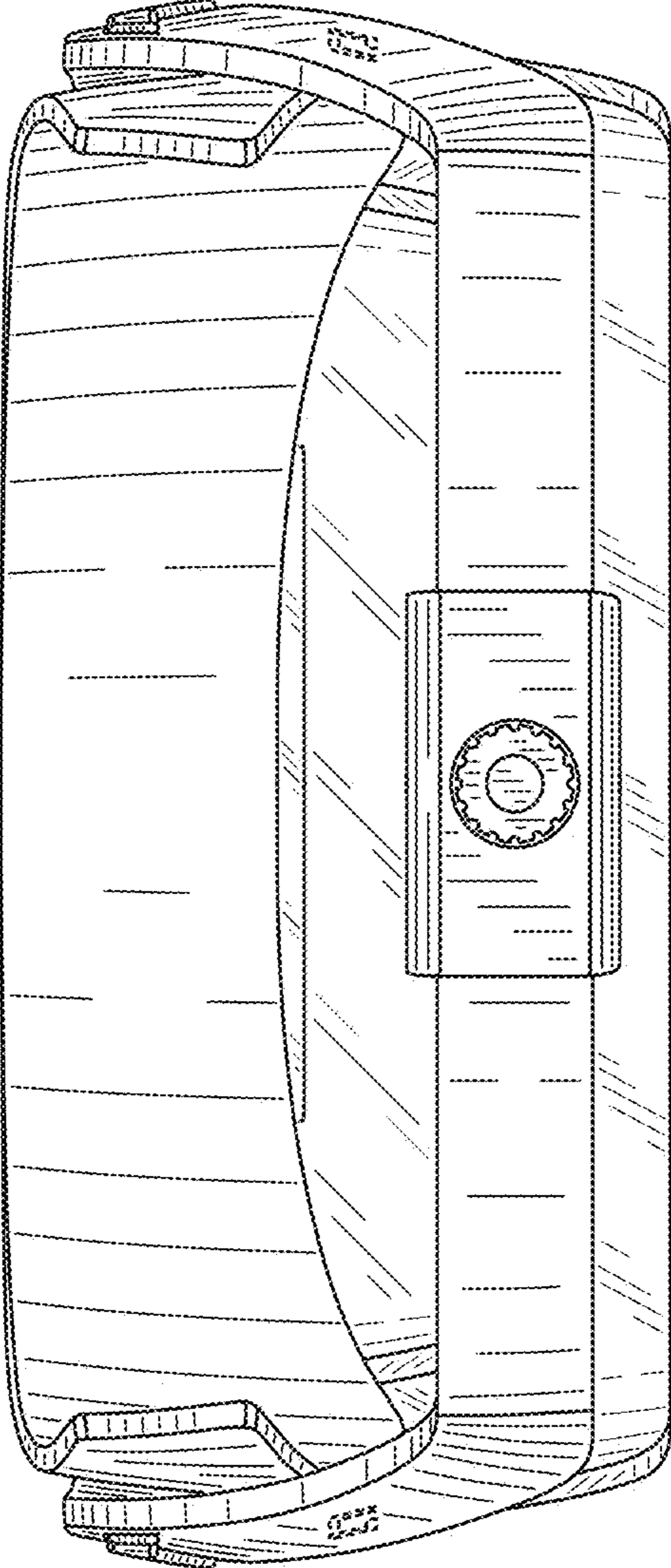

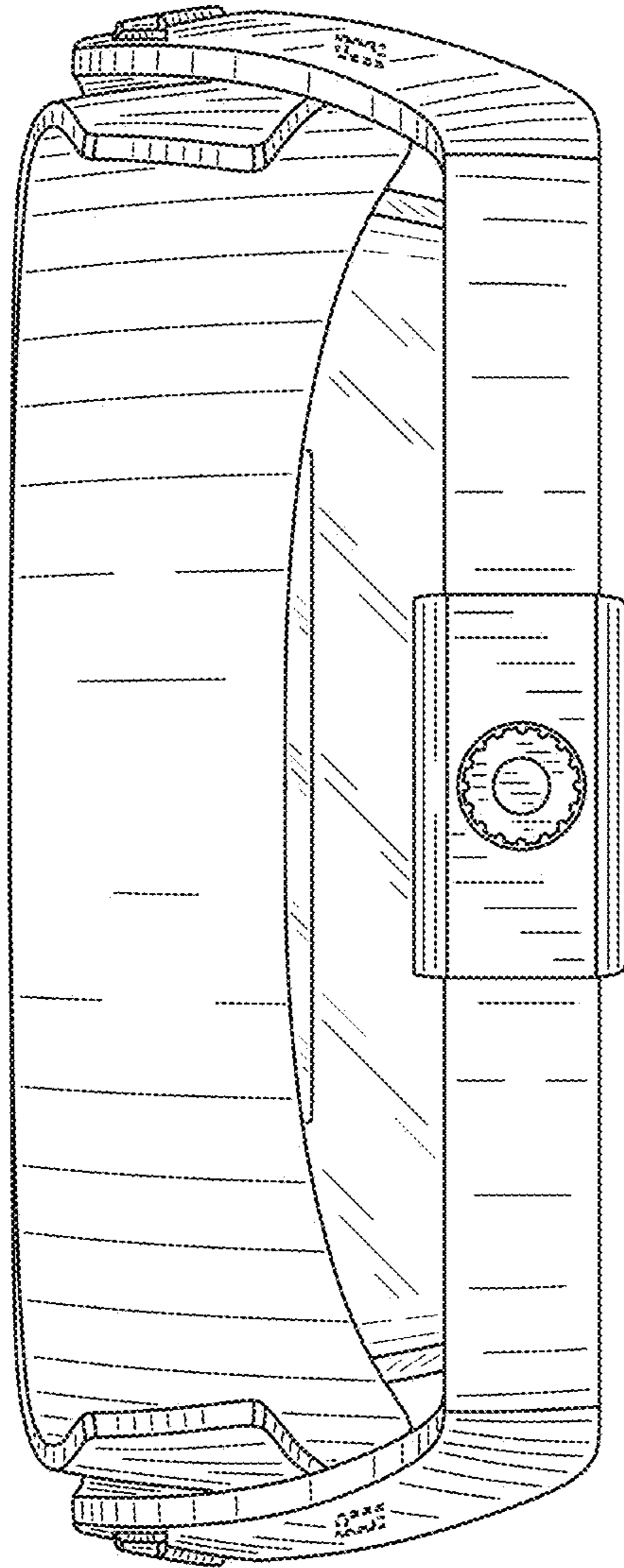

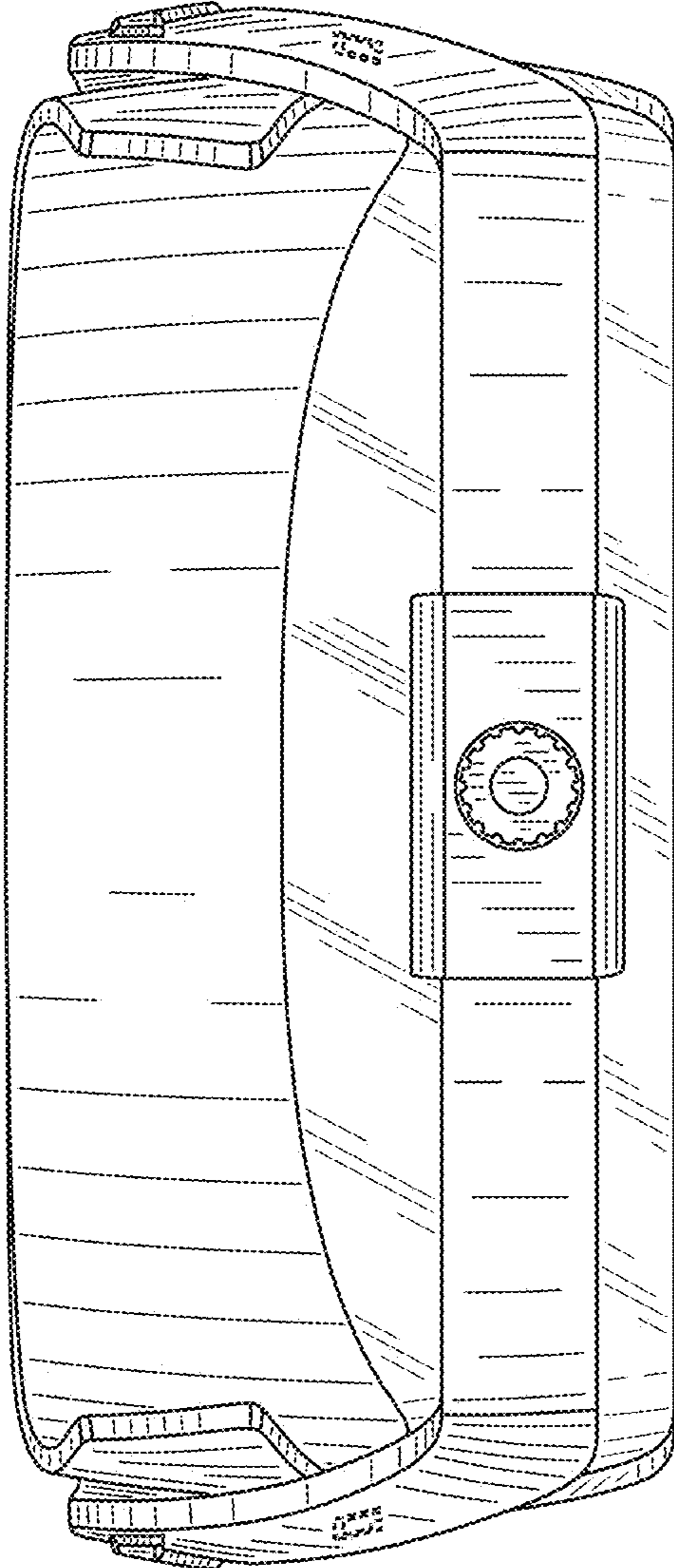

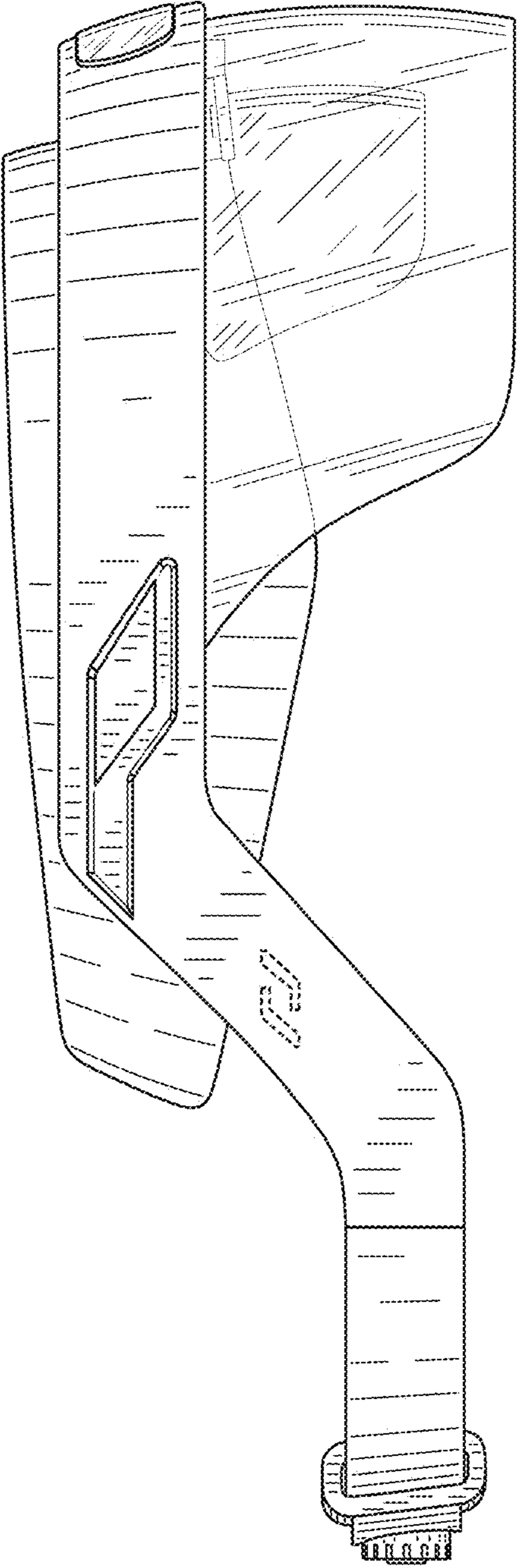

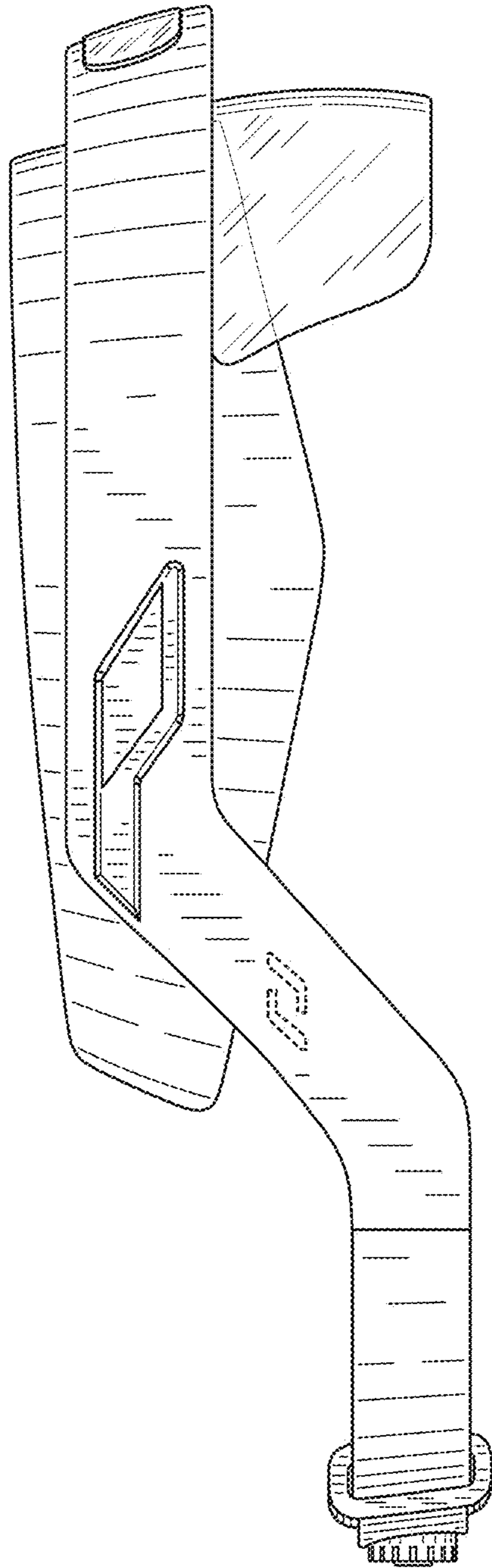

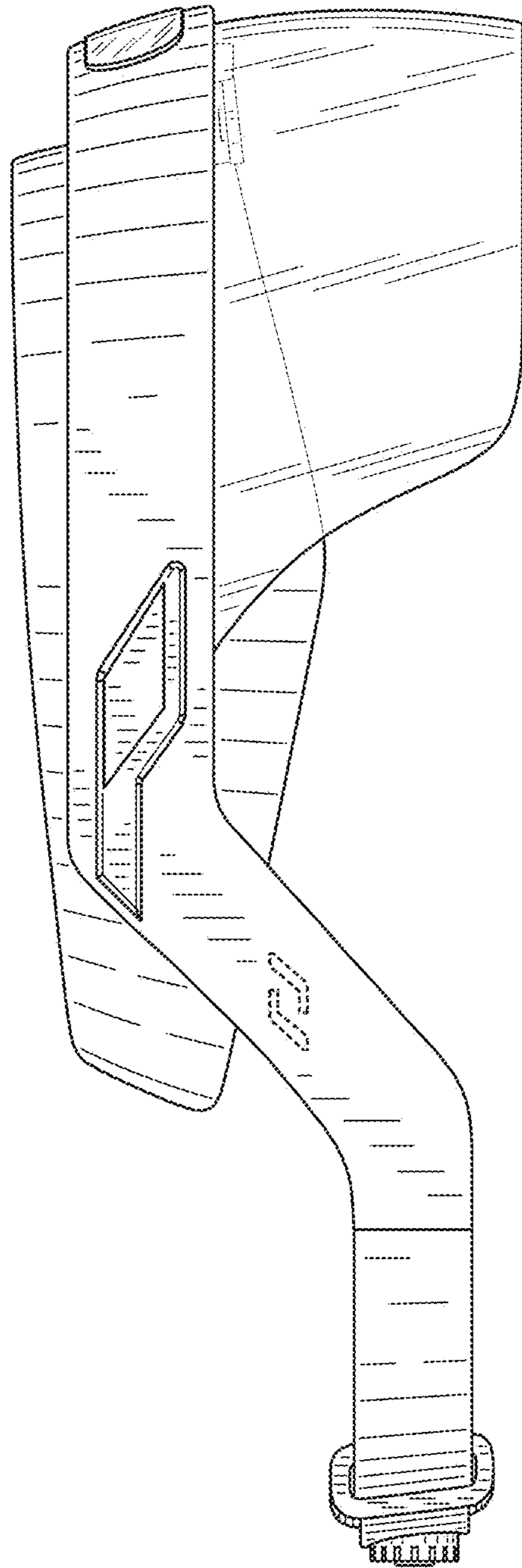

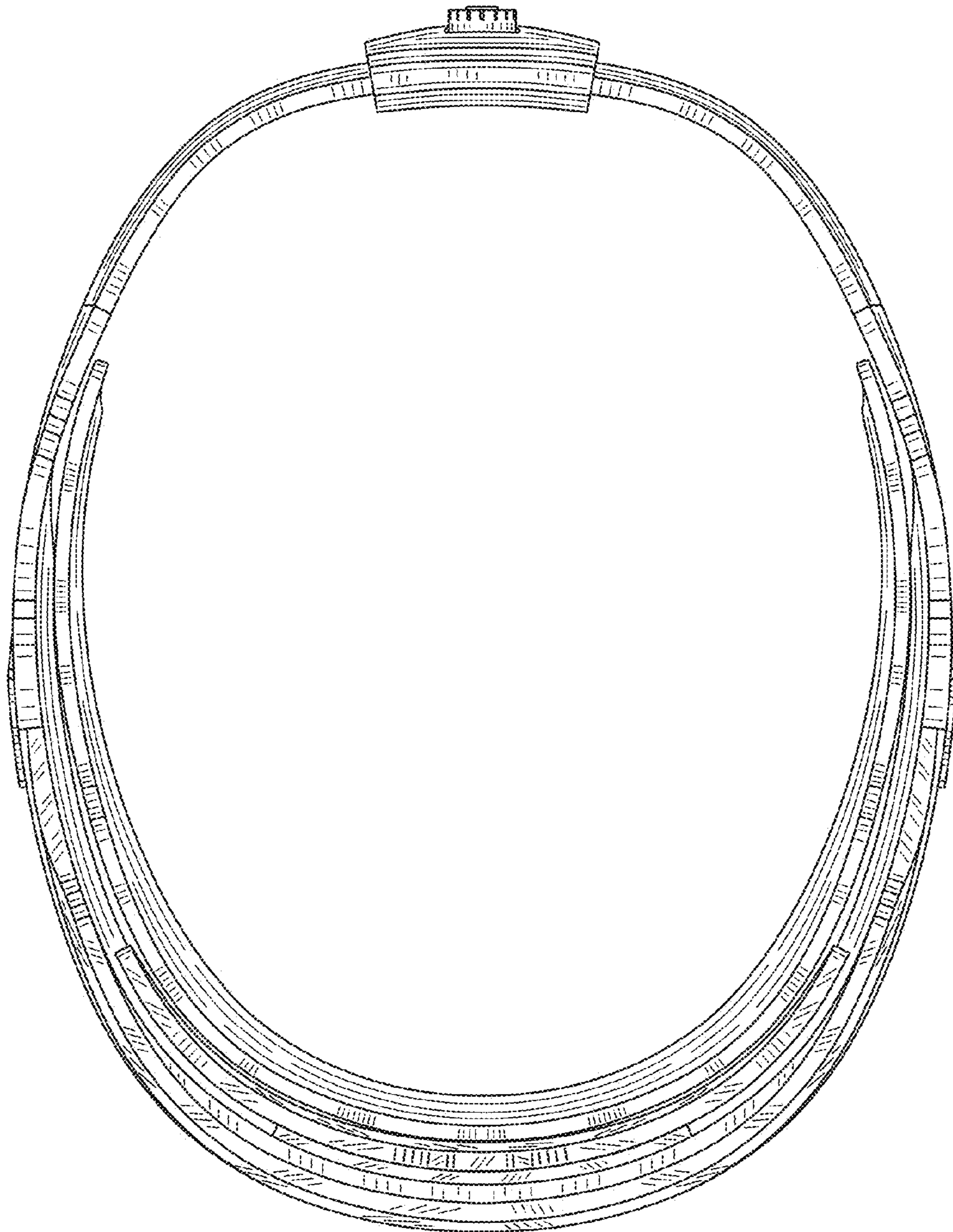

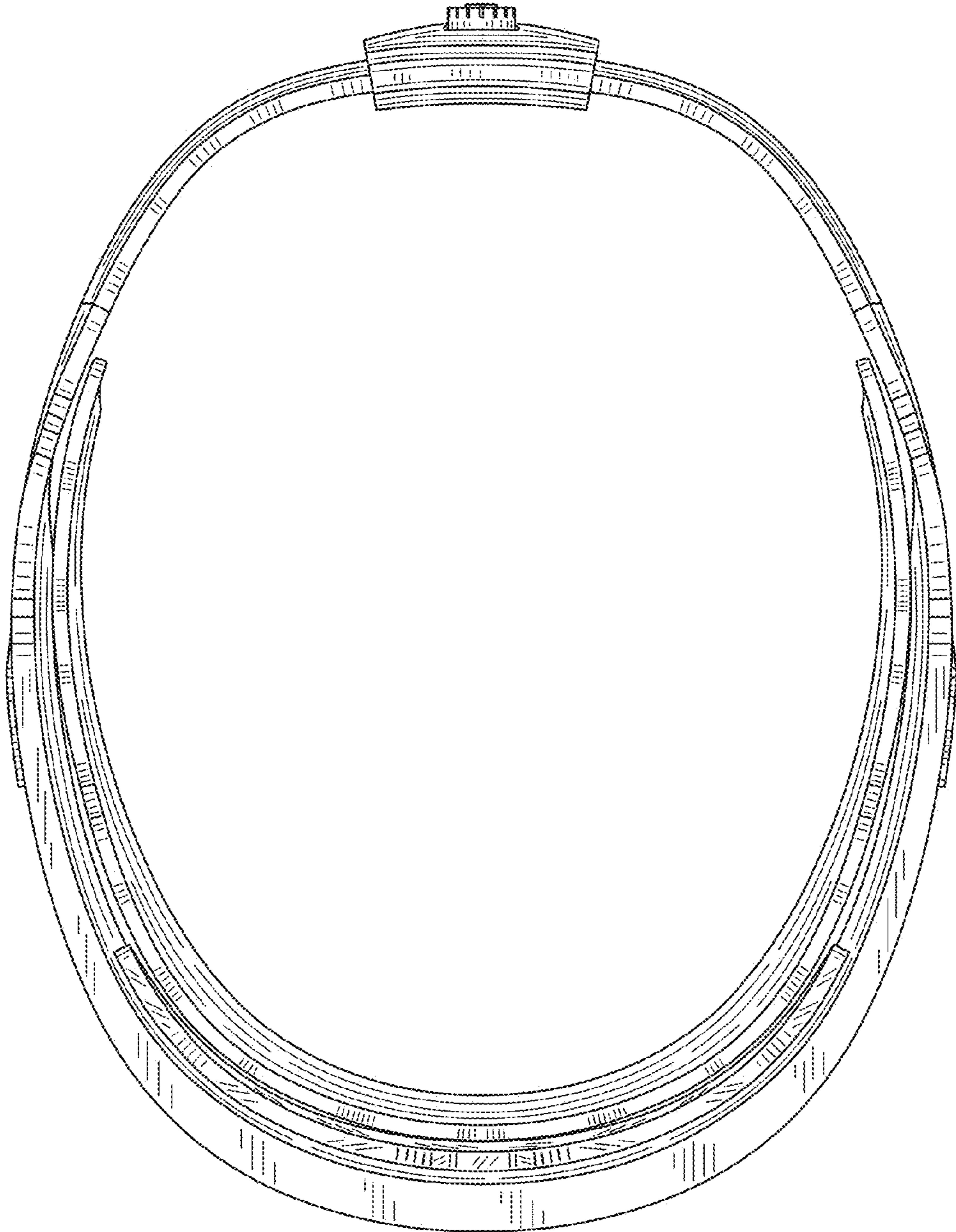

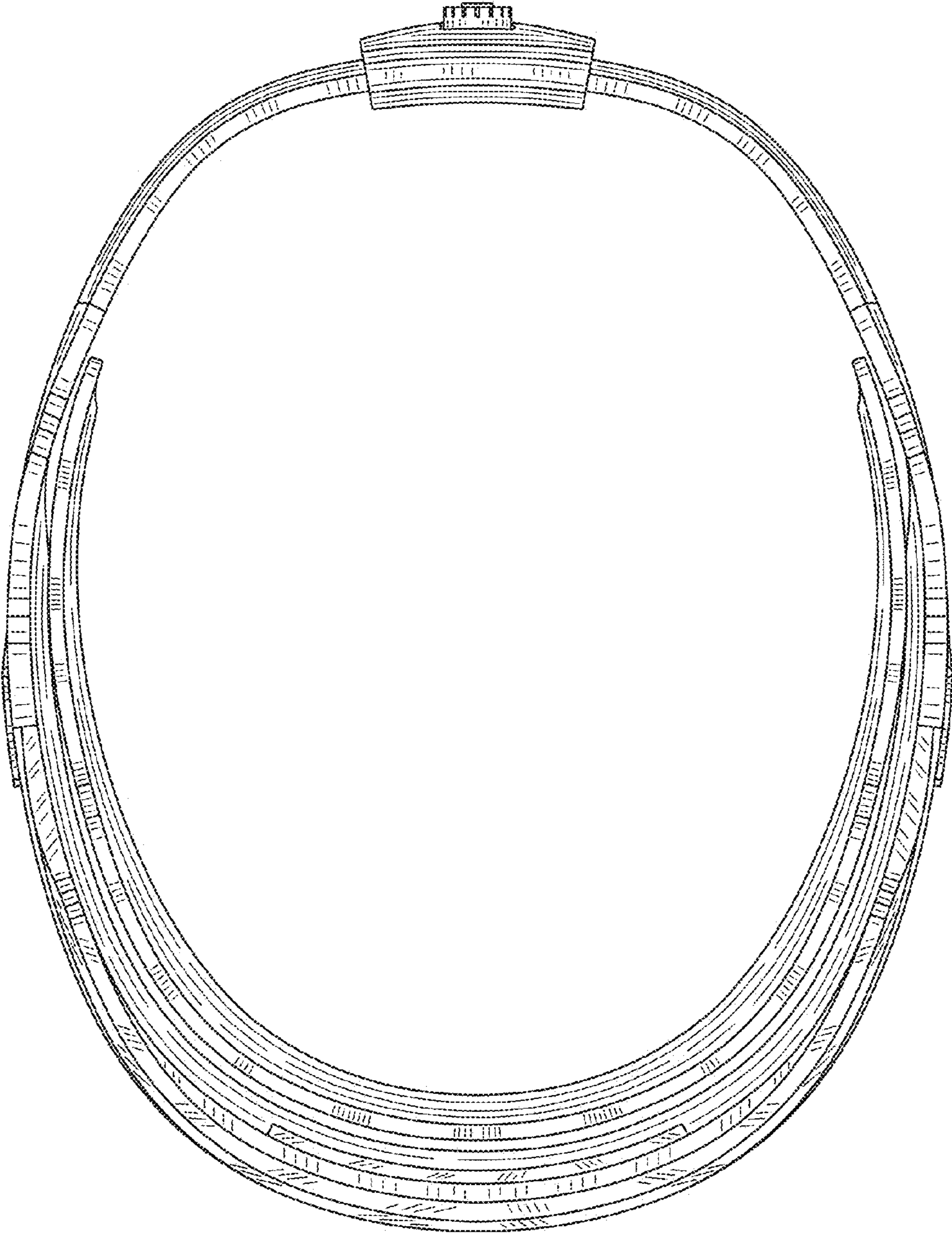

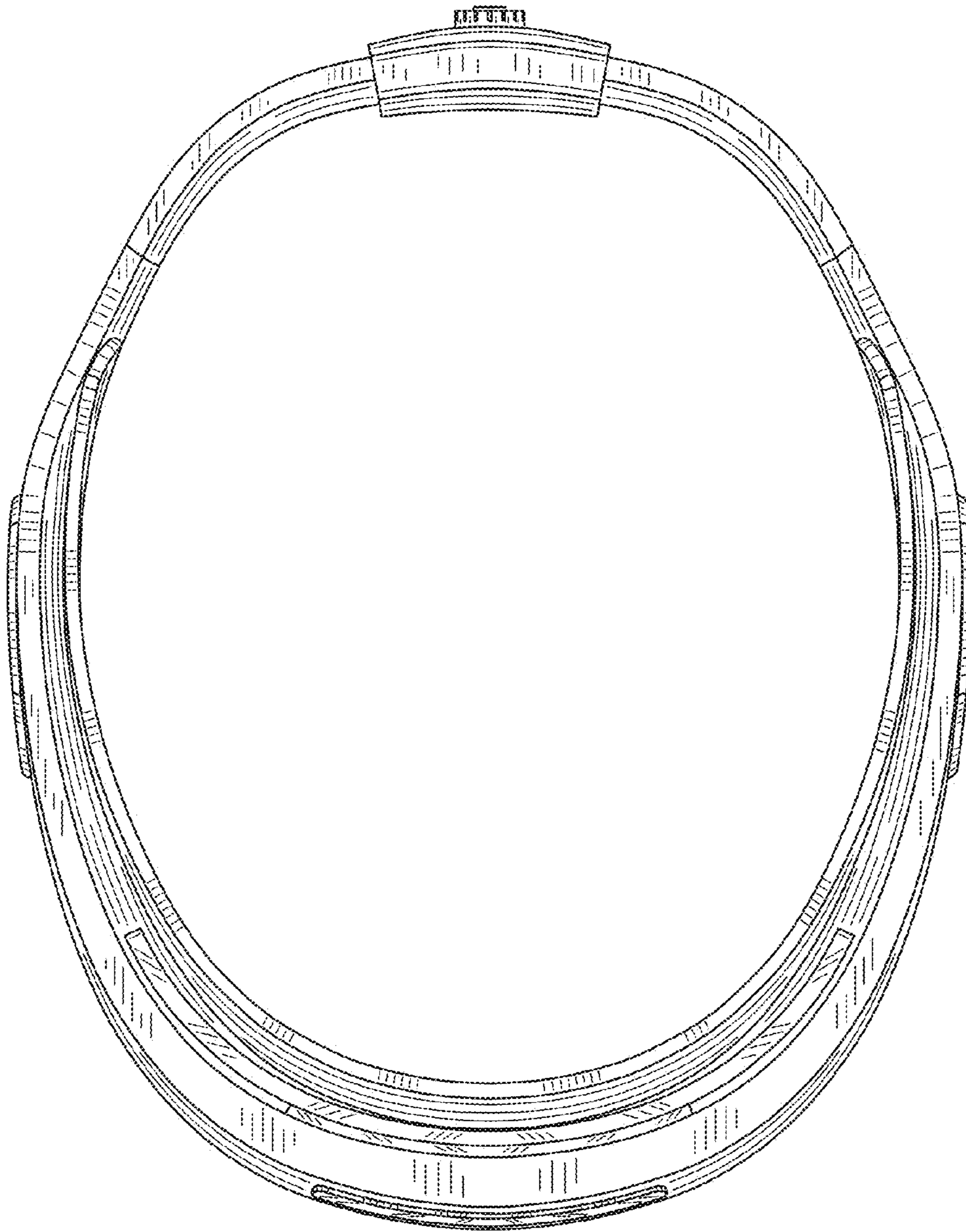
