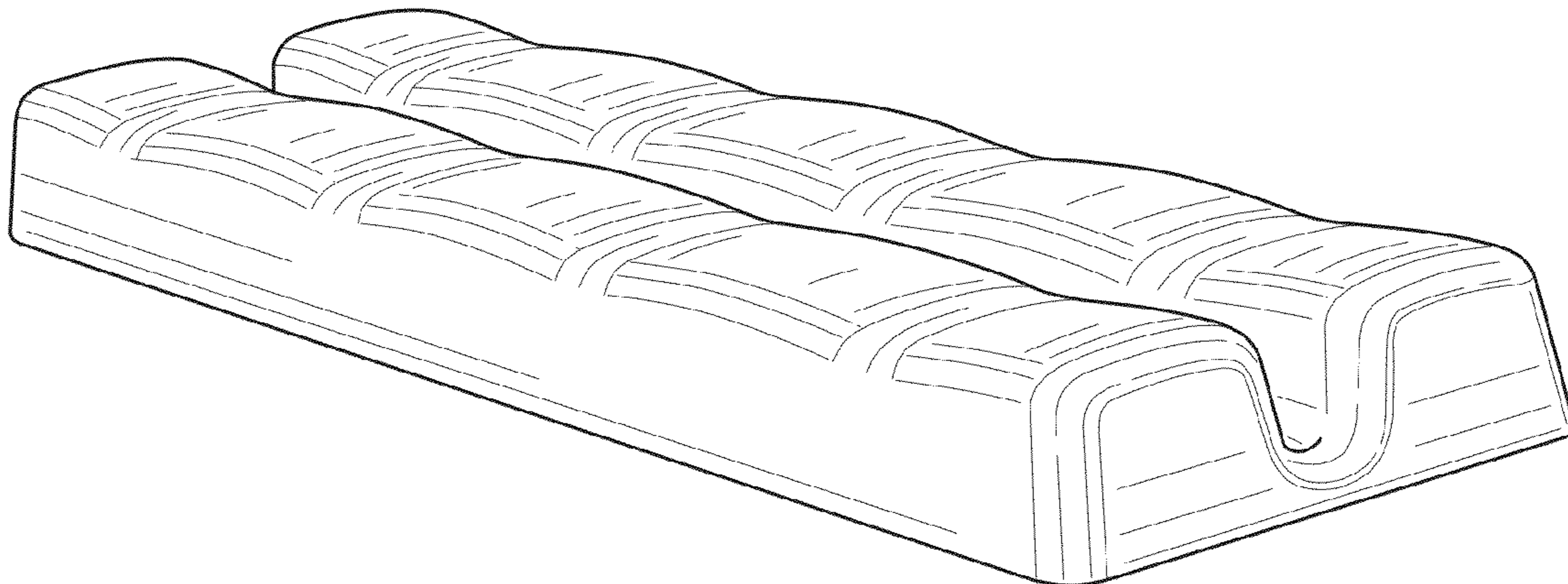
(57) **CLAIM**

The ornamental design for a chocolate-covered confection, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, left-side, and front perspective view of a chocolate-covered confection showing the new design; FIG. 2 is a left-side plan view thereof (the right-side plan view thereof is a mirror image of the left-side plan view provided in FIG. 2); FIG. 3 is a front plan view thereof (the rear plan view thereof is a mirror image of the front plan view provided in FIG. 3); and, FIG. 4 is a top plan view thereof. The surfaces or portions not shown in the drawing or described in the specification form no part of the claimed design.

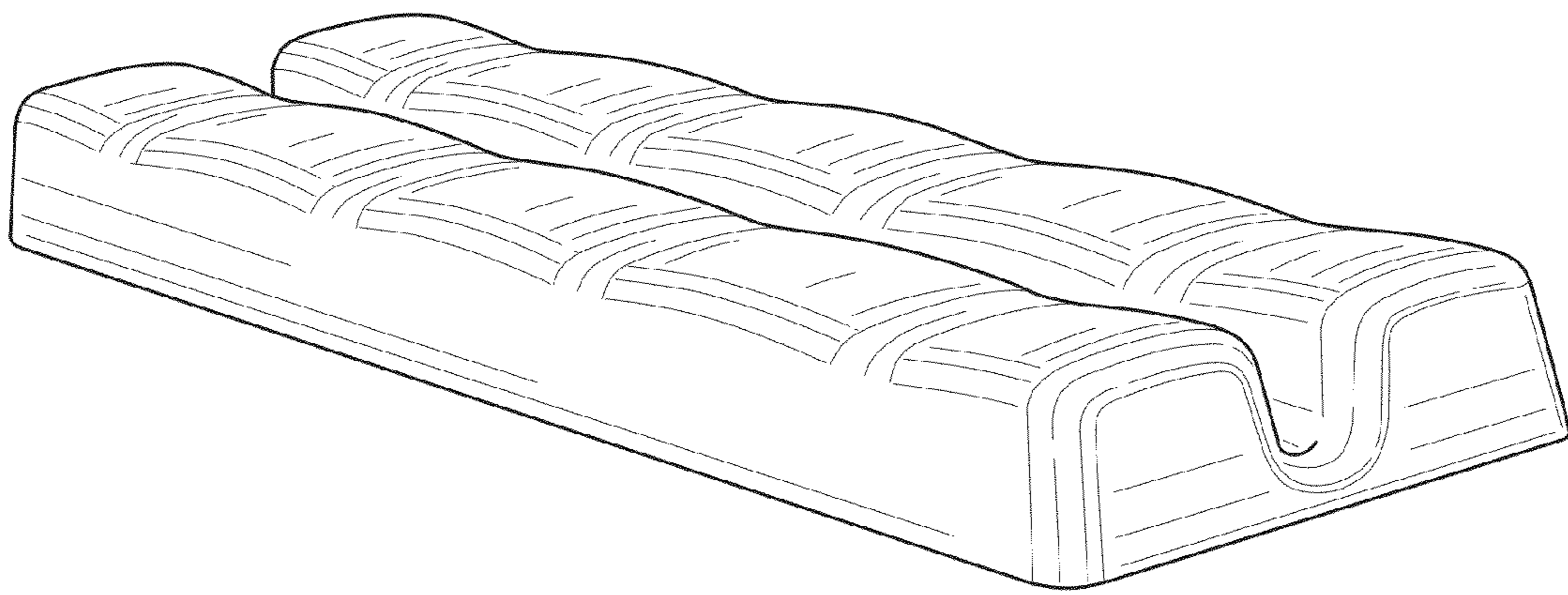

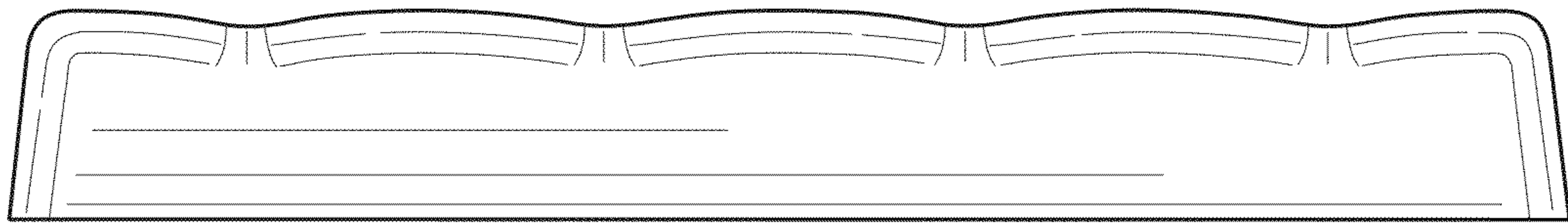

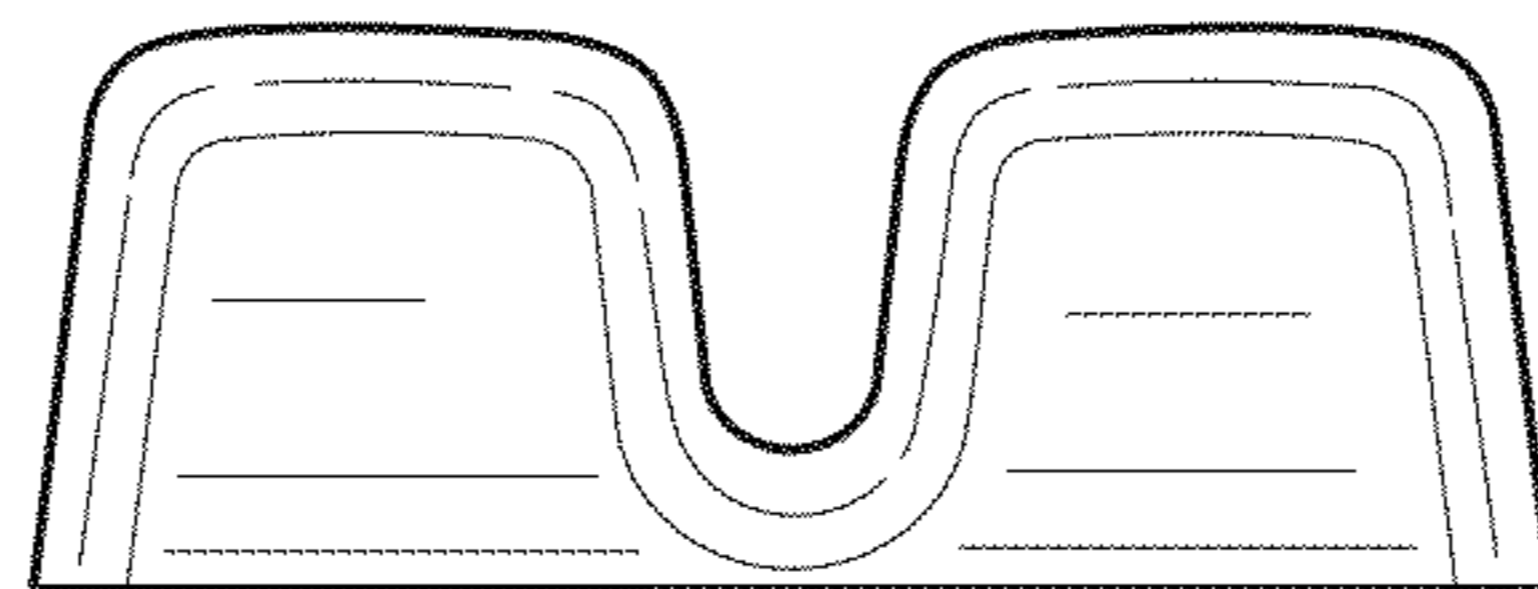

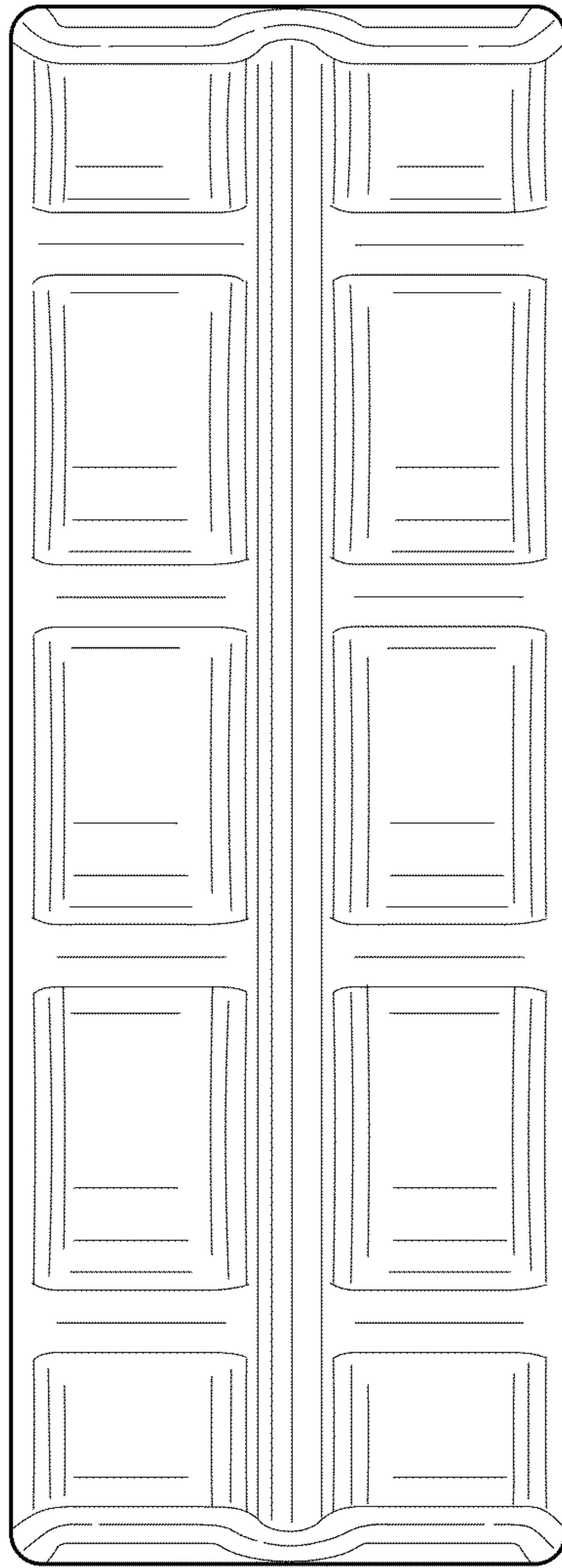
