(57) **CLAIM**

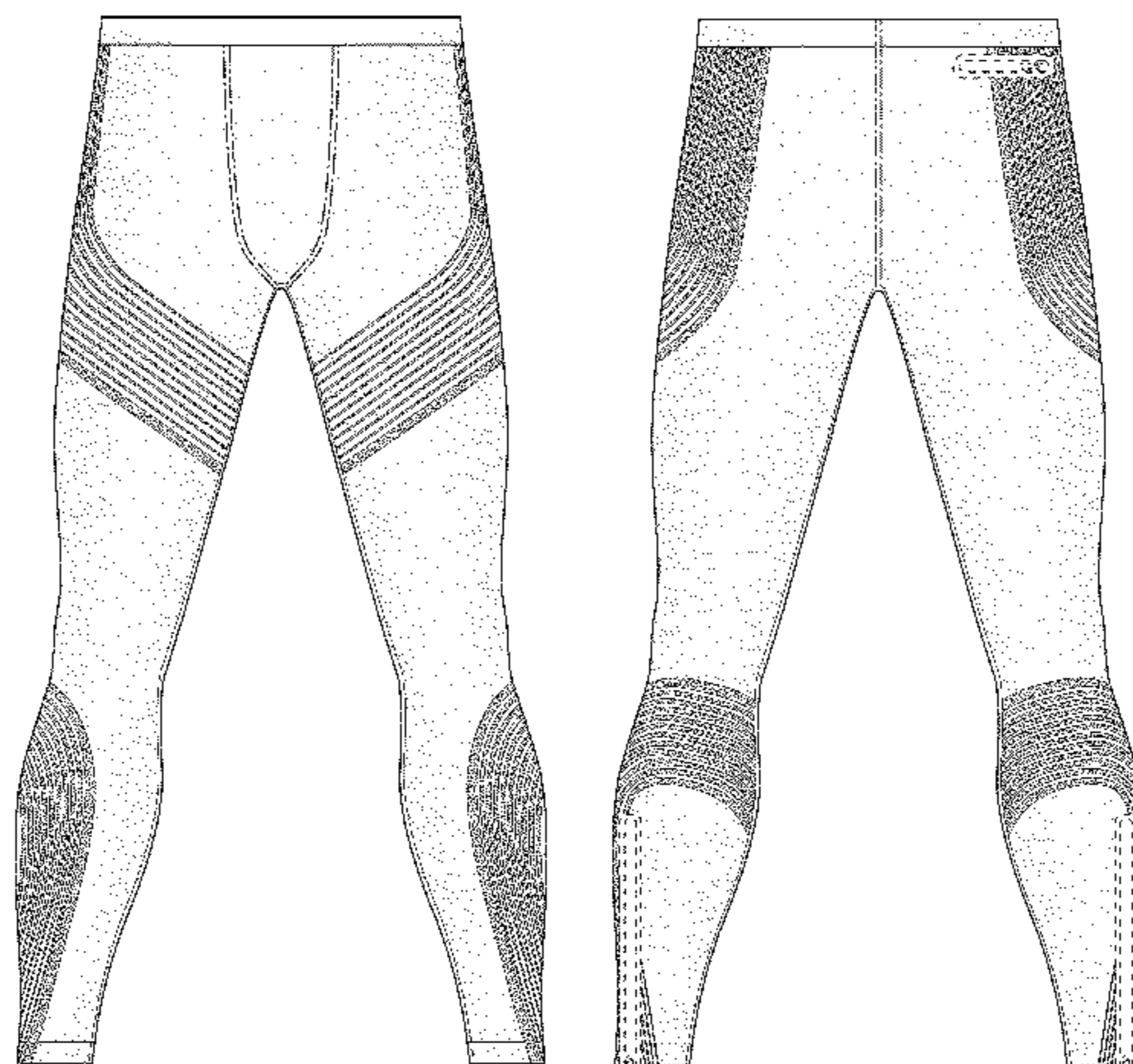
The ornamental design for pants, as shown and described.

**DESCRIPTION**

FIG. 1 is a front left perspective view of pants, showing a first embodiment of my new design;  
 FIG. 2 is a rear right perspective view thereof;  
 FIG. 3 is a front view thereof;  
 FIG. 4 is a rear view thereof;  
 FIG. 5 is a right side view thereof;  
 FIG. 6 is a left side view thereof;  
 FIG. 7 is a front left perspective view of the pants, showing a second embodiment of the design;  
 FIG. 8 is a rear right perspective view thereof;  
 FIG. 9 is a front view thereof;  
 FIG. 10 is a rear view thereof;  
 FIG. 11 is a right side view thereof; and,  
 FIG. 12 is a left side view thereof.

The uneven-length broken lines within the shaded area in FIGS. 1-12 represents unclaimed stitching and seams and forms no part of the claimed design. The generally horizontally-oriented even-length broken line region located in the upper-rear portion of the pants and generally vertically-oriented even-length broken line region located in the lower-rear portion of the pants in FIGS. 1-12 represent an unclaimed zipper regions and forms no part of the claimed design. The contrast in stipple shading in FIGS. 1-12 represents a contrast of appearance and does not represent any particular color, texture, or material.

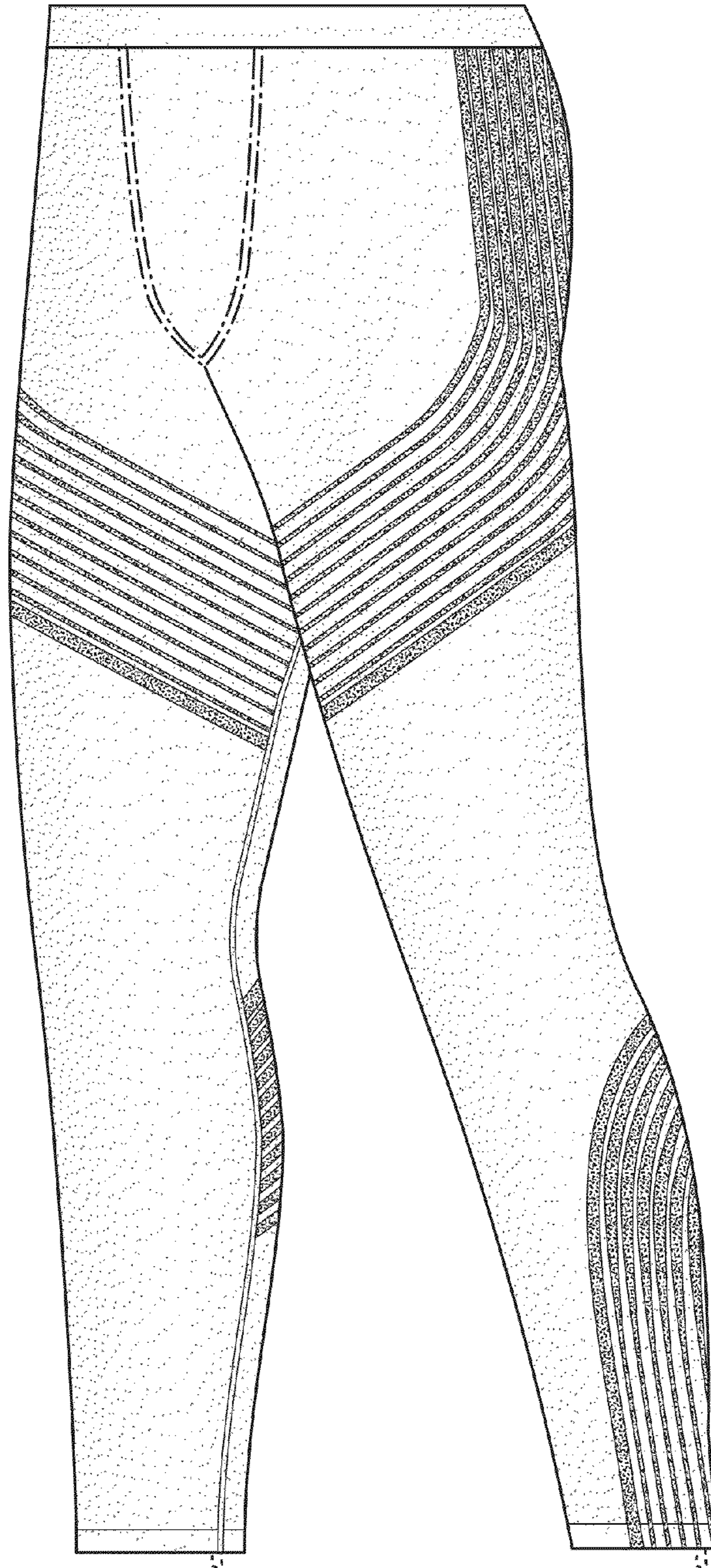

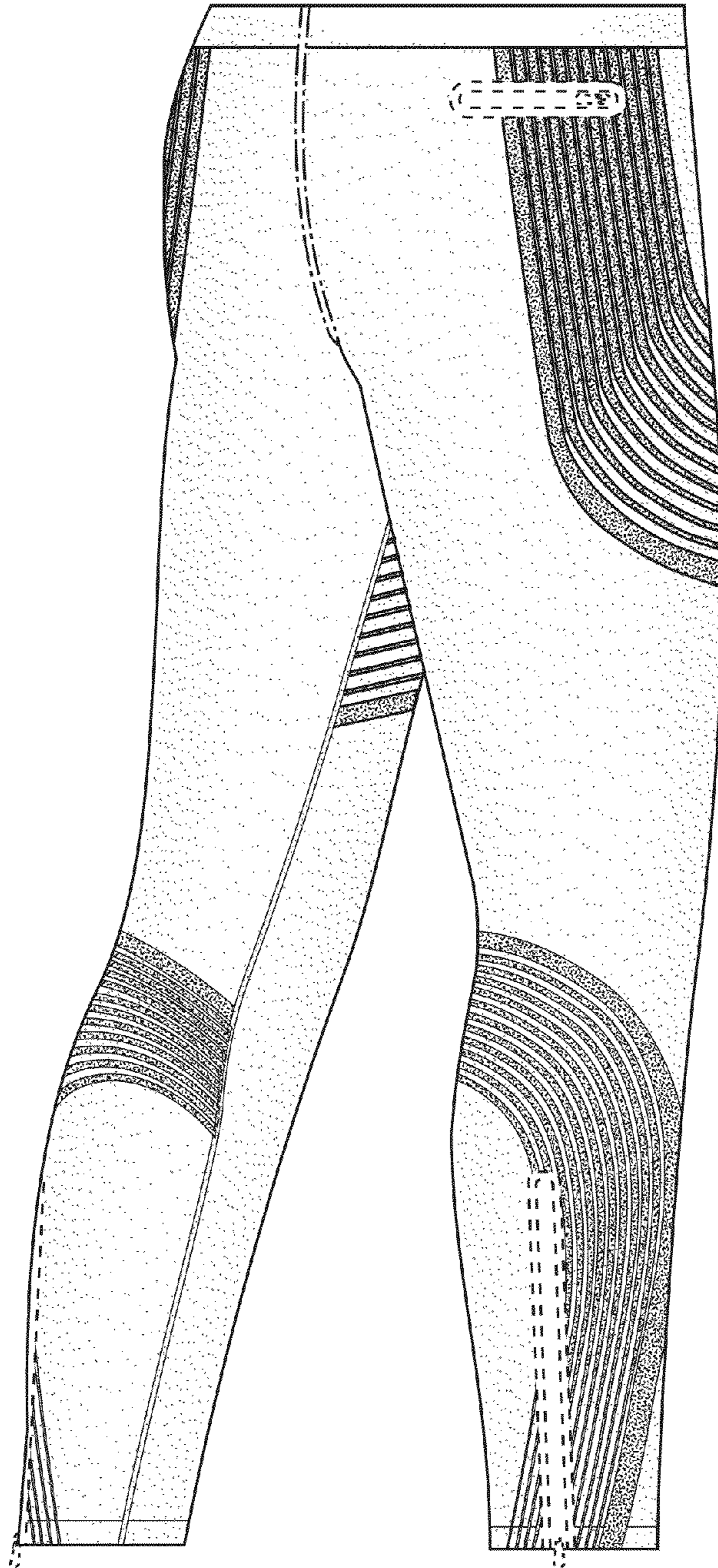

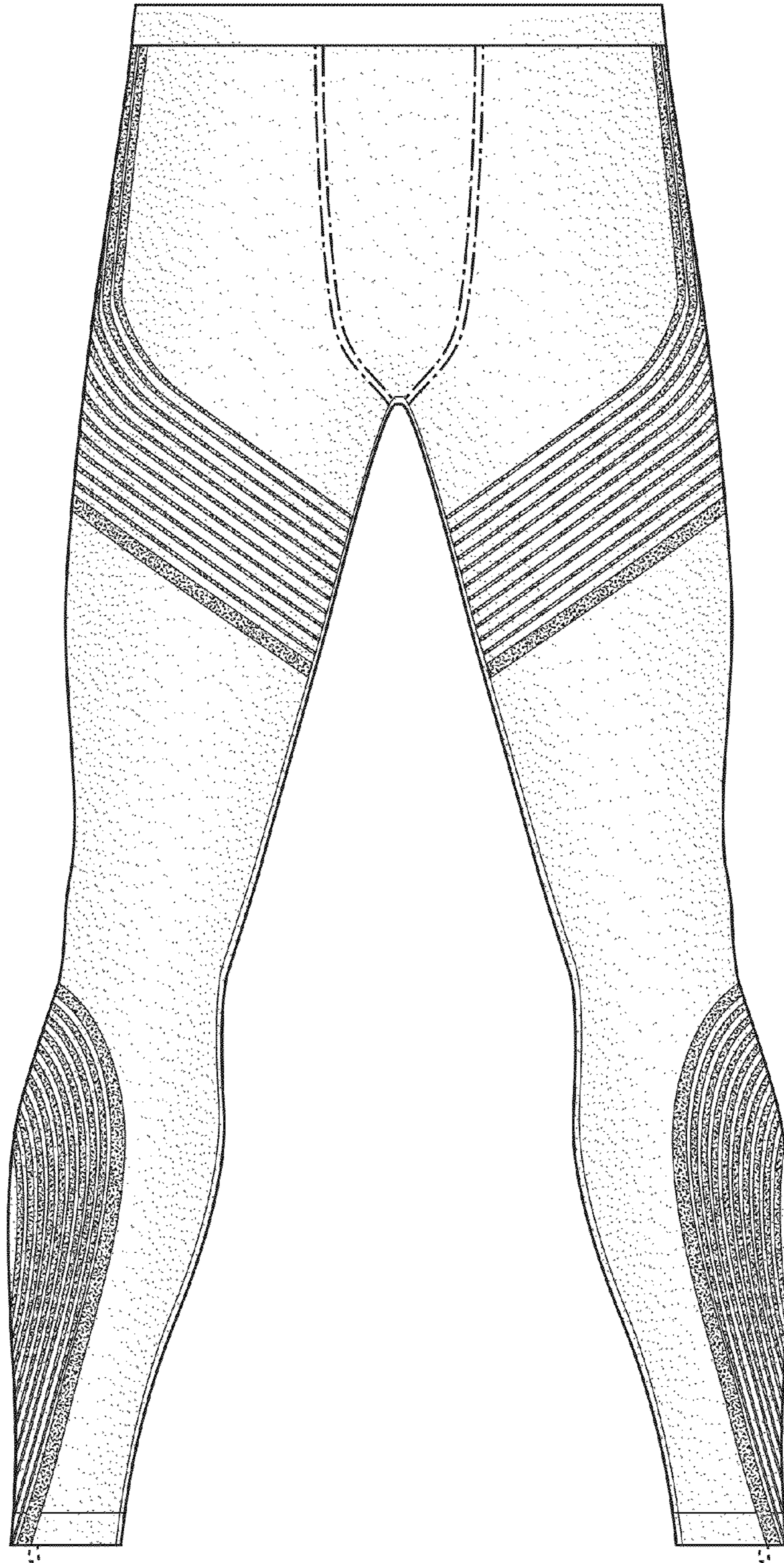

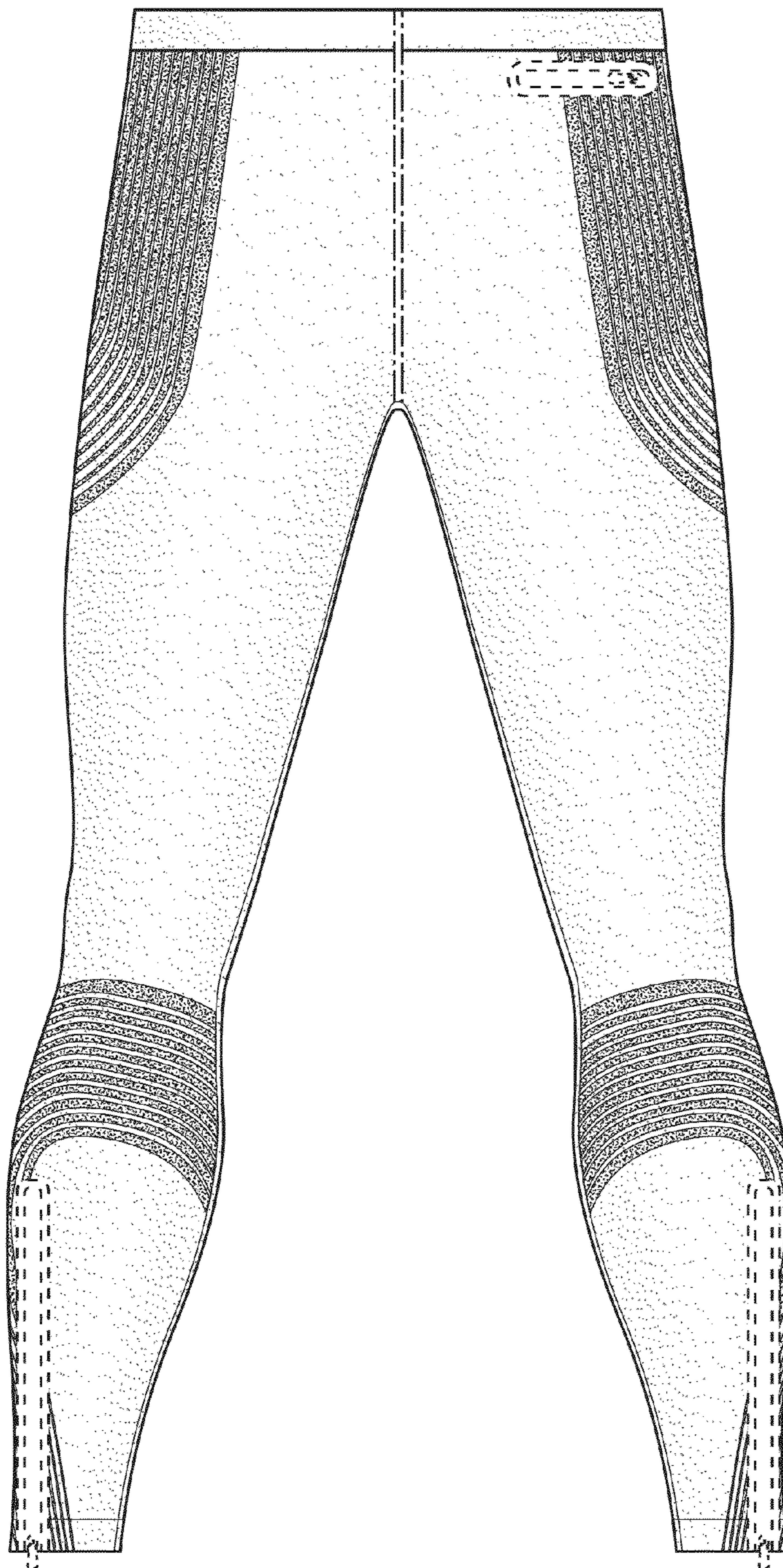

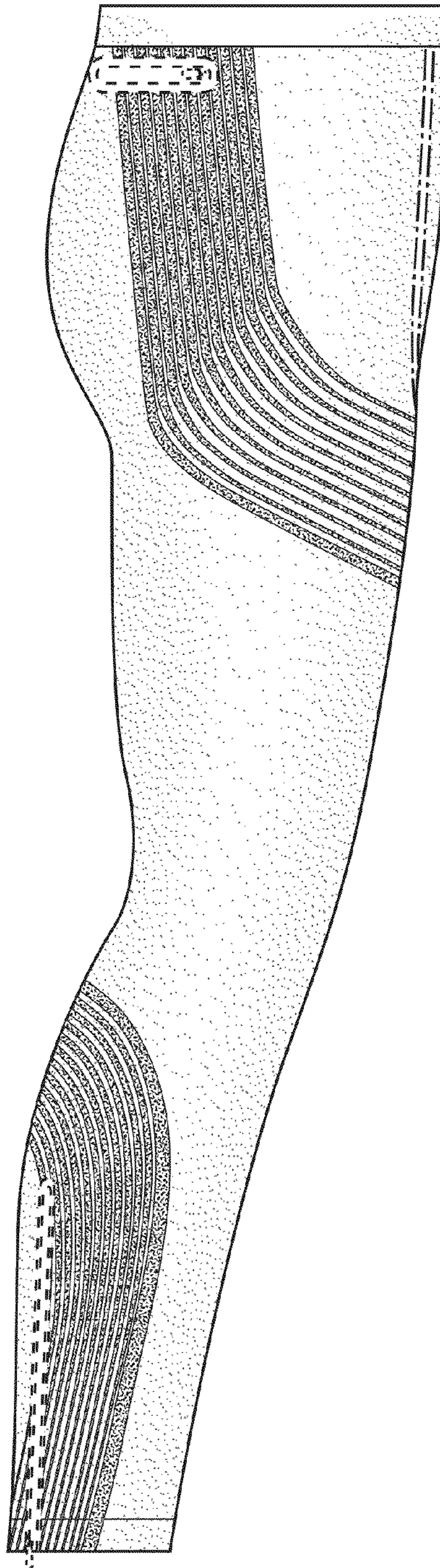

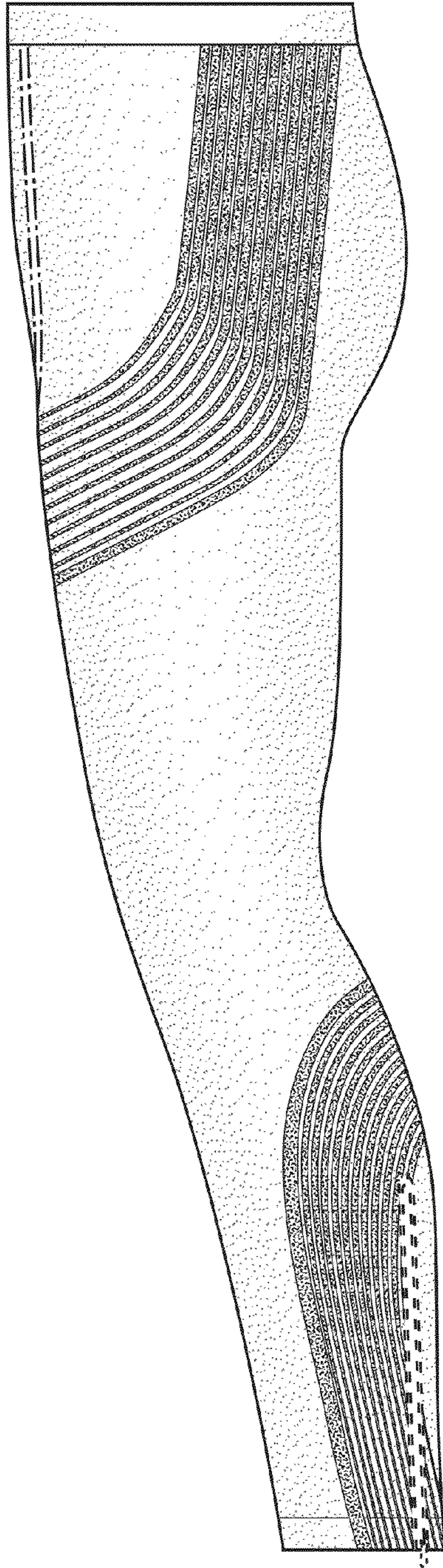

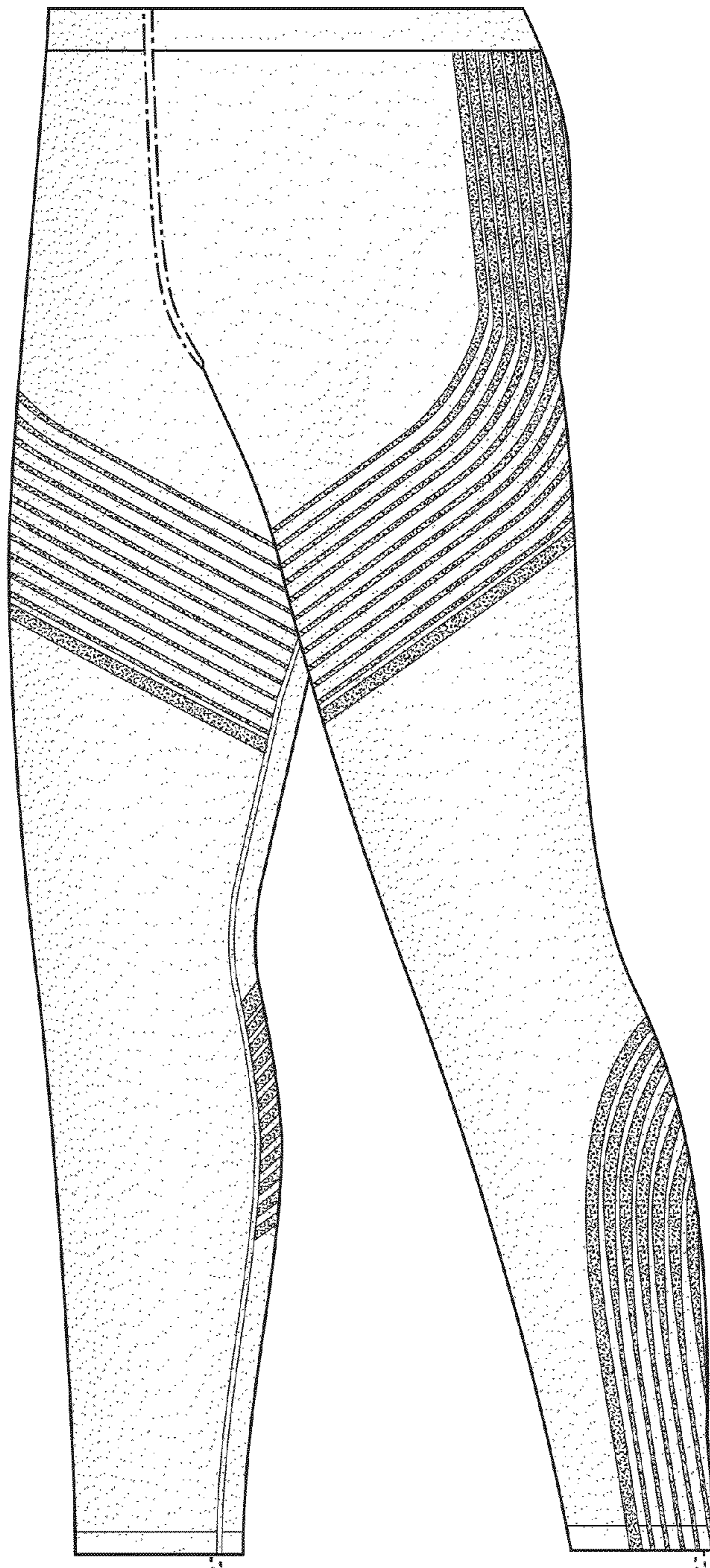

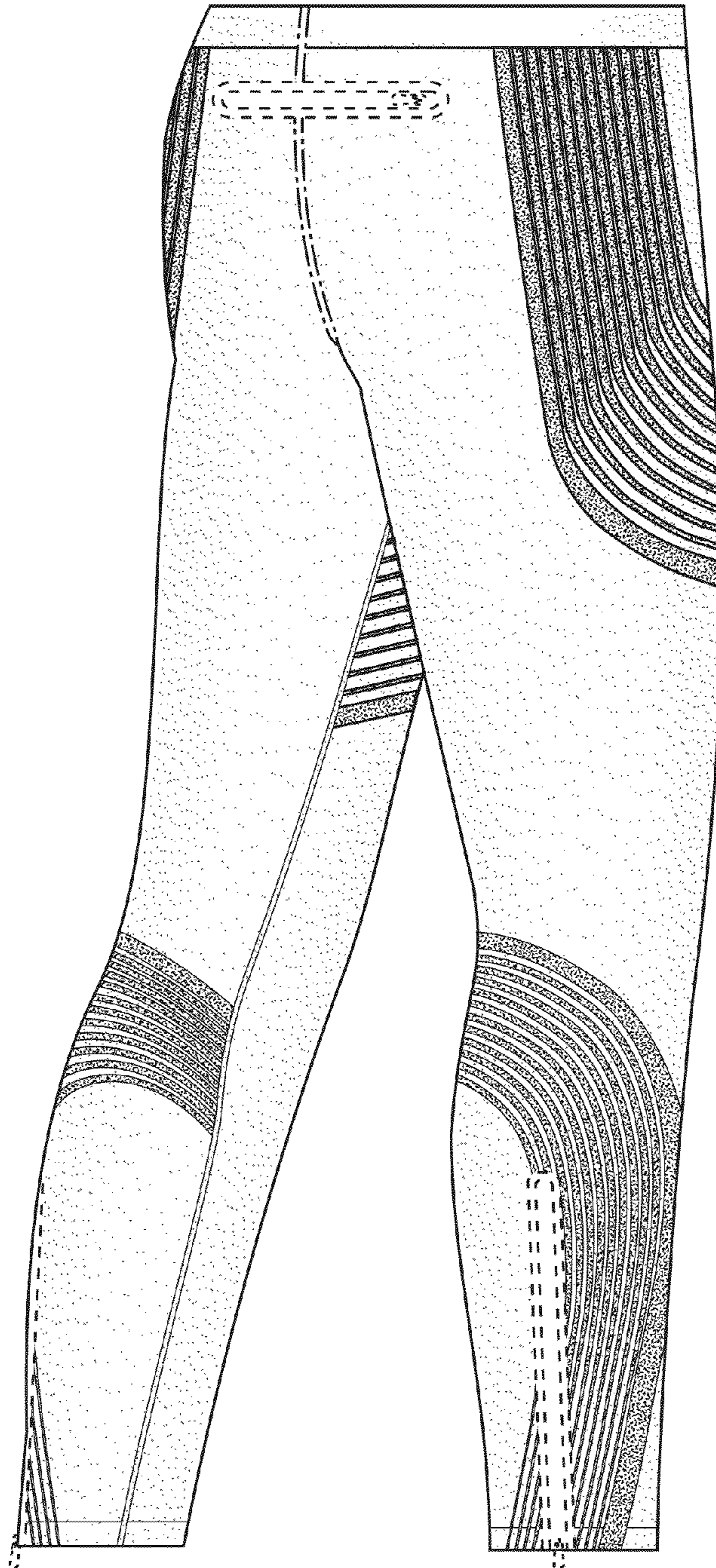

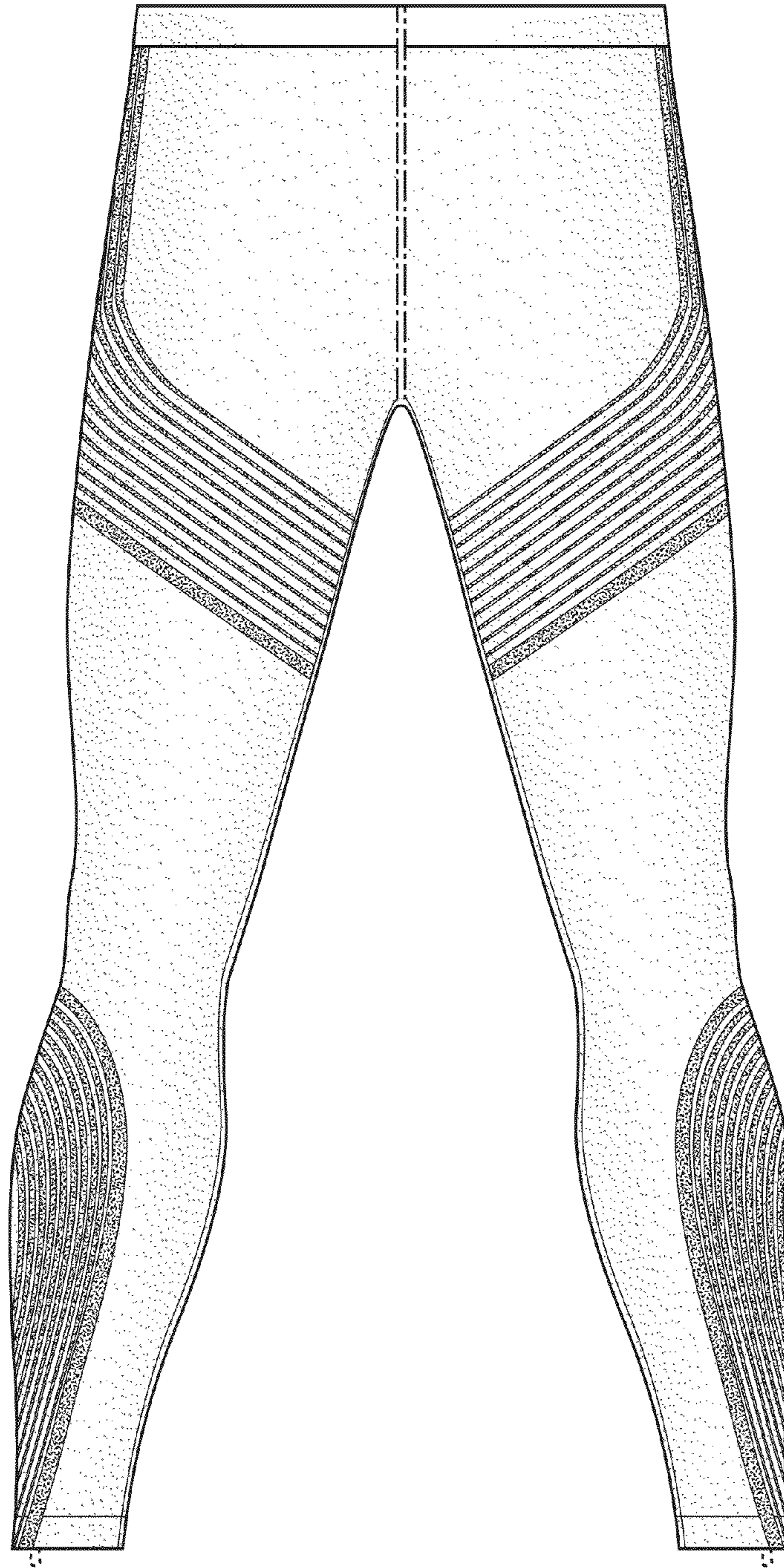




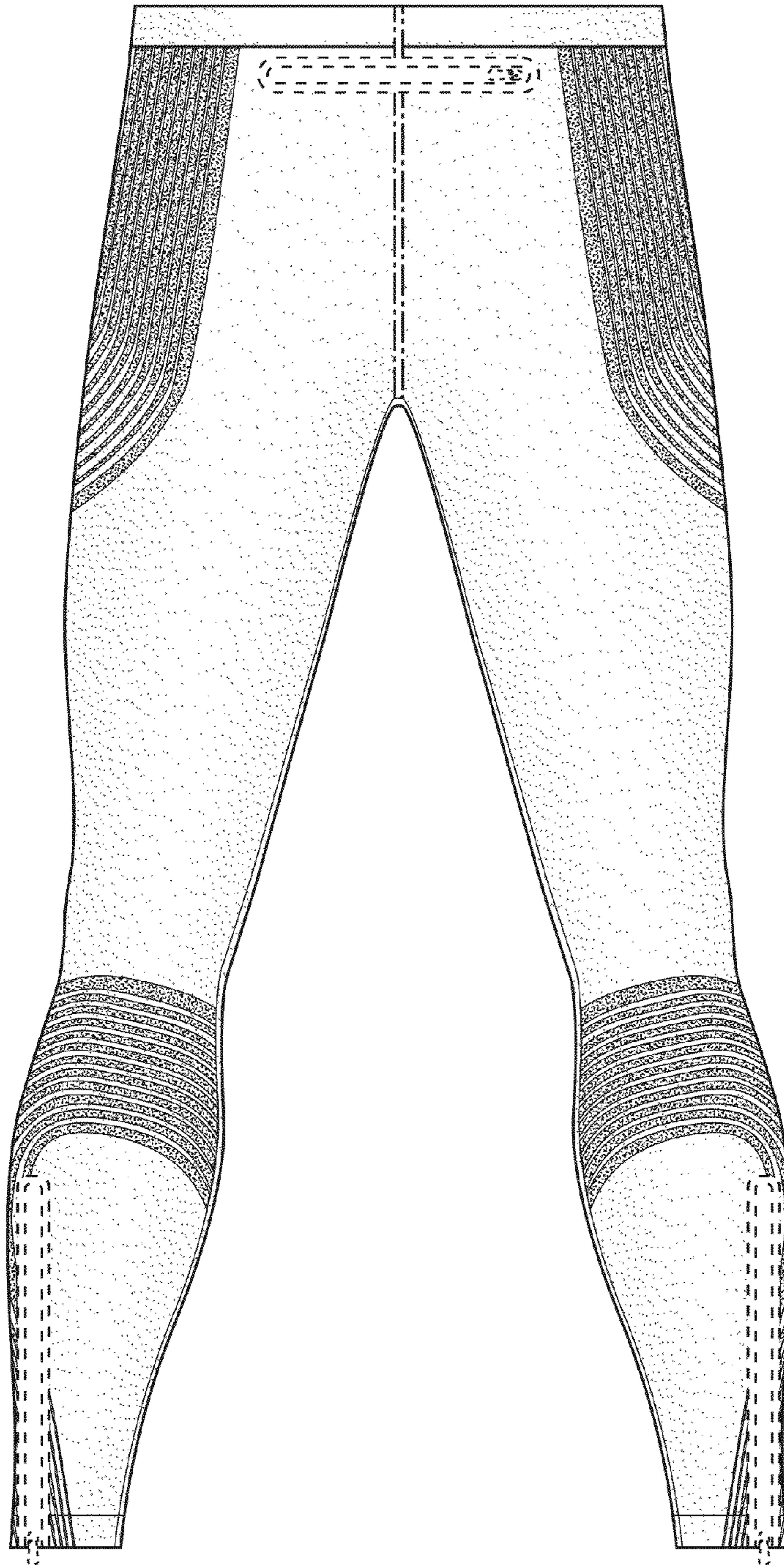

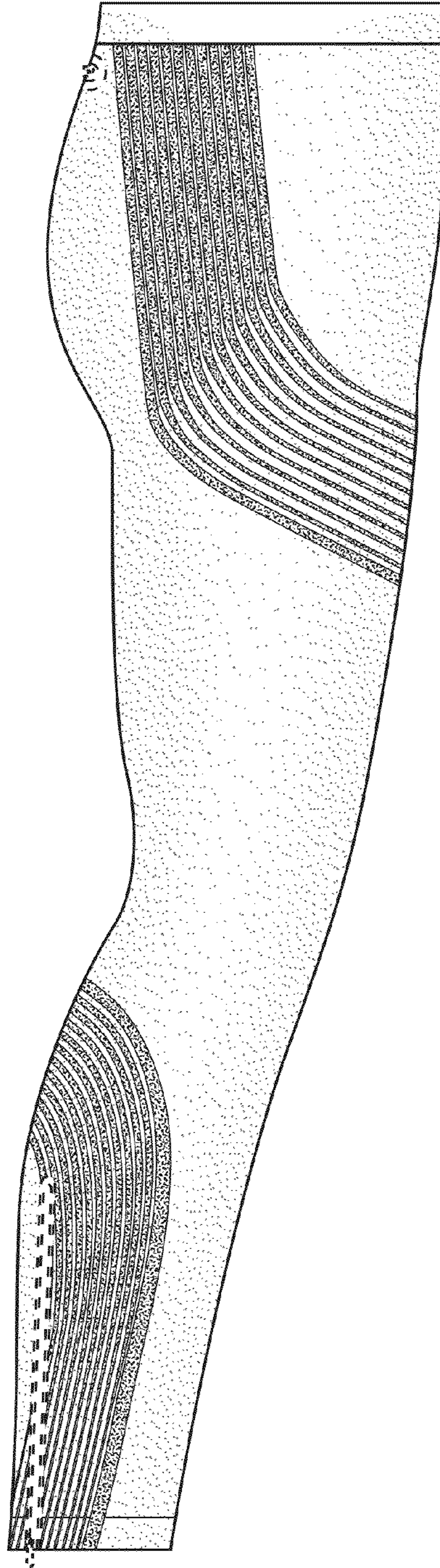

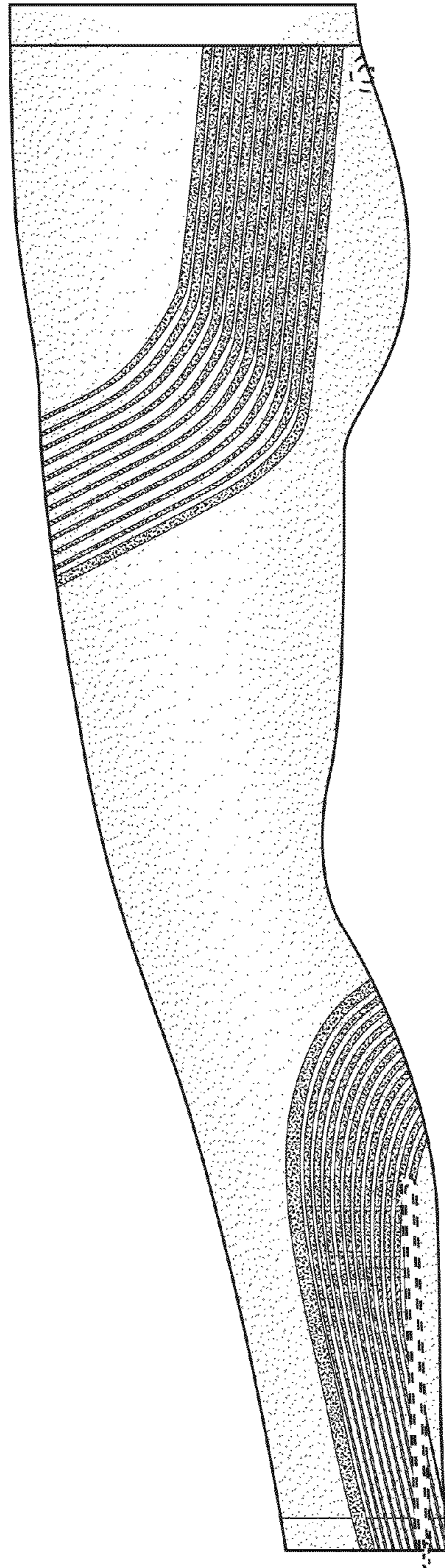
