DESCRIPTION

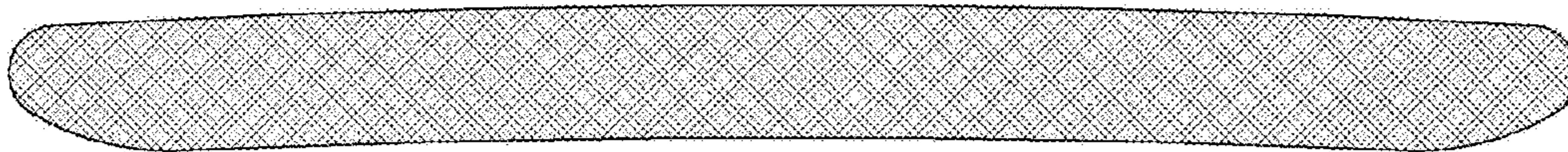
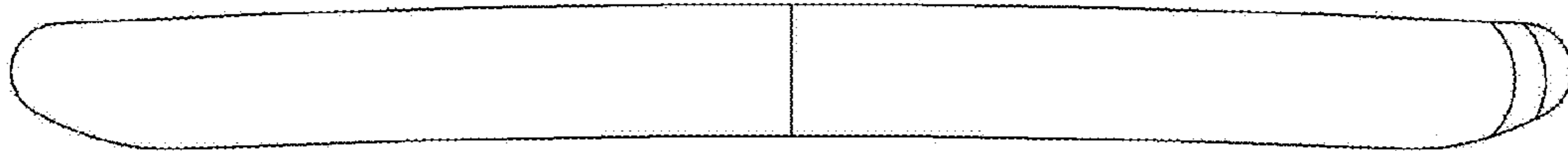
FIG. 1 is a front view of a garment liner showing the new design;

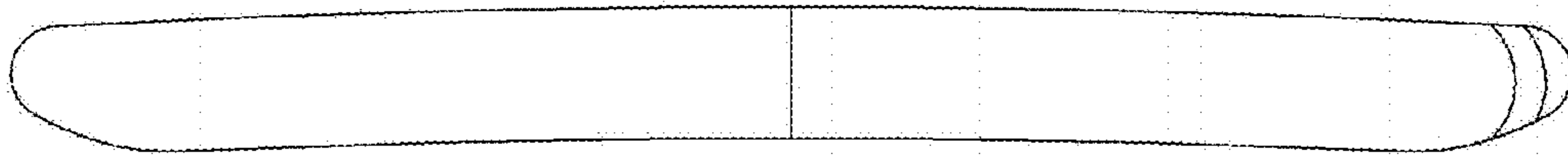

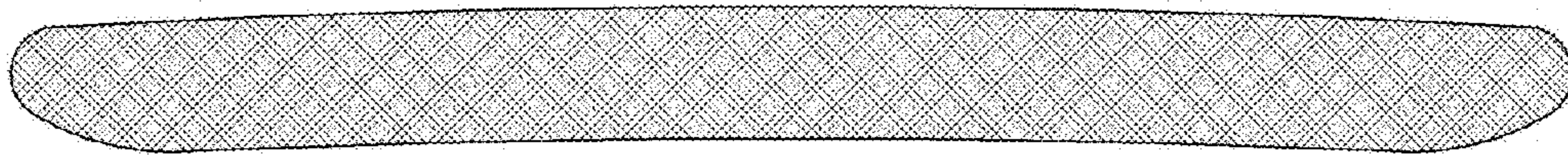

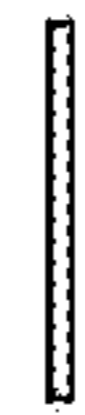
