The ornamental design for a wide brimmed hat, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a hat showing my new design;

FIG. 2 is a top plan view thereof;

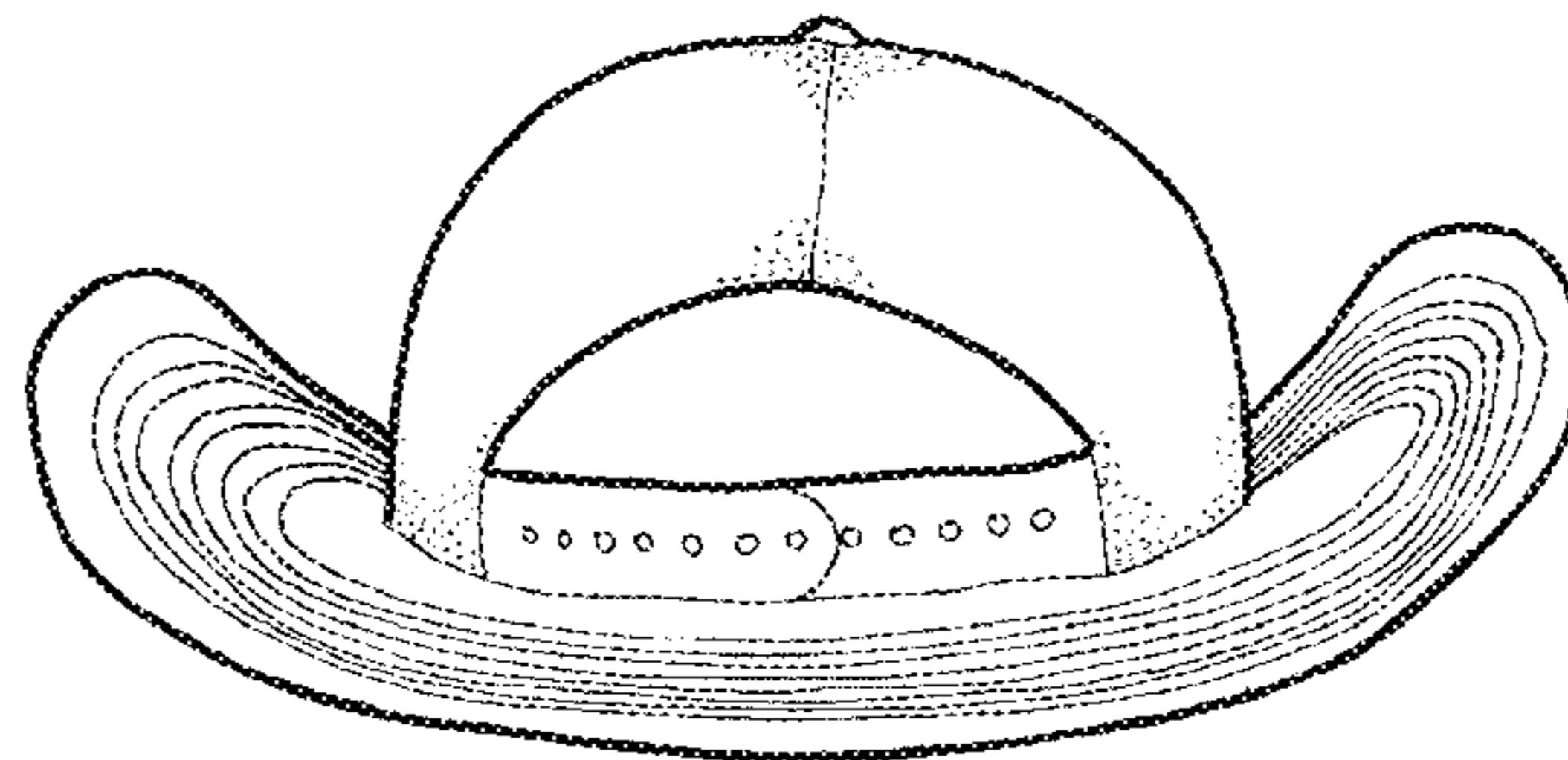
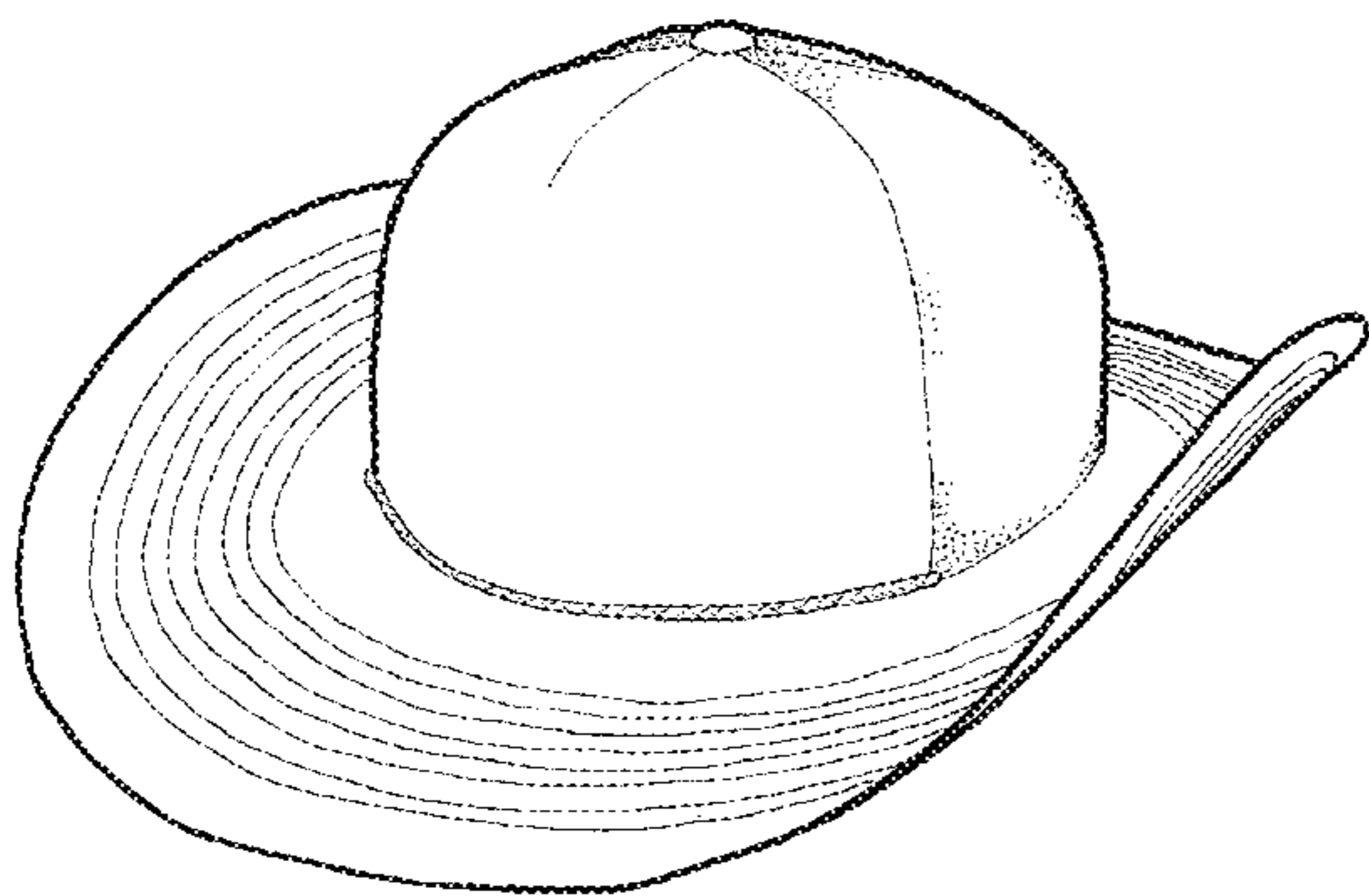
FIG. 3 is a back elevational view thereof;

FIG. 4 is a left side elevational view thereof, the right side being a mirror image; and,

FIG. 5 is a cross-section view taken along the line 5-5 shown in FIG. 2.

The broken-line indicia shown in FIG. 2 illustrate the line from which the cross-section 5-5 is taken and form no part of the claimed design.

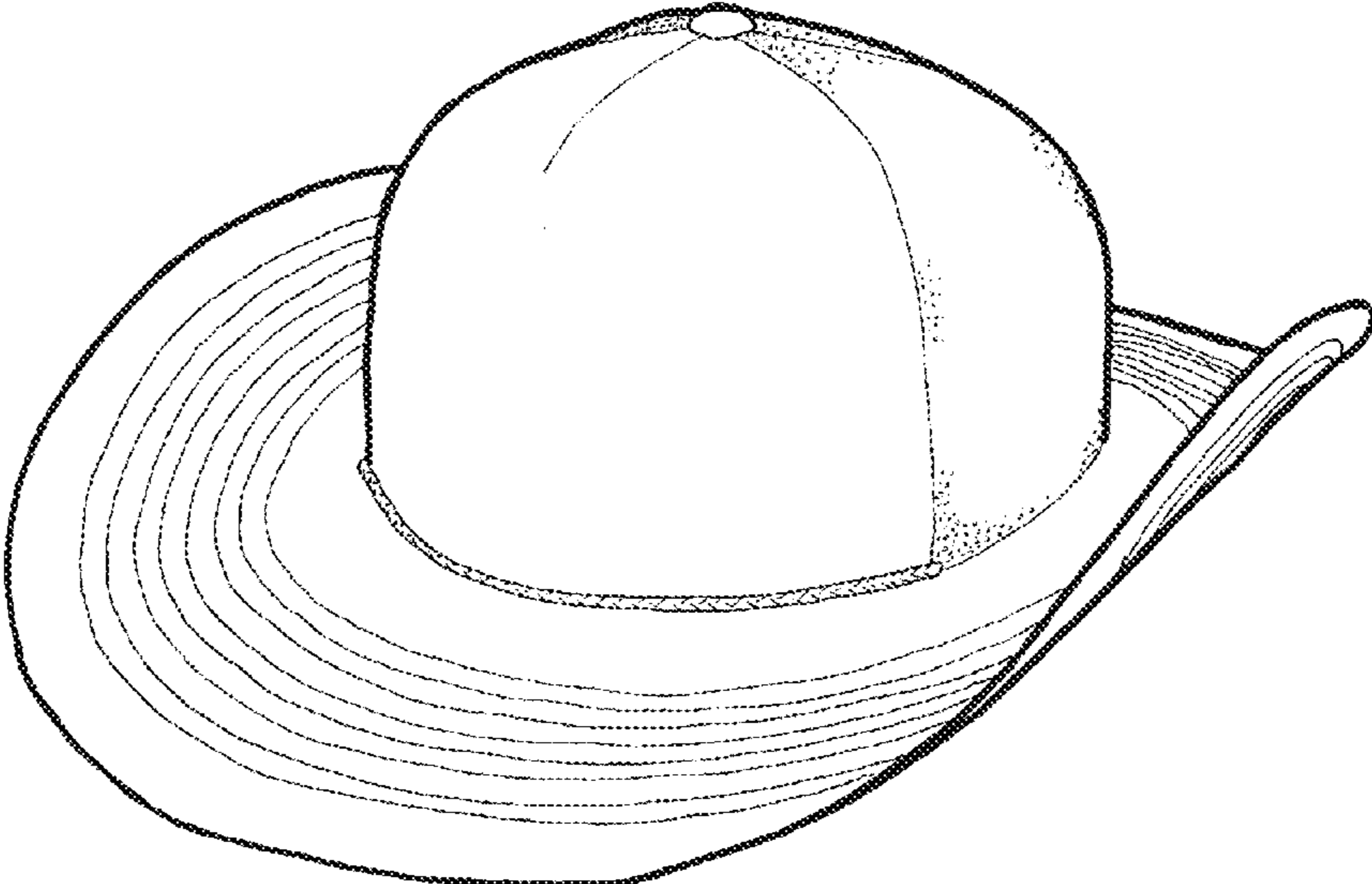

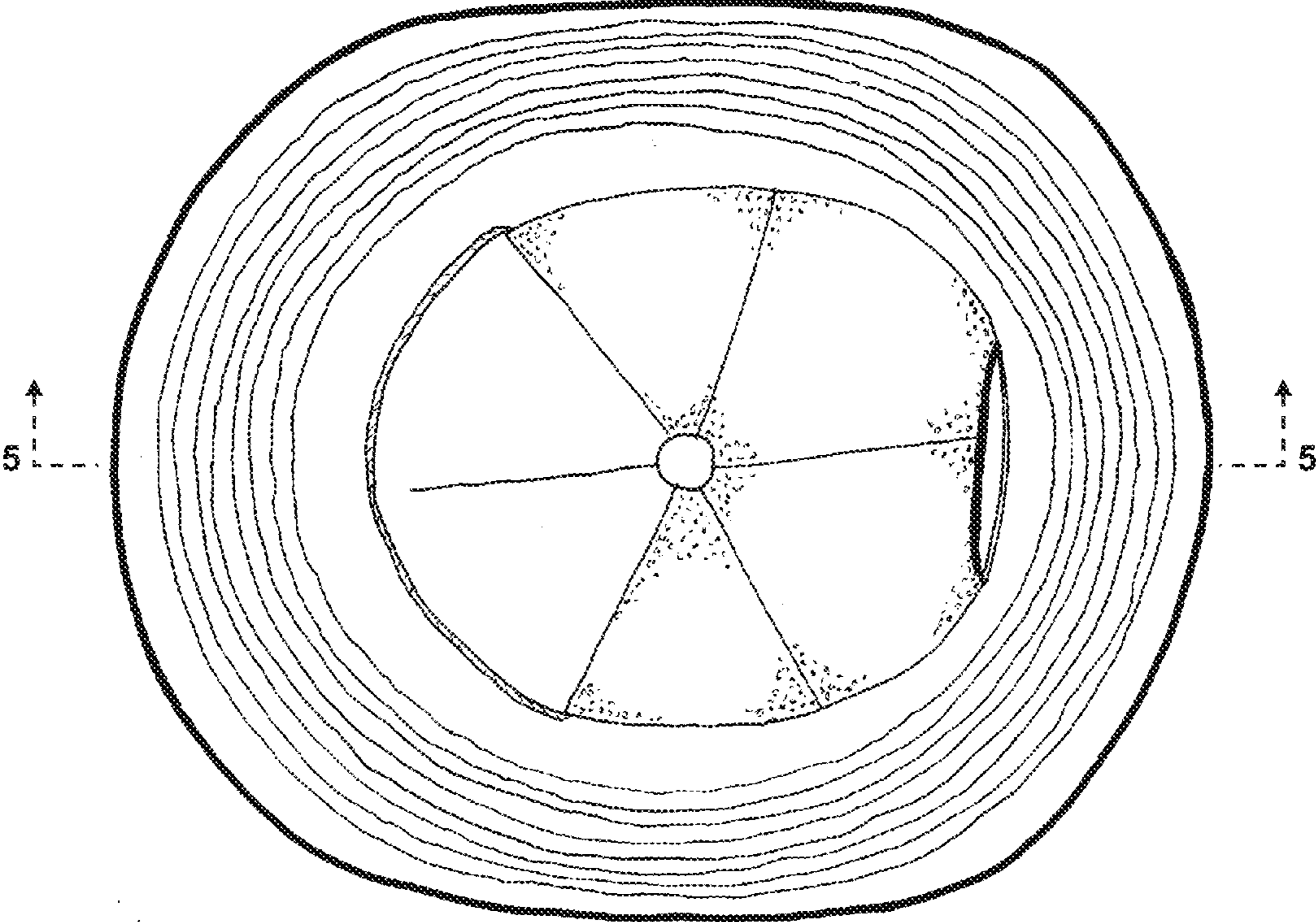

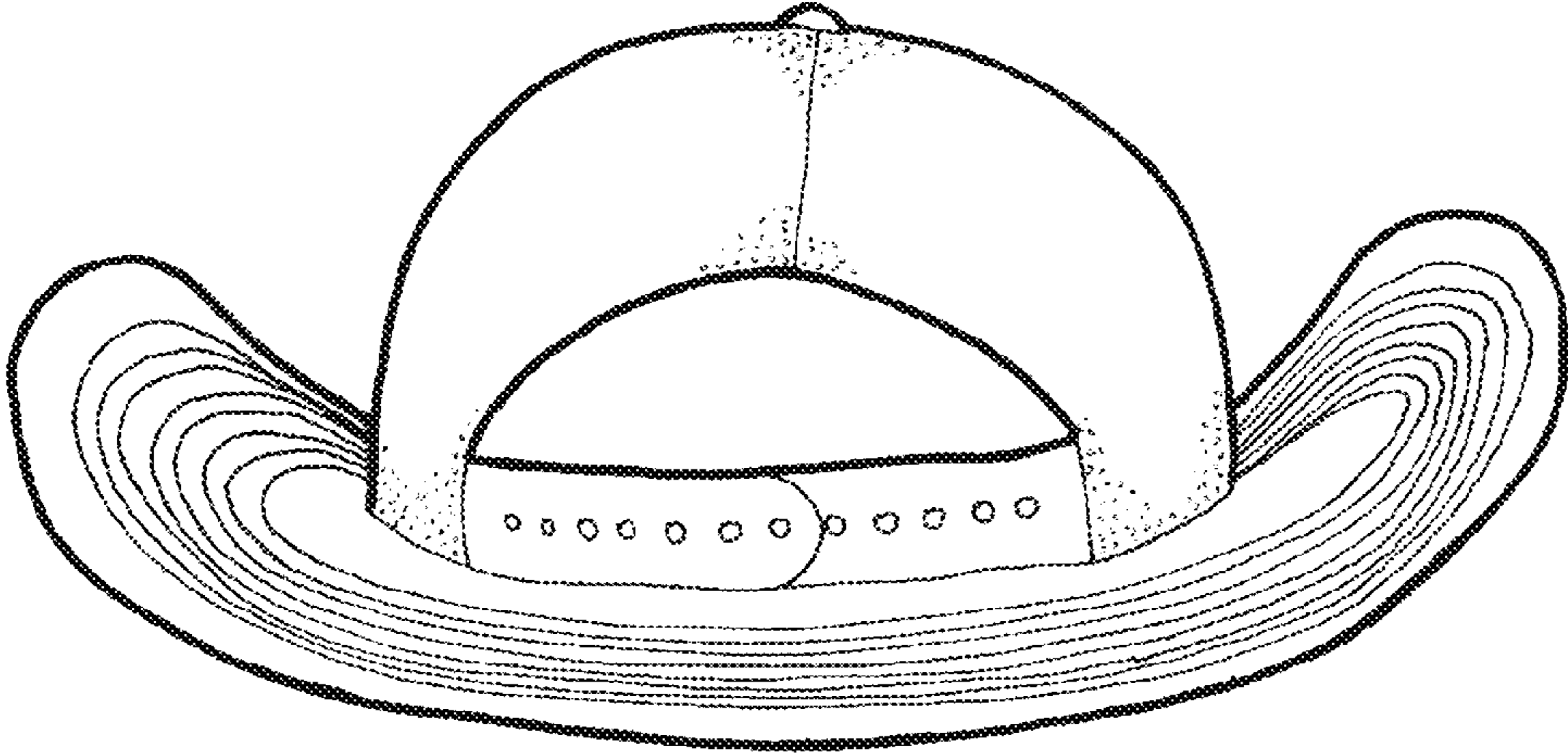

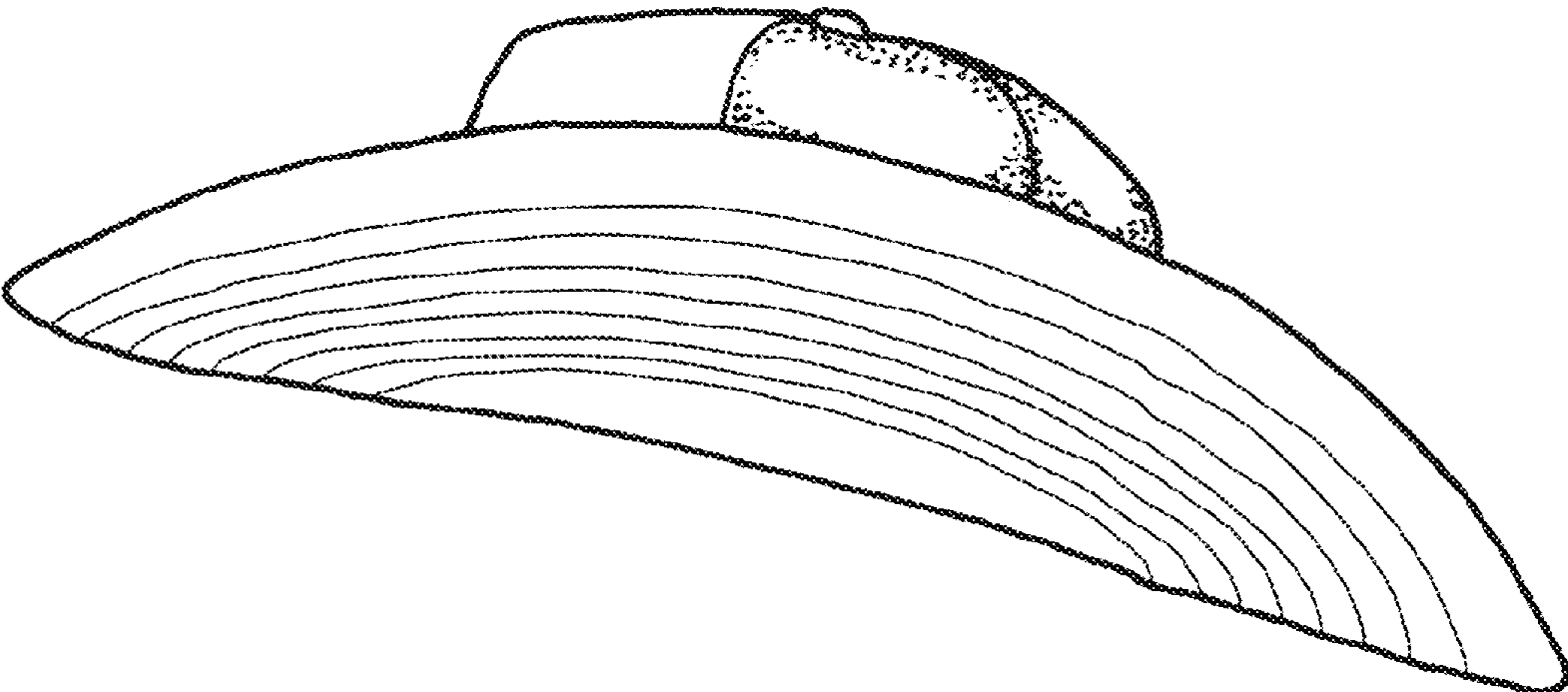

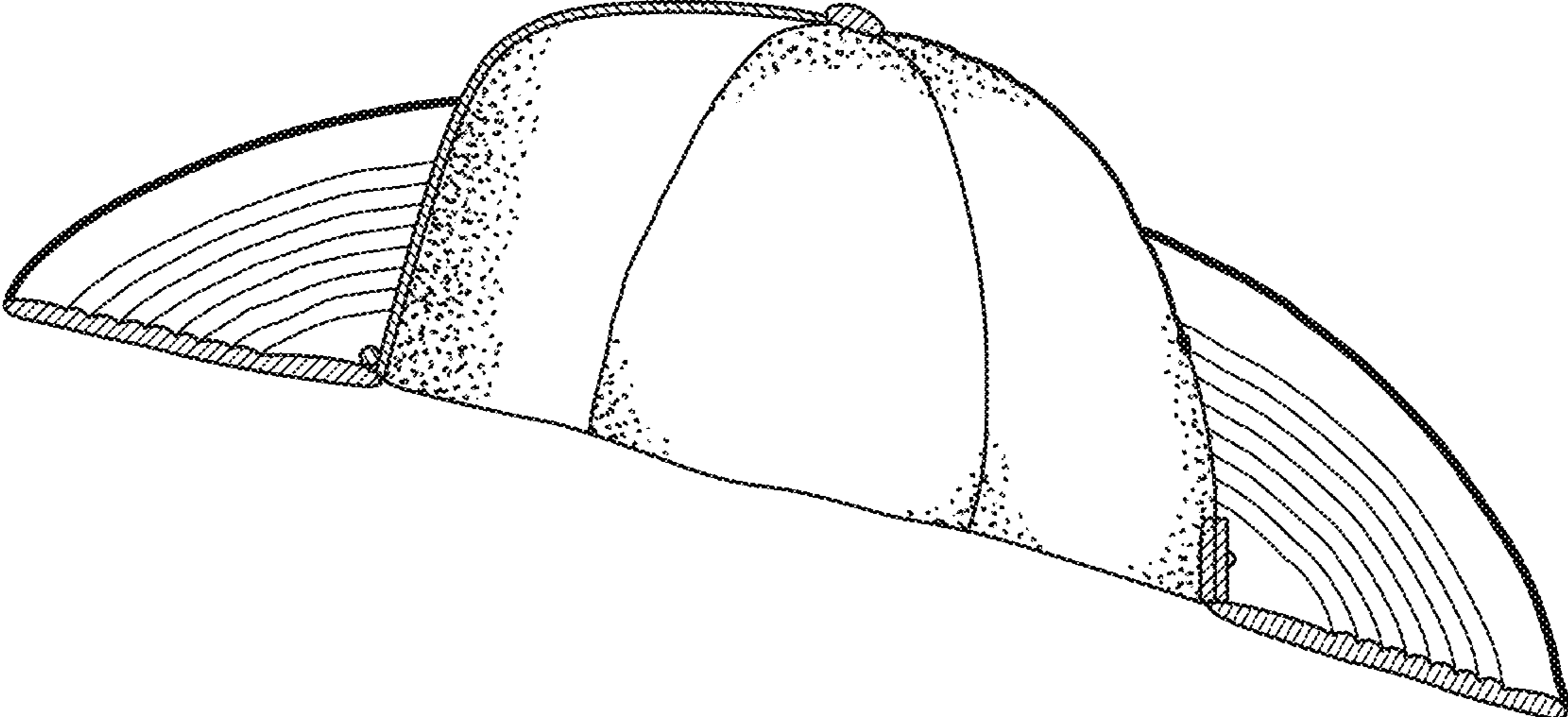
