FIG. 4 is a left view of the sandal of the present invention;

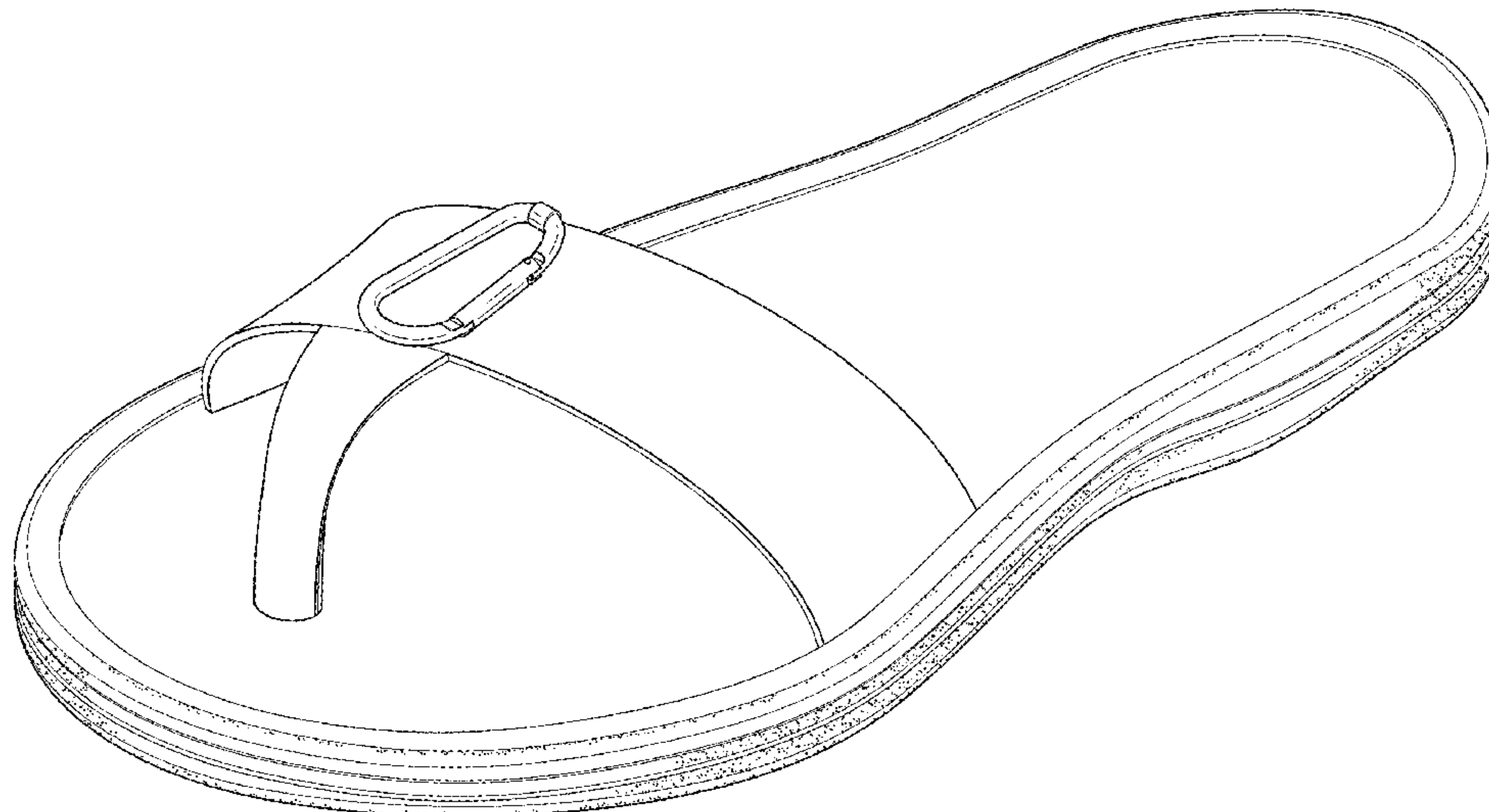
FIG. 5 is a right view of the sandal of the present invention;

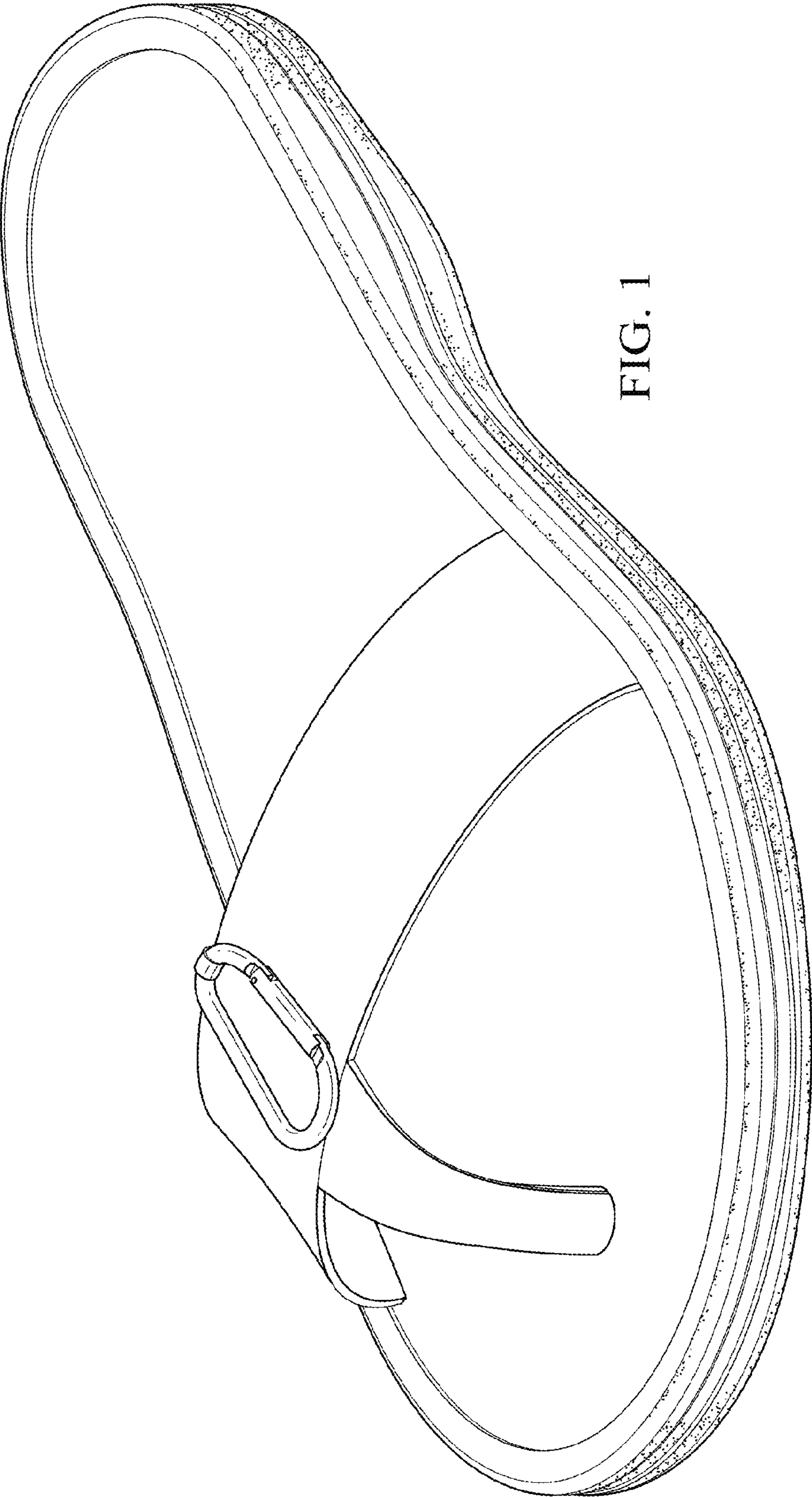

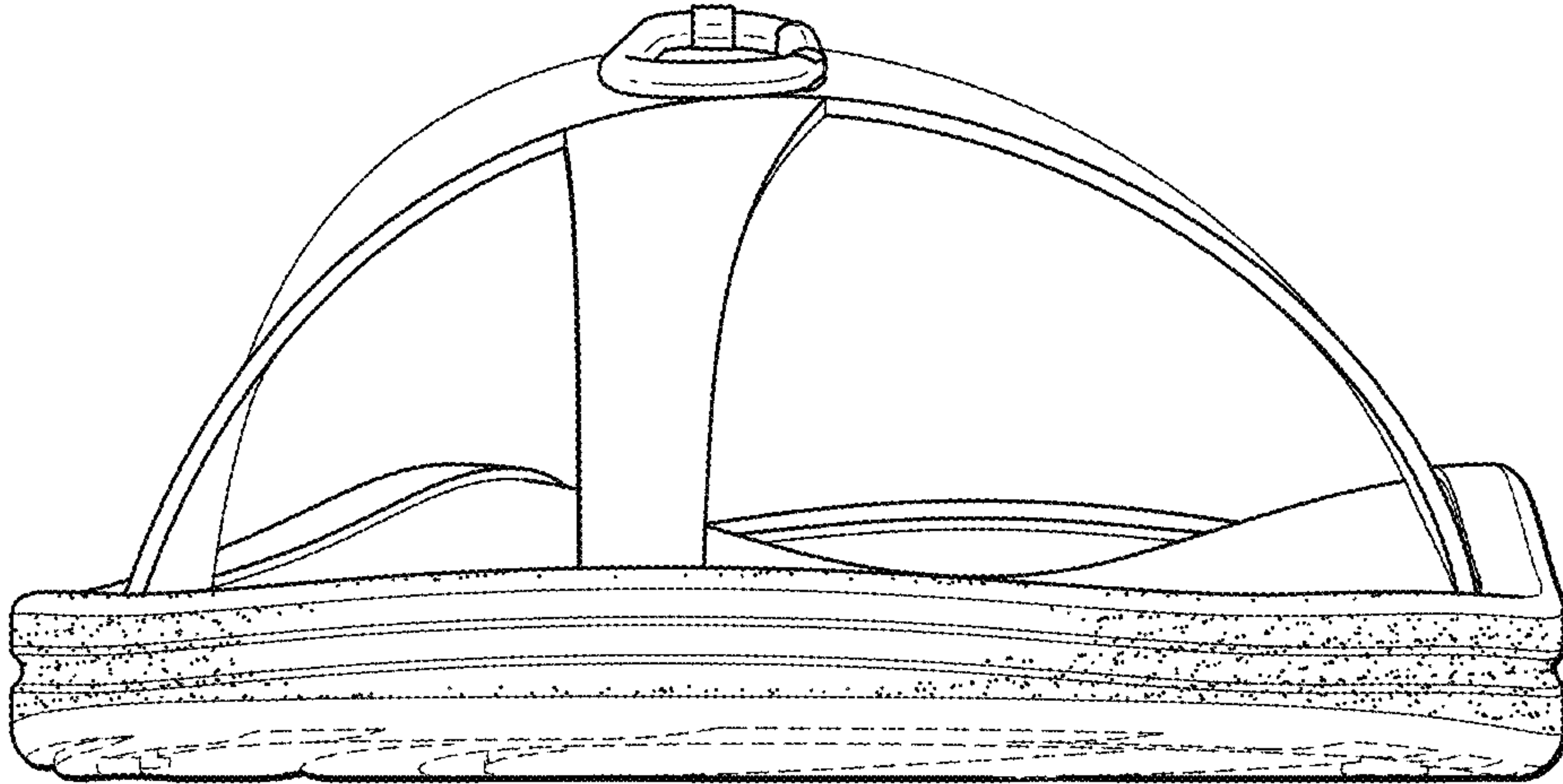

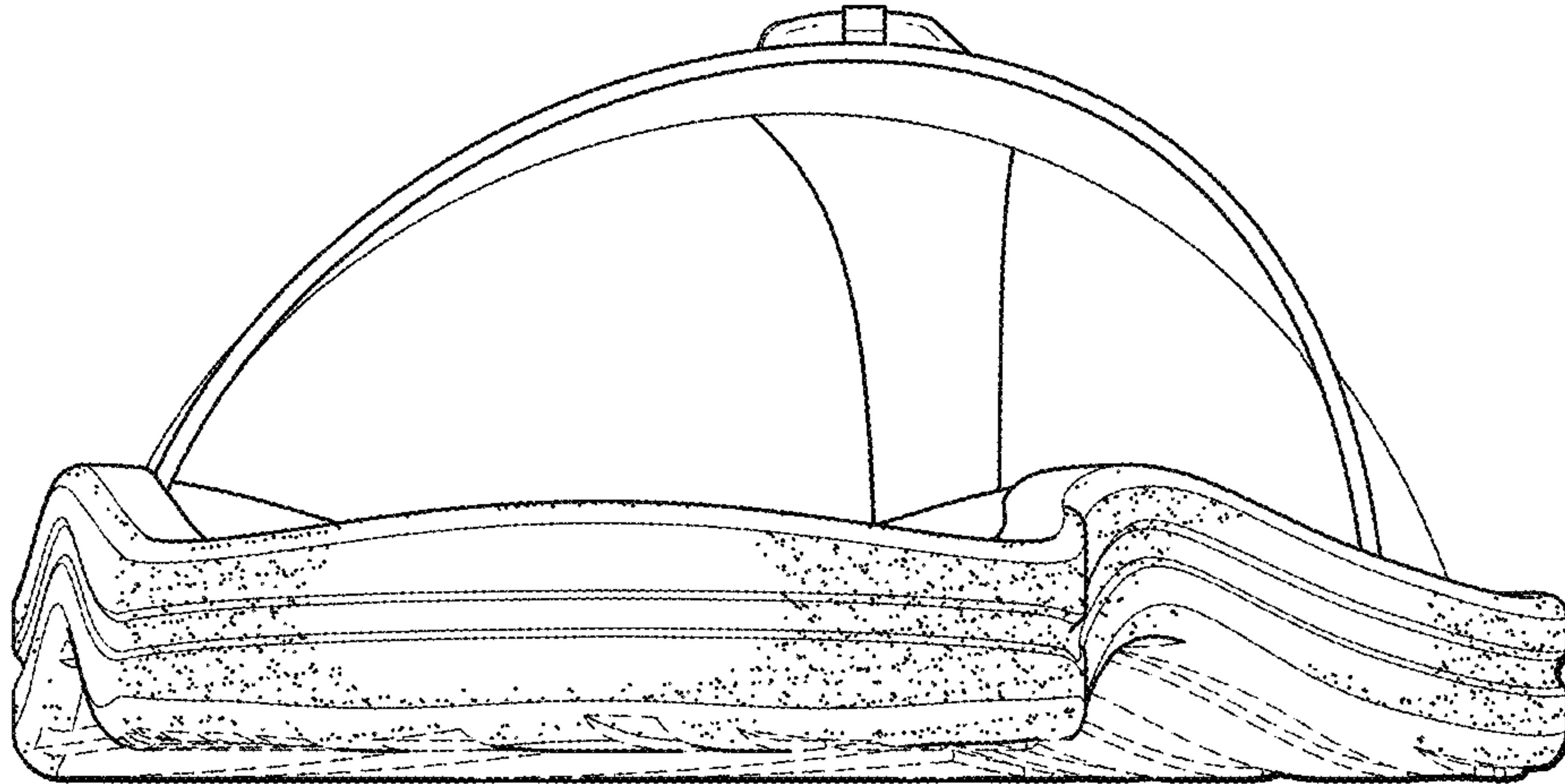

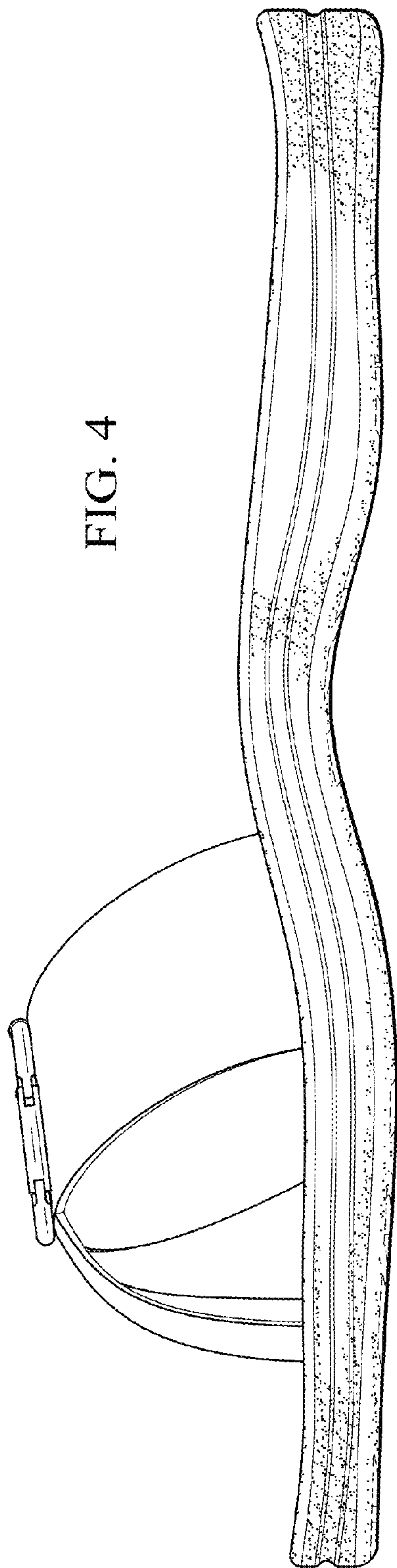

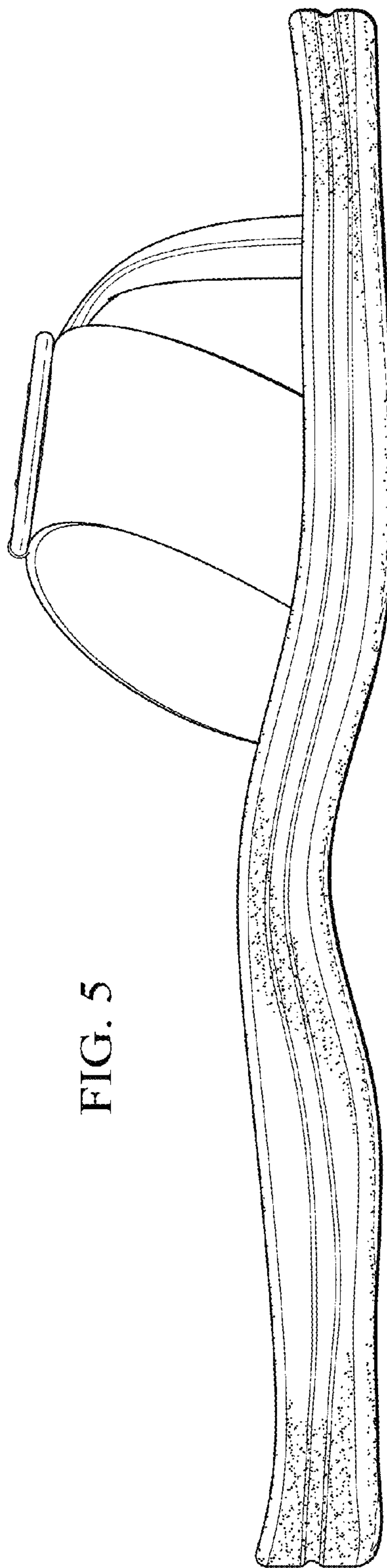
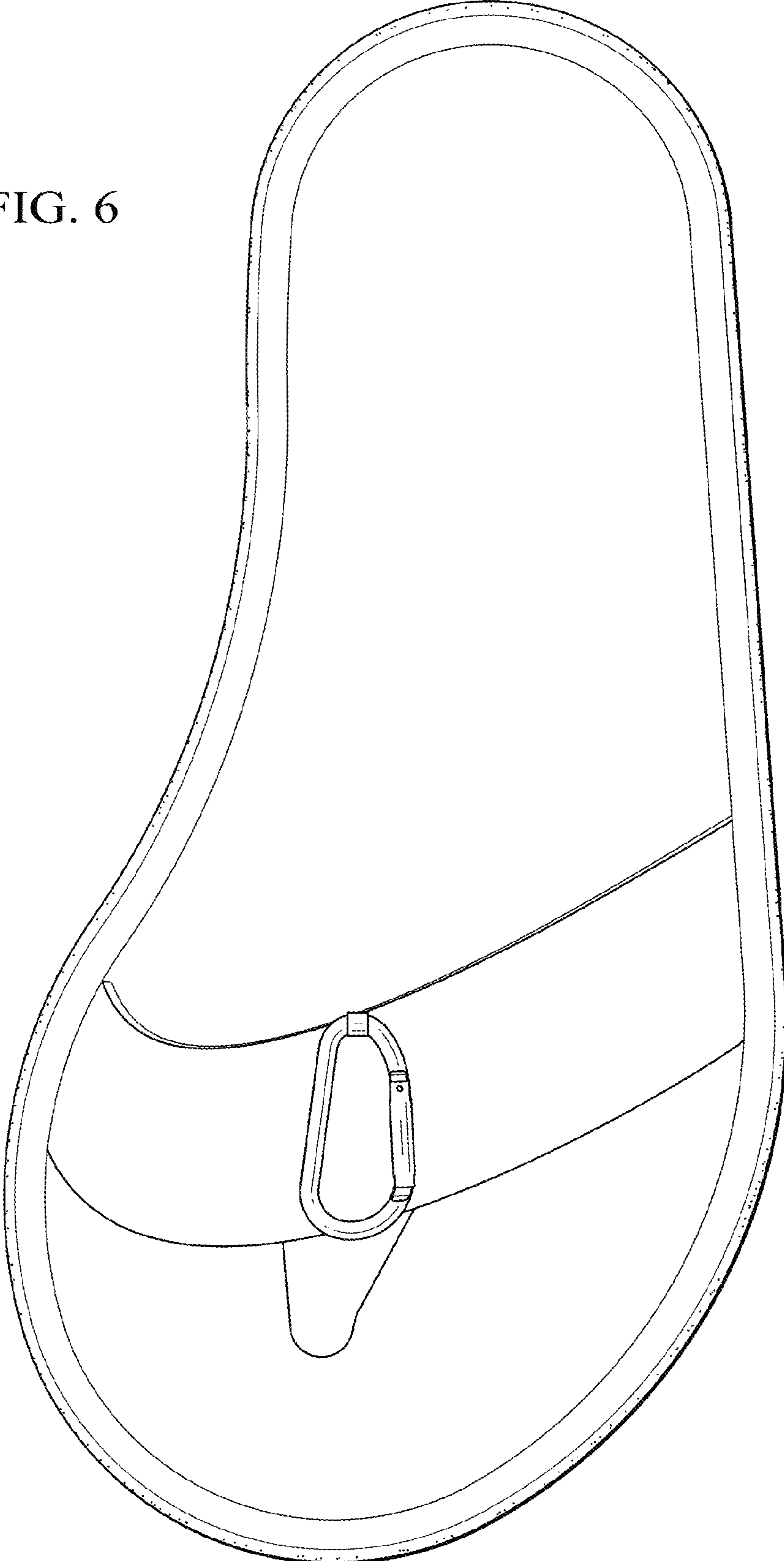

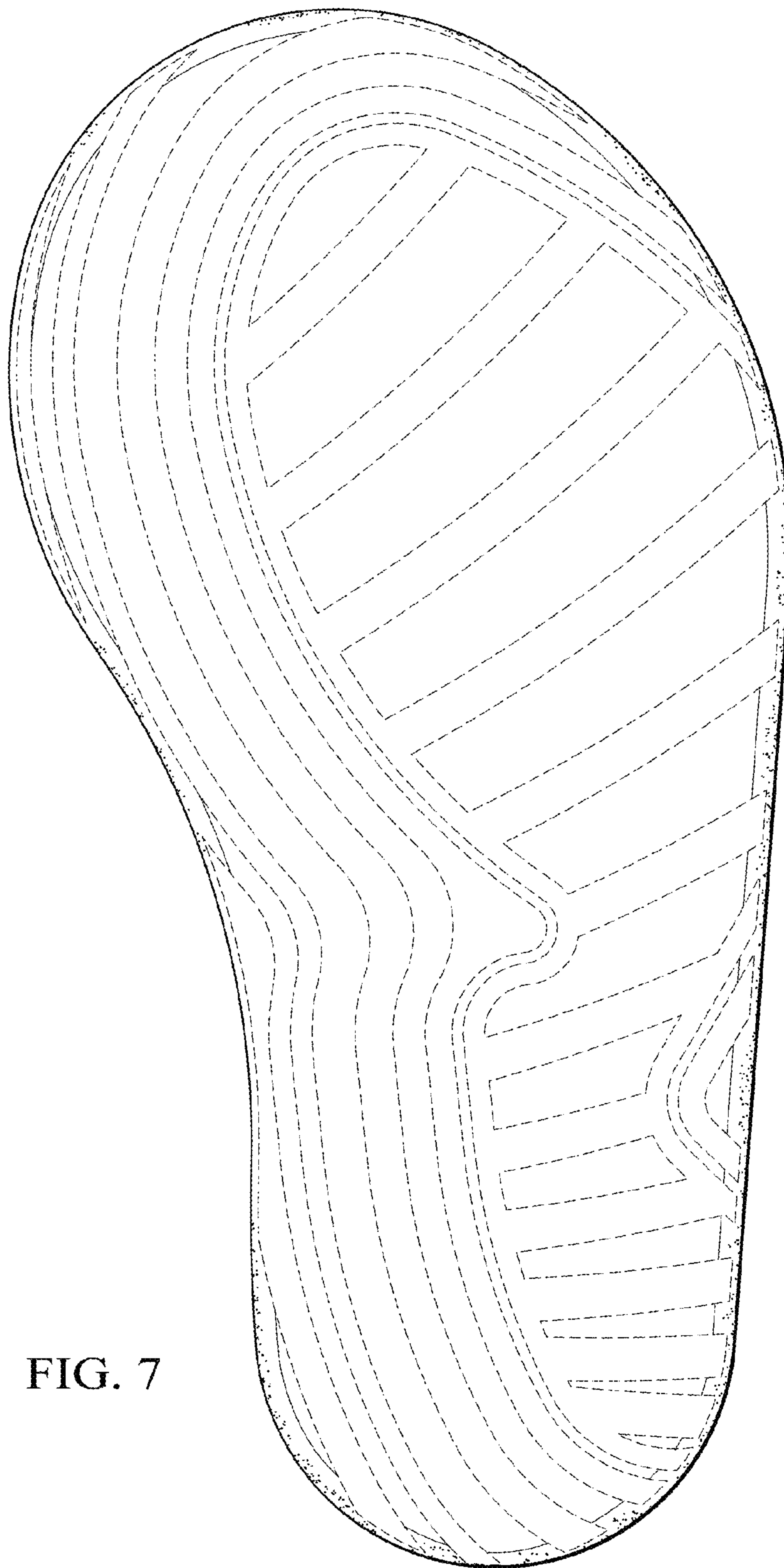
